FIG. 4 is a rear view of the transmitter;

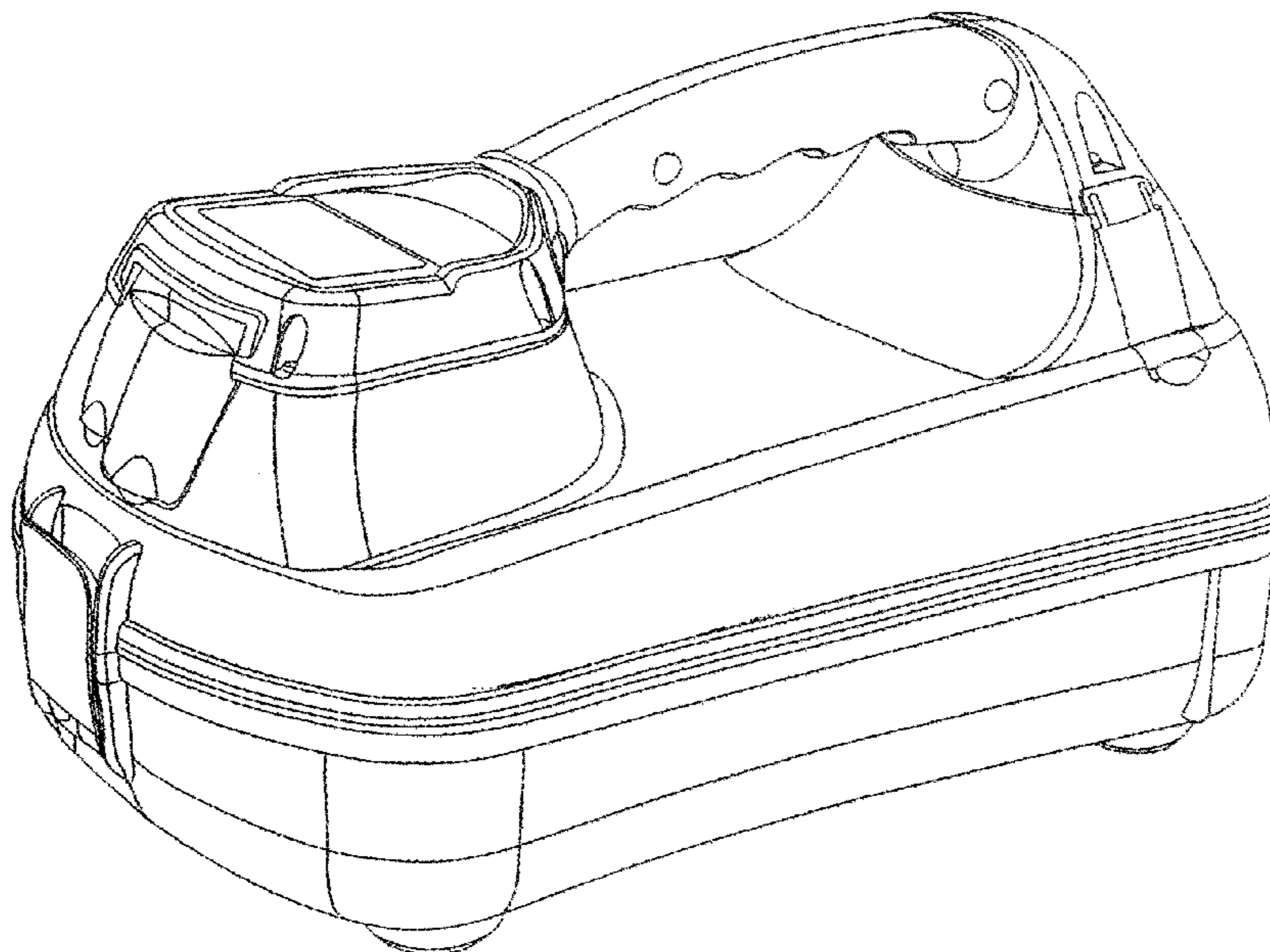
FIG. 5 is a front view of the transmitter;

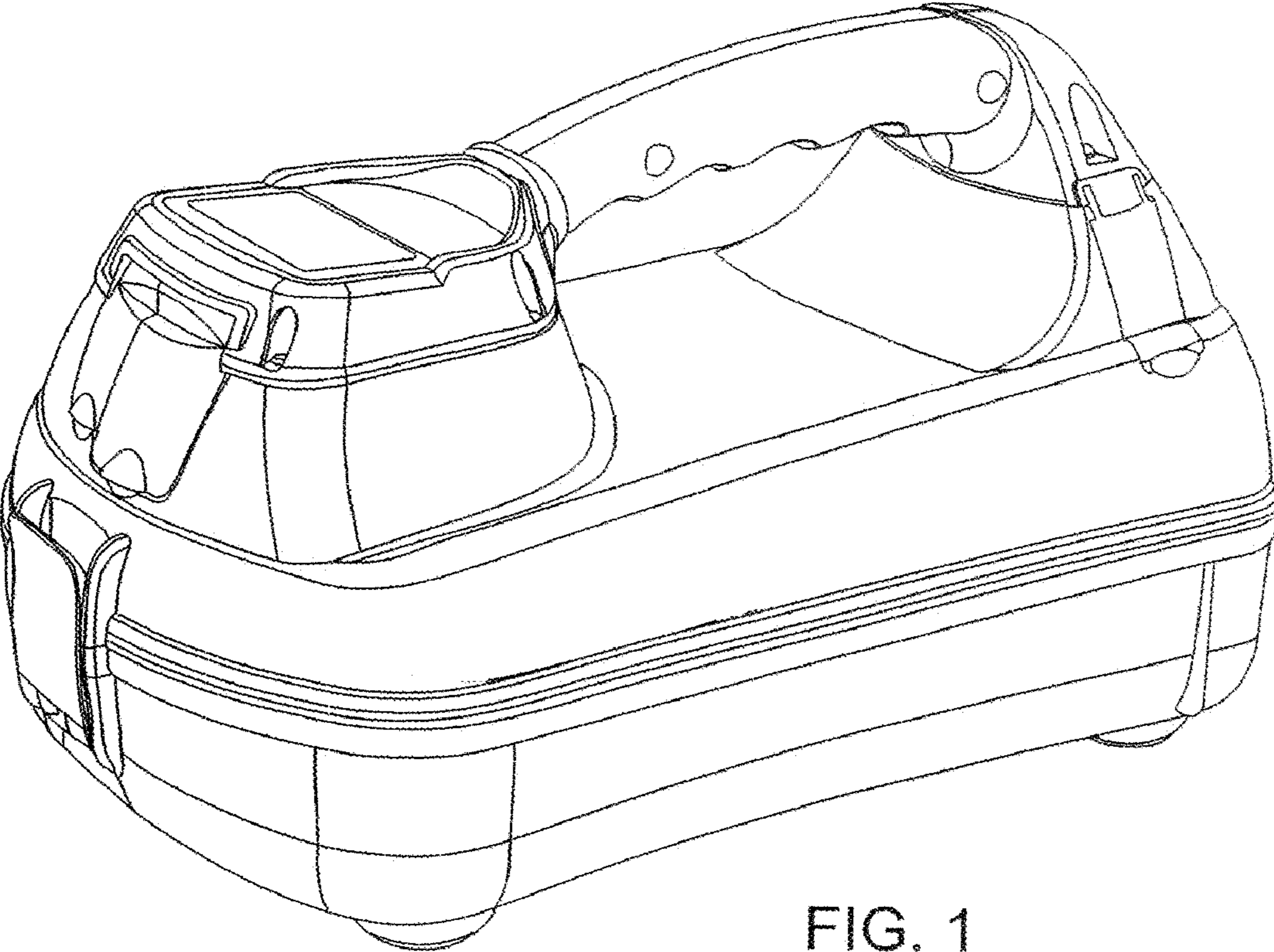

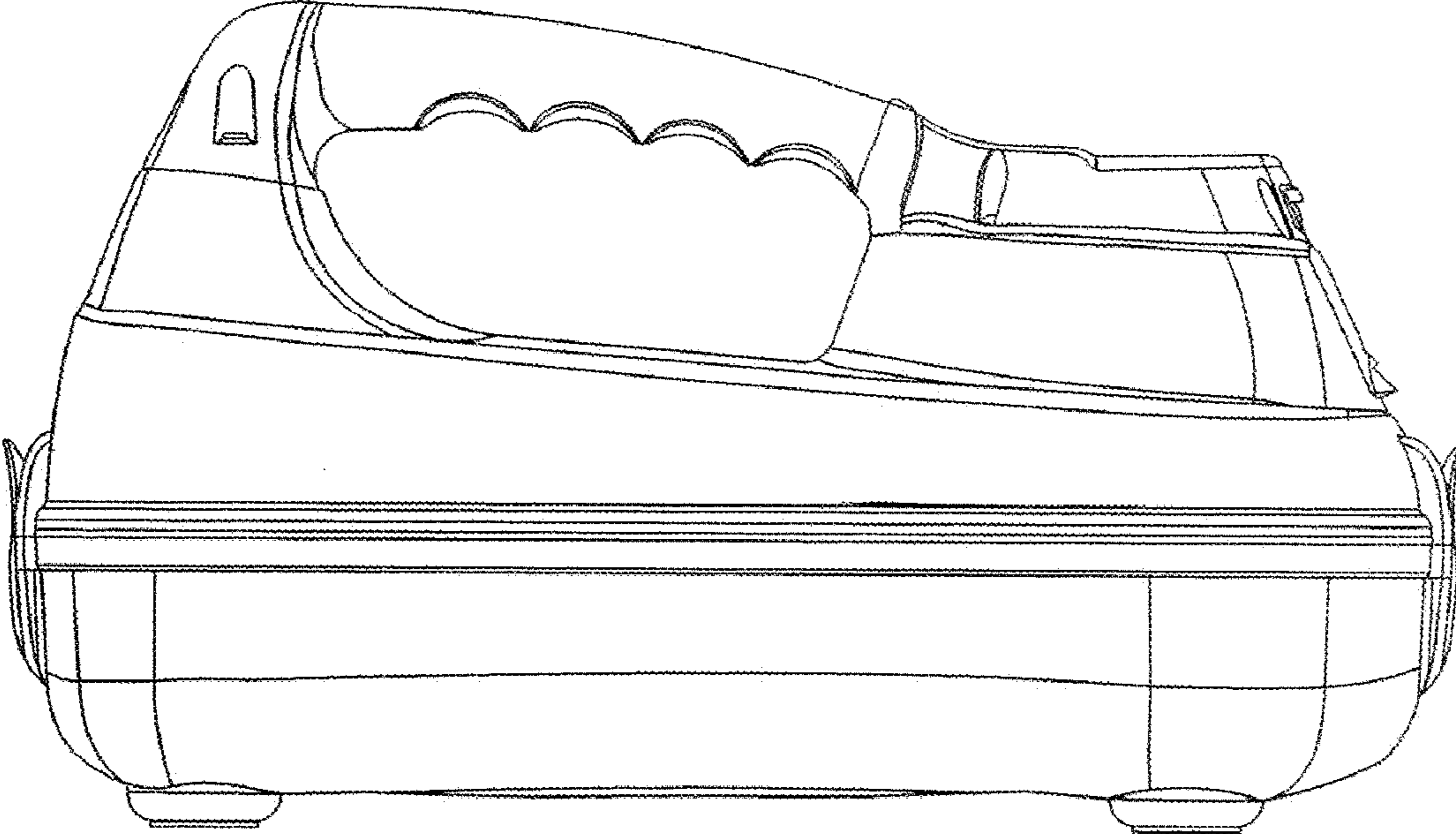

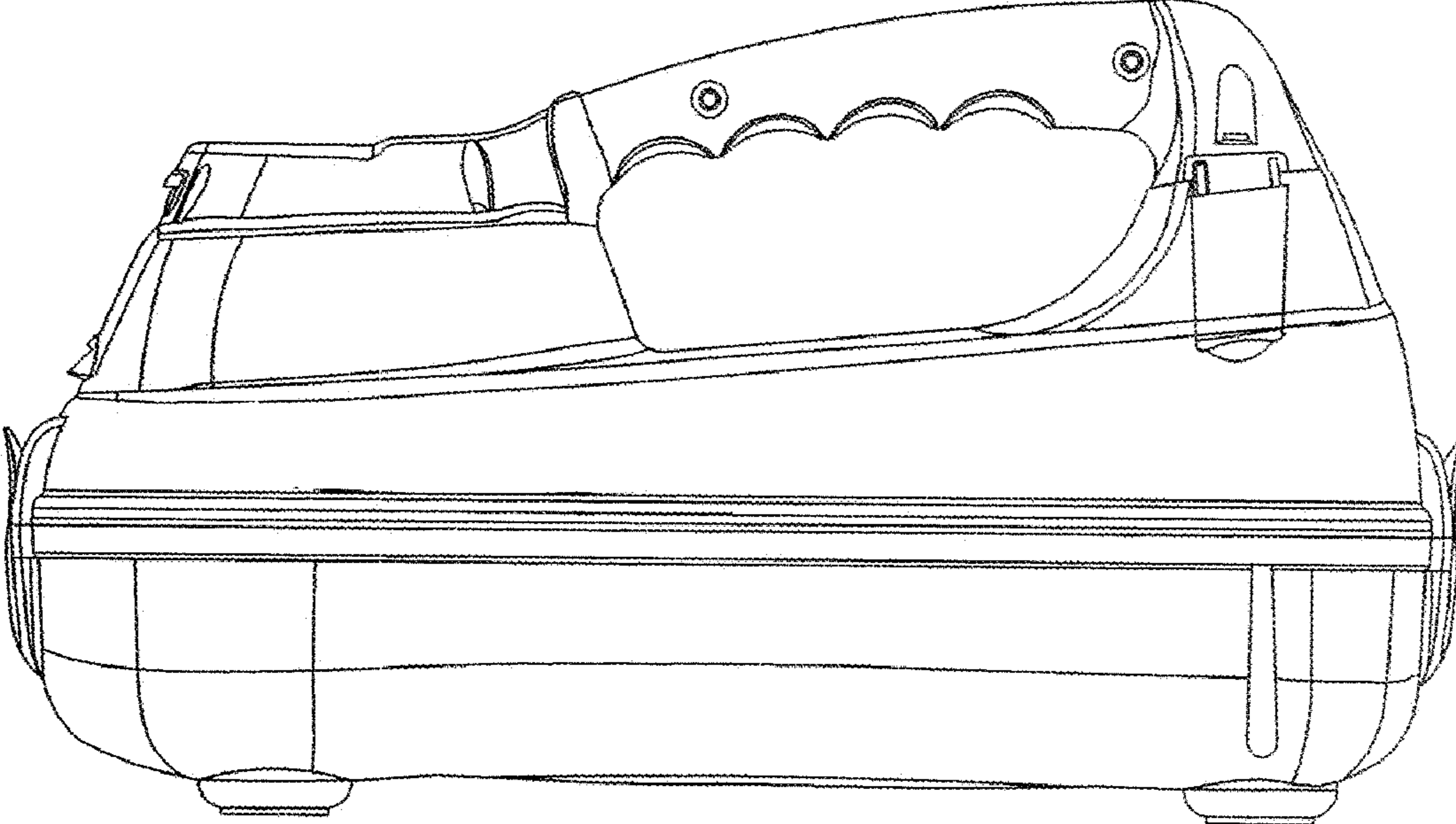

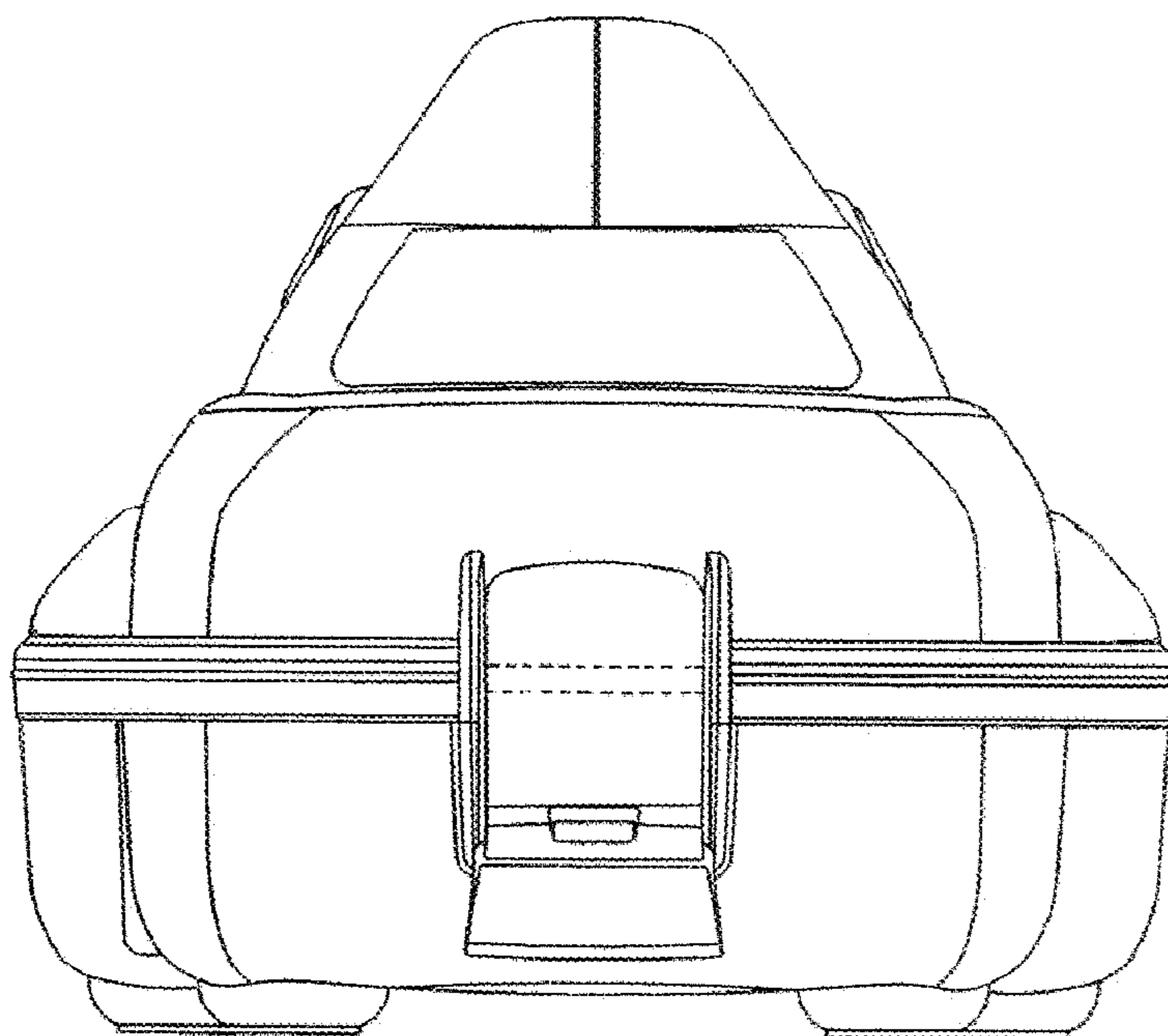

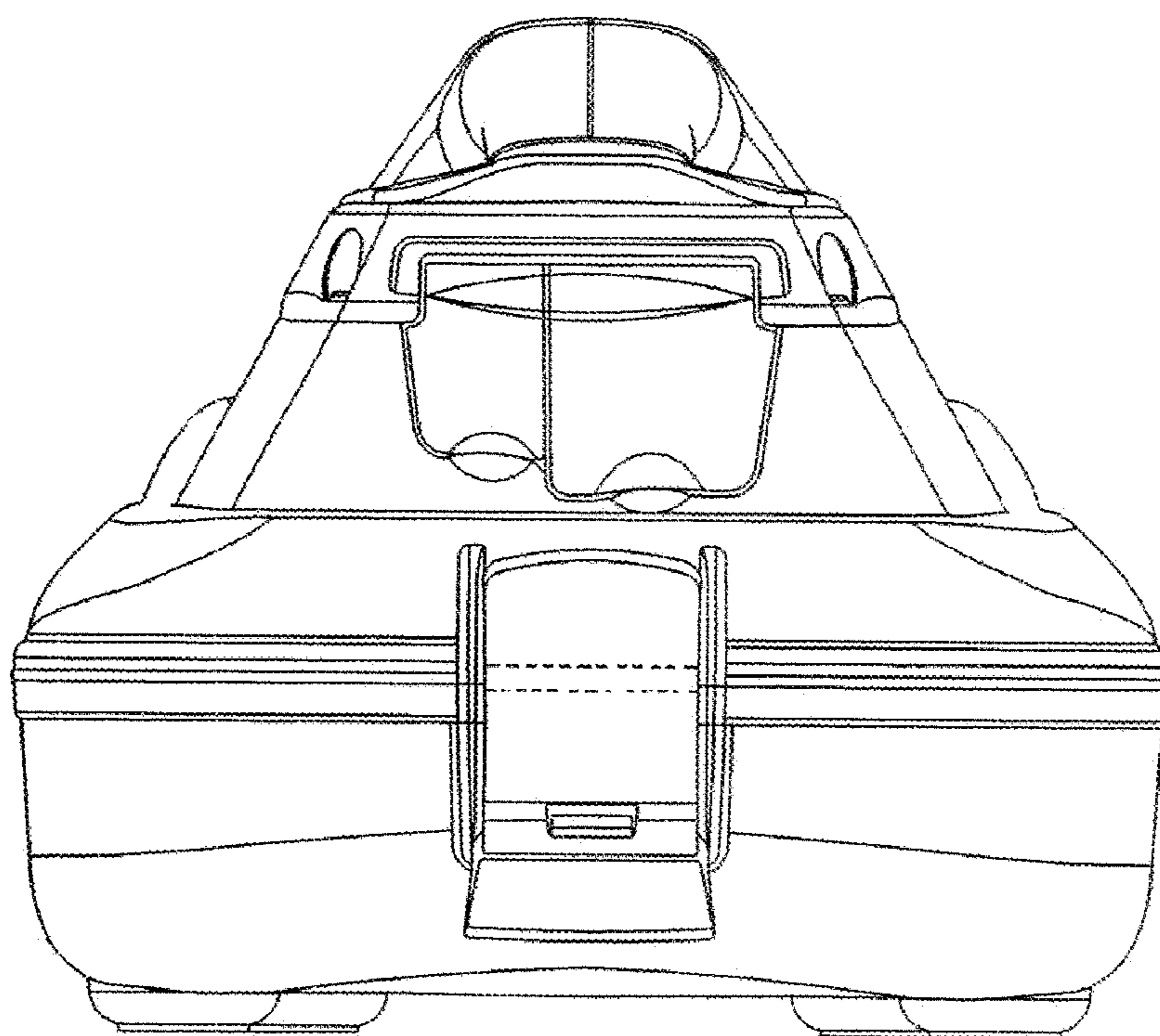

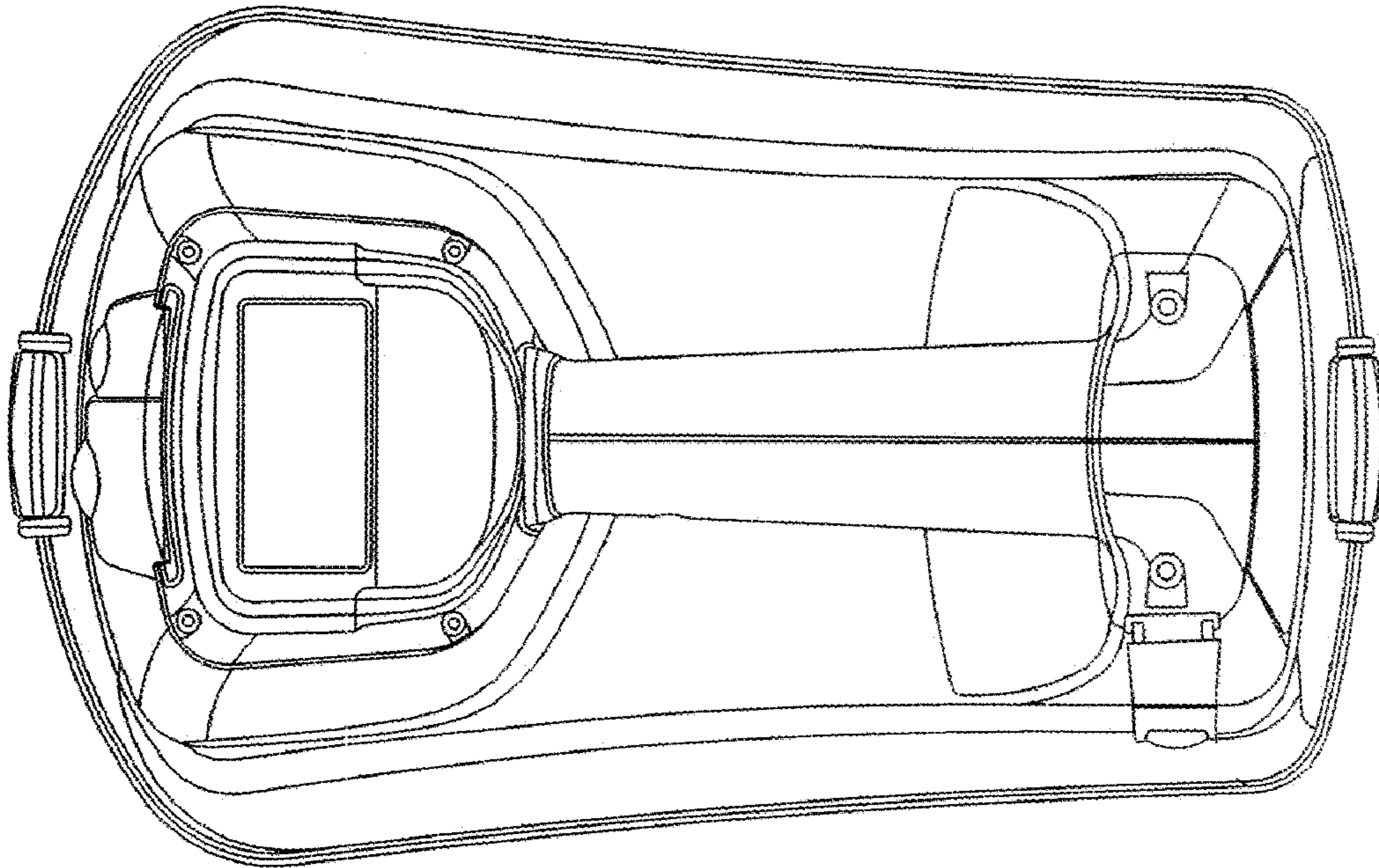

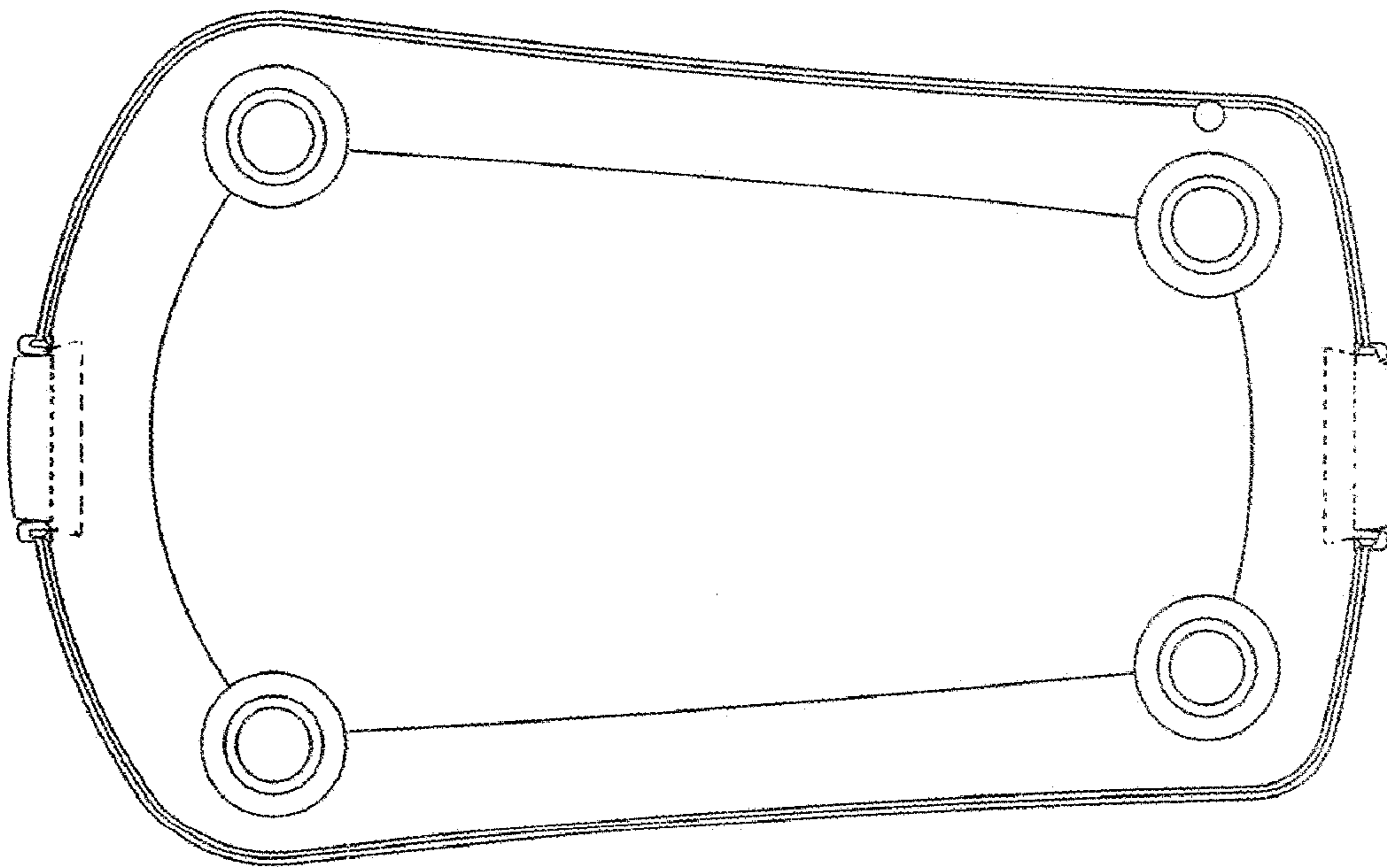
