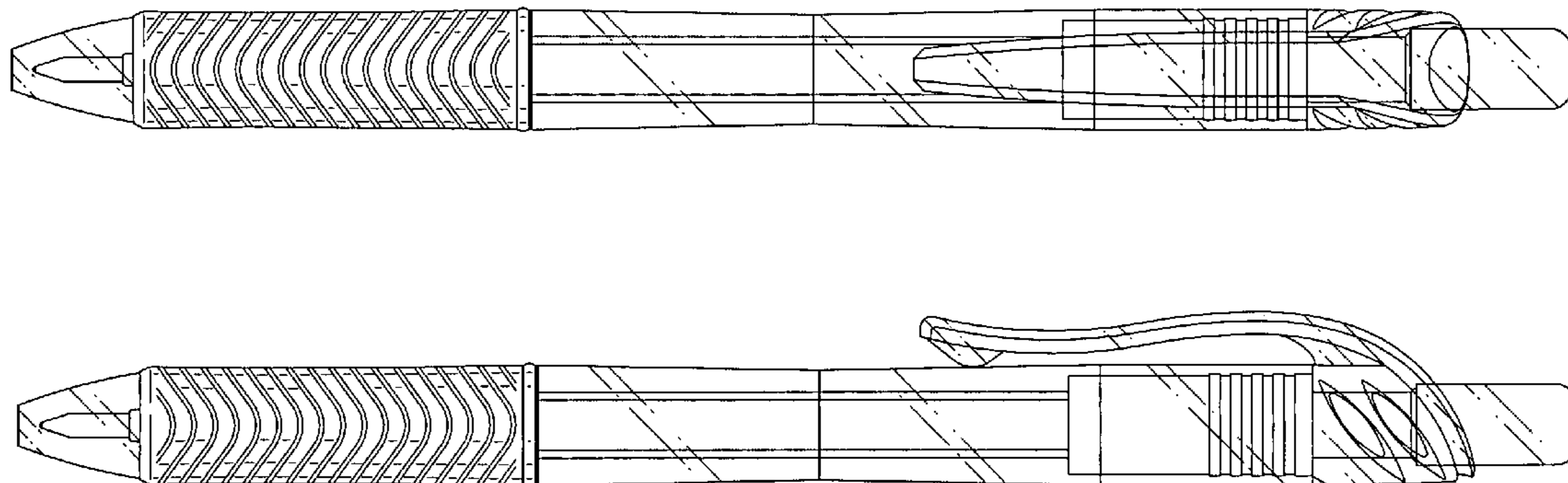
(57) **CLAIM**

The ornamental design for a ballpoint pen, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, top and left side of a ballpoint pen showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a bottom view, a top plan view being a mirror image thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a front view thereof, with the writing tip extended; and,
FIG. 8 is a bottom view thereof, with the writing tip extended.

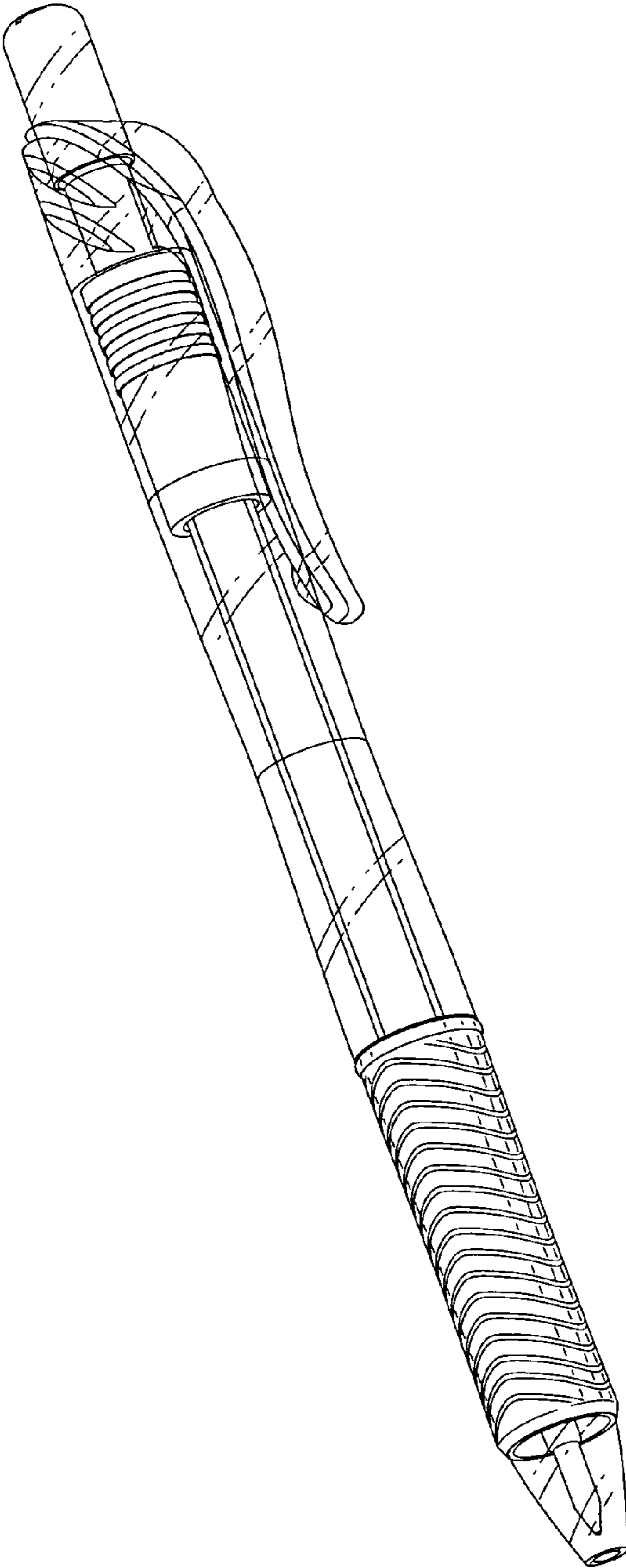

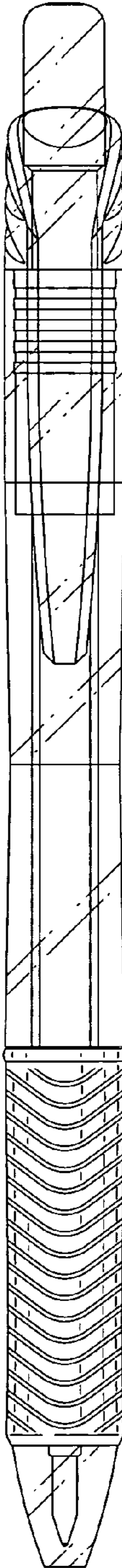

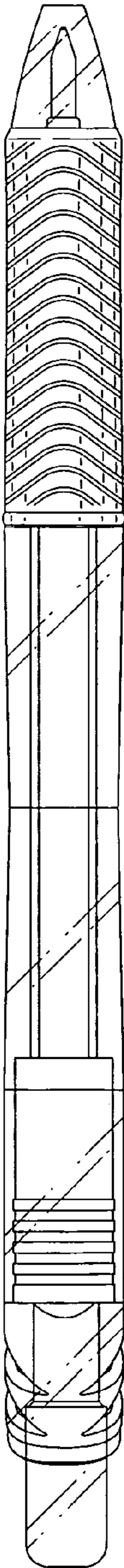

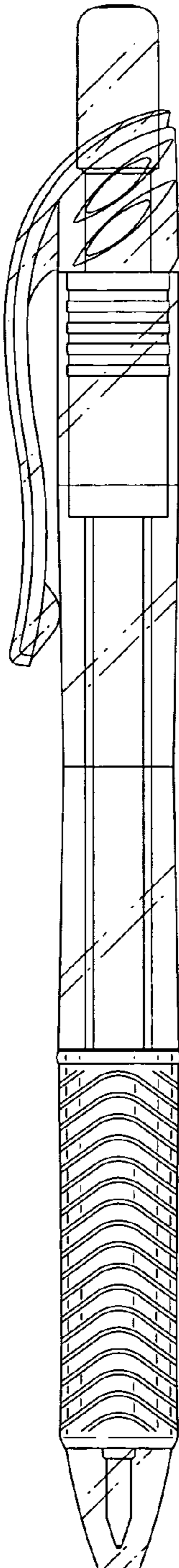

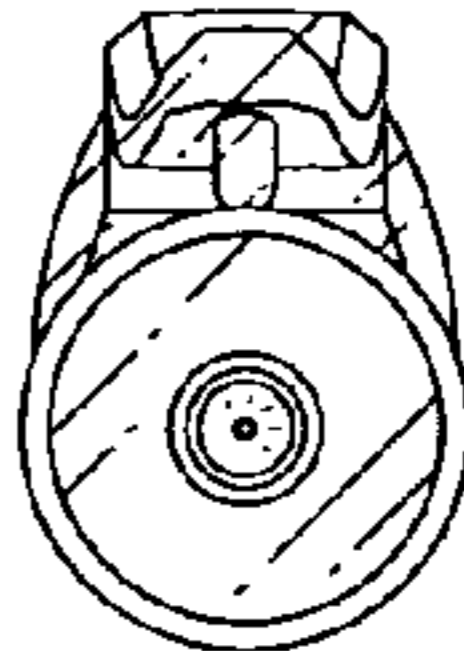

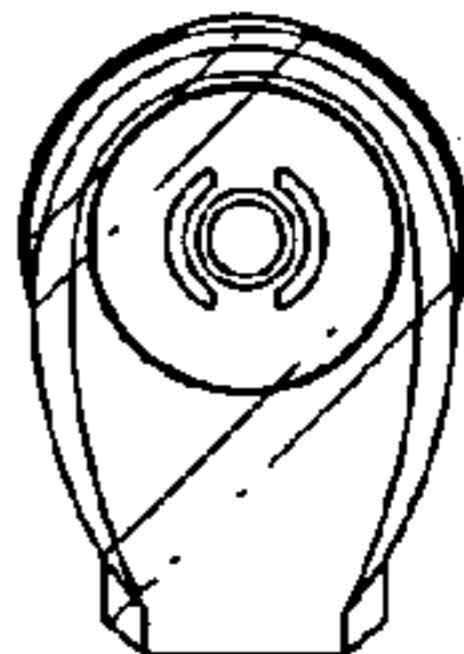

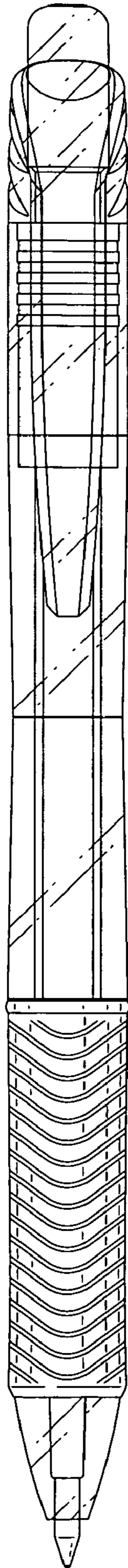

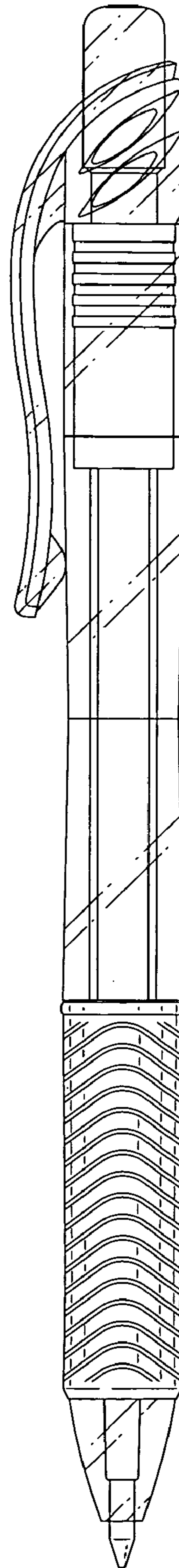
