DESCRIPTION

FIG. 1 is a perspective view of the front, top and left side of a correction pen showing my new design;

FIG. 3 is a rear view thereof;

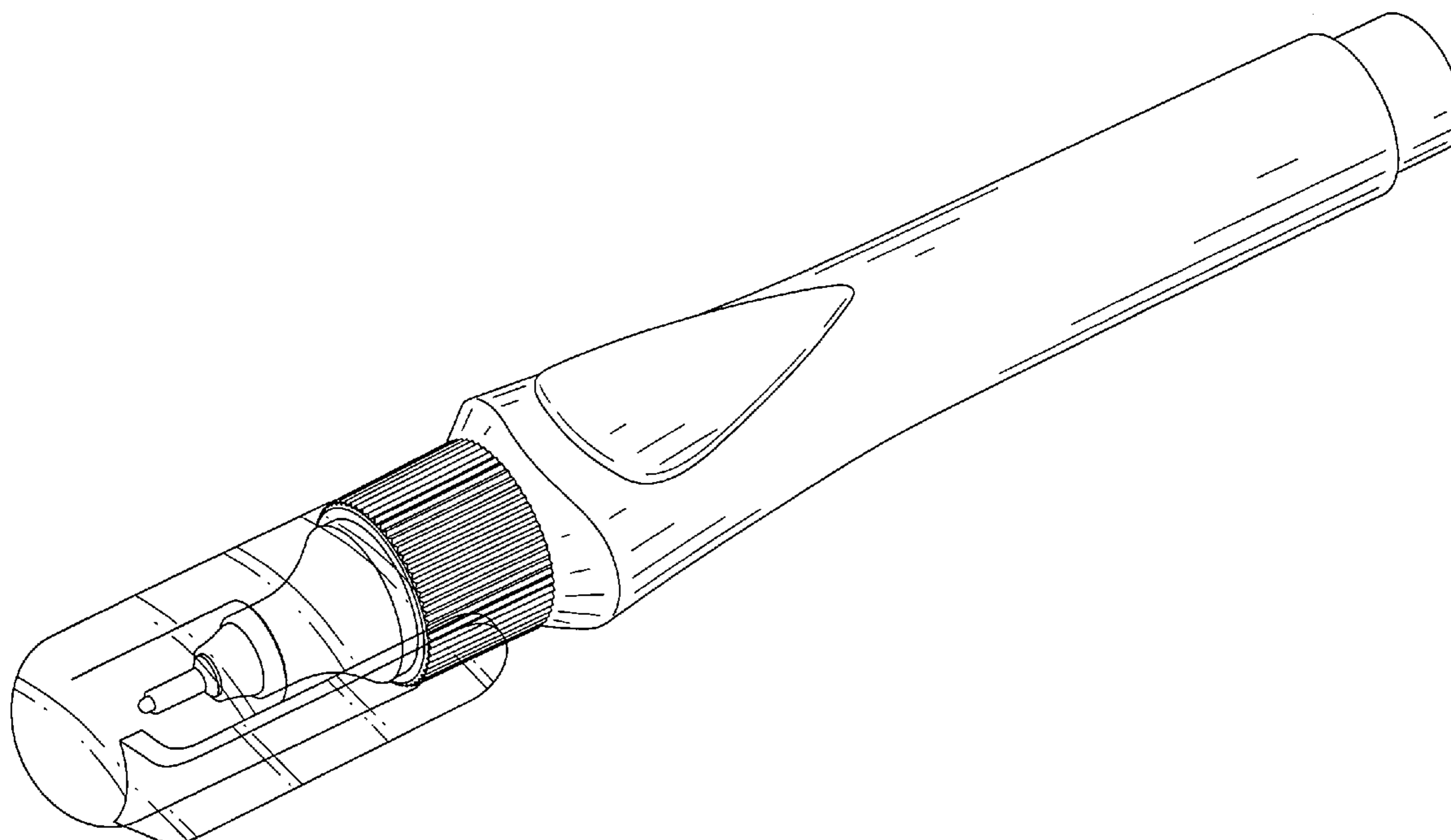
FIG. 4 is a bottom view, a top plan view being a mirror image thereof;

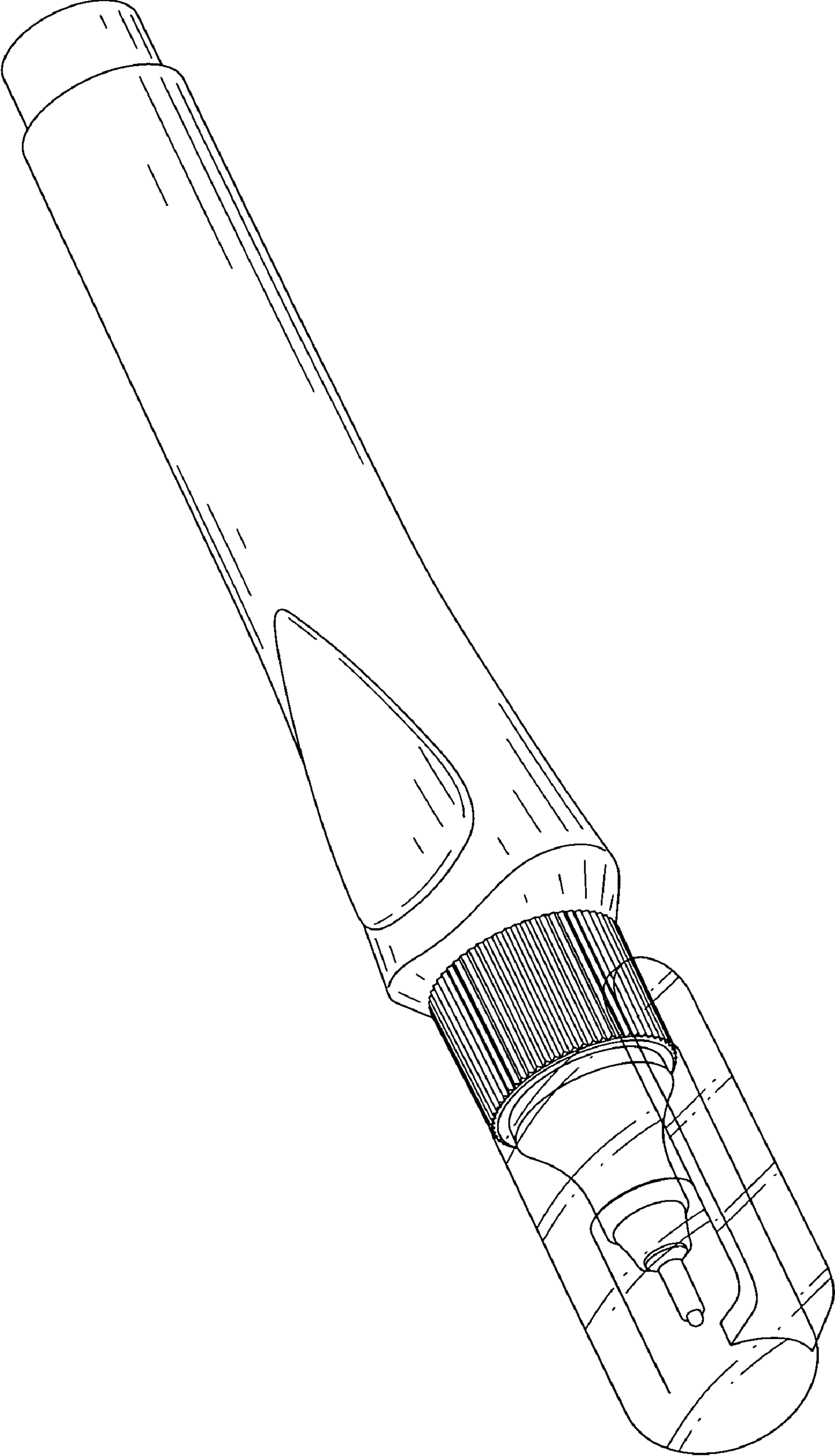

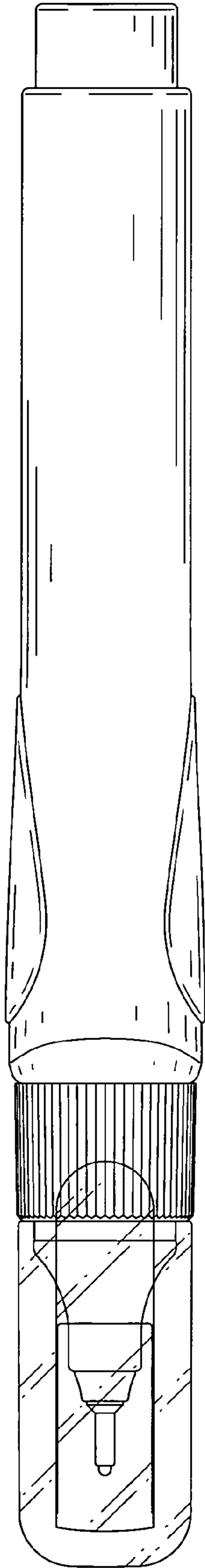

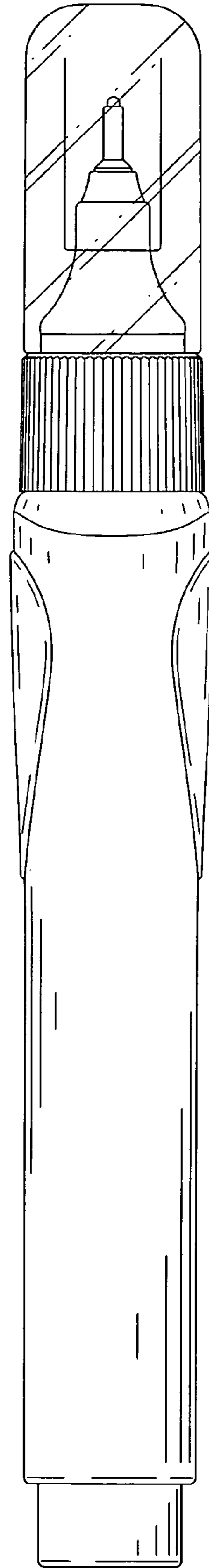

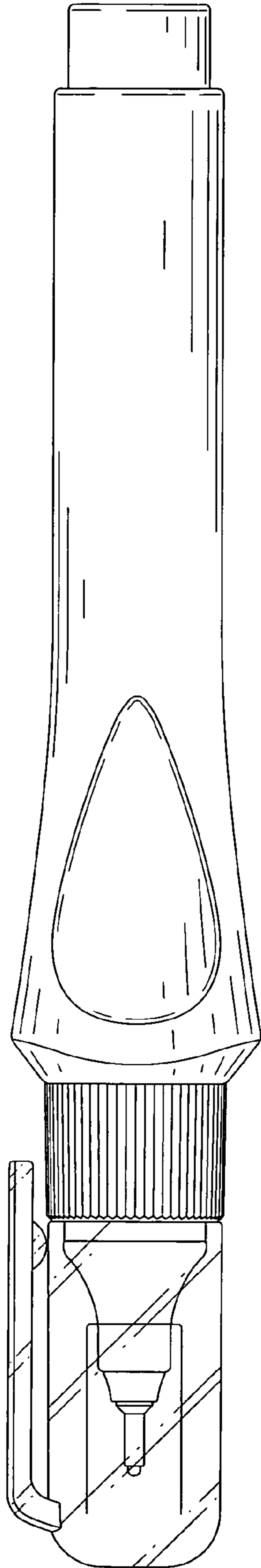

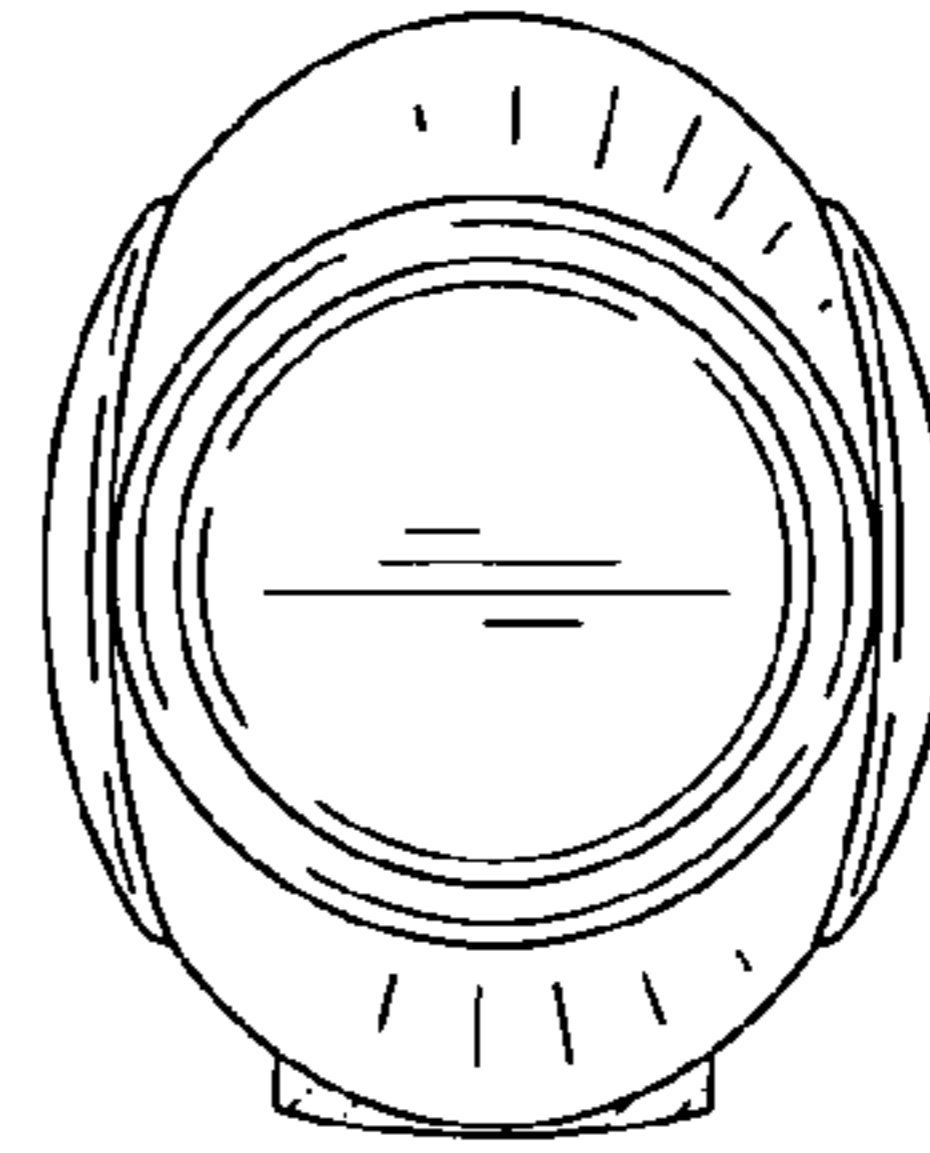

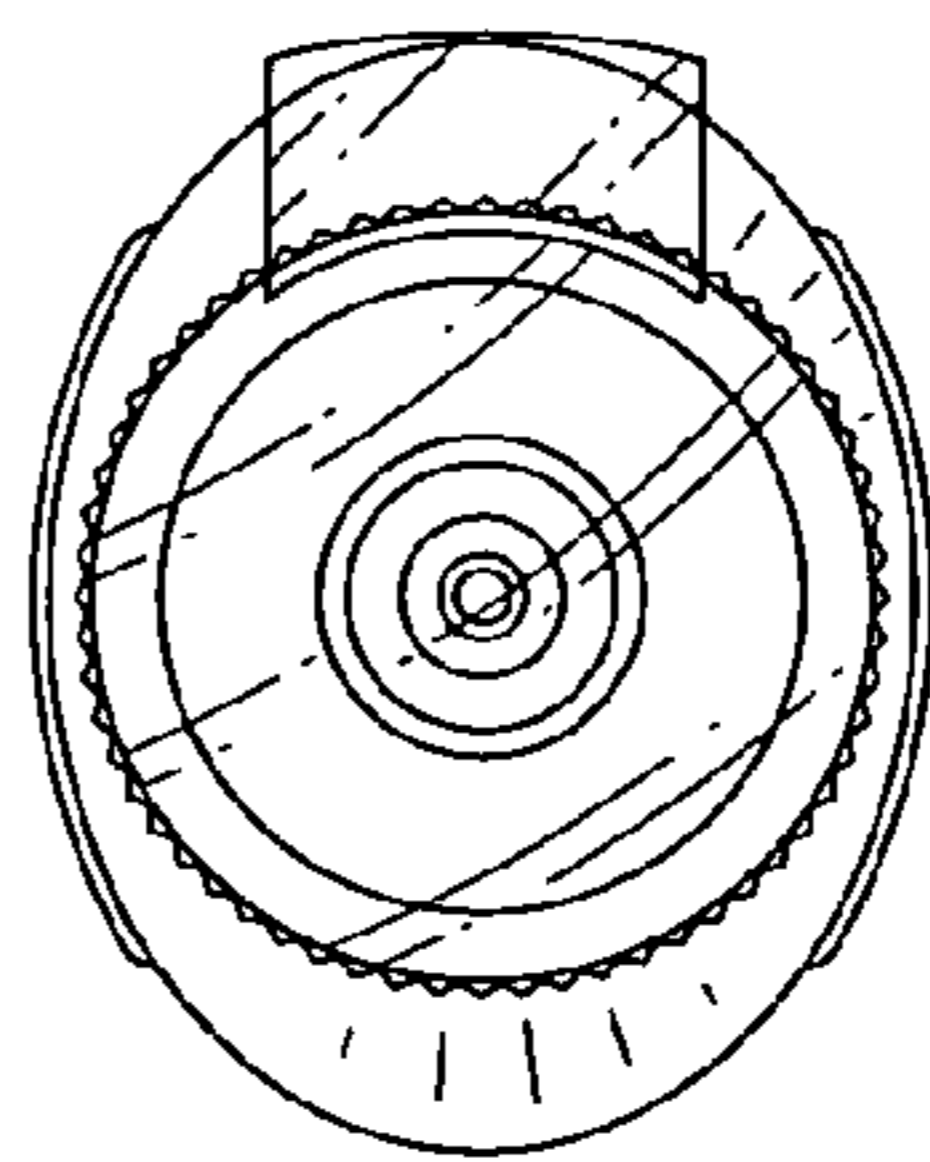

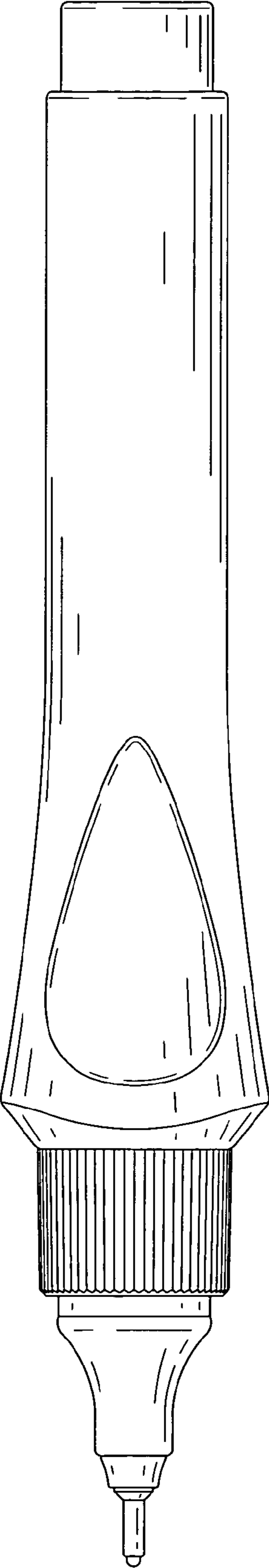
