(57) **CLAIM**

What is claimed is the ornamental design for a plush toy with an elastic wristband, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a plush toy with an elastic wristband, showing the new design;  
FIG. 2 is an enlarged rear elevational view thereof;  
FIG. 3 is an enlarged front elevational view thereof;  
FIG. 4 is an enlarged left-side elevational view thereof, the right-side elevational view being a mirror image thereof; and,  
FIG. 5 is an enlarged top plan view thereof, the bottom plan view being a mirror image thereof.

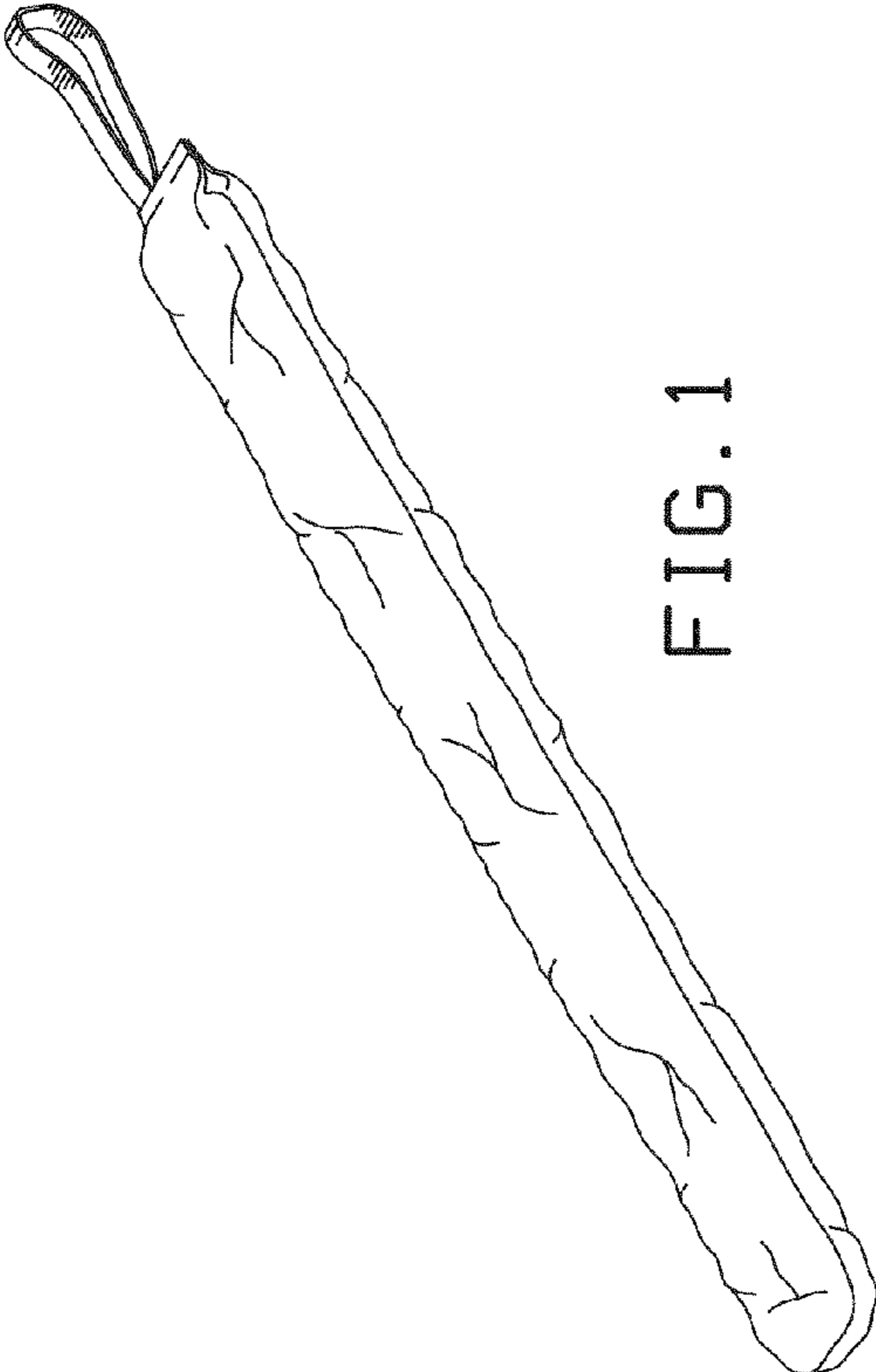

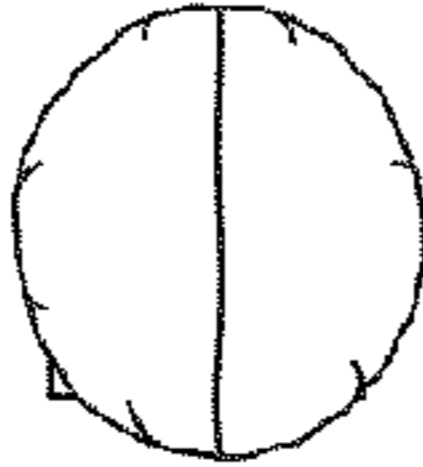

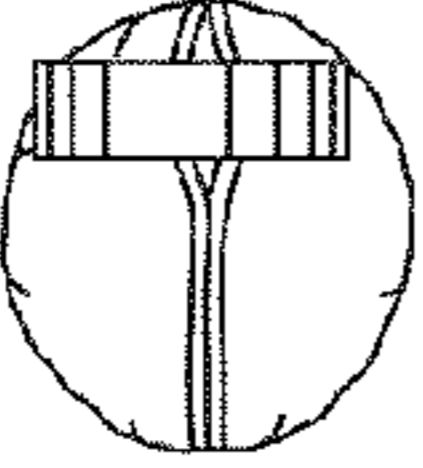

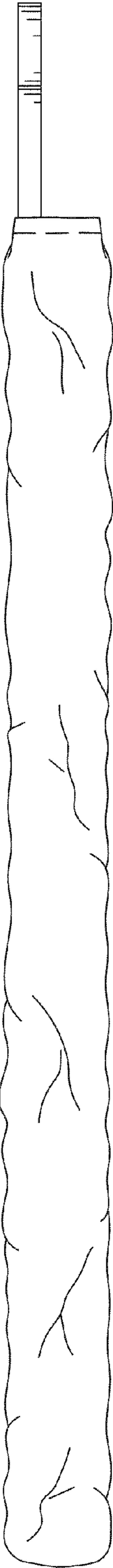
