FIG. 2 is a front view of the youth fanciful character of FIG. 1;

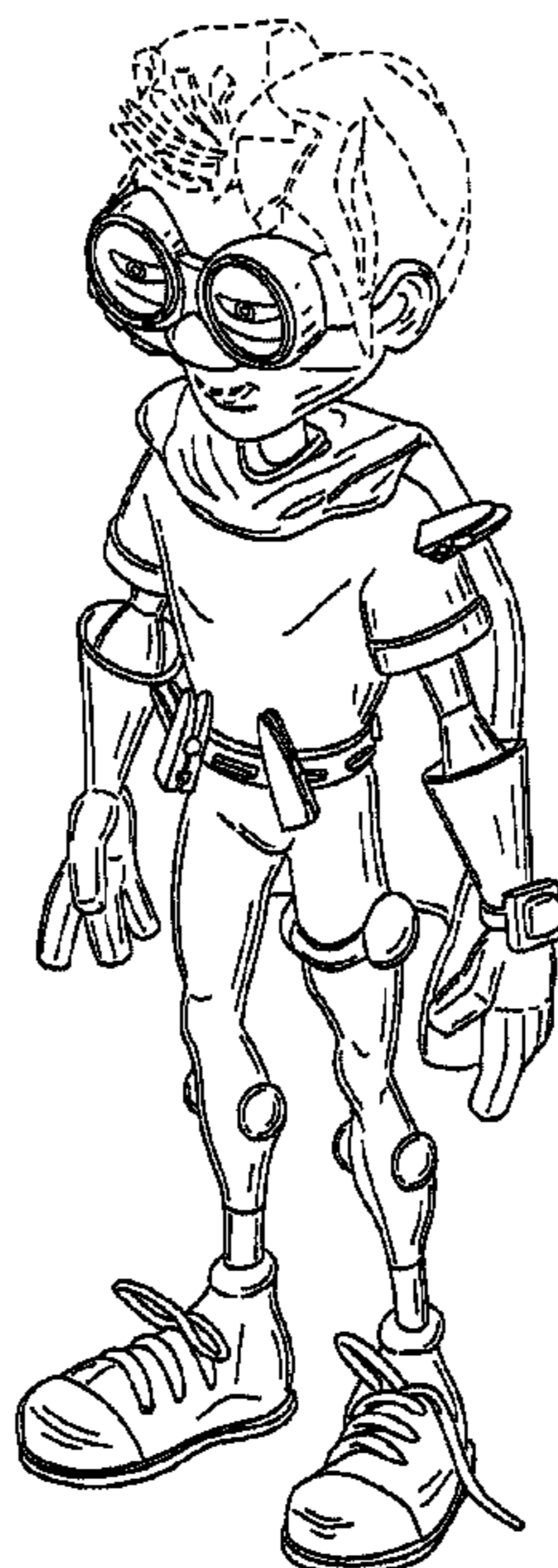
FIG. 3 is a back view of the youth fanciful character of FIG. 1;

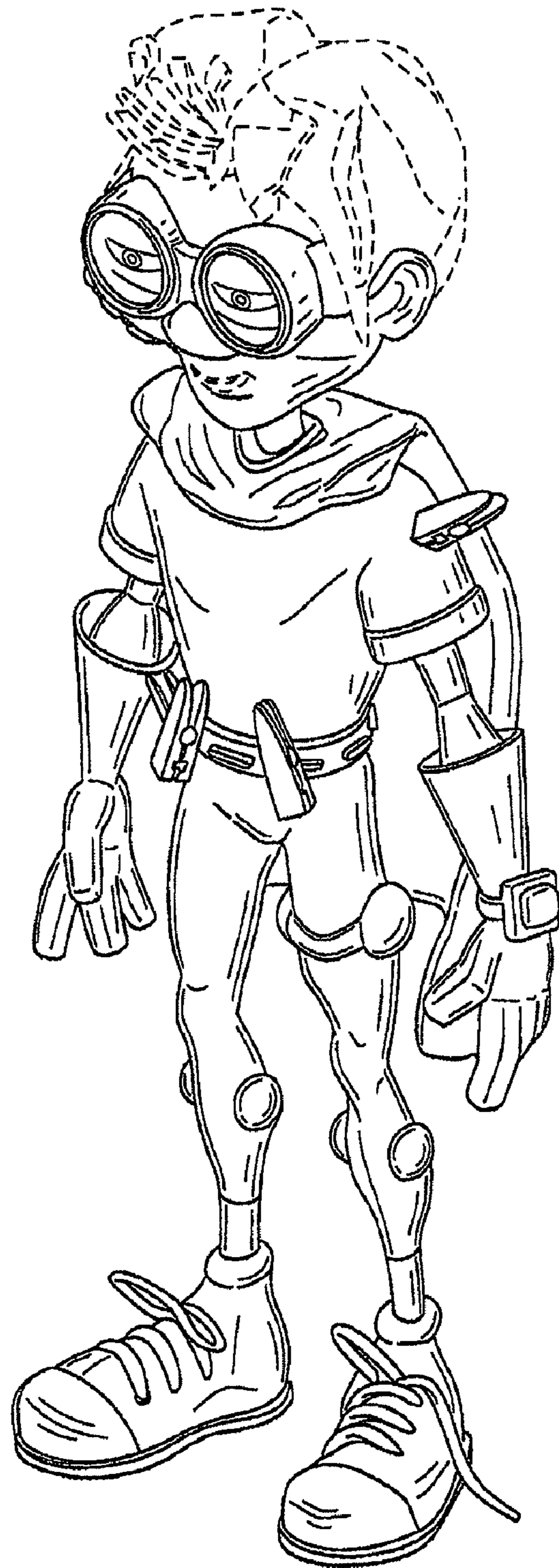

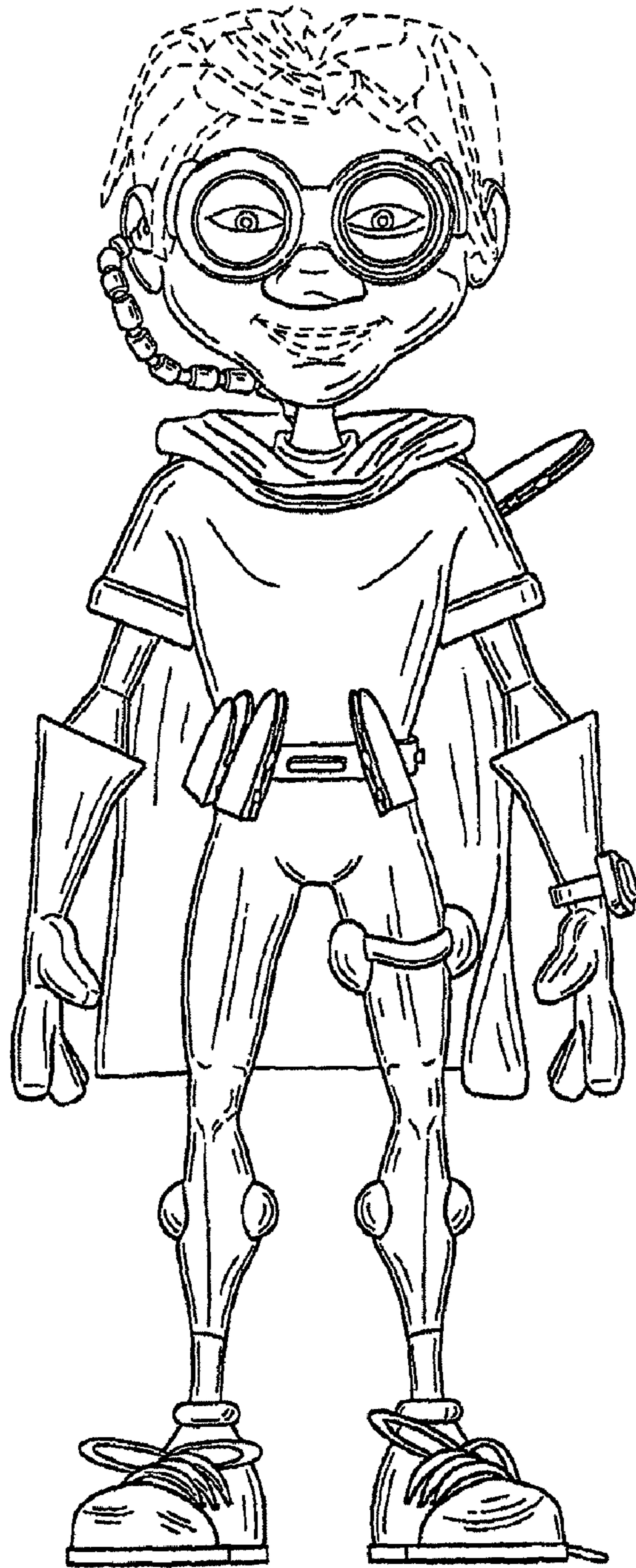

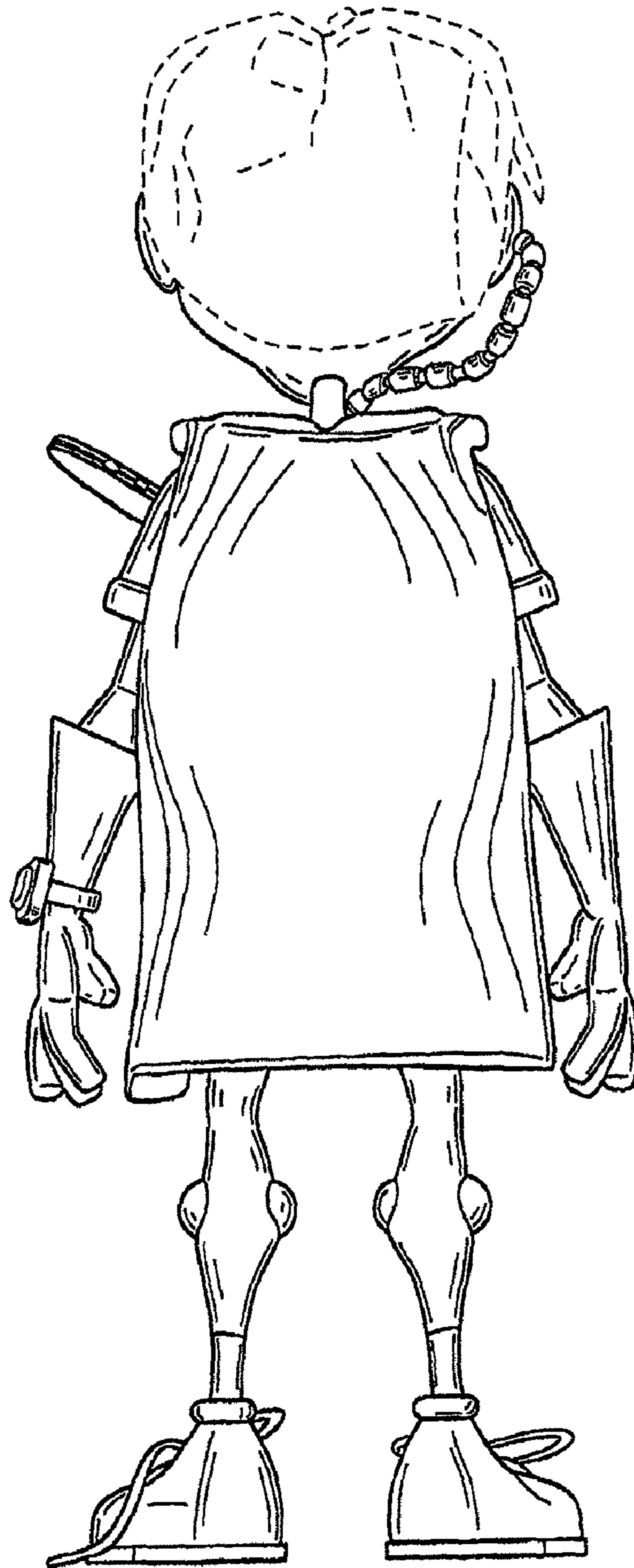

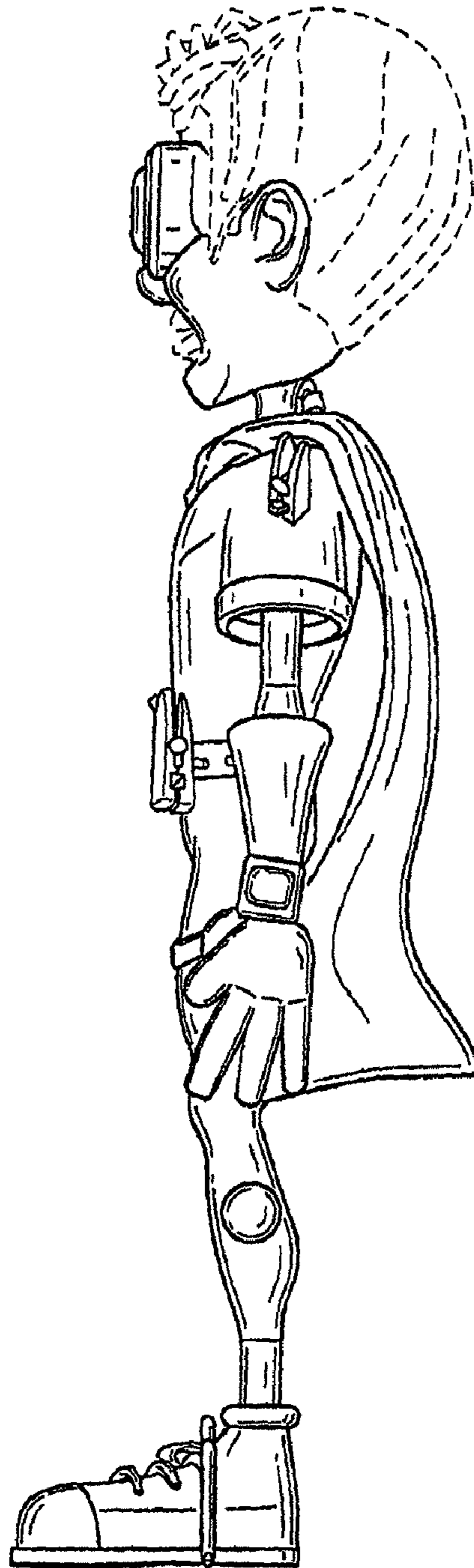

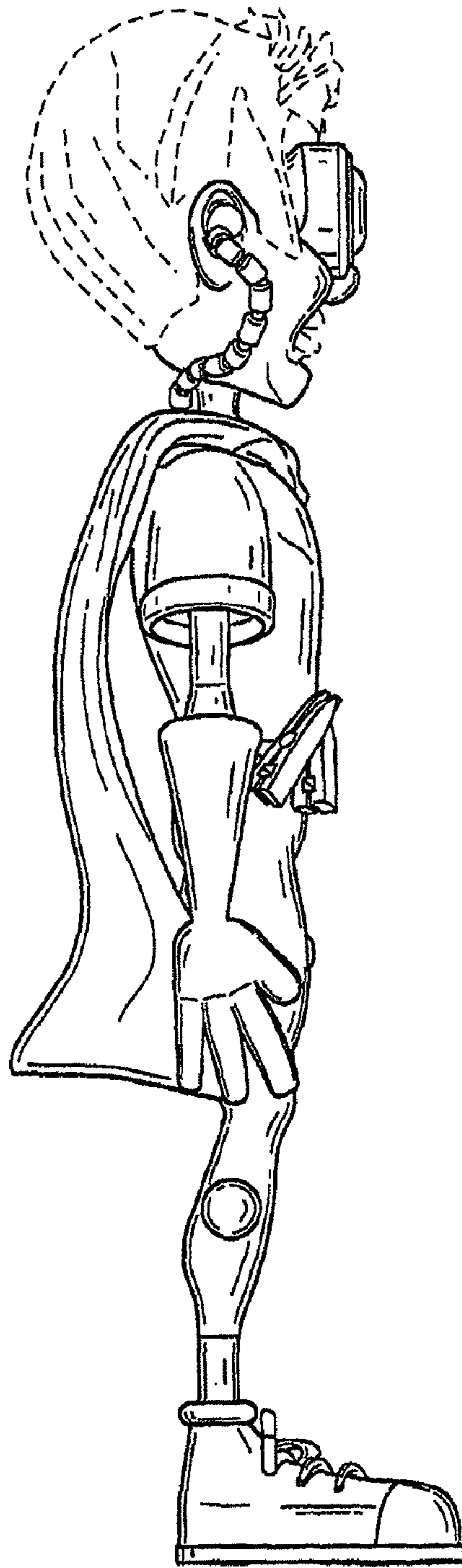
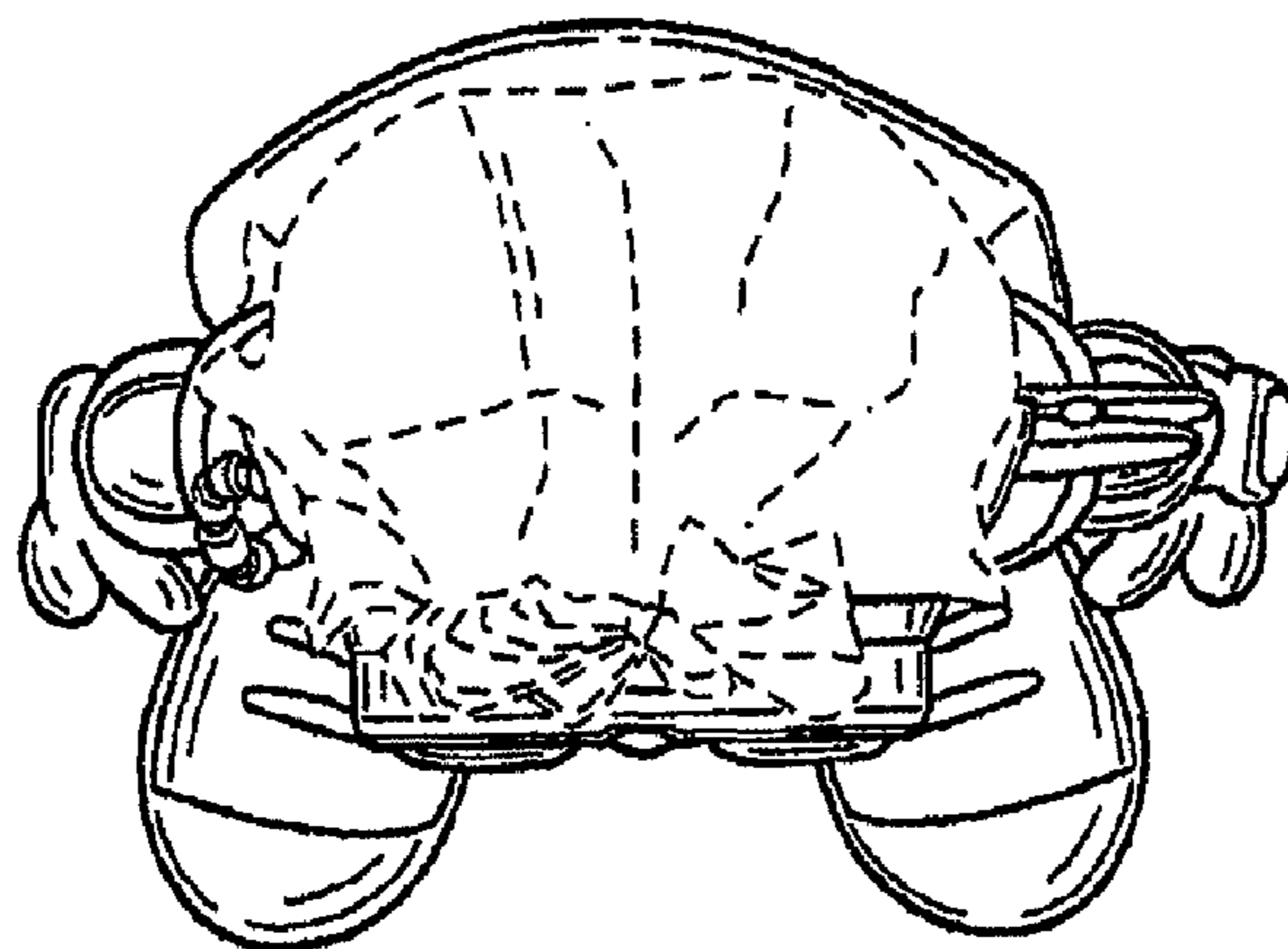
