(57) **CLAIM**

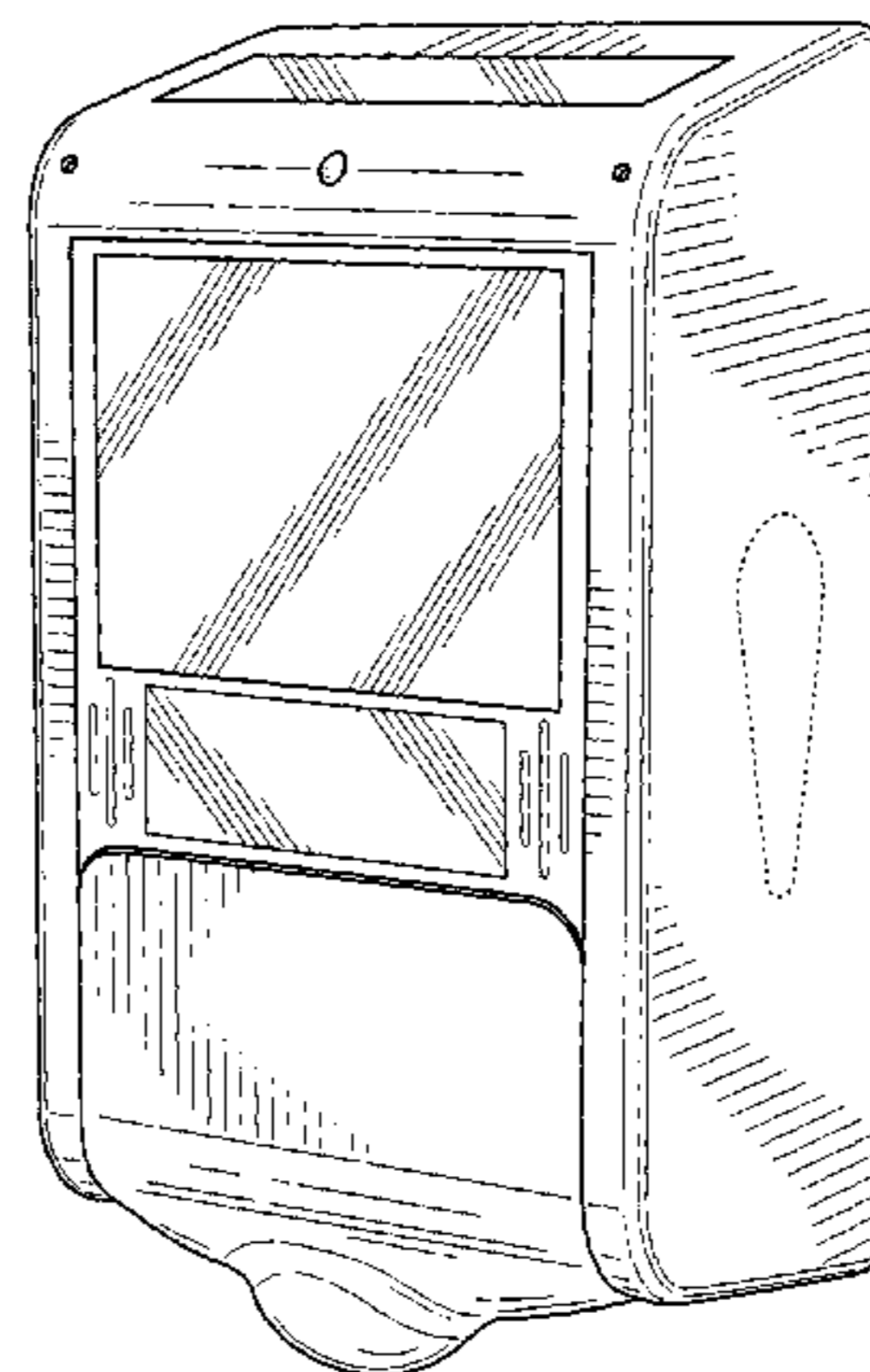
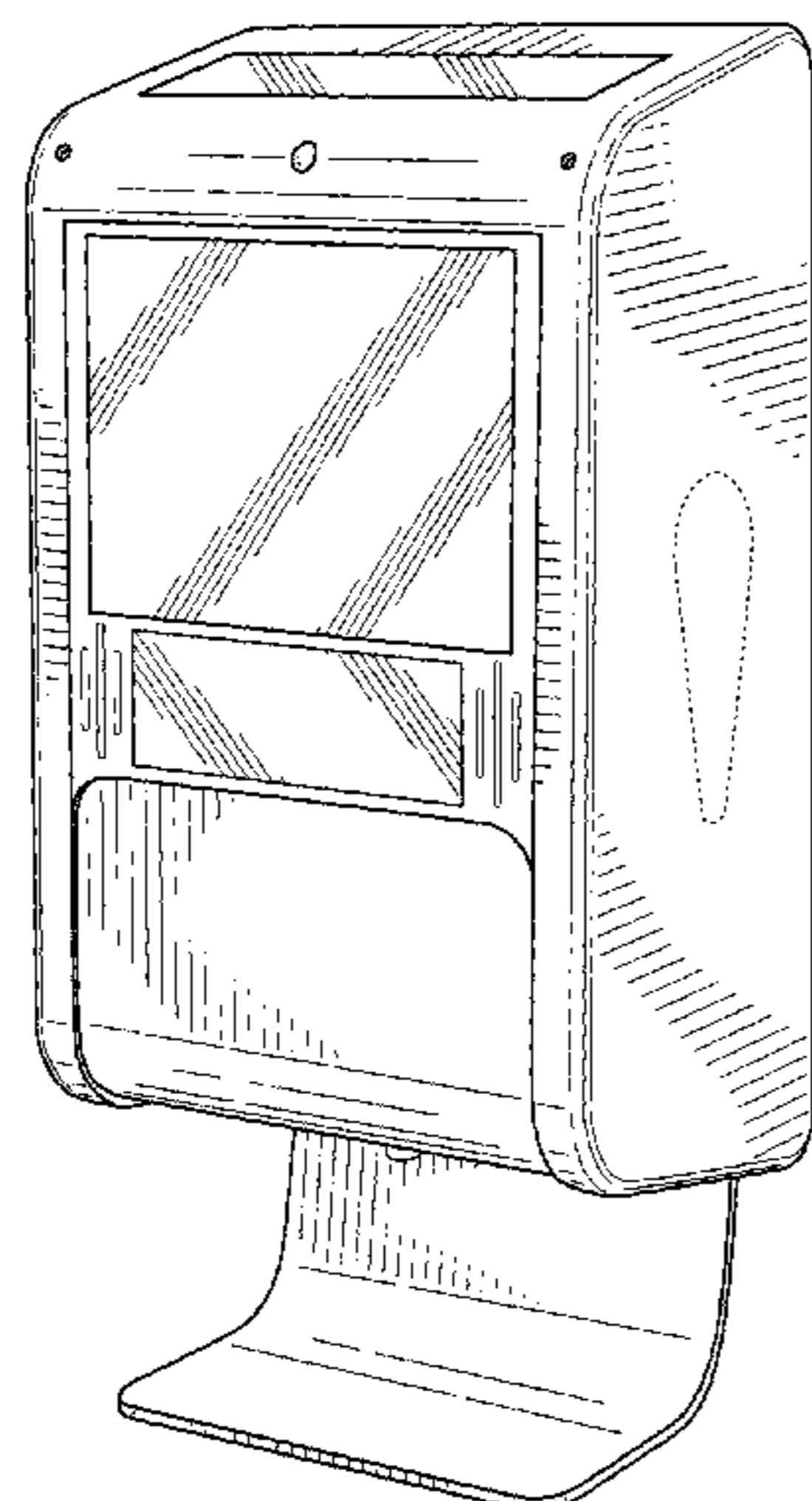
The ornamental design for an automatic dispenser for hand-sanitizing lotion, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an automatic dispenser for hand-sanitizing lotion with the lower pivotal tray in its downward, open position showing my new design;  
FIG. 2 is a perspective view thereof showing the lower pivotal tray in its upward, closed position;  
FIG. 3 is a first side elevational view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a second side elevational view thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a top view thereof; and,  
FIG. 8 is a bottom view thereof.

The broken lines are included for the purpose of illustrating portions of the automatic dispenser for hand-sanitizing lotion that form no part of the claimed design.

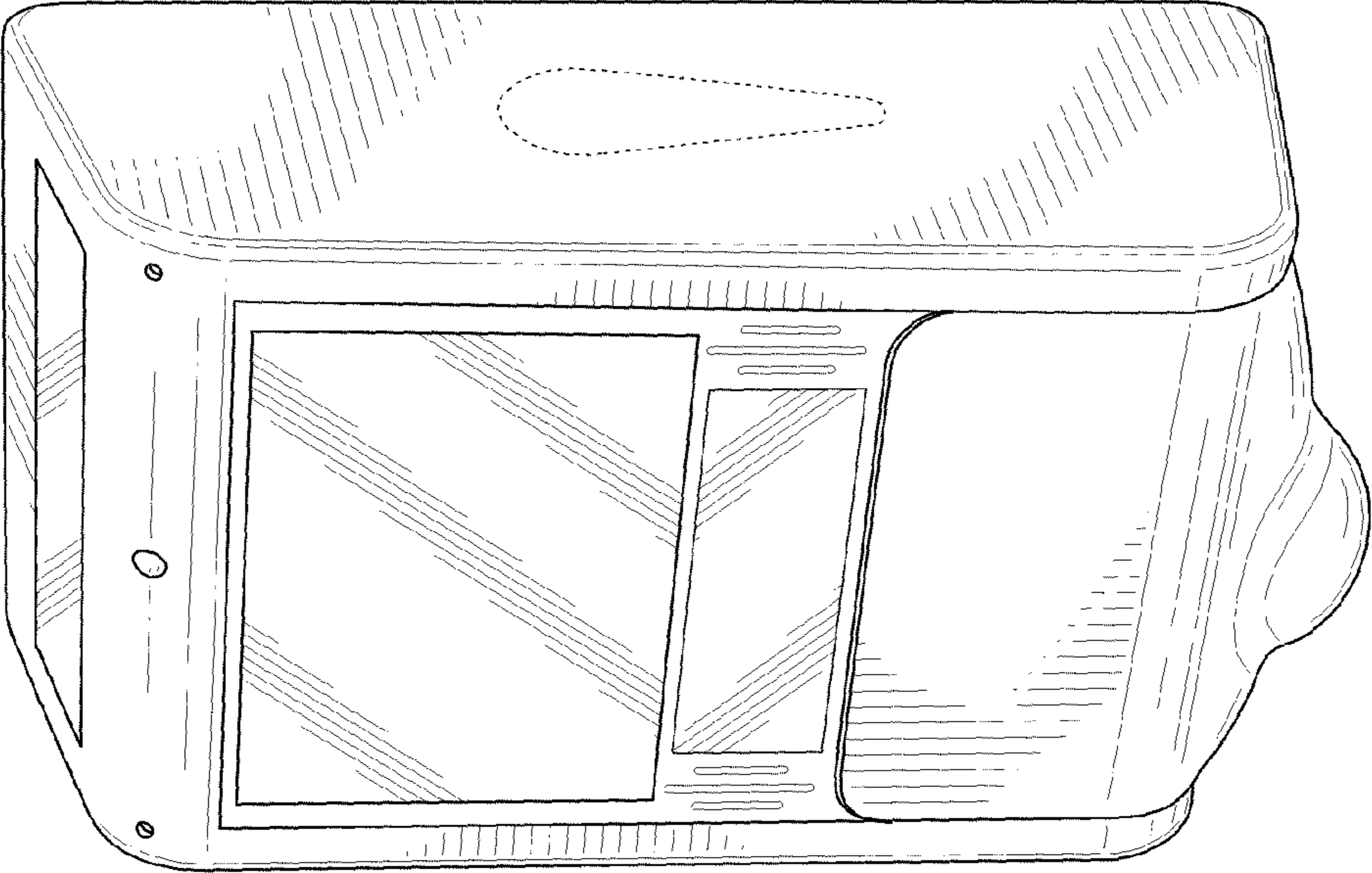

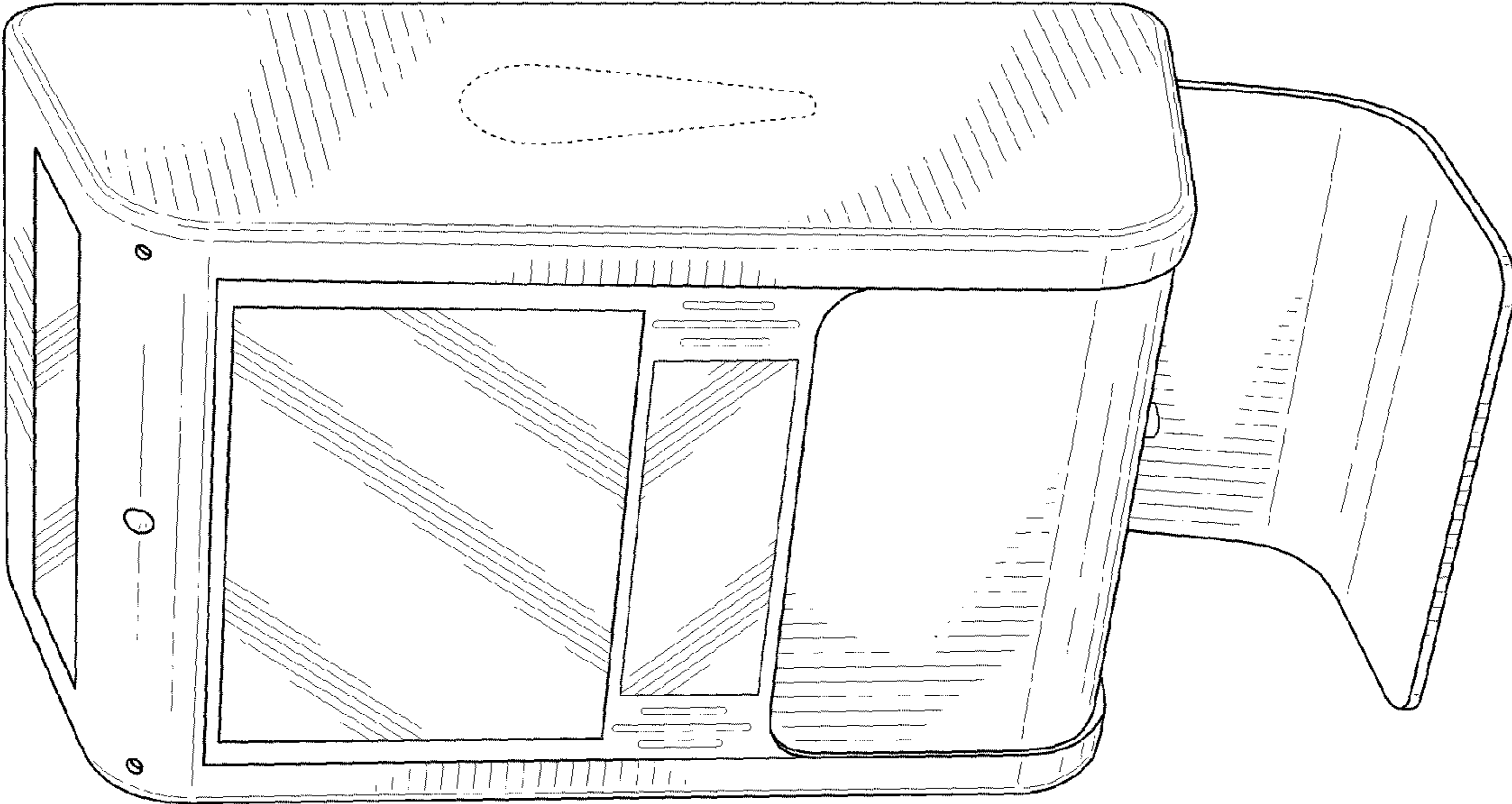
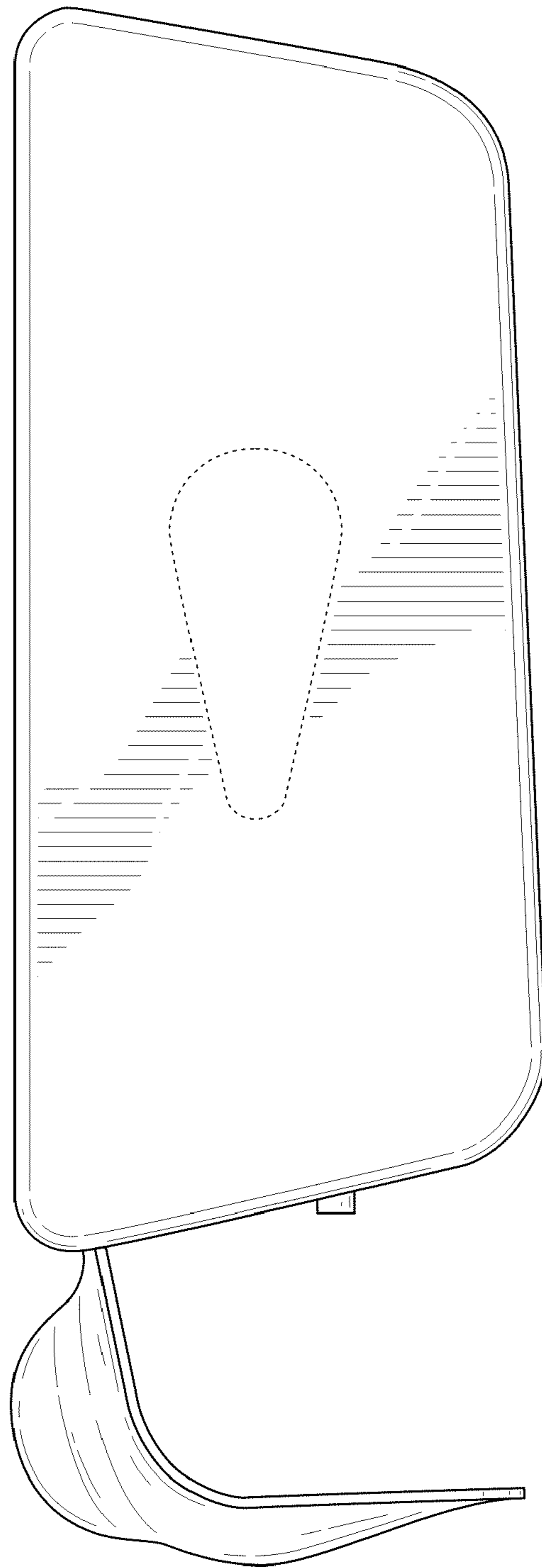
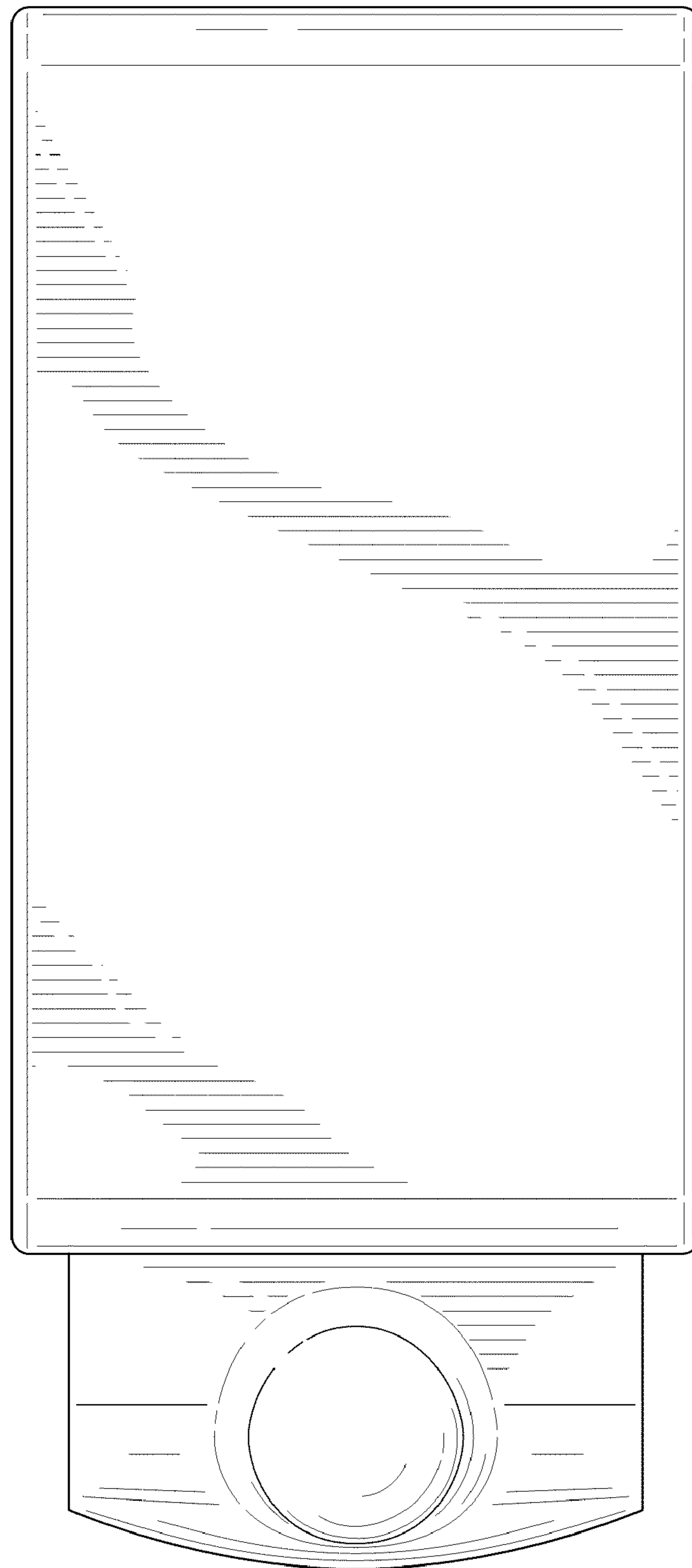


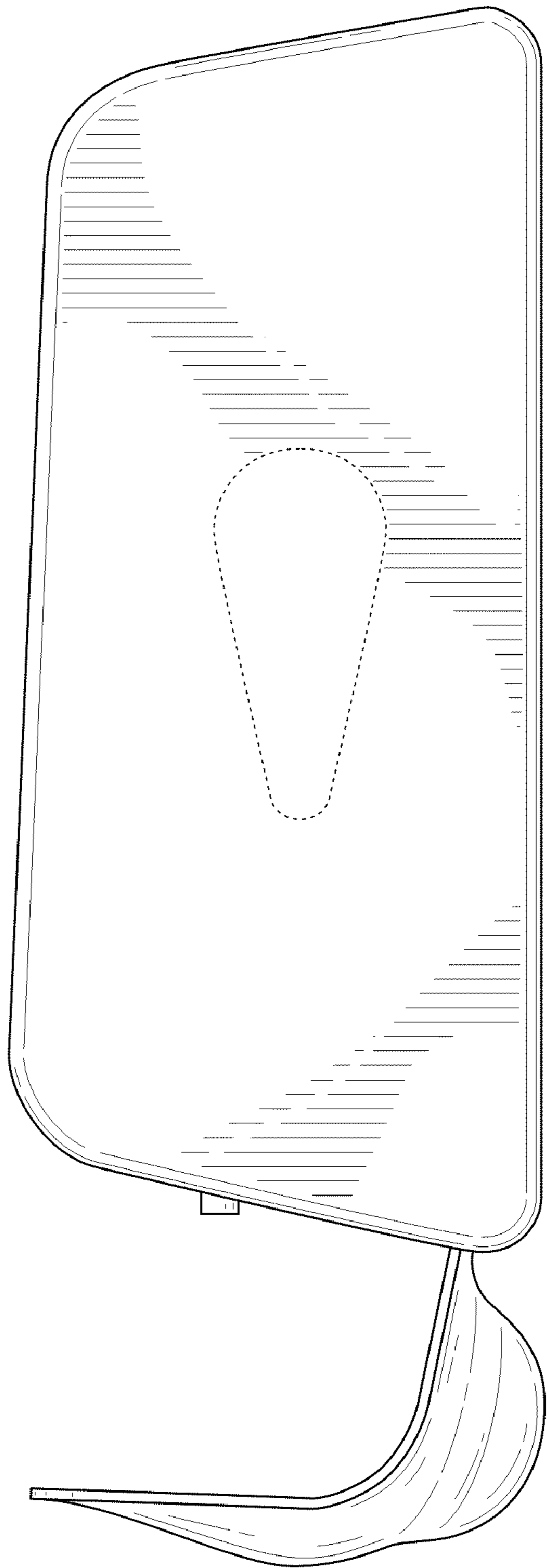

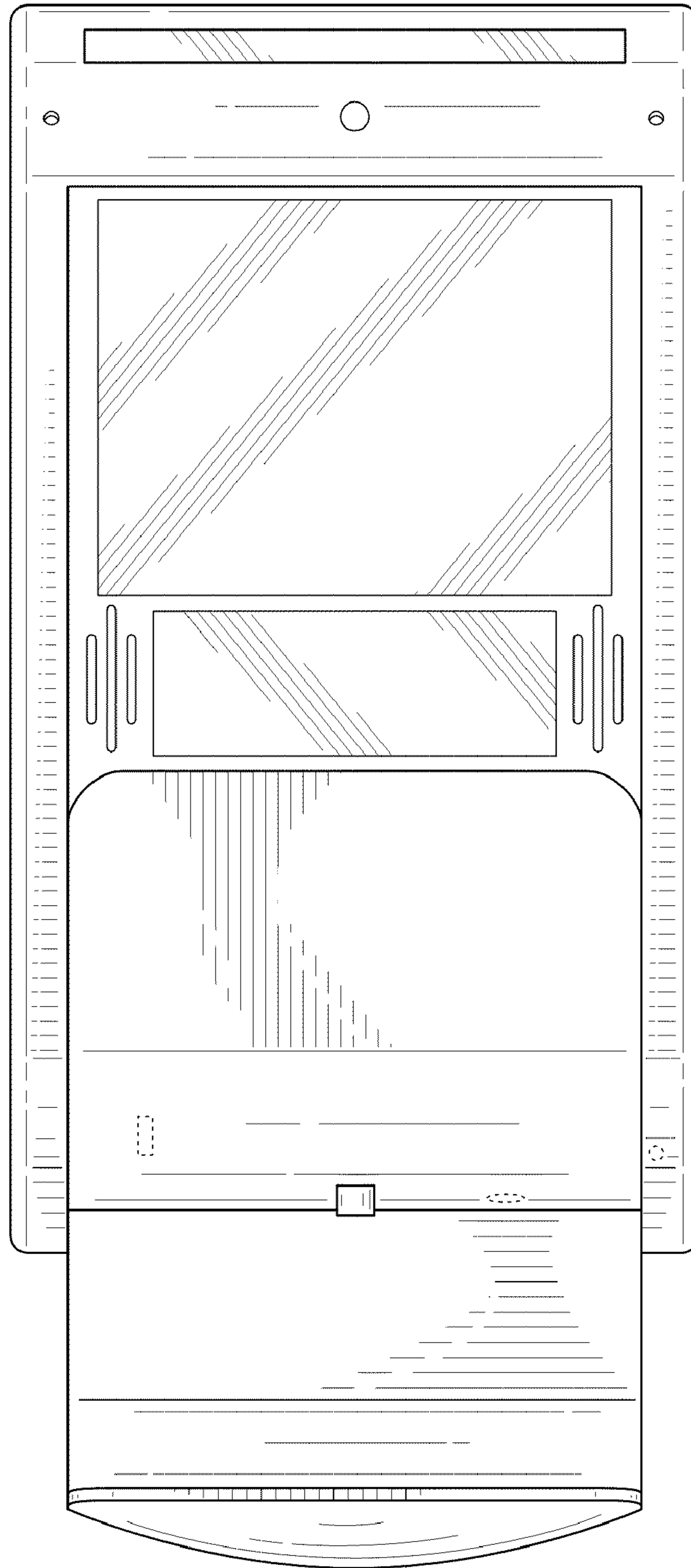
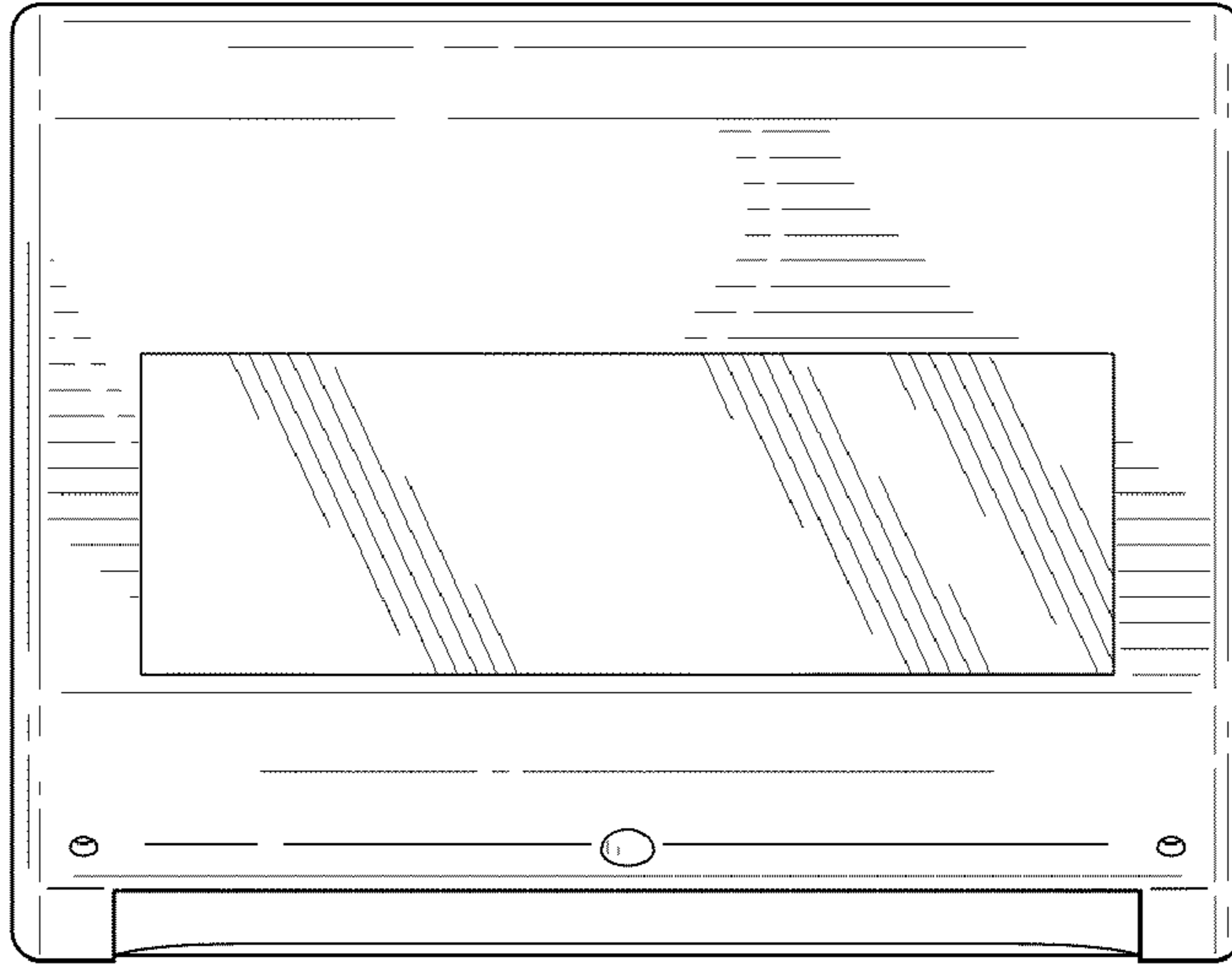
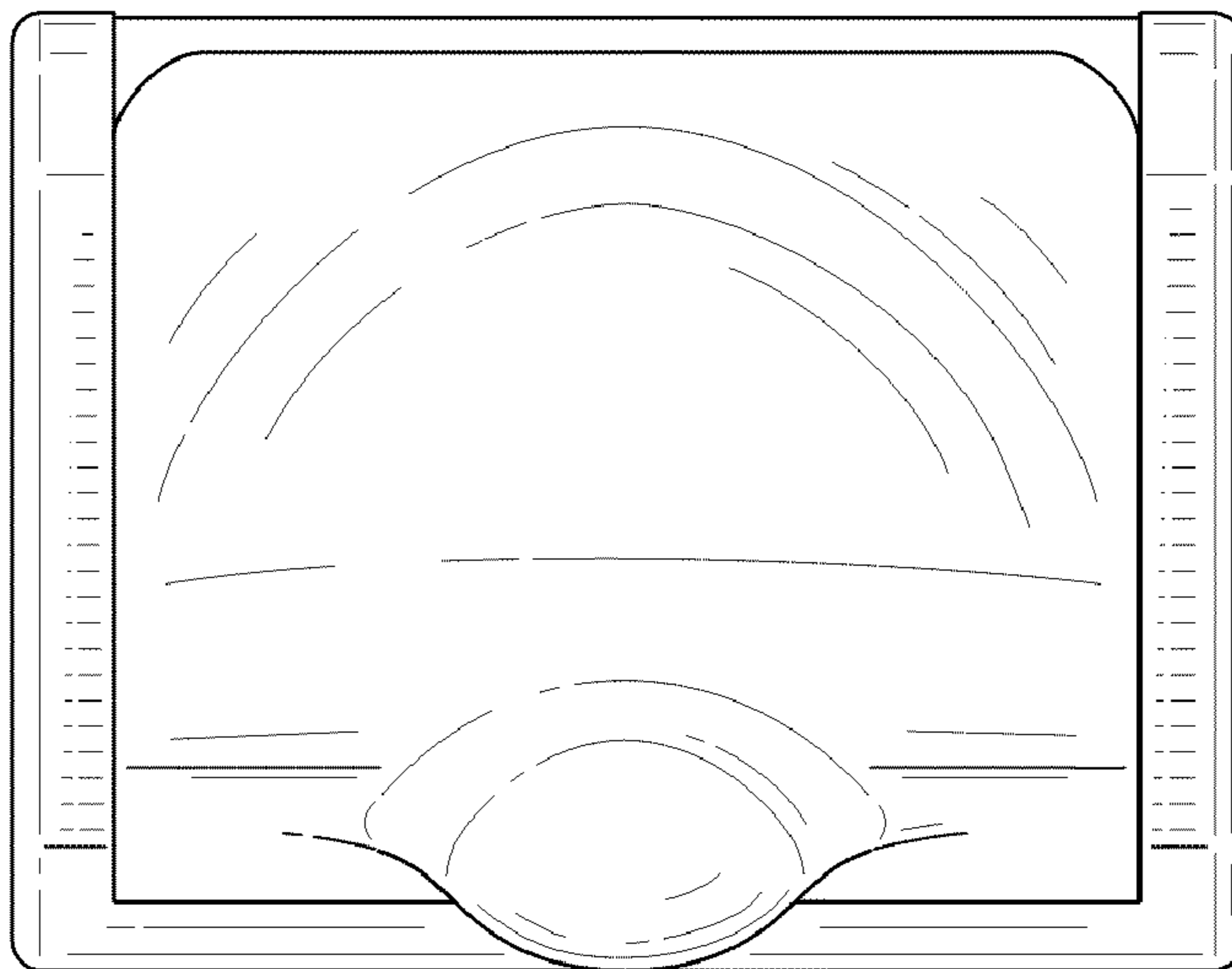
