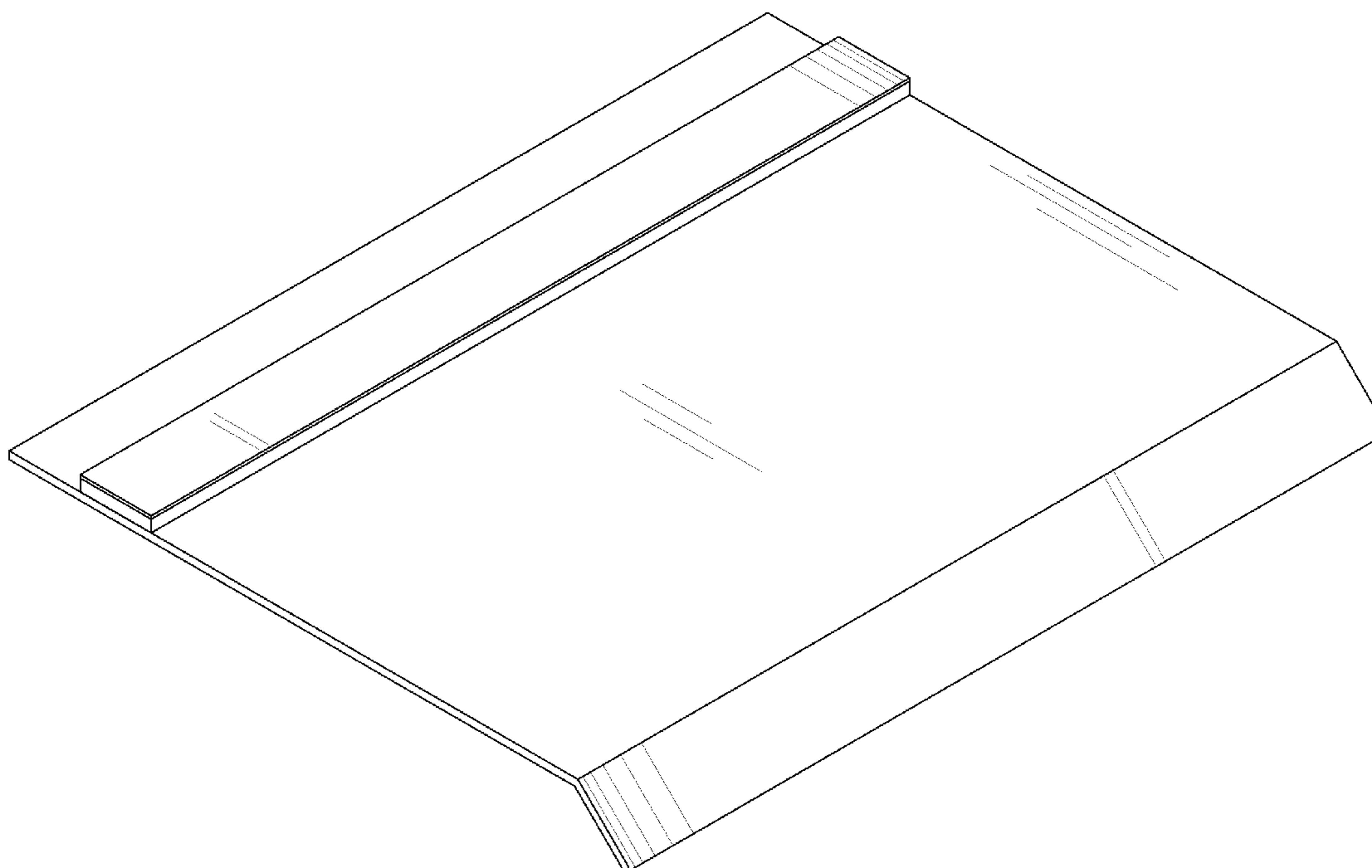

DESCRIPTION

FIG. 1 is a perspective view of a molded polymeric drip edge having an adhesive layer and a release sheet;
FIG. 2 is a top view thereof;
FIG. 3 is a left side view of the molded polymeric drip edge, the right side view being a mirror image thereof;
FIG. 4 is a front view of the molded polymeric drip edge; and,
FIG. 5 is a rear view thereof.

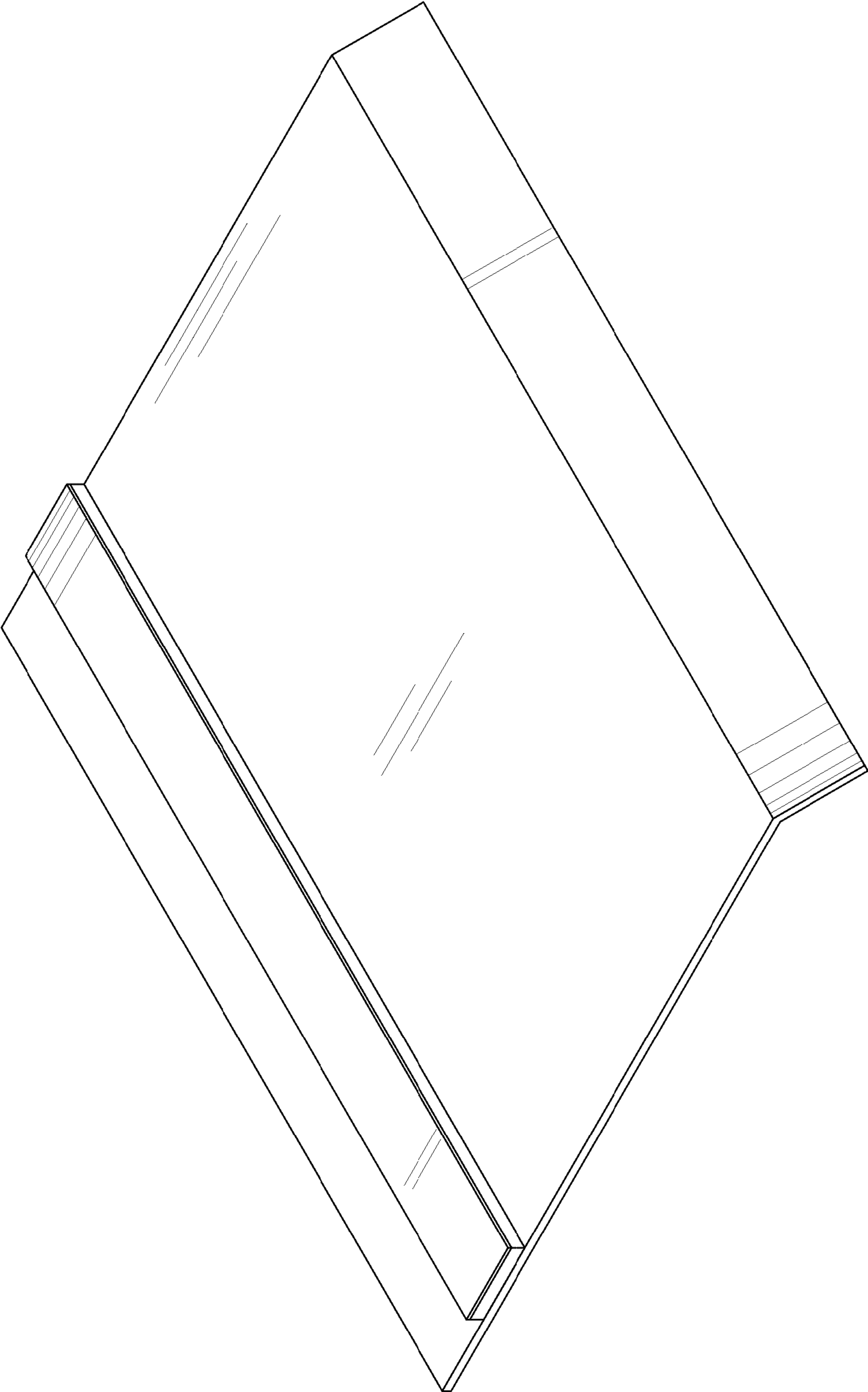

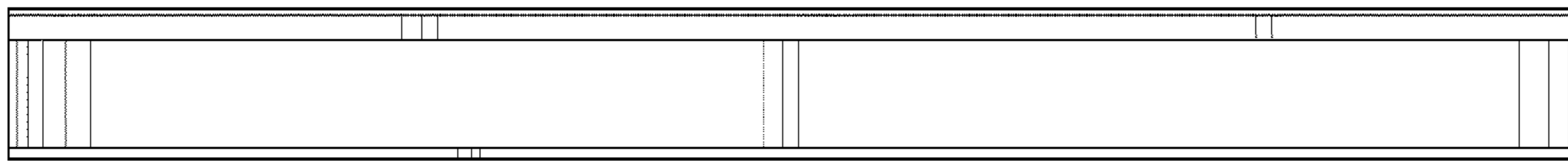
