FIG. 3 is a right side elevation view of the glove of the present invention.

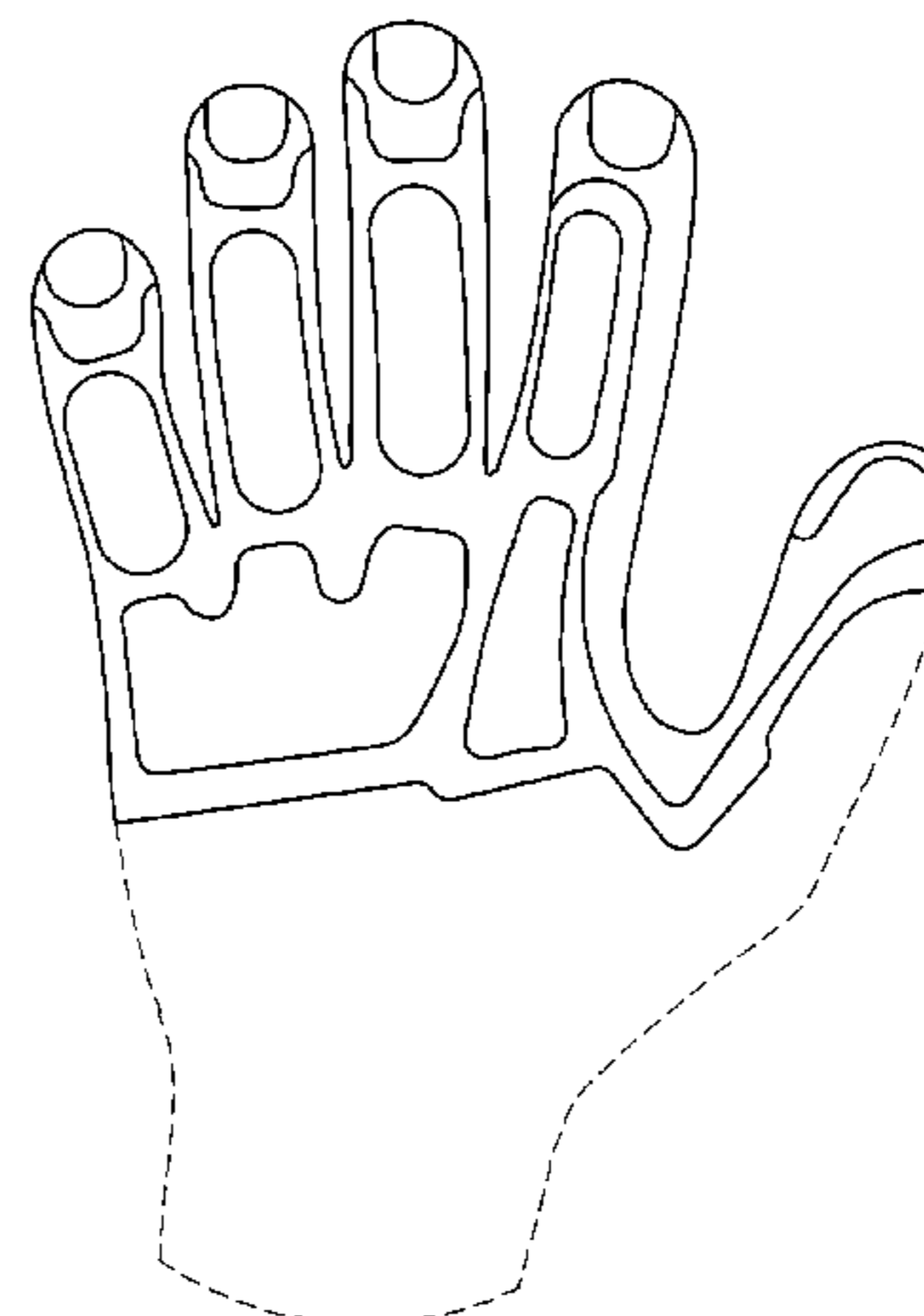
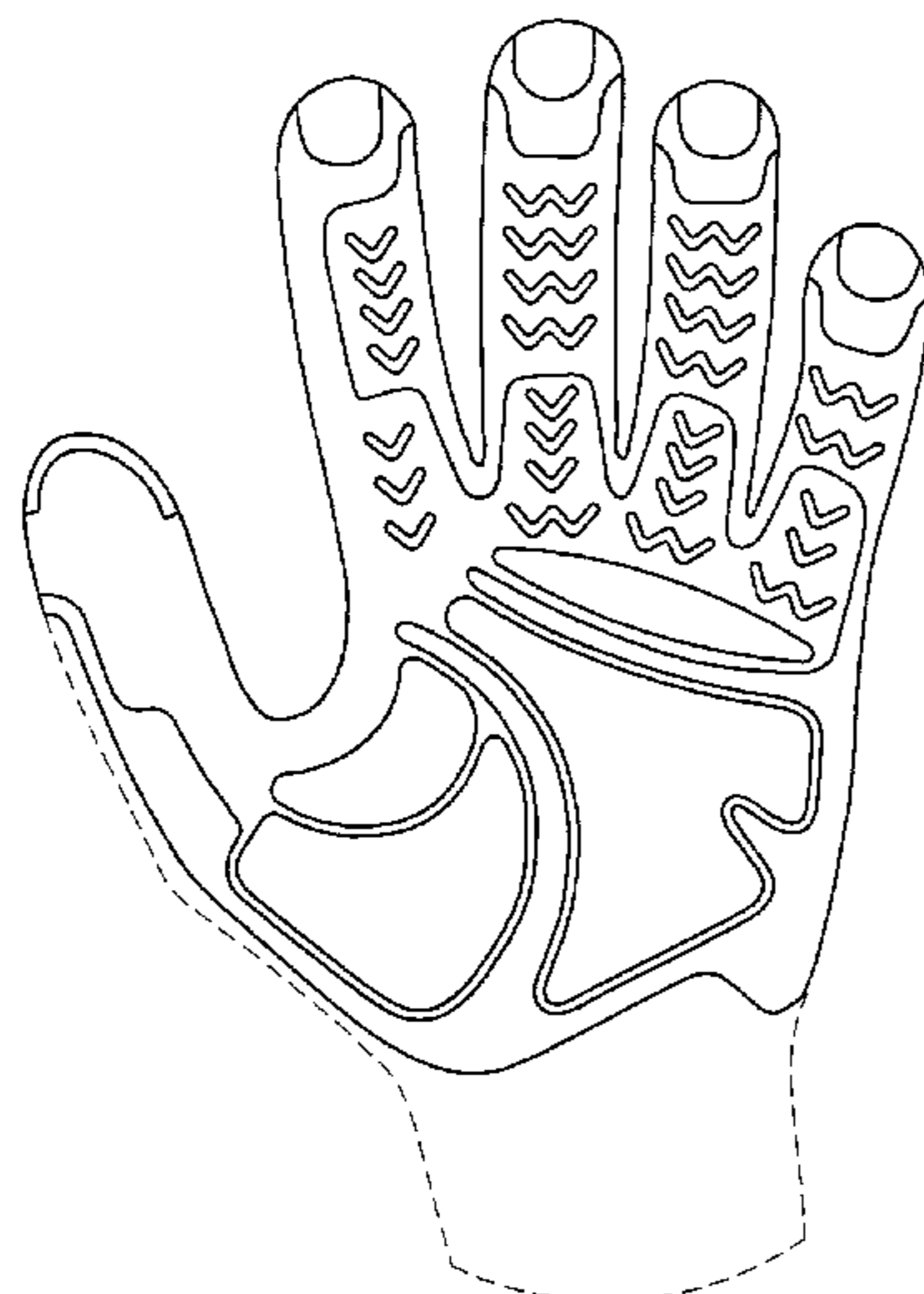
FIG. 4 is a left side elevation view of the glove of the present invention.

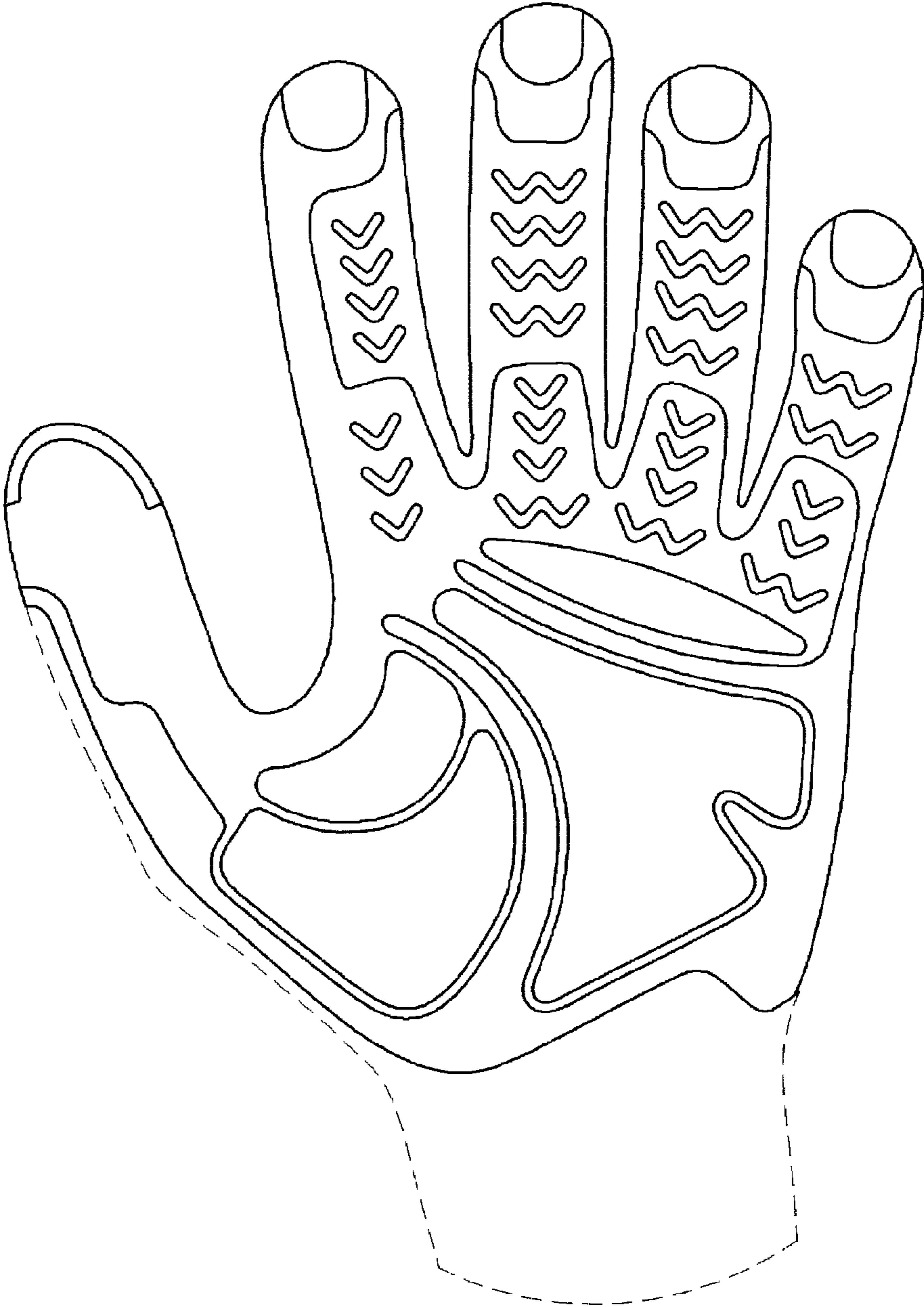

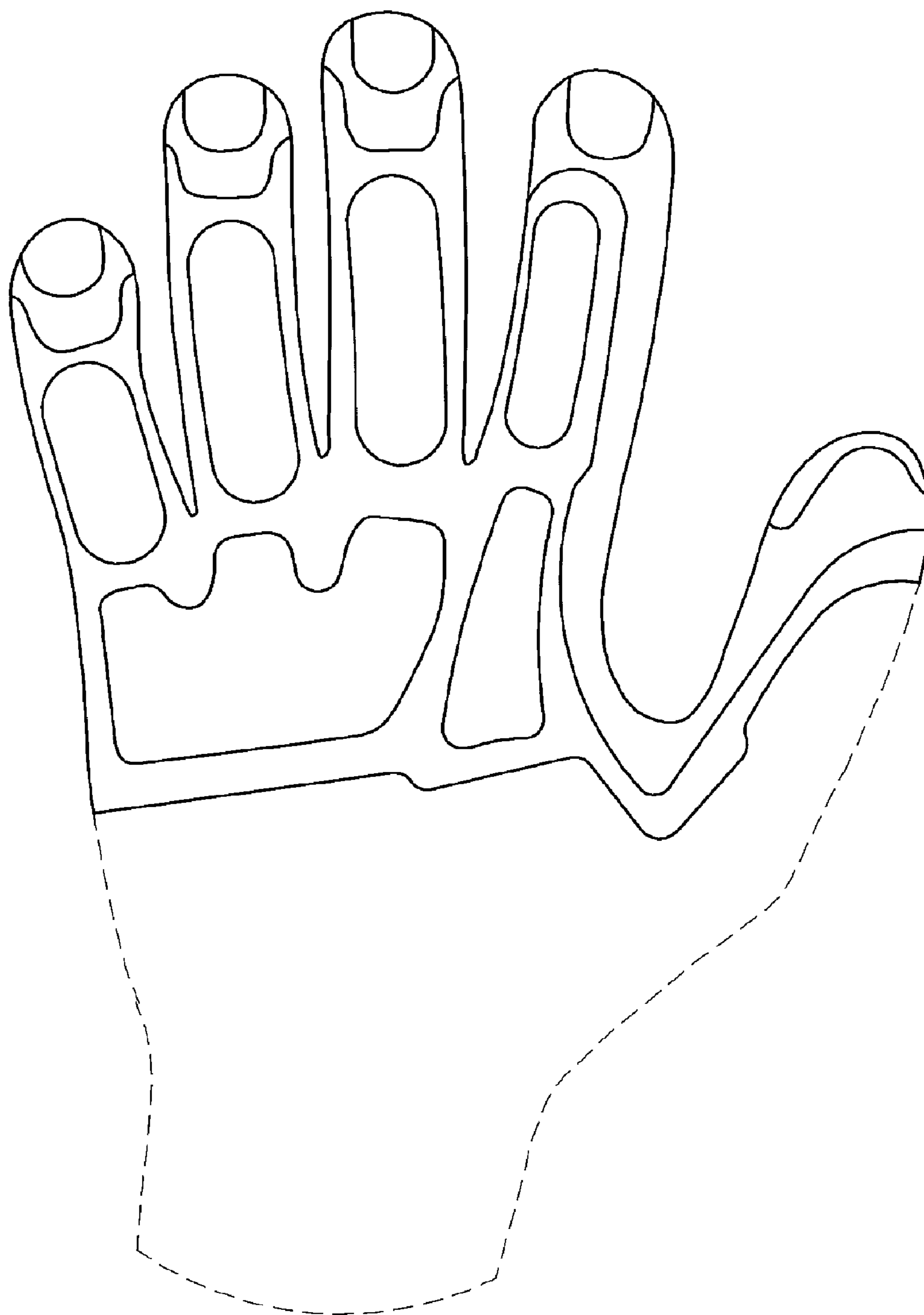

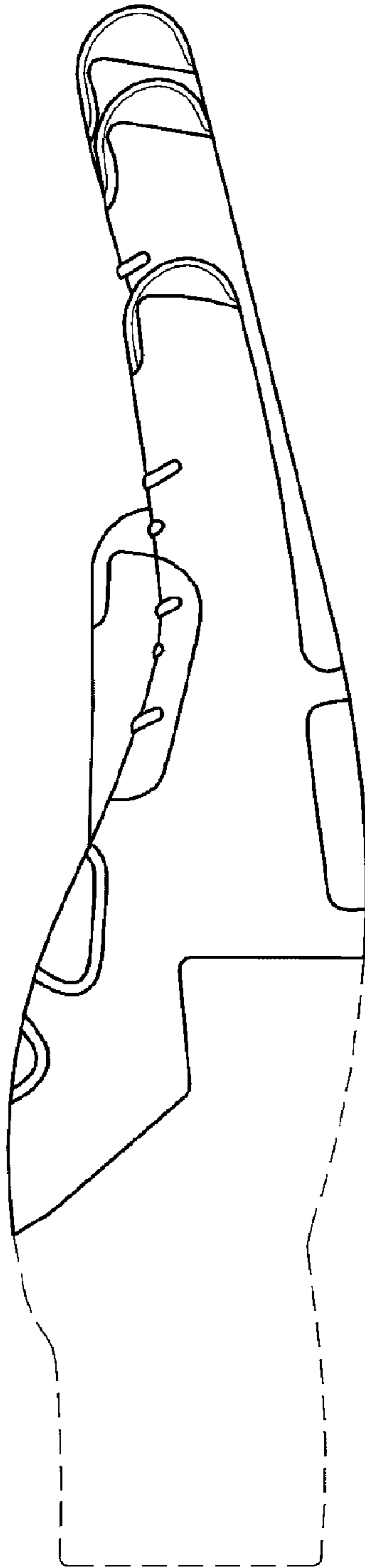

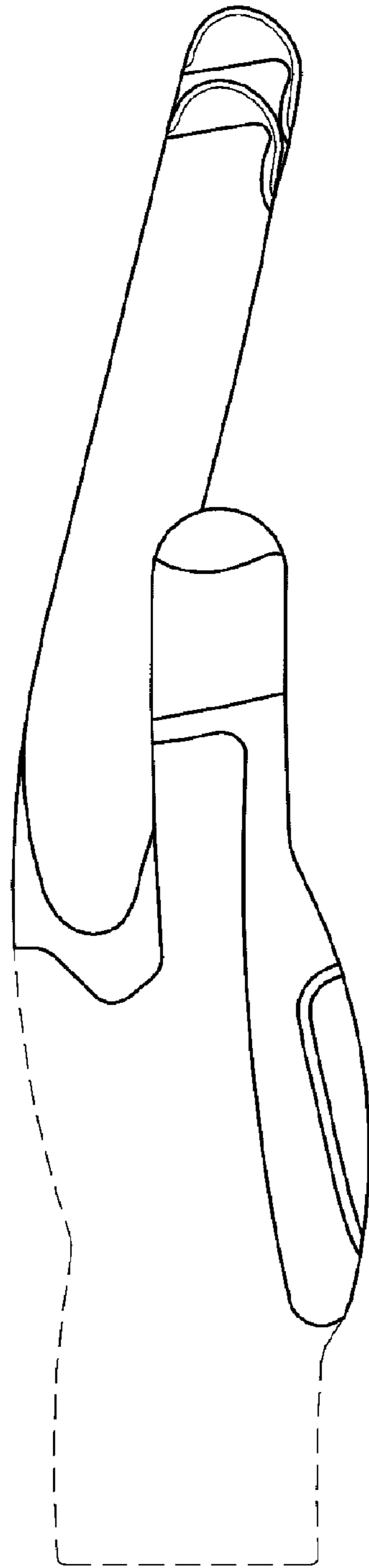

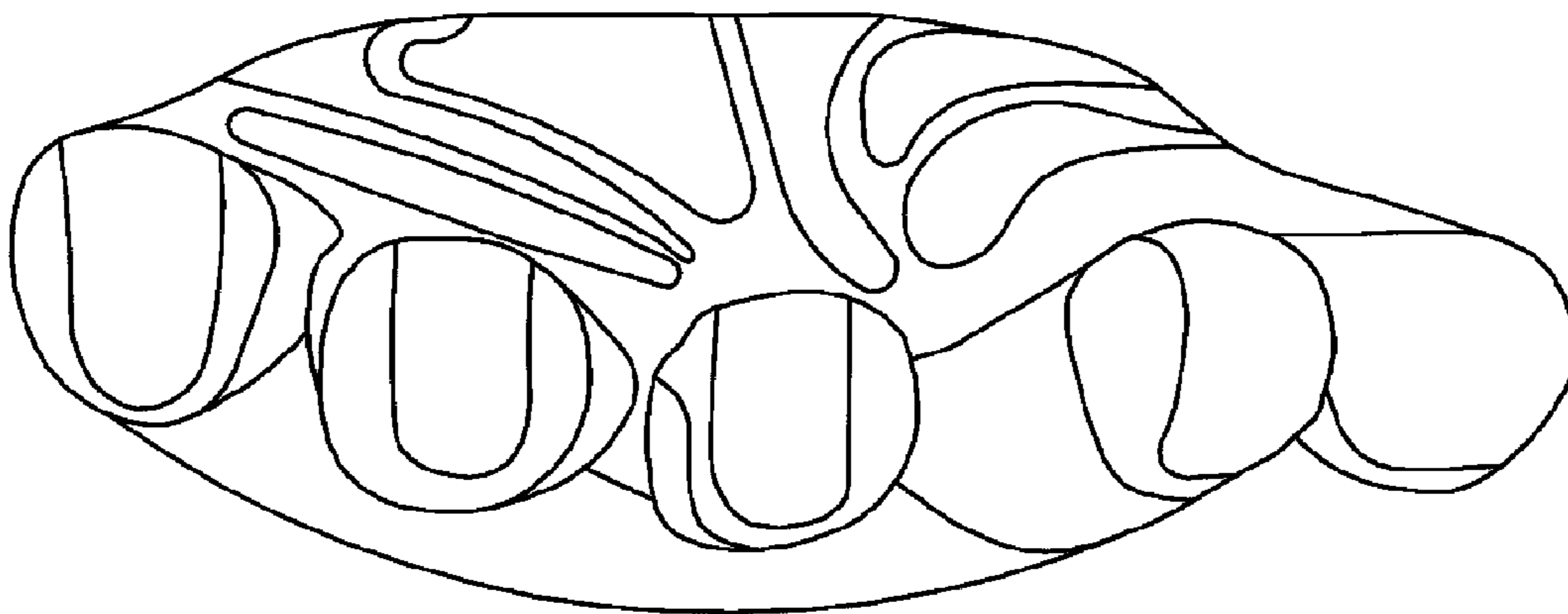

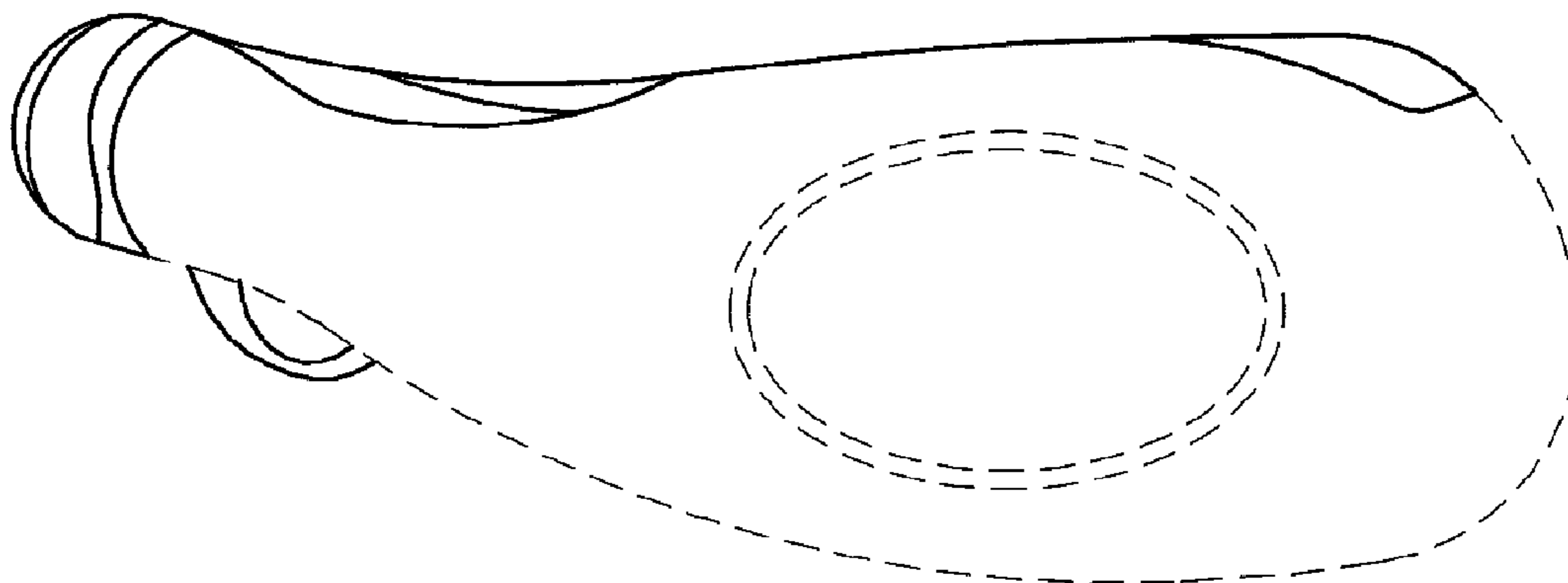
