(57) **CLAIM**

I claim an ornamental design for apparel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of apparel having a plurality of zippers running a substantial portion of the length from the bottom of the apparel toward the shoulder area of the apparel; FIG. 2 is a front view of the claimed design of FIG. 1; FIG. 3 is a front view of the claimed design of FIG. 1, wherein the zippers are shown partially open; FIG. 4 is a front view of the claimed design of FIG. 1, wherein the zippers are shown open; FIG. 5 is a back view of the claimed design of FIG. 1; FIG. 6 is a back view of the claimed design of FIG. 1, wherein the zippers are open; FIG. 7 is a top view of the claimed design of FIG. 1; FIG. 8 is a bottom view of the claimed design of FIG. 1; FIG. 9 is a right side view of the claimed design of FIG. 1; and, FIG. 10 is a left side view of the claimed design of FIG. 1. The broken lines, throughout the views, show the portions of the apparel that form no part of the claimed design.

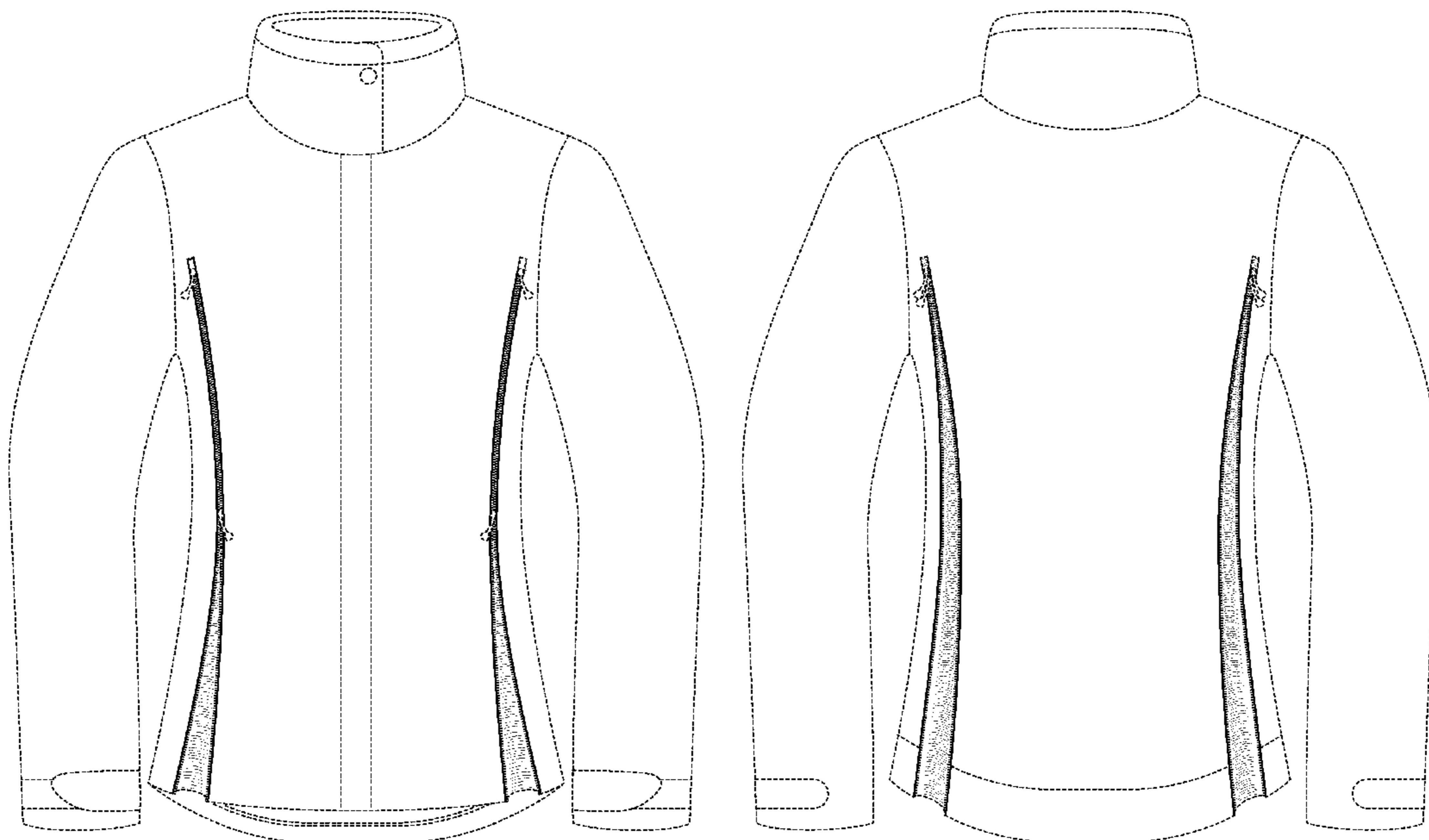

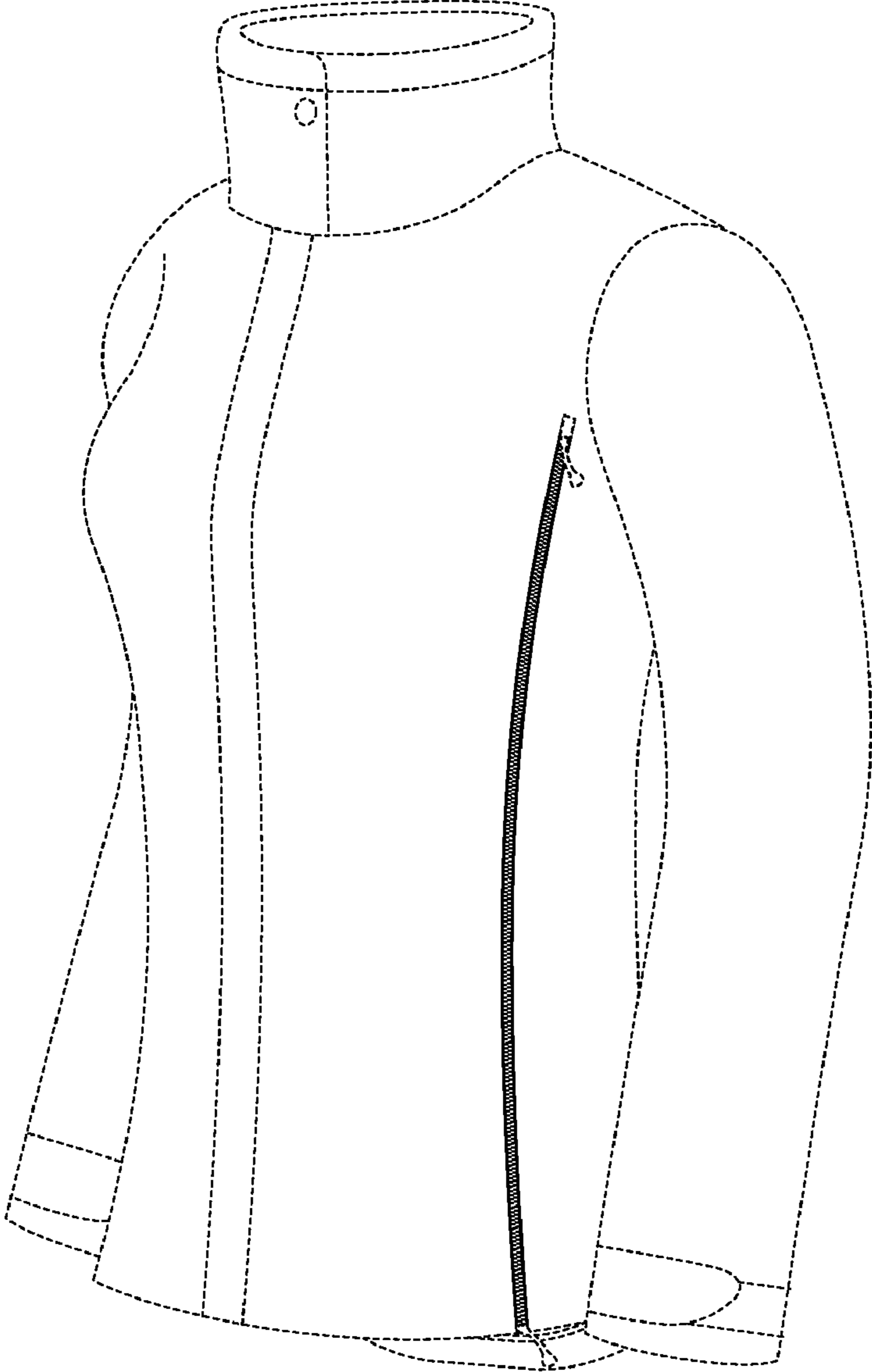

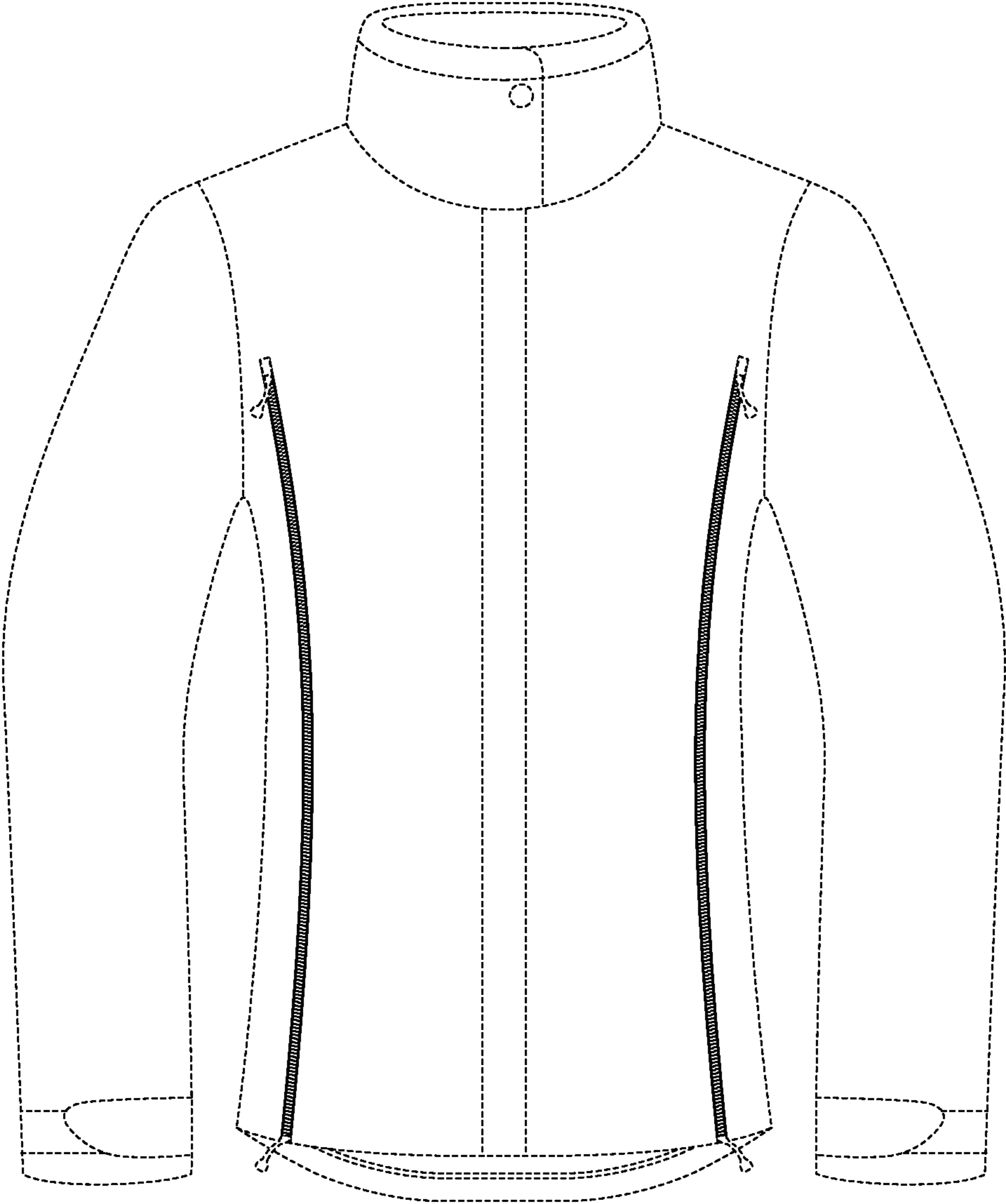

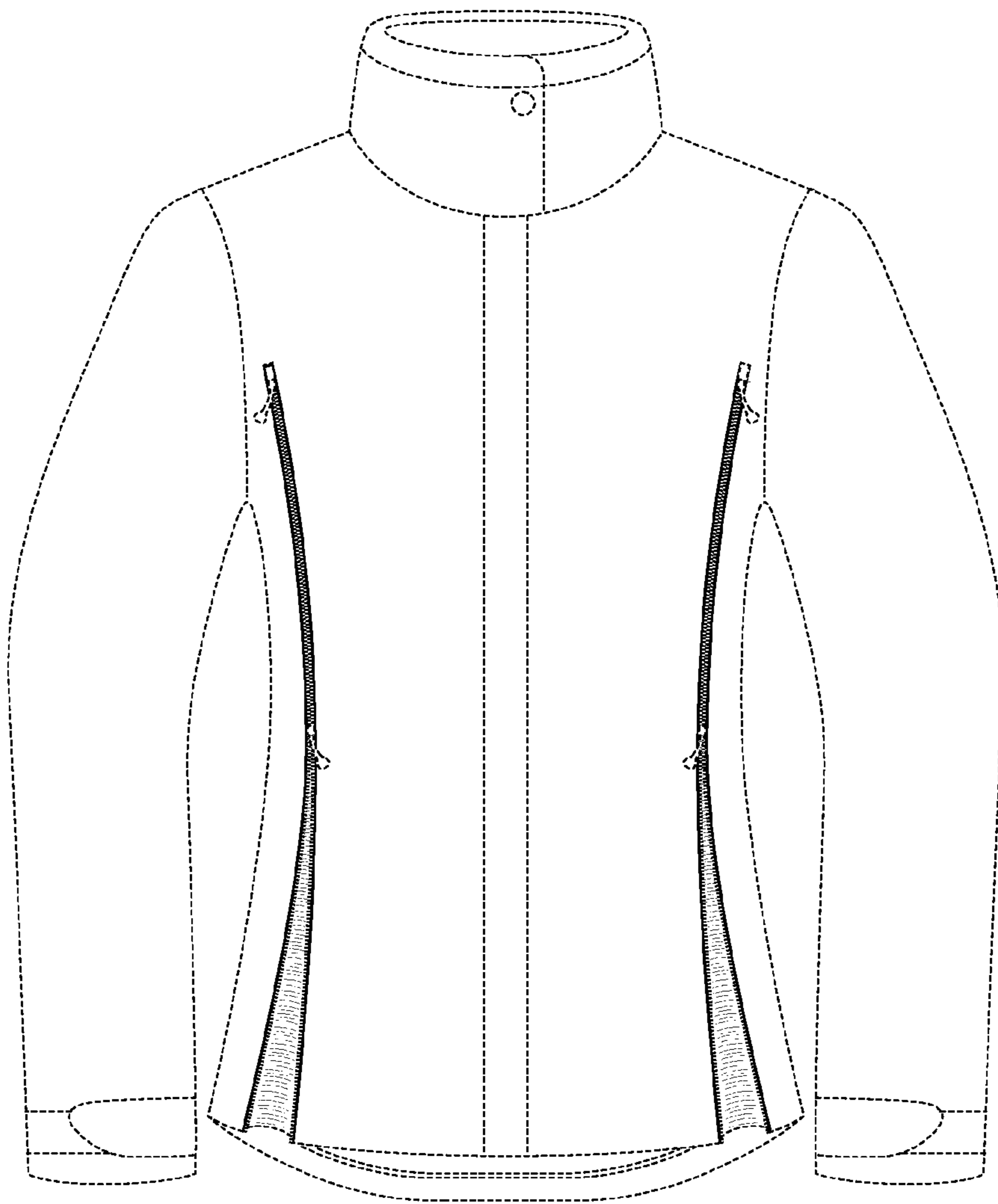

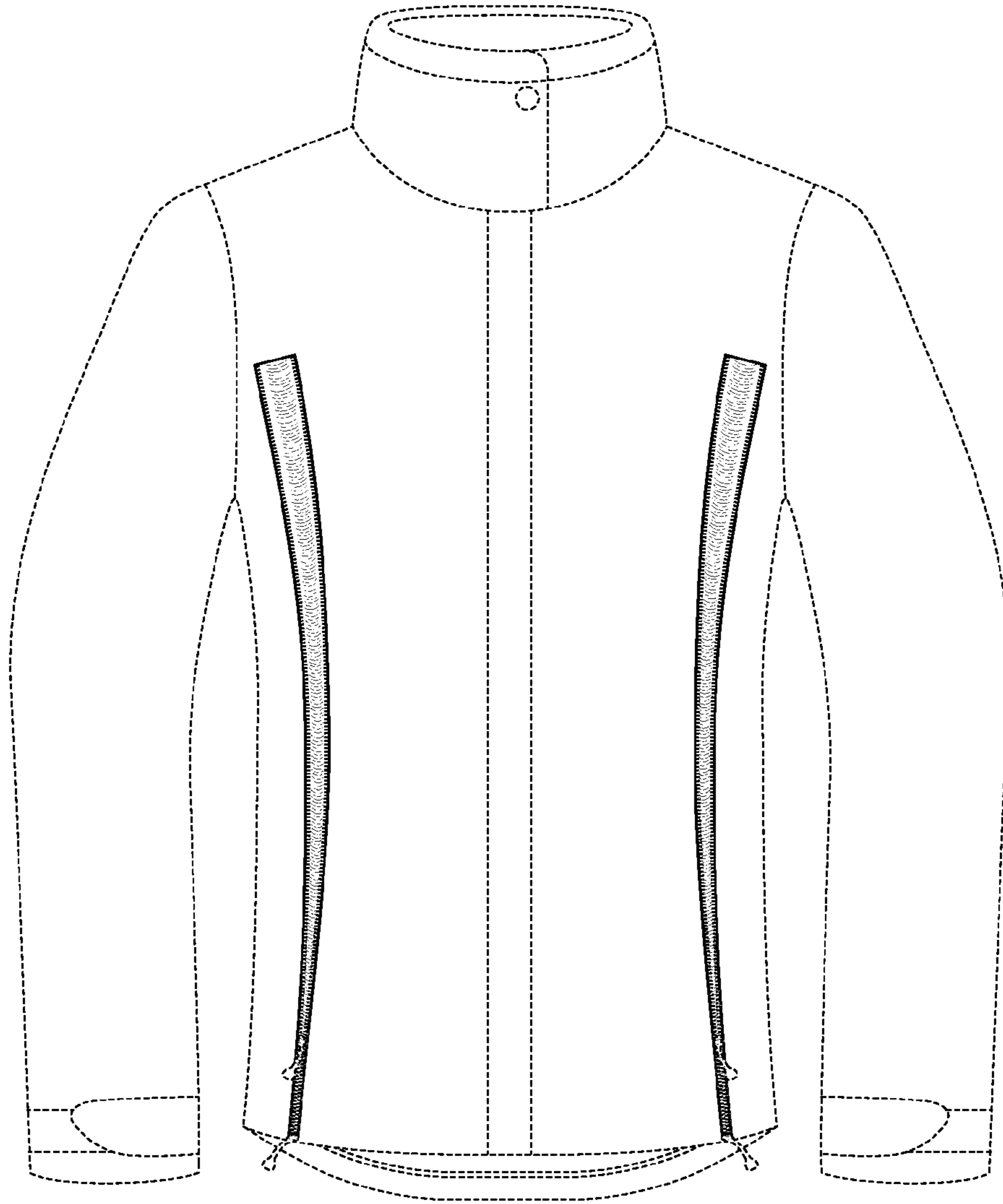

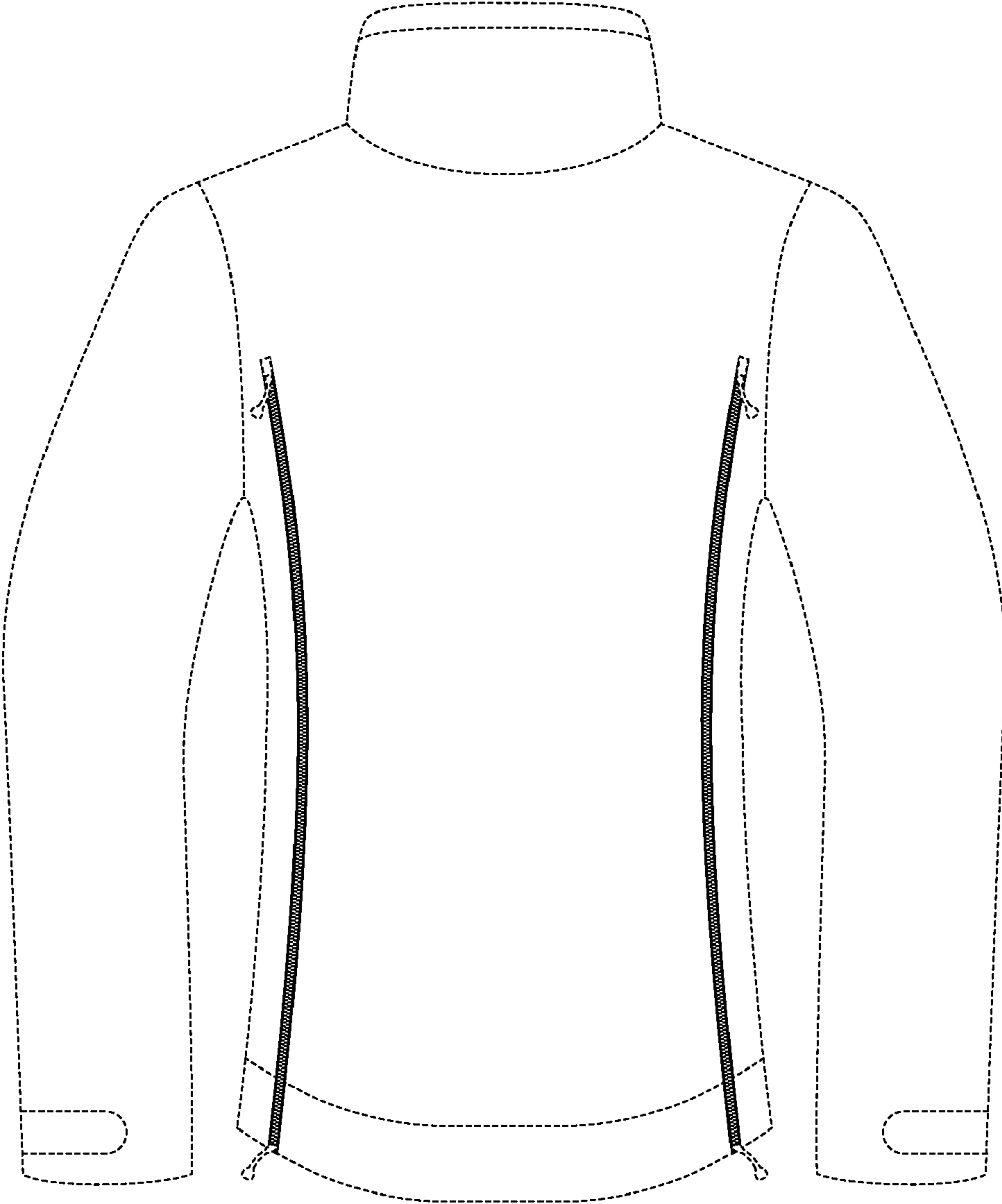

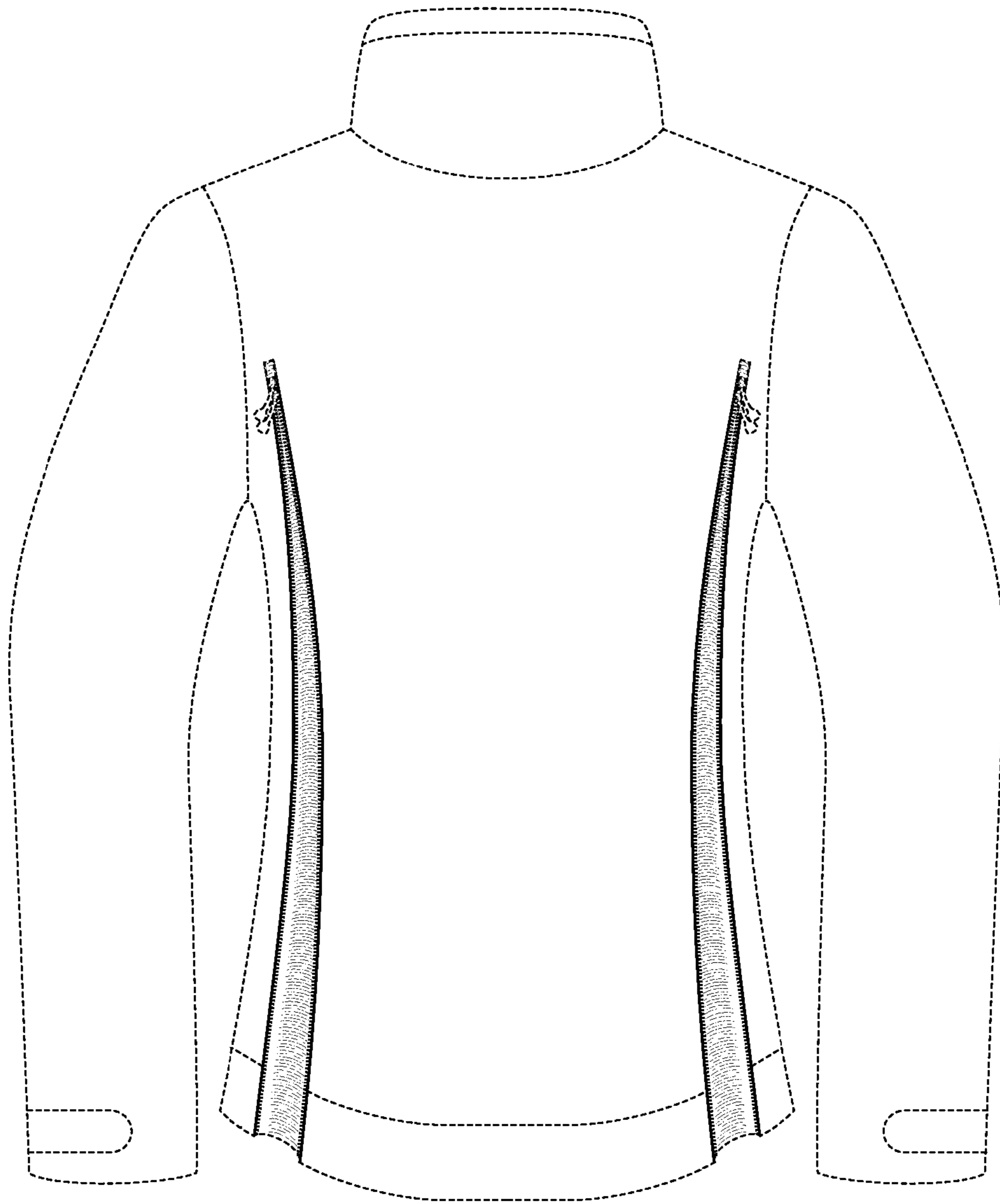

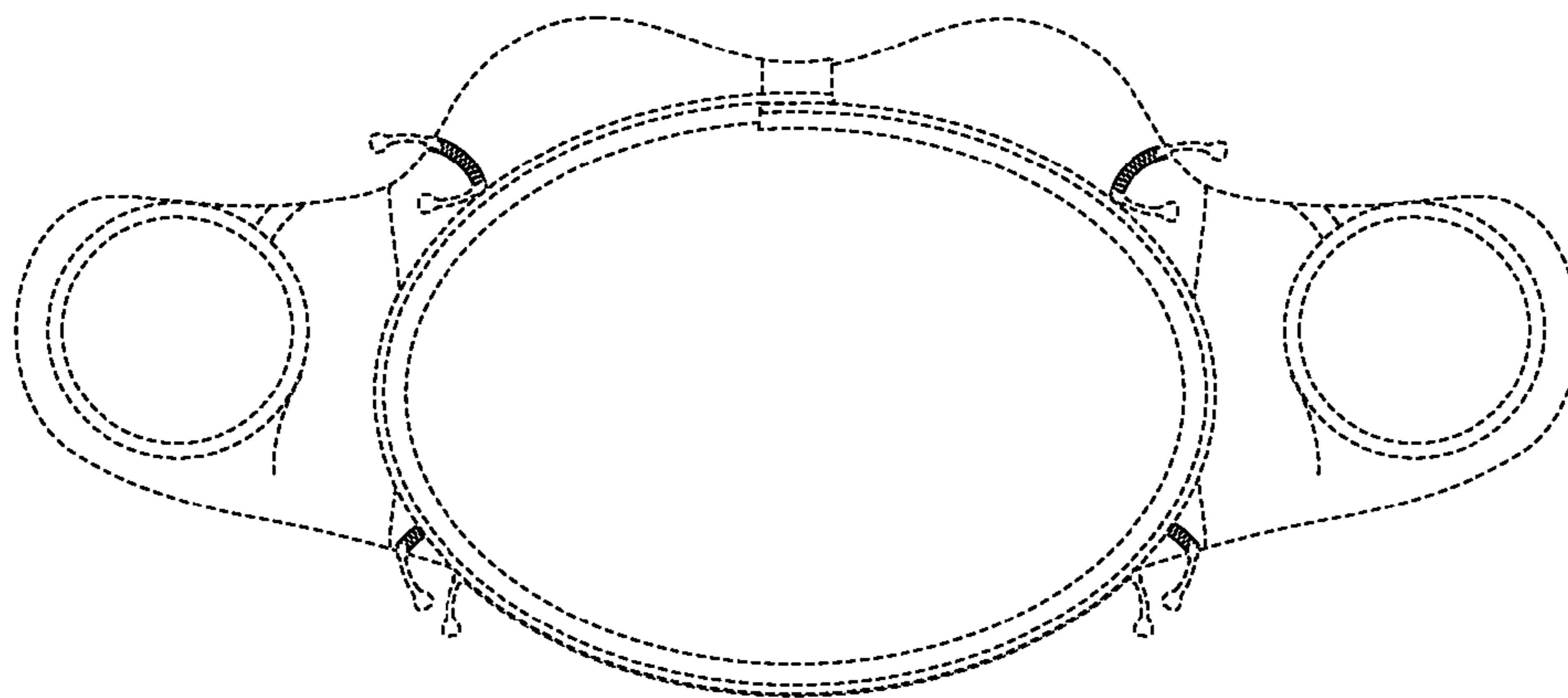
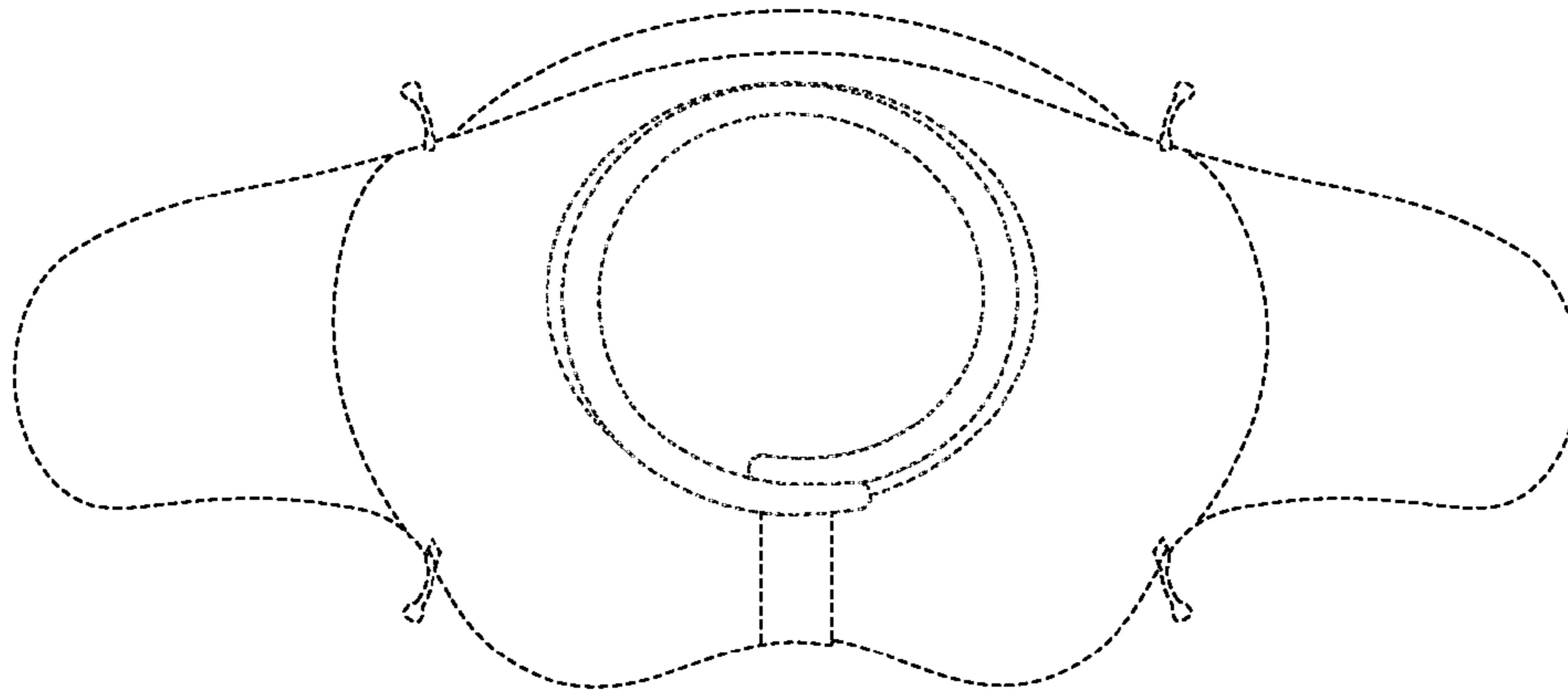

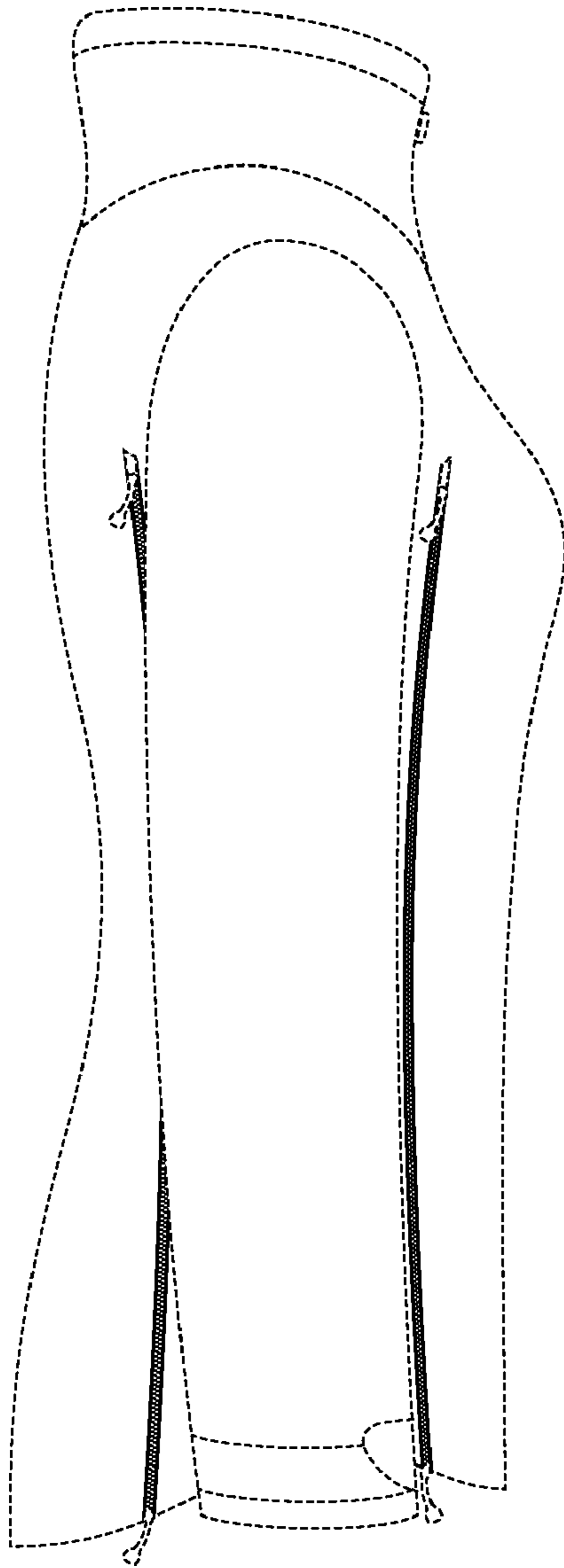

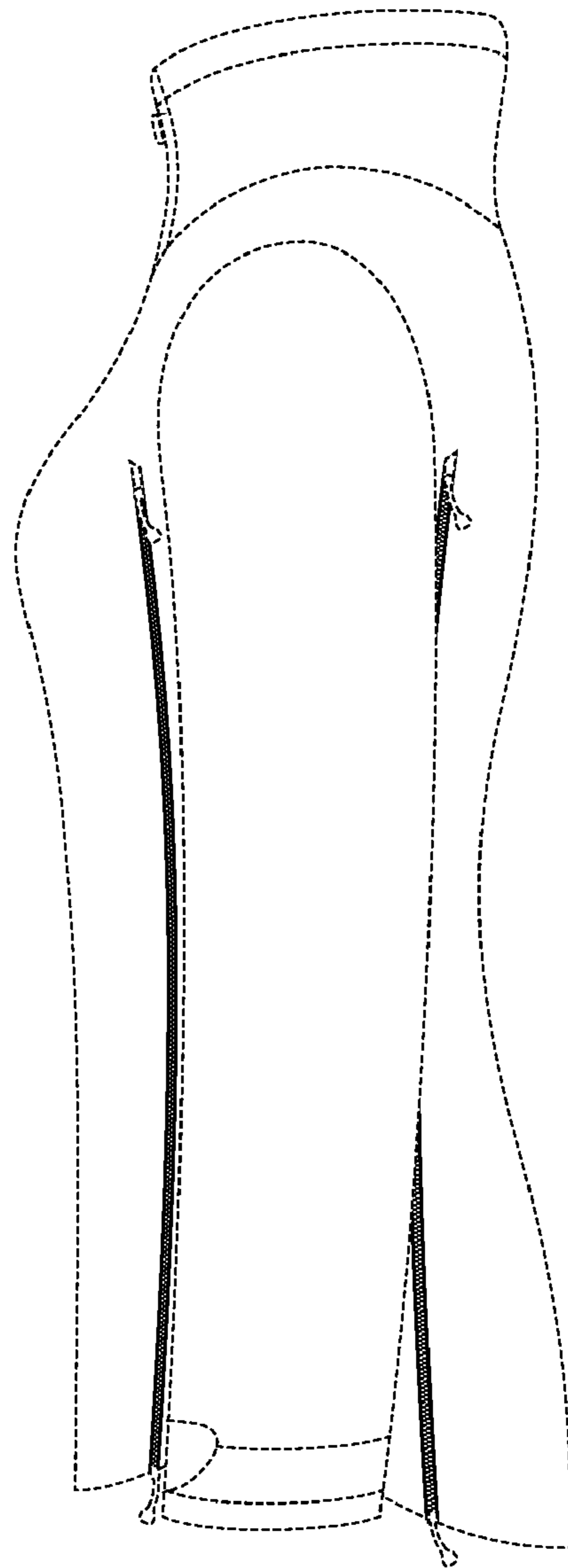
