**DESCRIPTION**

FIG. 5 is a rear view of the boot shown in FIG. 1;

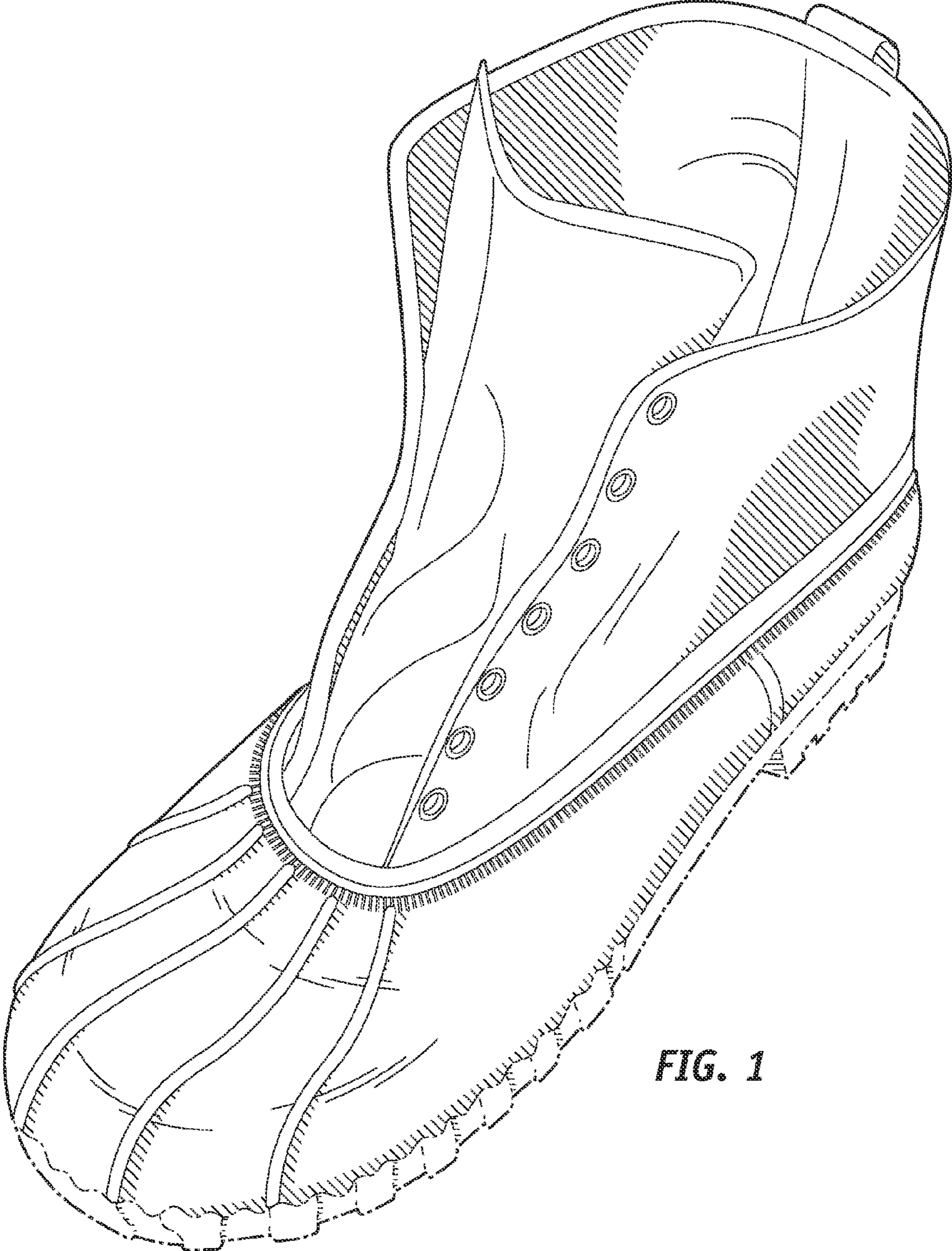
FIG. 6 is a front view of the boot shown in FIG. 1; and,

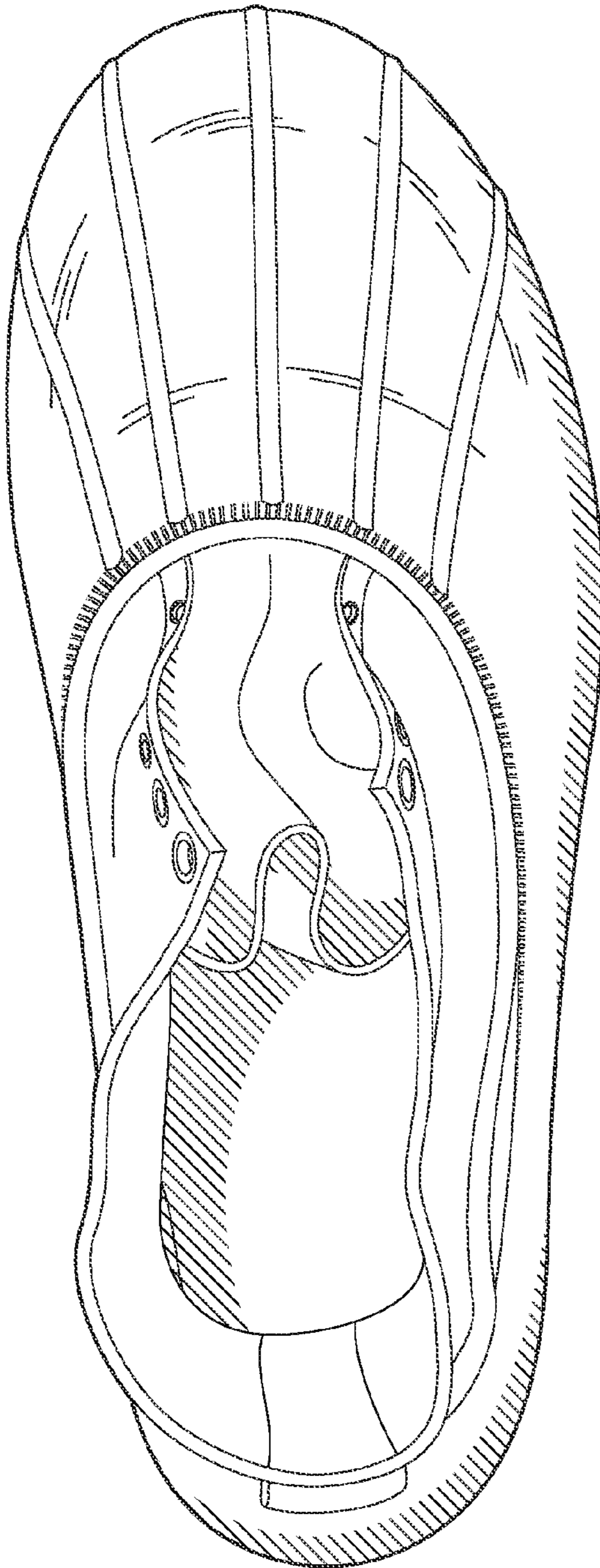

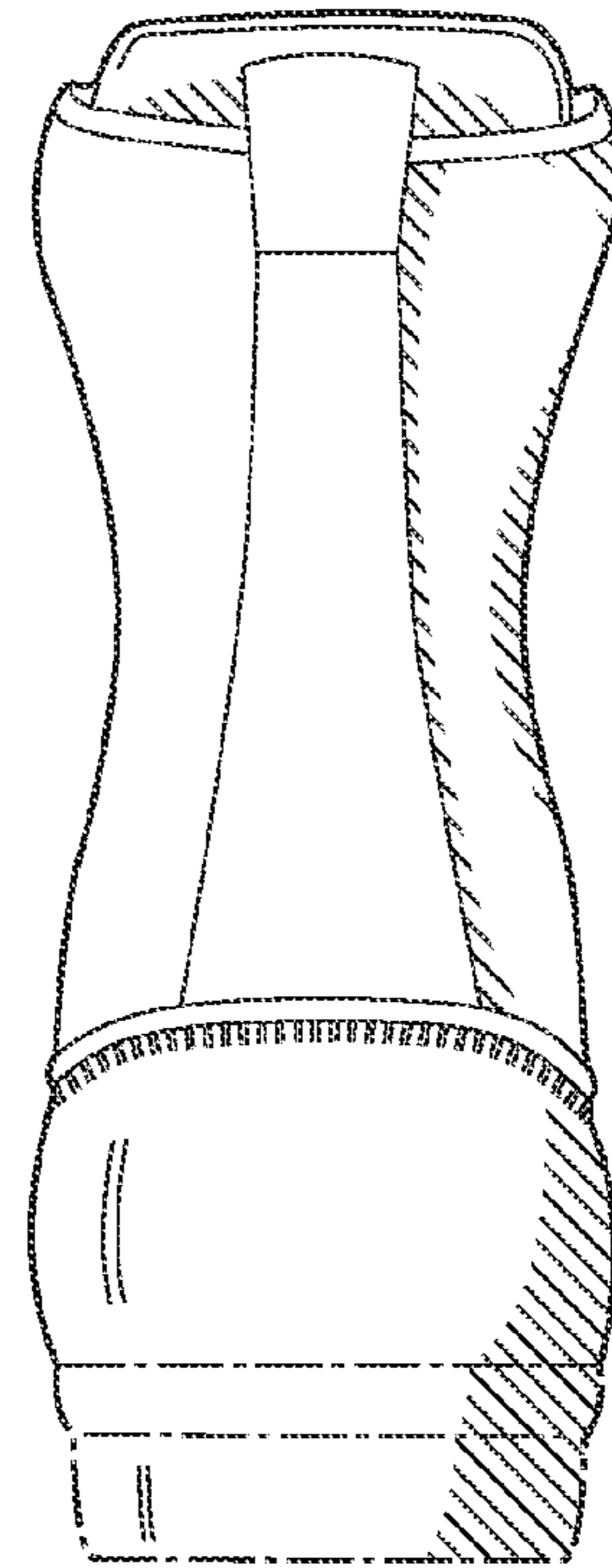

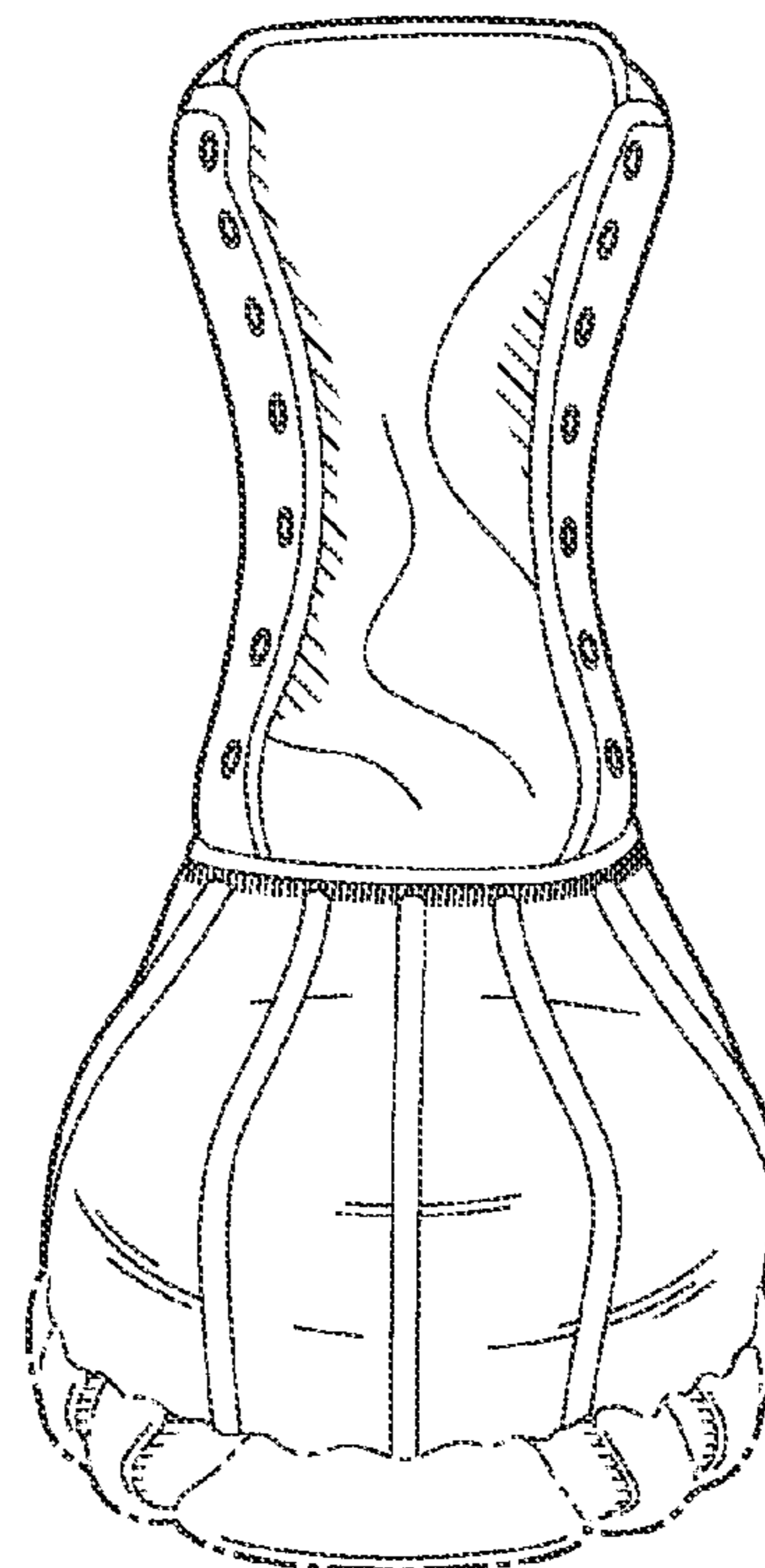
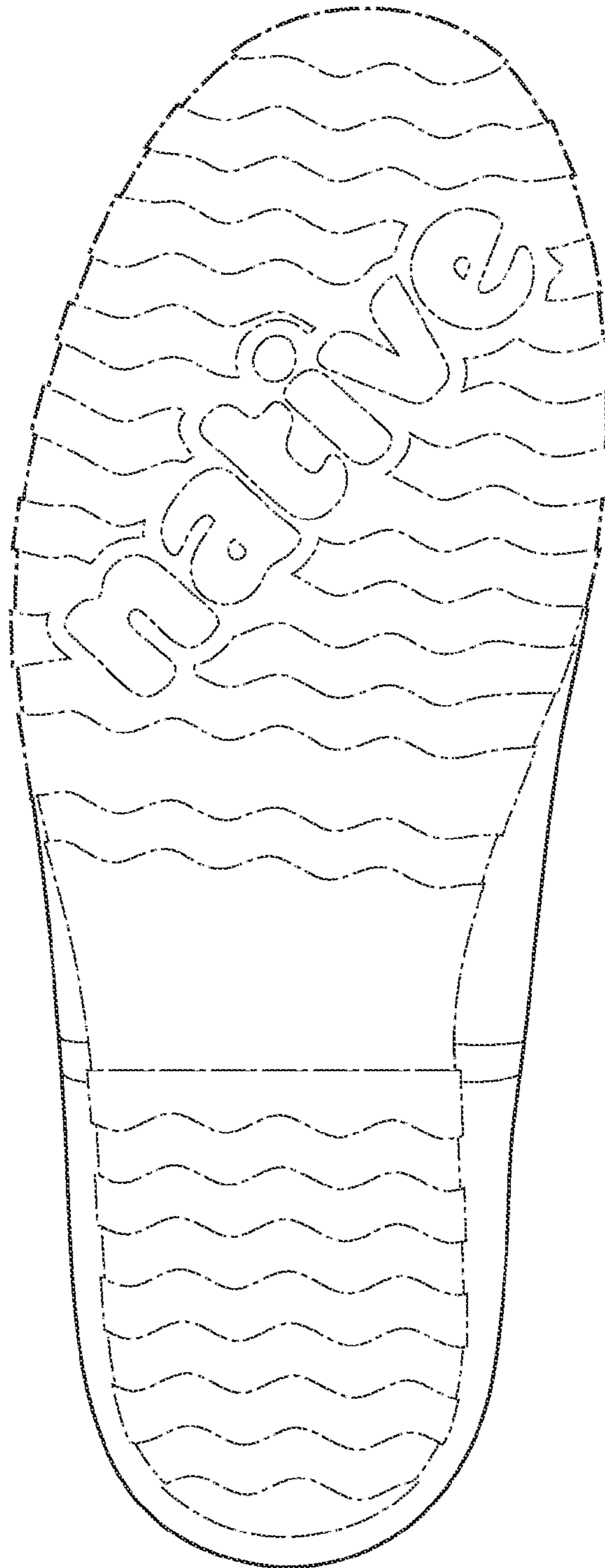
