FIG. 4 is a top view of a fourth embodiment of an absorbent article material with surface indicia.

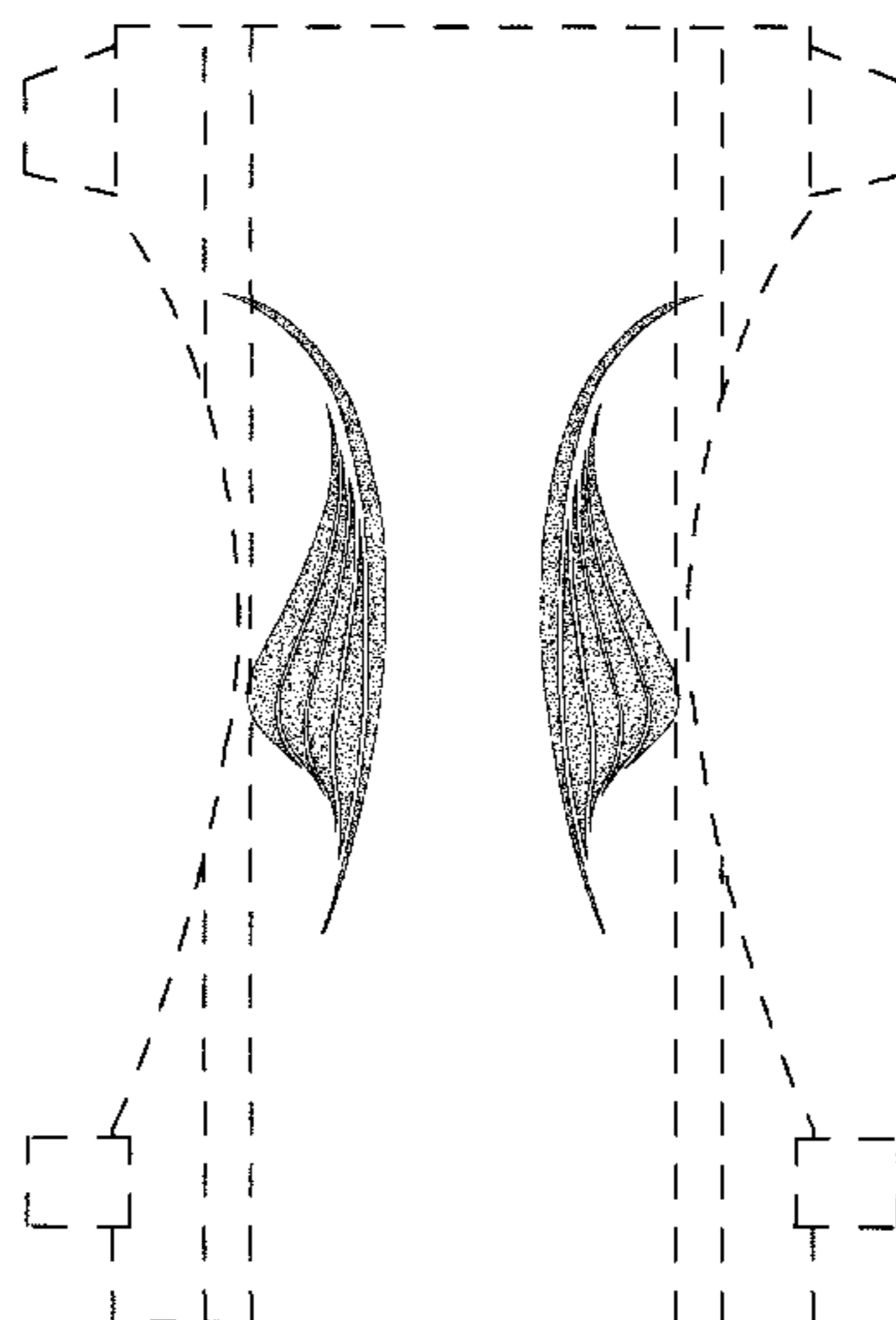
FIG. 5 is a top view of a fifth embodiment of an absorbent article material with surface indicia; and,

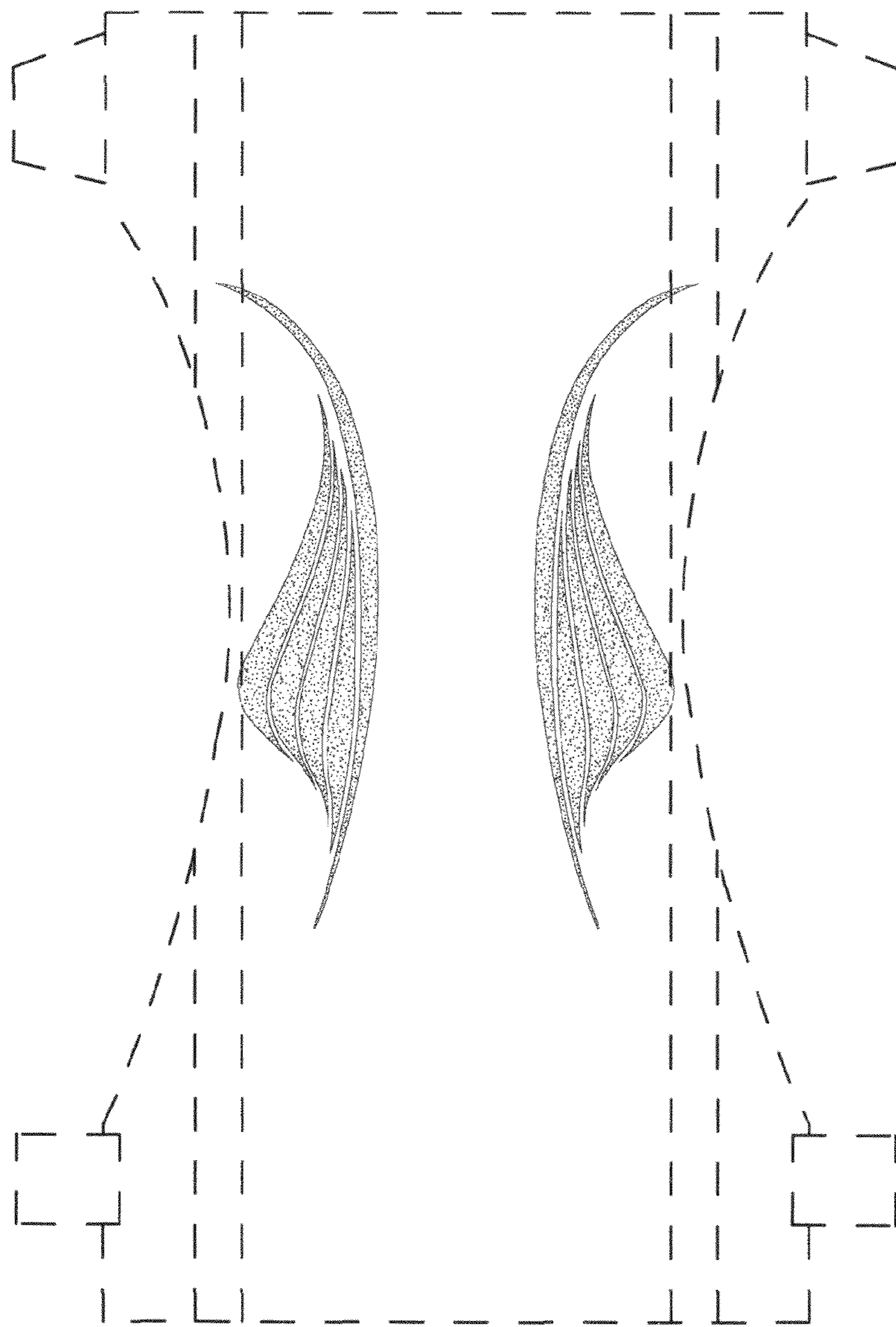

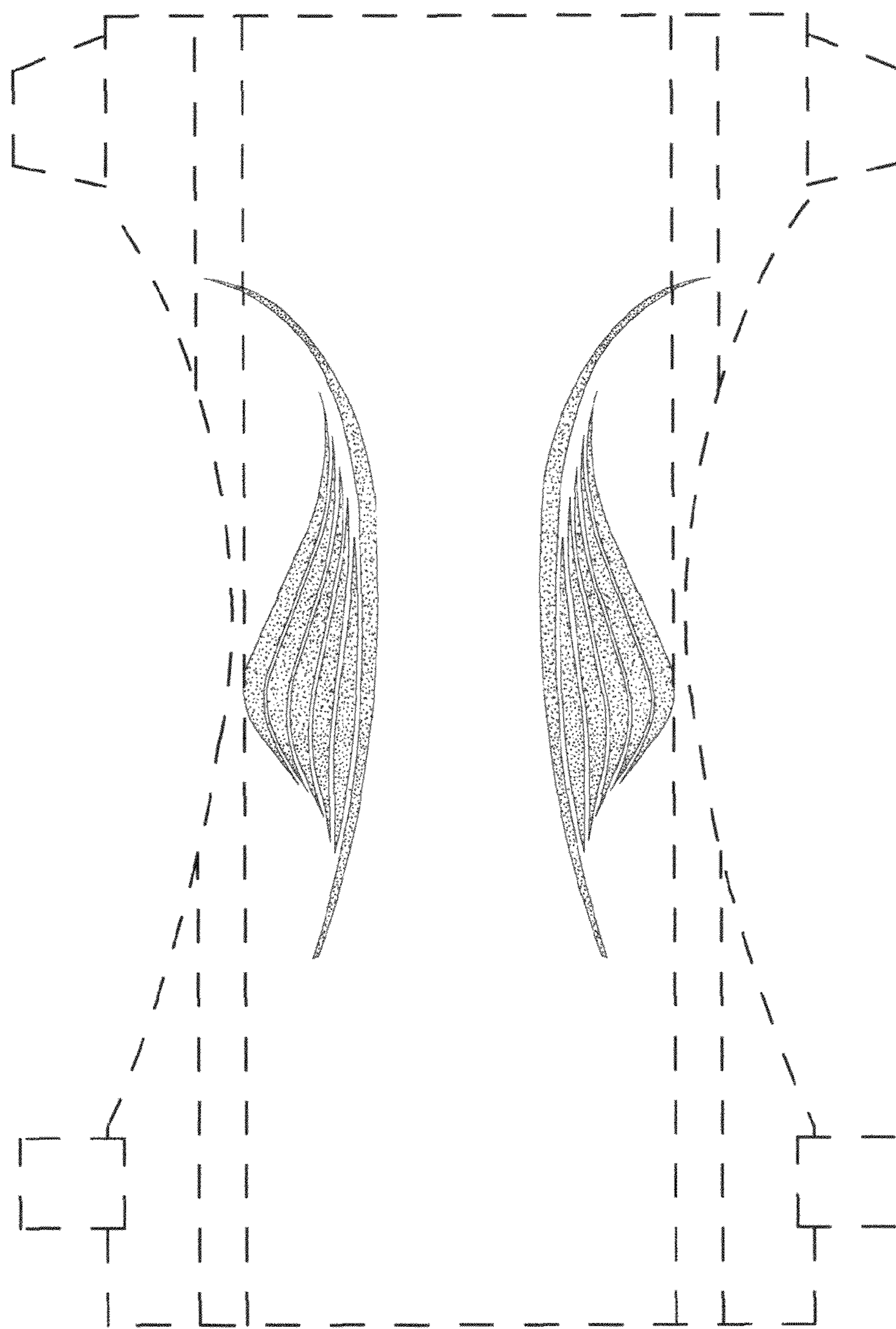

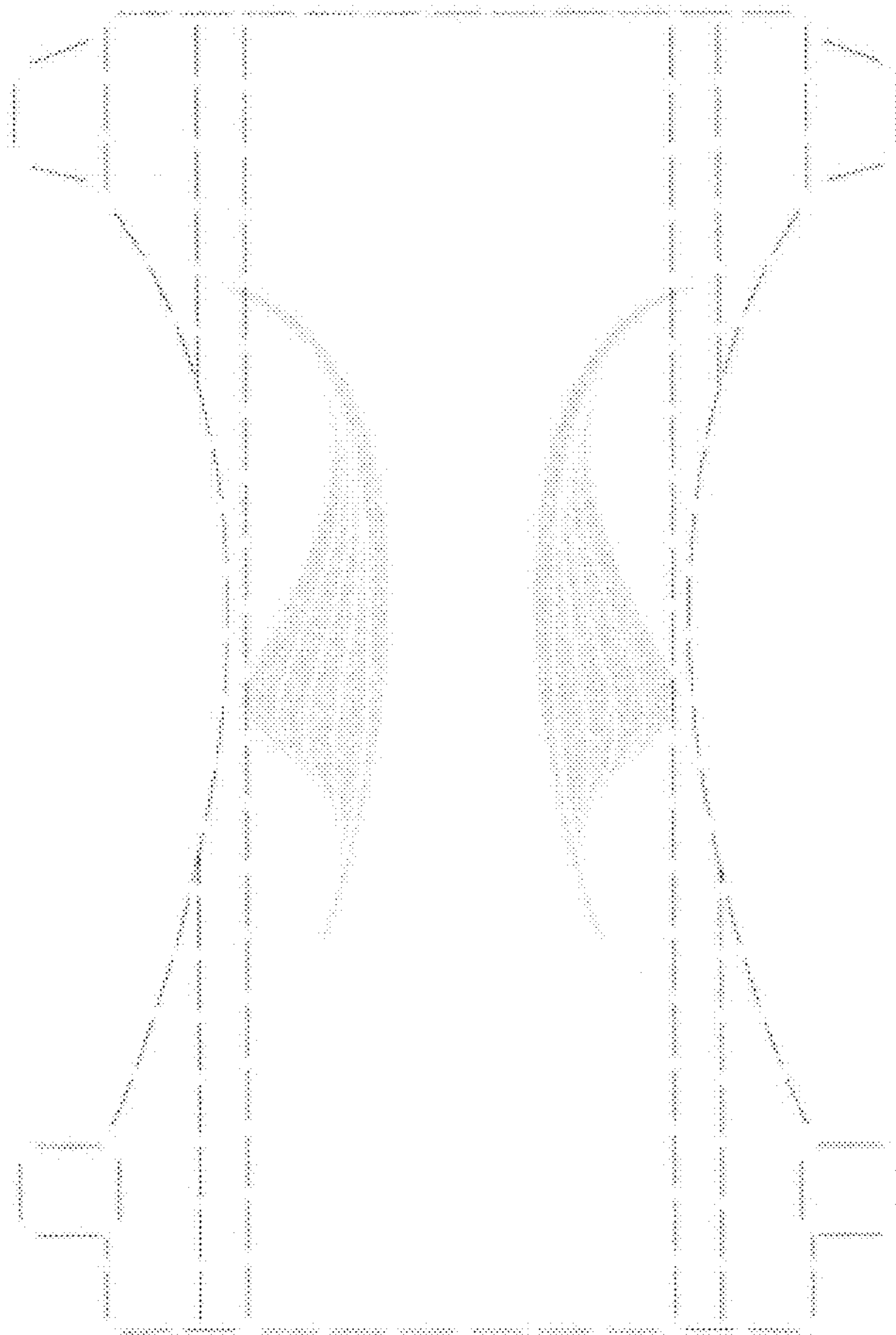

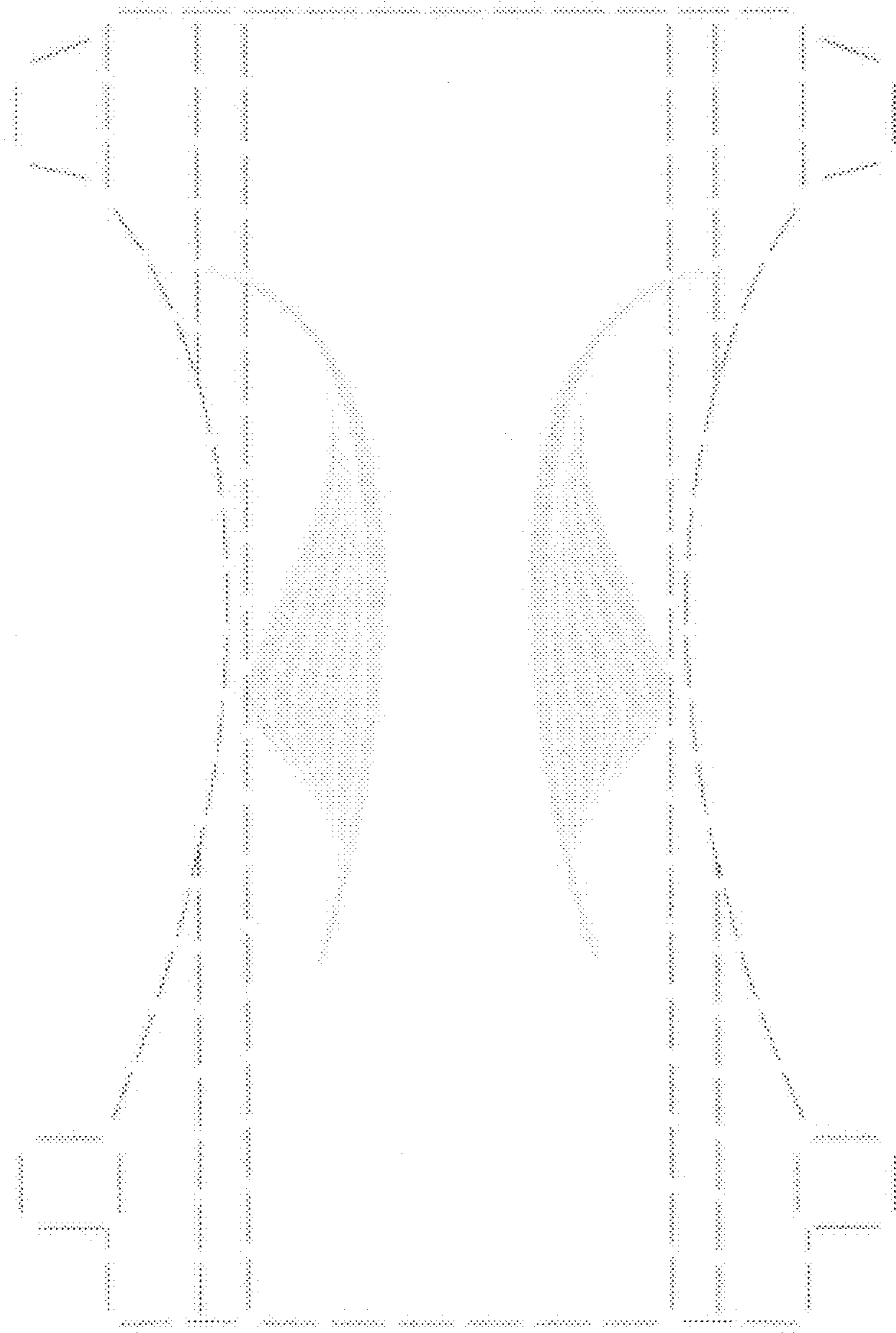

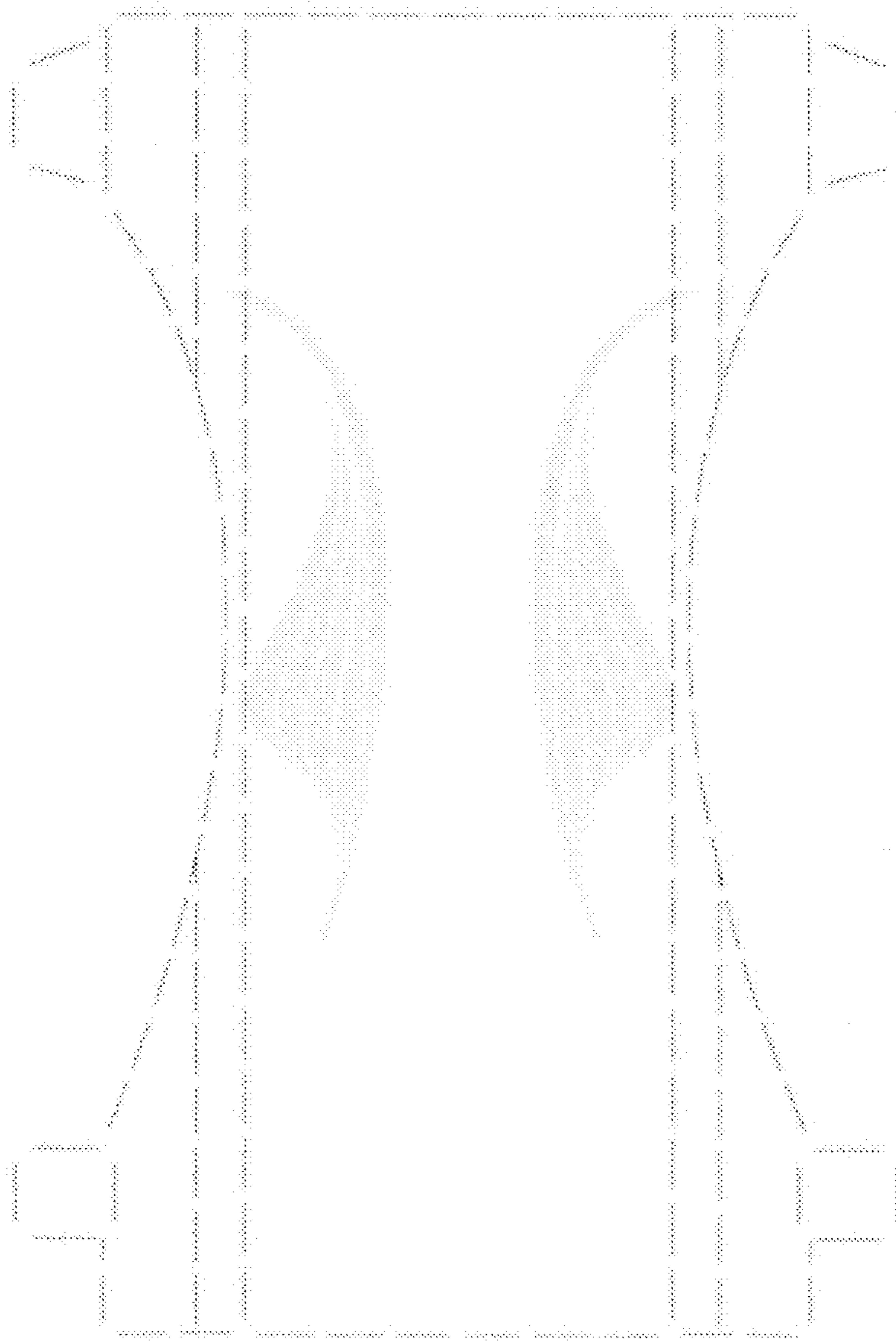

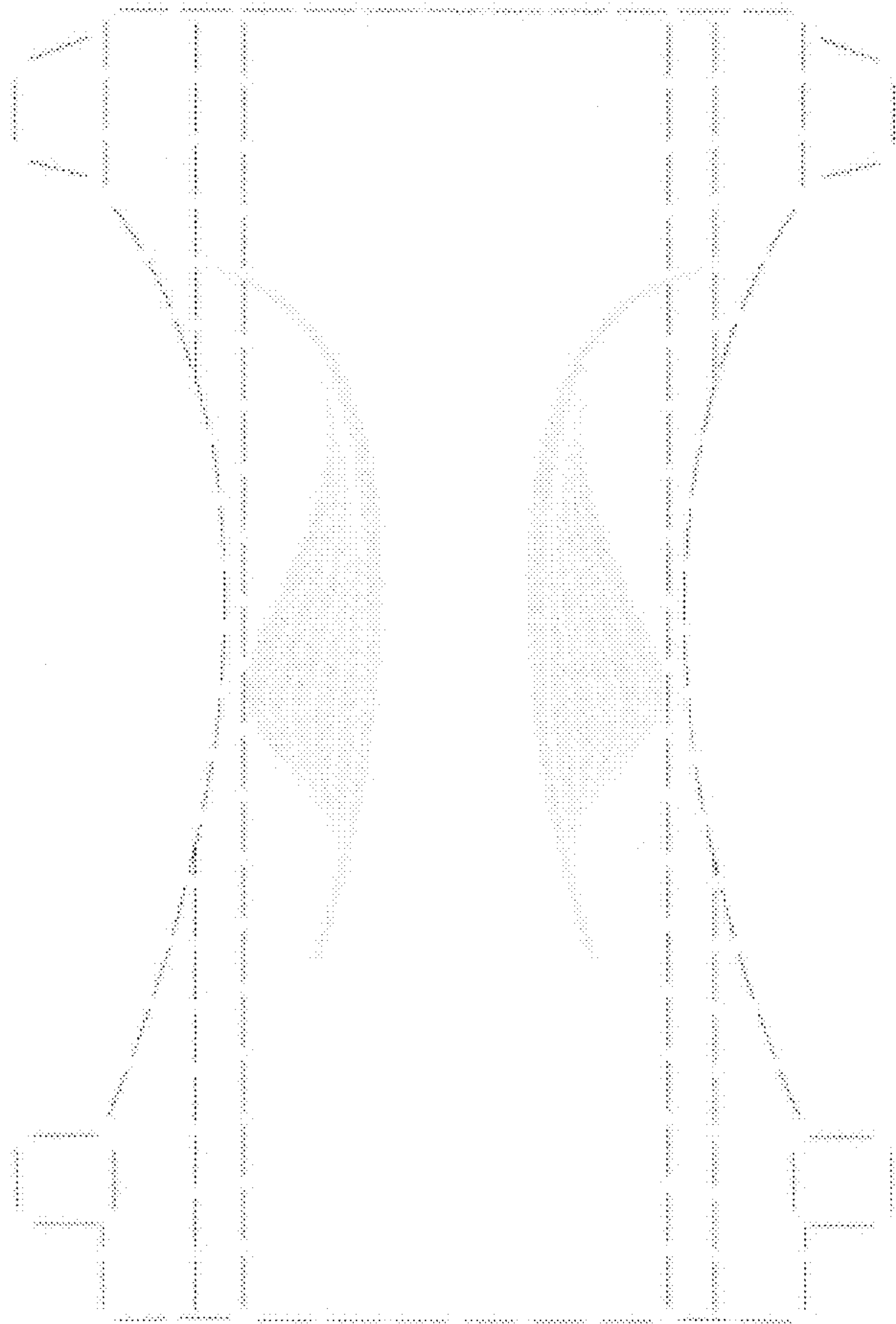
