(57) **CLAIM**

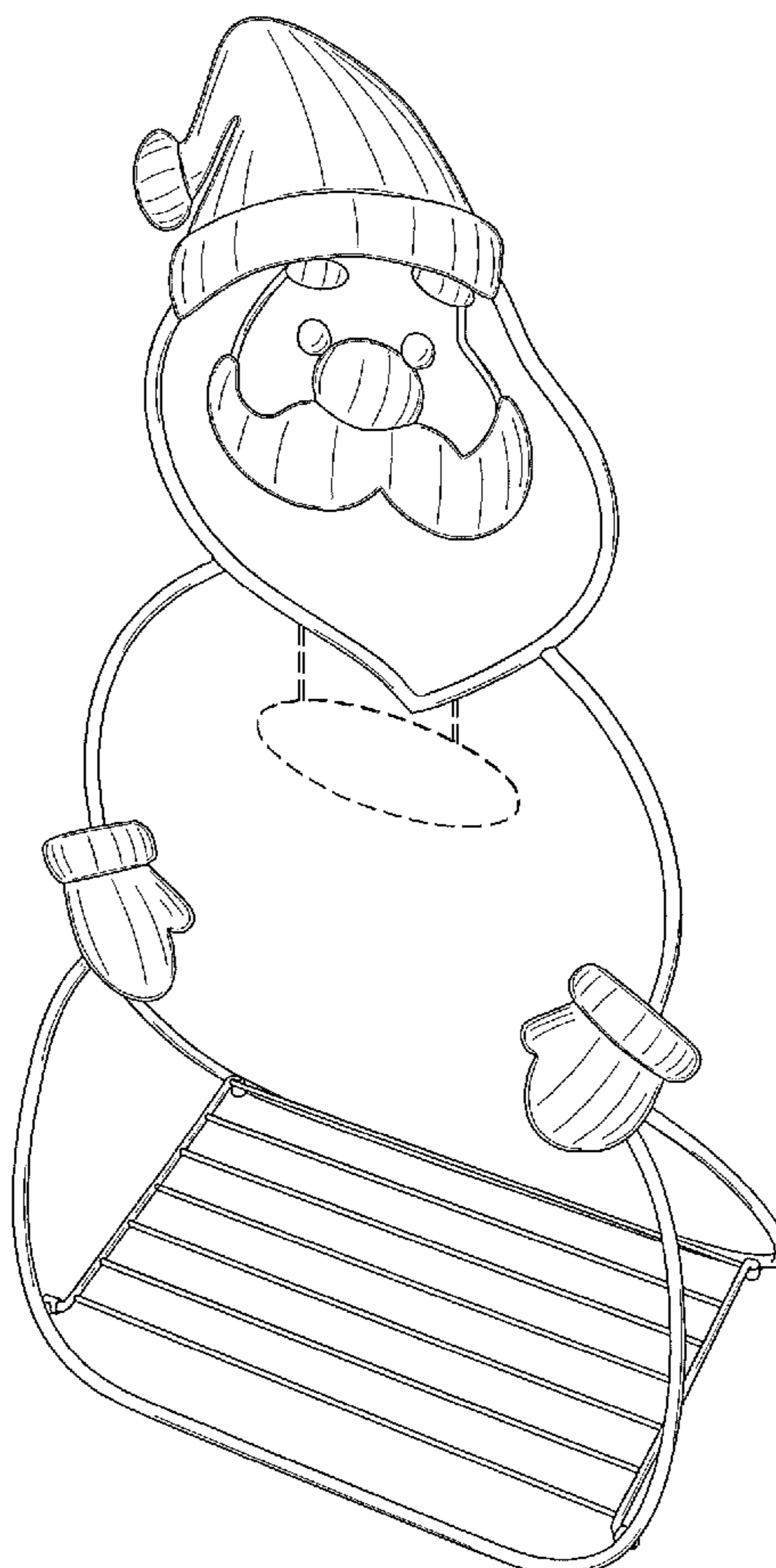
I claim the ornamental design for a Santa planter holder, as shown and described.

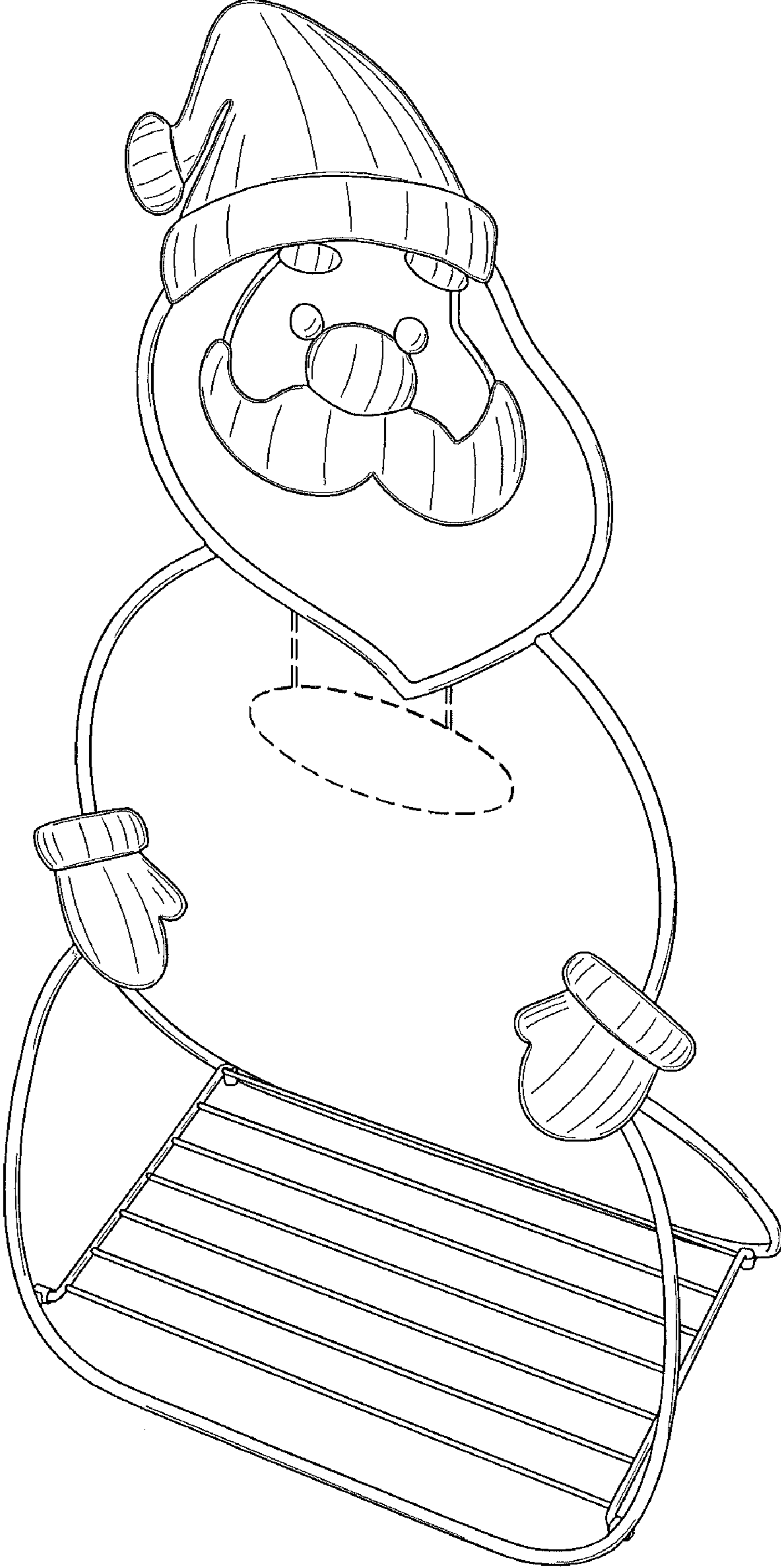

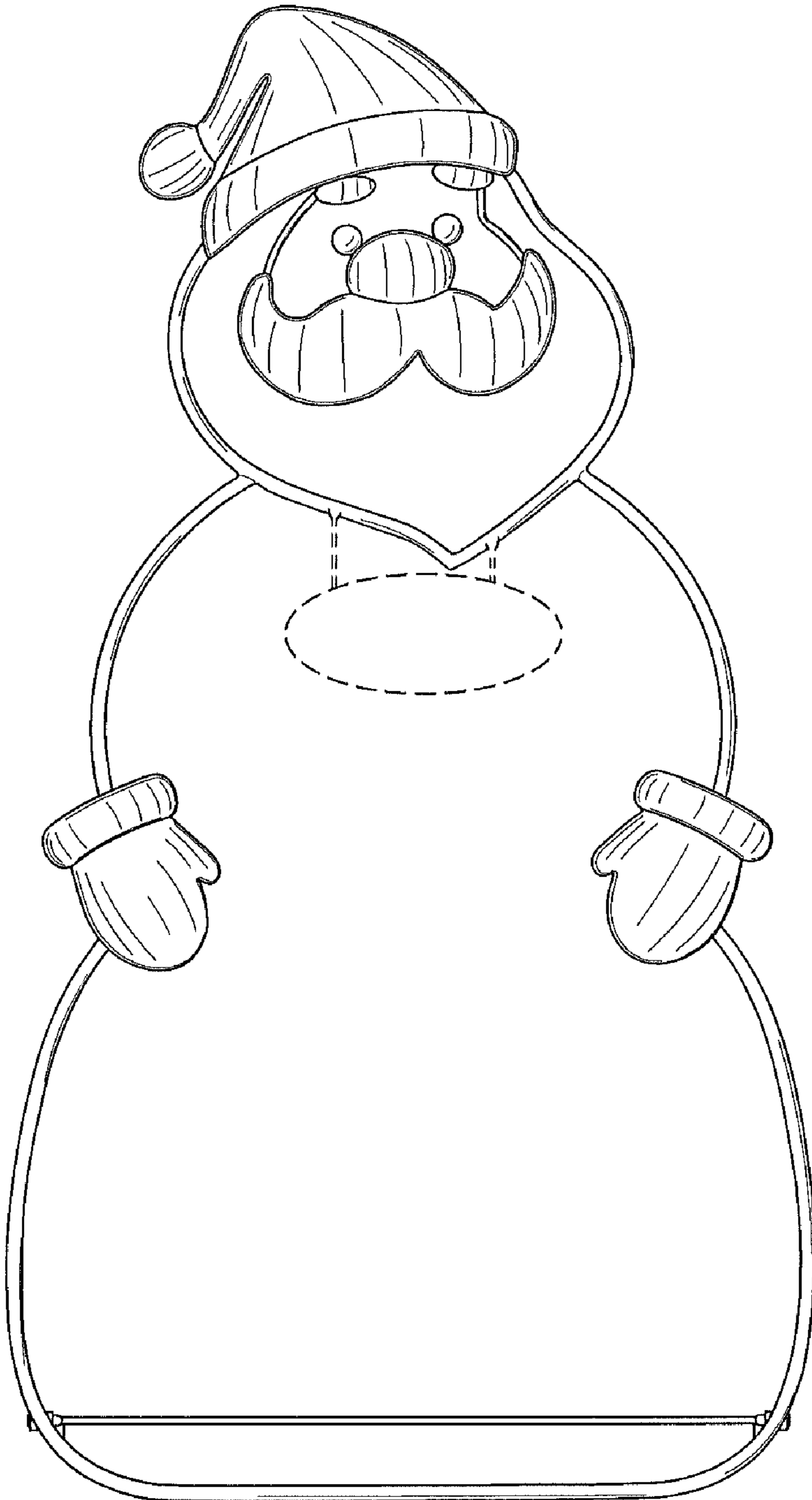

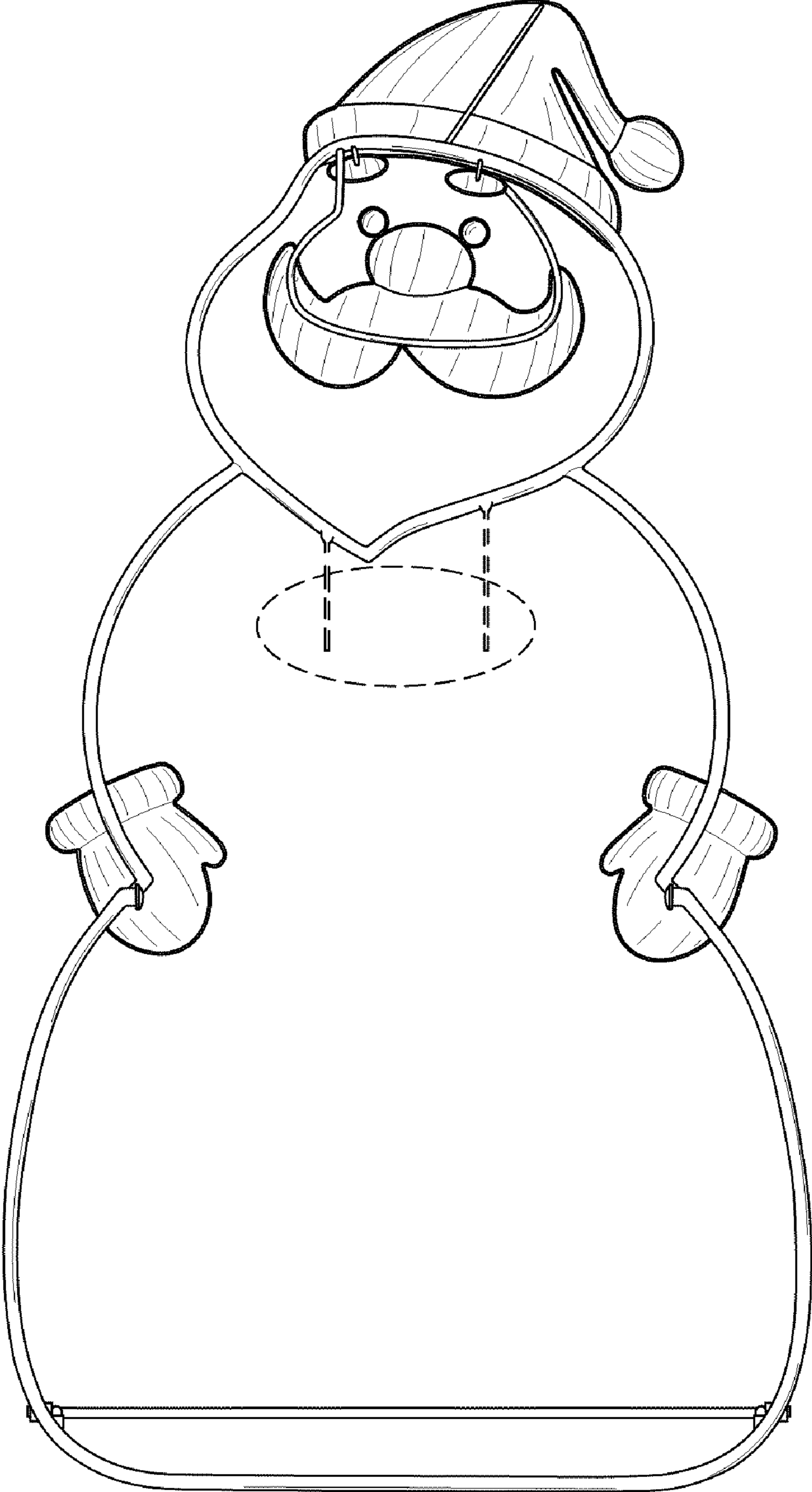

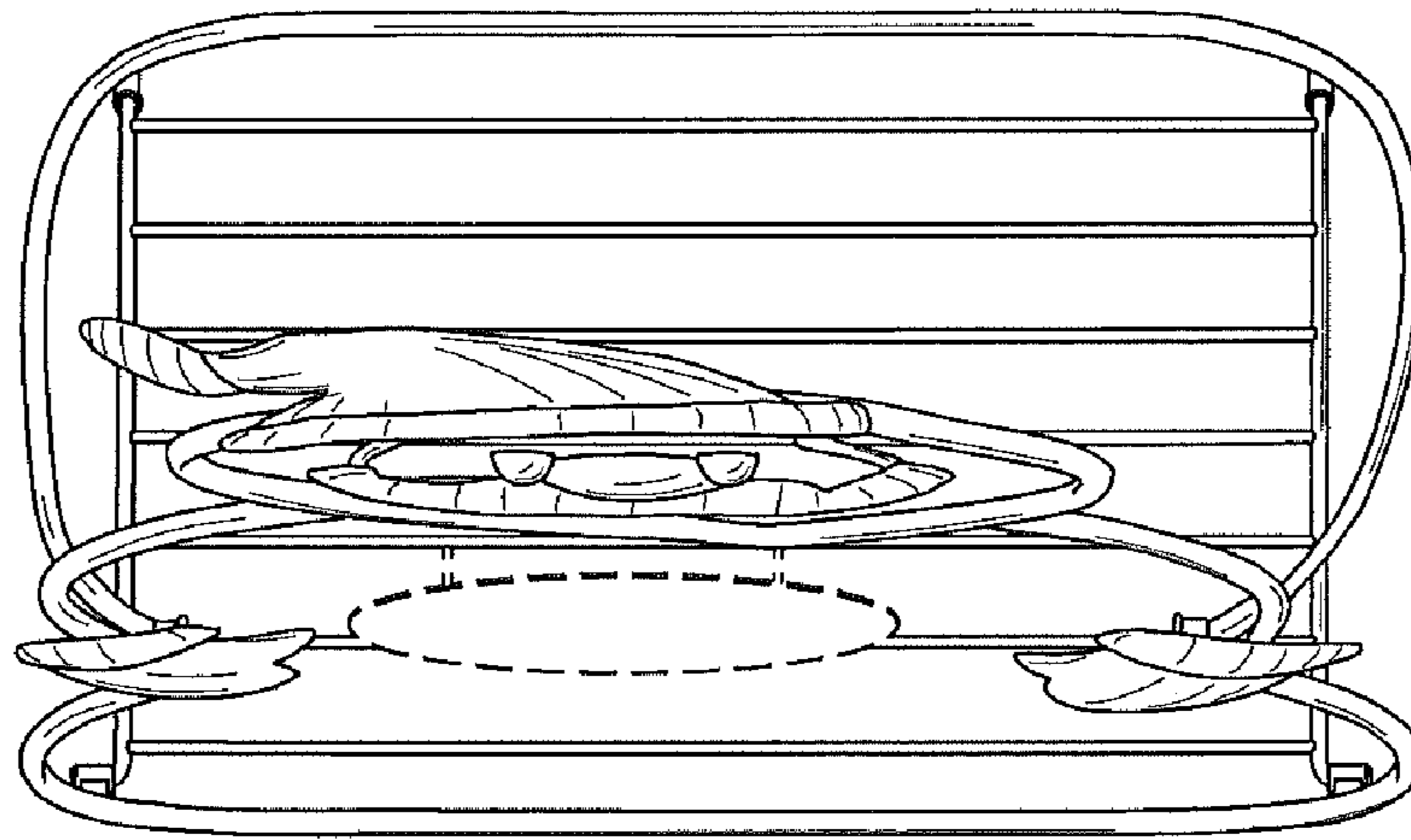

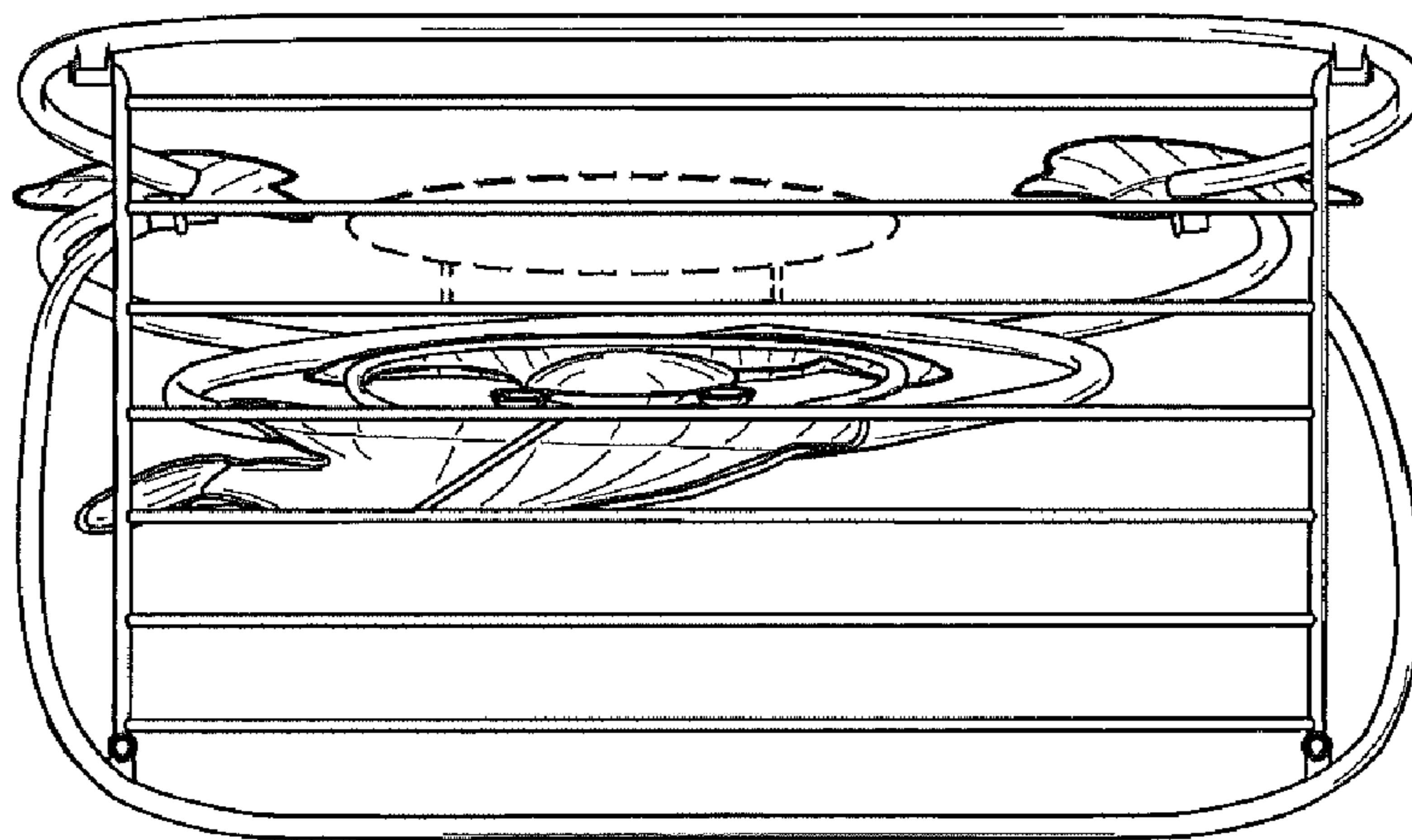

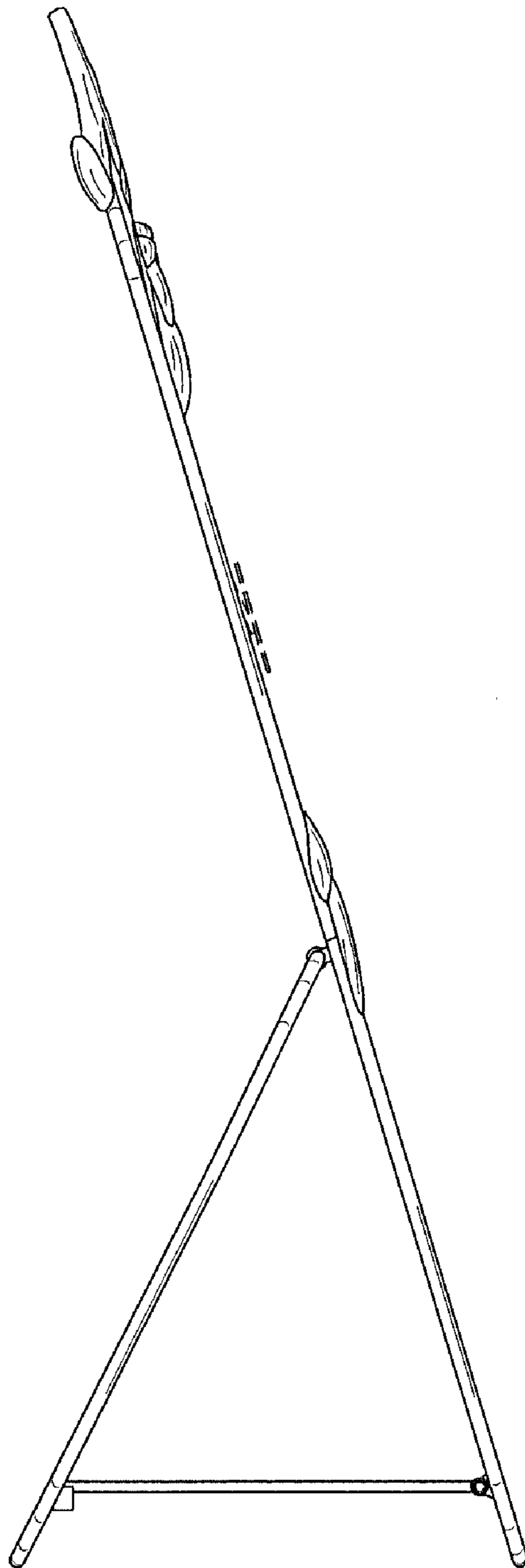

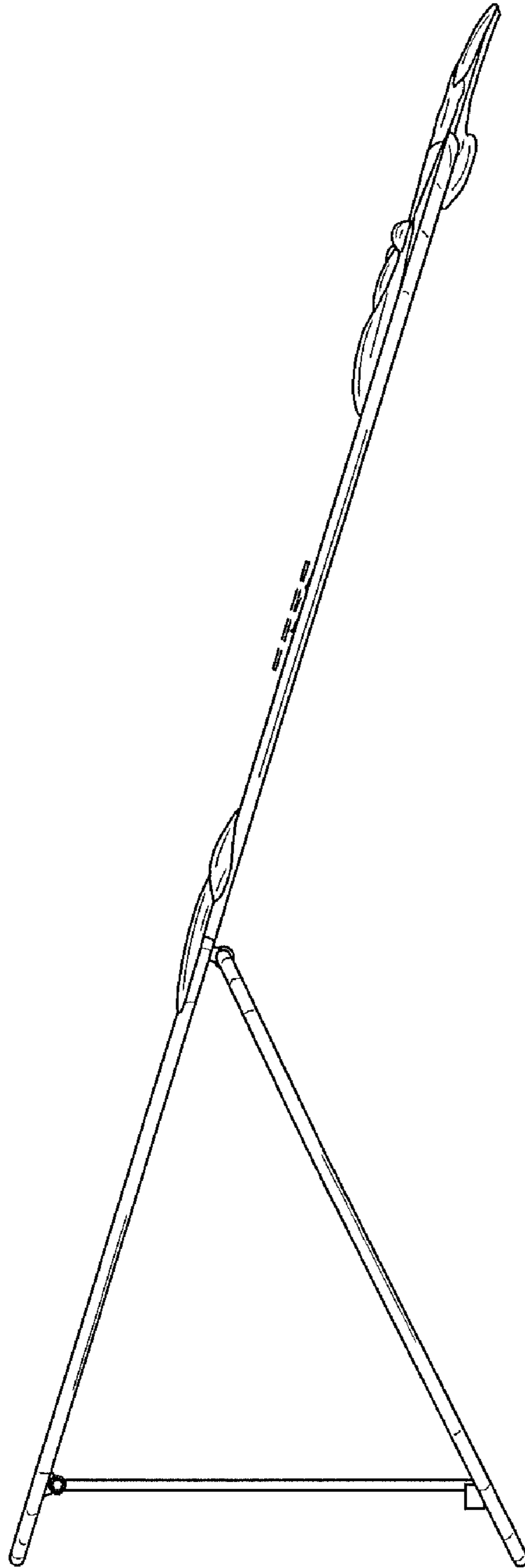
