FIG. 2 is a top plan view thereof.

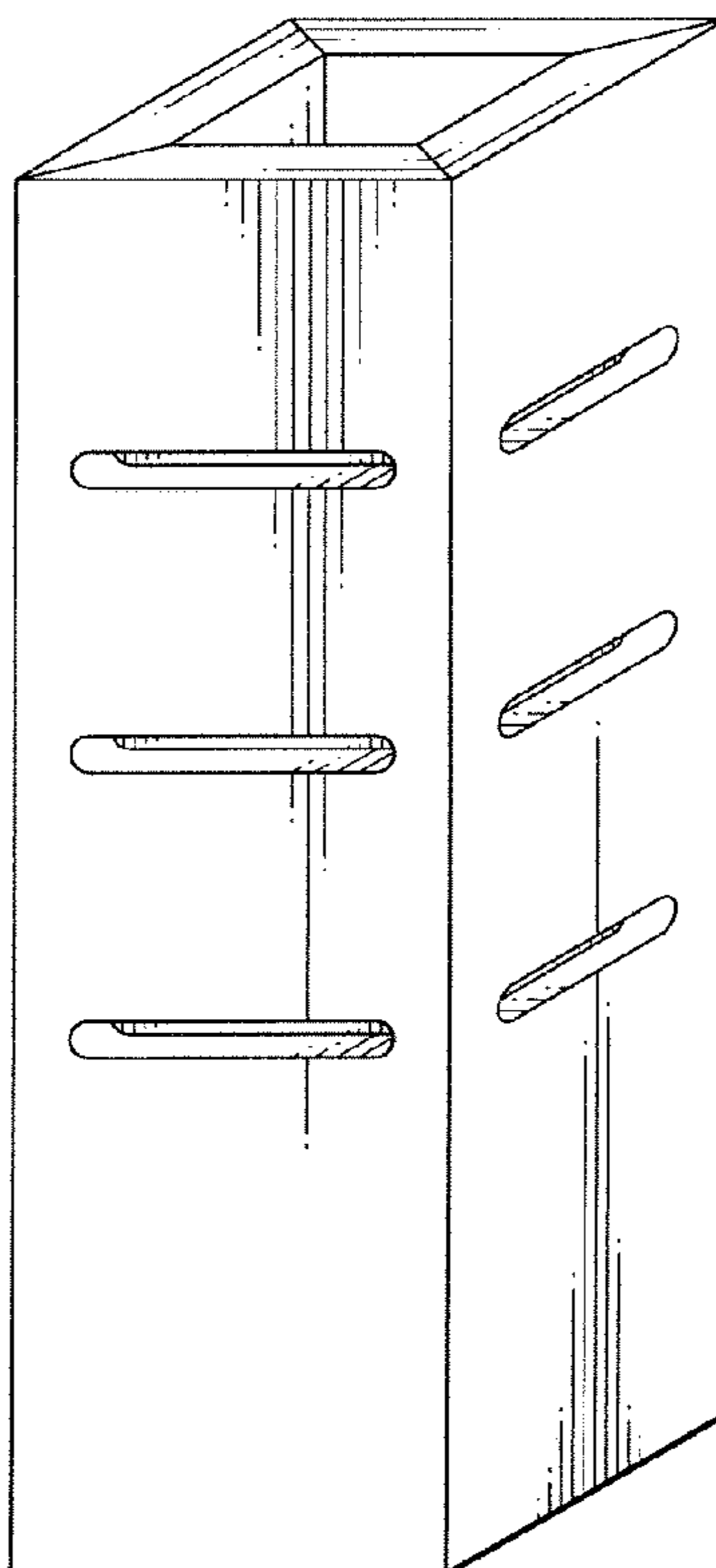
FIG. 3 is an exterior elevational view of the Display and Sales Unit in an unfolded configuration.

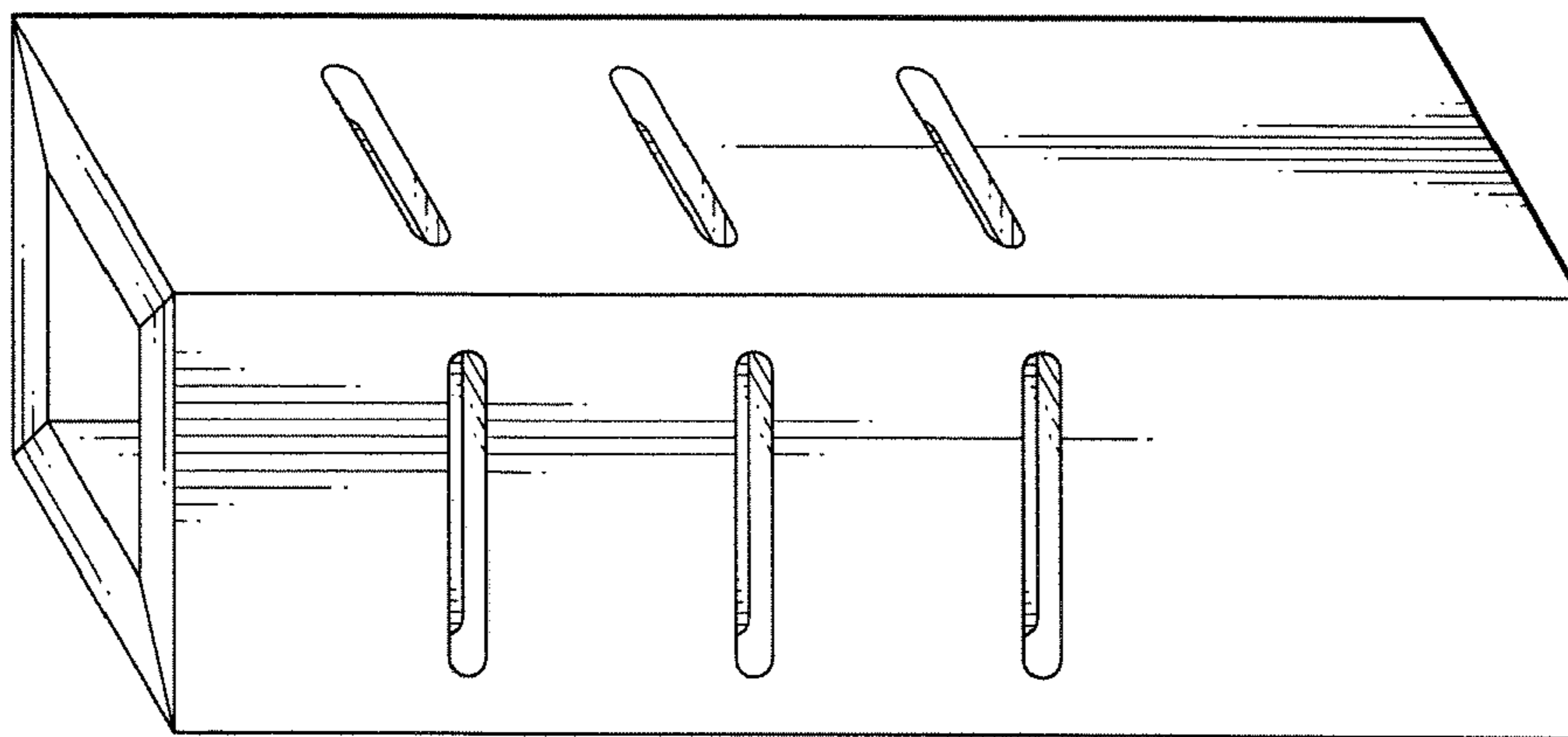

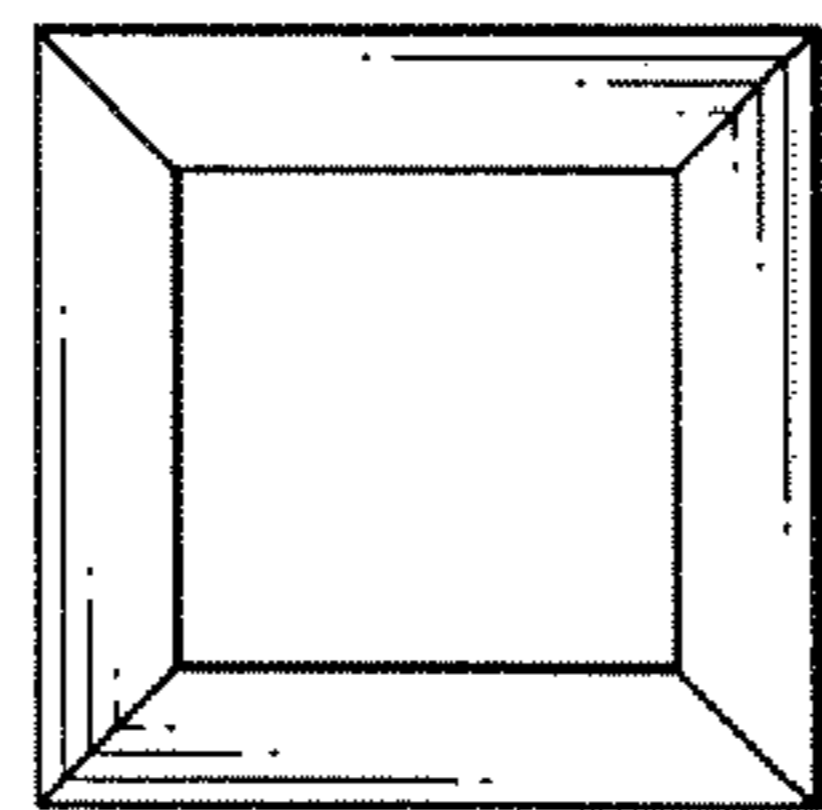

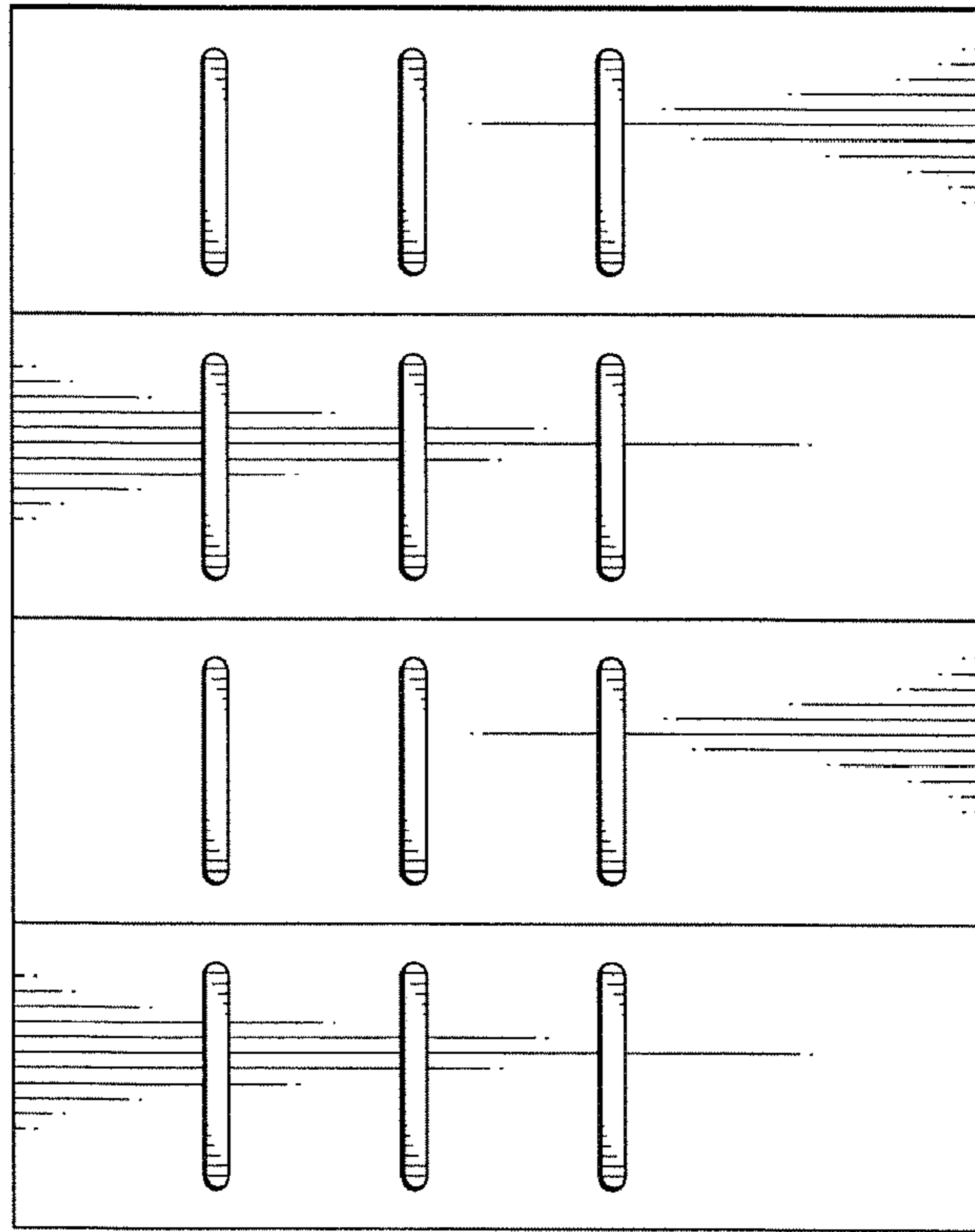

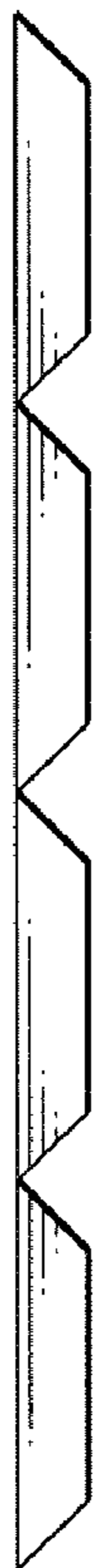

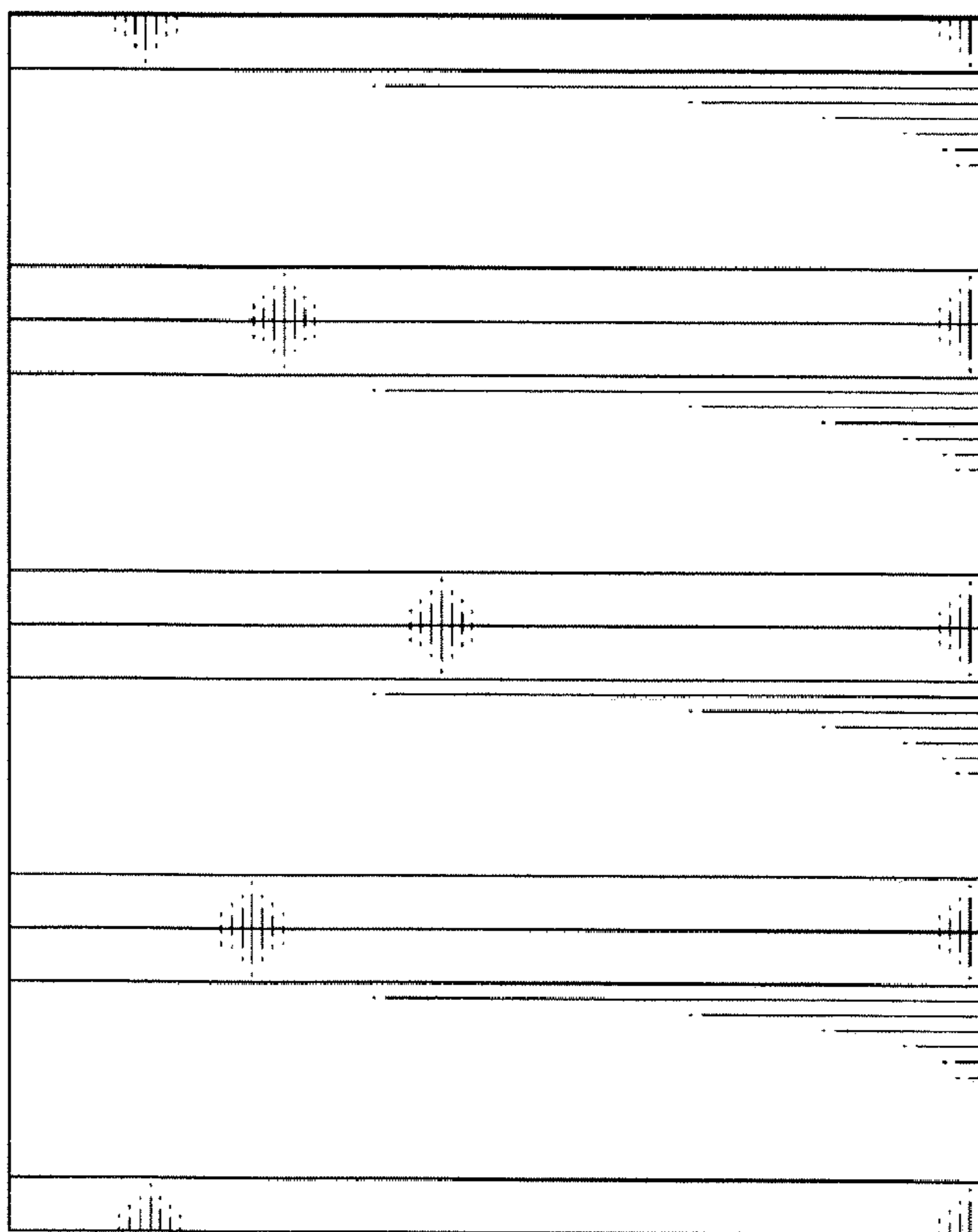
