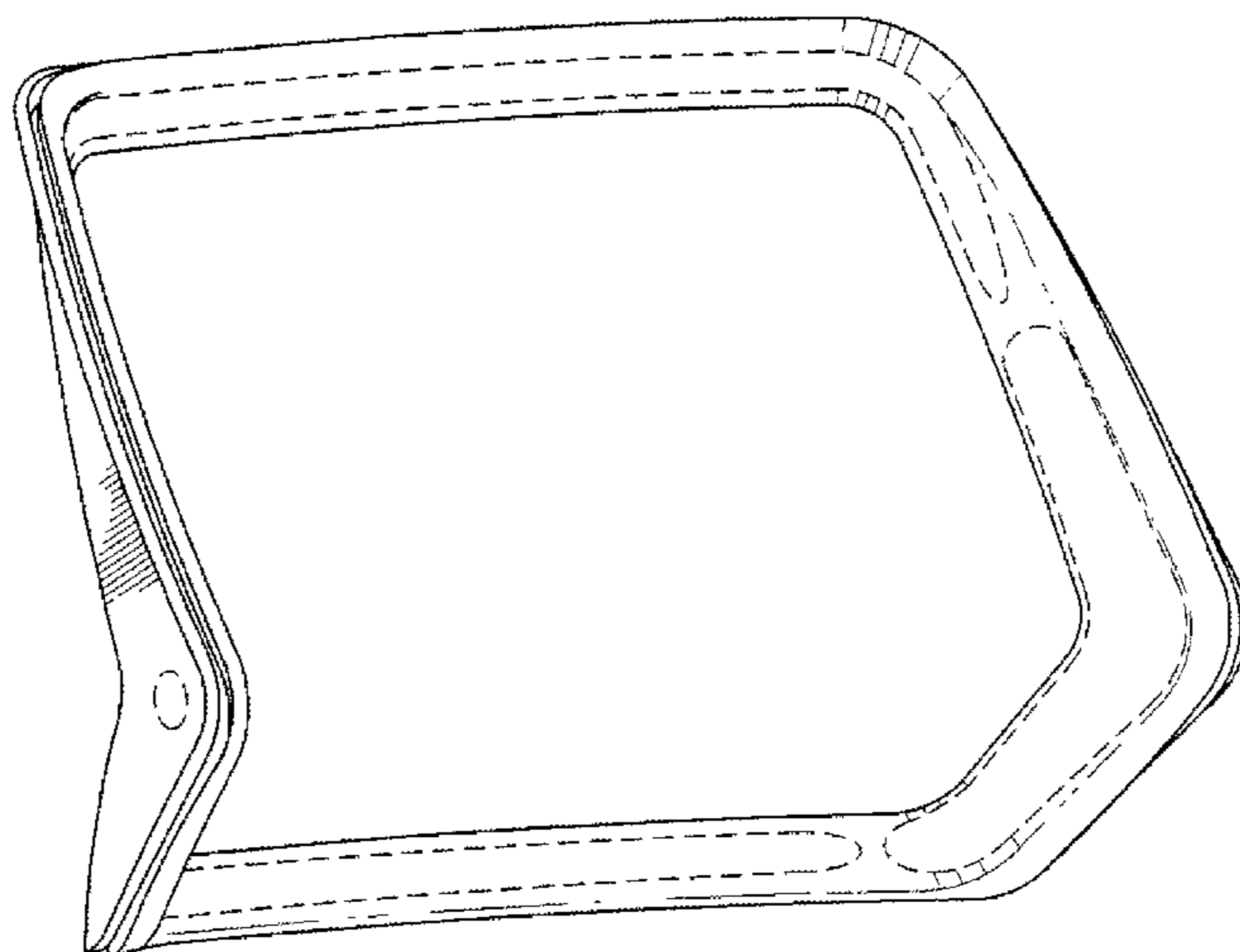
(57) **CLAIM**

I claim the ornamental design for a seating unit back, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a seating unit back according to the new design;  
FIG. 2 is a left side view of the seating unit back shown in FIG. 1; the opposed right side view being a mirror image thereof;  
FIG. 3 is a front view of the seating unit back shown in FIG. 1;  
FIG. 4 is a rear view of the seating unit back shown in FIG. 1;  
FIG. 5 is a top view of the seating unit back shown in FIG. 1; and,  
FIG. 6 is a bottom view of the seating unit back shown in FIG. 1.  
In the drawings, features in broken lines form no part of the claimed design.

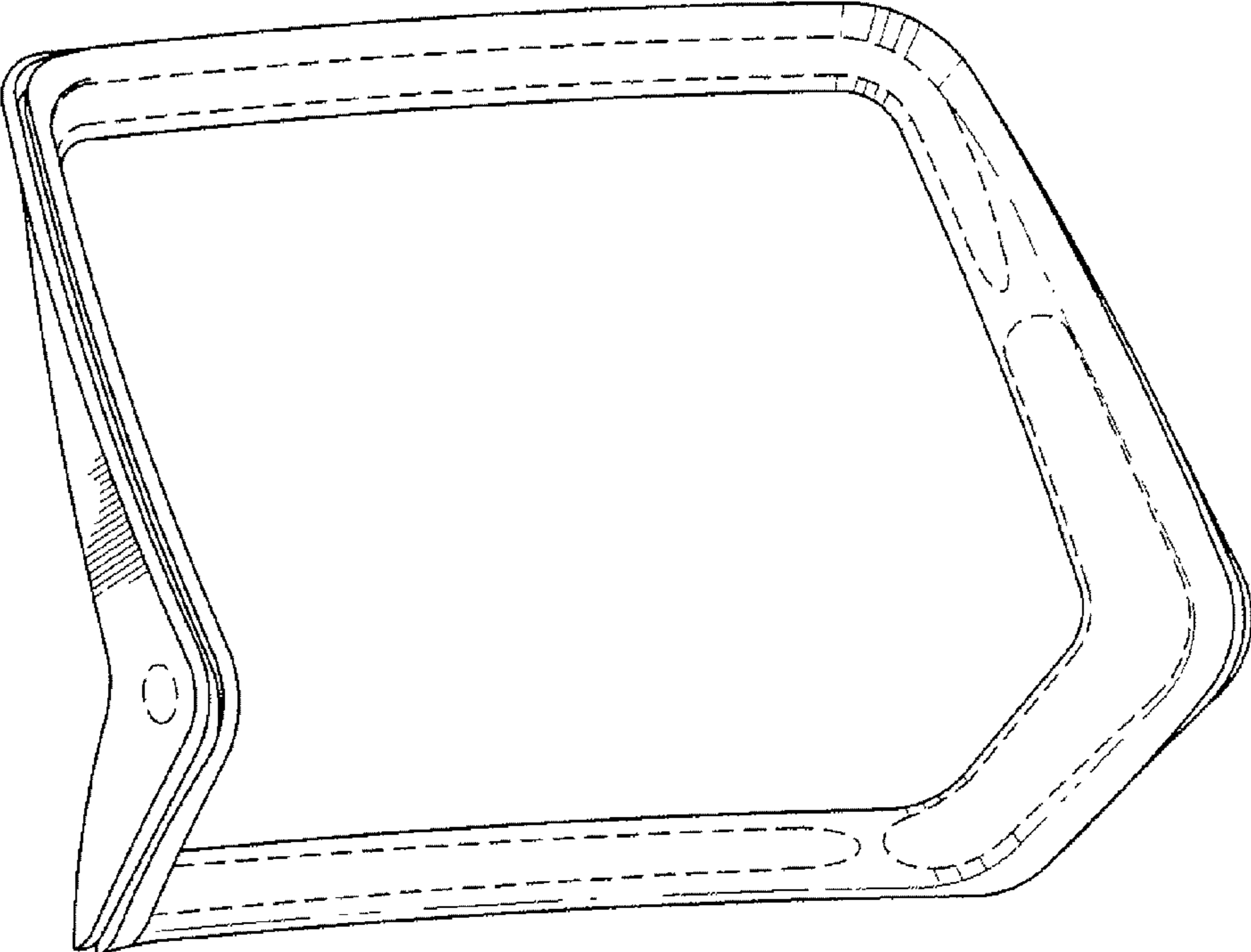
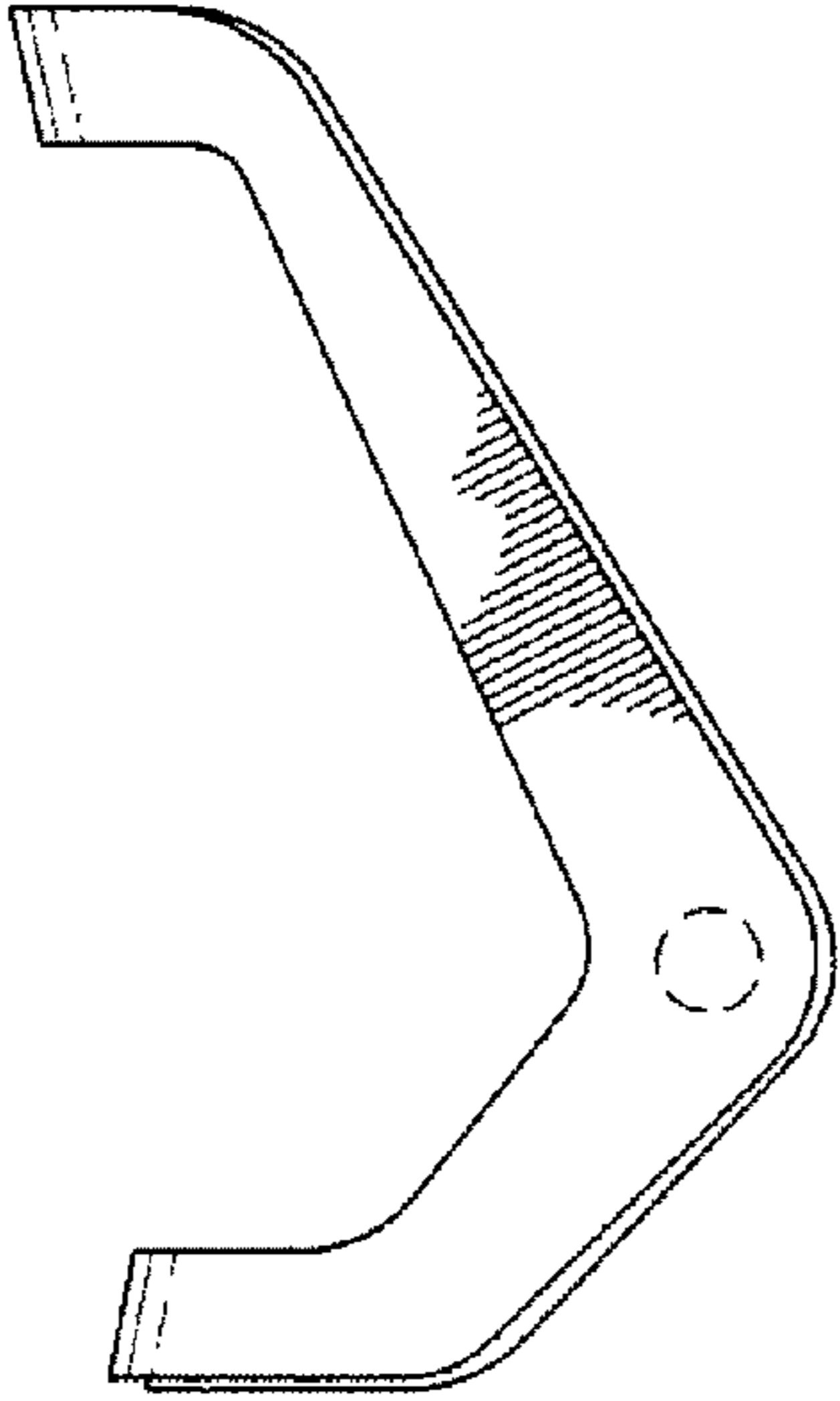
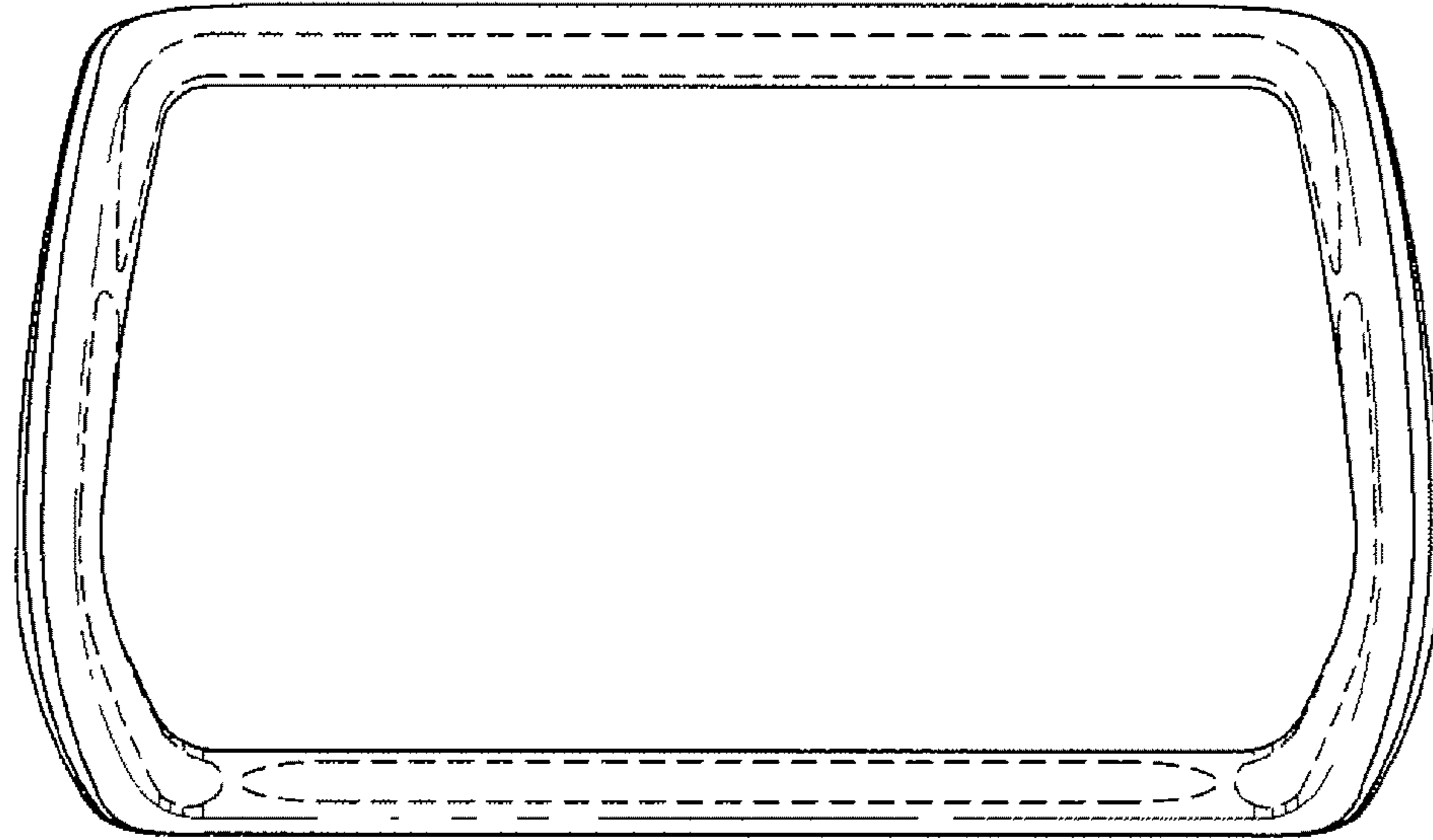


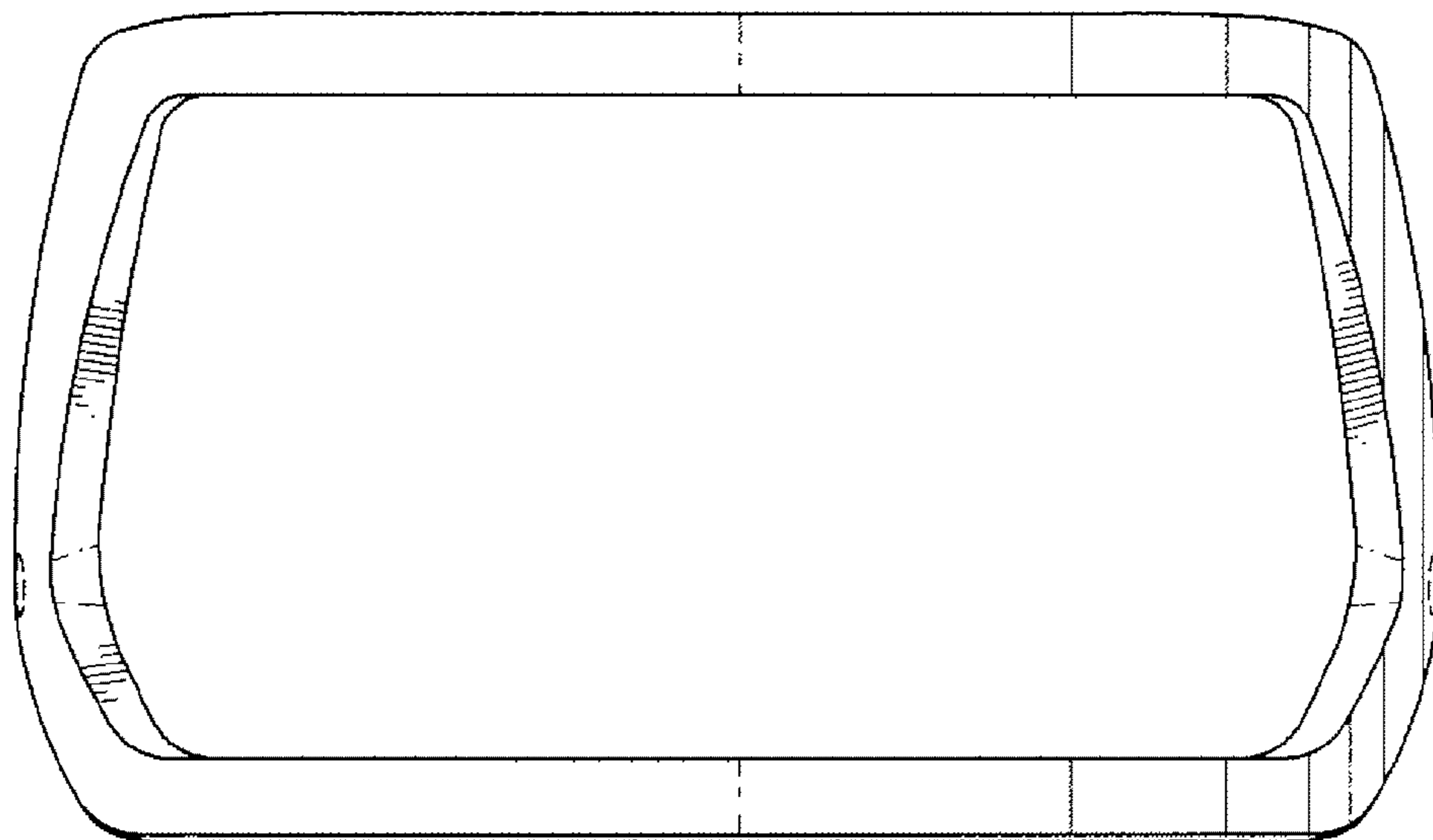

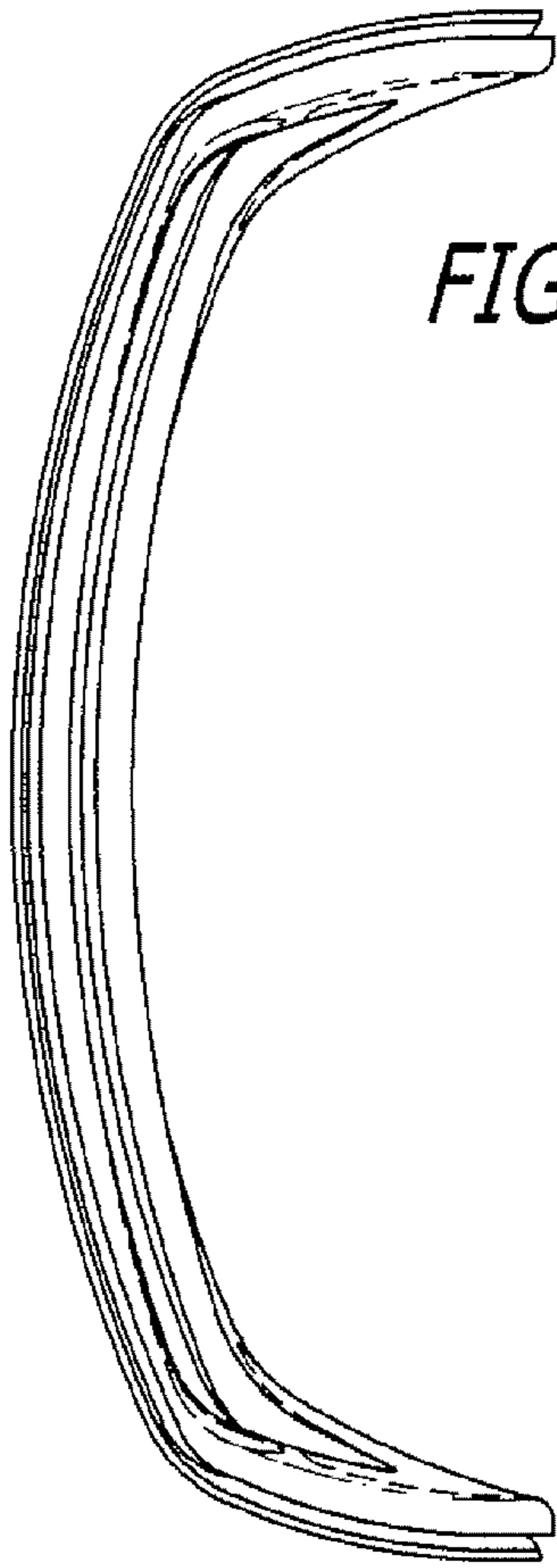

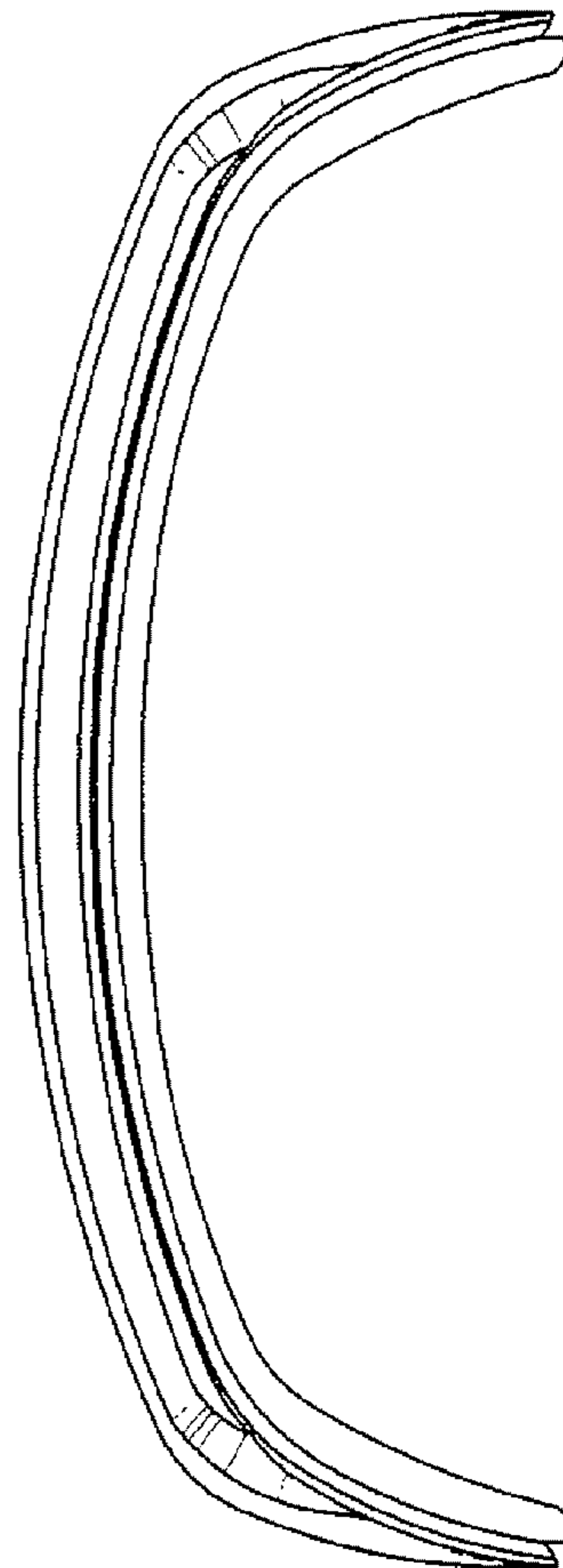
