(57) **CLAIM**

The ornamental design for a pan, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a pan showing my new design;  
FIG. 2 is a front view thereof, the back view being mirror images thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is an enlarged cross sectional view along axis 6-6 thereof; and,  
FIG. 7 is an enlarged view of a portion of the cross section thereof.

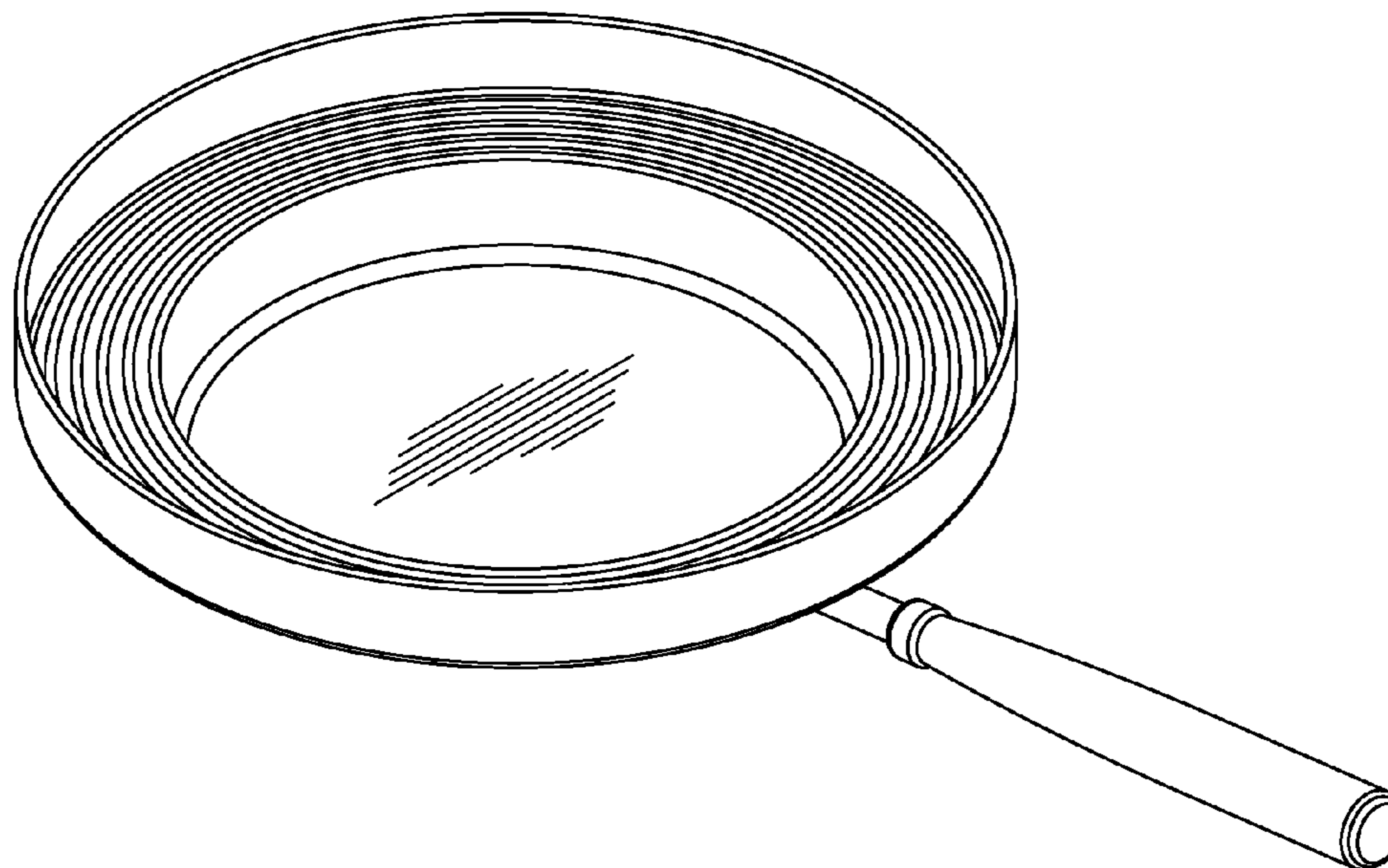

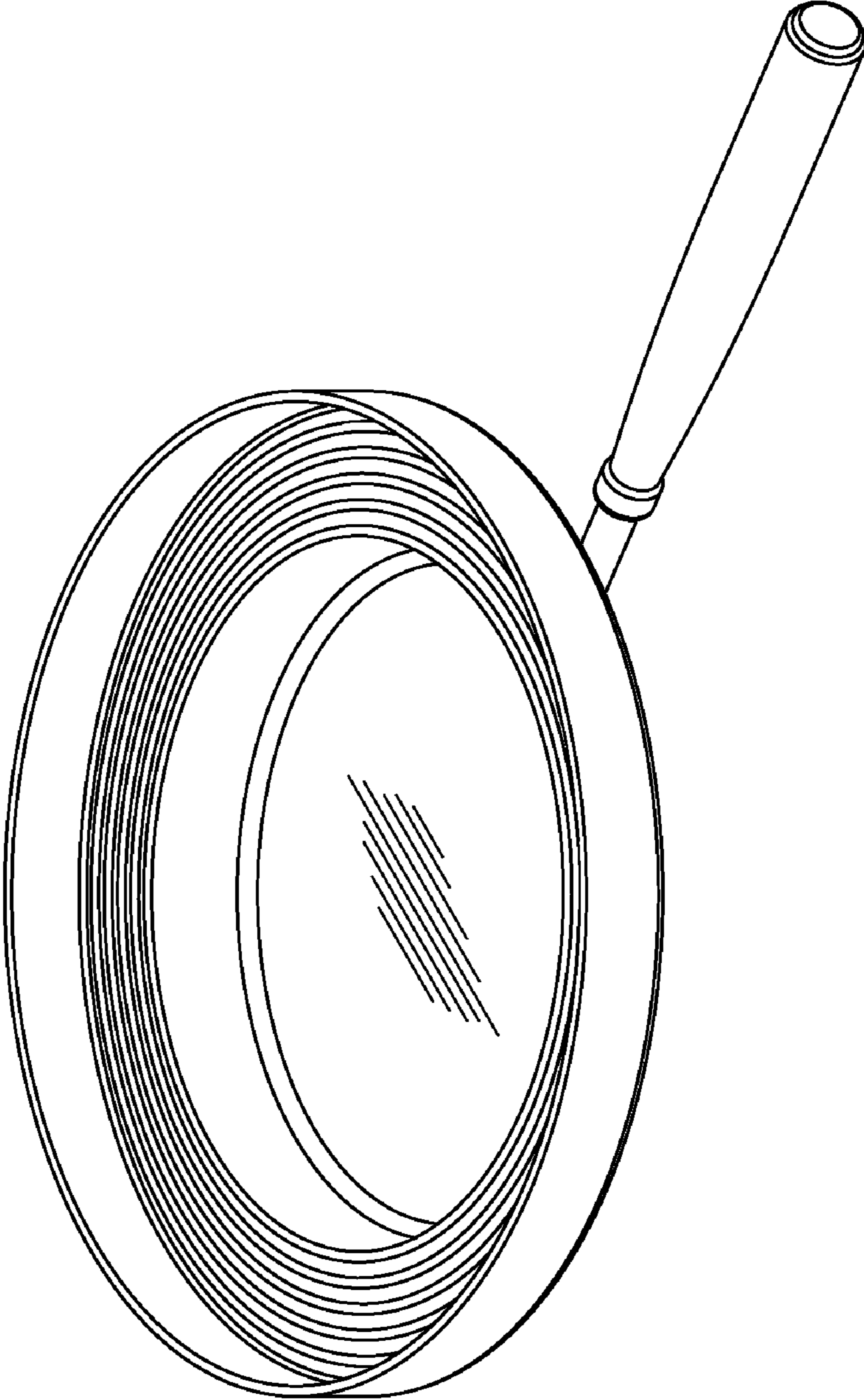

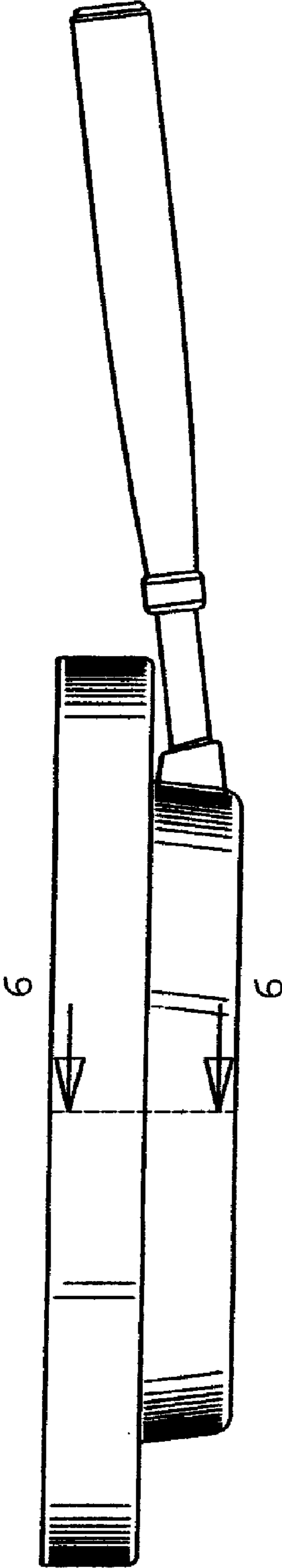

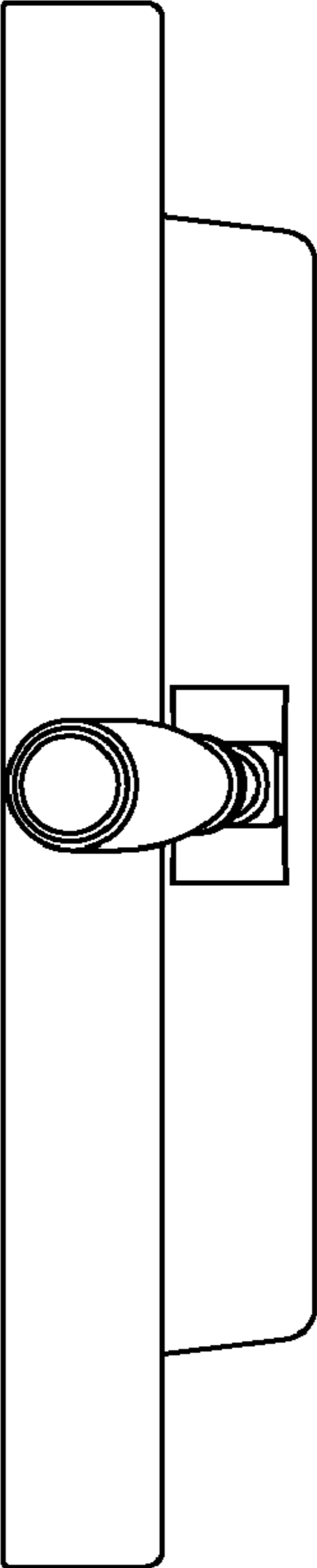

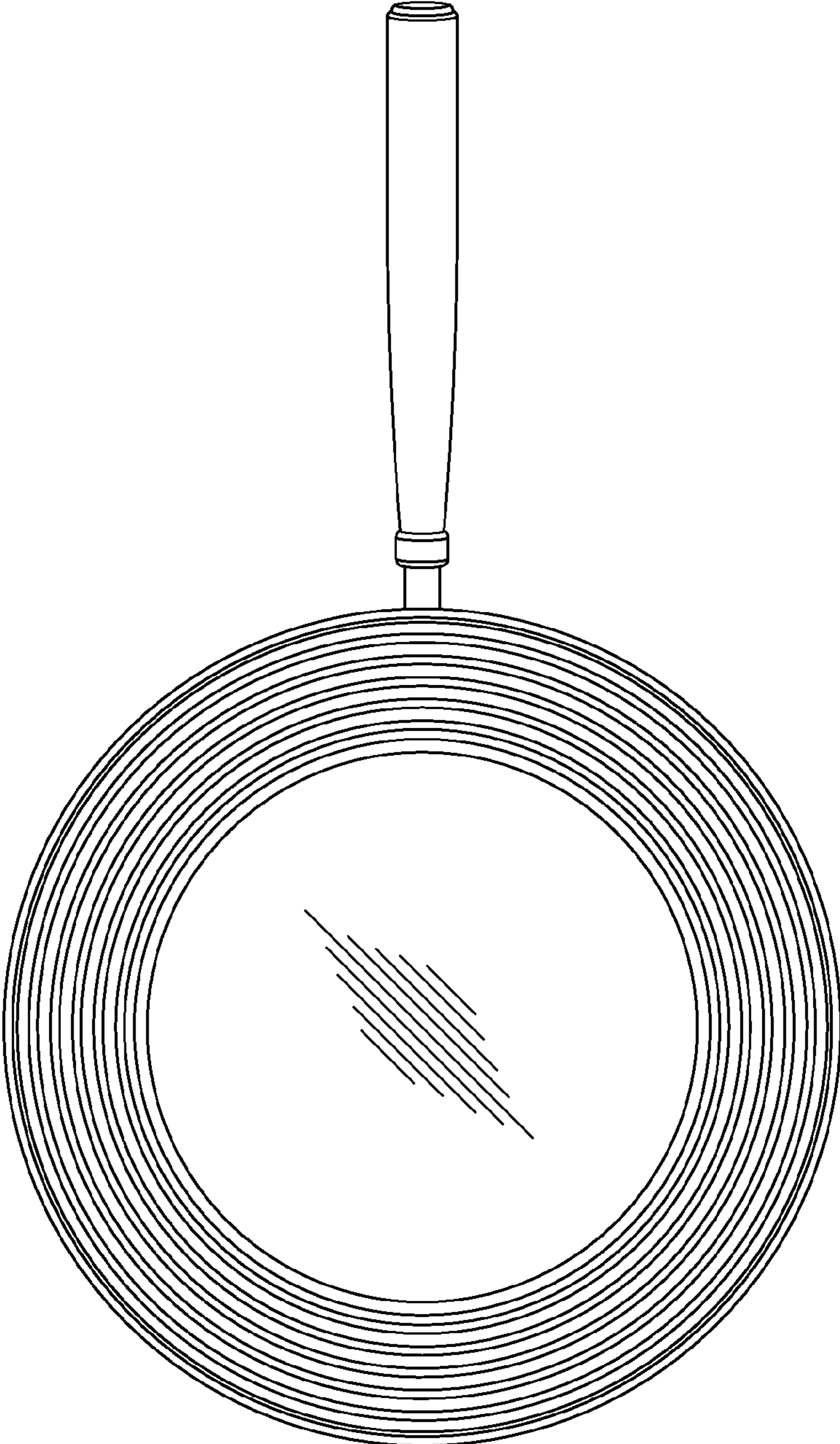

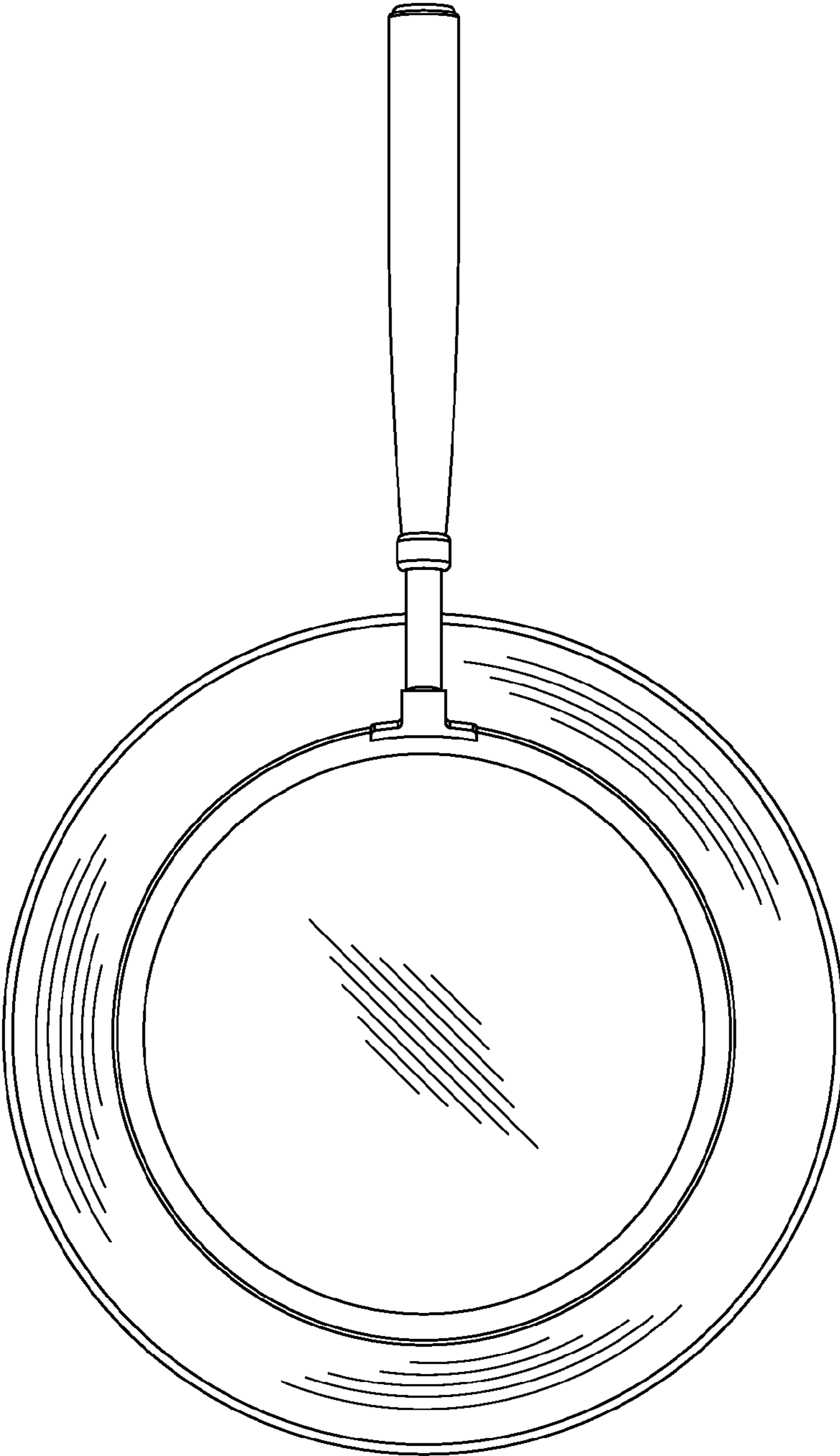

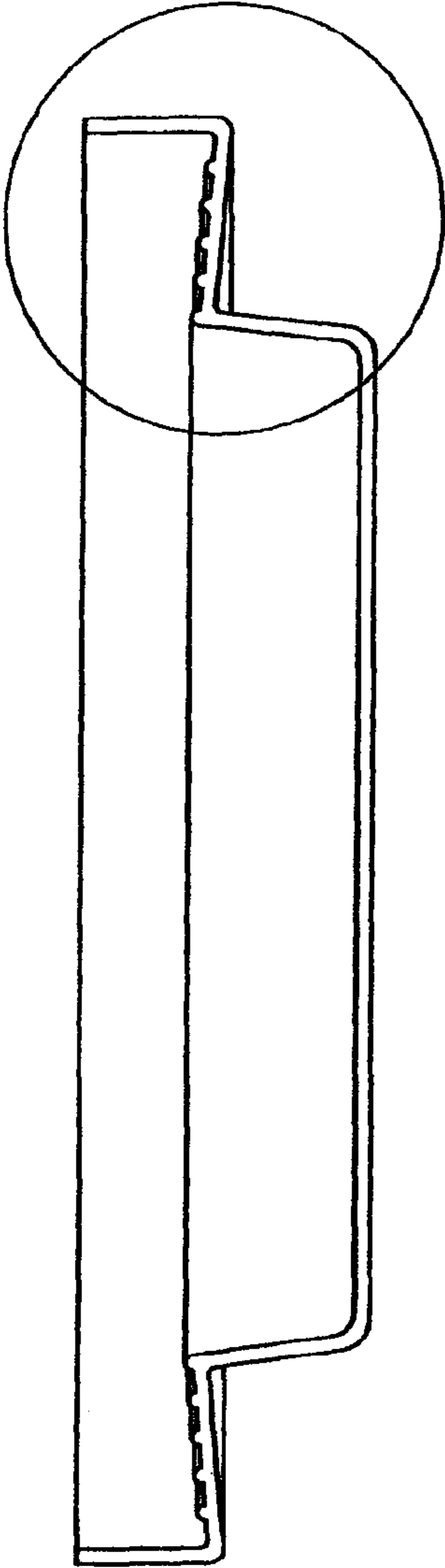
