(57) **CLAIM**

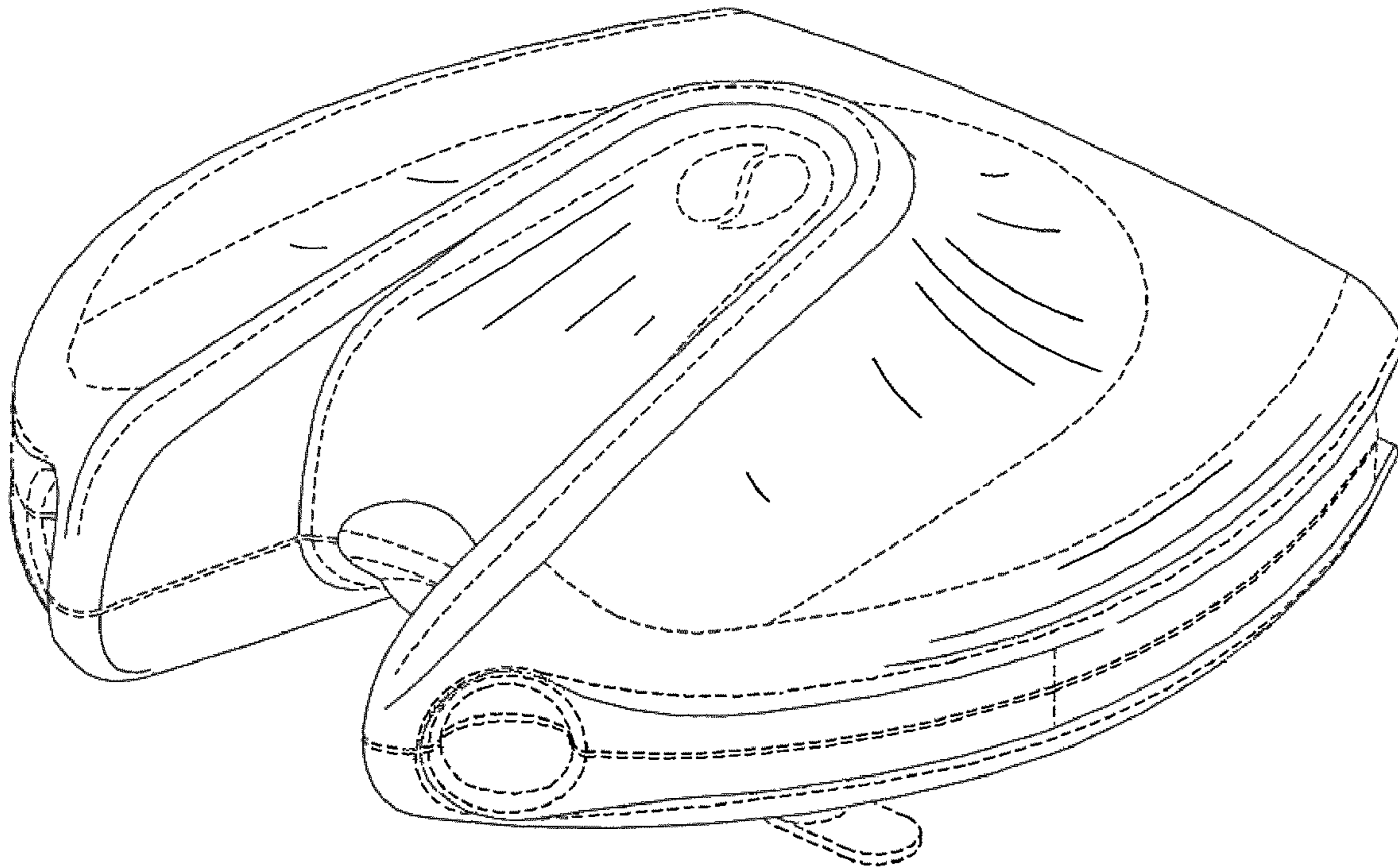
The ornamental design for the fortune cookie appliance, as shown and described.

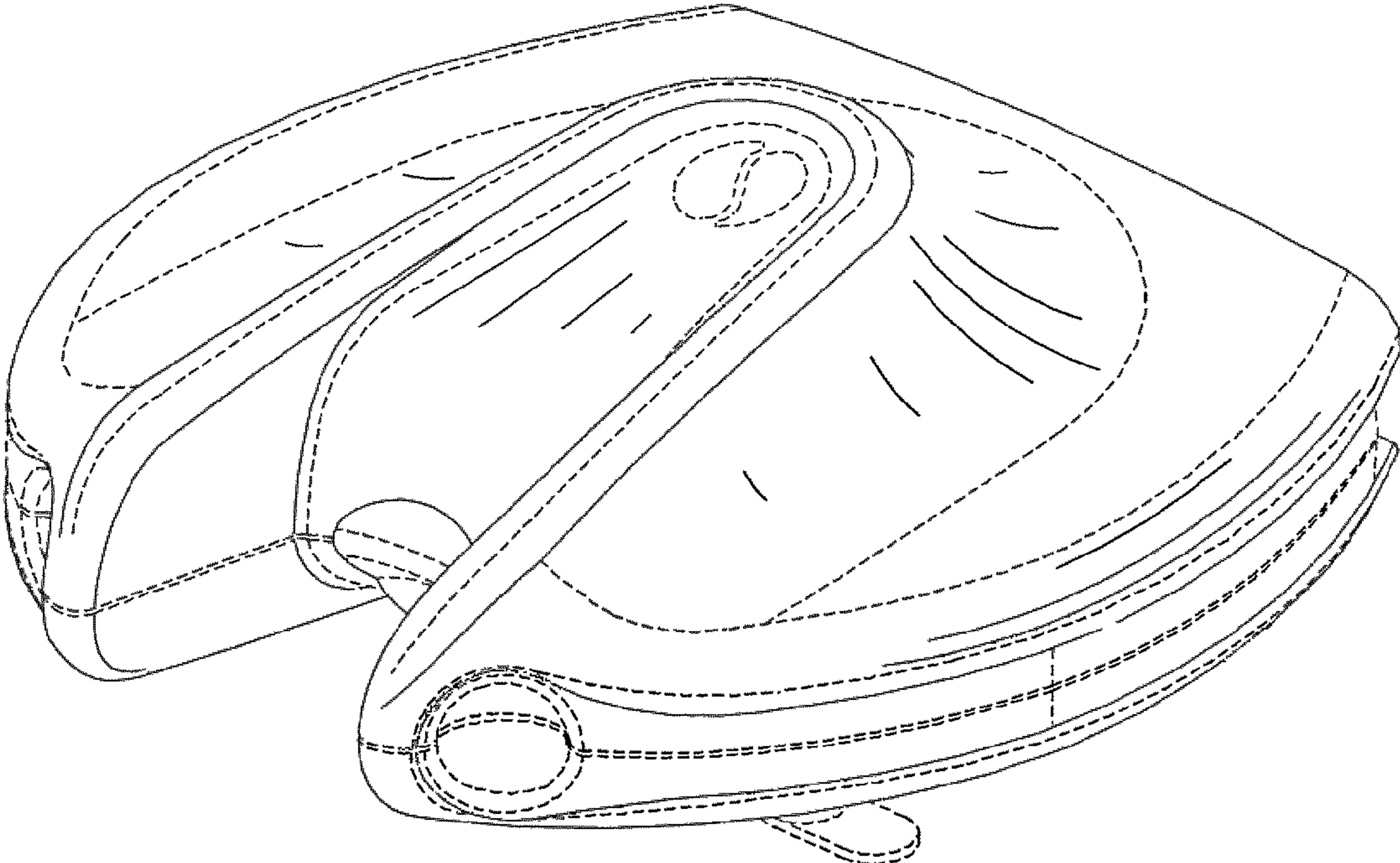

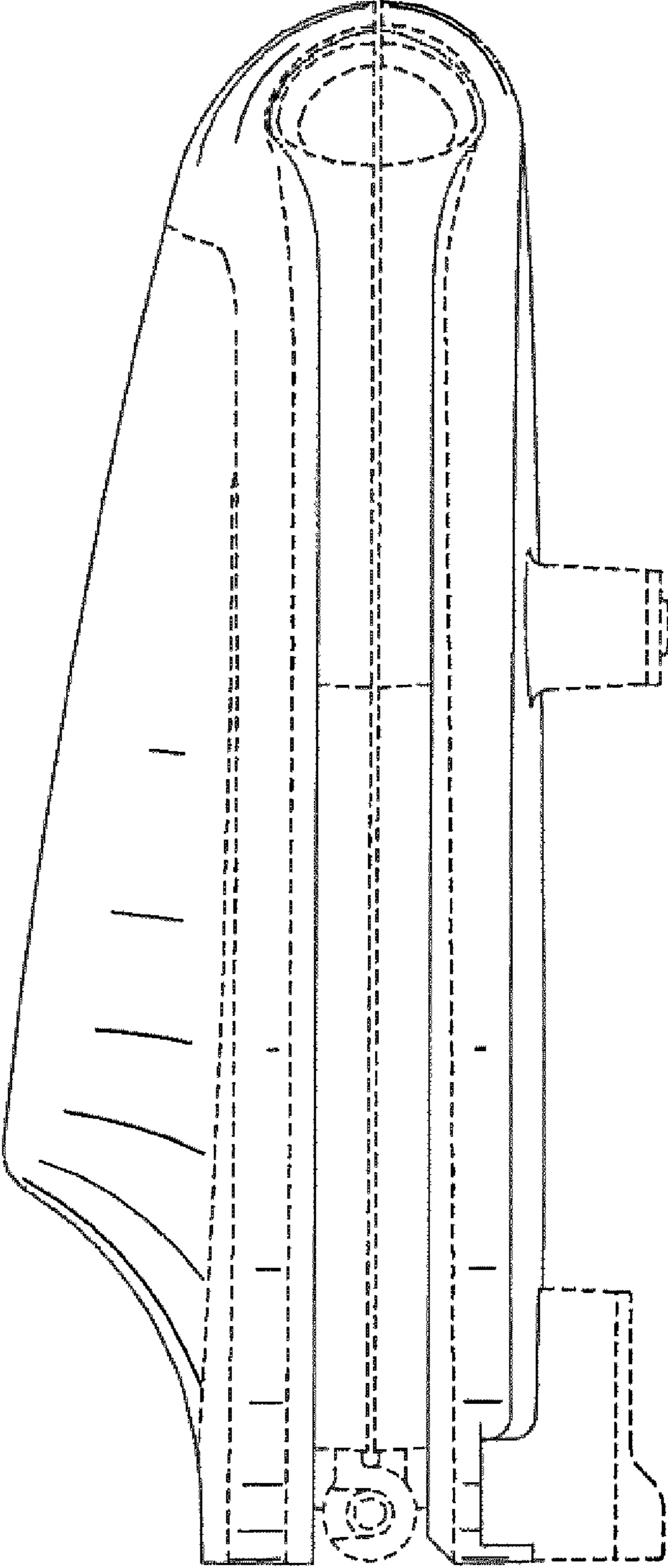

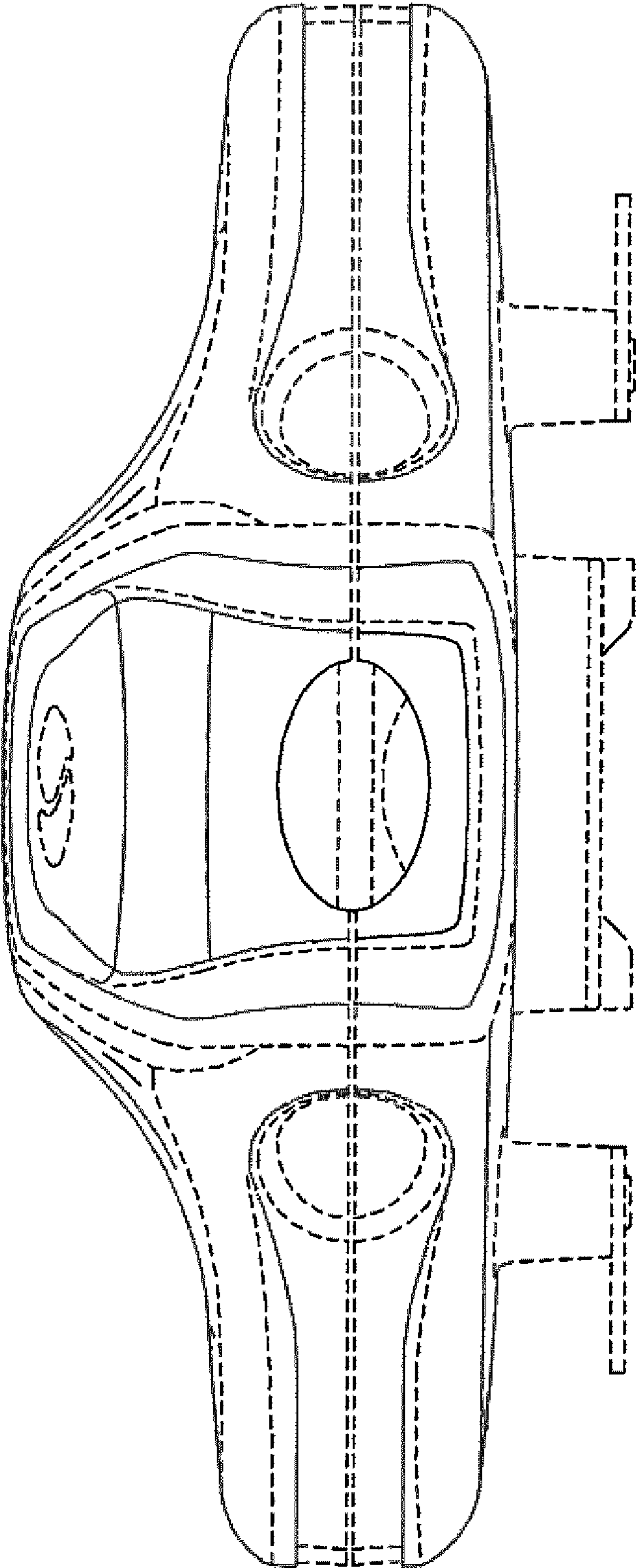

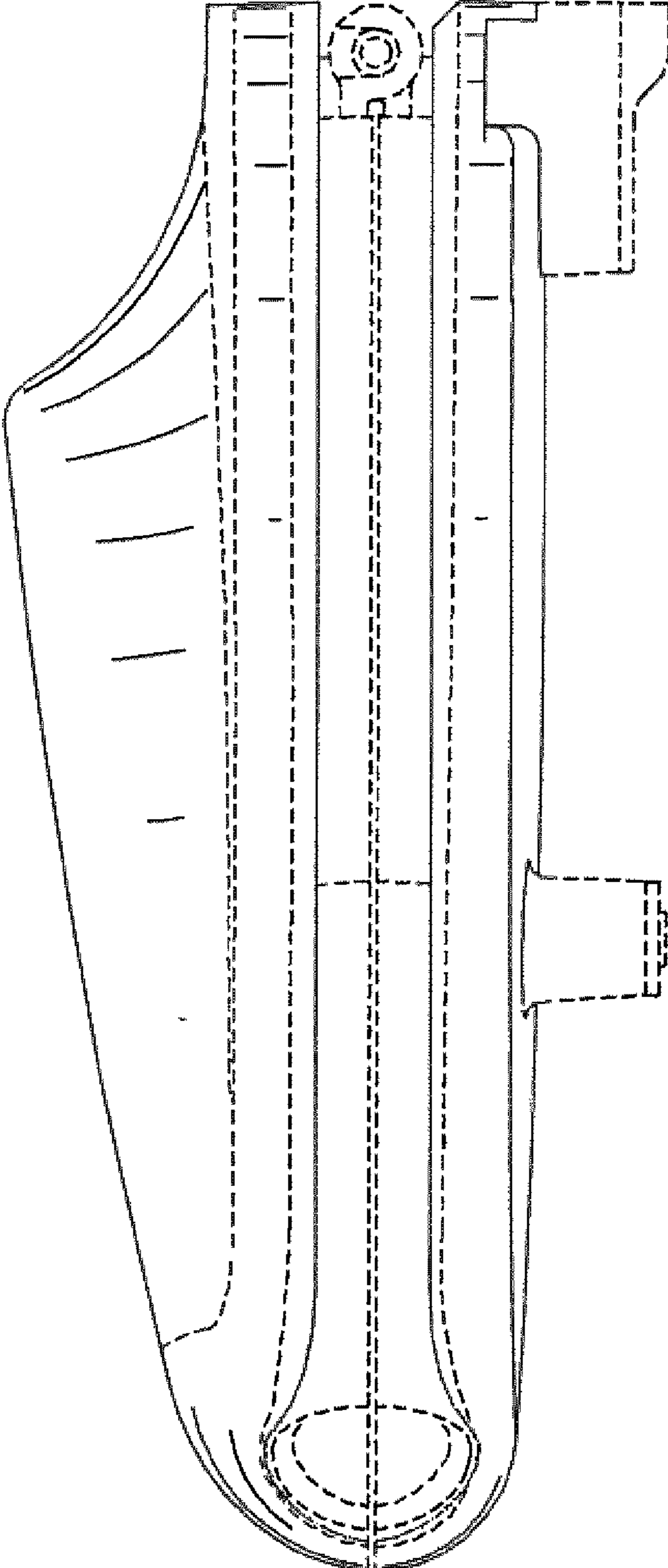

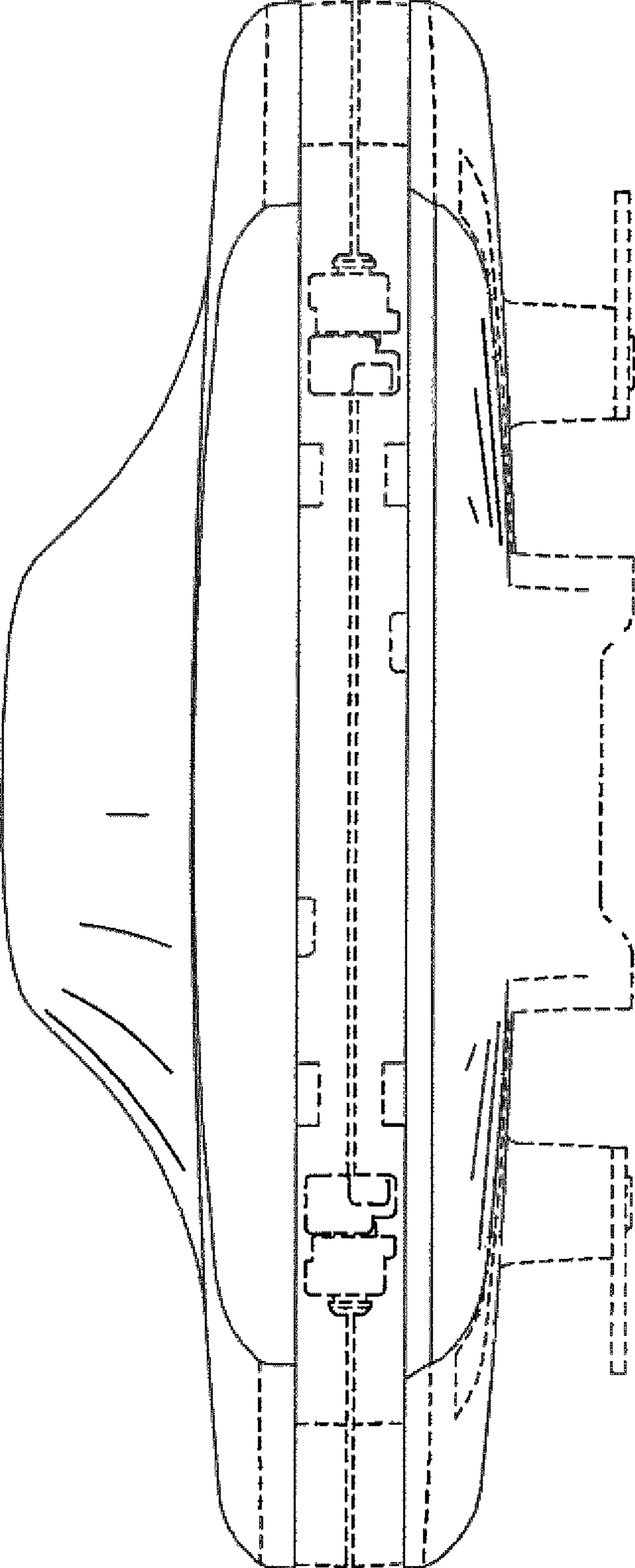

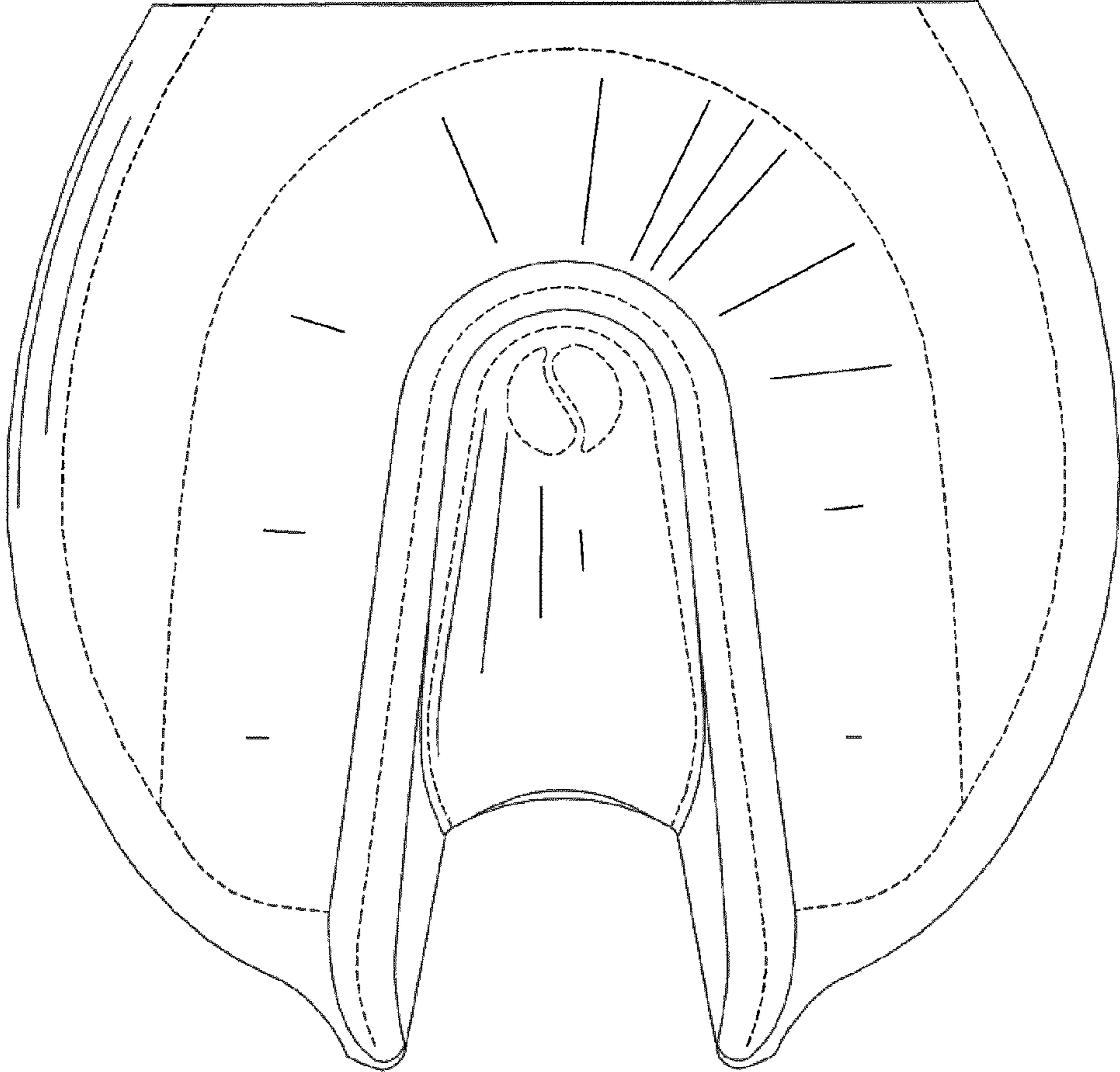

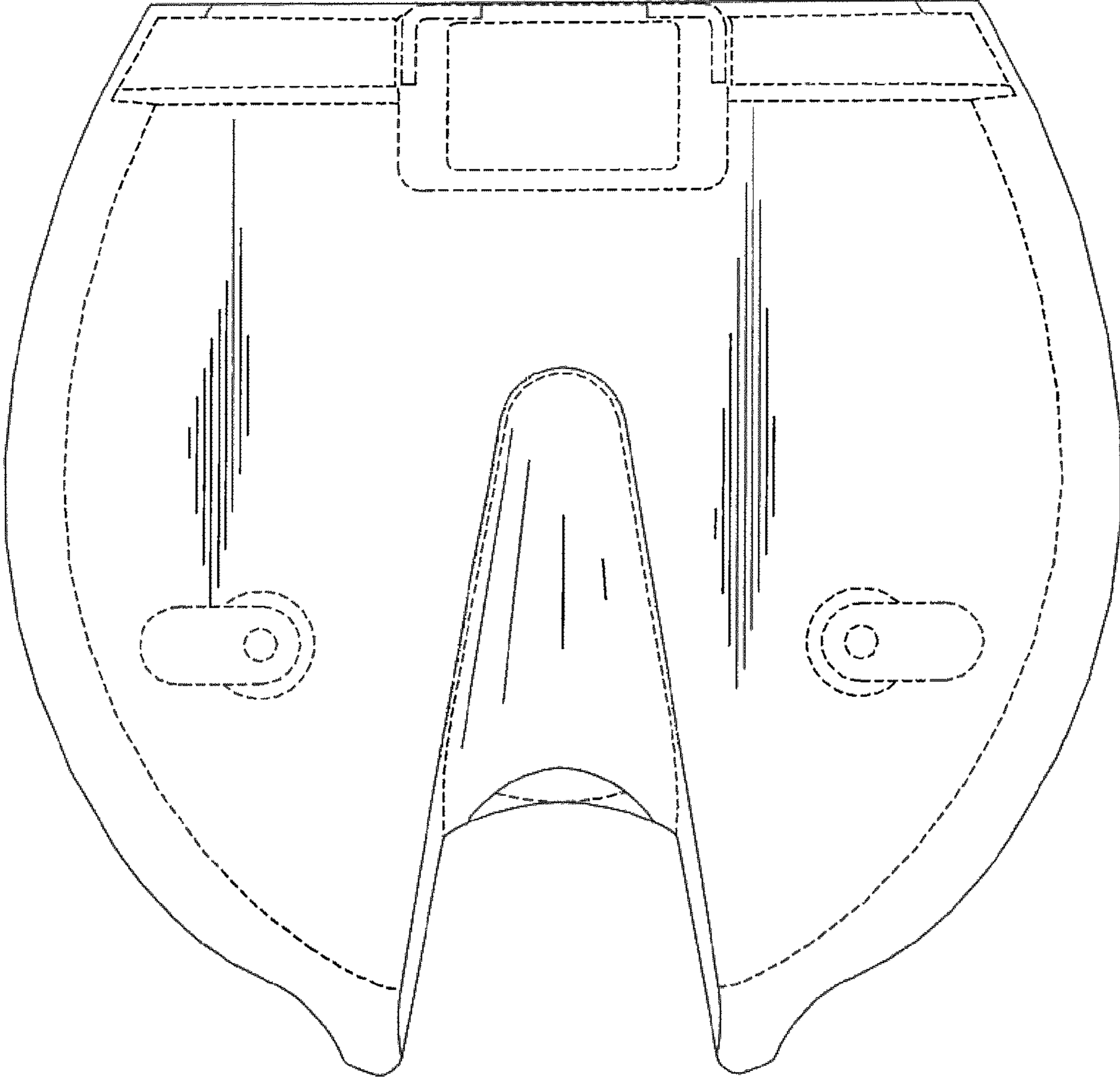
