FIG. 1 is a perspective front view of the cup;

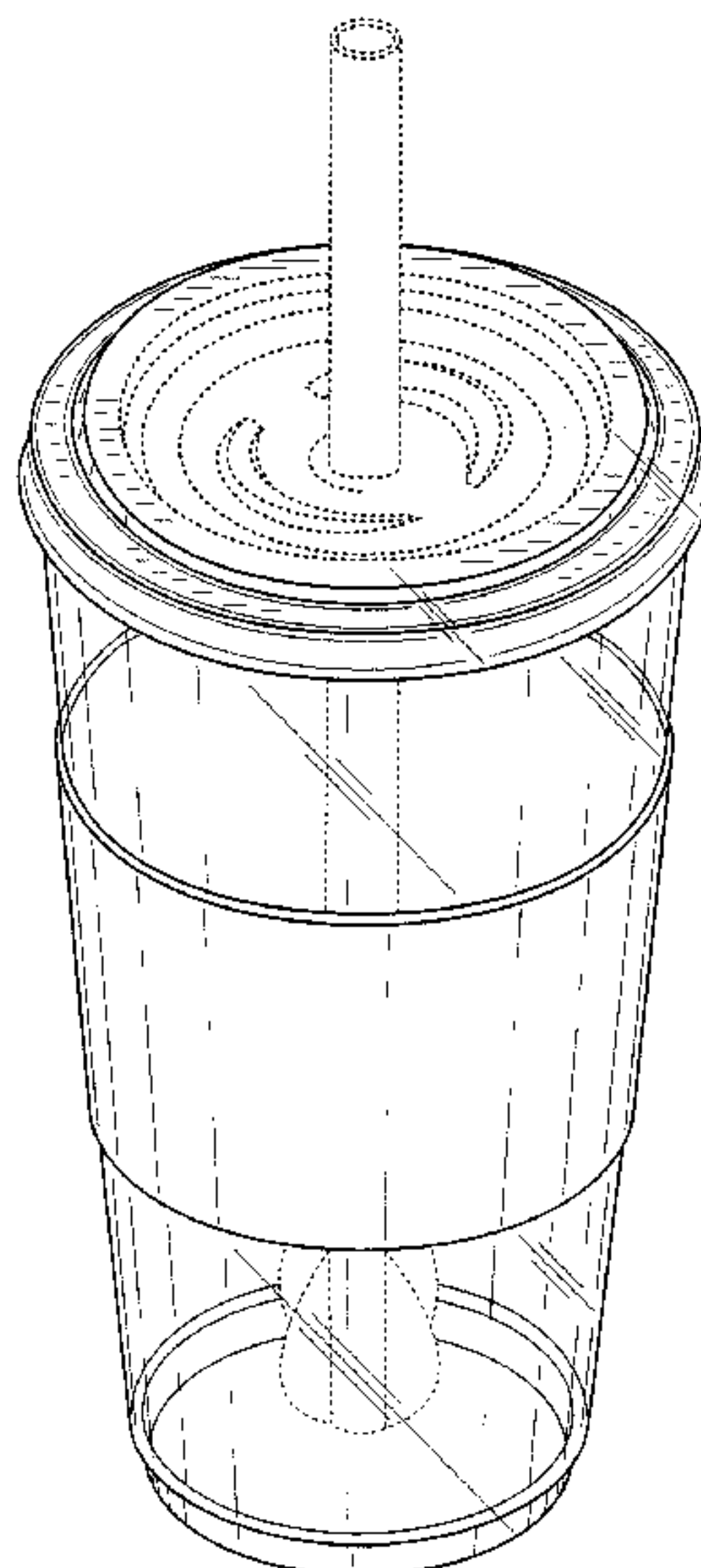
FIG. 2 is a side view of FIG. 1;

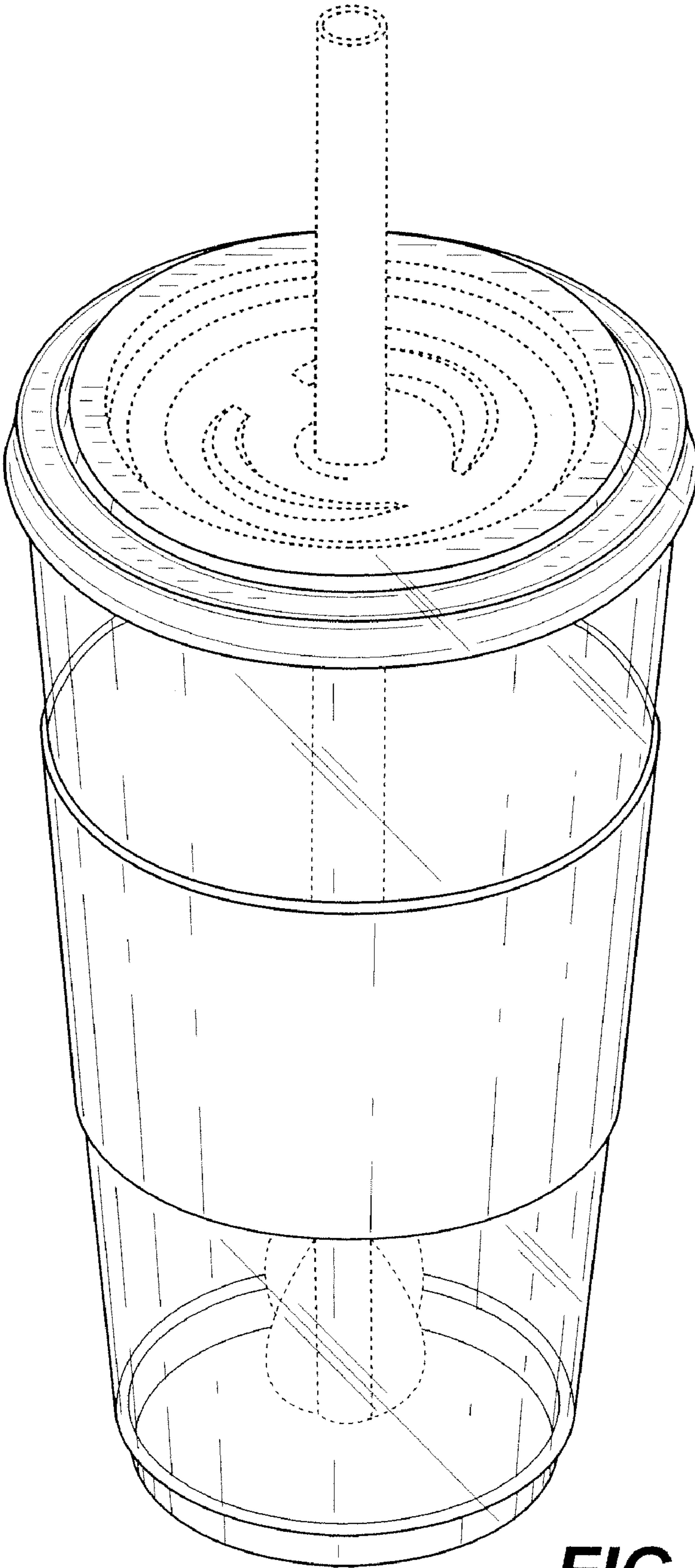

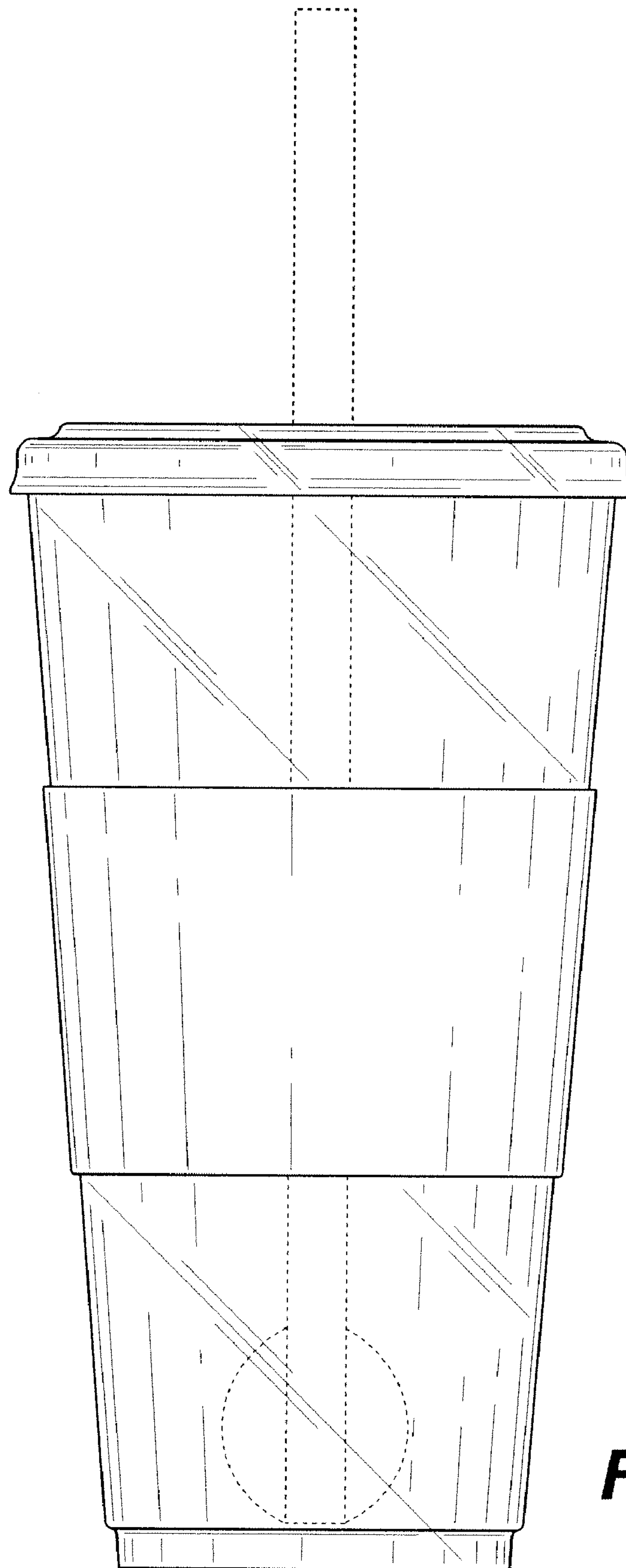

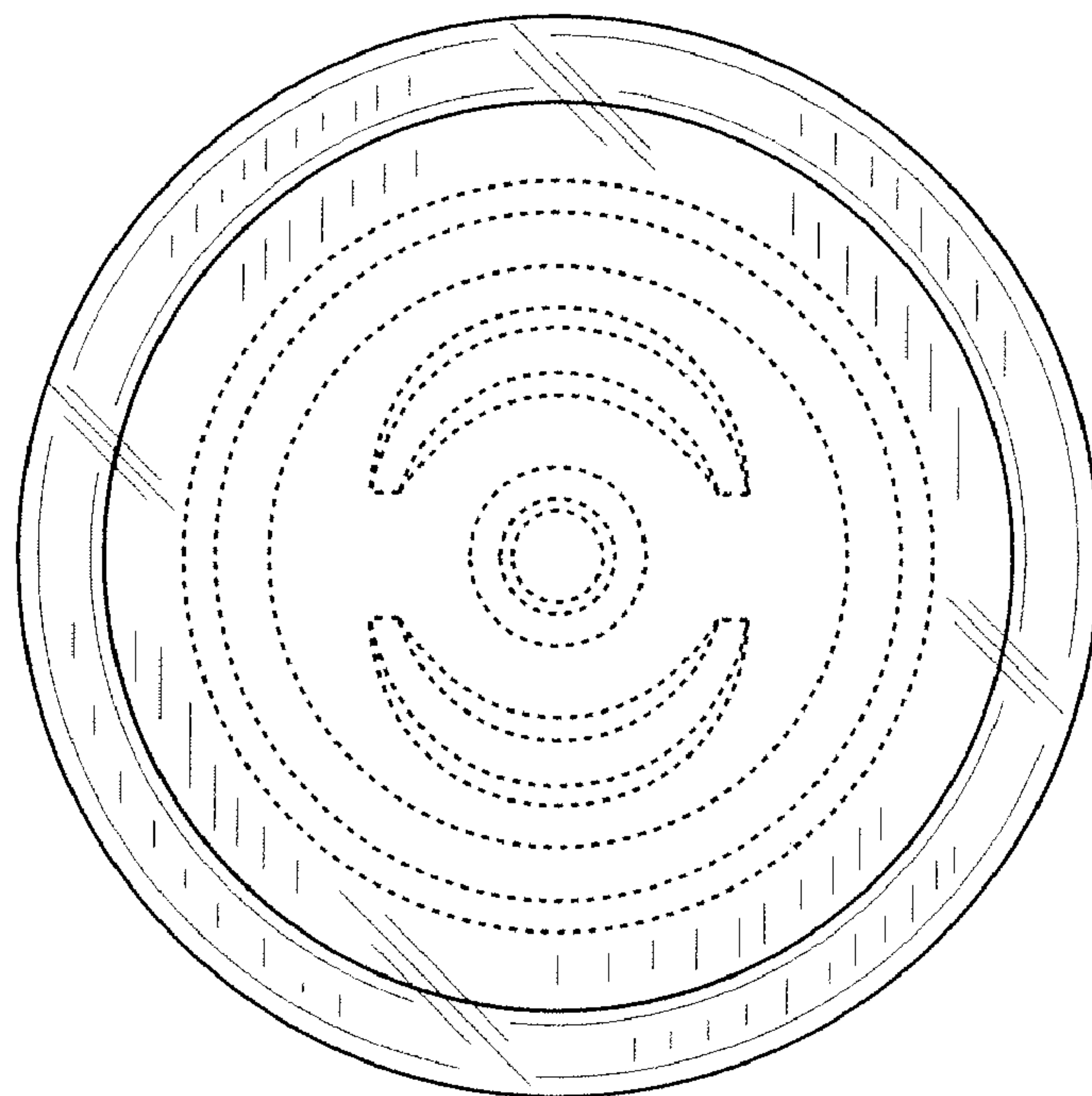

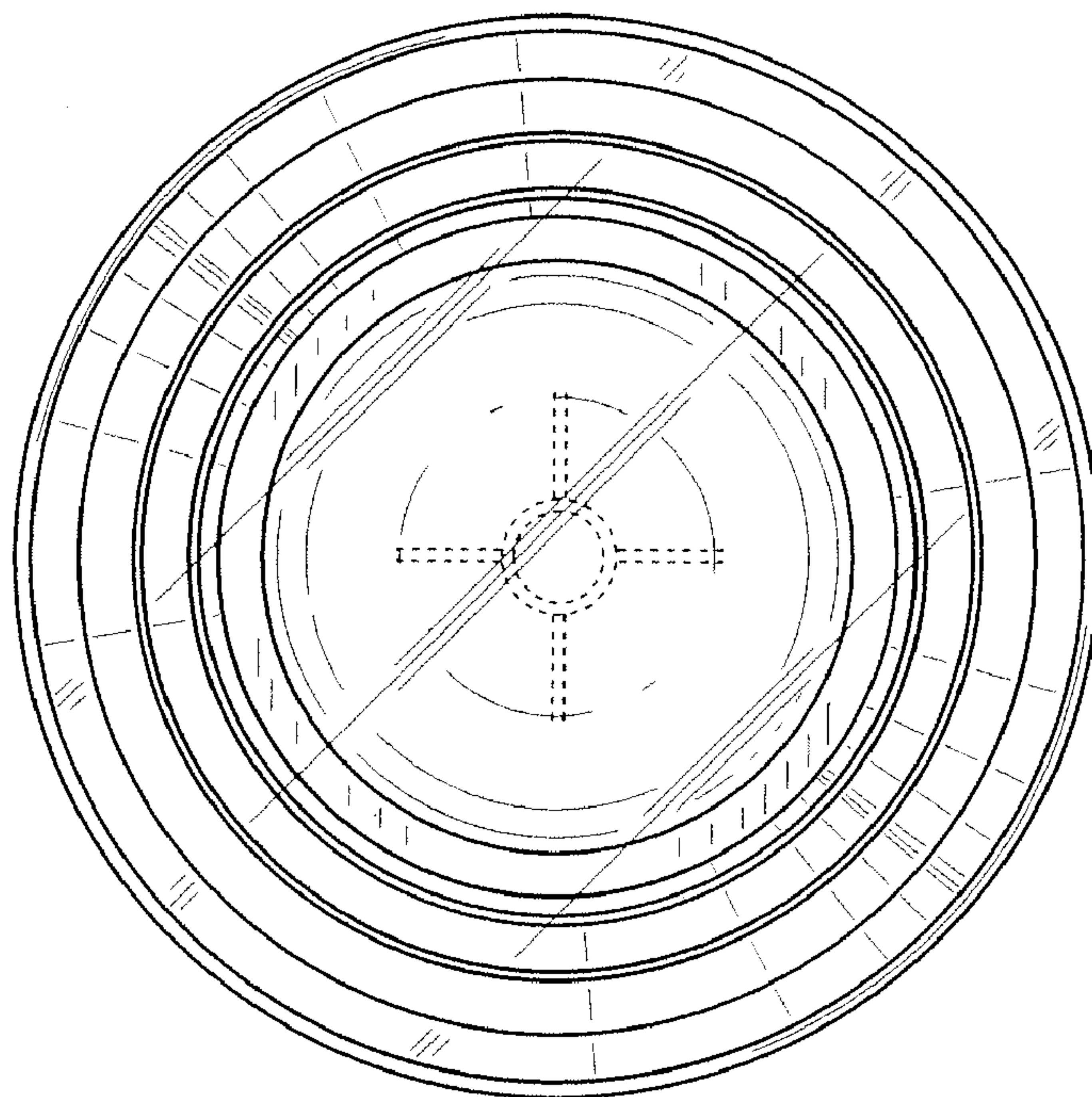
