(57) **CLAIM**

We claim the ornamental design for a portable angle impact tool, as shown and described.

**DESCRIPTION**

FIG. 3 is a front view of the portable angle impact tool shown in FIG. 1.

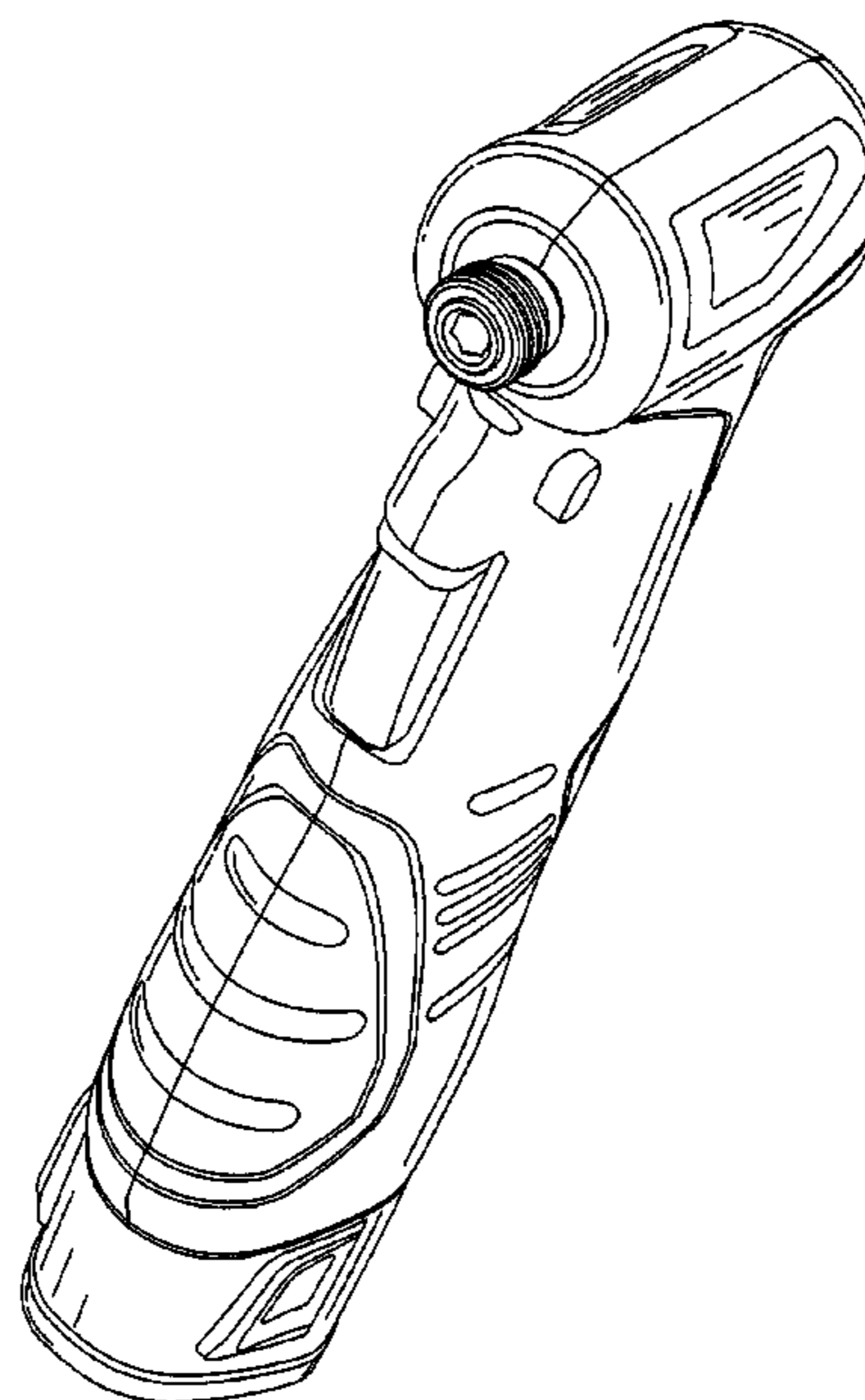
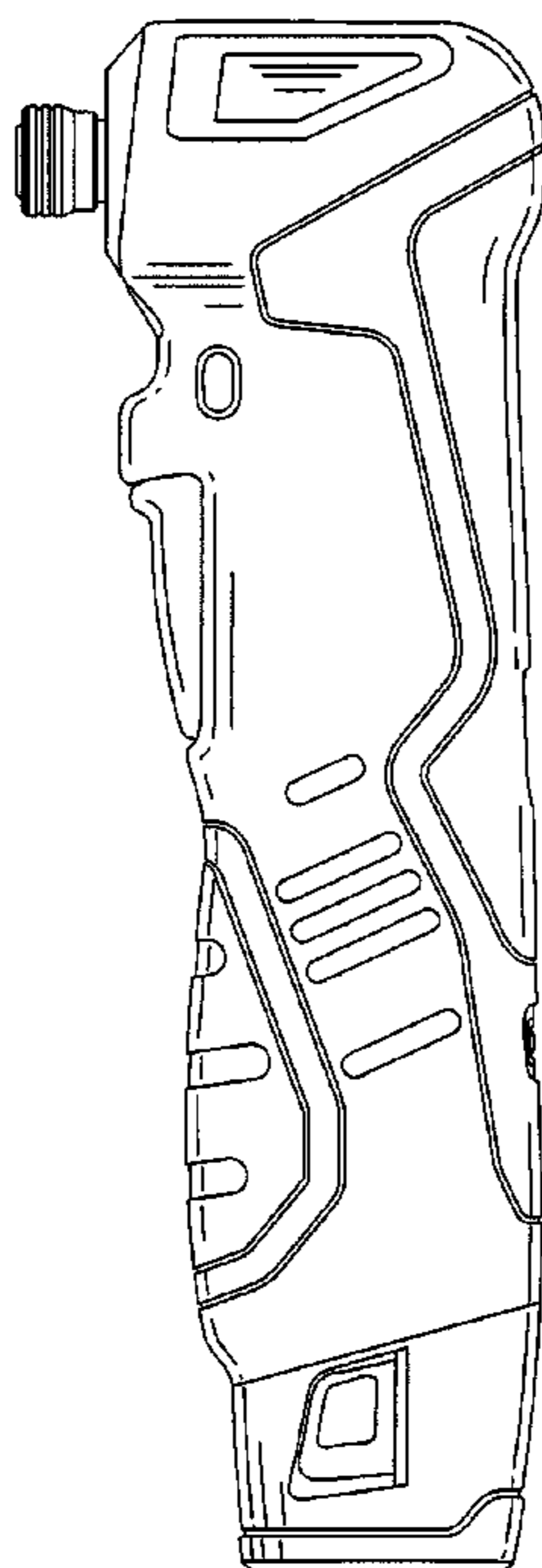
FIG. 4 is a rear view of the portable angle impact tool shown in FIG. 1.

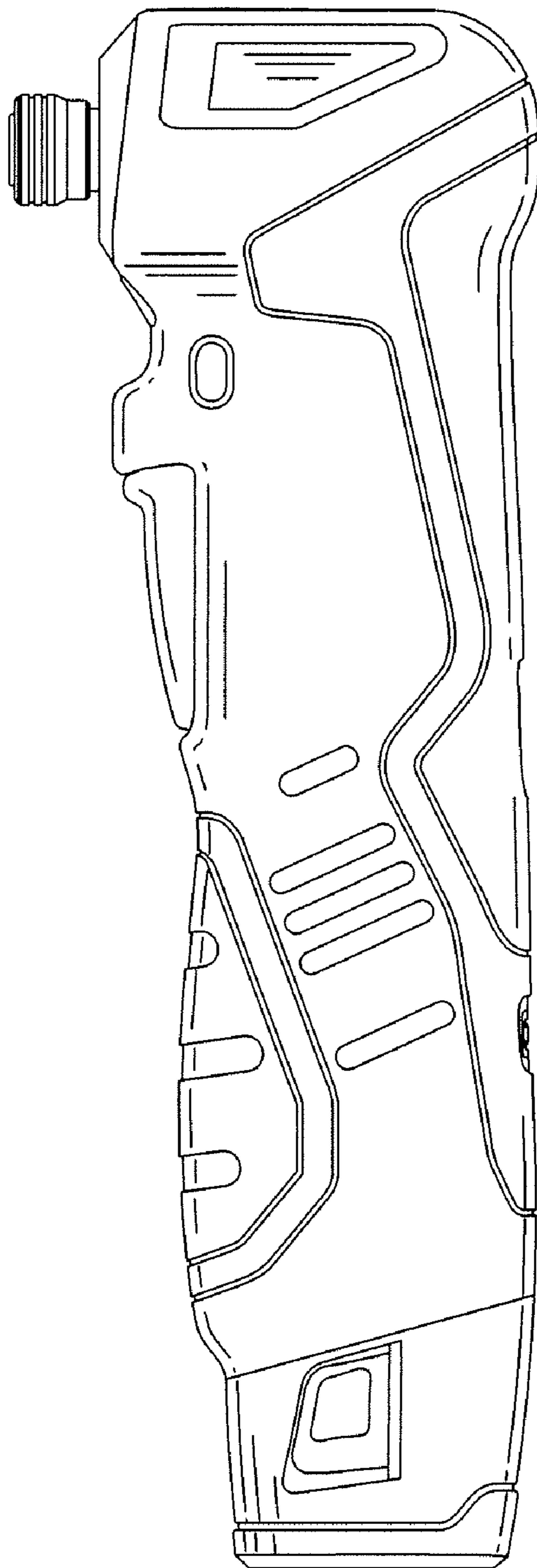

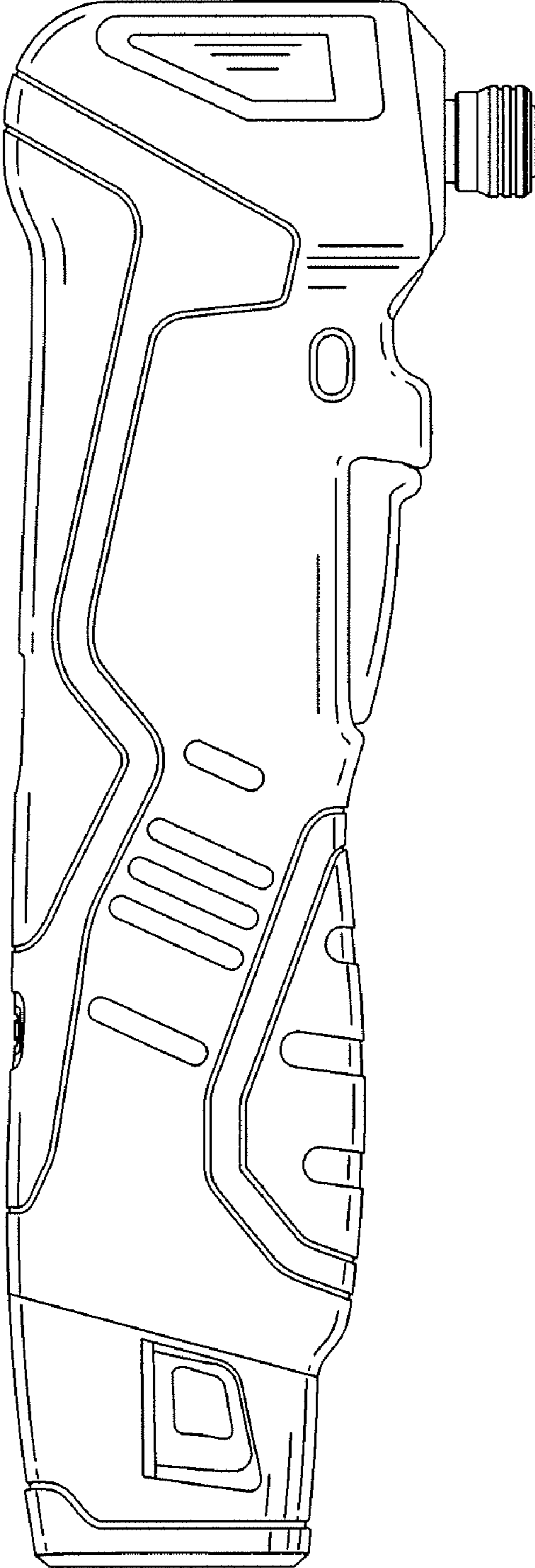

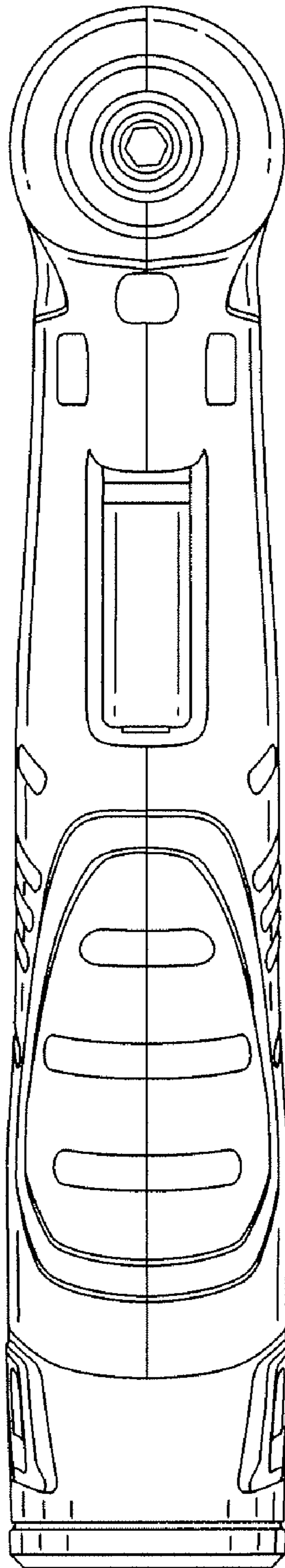

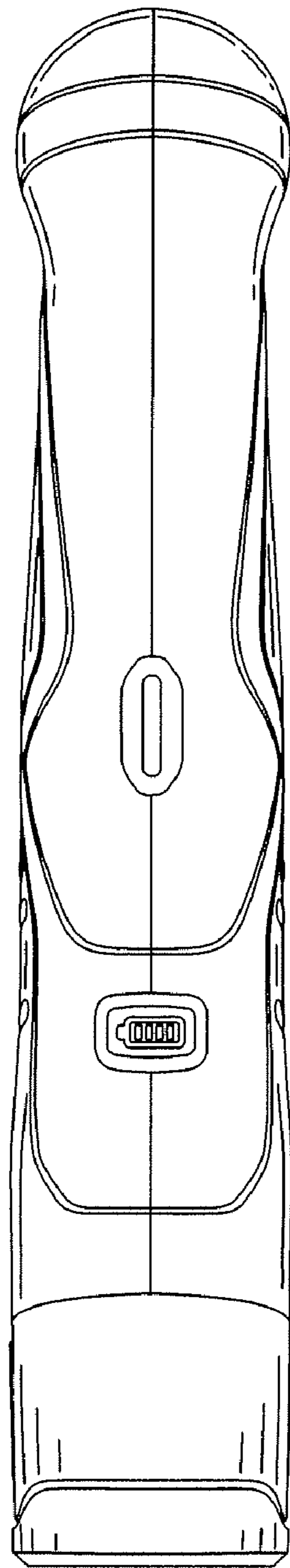

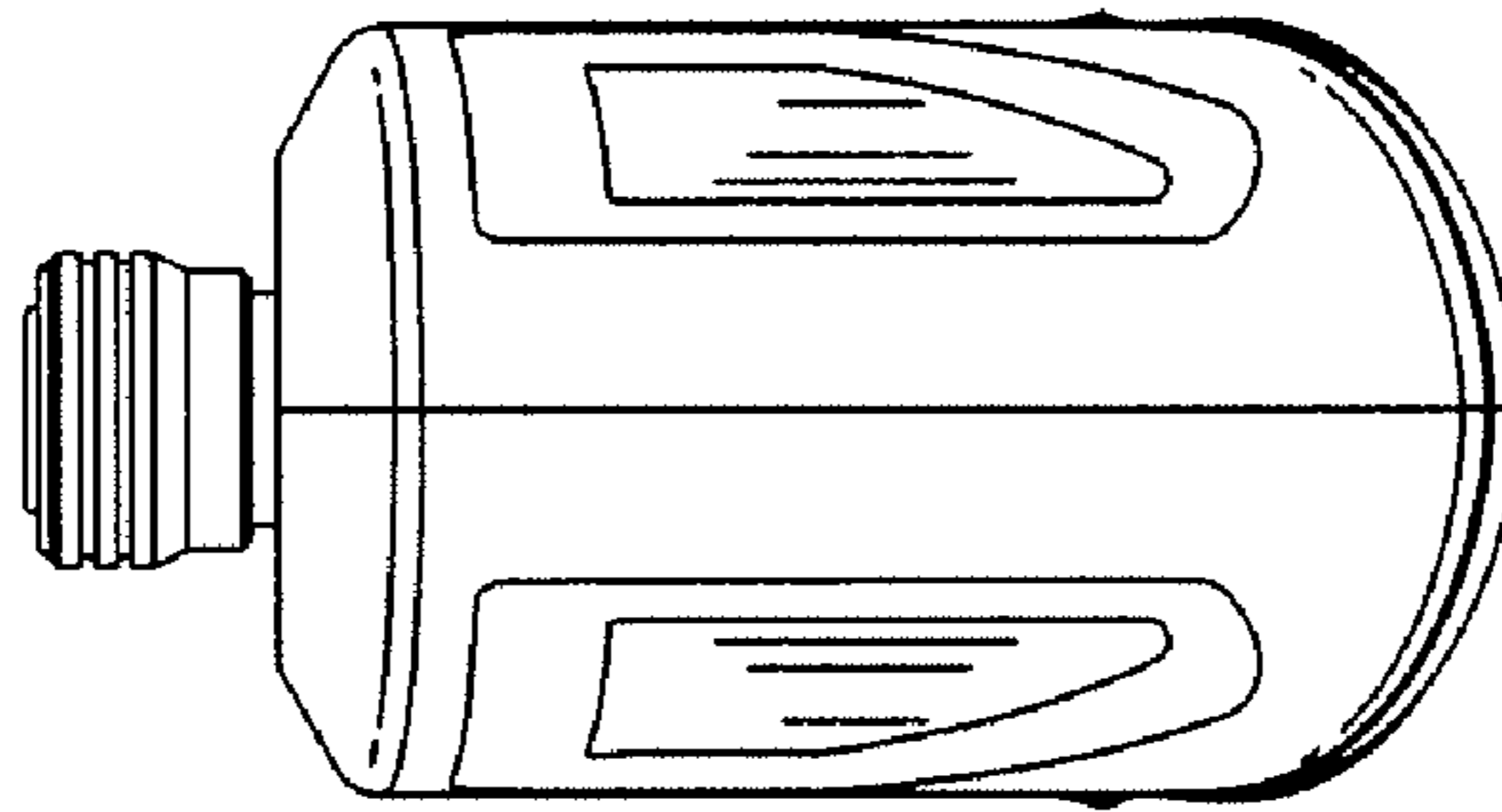

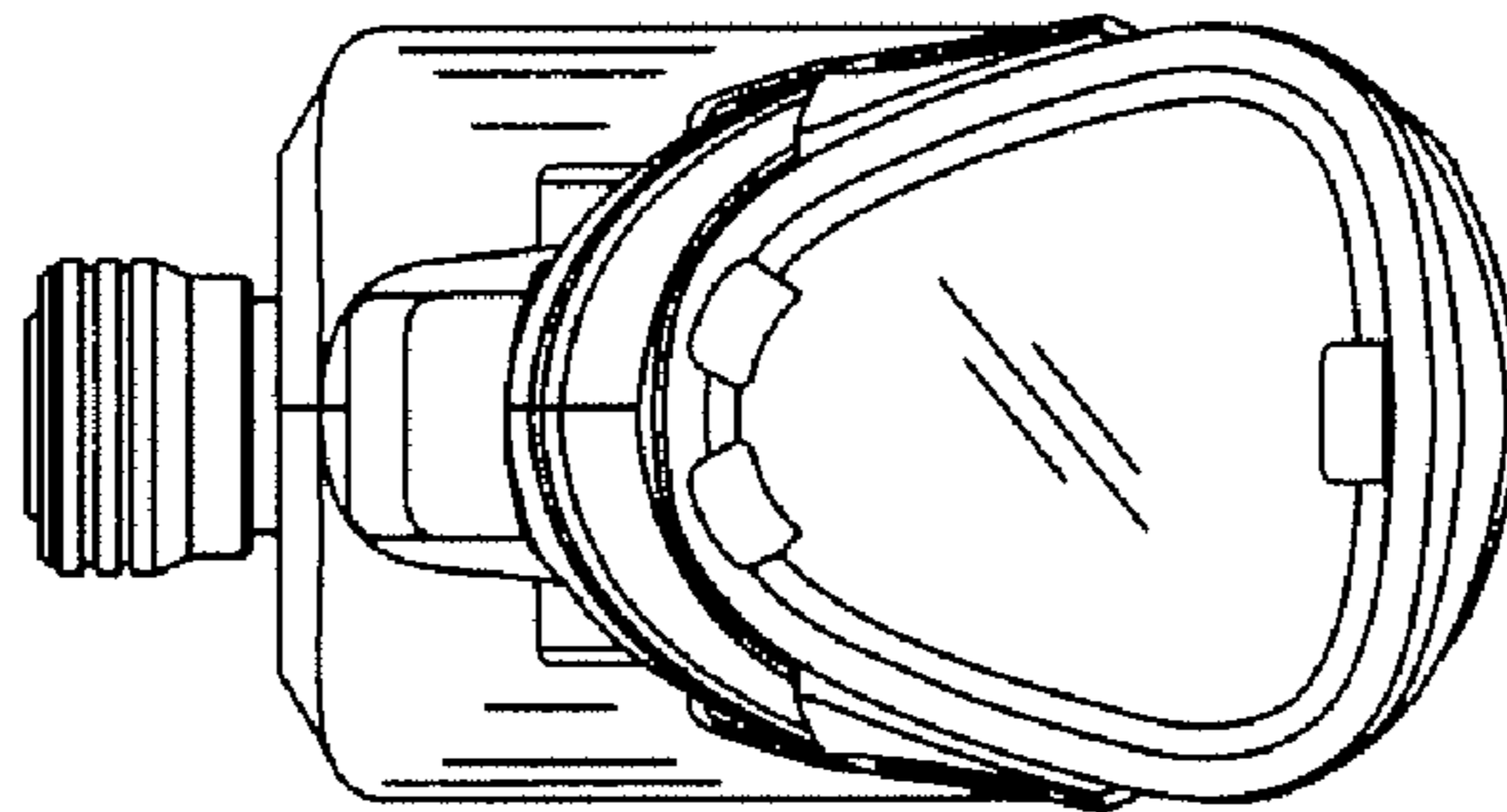

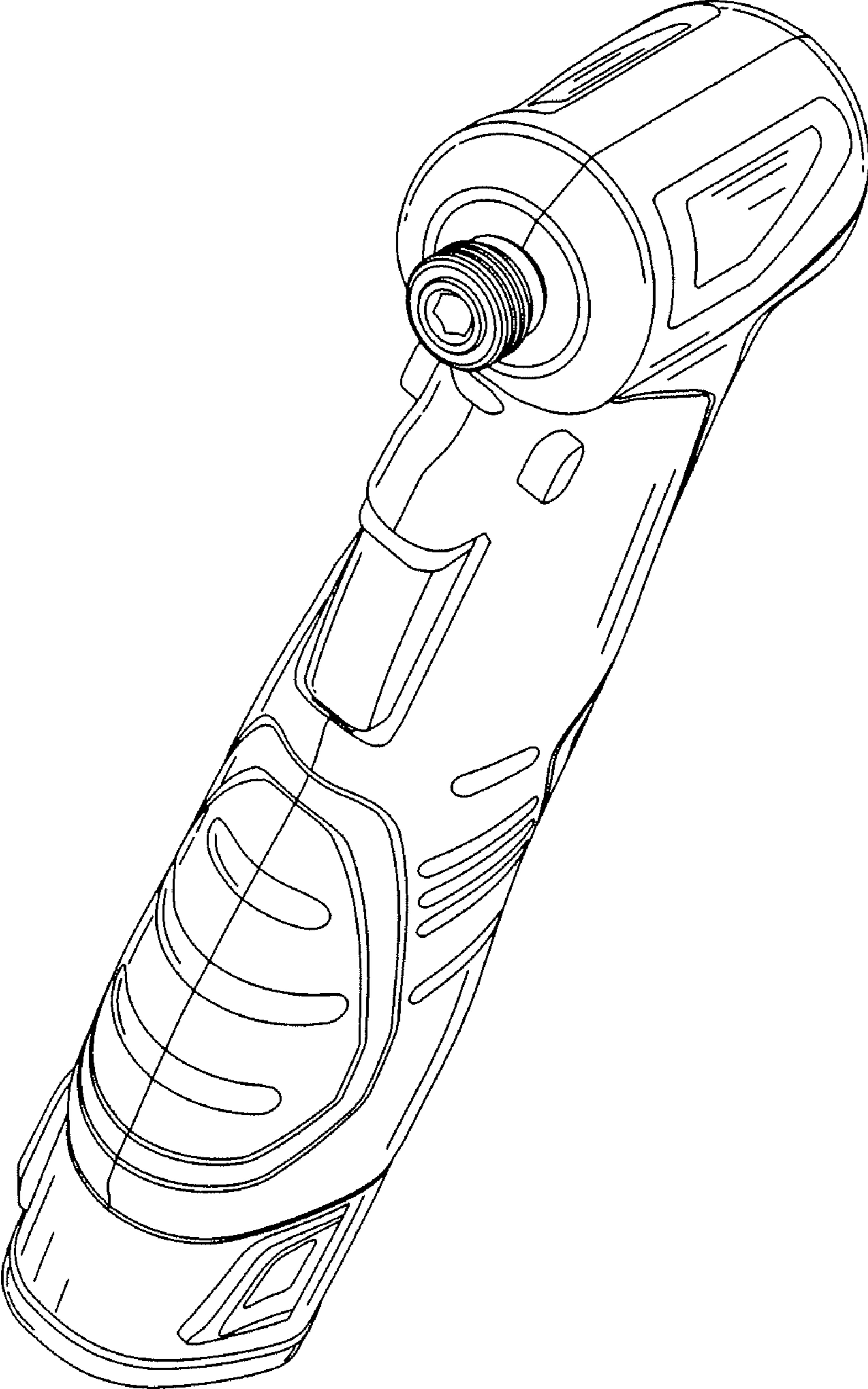
