(57) **CLAIM**

I claim the ornamental design for a locking bar, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a locking bar;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image;
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image; and,
FIG. 5 is a front side elevational view thereof.

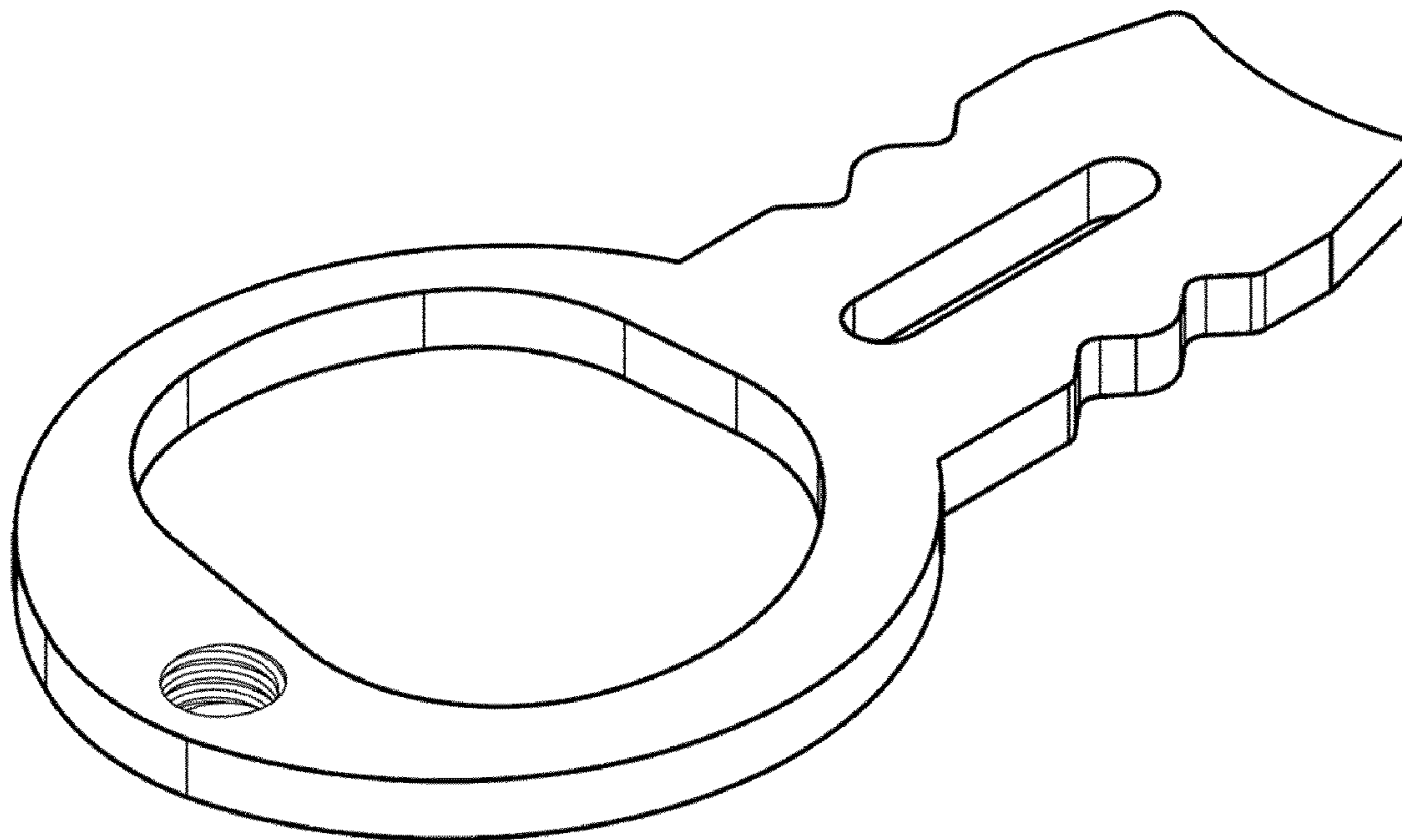

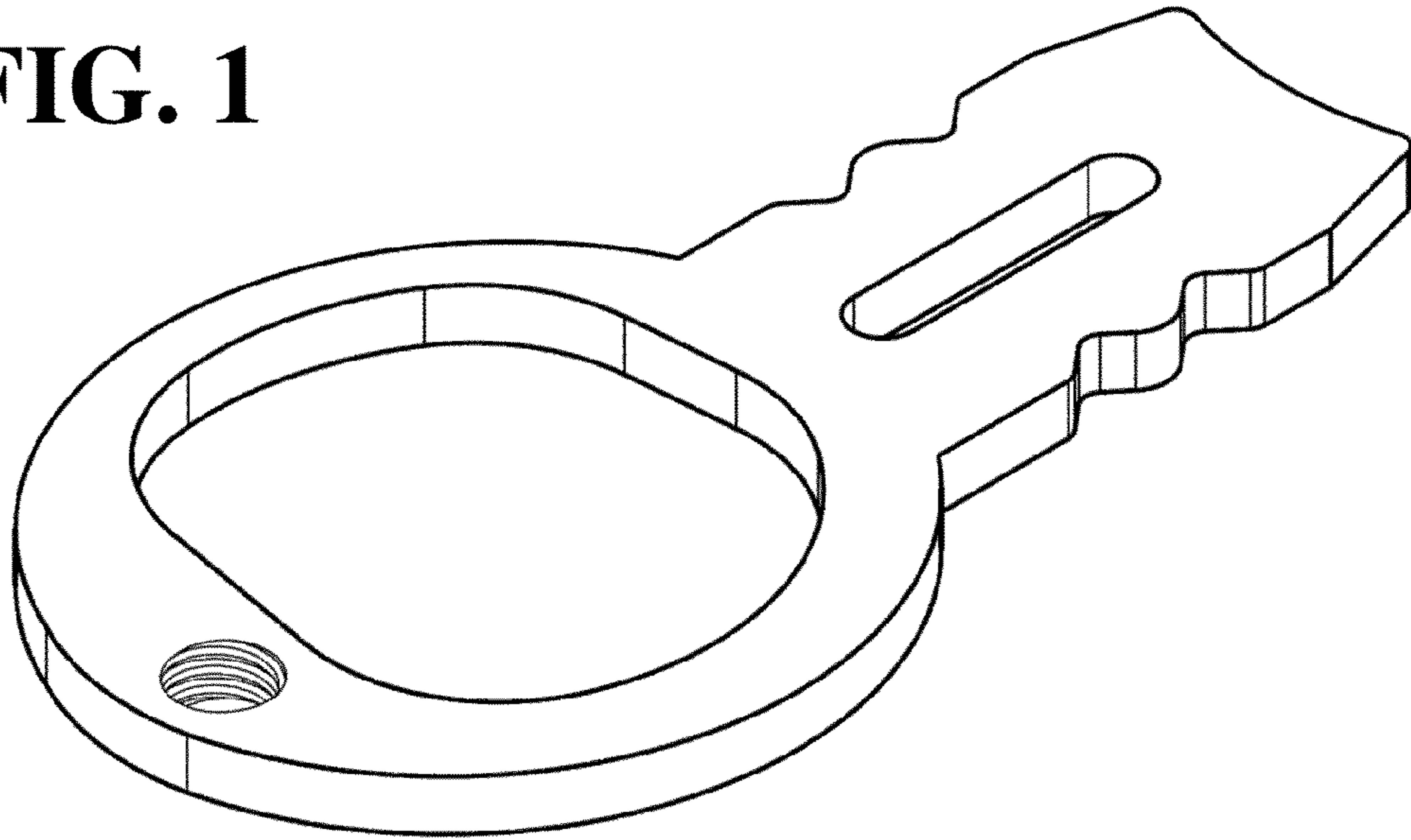

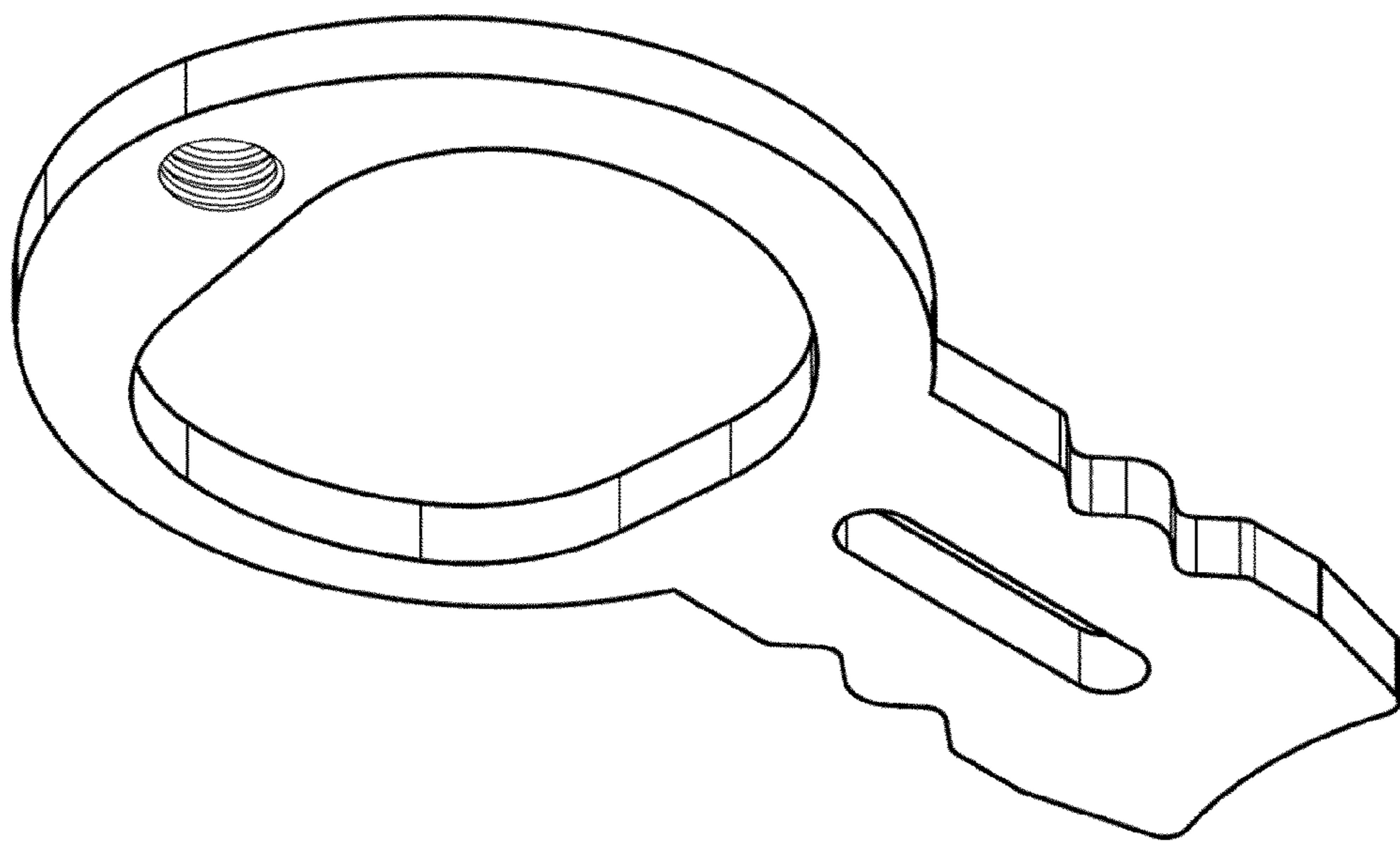

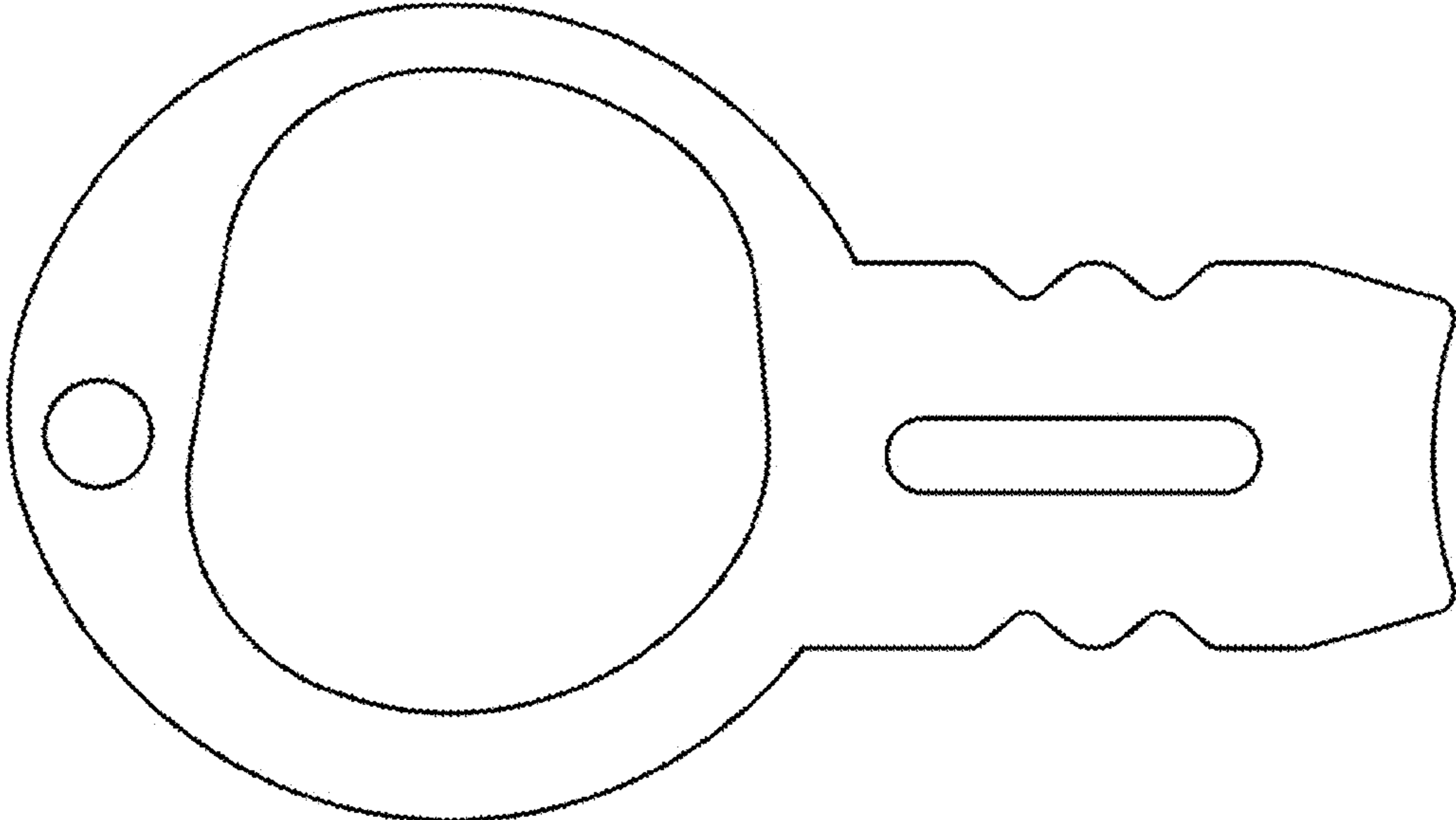

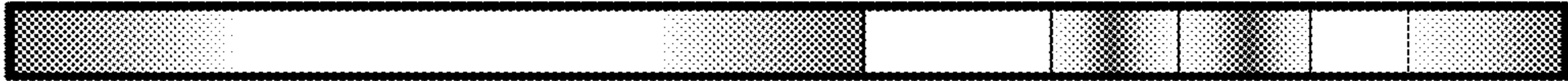
