DESCRIPTION

FIG. 1 is an elevated perspective view of a label artwork in accordance with the present invention;

FIG. 4 is right side view of a label artwork in accordance with the present invention, as shown in FIG. 1;

FIG. 5 is a left side view of a label artwork in accordance with the present invention, as shown in FIG. 1;

FIG. 6 is a top side view of a label artwork in accordance with the present invention, as shown in FIG. 1;

FIG. 7 is a bottom side view of a label artwork in accordance with the present invention, as shown in FIG. 1;

FIG. 8 is an elevated perspective view of a label artwork in accordance with the present invention;

FIG. 9 is a frontal planar view of a label artwork in accordance with the present invention, as shown in FIG. 8;

FIG. 10 is back planar view of a label artwork in accordance with the present invention, as shown in FIG. 8;

FIG. 11 is right side view of a label artwork in accordance with the present invention, as shown in FIG. 8;

FIG. 12 is a left side view of a label artwork in accordance with the present invention, as shown in FIG. 8;

FIG. 13 is a top side view of a label artwork in accordance with the present invention, as shown in FIG. 8; and,

FIG. 14 is a bottom side view of a label artwork in accordance with the present invention, as shown in FIG. 8.

The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

It is further understood that FIGS. 8 to 12 depict an embodiment of the present invention where a design having various shades of gold, yellow, orange, red, and/or brown are used to create a patterned design. Other colors can also be used where variations are used to create at least a portion of the patterned design, as shown in FIGS. 1 to 7.

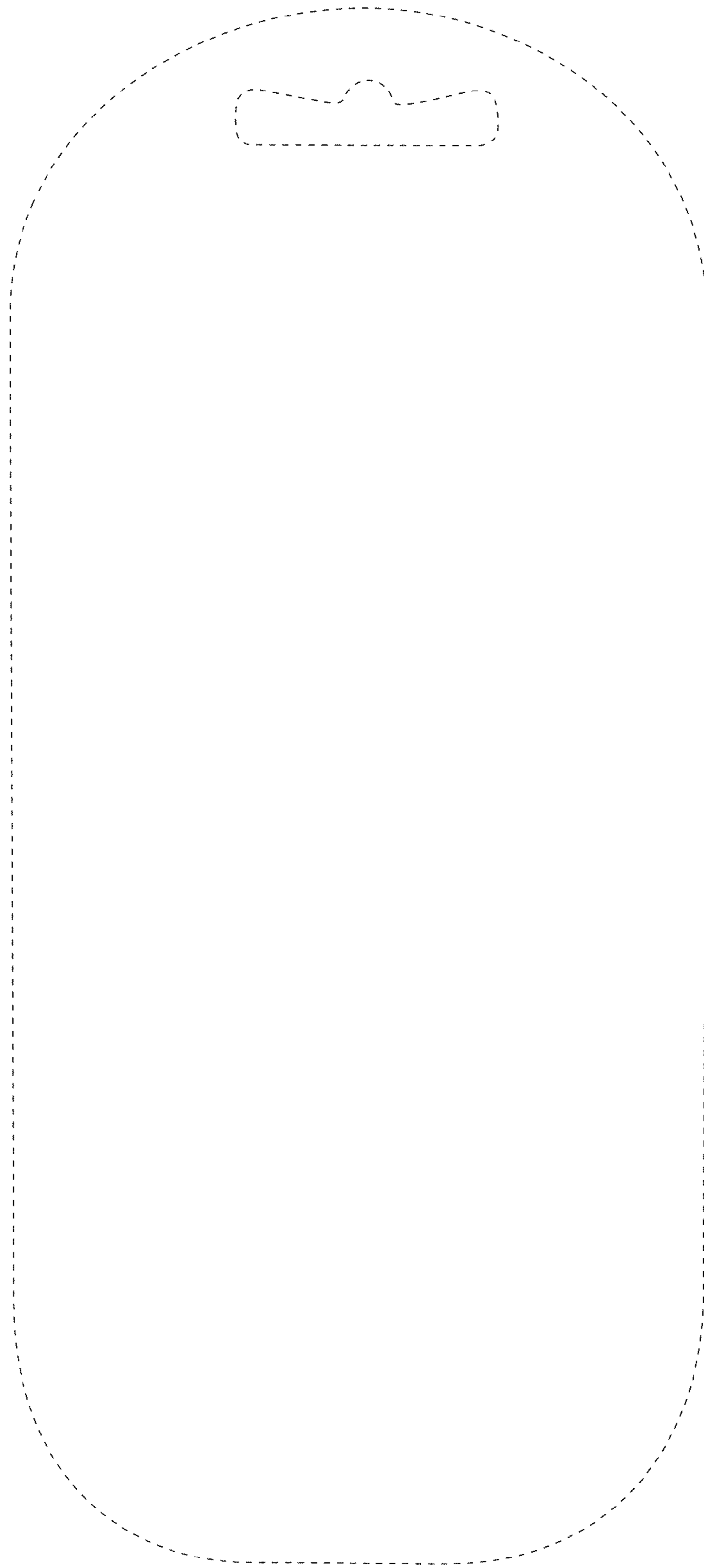

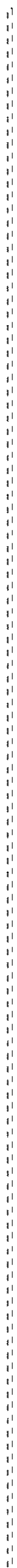

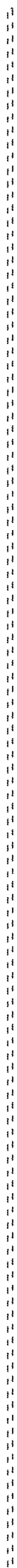

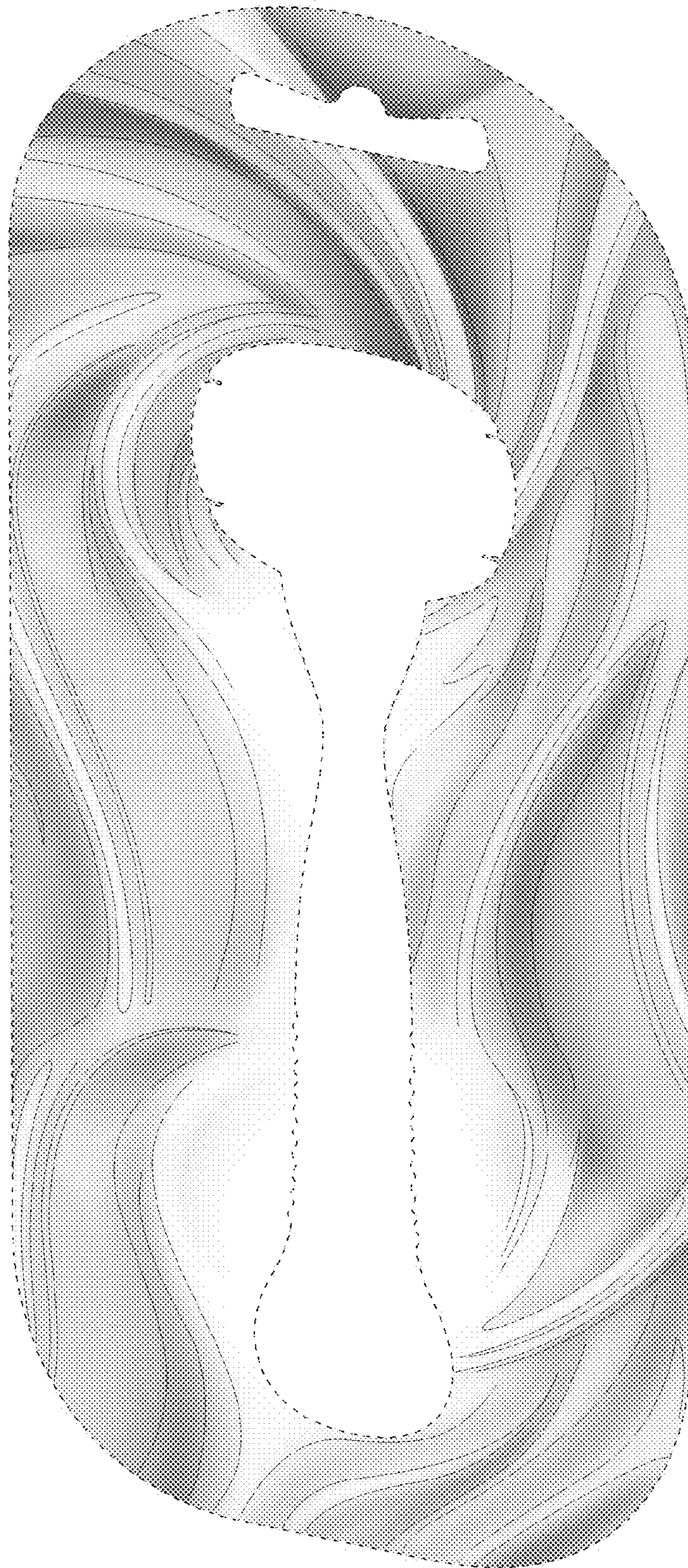

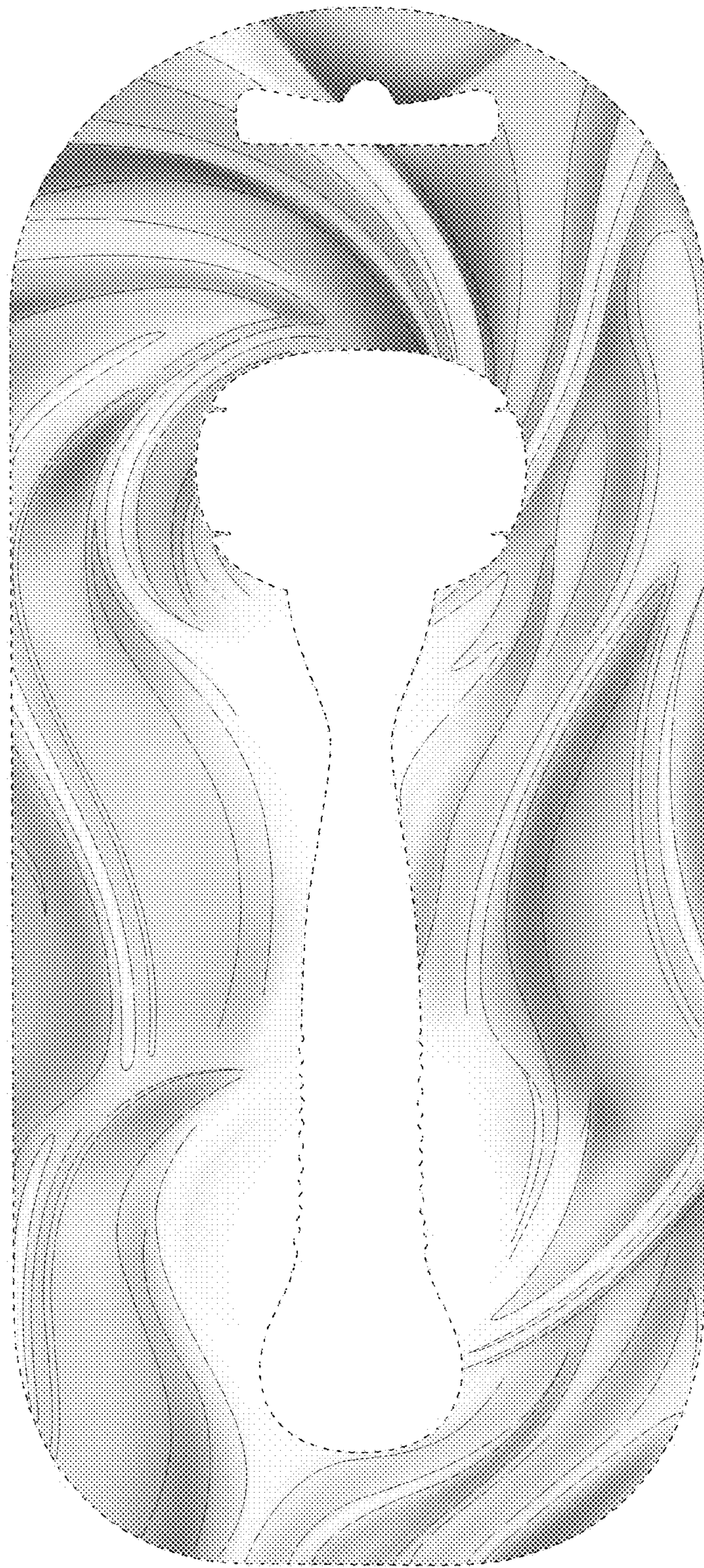

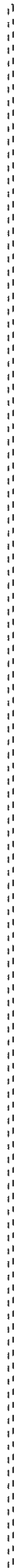

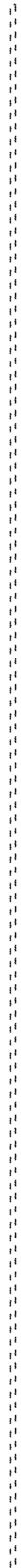
