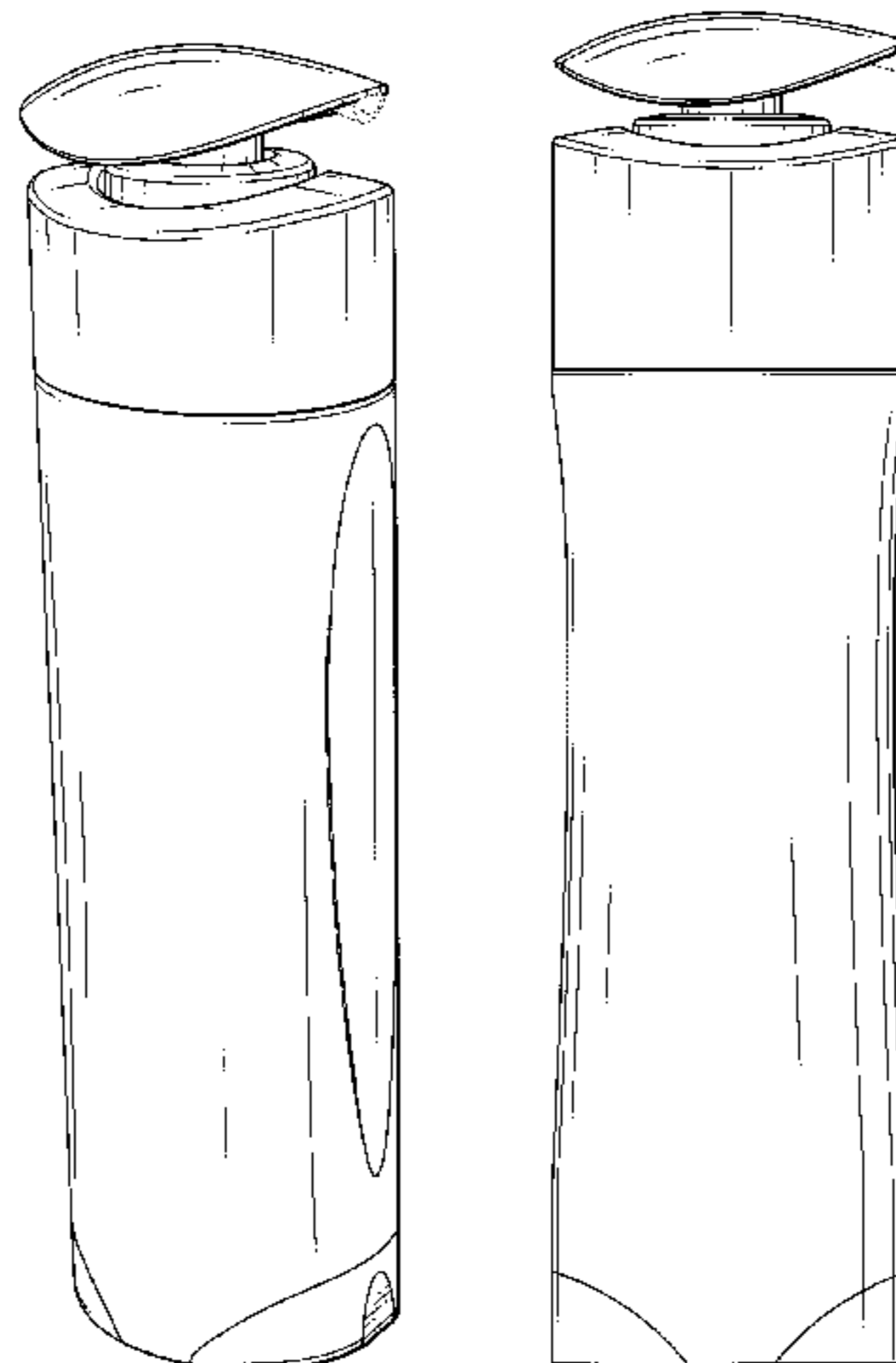
(57) **CLAIM**

The ornamental design for a container for hair care composition, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container for hair care composition showing our new design; FIG. 2 is a front side view of the container for hair care composition as shown in FIG. 1; FIG. 3 is a right side view of the container for hair care composition as shown in FIG. 1; FIG. 4 is a back side view of the container for hair care composition as shown in FIG. 1; FIG. 5 is a left side view of the container for hair care composition as shown in FIG. 1; FIG. 6 is a top view of the container for hair care composition as shown in FIG. 1; and, FIG. 7 is a bottom view of the container for hair care composition as shown in FIG. 1. The broken lines shown in the drawing views are included for the purpose of showing environmental structure that forms no part of the claimed design.

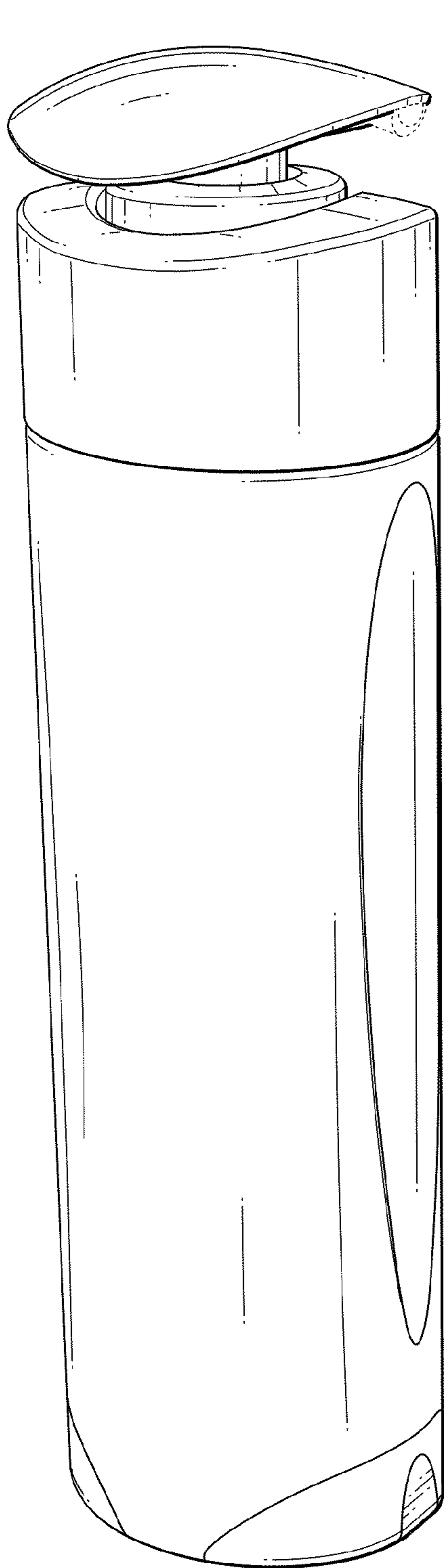

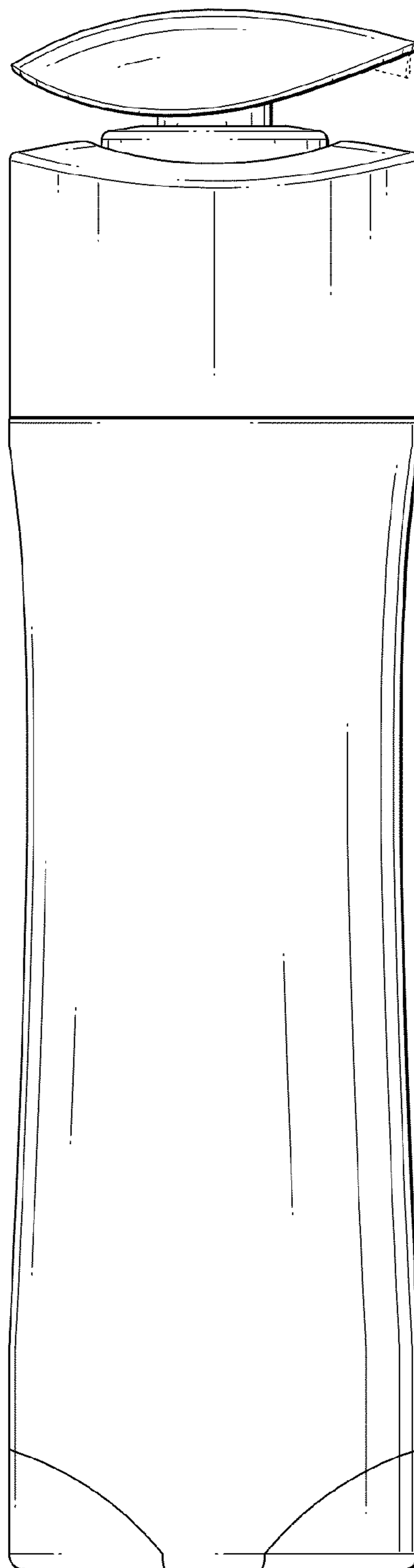

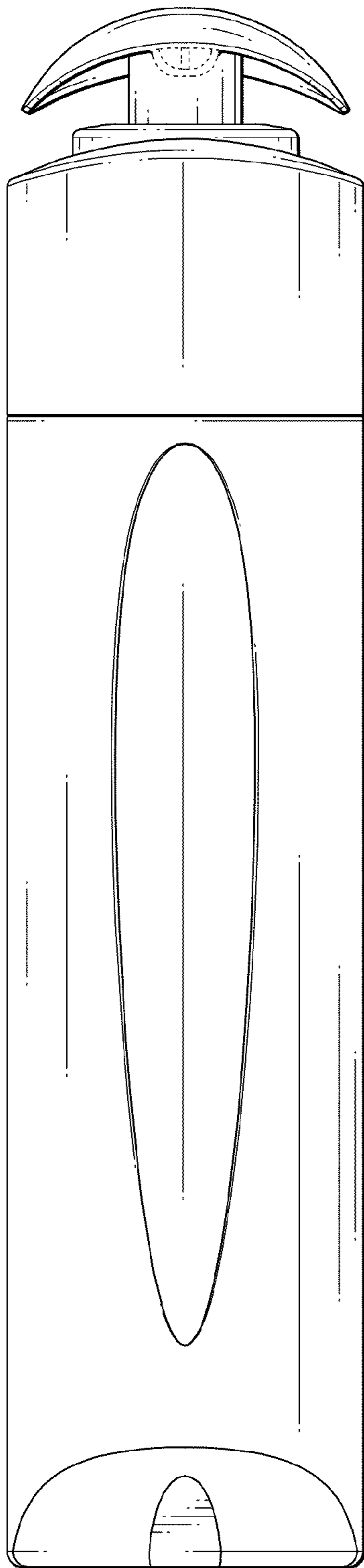

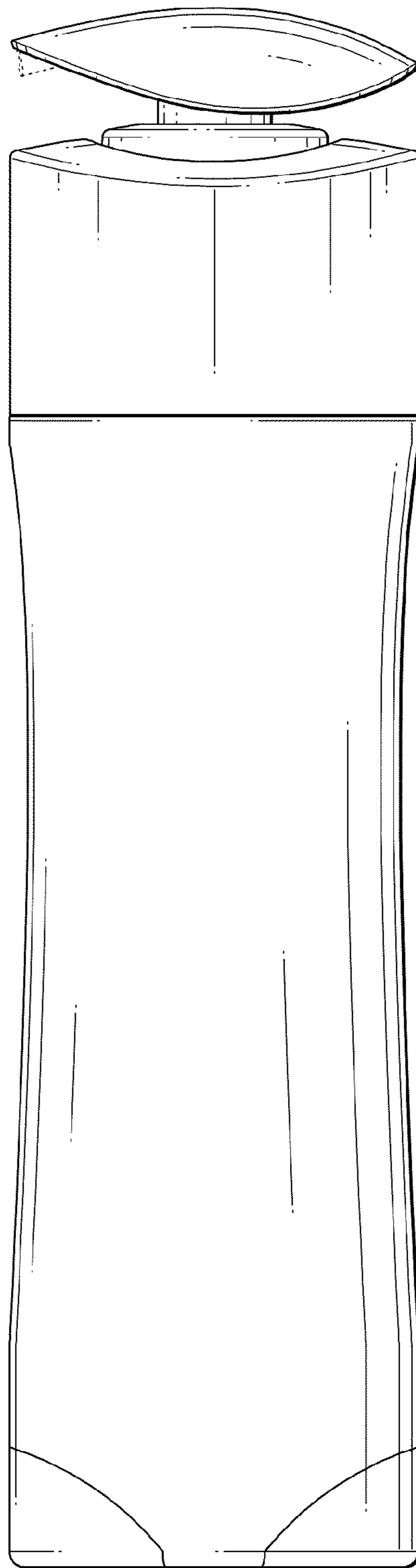

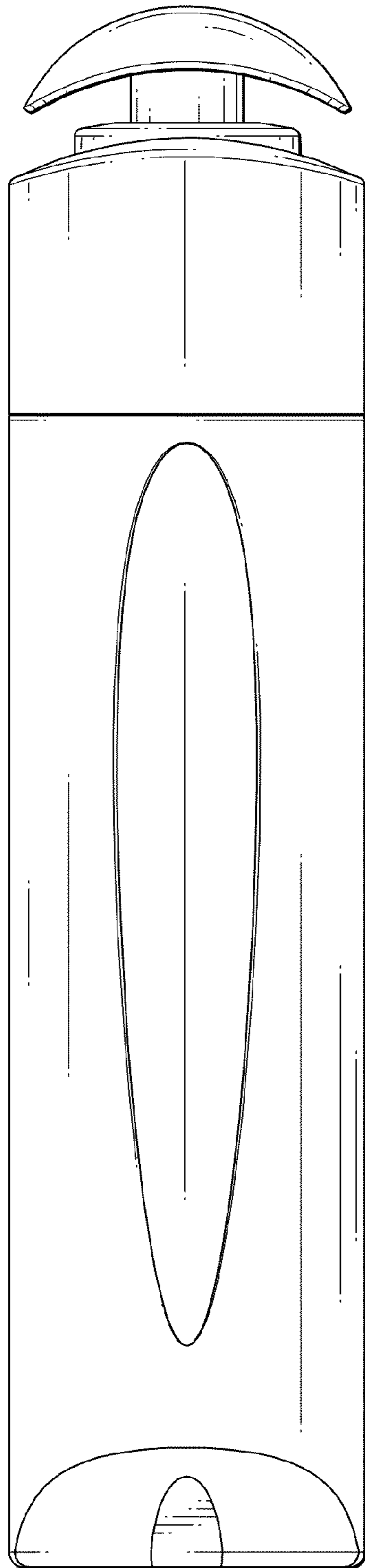

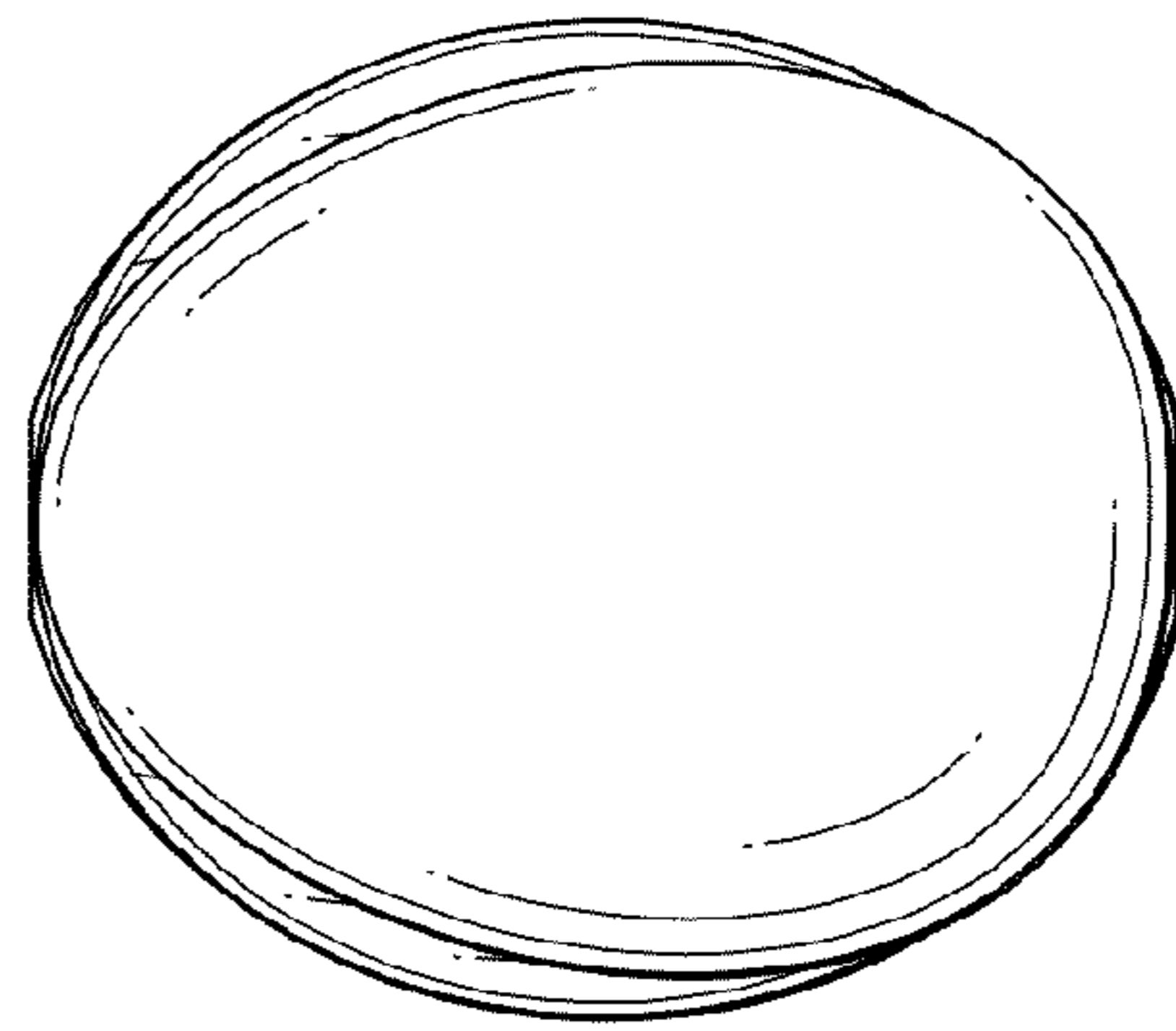

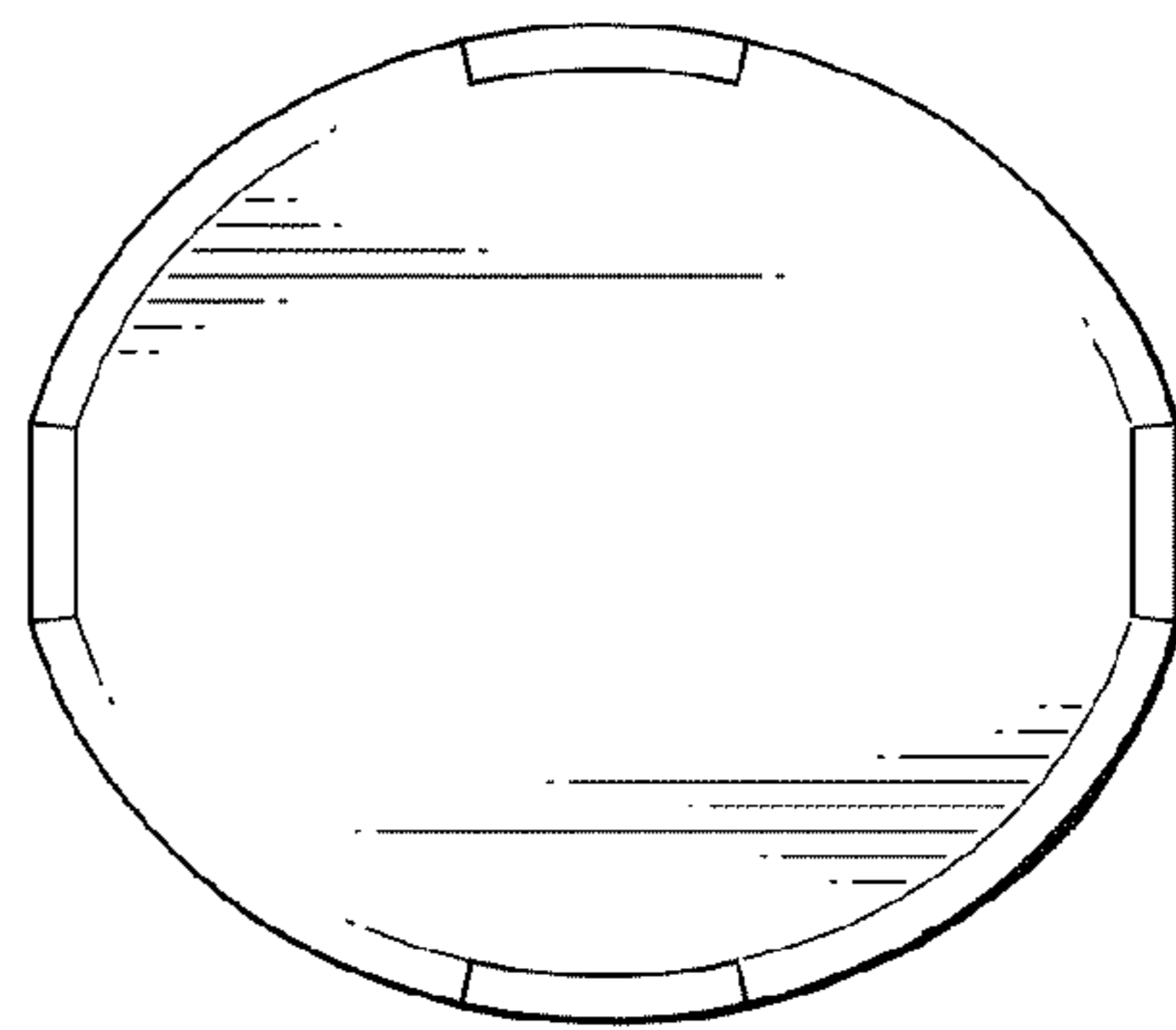
