The ornamental design for a fuel tank cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fuel tank cap showing our new design;

FIG. 2 is a front view thereof, the rear view being identical to the front view;

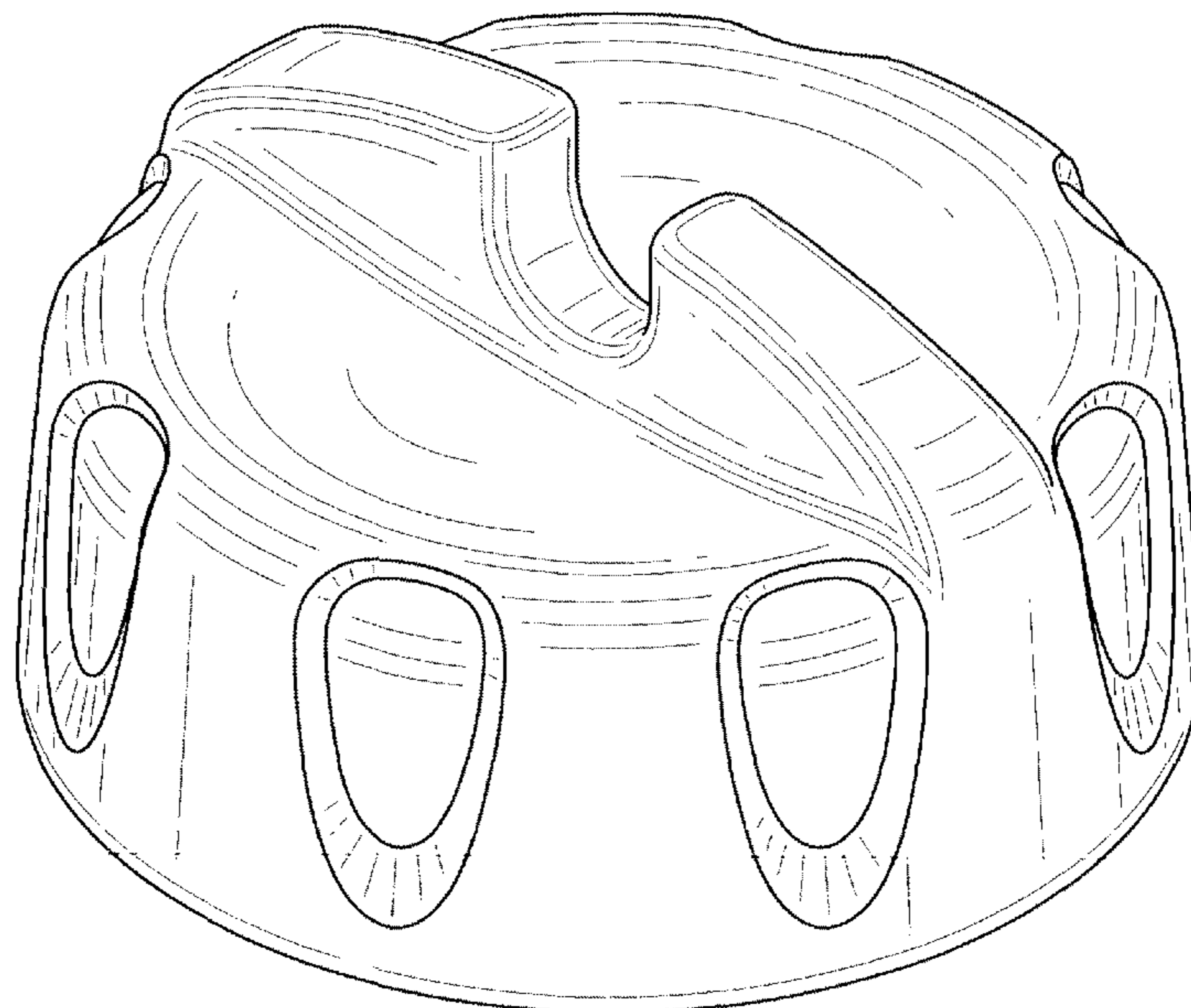
FIG. 3 is a top plan view thereof;

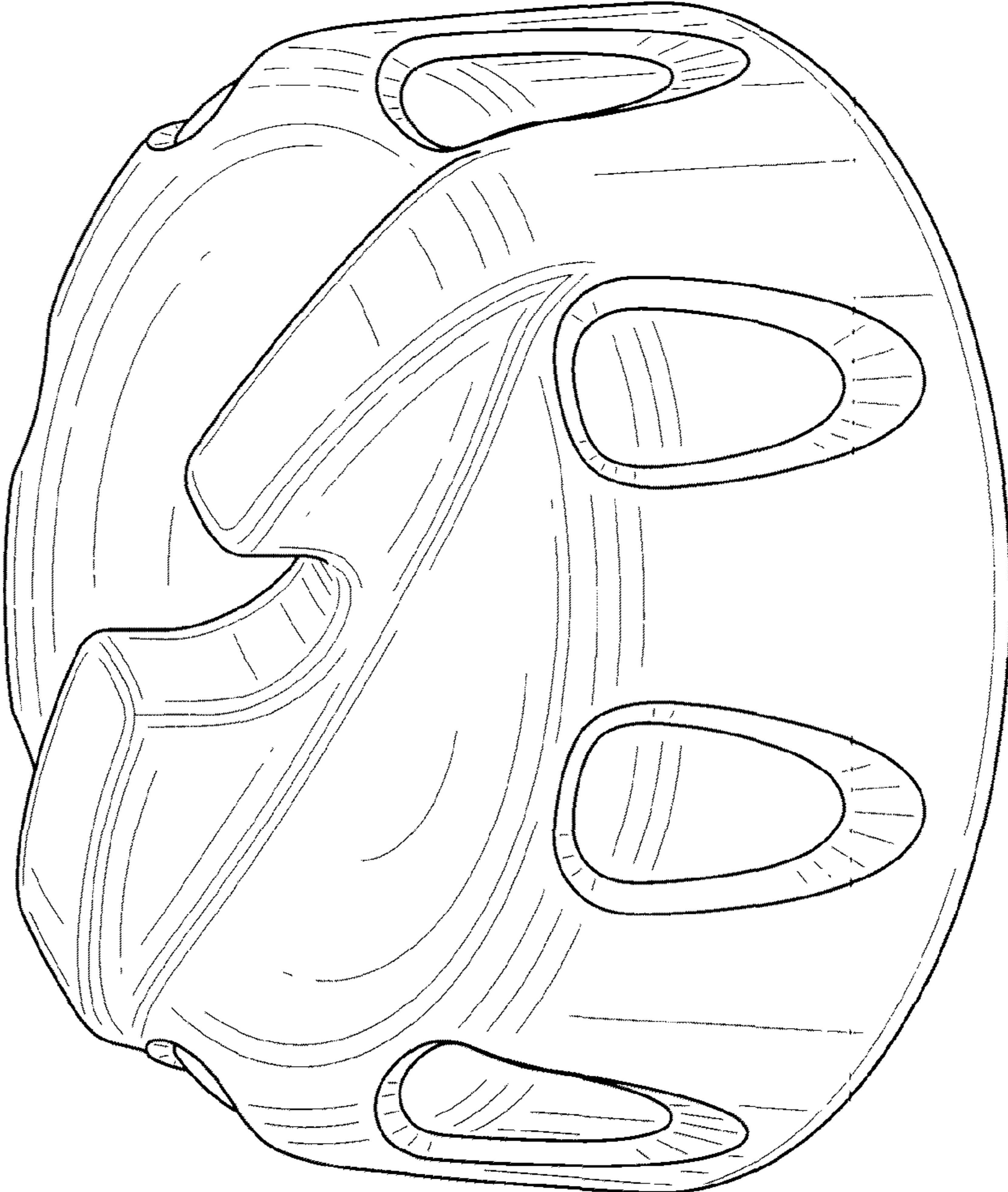

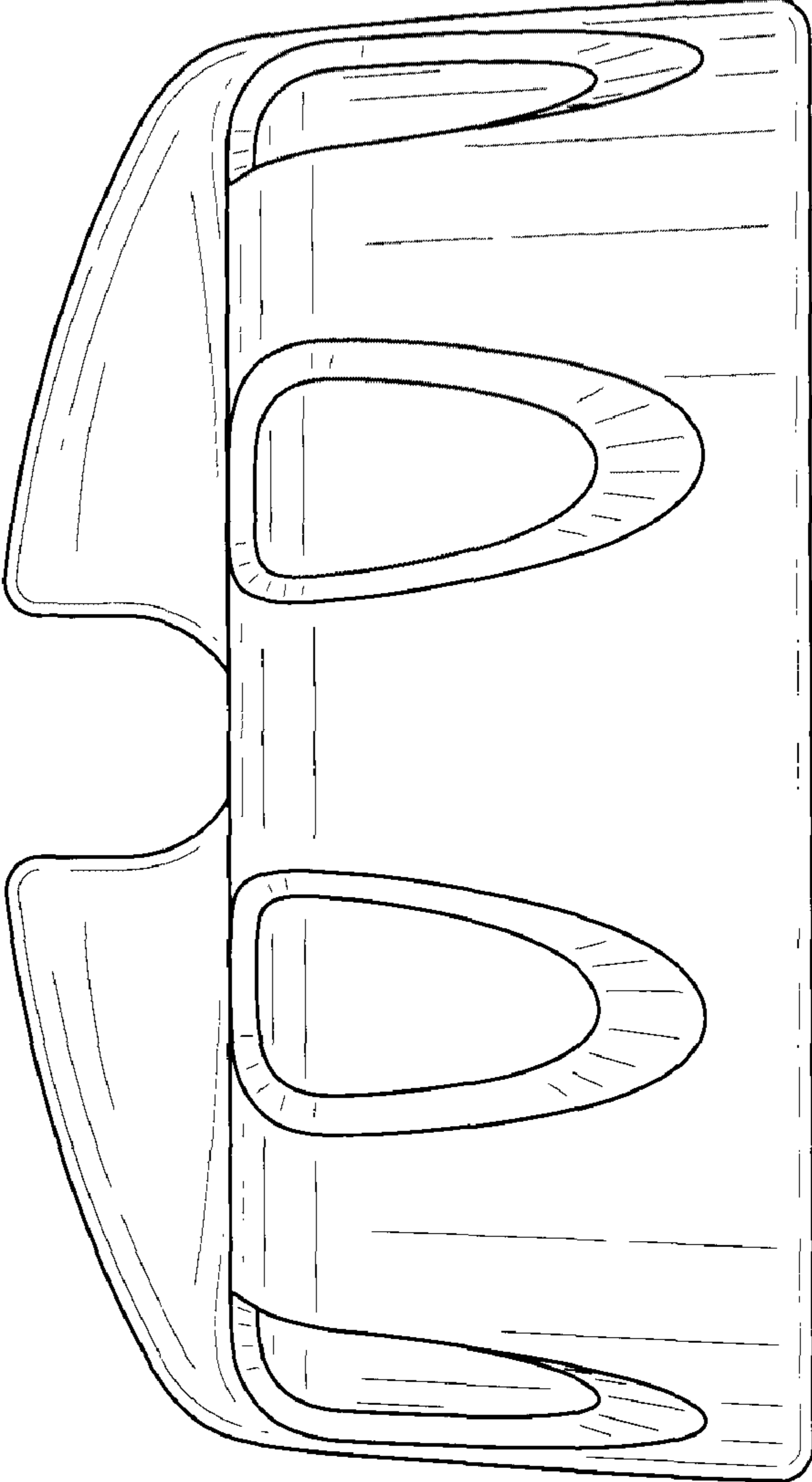

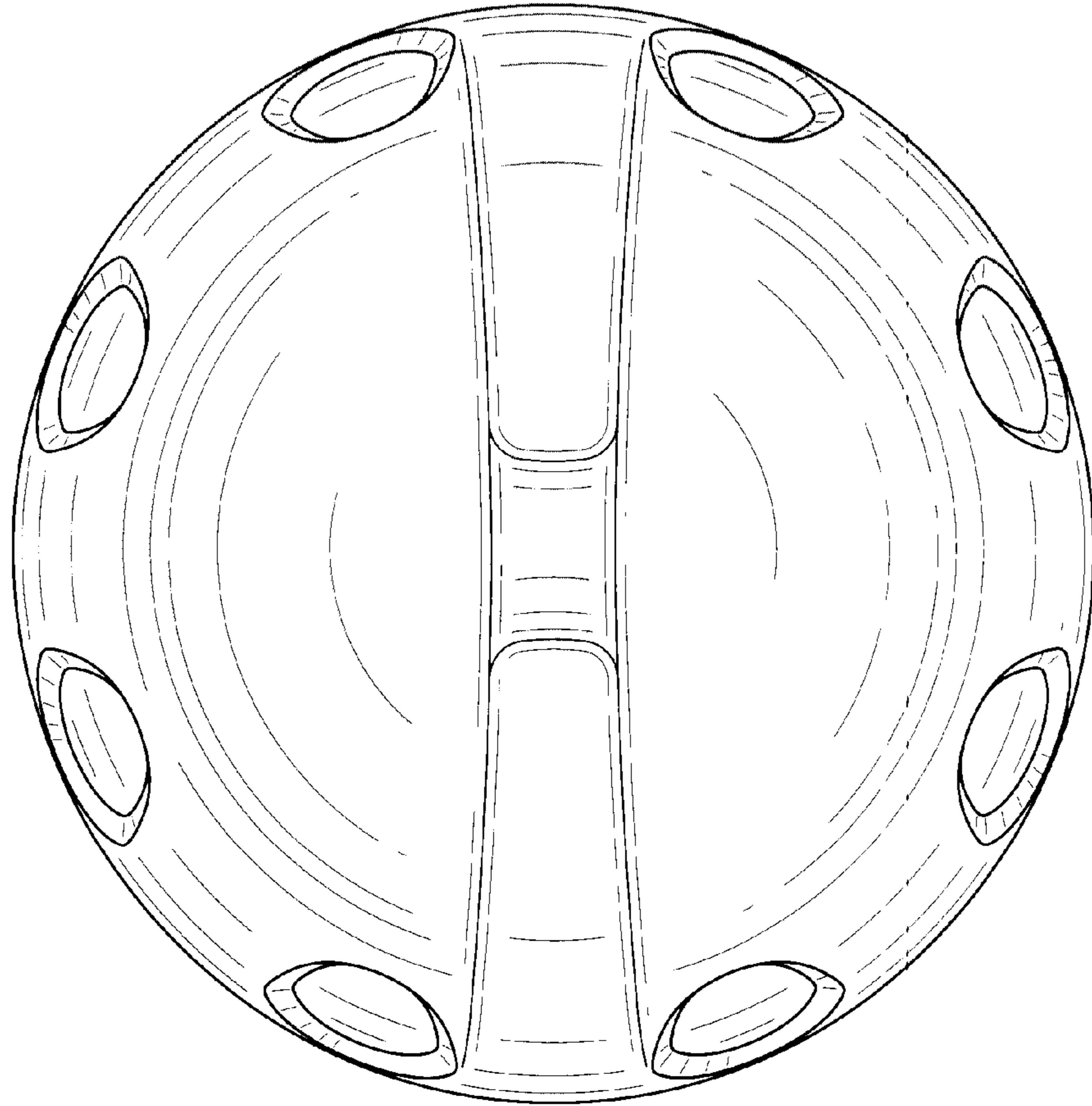
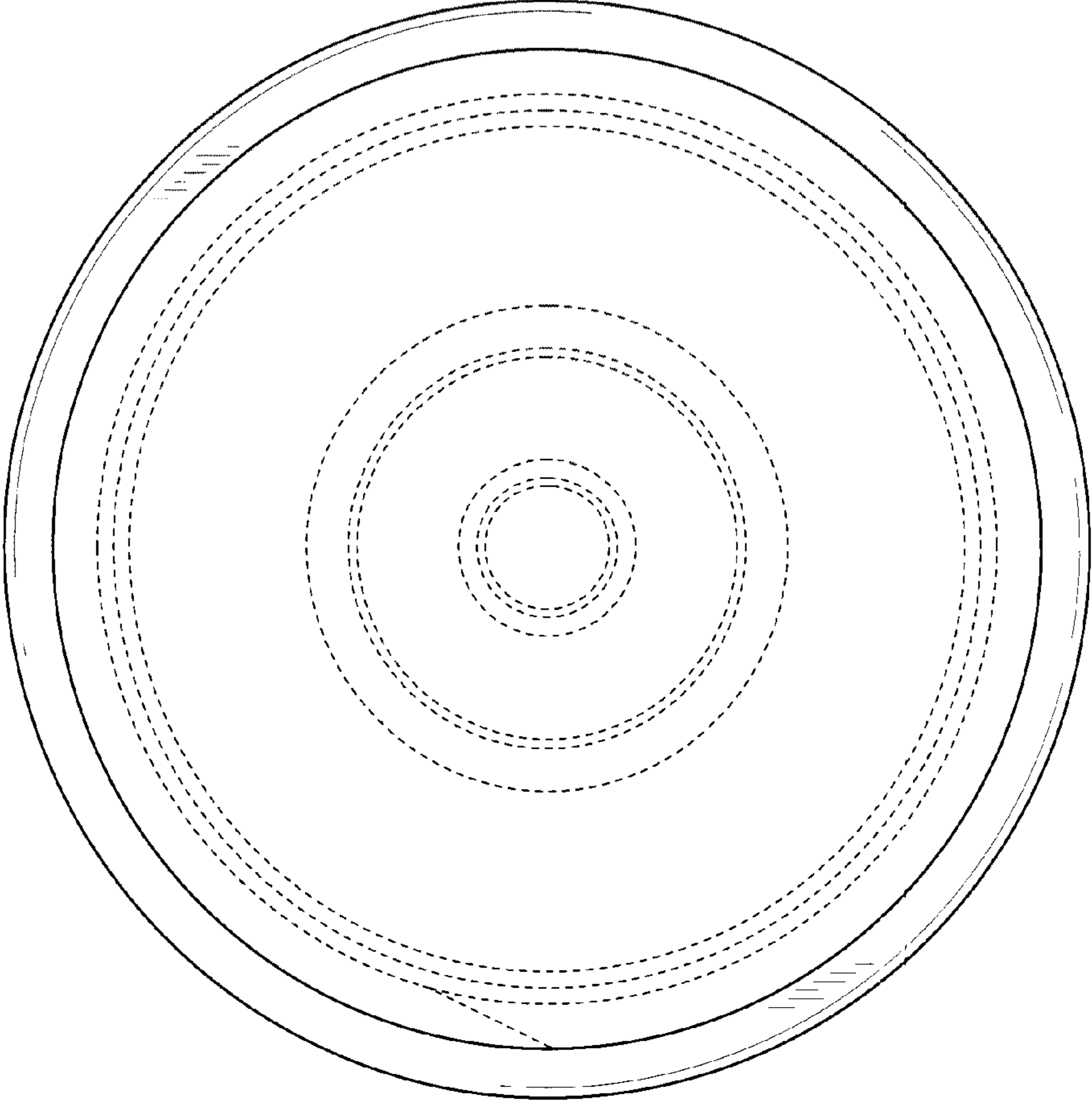
