The ornamental design for a booster cable, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a booster cable showing my new design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof; and,  
 FIG. 7 is a perspective view of the booster cable with a part of the cable omitted to indicate that the length of the cable is not part of the design.

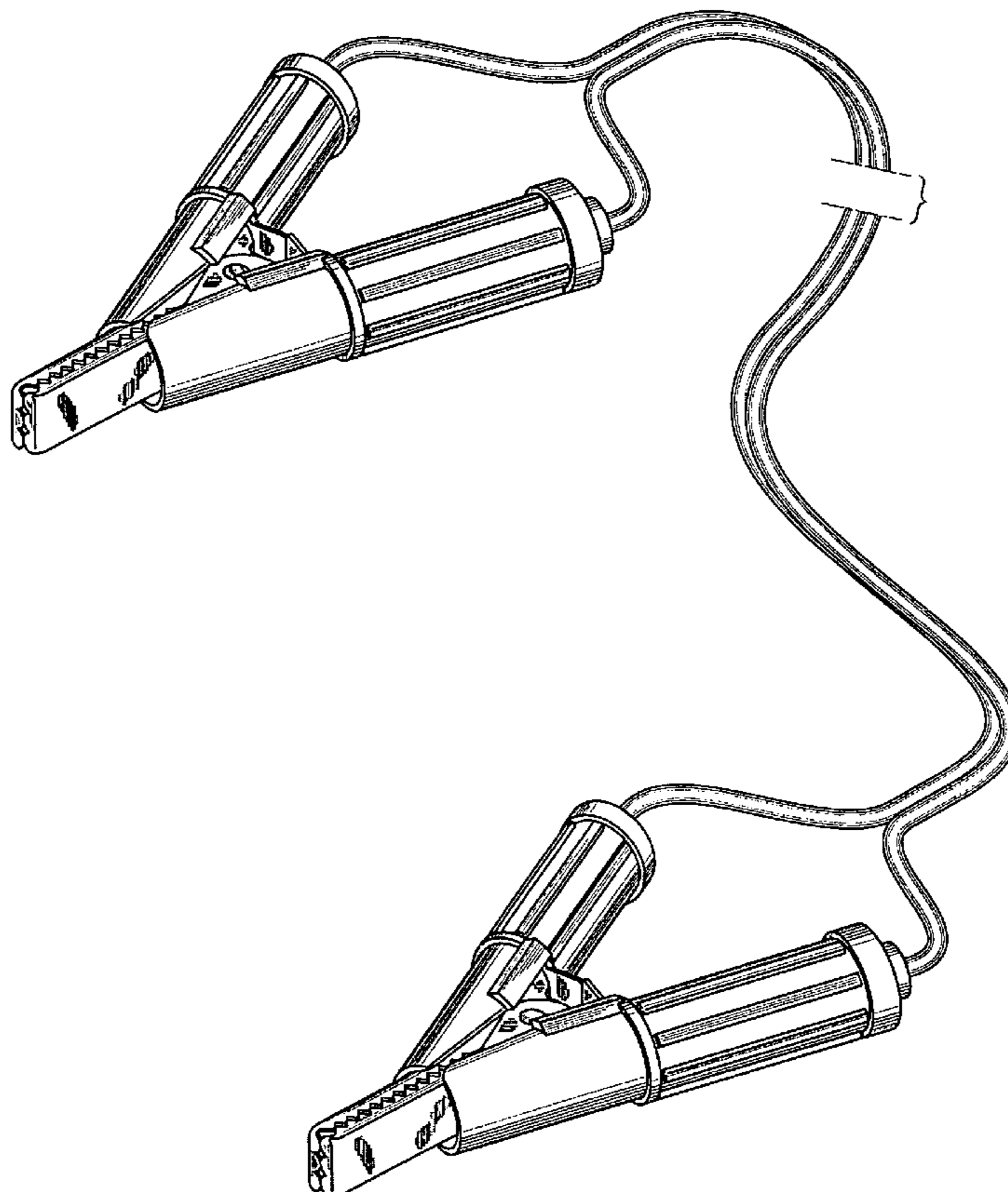

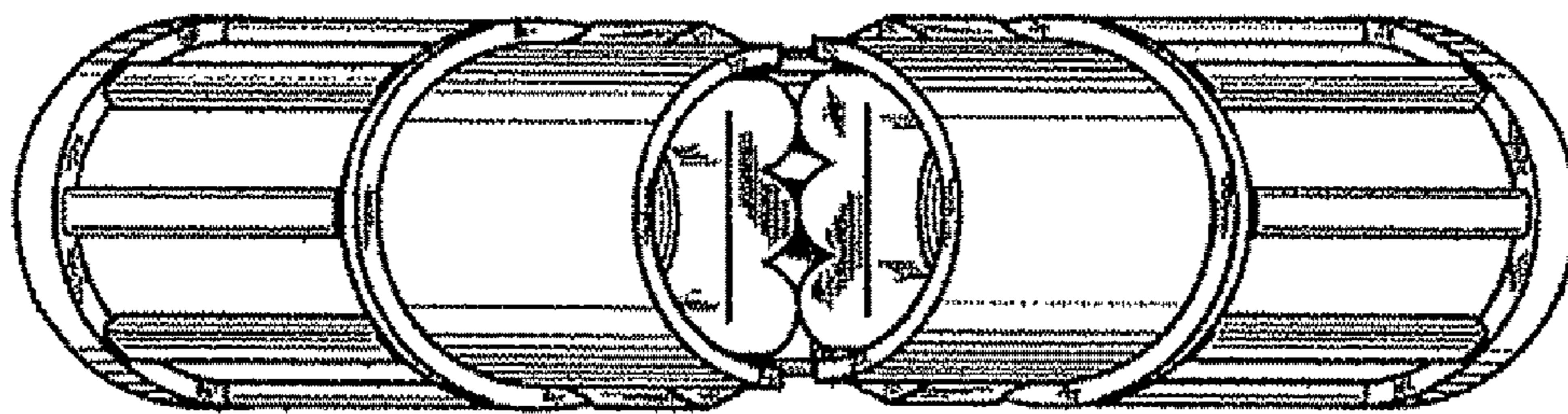

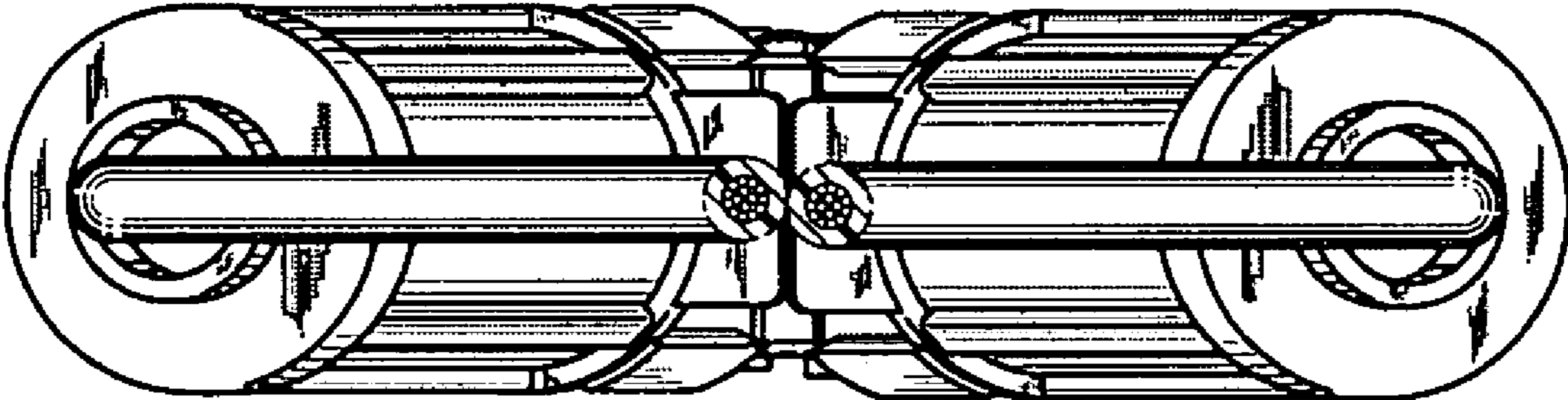

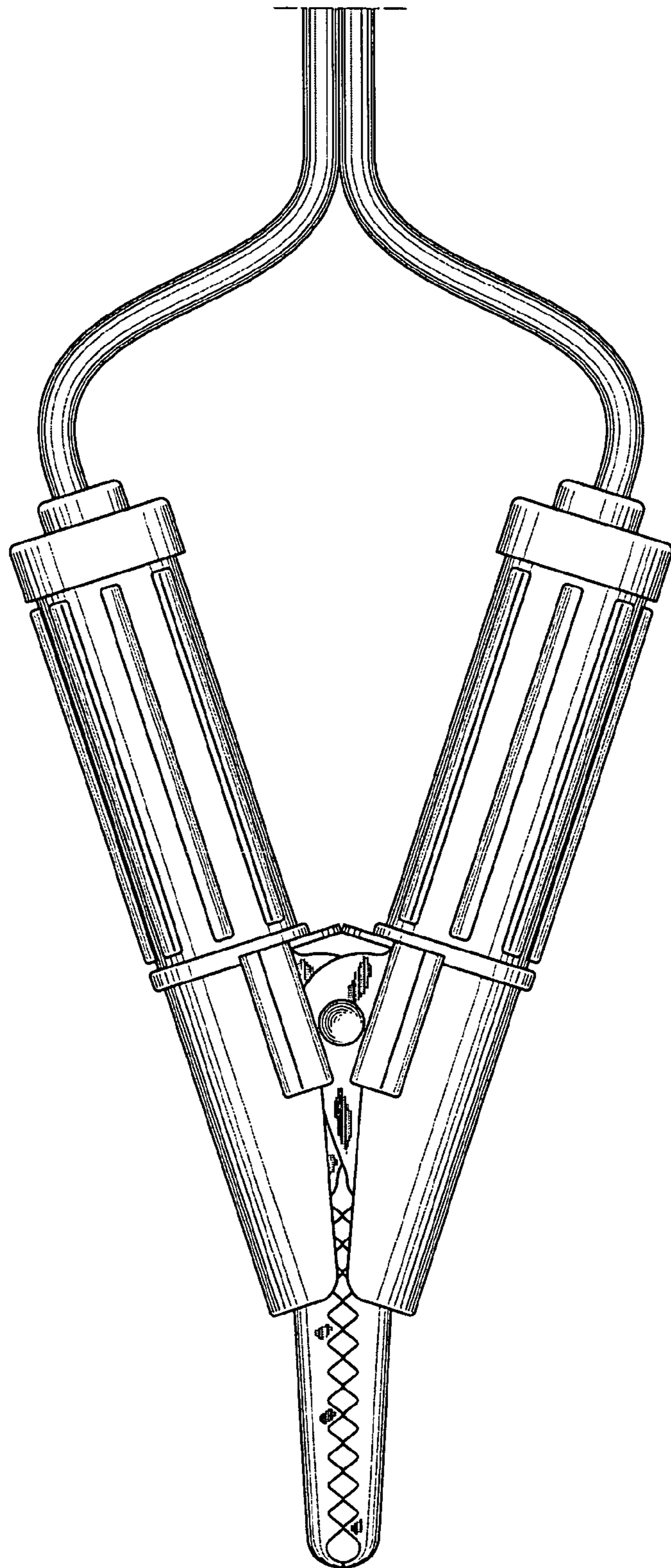

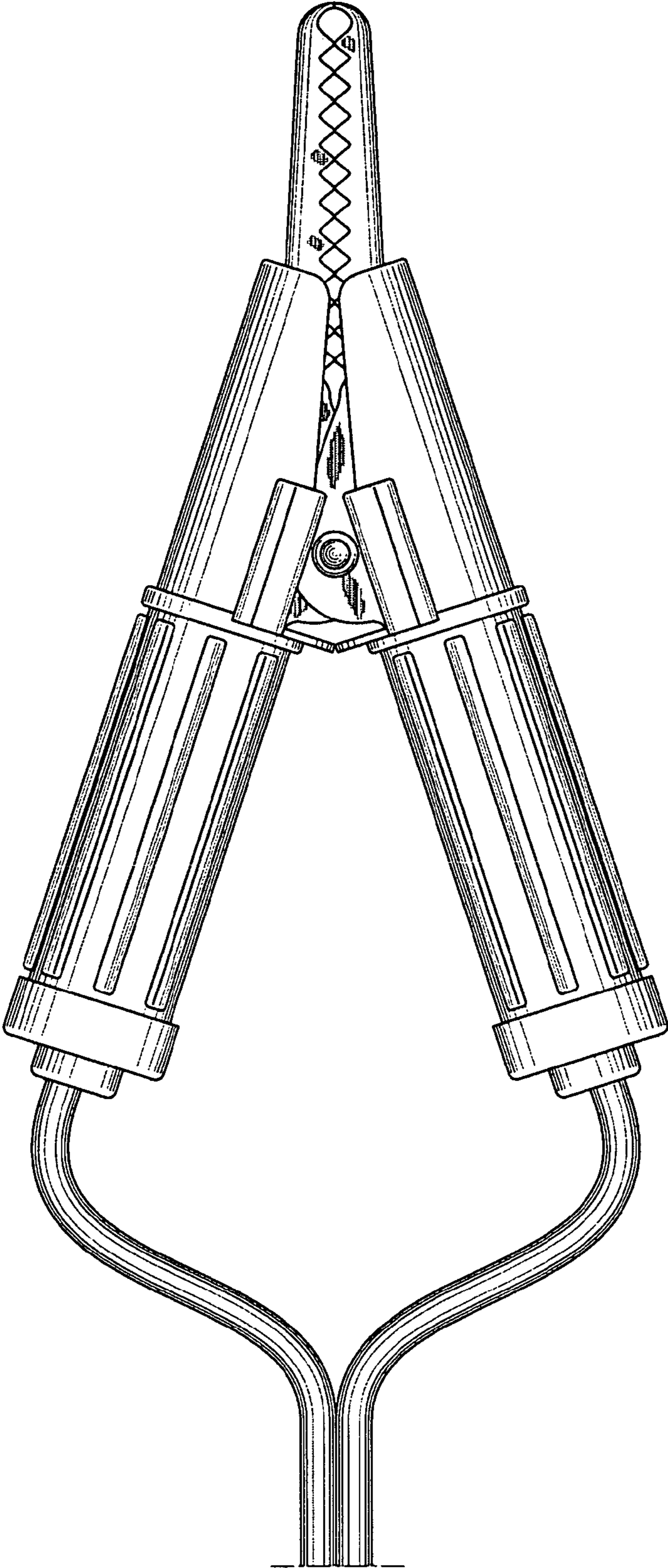

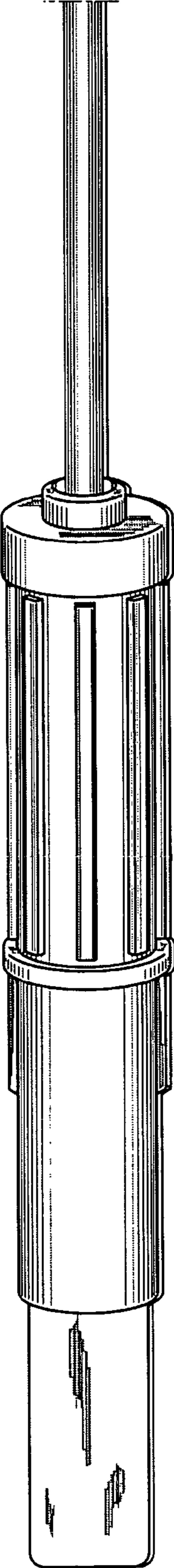

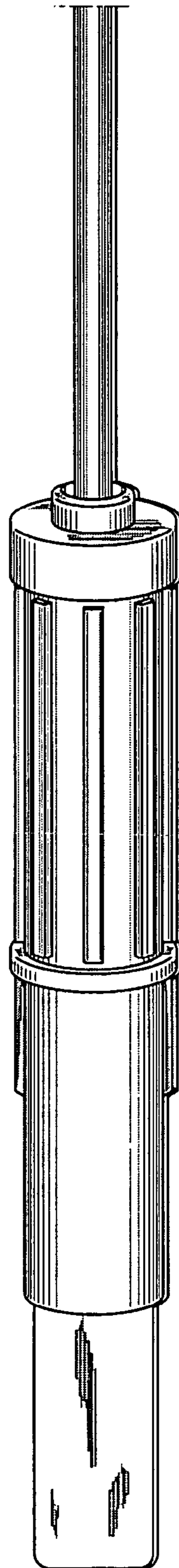
