FIG. 3 is an illustration of a bottom view of the electronic device stand.

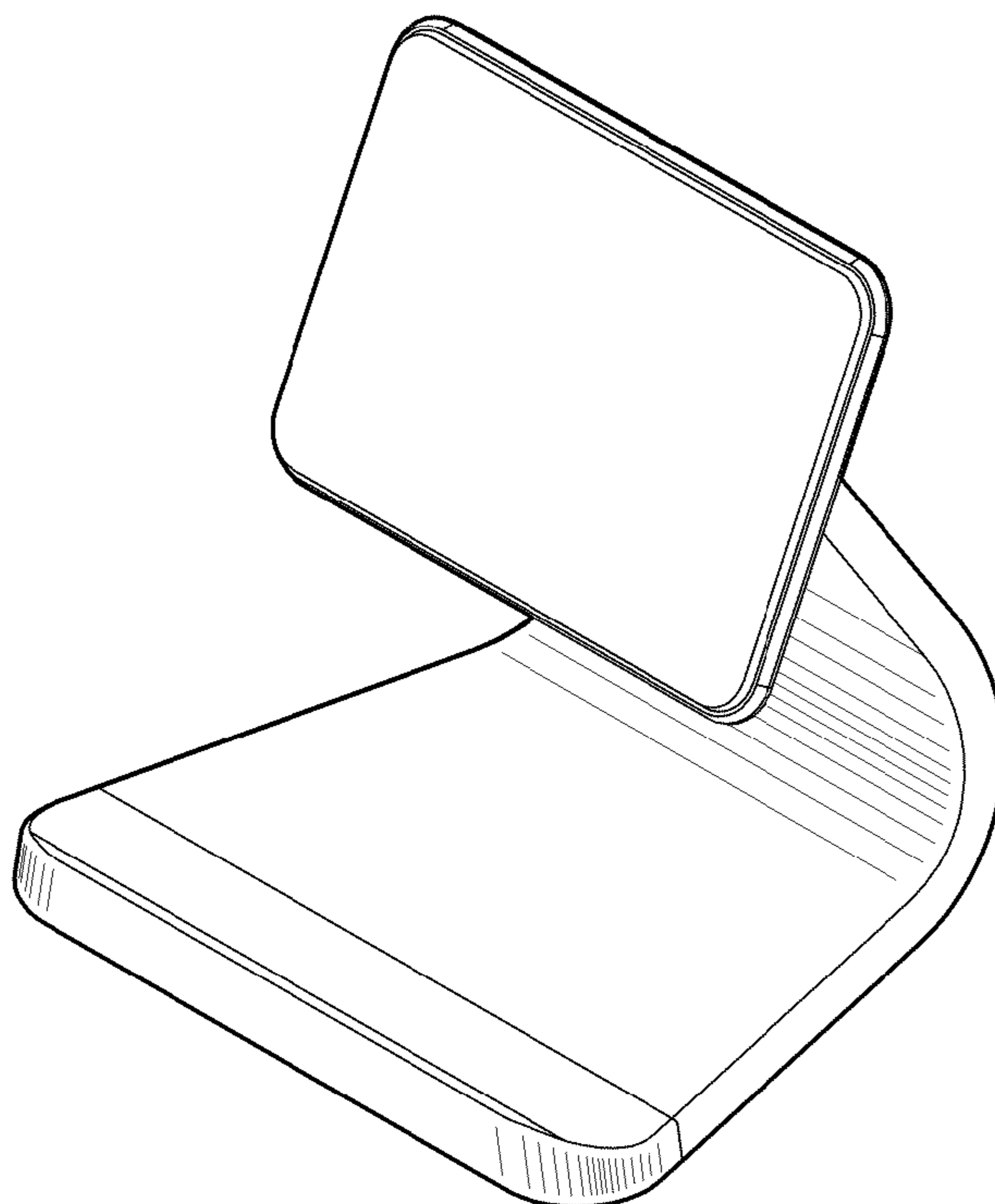
FIG. 4 is an illustration of a left side view of the electronic device stand.

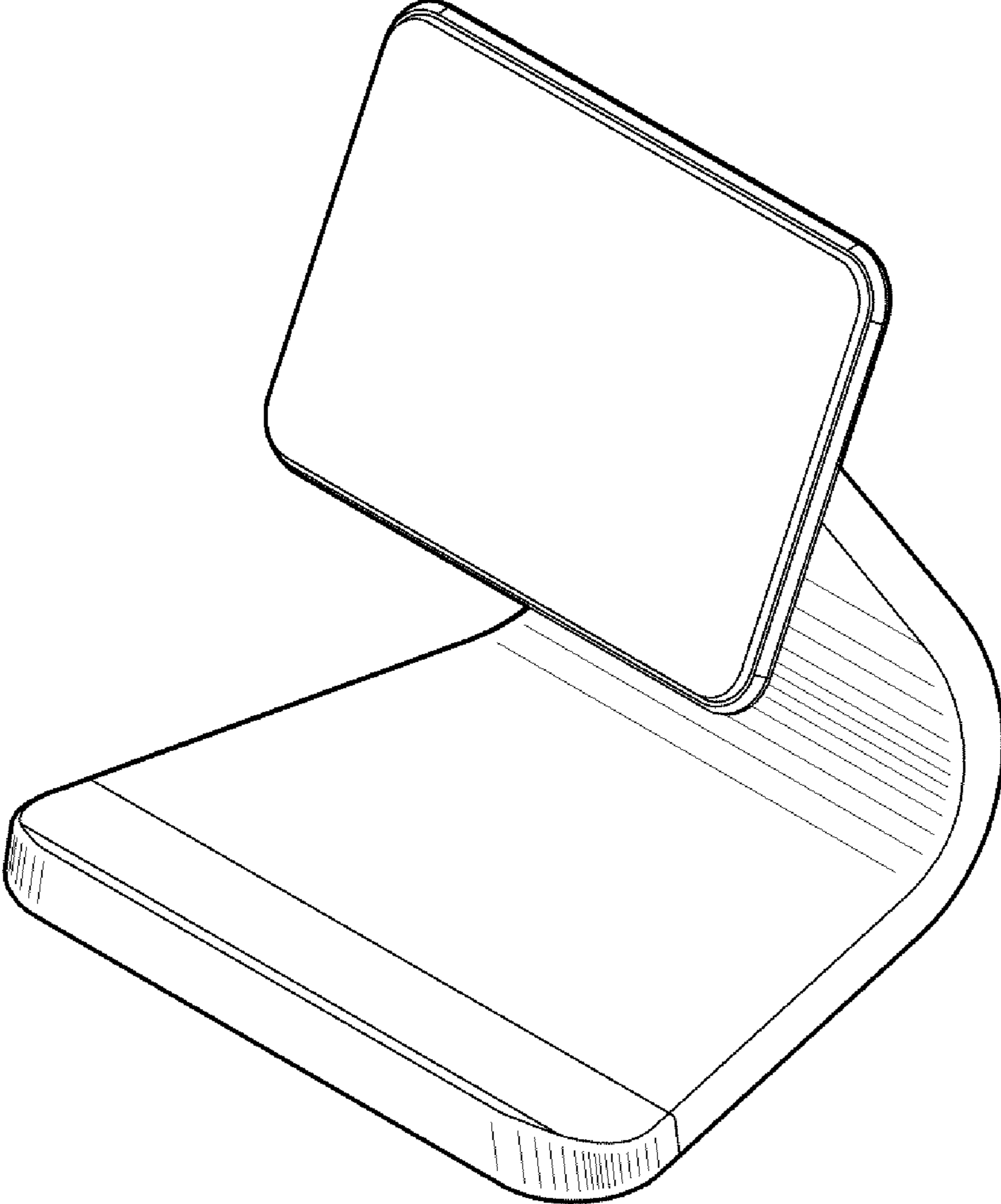

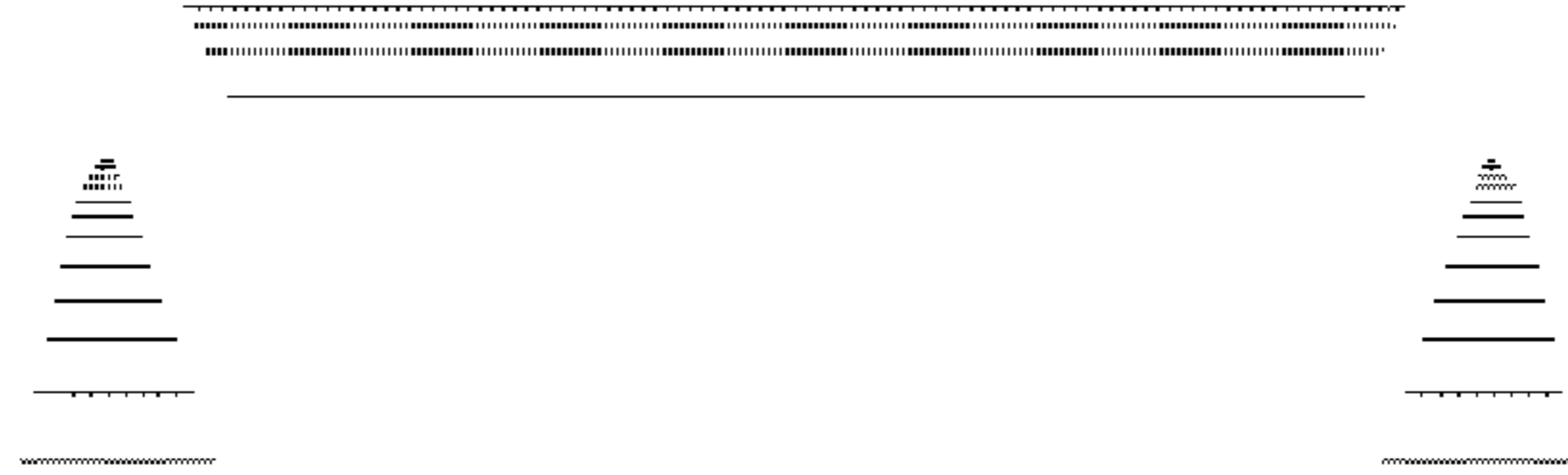

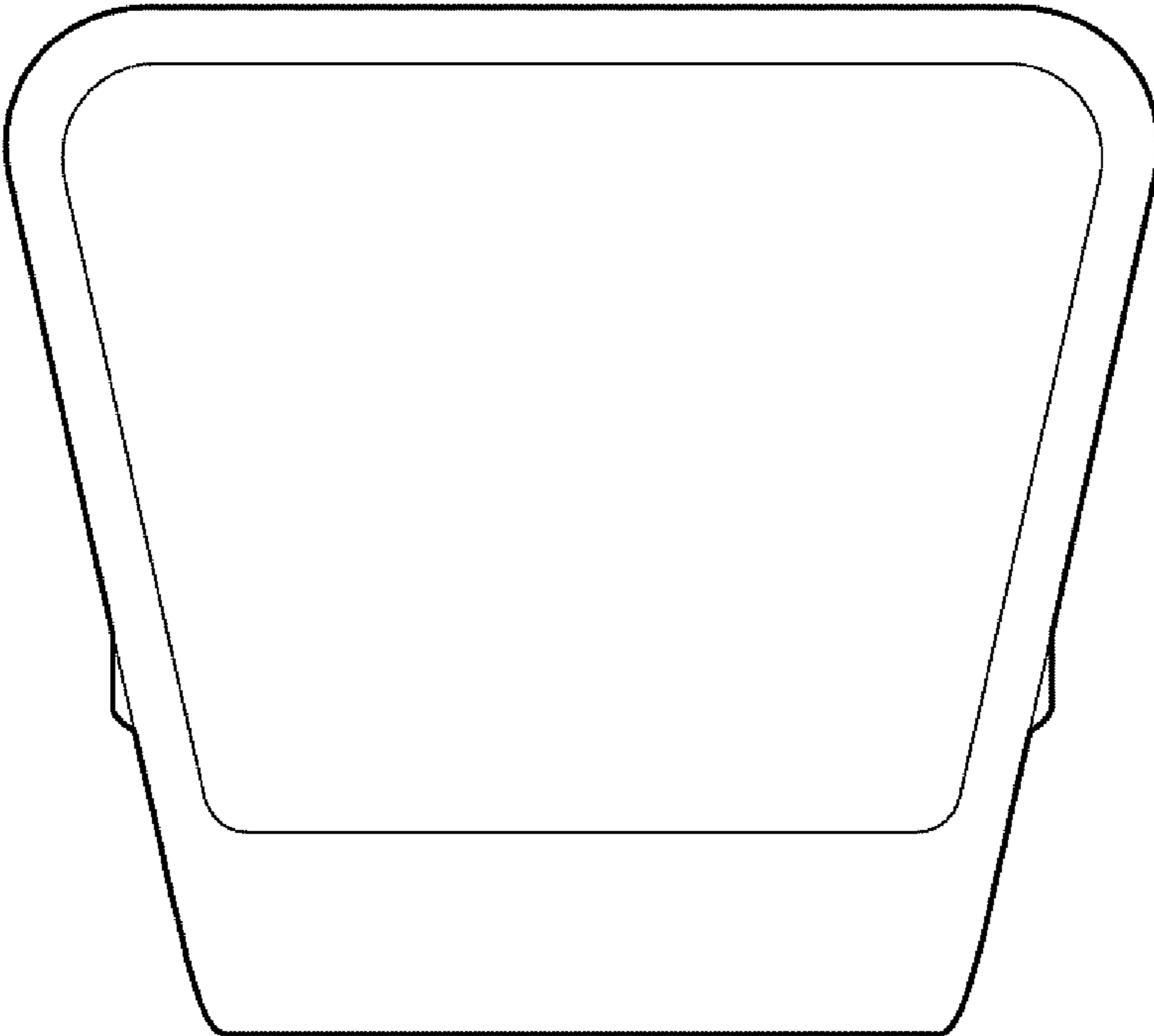

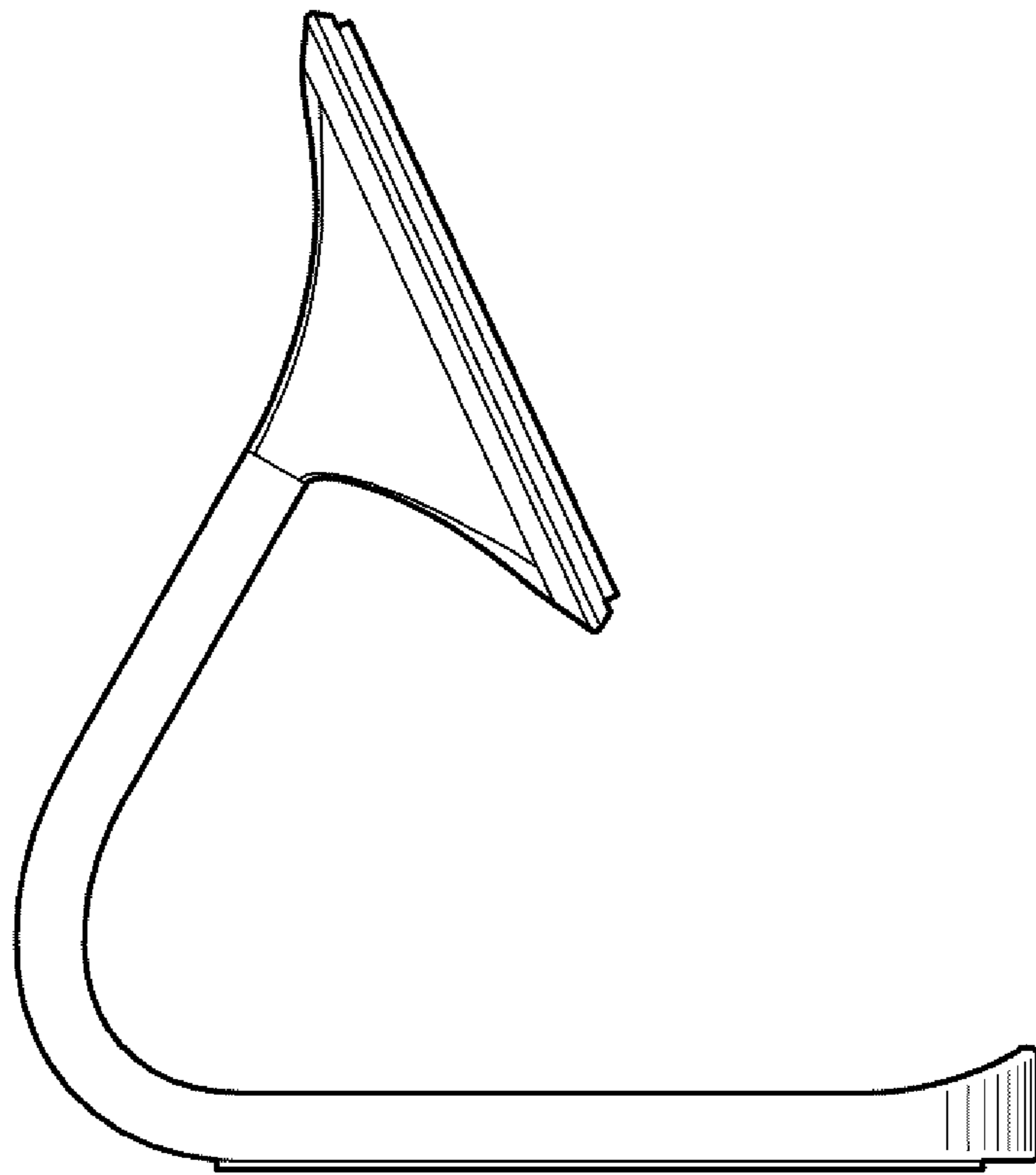

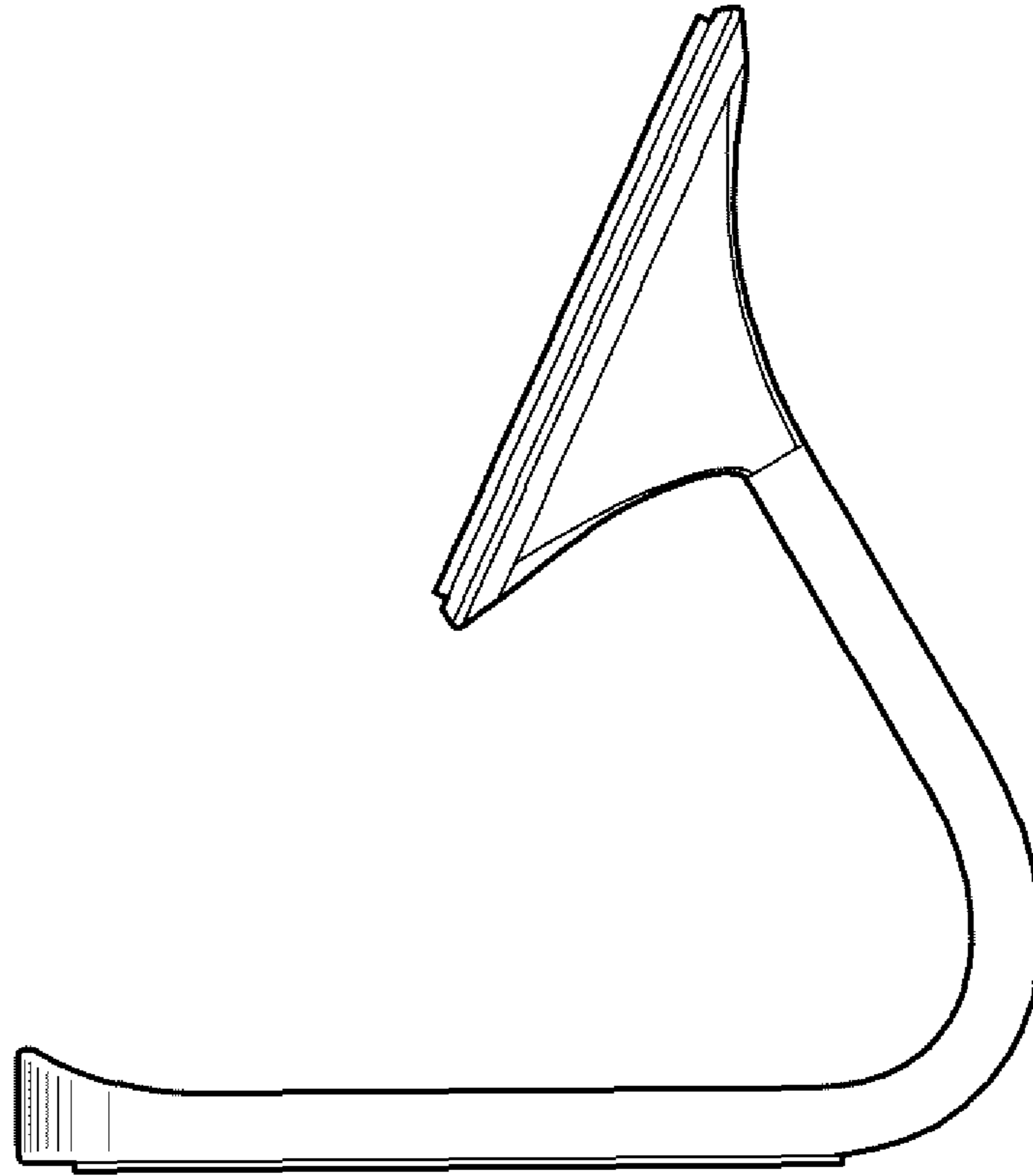

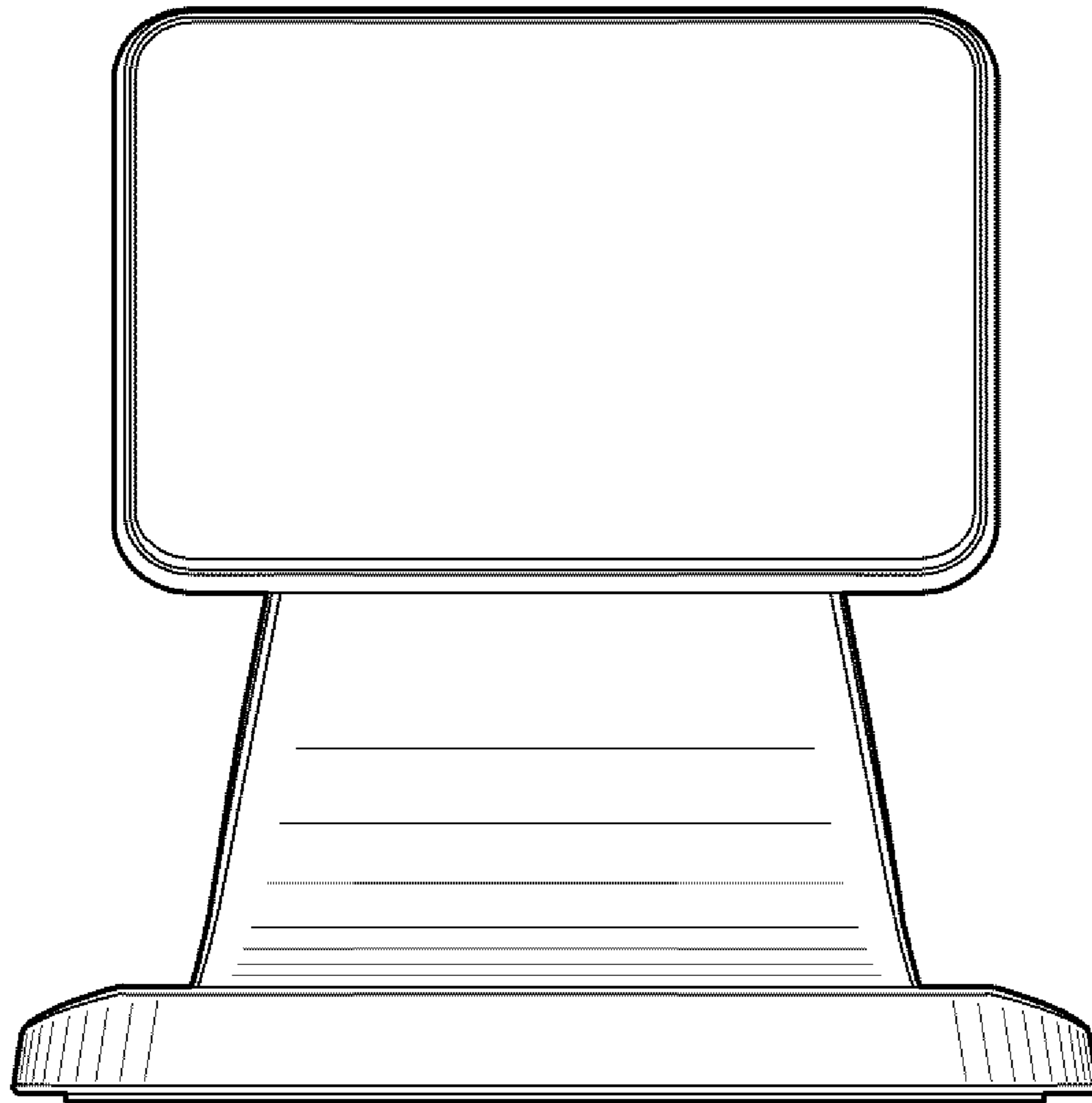

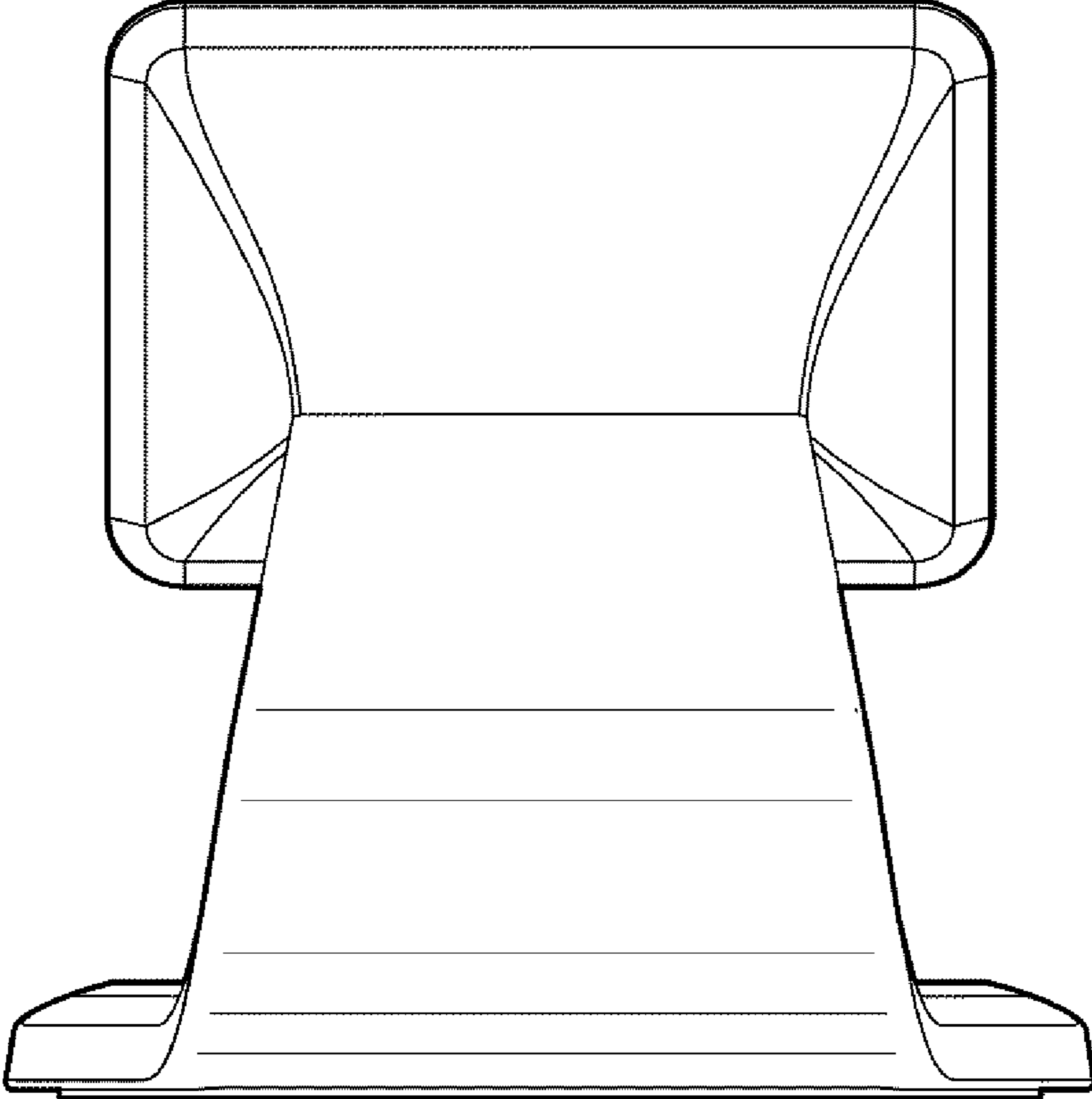
