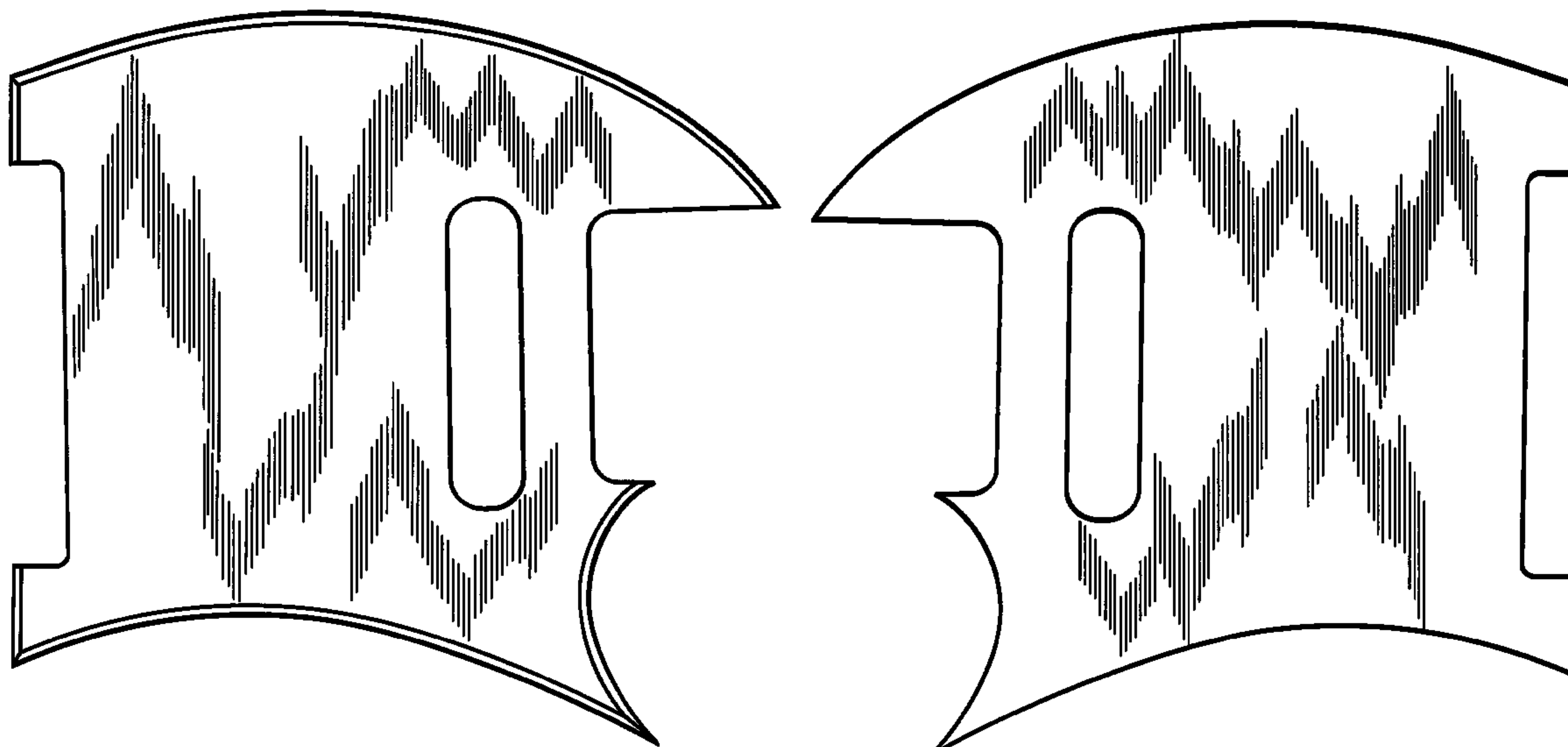
(57) **CLAIM**

We claim the ornamental design for a guitar pick guard, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a guitar pick guard;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front side elevational view thereof;
FIG. 5 is a back side elevational view thereof;
FIG. 6 is a left side elevational view thereof; and,

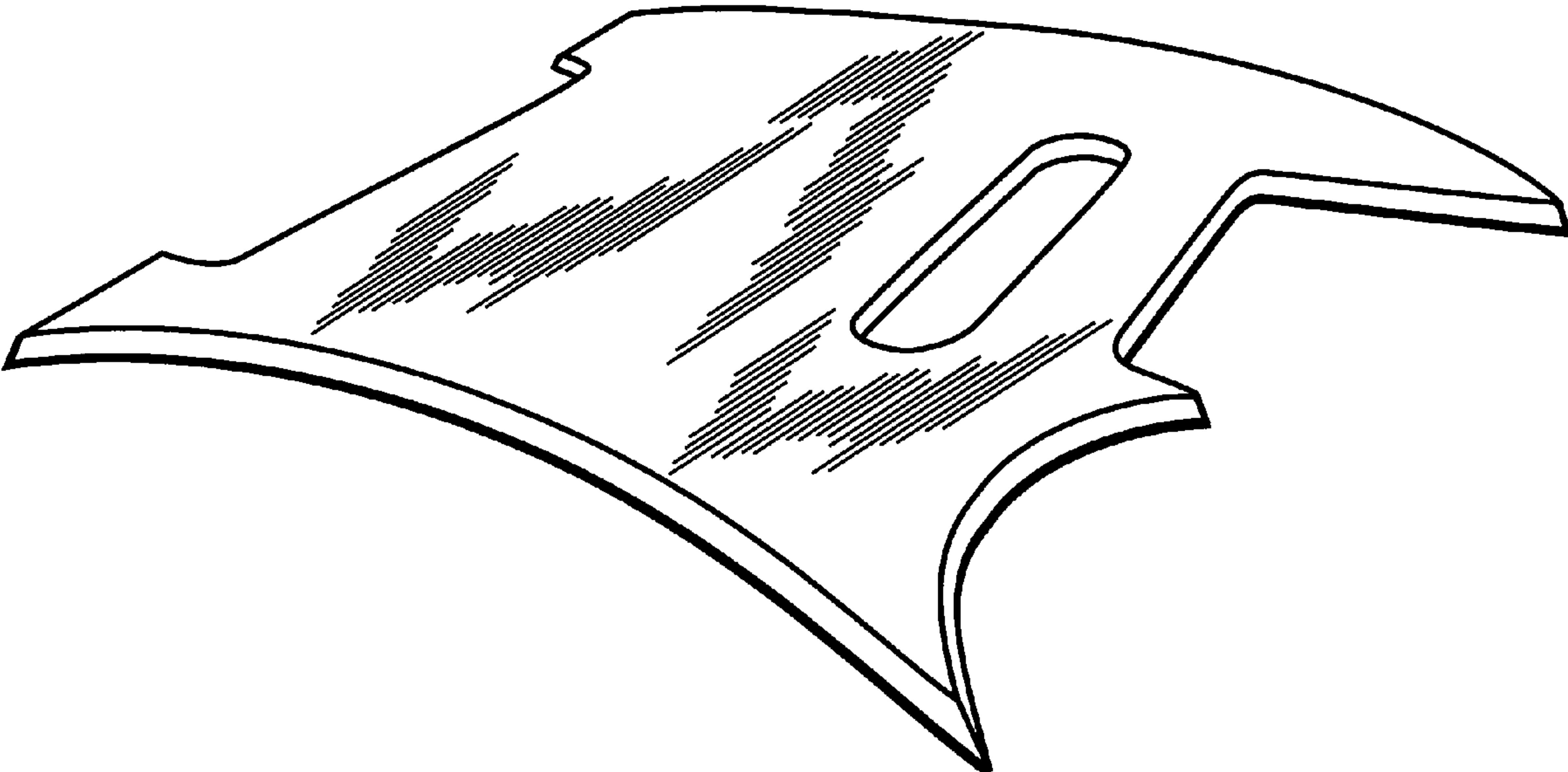

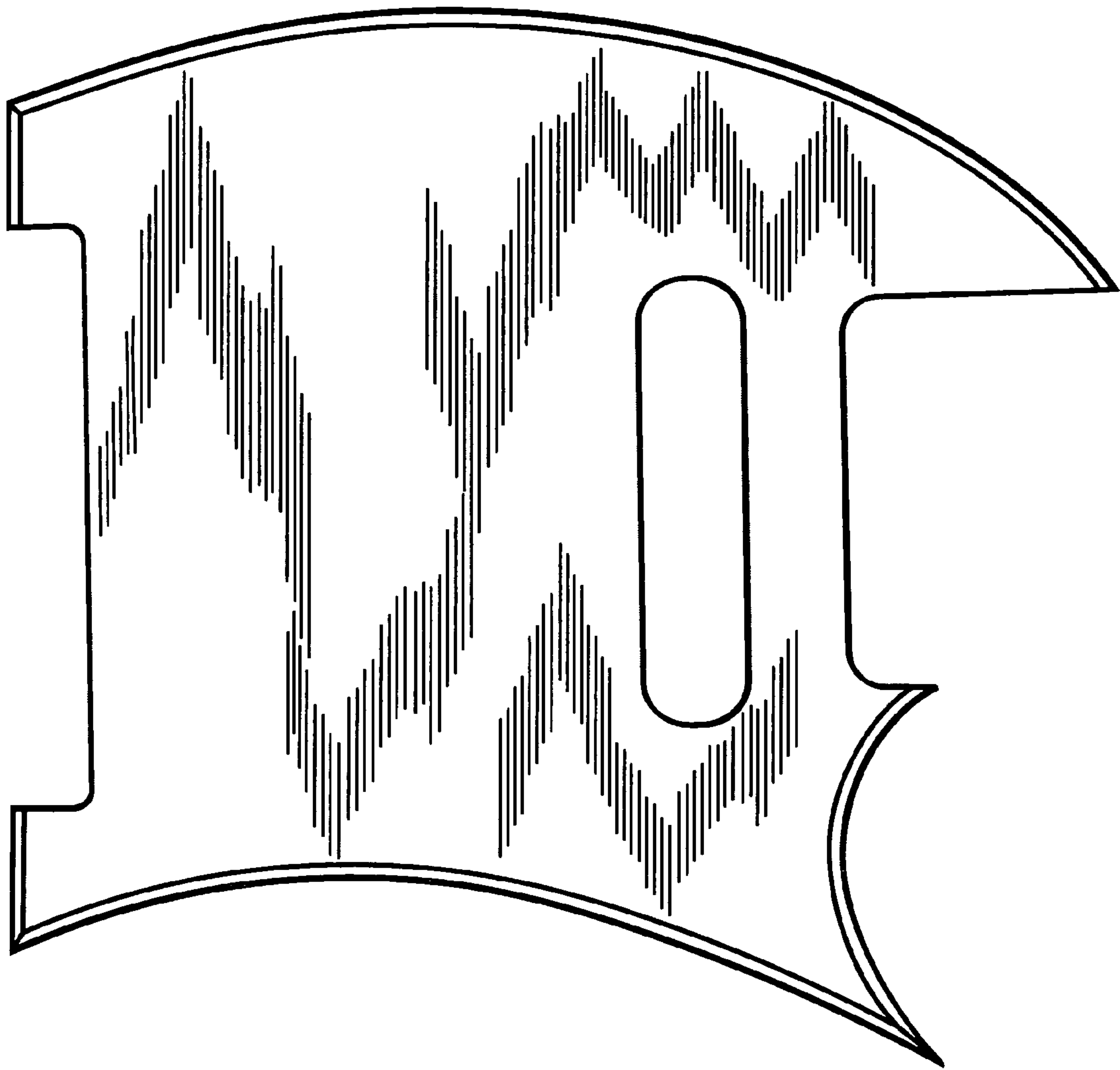

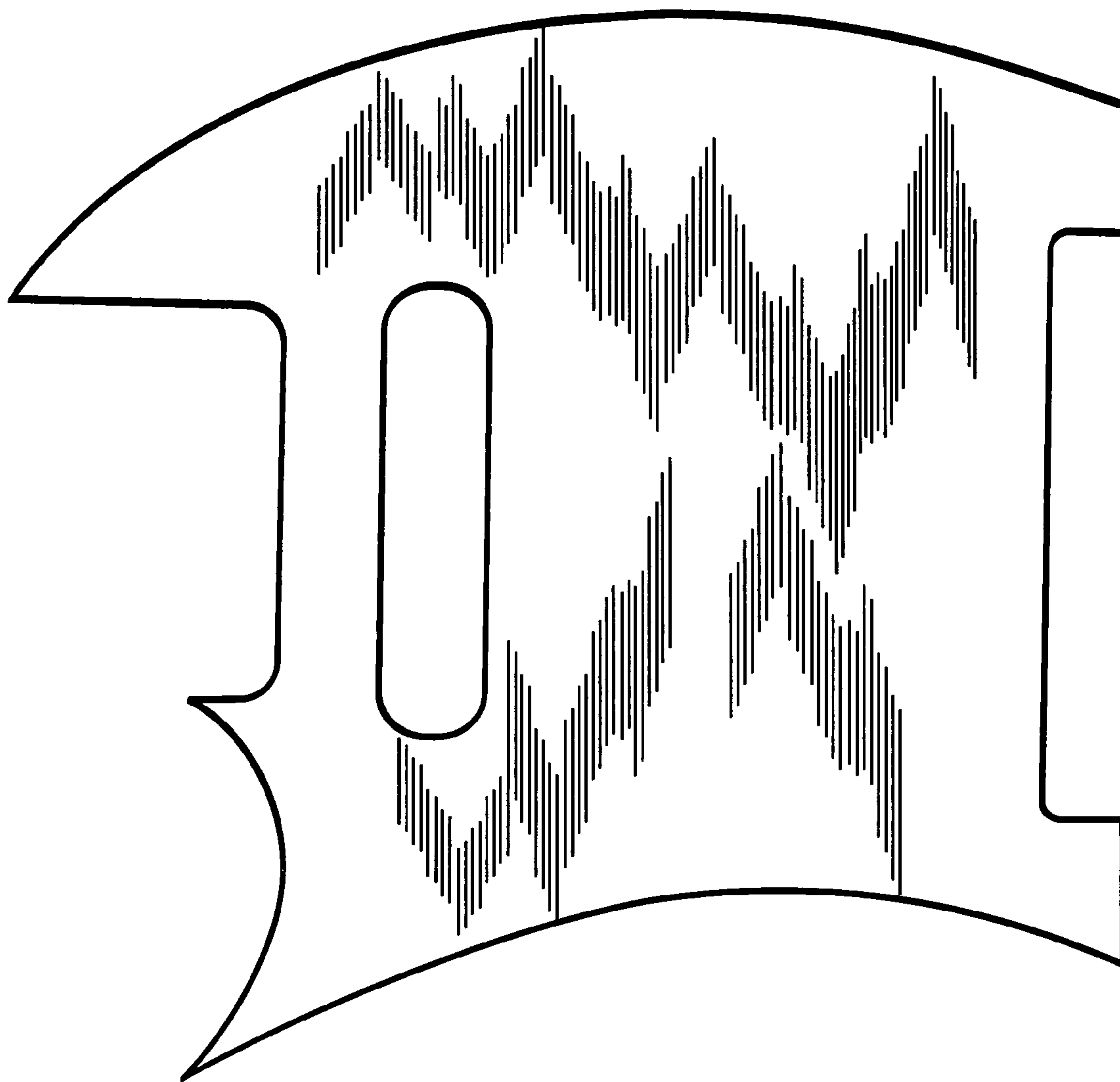

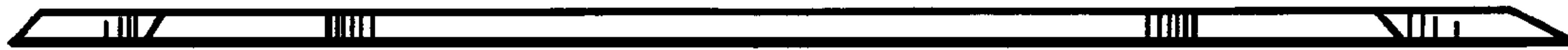
