(57) **CLAIM**

The ornamental design for a wall mounted nameplate, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the wall mounted nameplate illustrating the new design;

FIG. 2 is a right side view of the wall mounted nameplate illustrated in FIG. 1 (the left side view is a mirror image of FIG. 2);

FIG. 3 is a rear view of the wall mounted nameplate illustrated in FIG. 1;

FIG. 4 is a left side view of the wall mounted nameplate illustrated in FIG. 1;

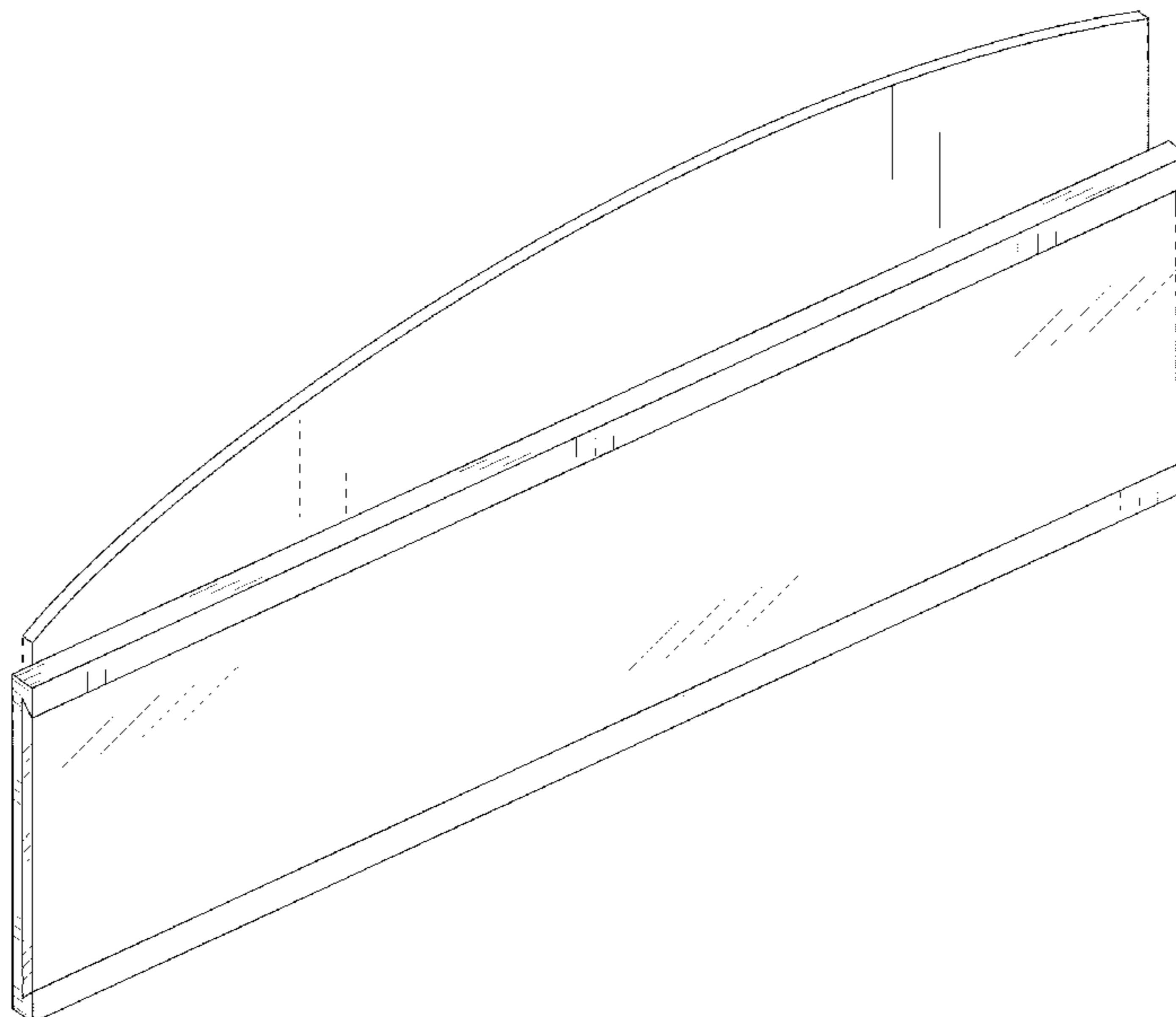
FIG. 5 is a top view of the wall mounted nameplate illustrated in FIG. 1;

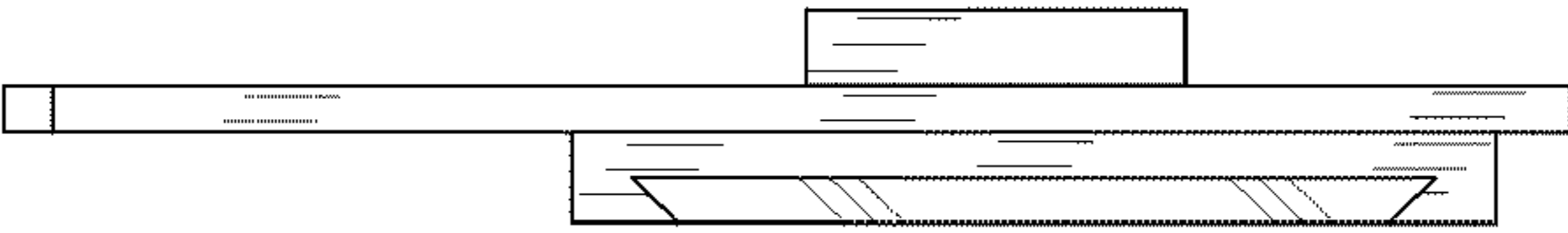

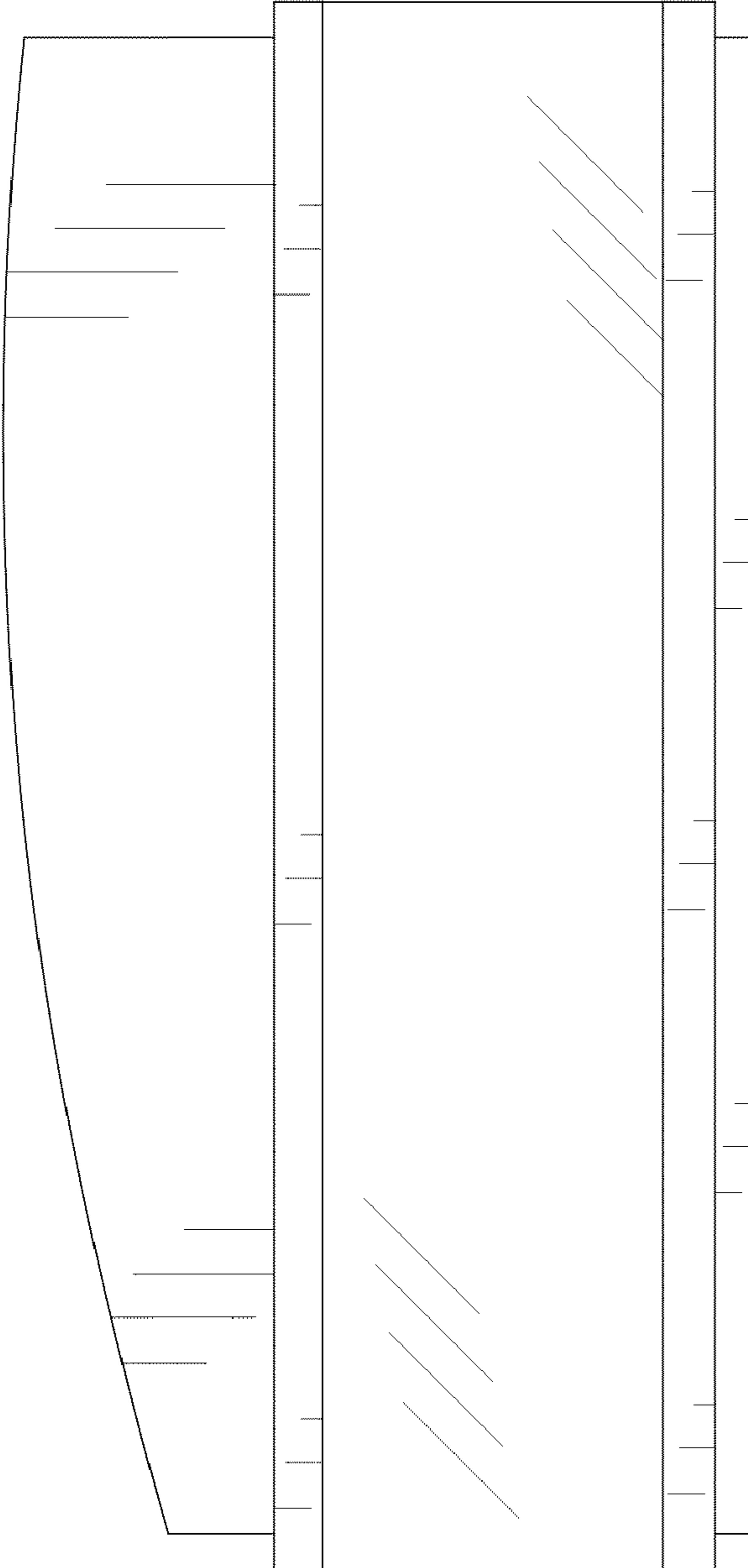

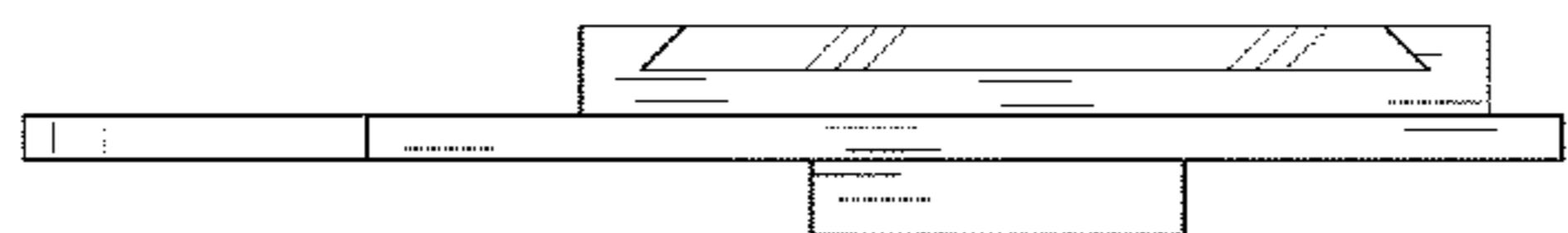

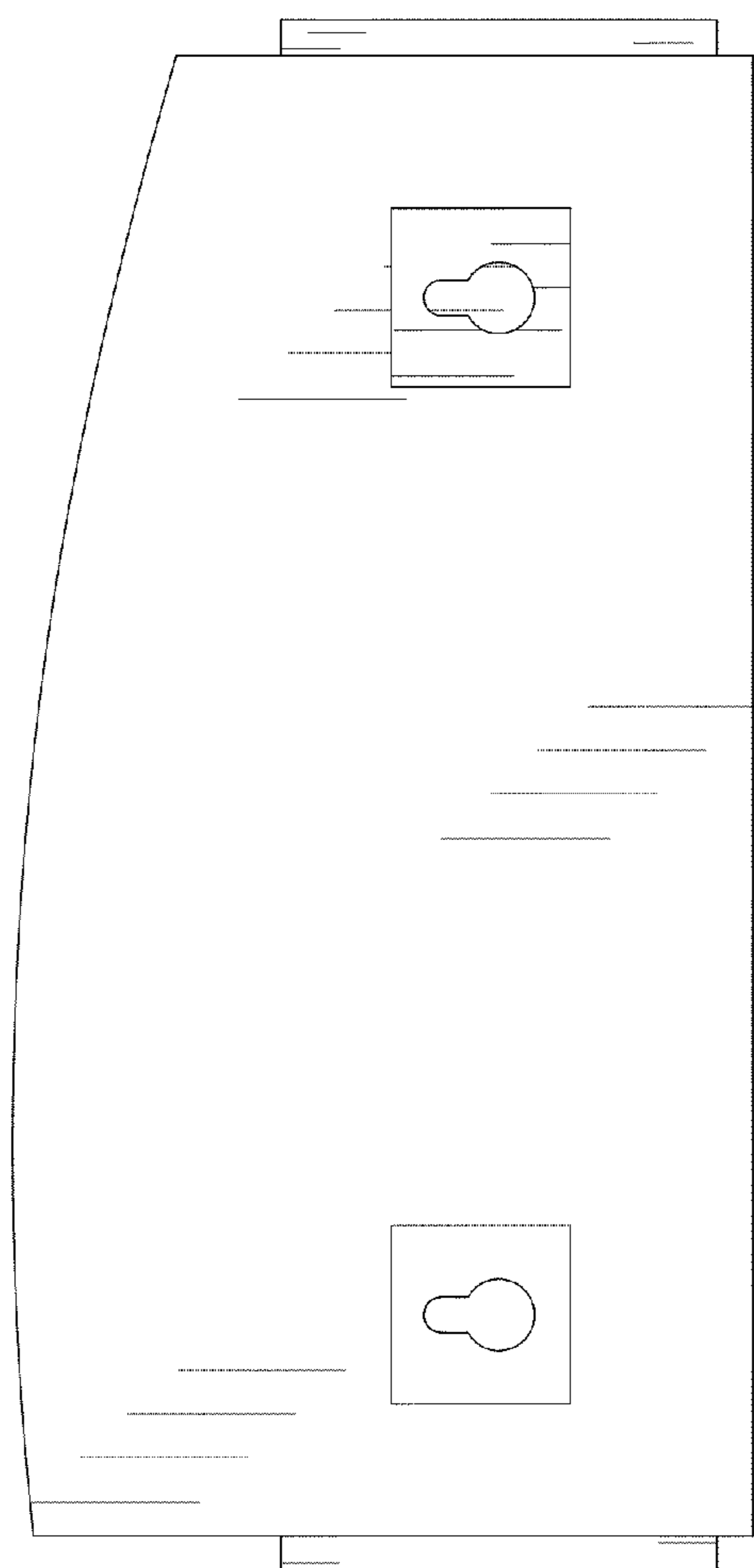

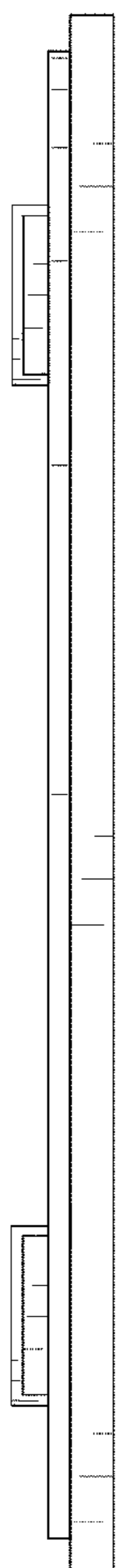

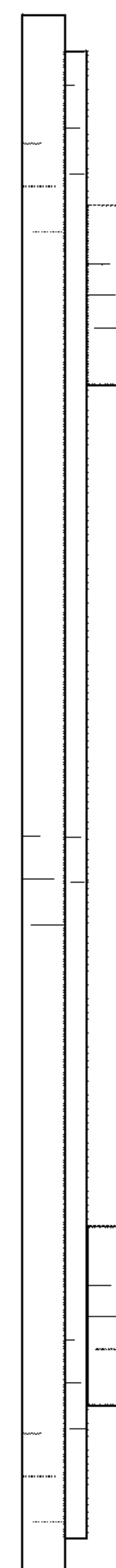

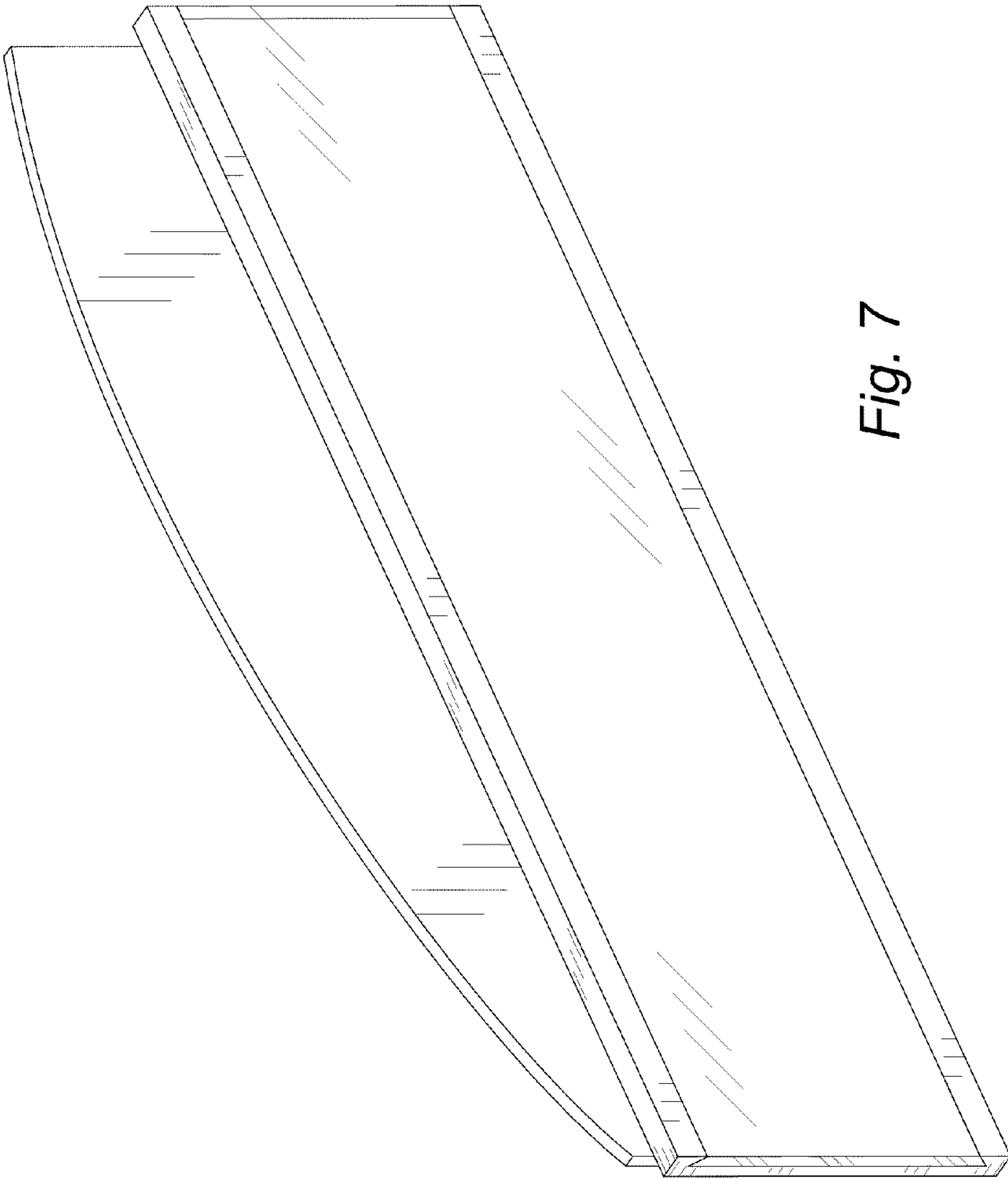

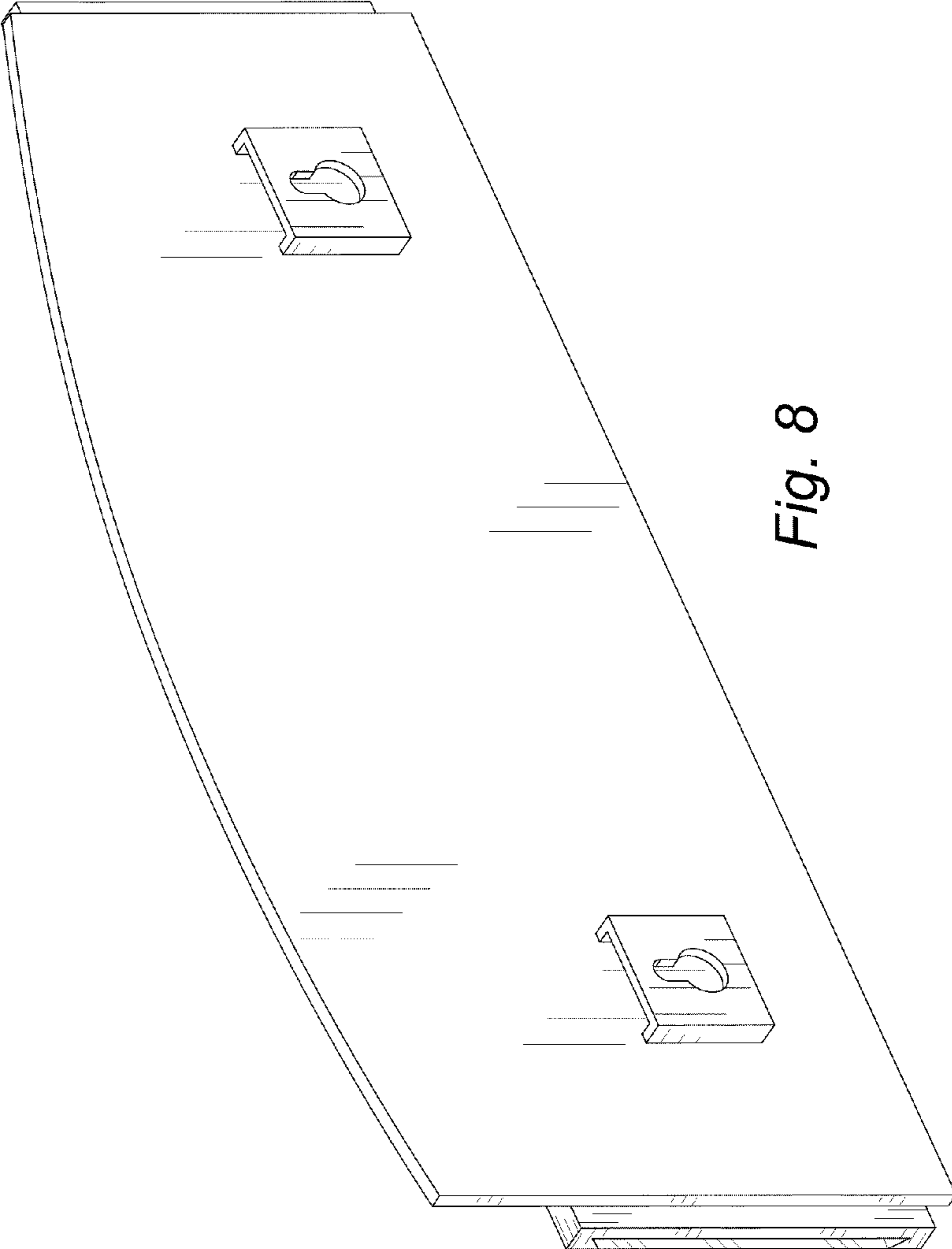
