The ornamental design for a forceps, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a forceps according to the invention.

FIG. 2 is a right side elevational view of the forceps of FIG. 1.

FIG. 3 is a top plan view of the forceps of FIG. 1.

FIG. 4 is a bottom plan view of the forceps of FIG. 1.

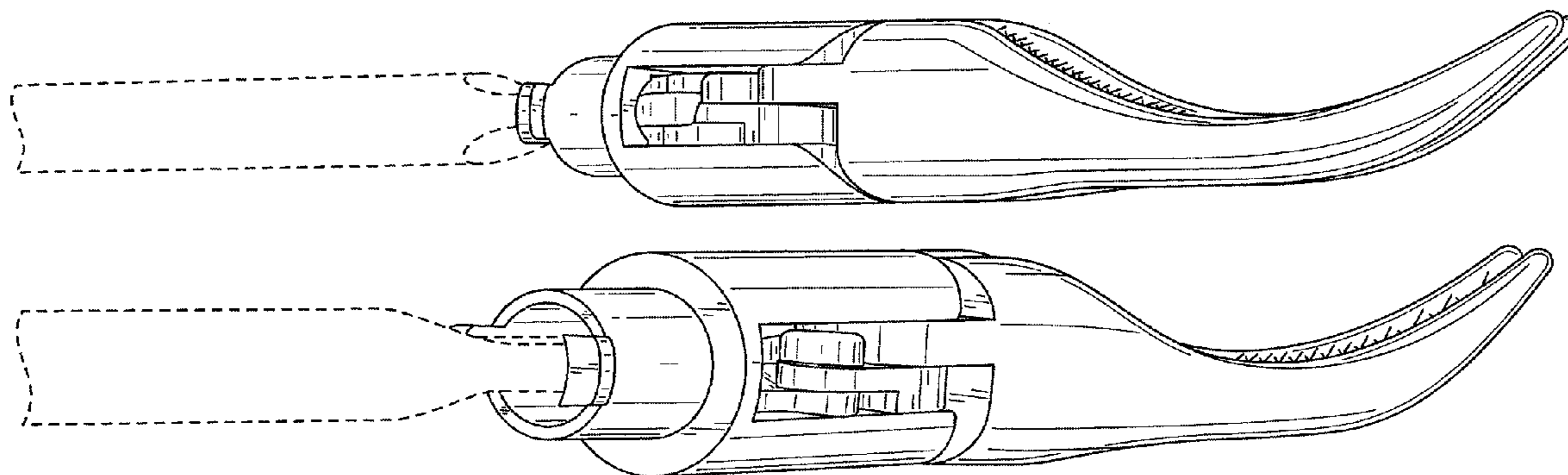
FIG. 5 is a front perspective view of the forceps of FIG. 1.

FIG. 6 is a rear perspective view of the forceps of FIG. 1; and,

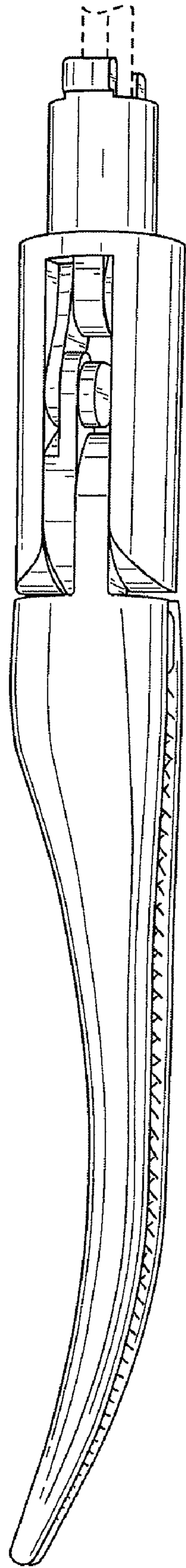

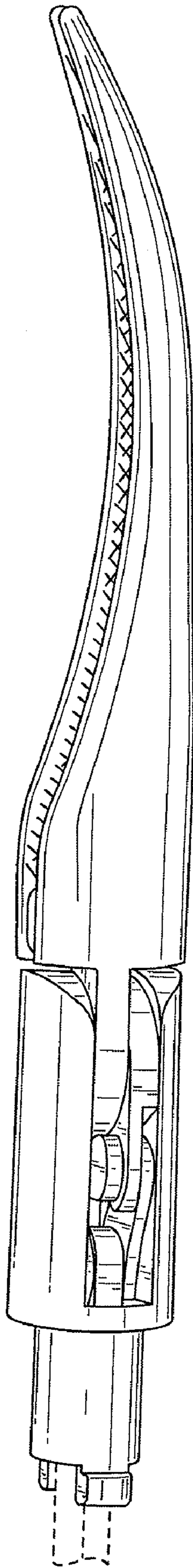

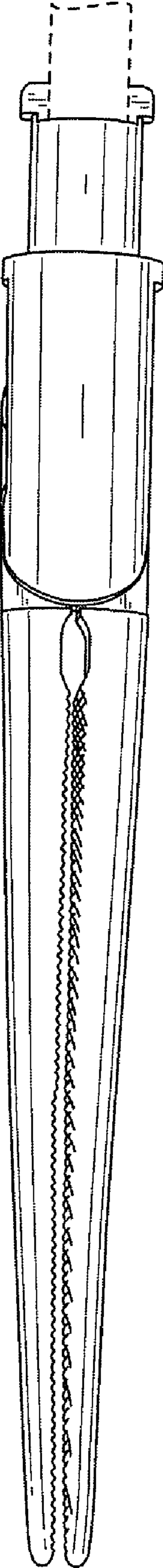

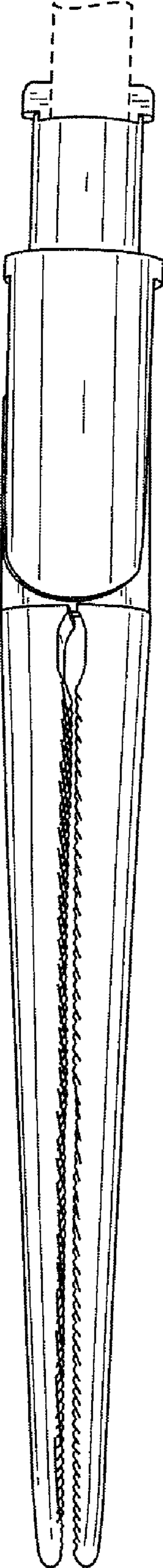

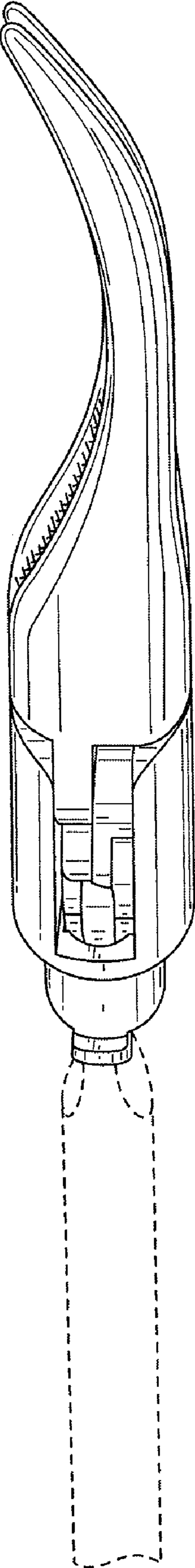

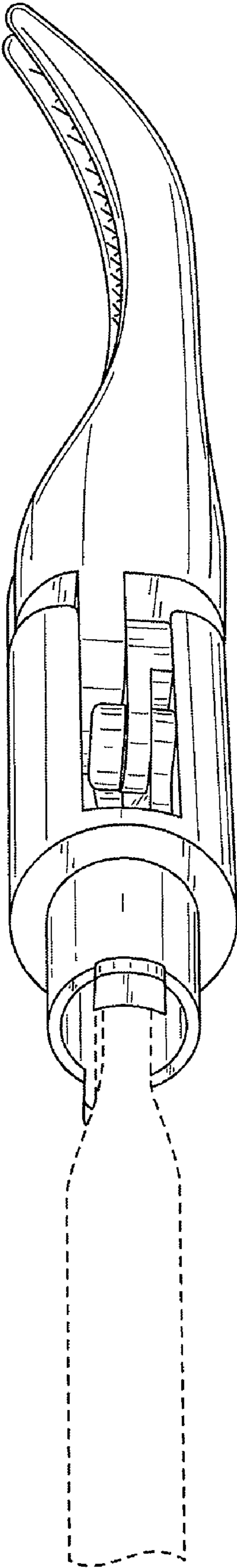

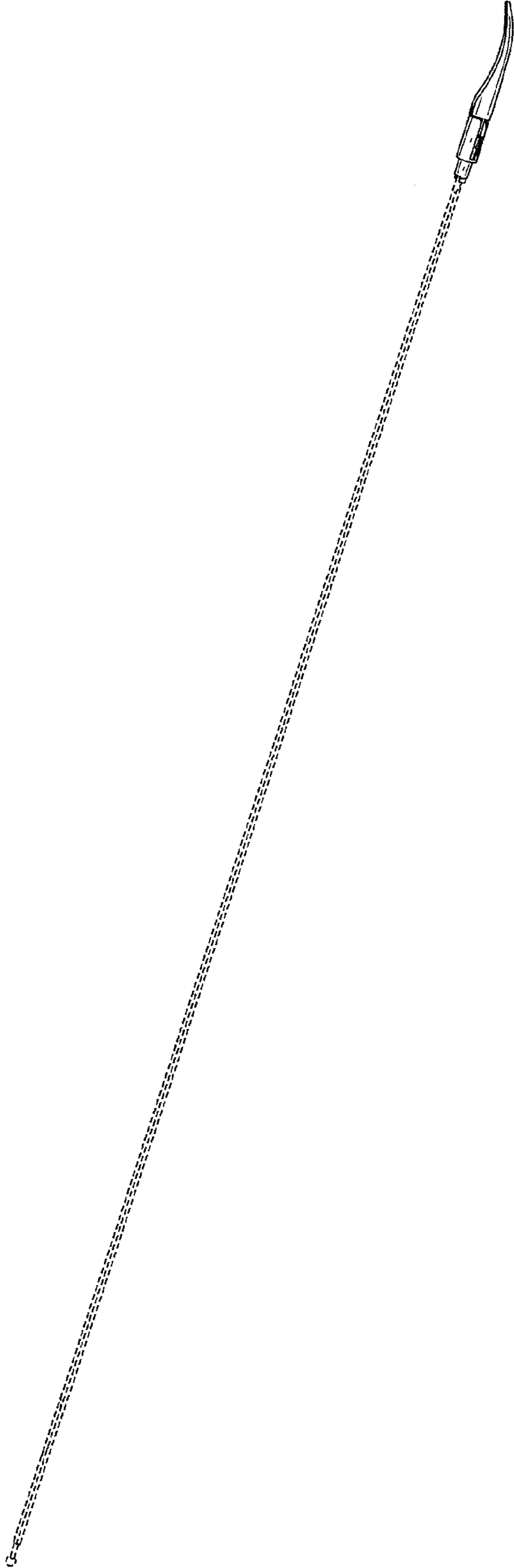
