(57) **CLAIM**

I claim the ornamental design for a tobacco pipe reemer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tobacco pipe reemer, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

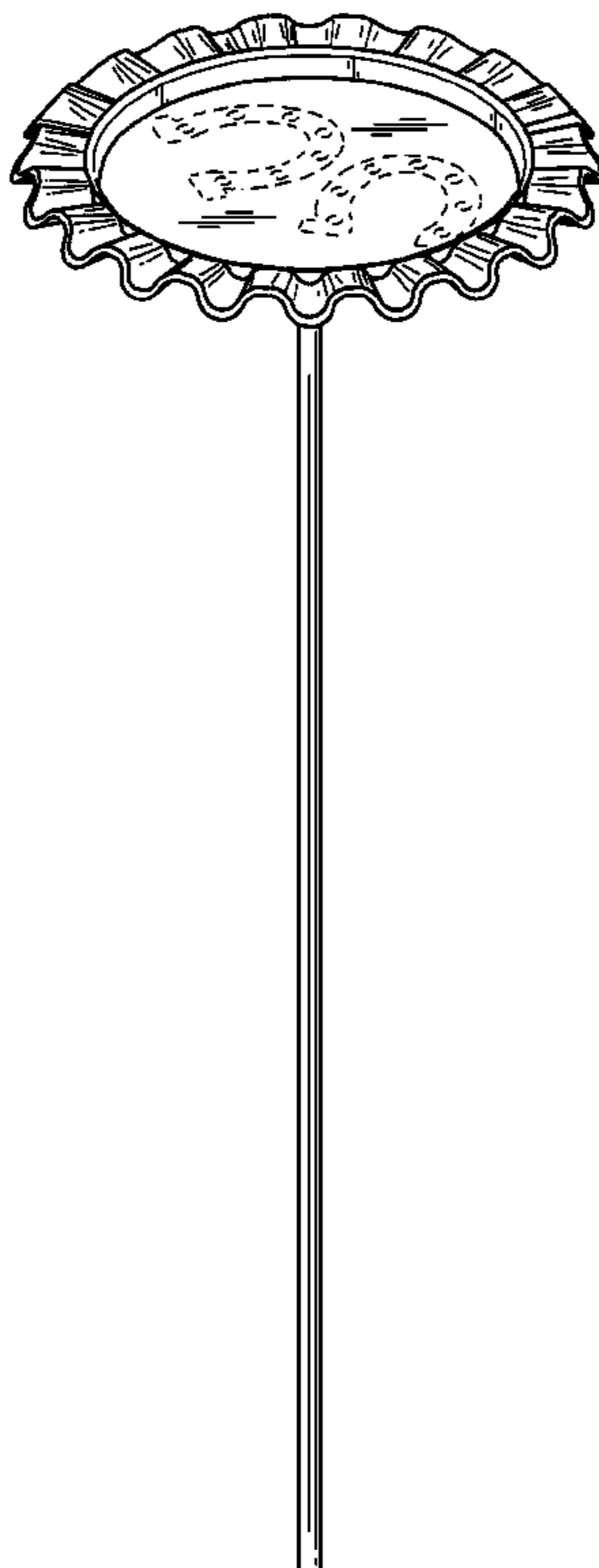
FIG. 5 is a right-side elevational view thereof;

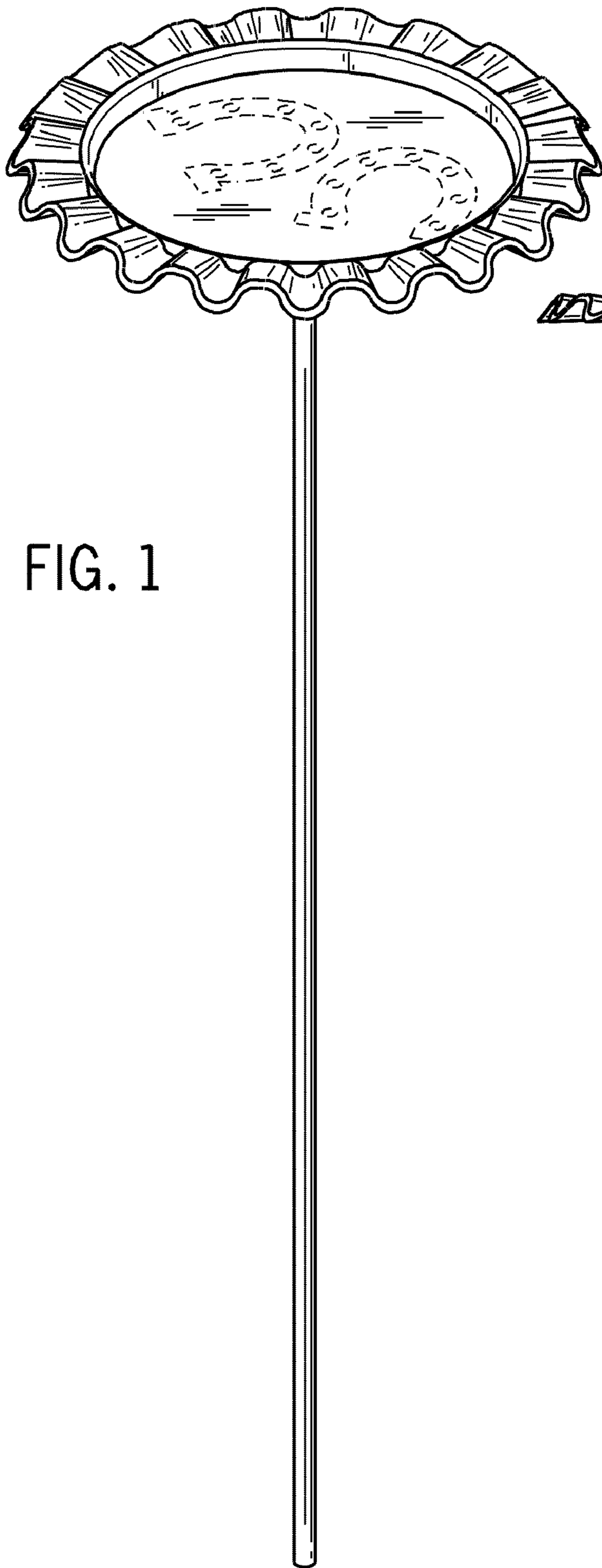

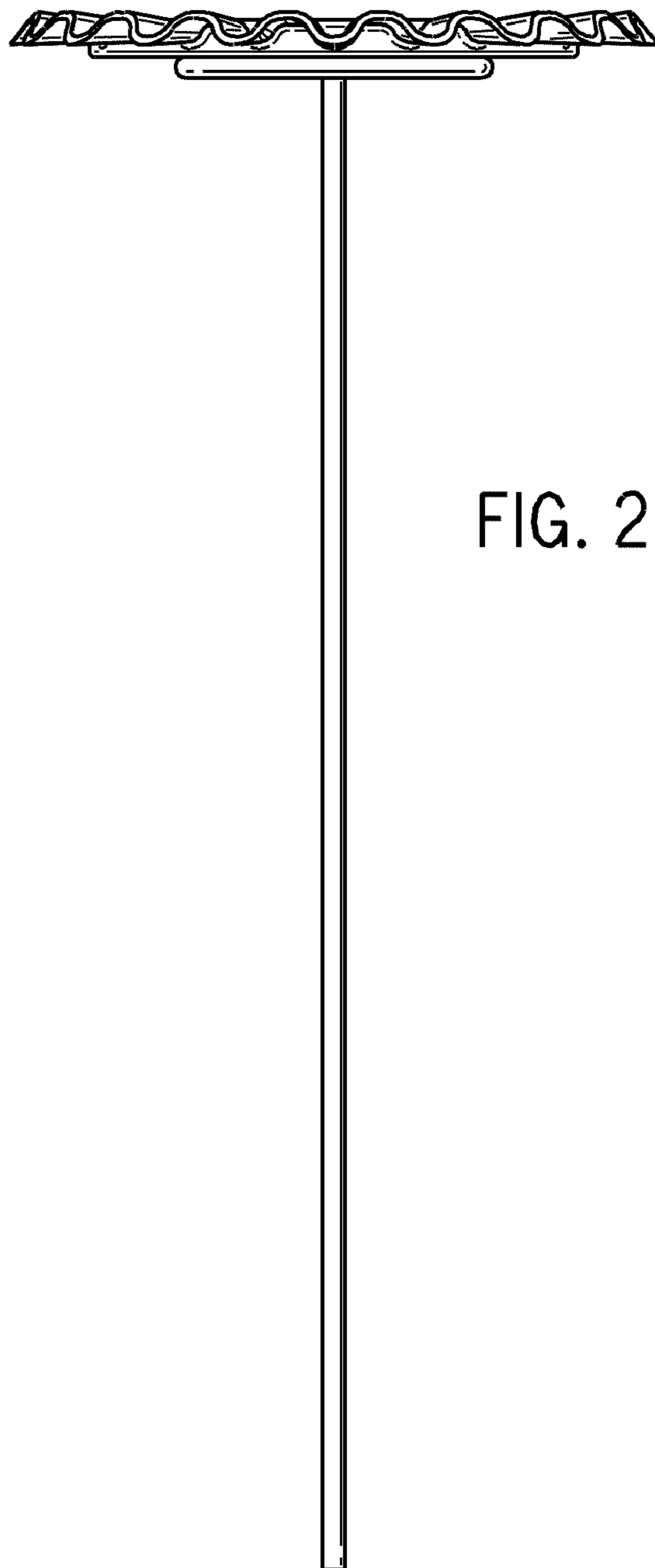

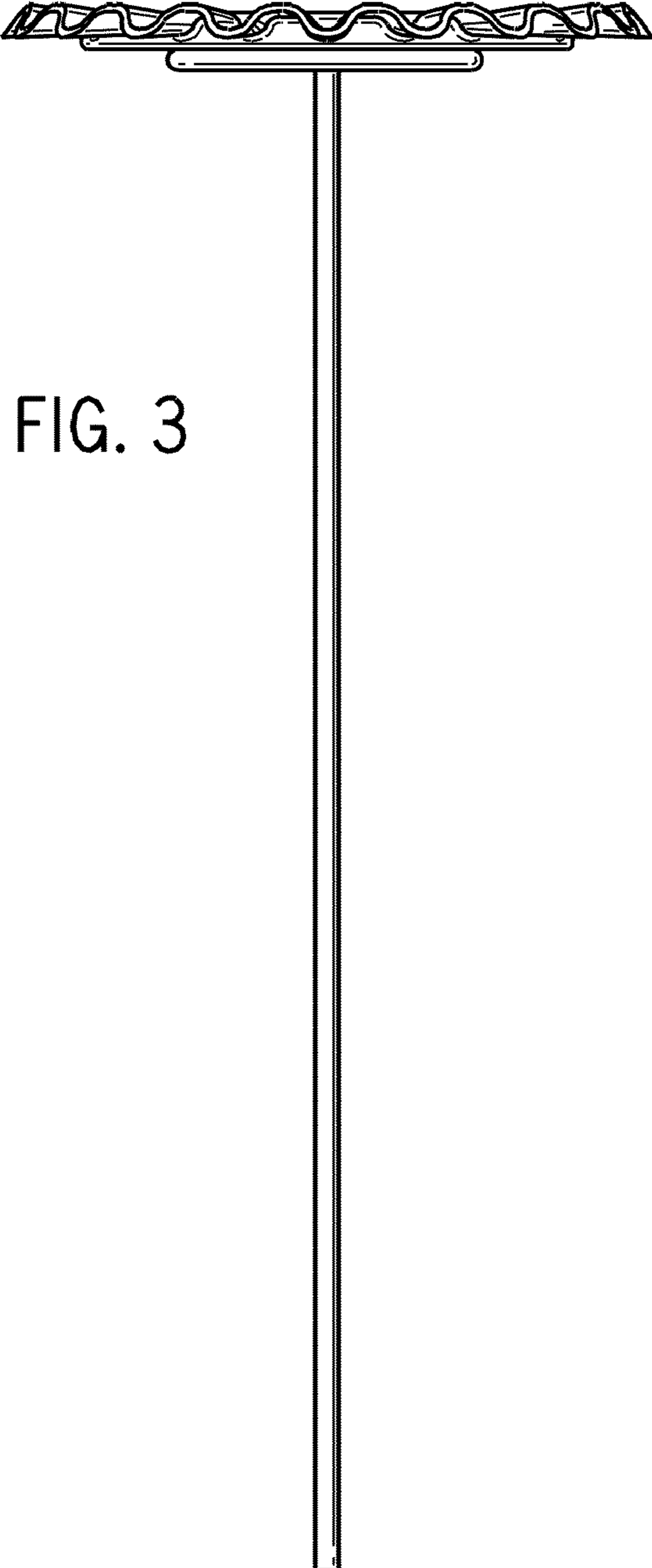

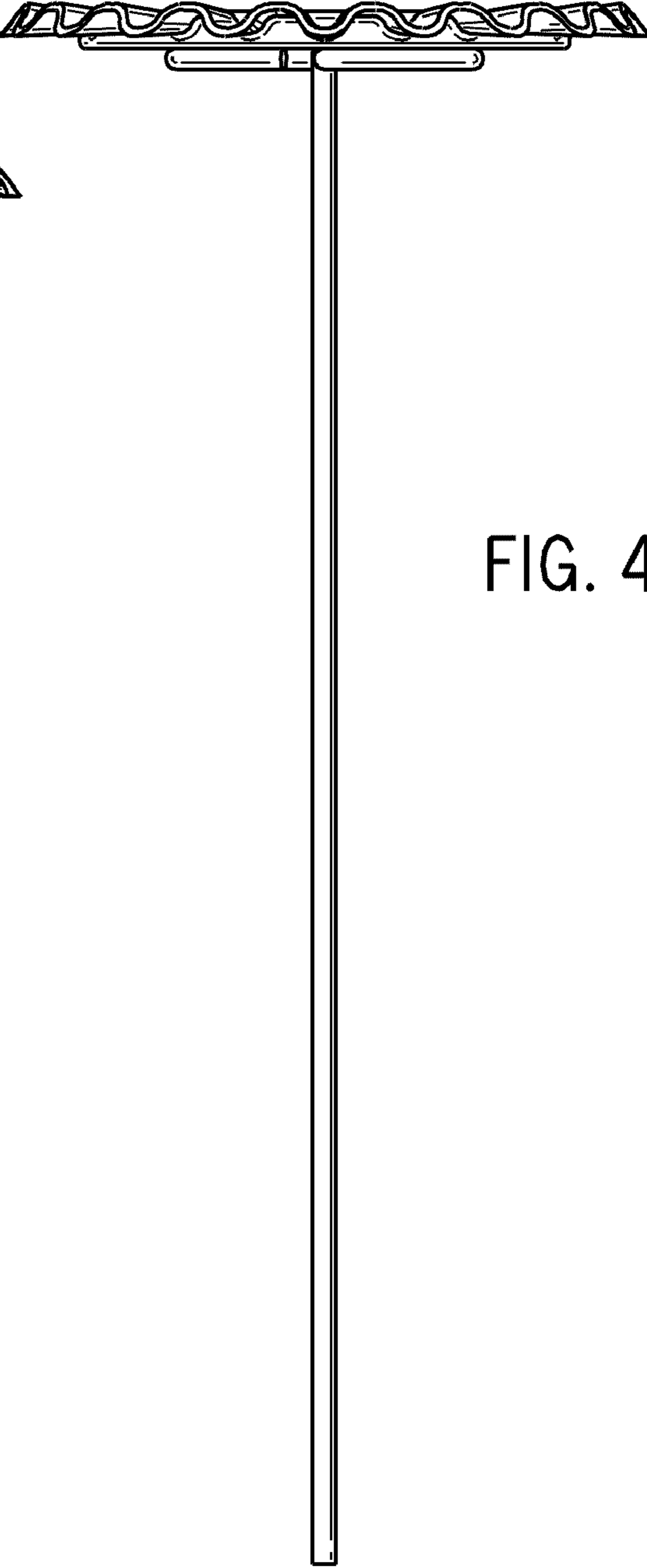

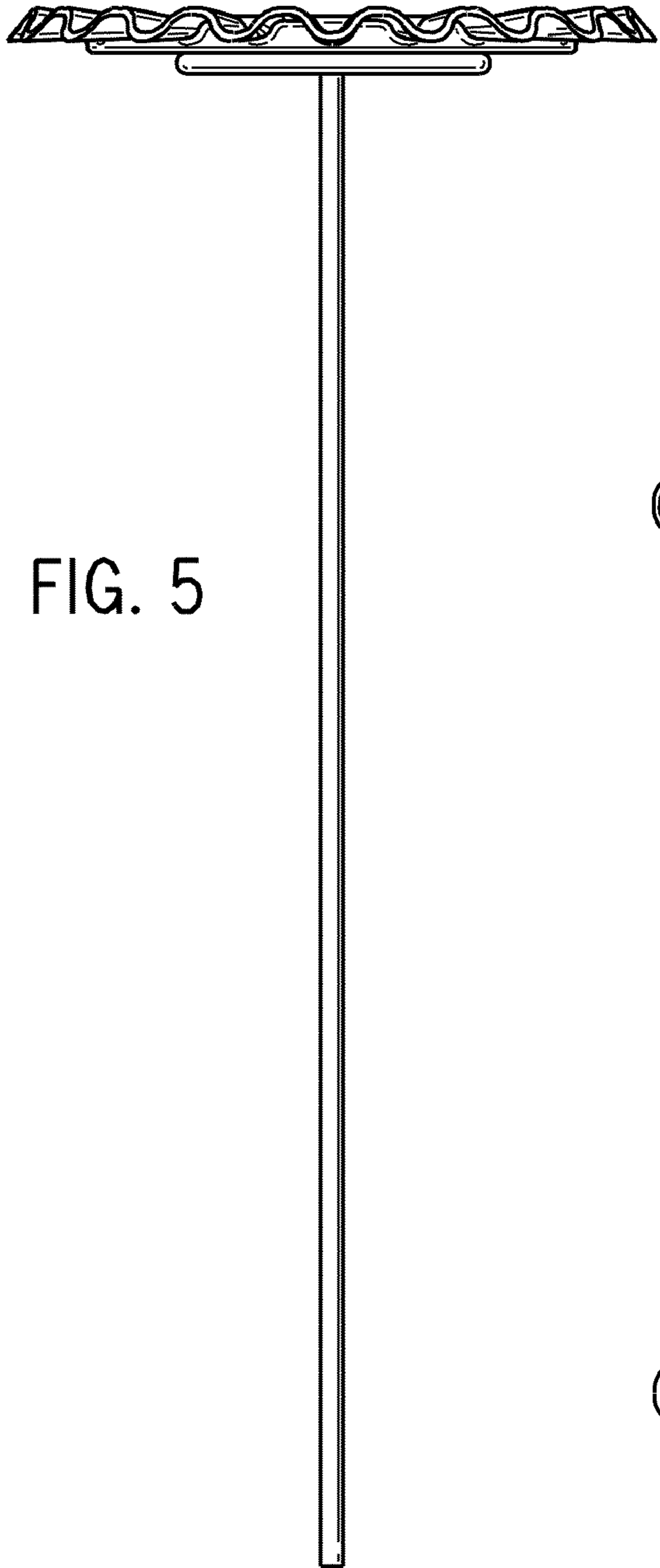

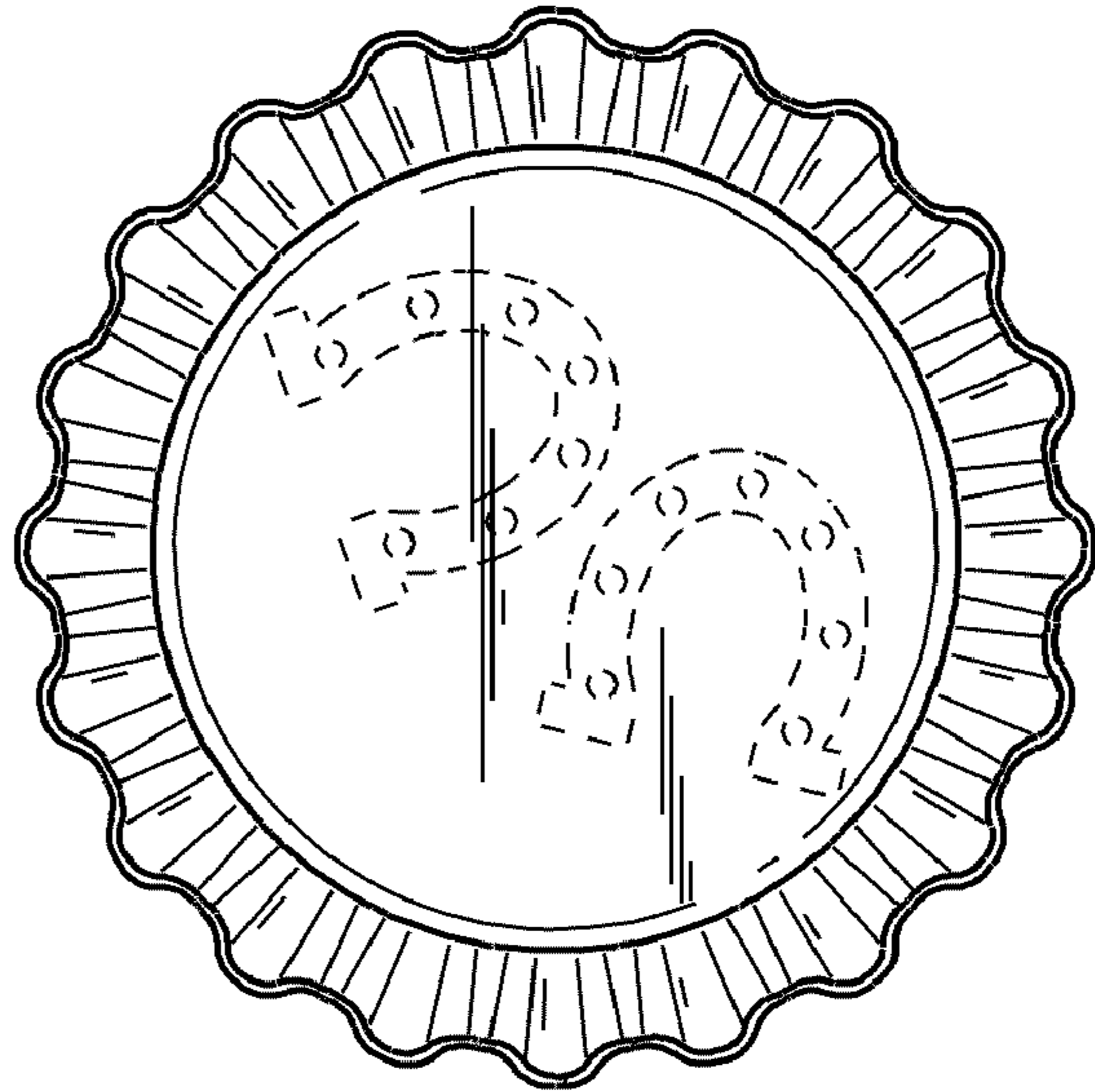

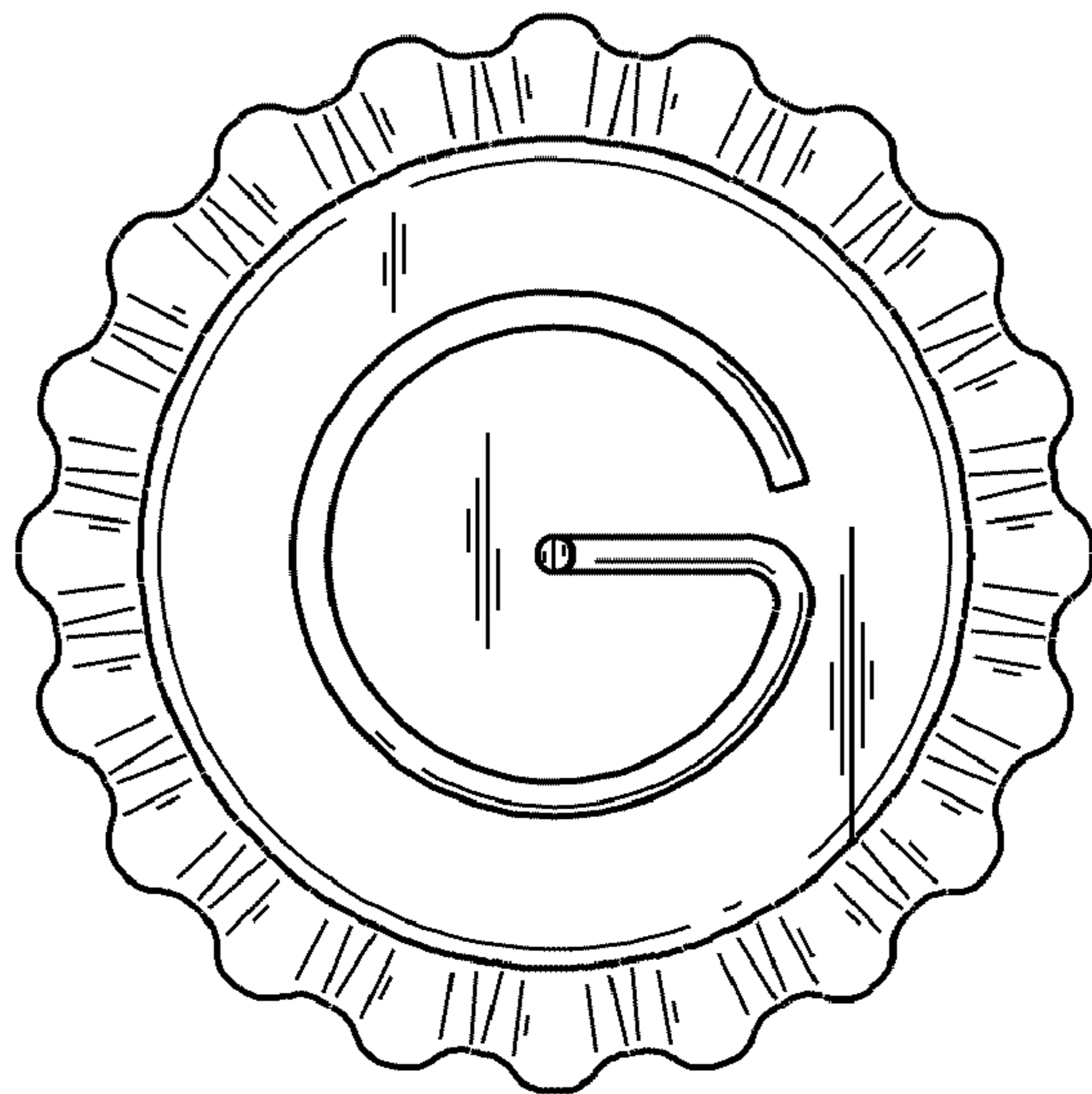
