(57) **CLAIM**

The ornamental design for an electric shaver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electric shaver;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is an enlarged top plan view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is an enlarged front view showing 5-5 portion in FIG. 4.
 FIG. 6 is an enlarged sectional view thereof taken along line 6-6 of FIG. 5, in which the internal components are omitted;
 FIG. 7 is a right side view thereof;
 FIG. 8 is an enlarged right side view showing 8-8 portion in FIG. 7;
 FIG. 9 is a rear view thereof;
 FIG. 10 is a left side view thereof; and,
 FIG. 11 is a bottom plan view thereof.
 The portions of the article in broken lines are shown for illustrative purposes only and form no part of the claimed design.

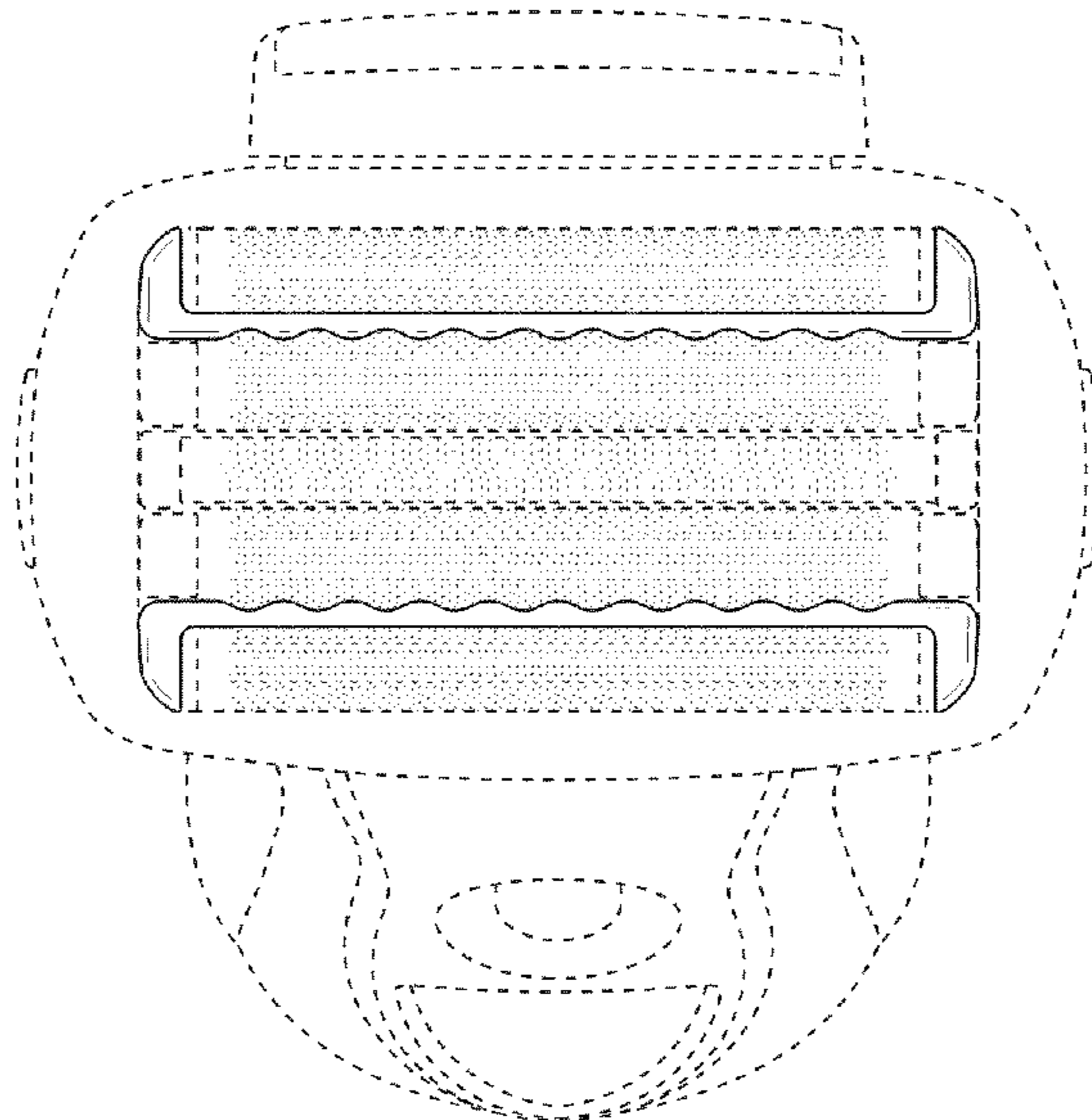

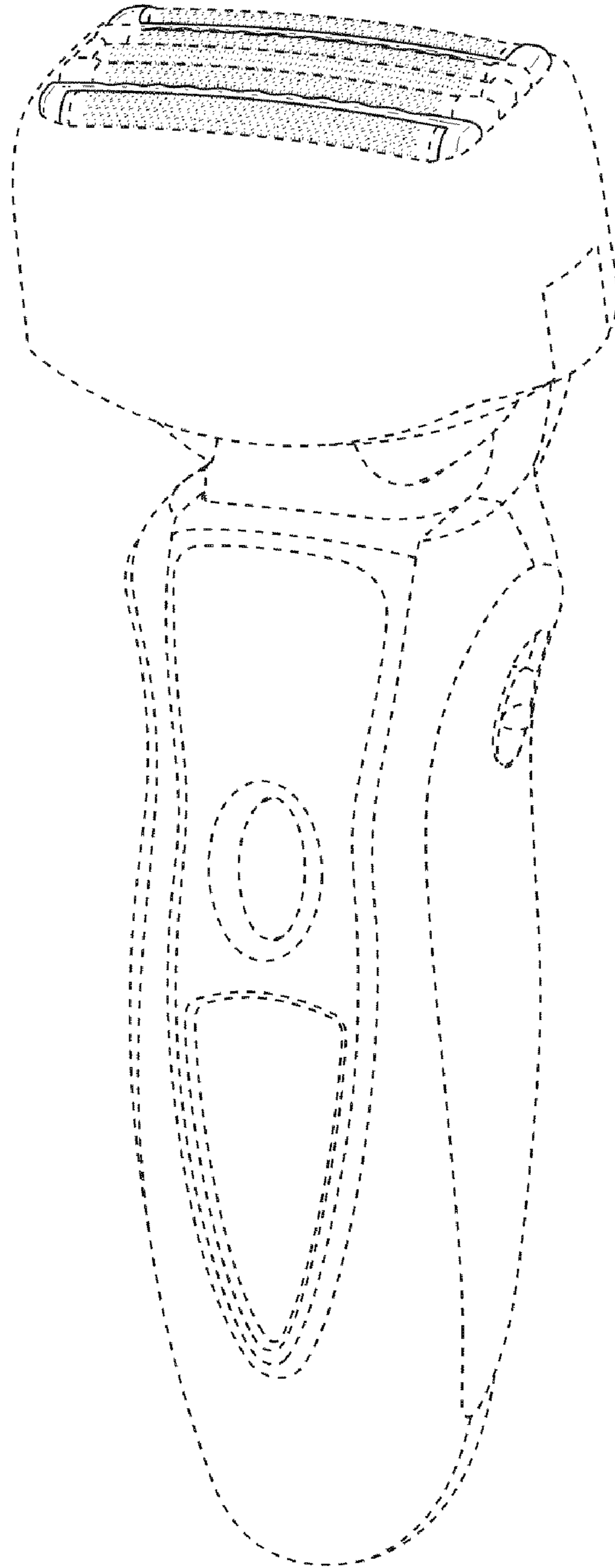

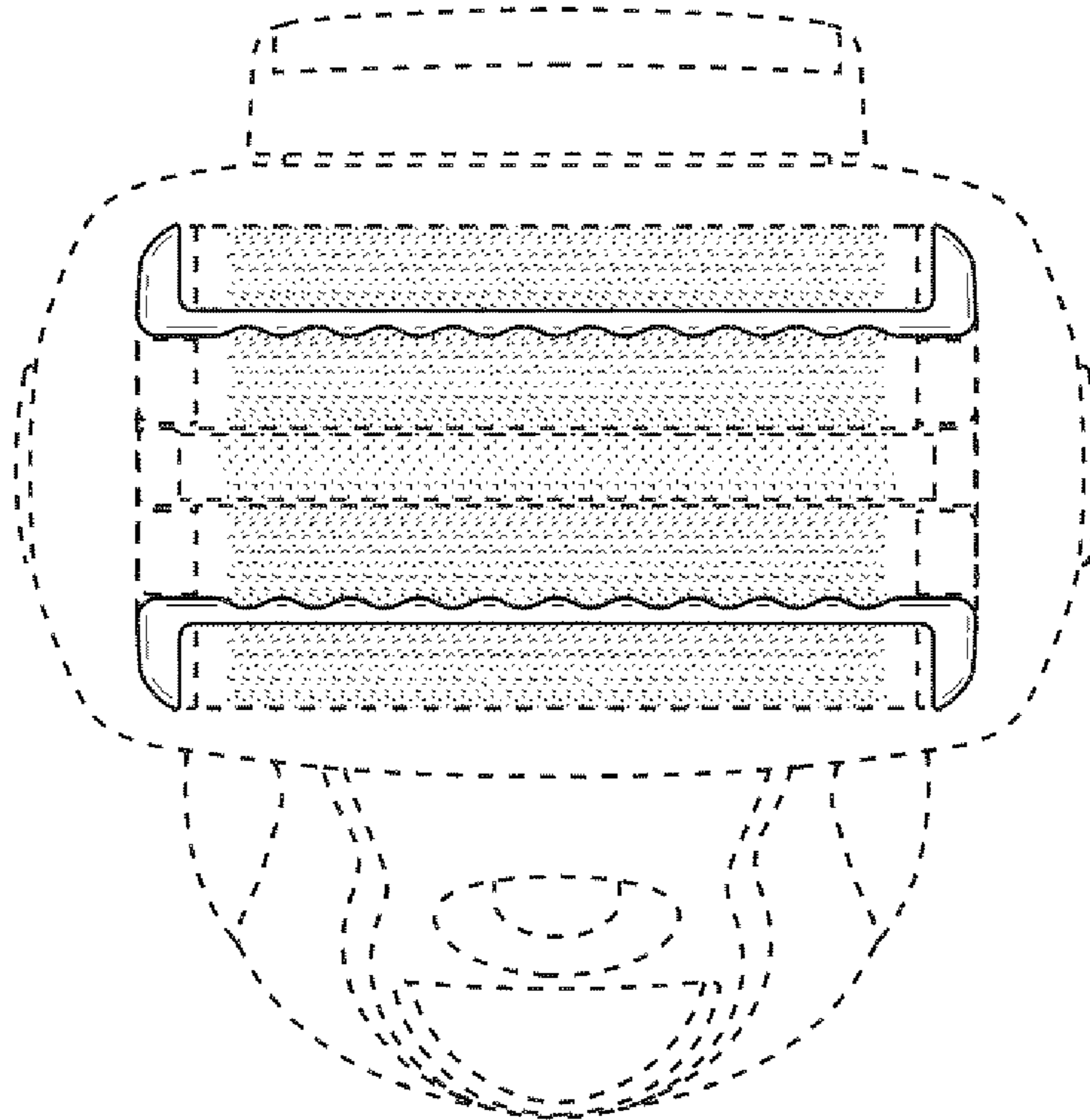

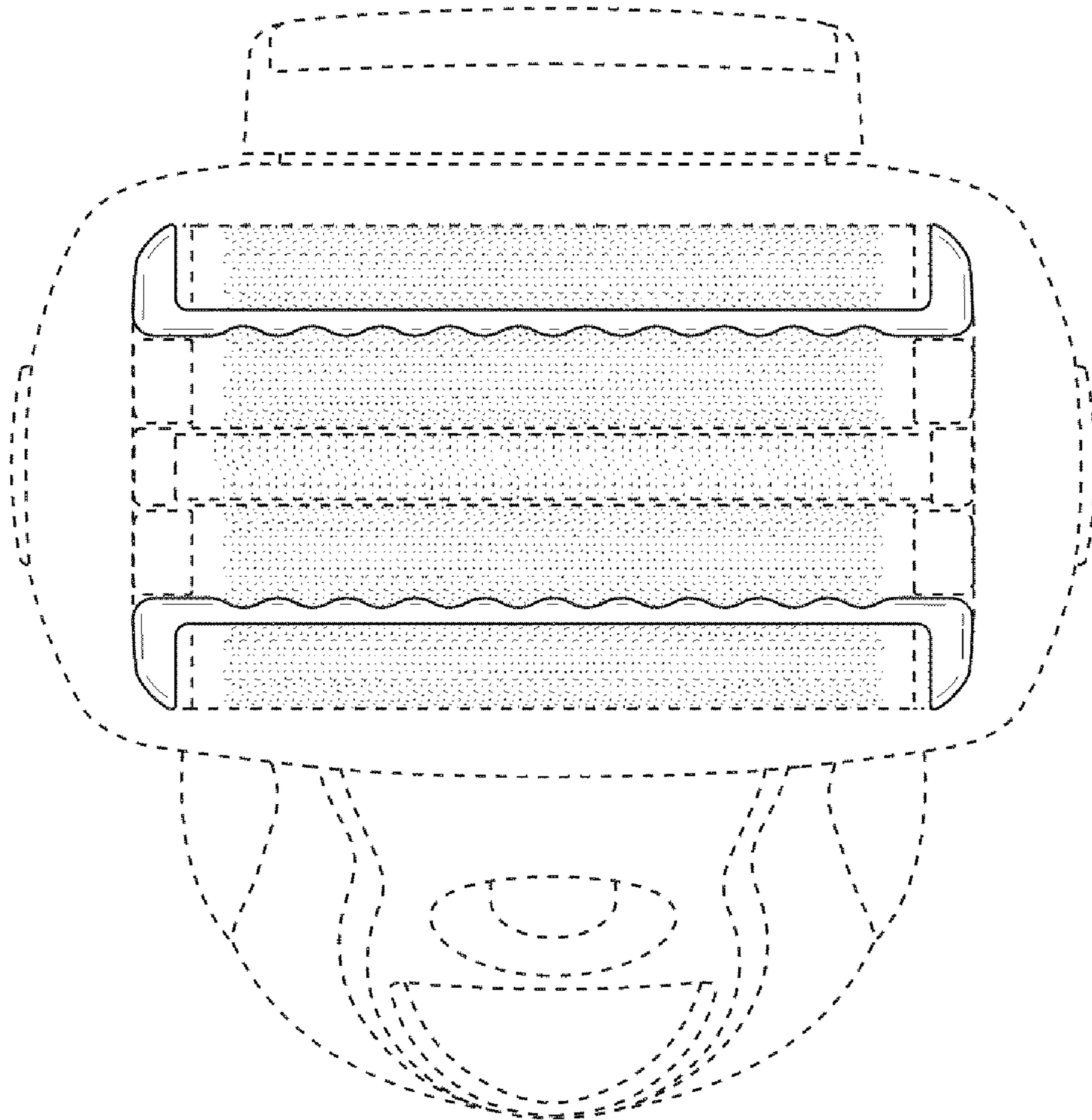

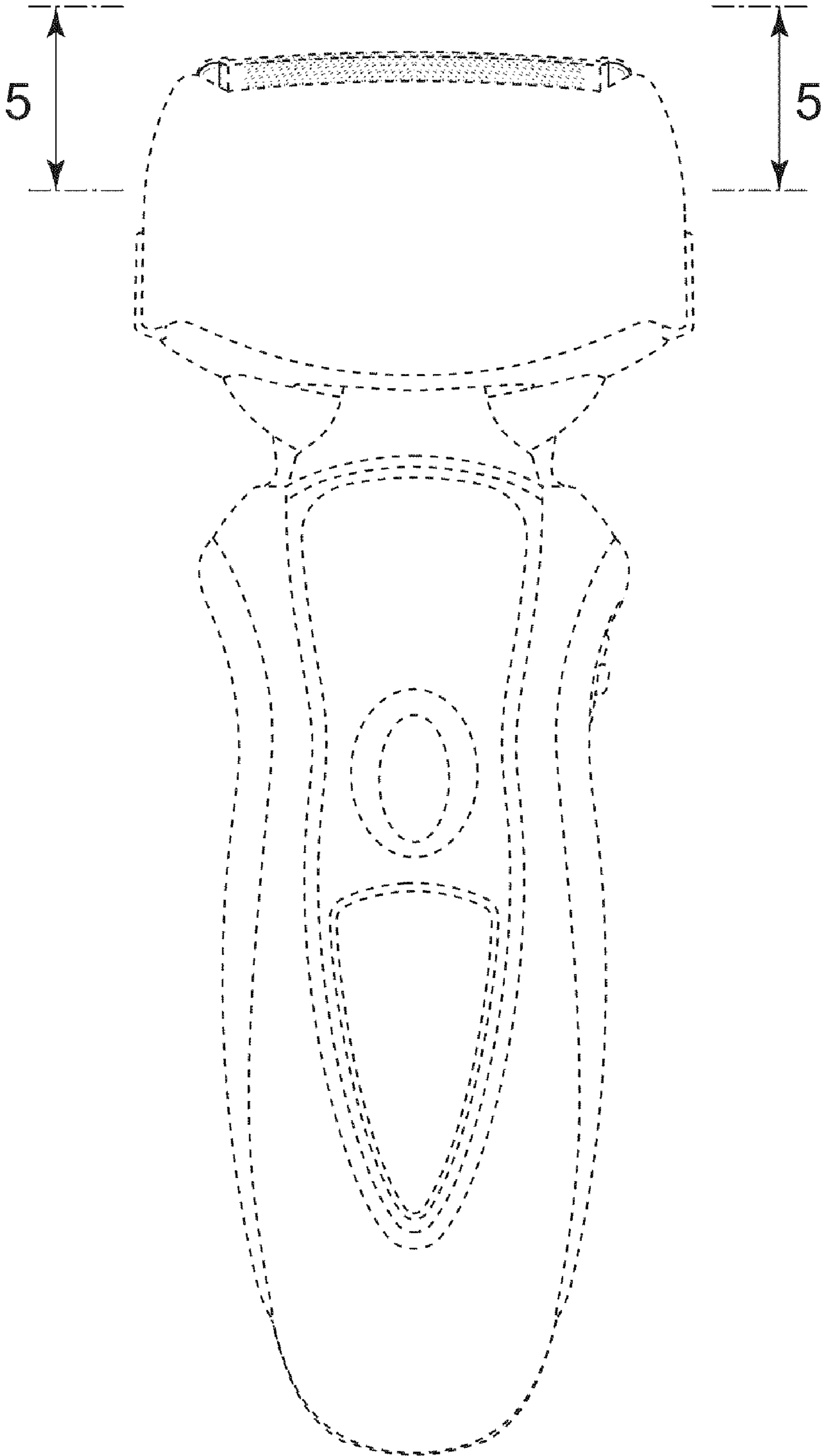

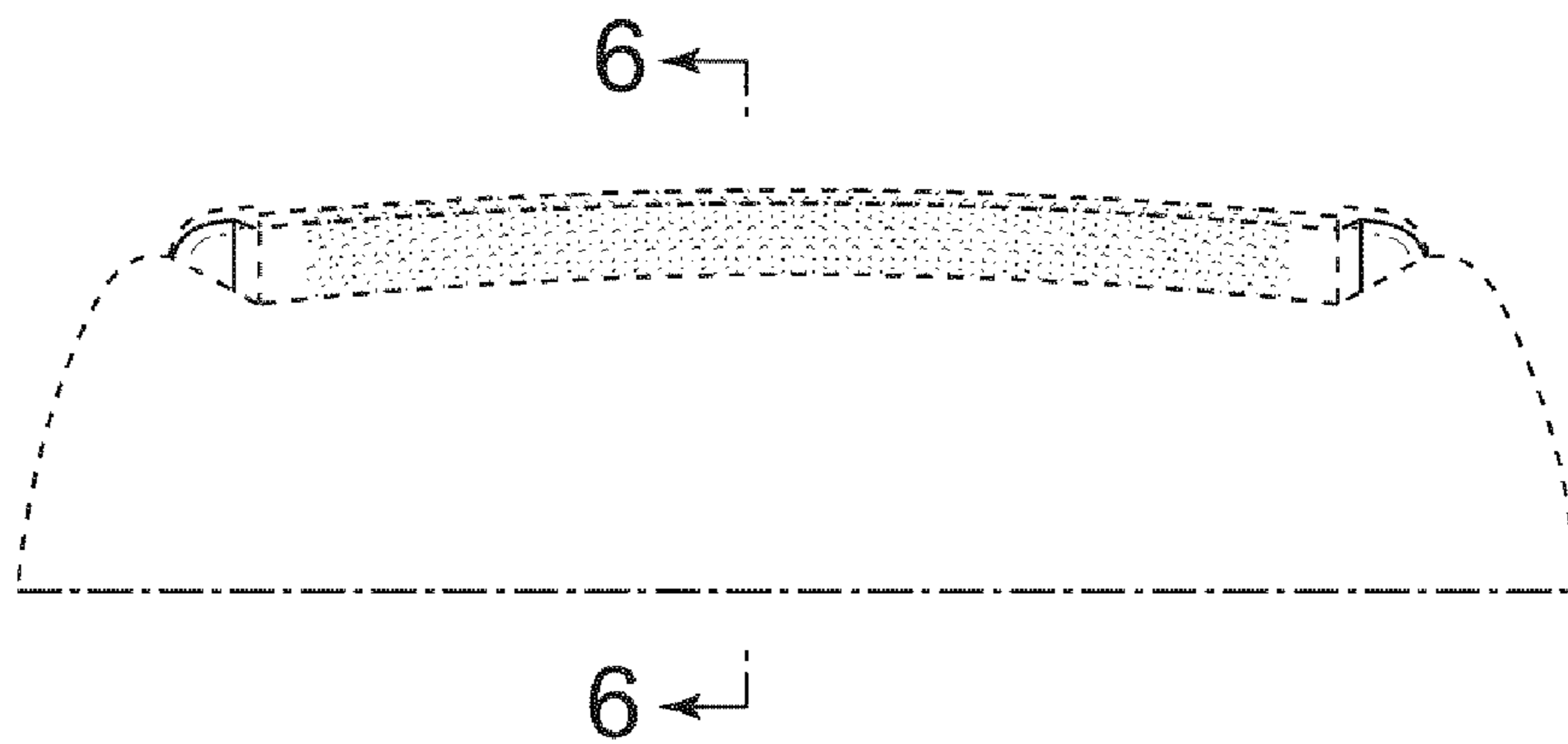

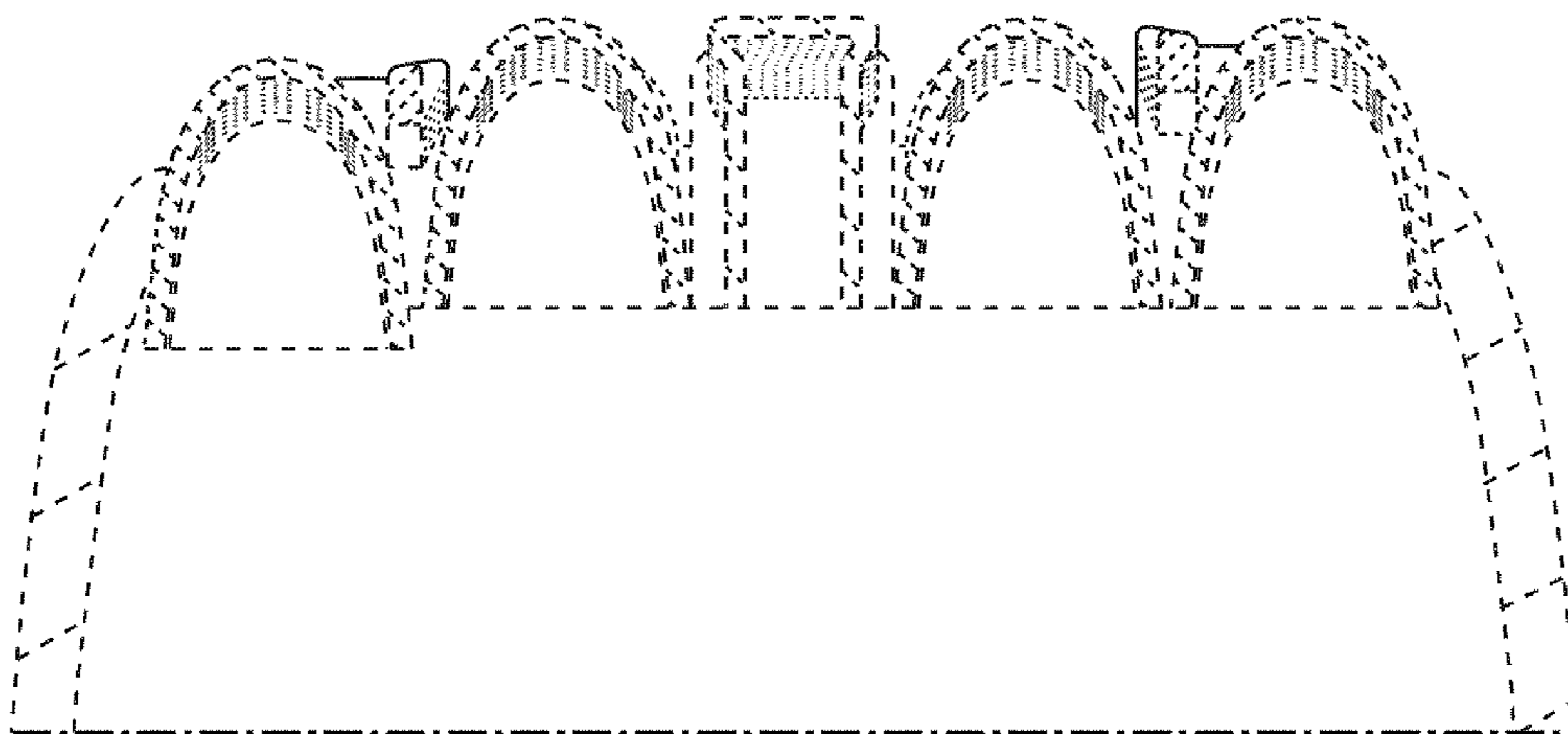

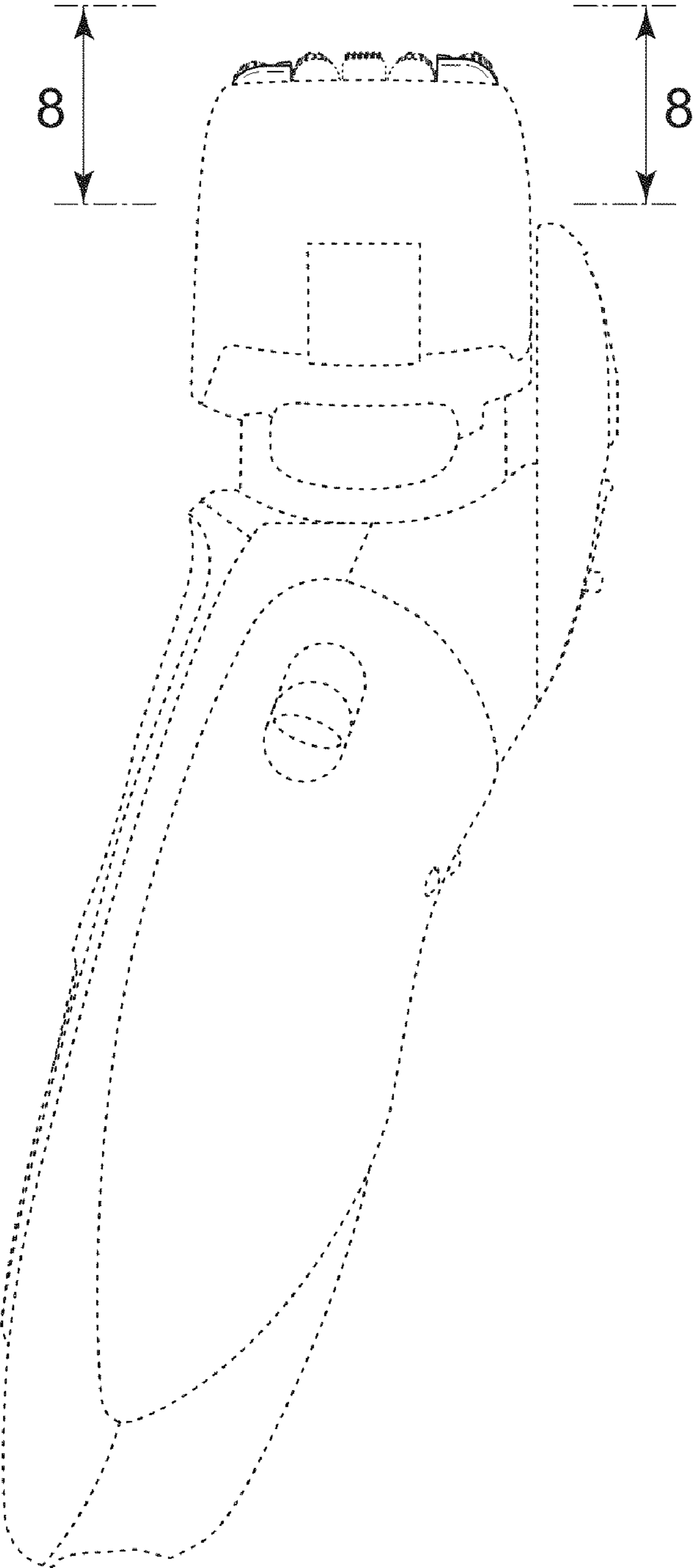

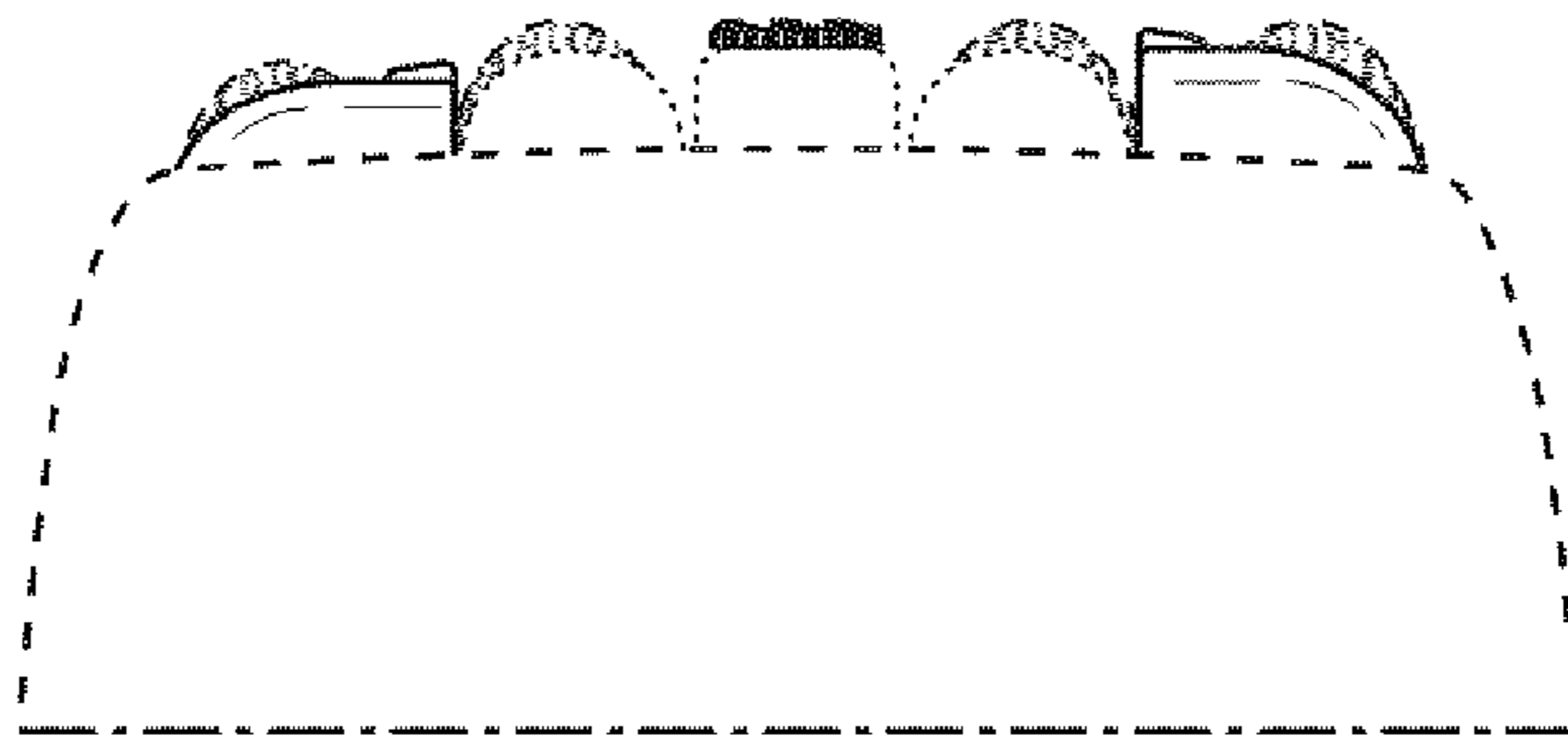

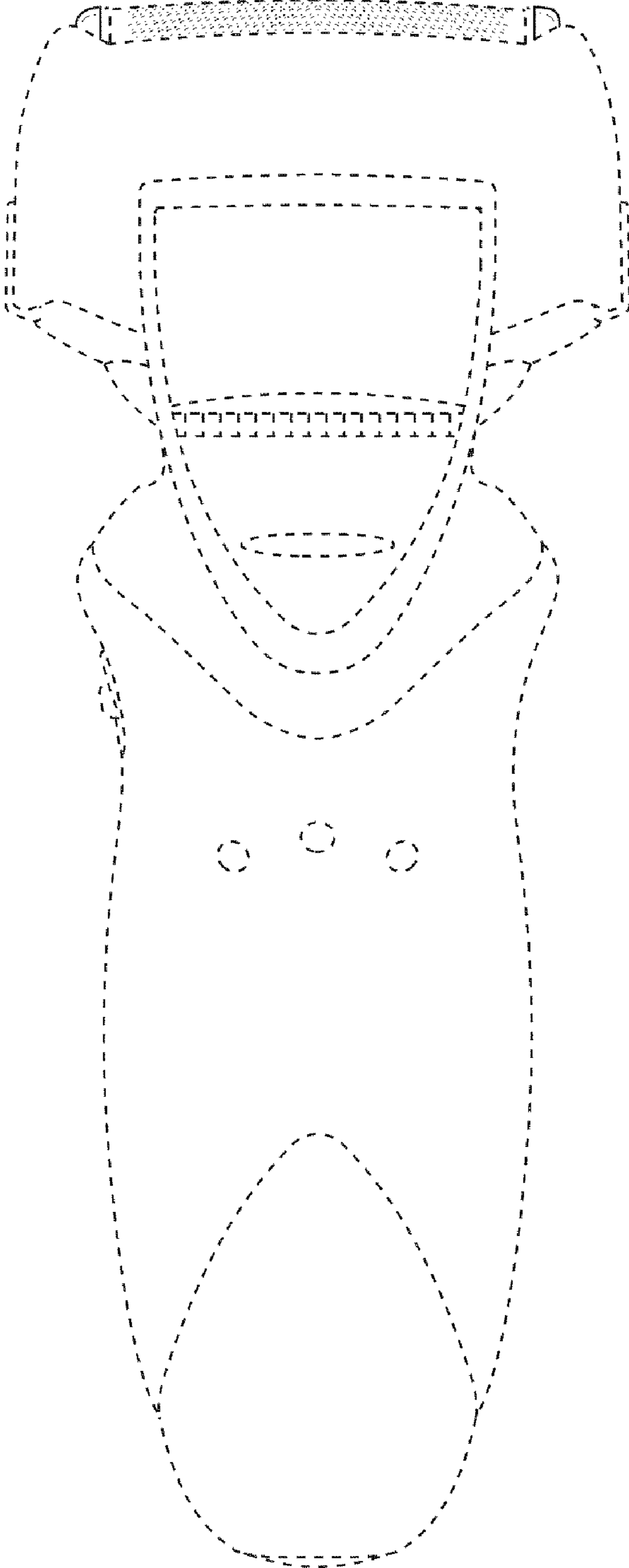

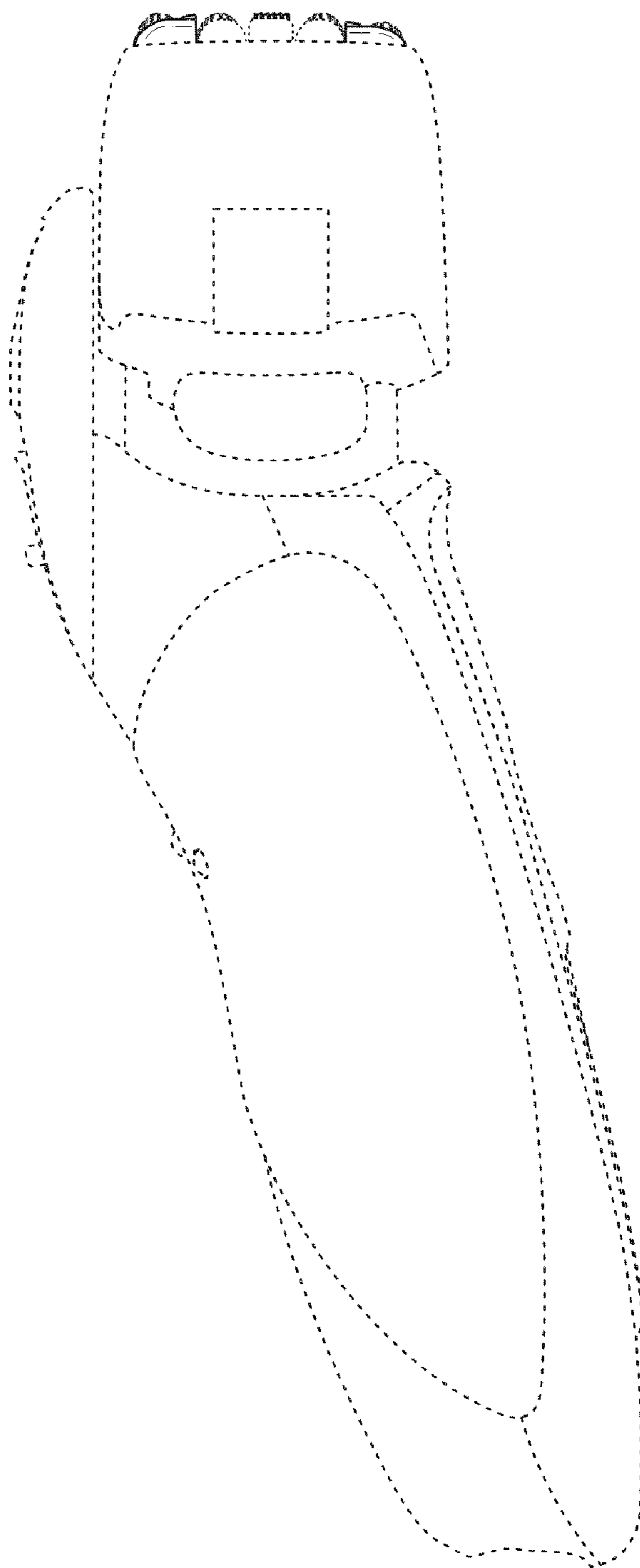
