(57) **CLAIM**

The ornamental design for a vacuum attachment nozzle for removal of concrete residue from anchor holes, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the vacuum attachment nozzle for removal of concrete residue from anchor holes. The opposite side is a mirror image and therefore is not shown. The broken line drawing of a vacuum hose is for illustrative purposes only and forms no part of the claimed design.

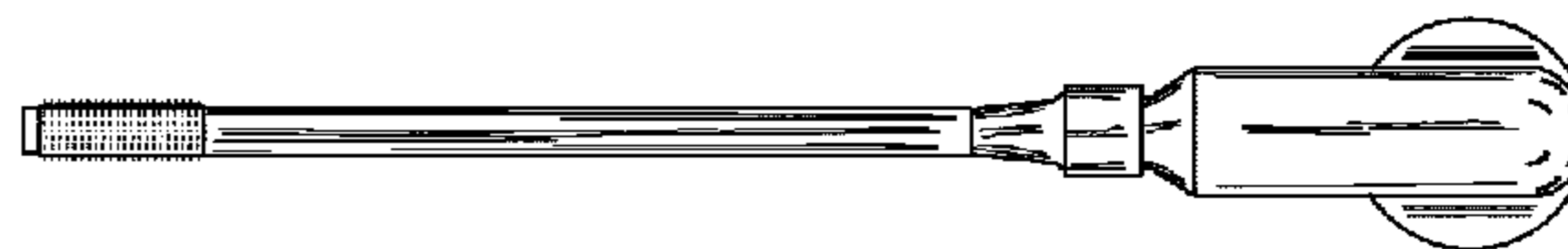
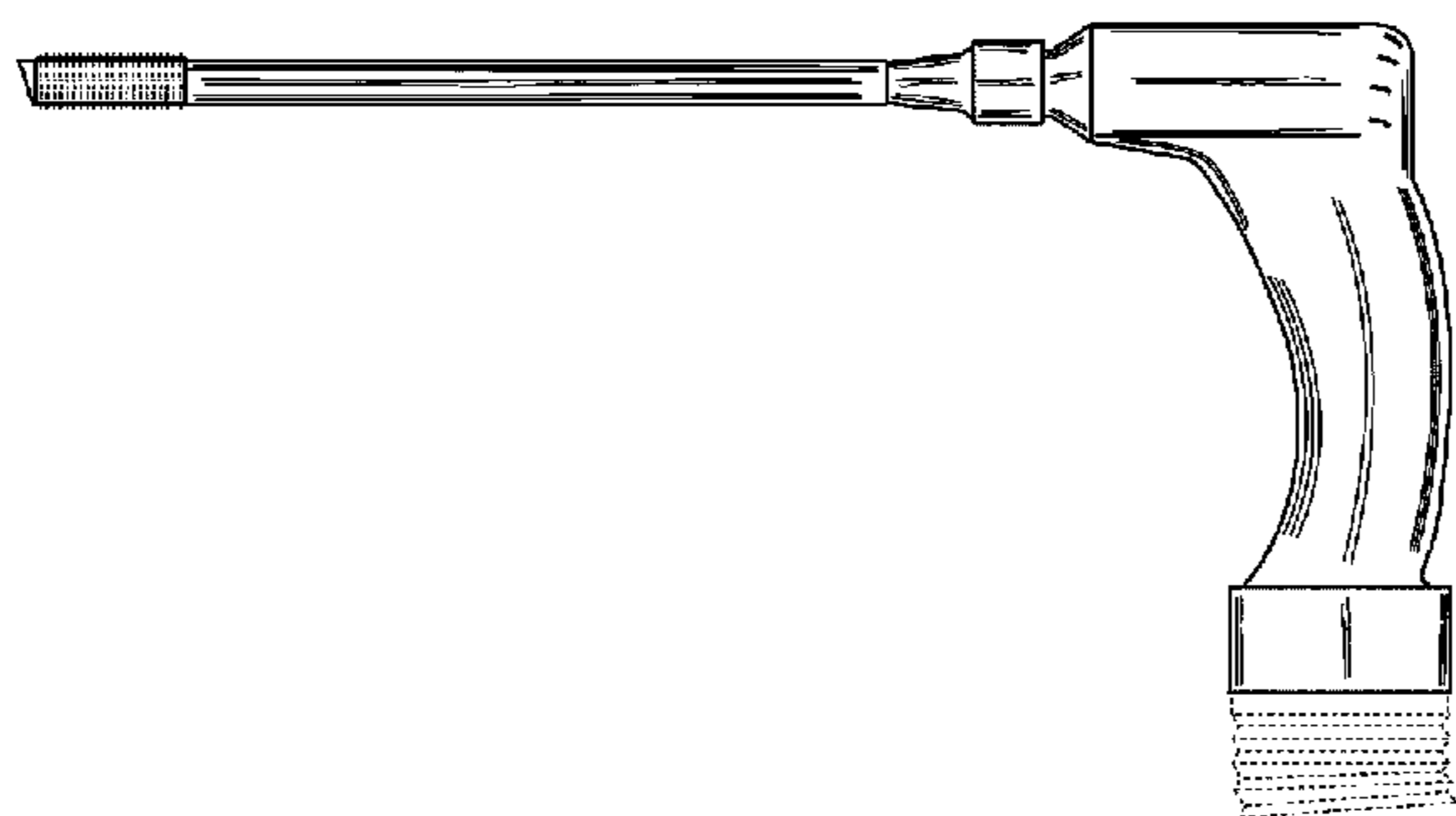
FIG. 2 is a top view thereof.

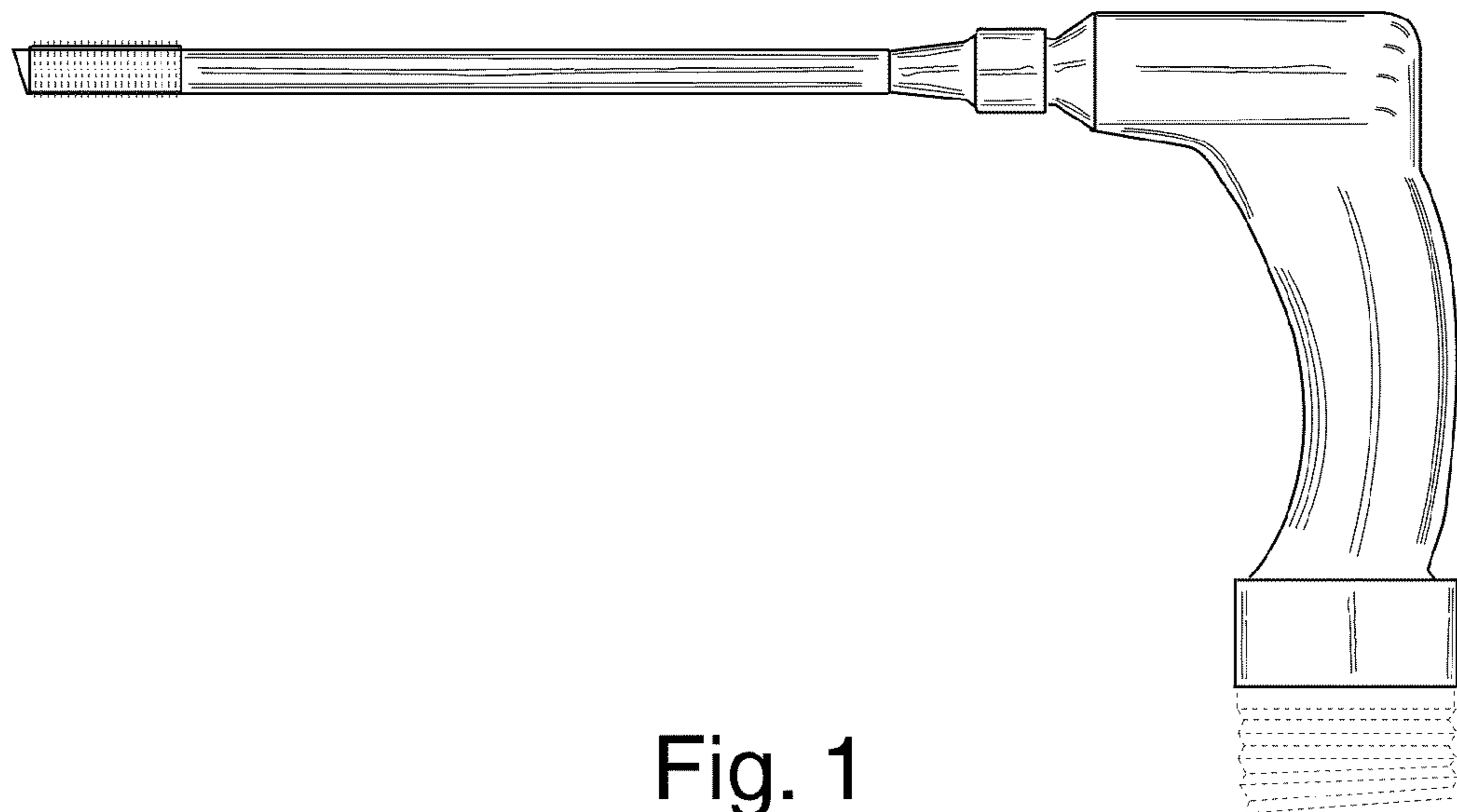

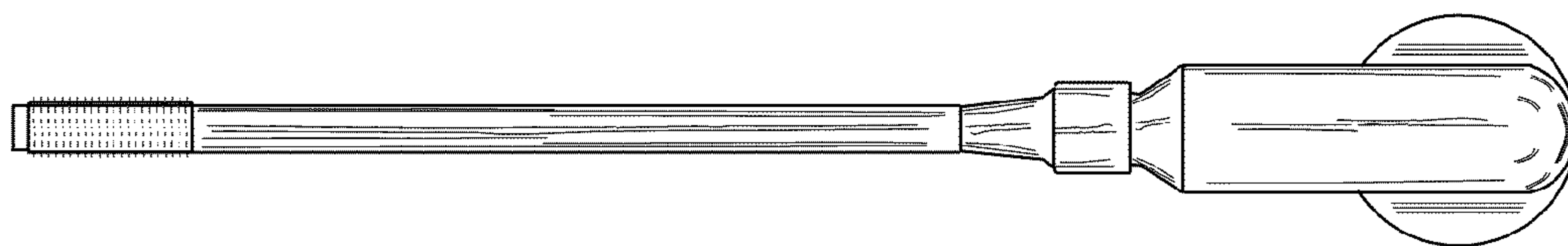

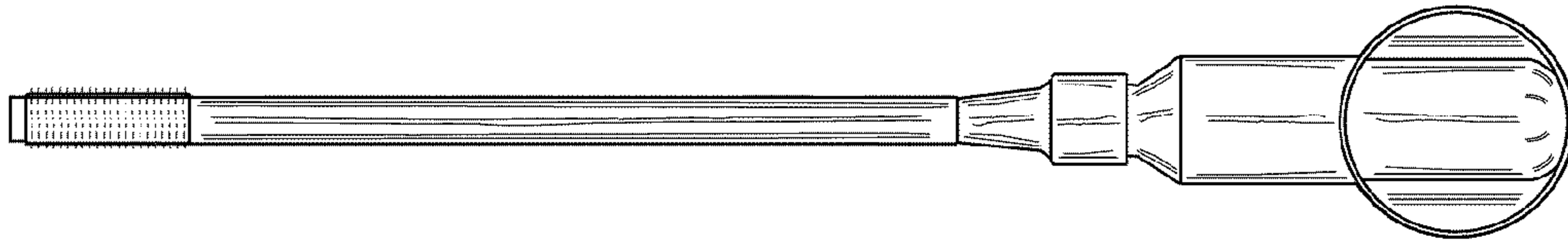

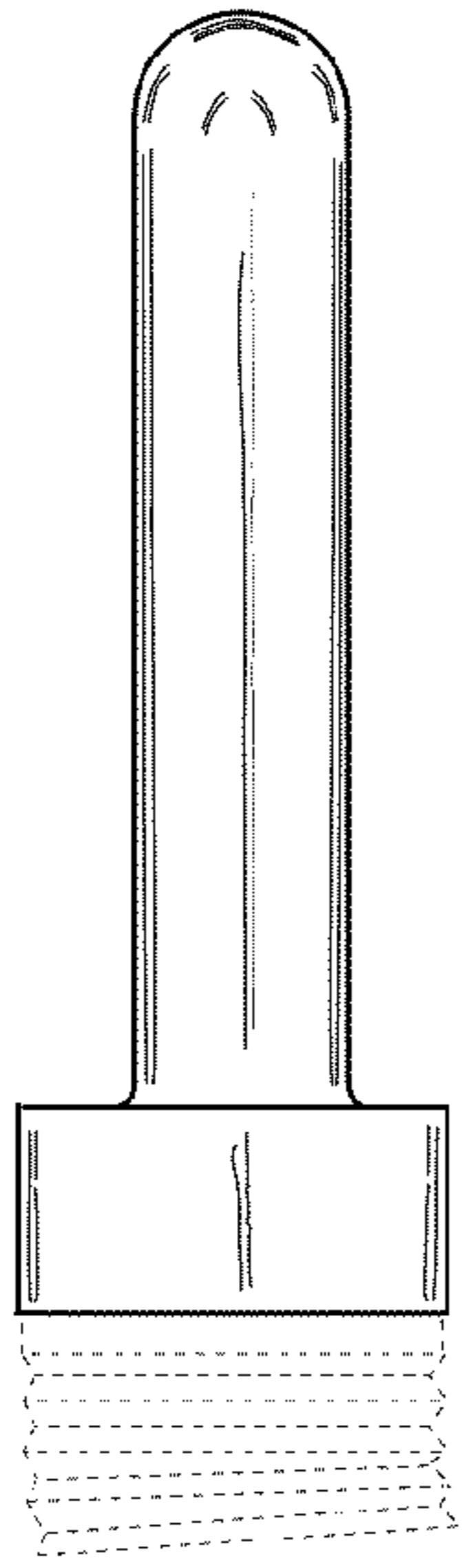

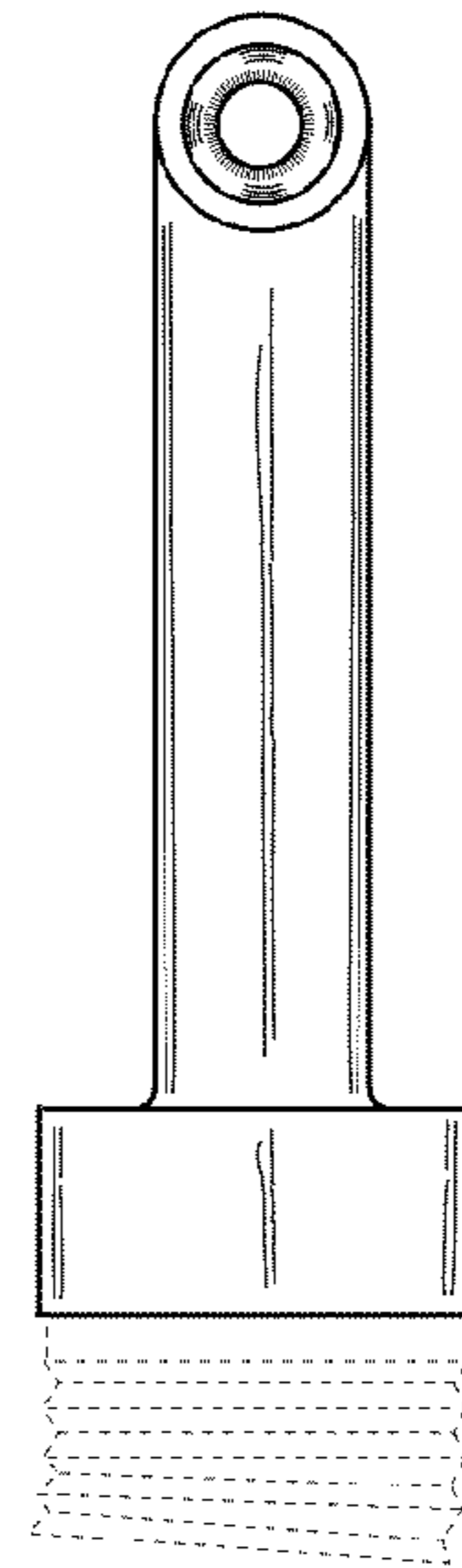
