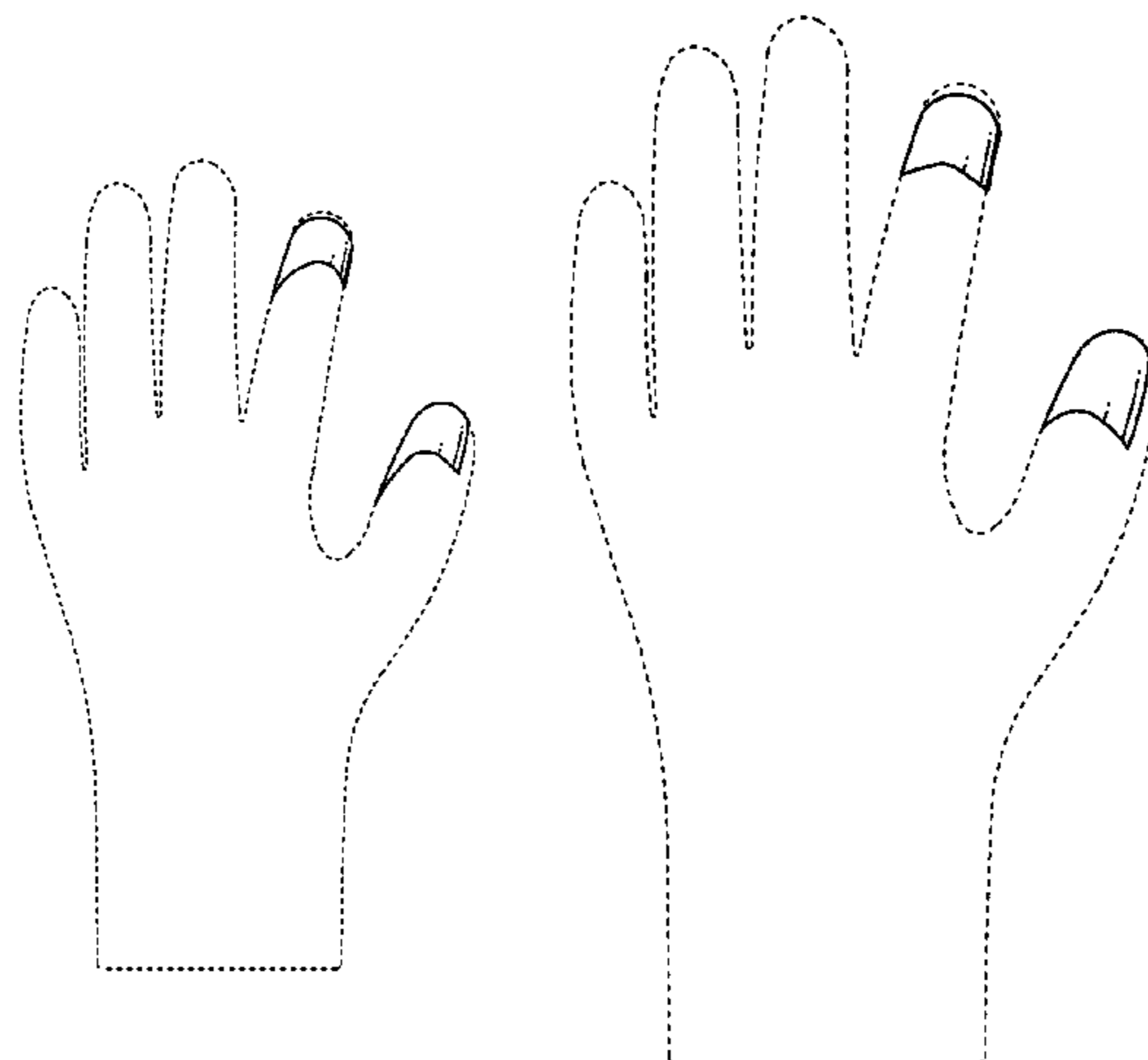
(57) **CLAIM**

The ornamental design for patches for a glove, as shown and described.

**DESCRIPTION**

FIGS. 1-7 are for a first embodiment, in which:  
FIG. 1 is a perspective palmar view of patches for a glove, showing my design;  
FIG. 2 is a palm-side elevation view thereof;  
FIG. 3 is a lateral side elevation view thereof;  
FIG. 4 is a medial side elevation view thereof;  
FIG. 5 is dorsal view thereof;  
FIG. 6 is a top plan view thereof; and  
FIG. 7 is a bottom plan view thereof.  
FIGS. 8-14 are for a second embodiment, in which:  
FIG. 8 is a perspective palmar view of patches for a glove, showing my design;  
FIG. 9 is a palm-side elevation view thereof;  
FIG. 10 is a lateral side elevation view thereof;  
FIG. 11 is a medial side elevation view thereof;  
FIG. 12 is dorsal view thereof;  
FIG. 13 is a top plan view thereof; and,  
FIG. 14 is a bottom plan view thereof.  
The glove shown in broken lines illustrates the article to which the claimed design is applied. The broken-line subject matter forms no part of the claimed design.  
The device is a glove having patches at finger tips.

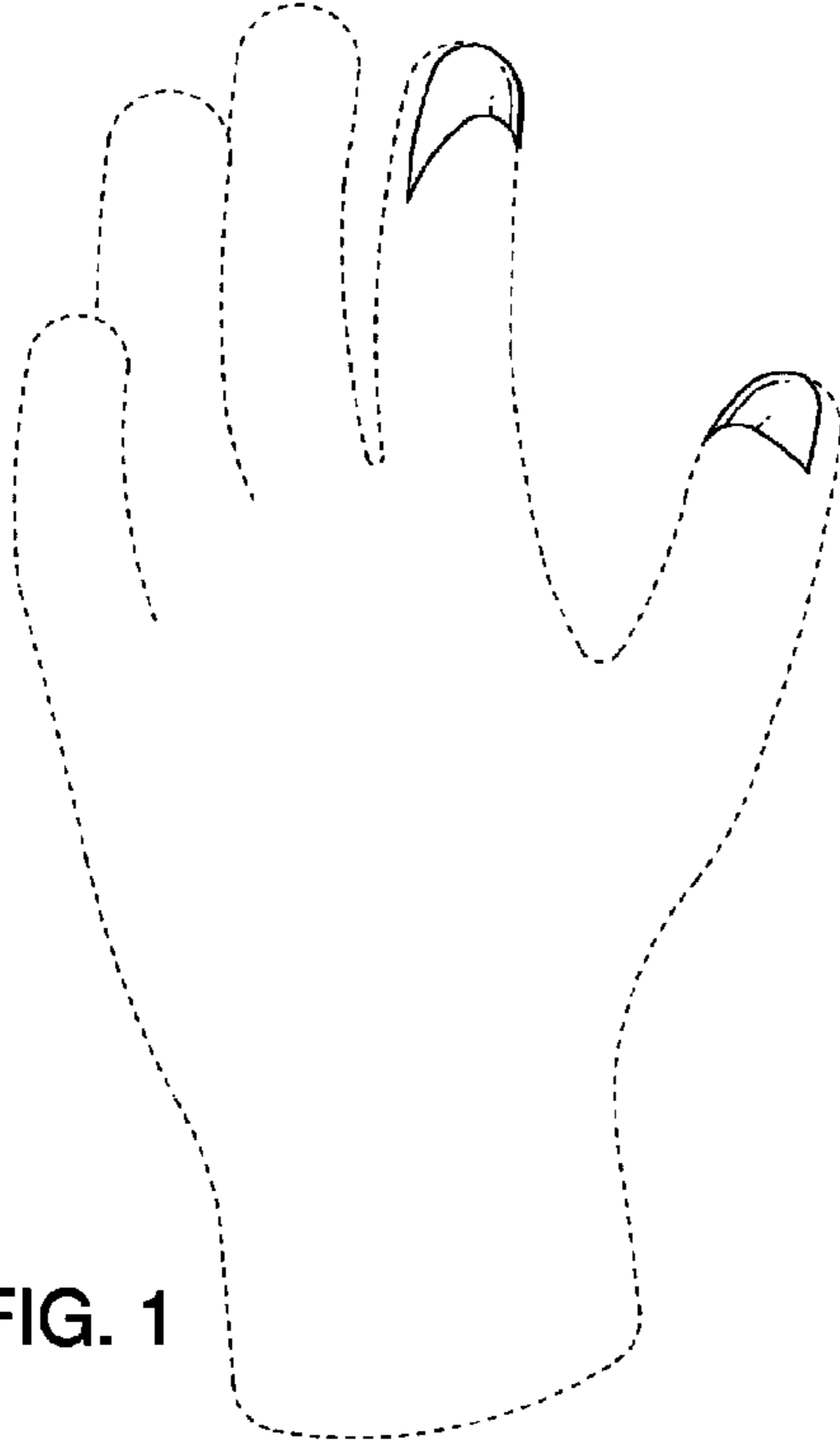

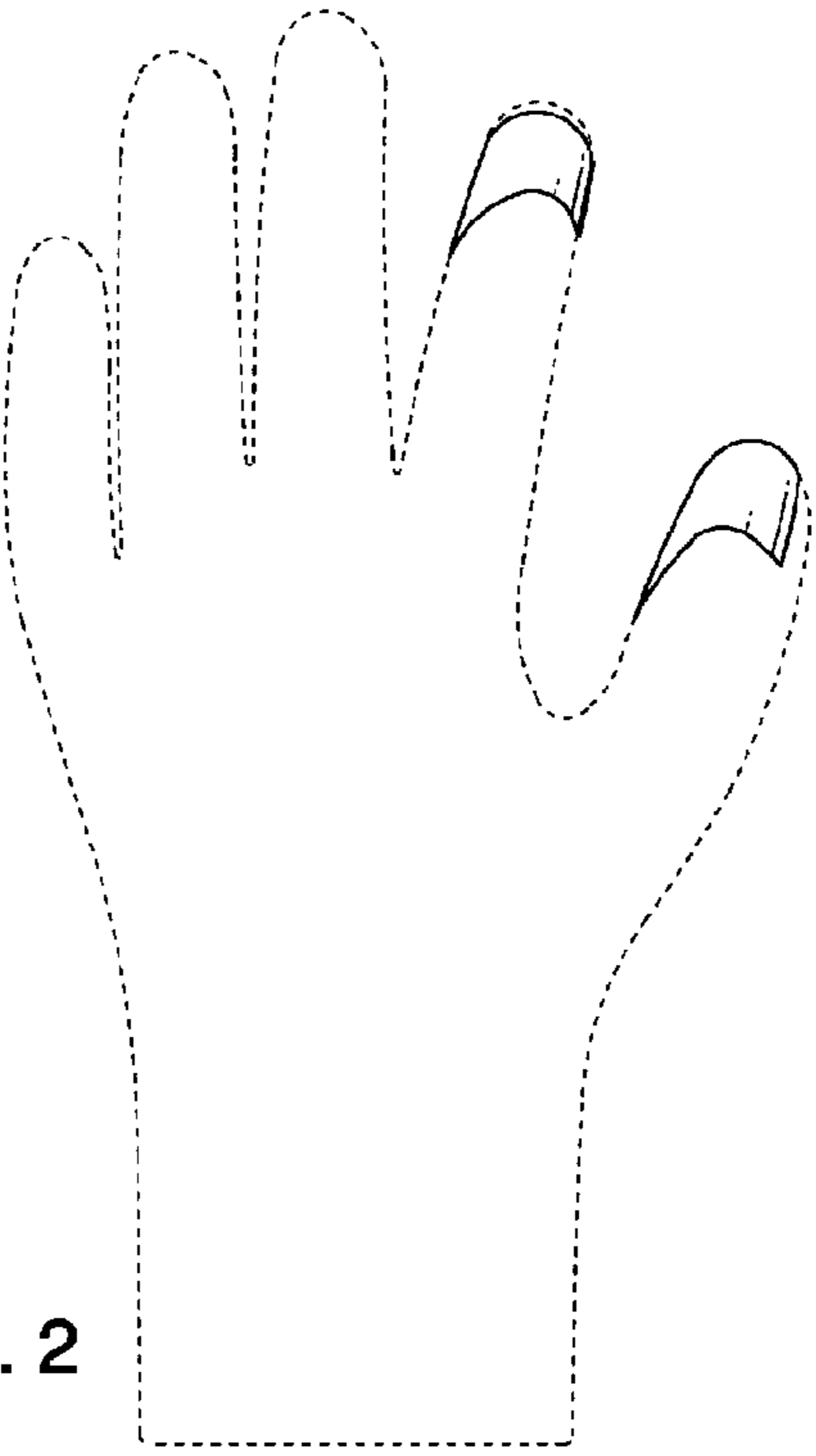

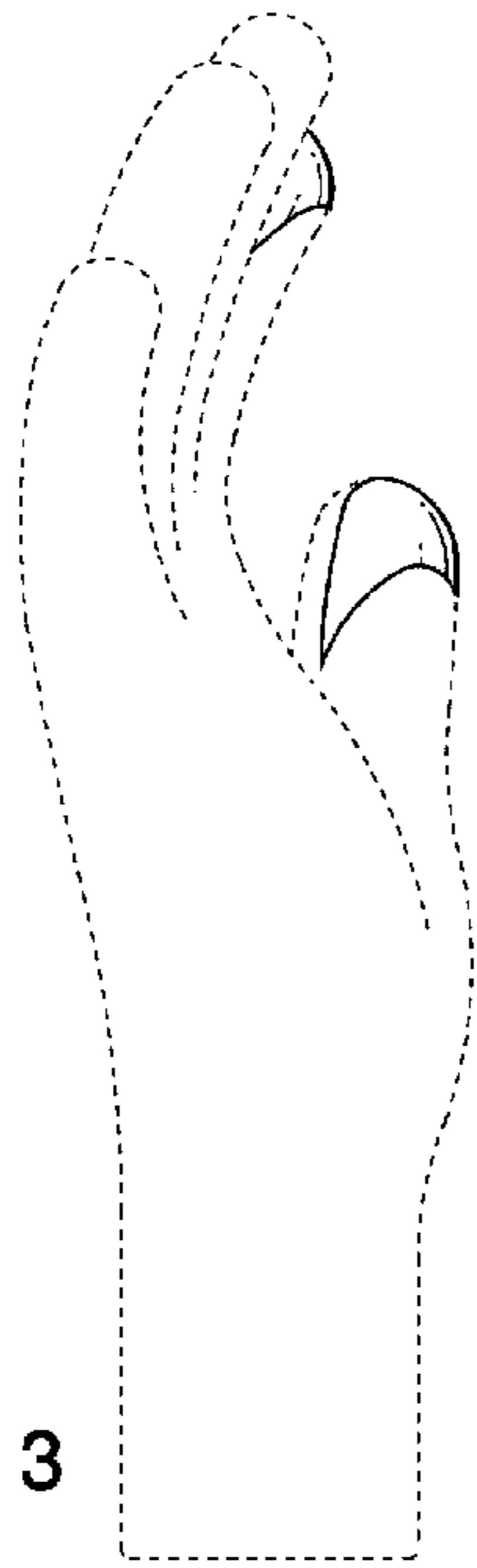

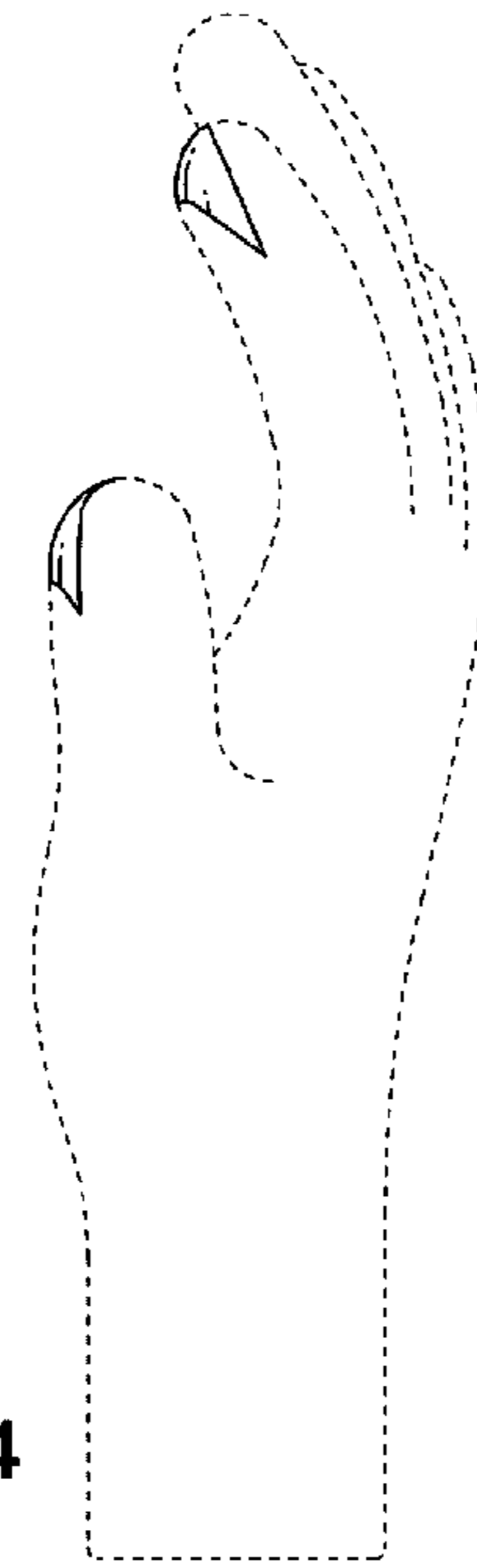

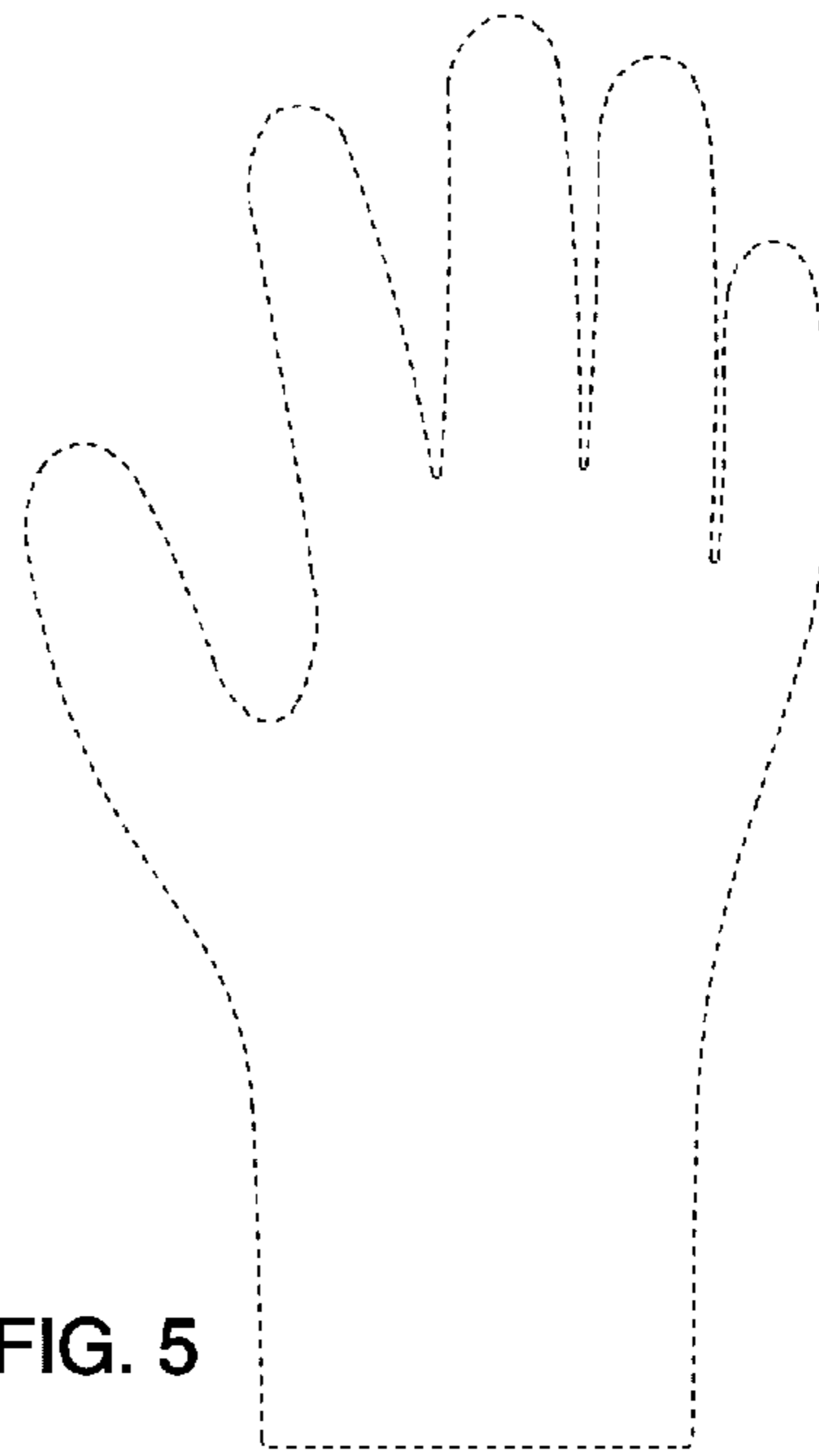
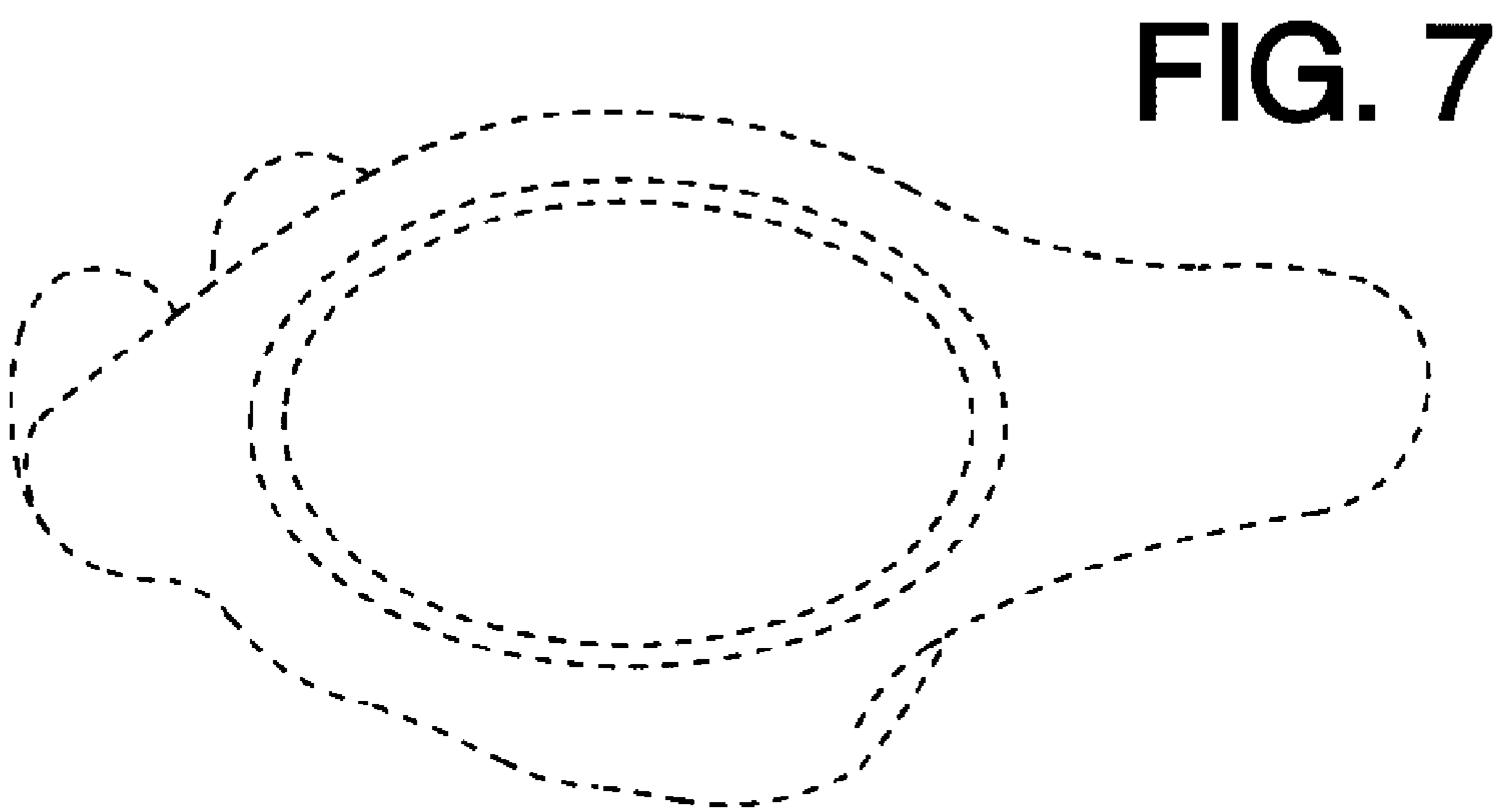
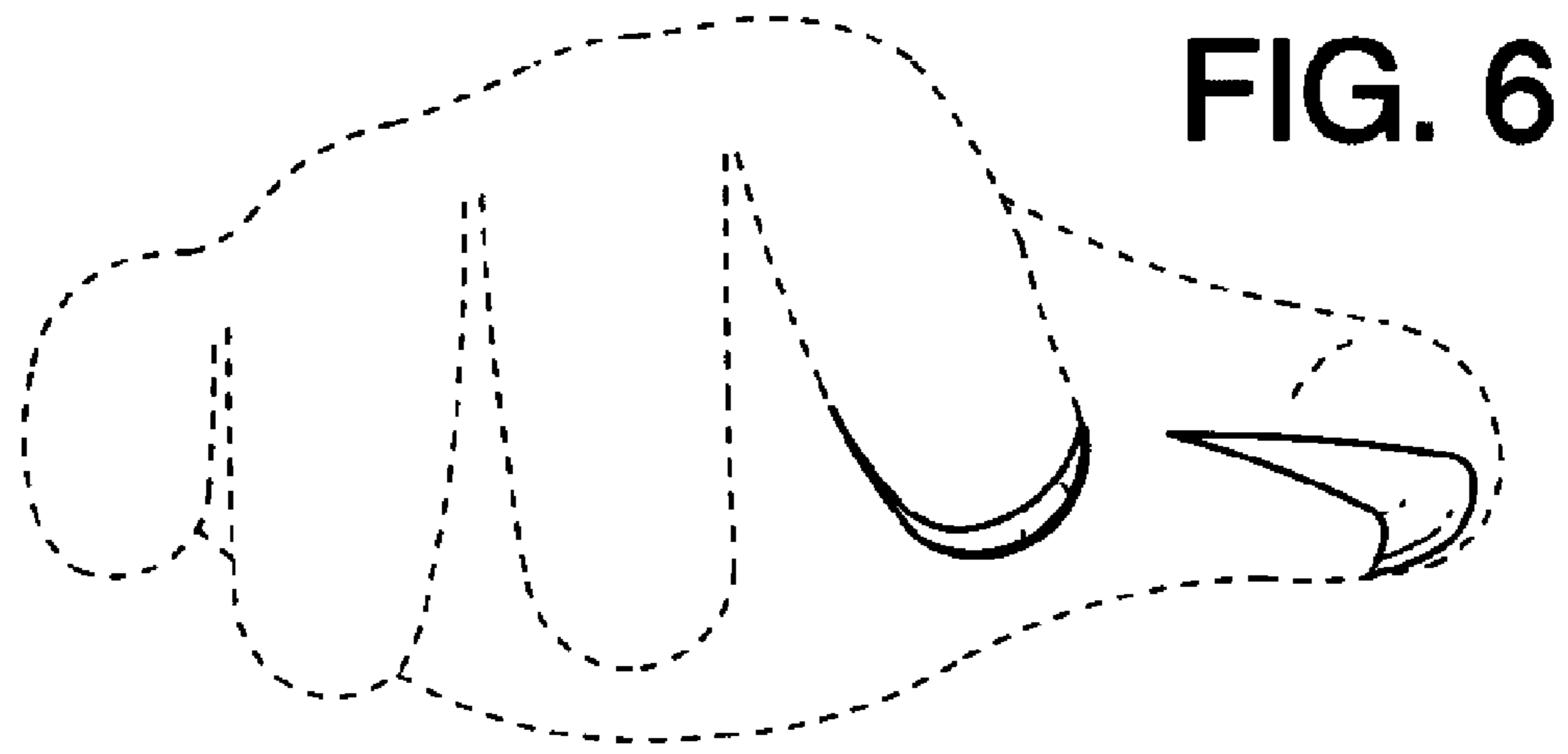

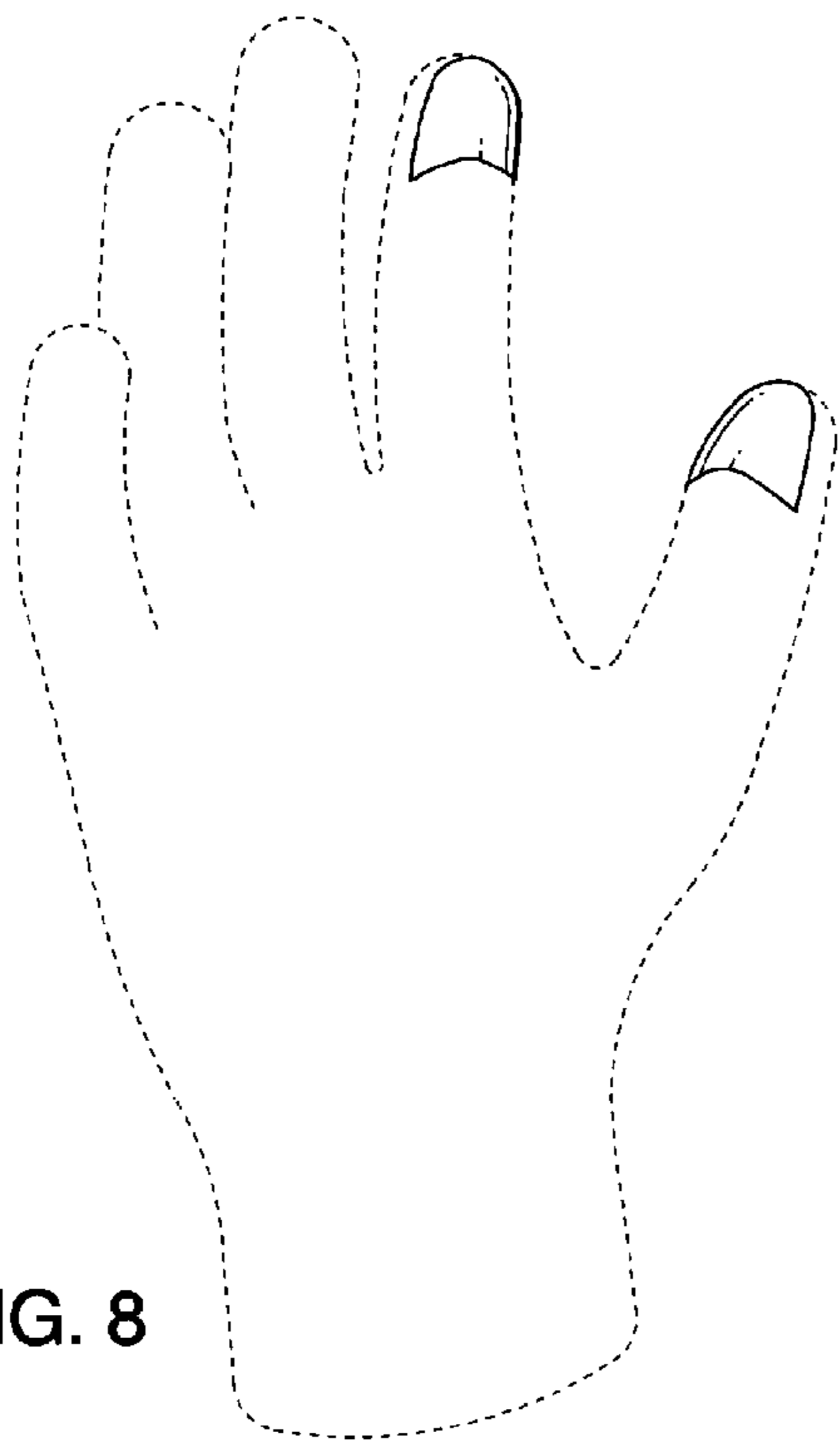

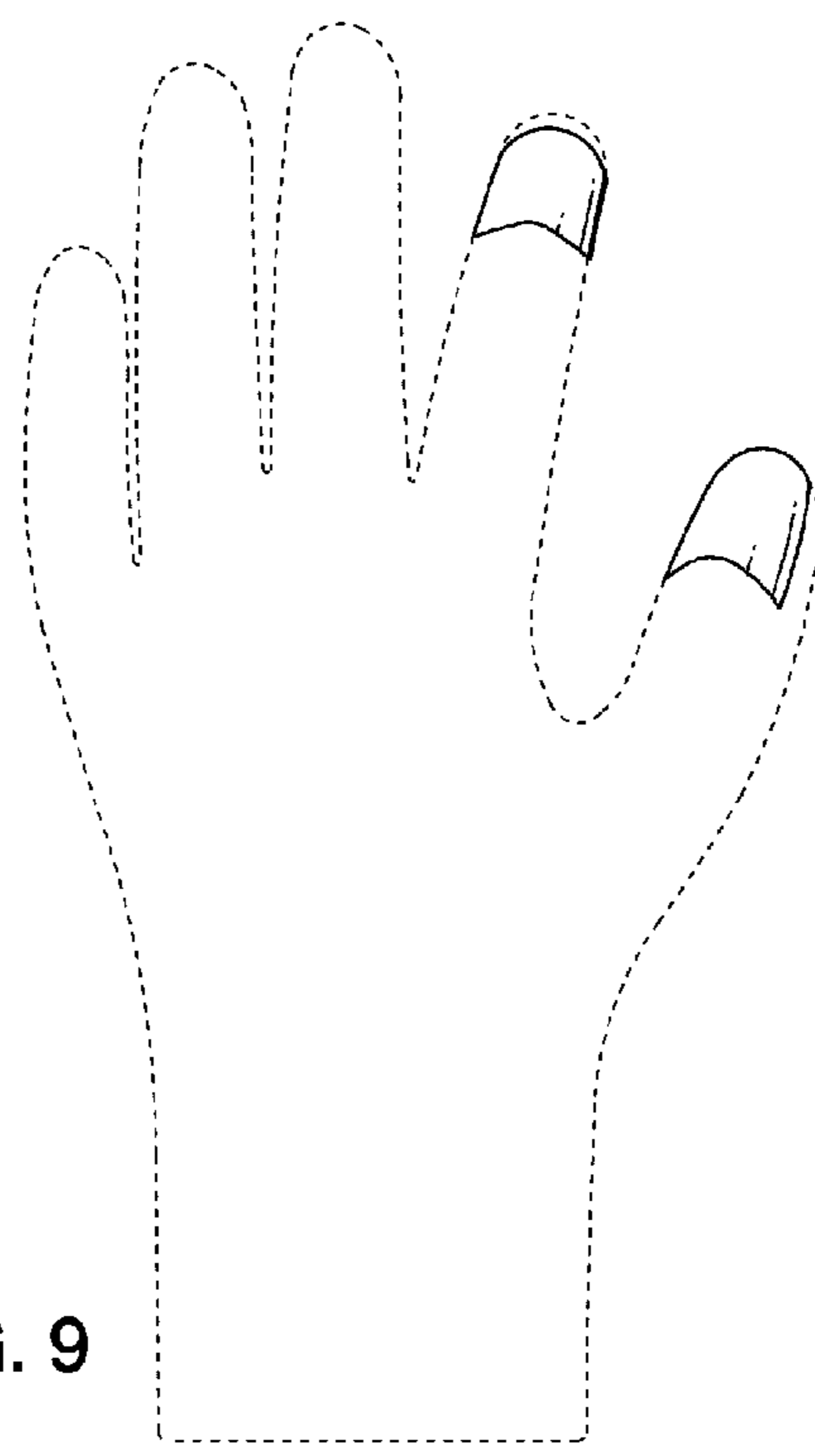

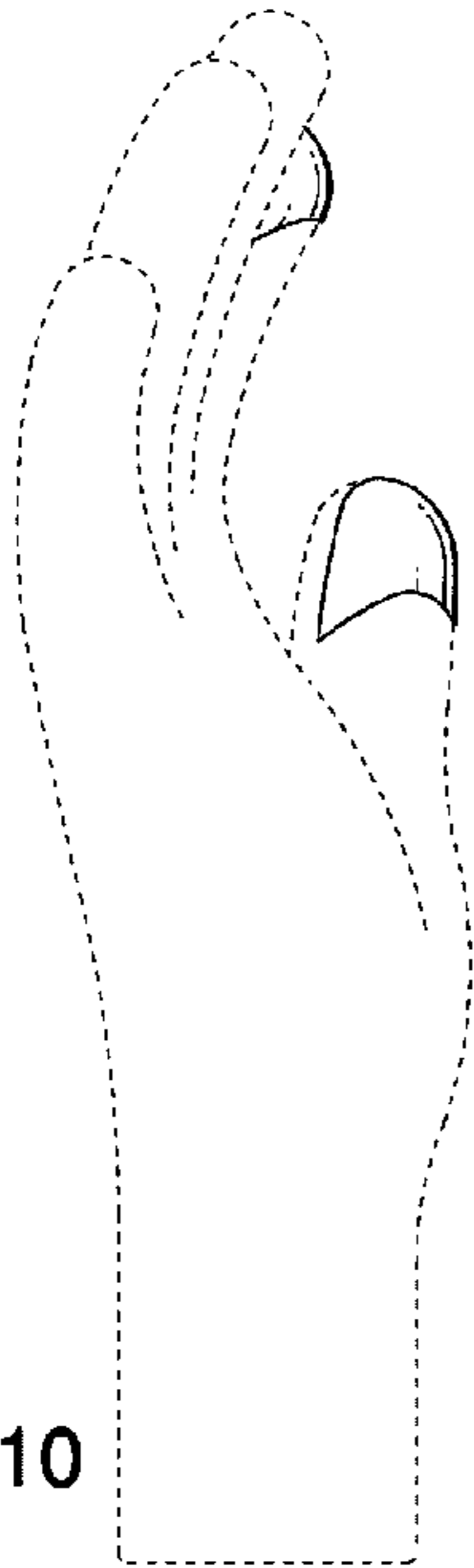

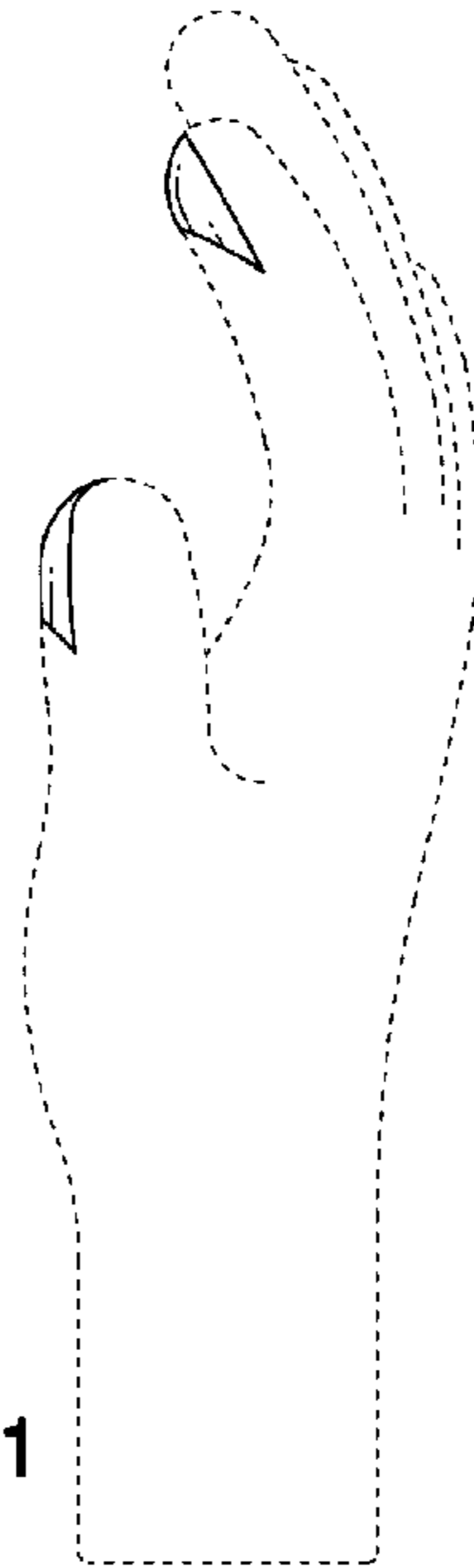

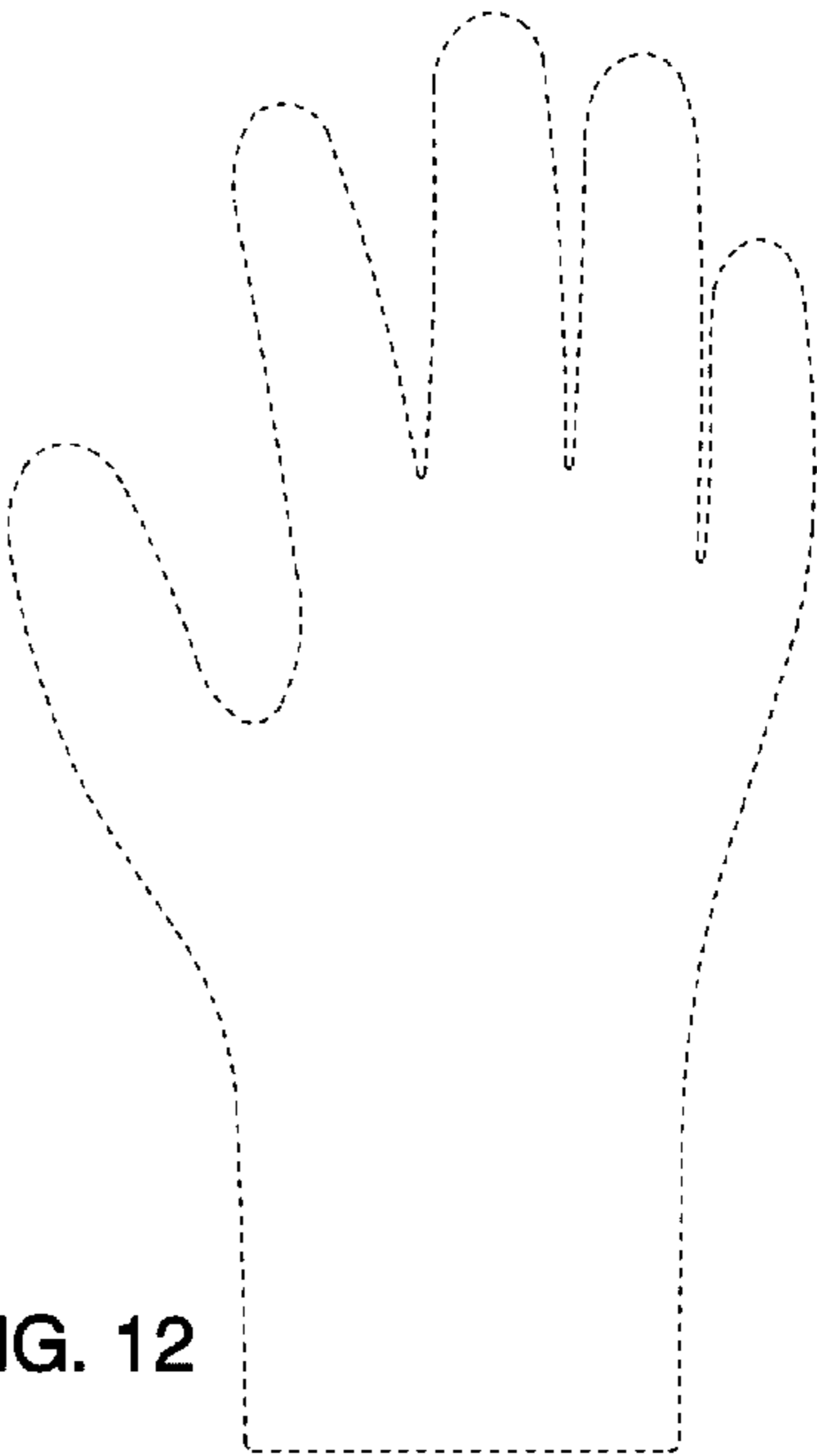
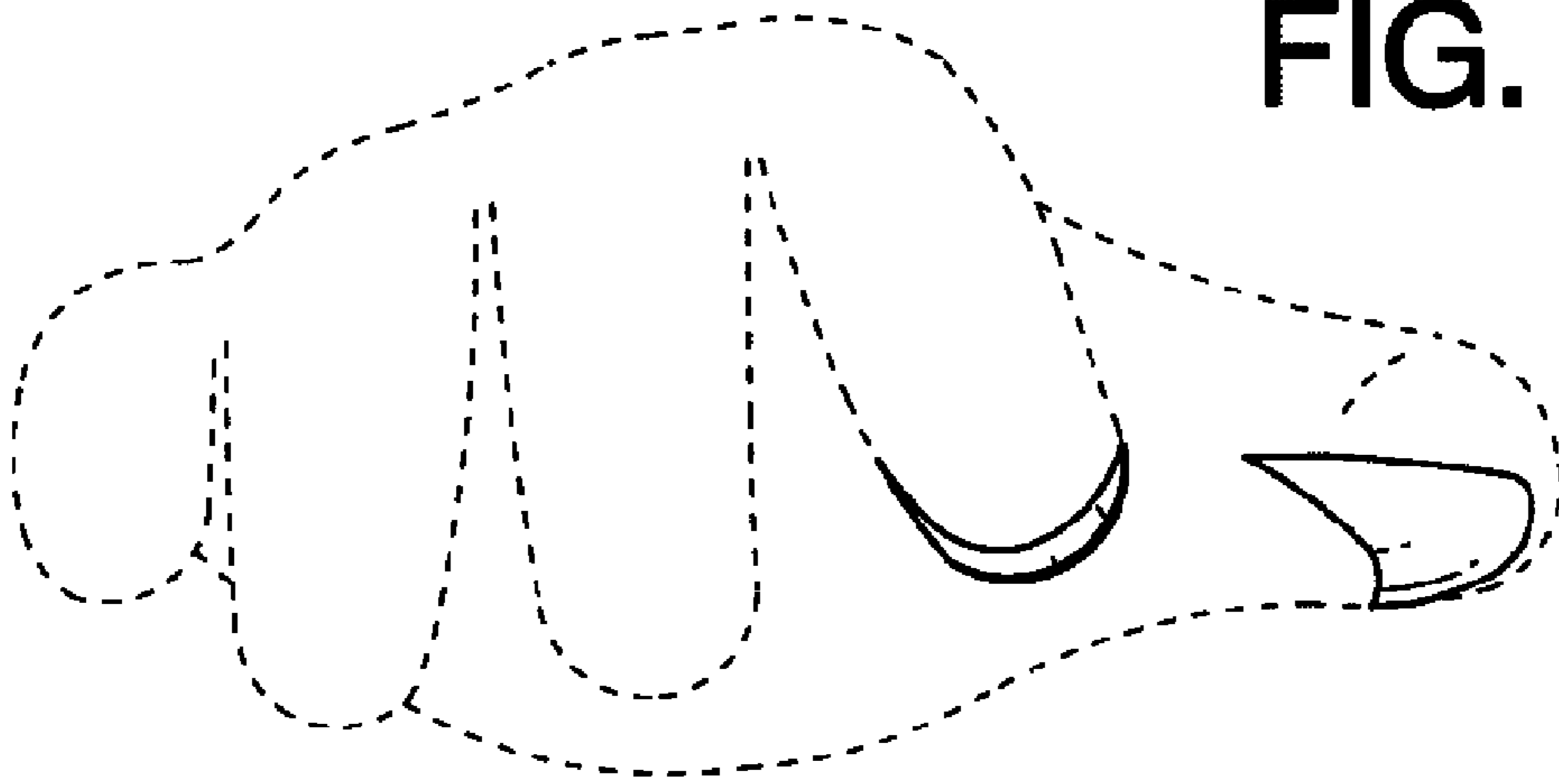
