(57) **CLAIM**

The ornamental design for super absorbent panties, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front of our new design for super absorbent panties.

FIG. 2 is a plan view from the top of the panties shown in FIG. 1.

FIG. 3 is a front elevational view of the panties shown in FIG. 1.

FIG. 4 is a rear elevational view of the panties shown in FIG. 1.

FIG. 5 is a bottom plan view of the panties shown in FIG. 1.

FIG. 6 is a side elevational view of the panties shown in FIG. 1. A view from the opposite side would be a mirror image thereof.

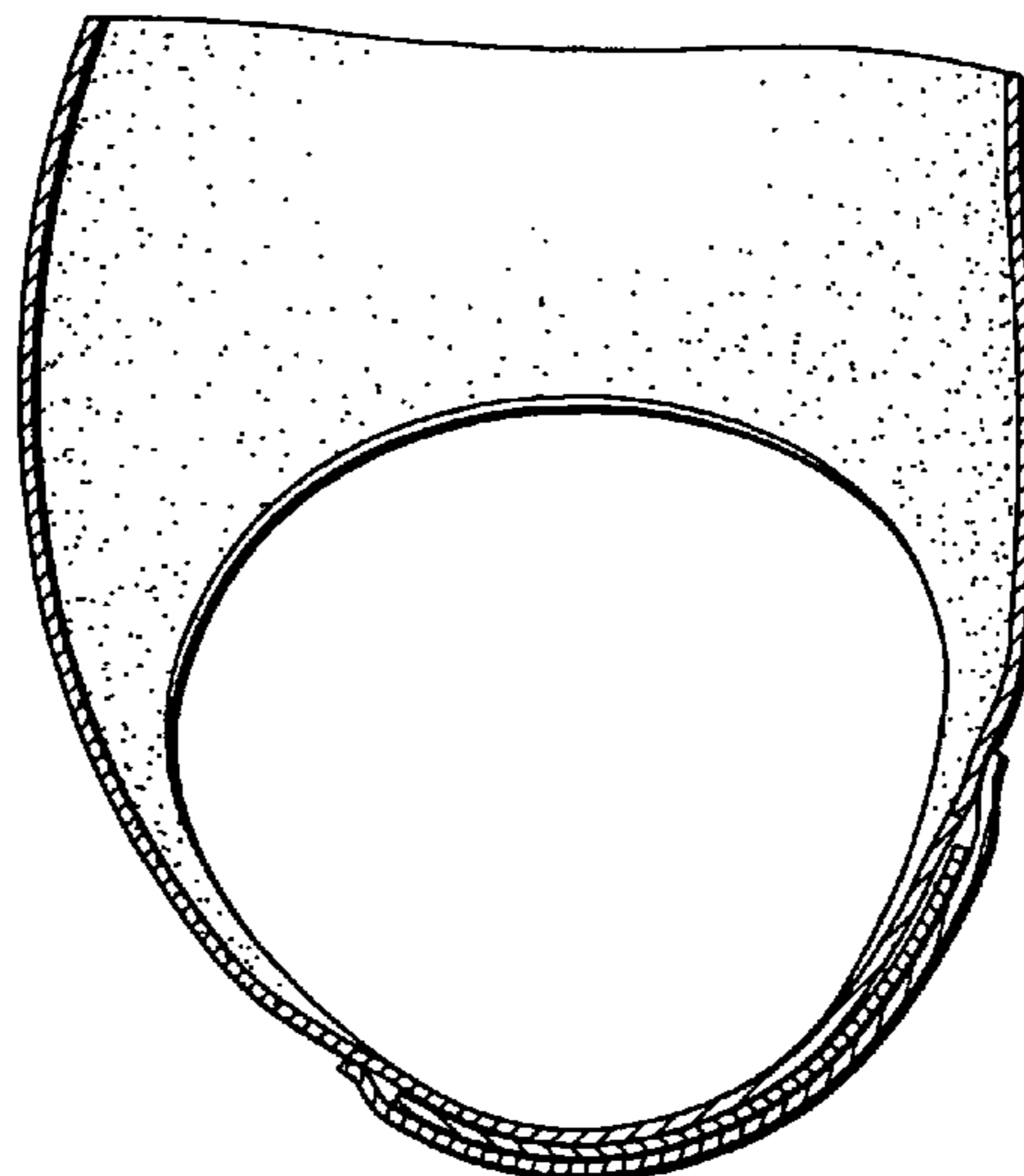
FIG. 7 is a perspective view of the superabsorbent panties of our new design showing the superabsorbent pad insert in specific detail; and,

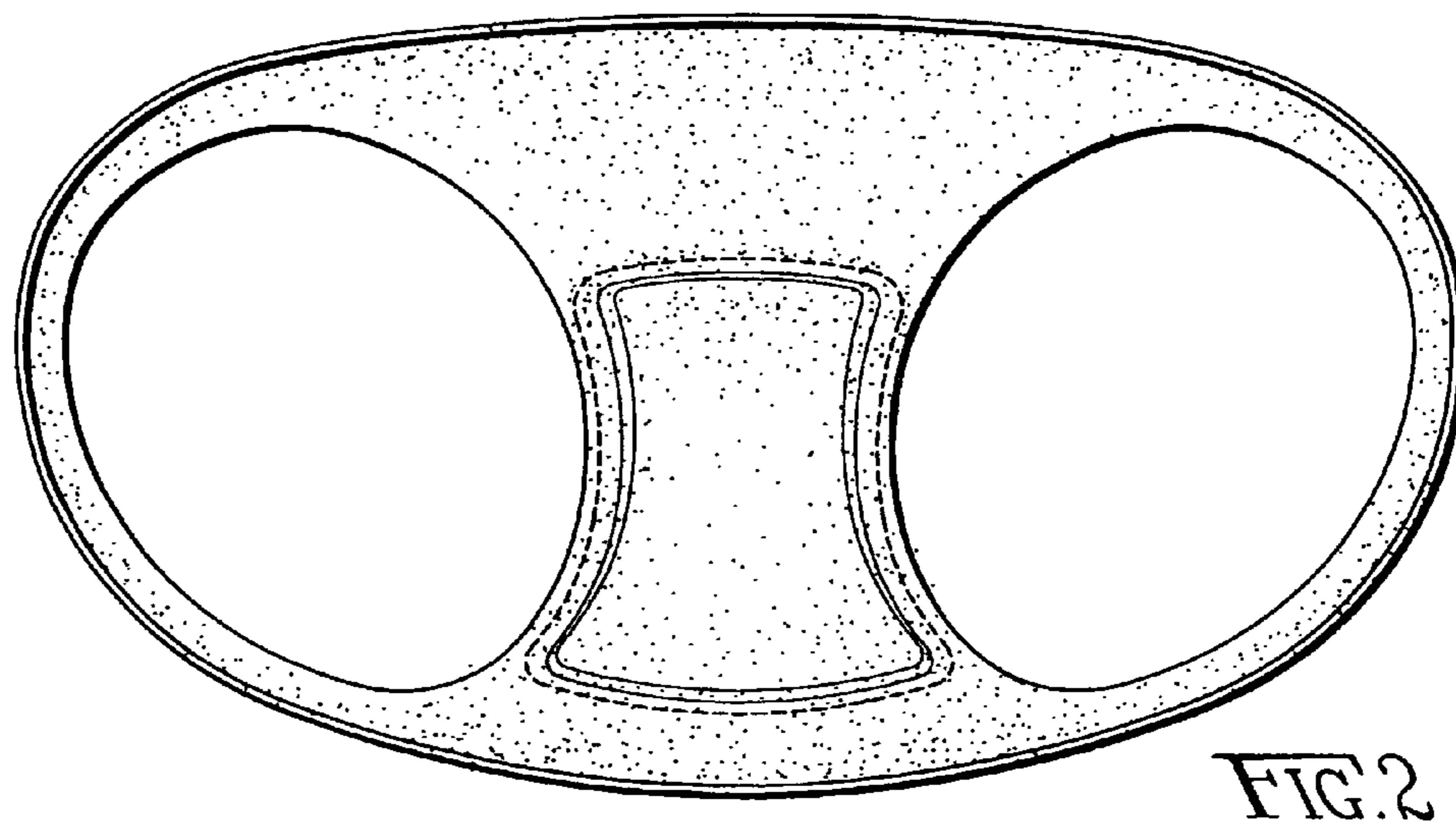
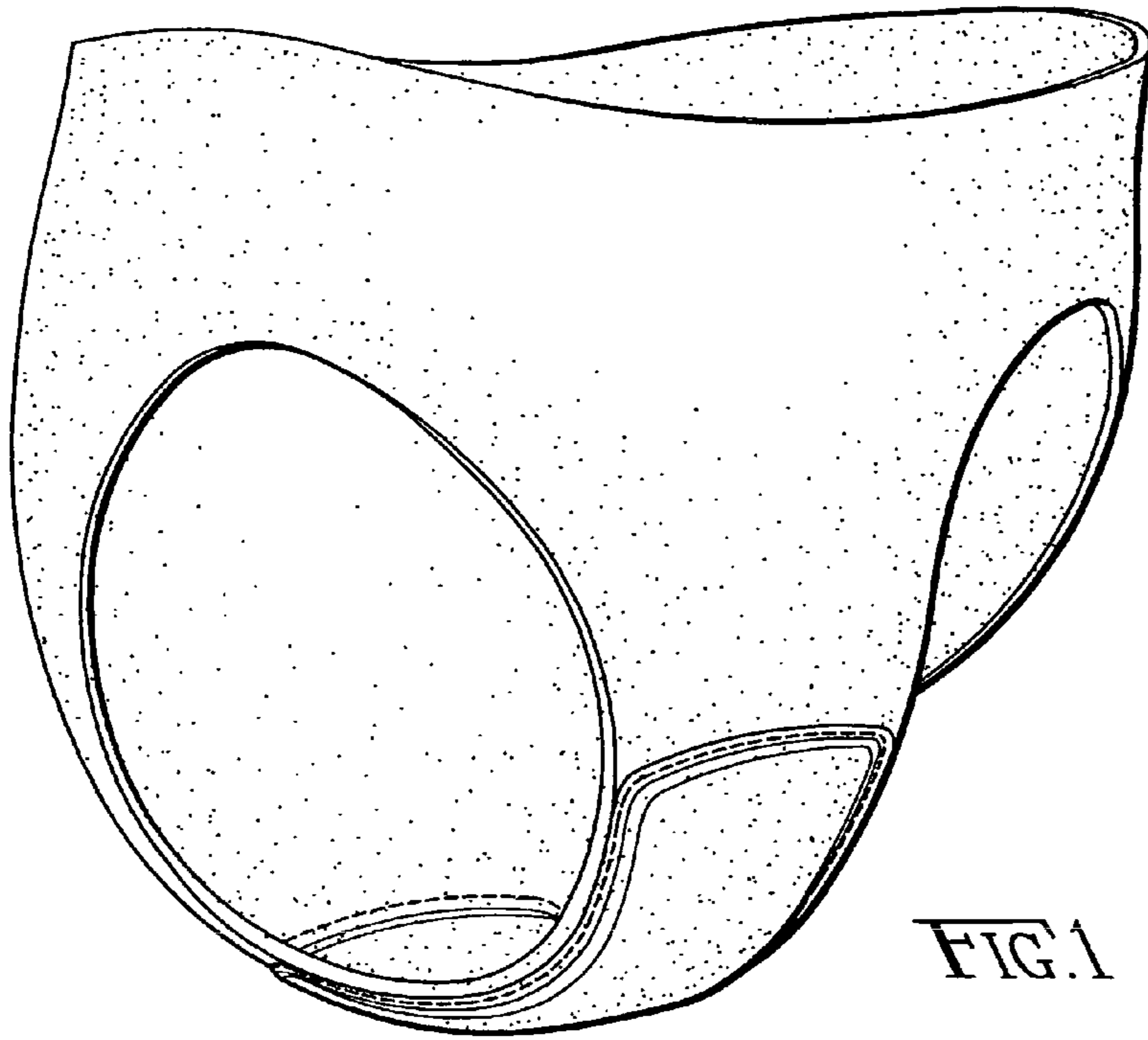
FIG. 8 is a cross sectional elevational view through the line 8-8 of FIG. 7.

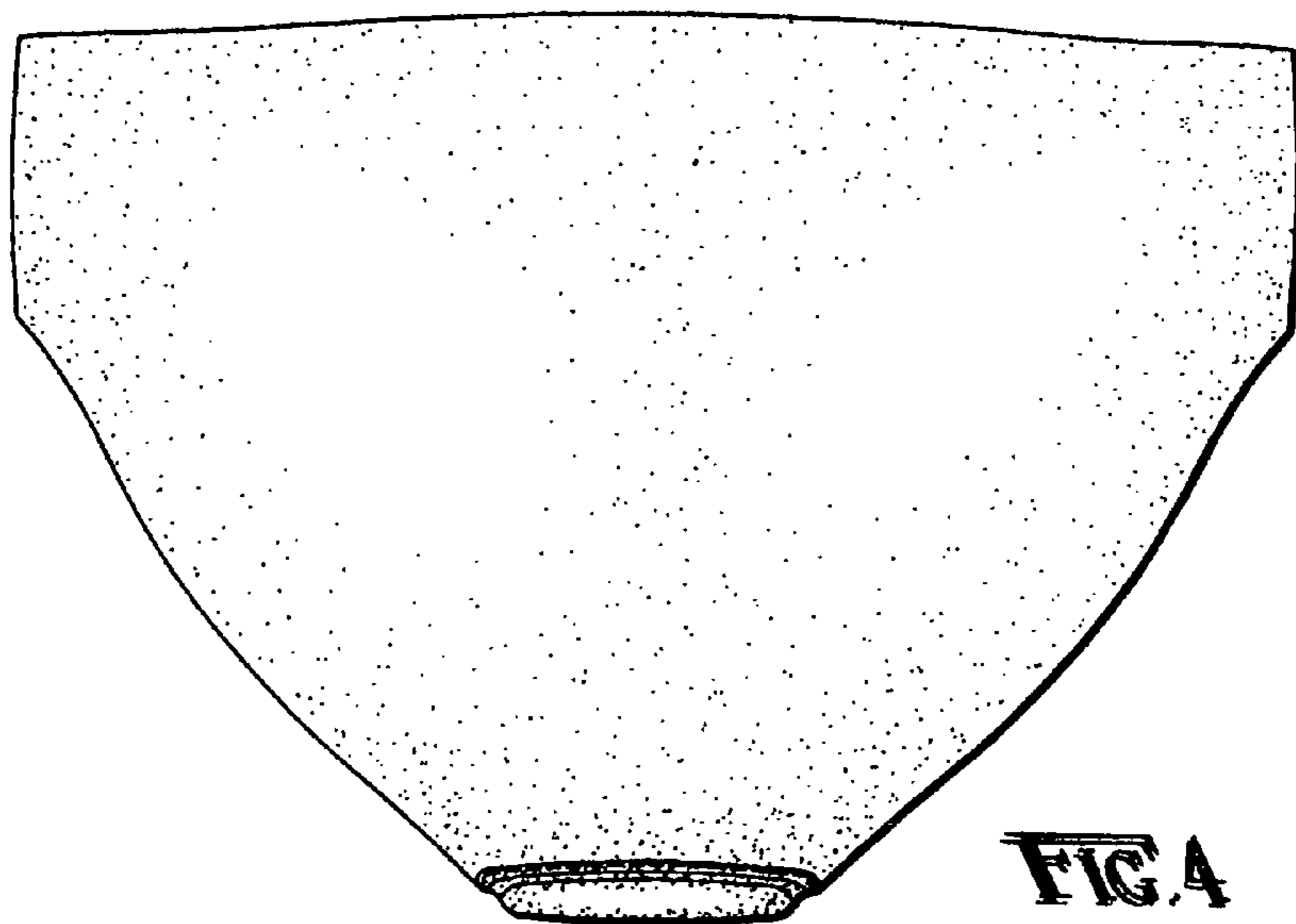
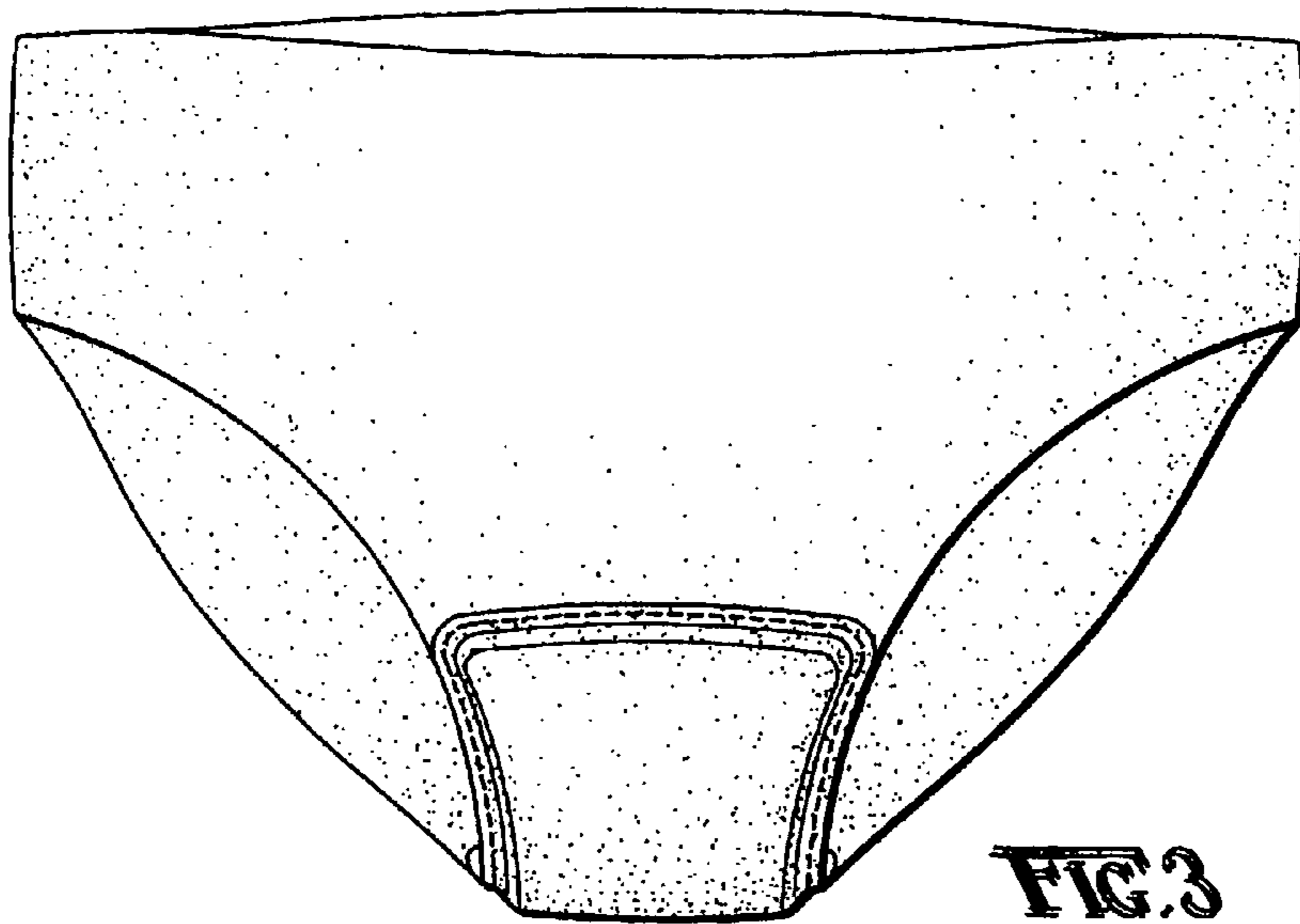
The stippling in the drawings represent texture.

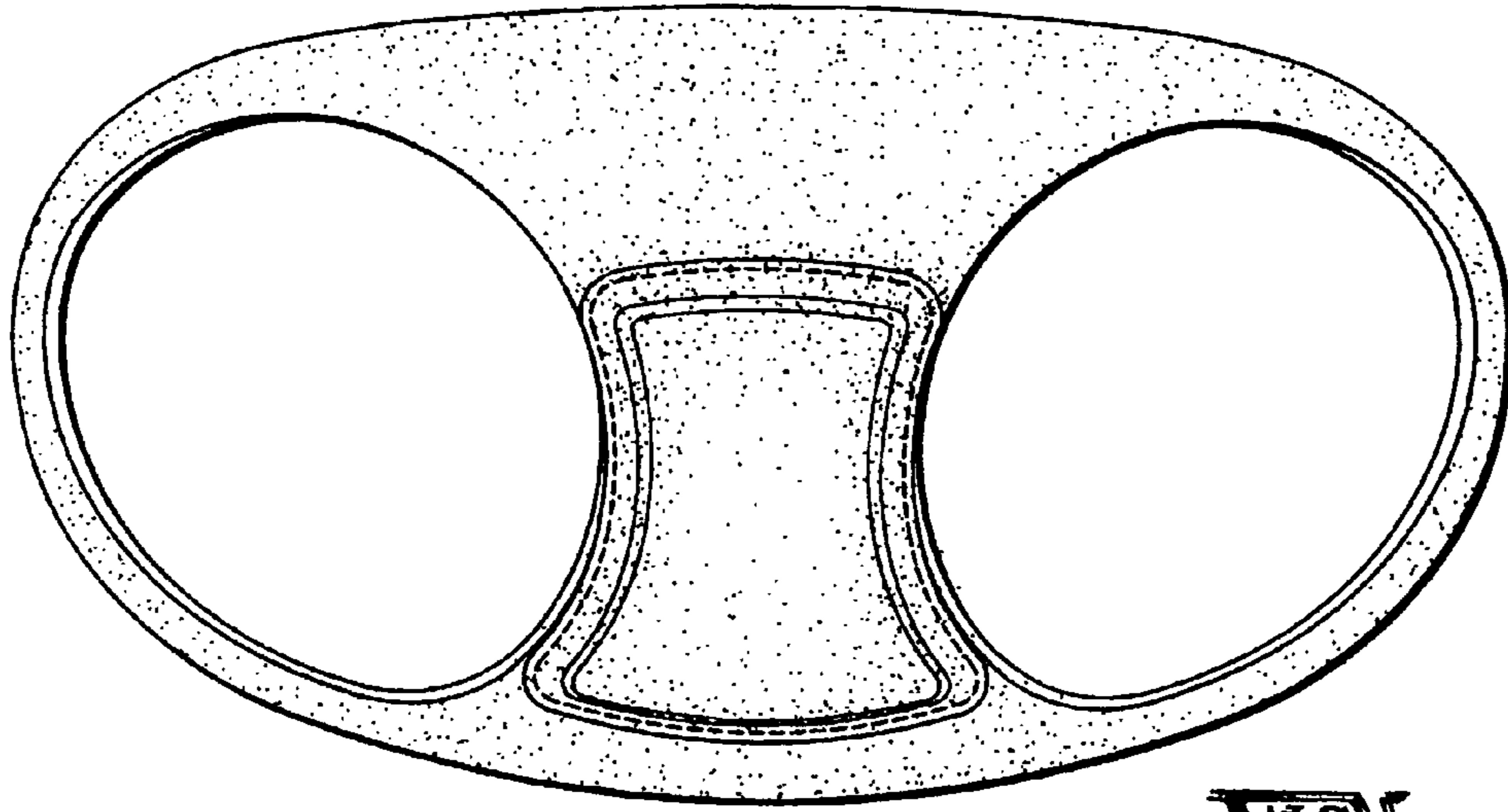
The broken lines in the drawings represent stitching, and are part of the claimed design.

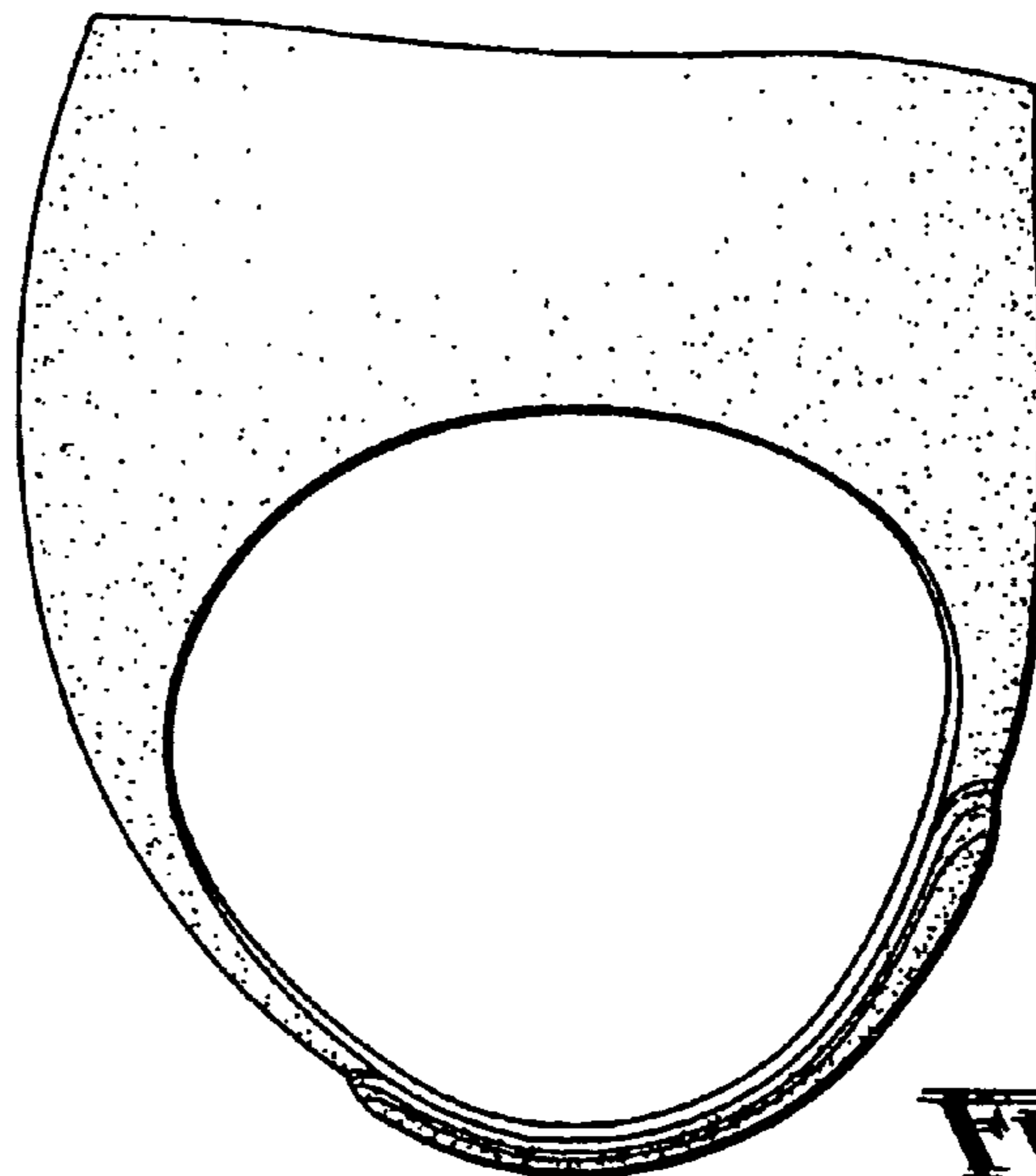
