**DESCRIPTION**

FIG. 4 is a front closeup view of an intermediate portion thereof;

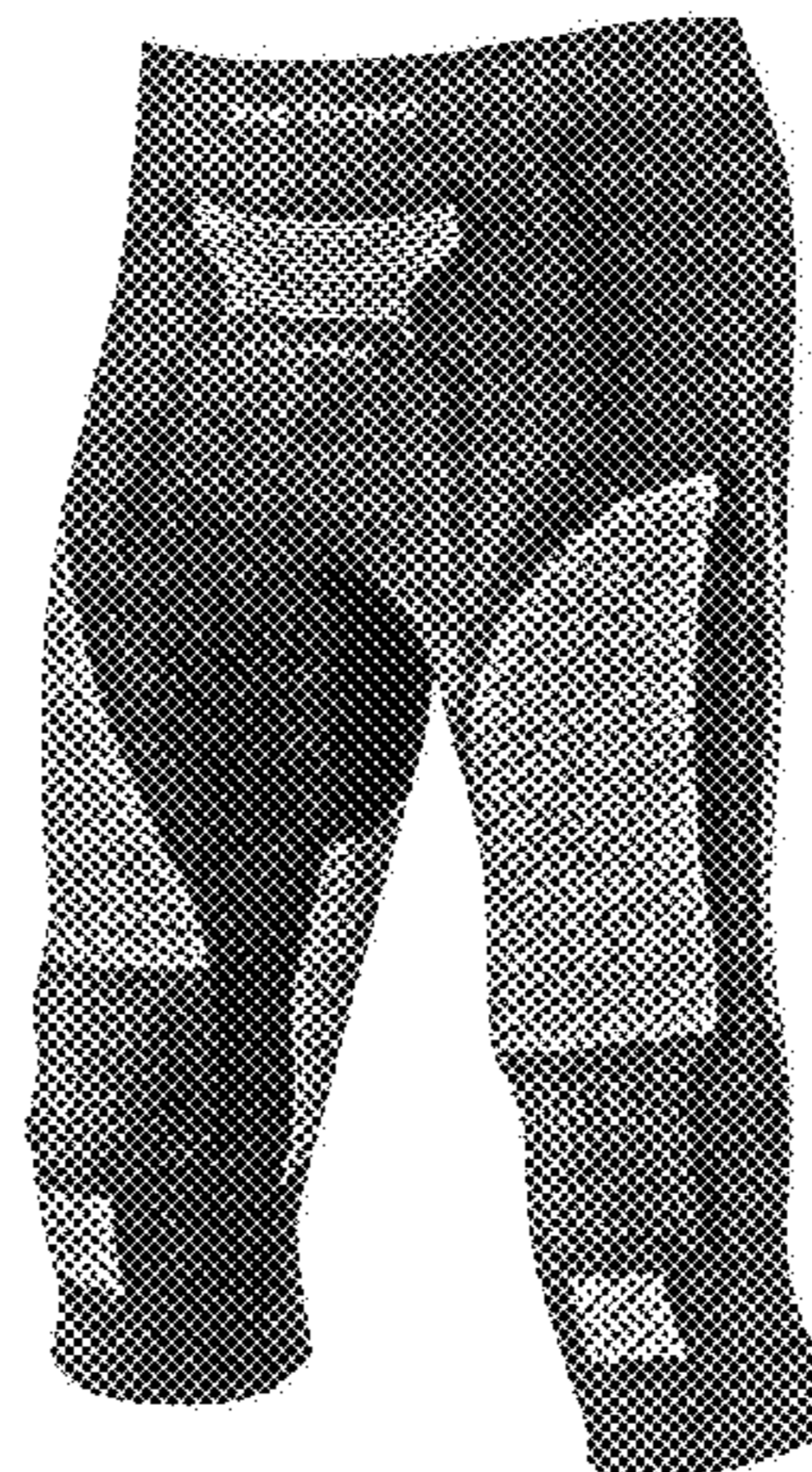
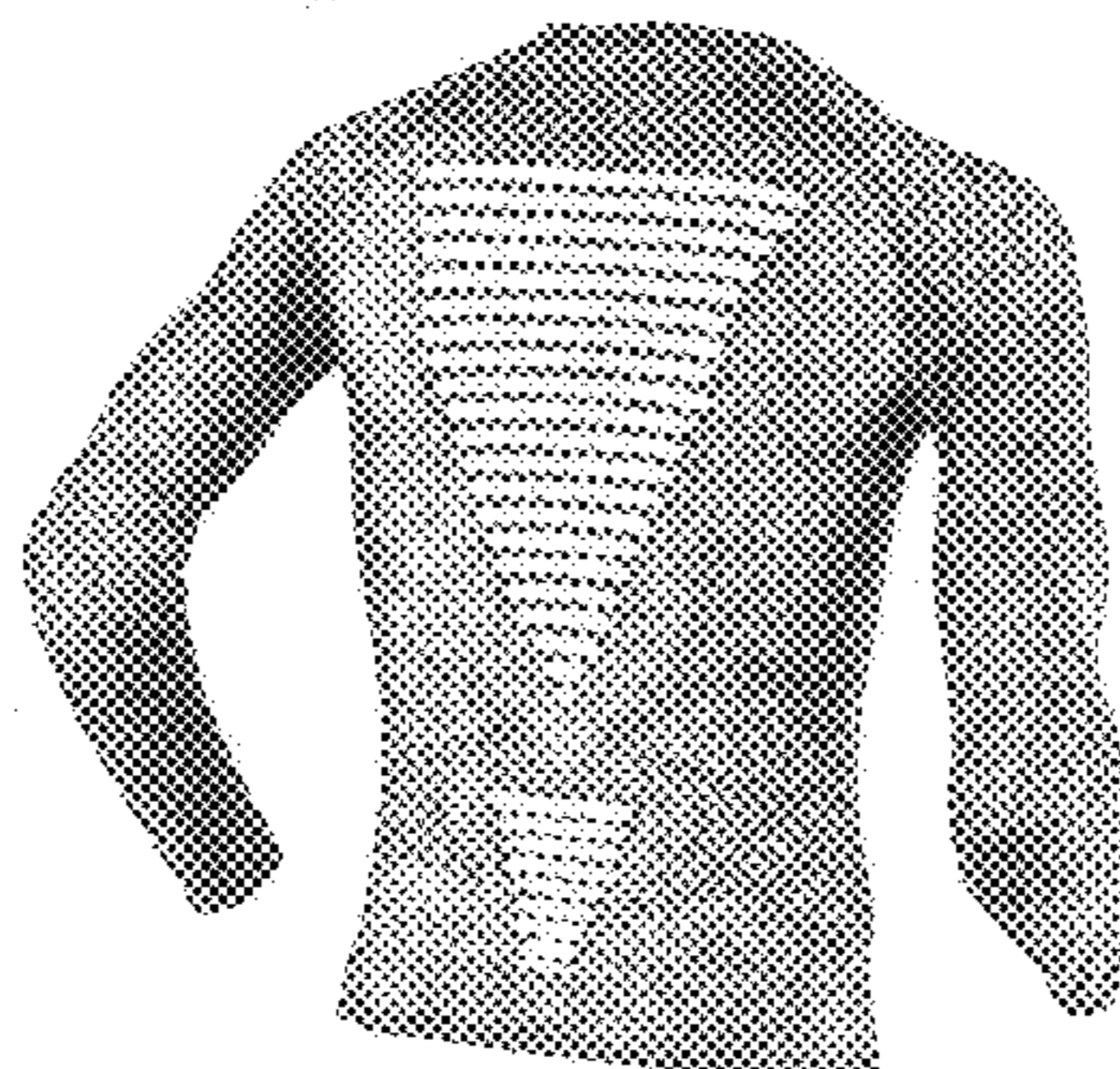
FIG. 5 is a detail view thereof;

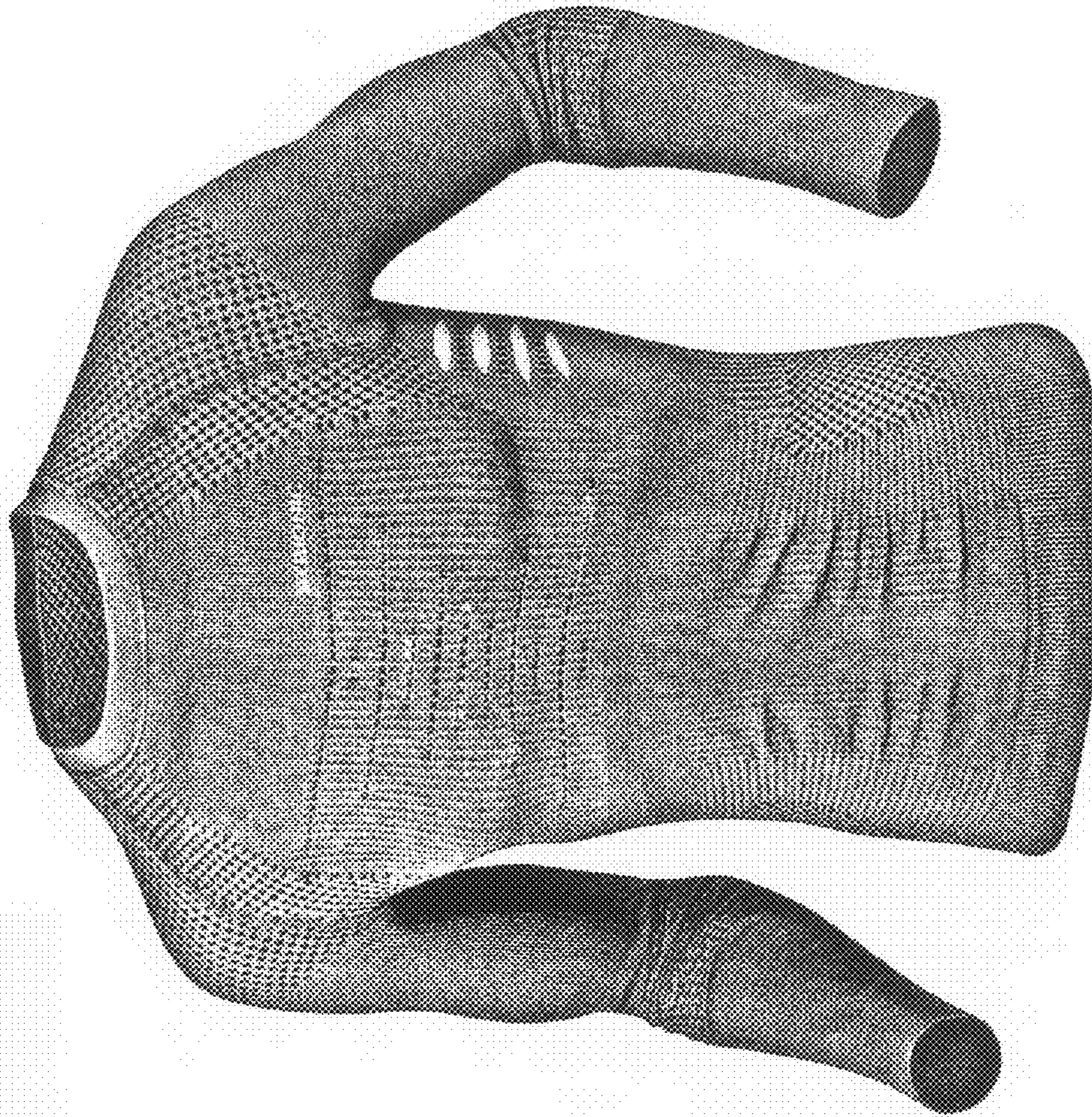

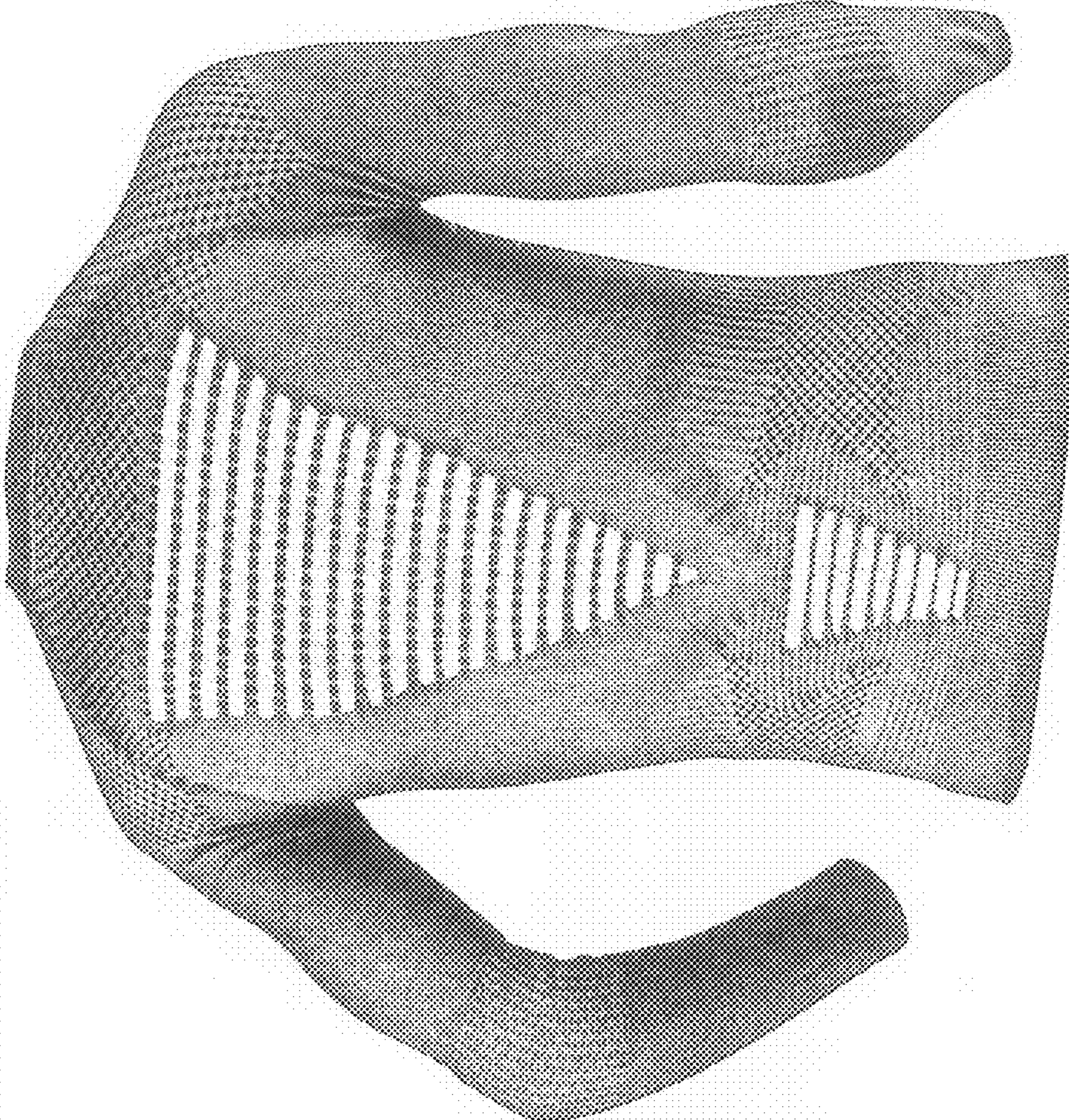

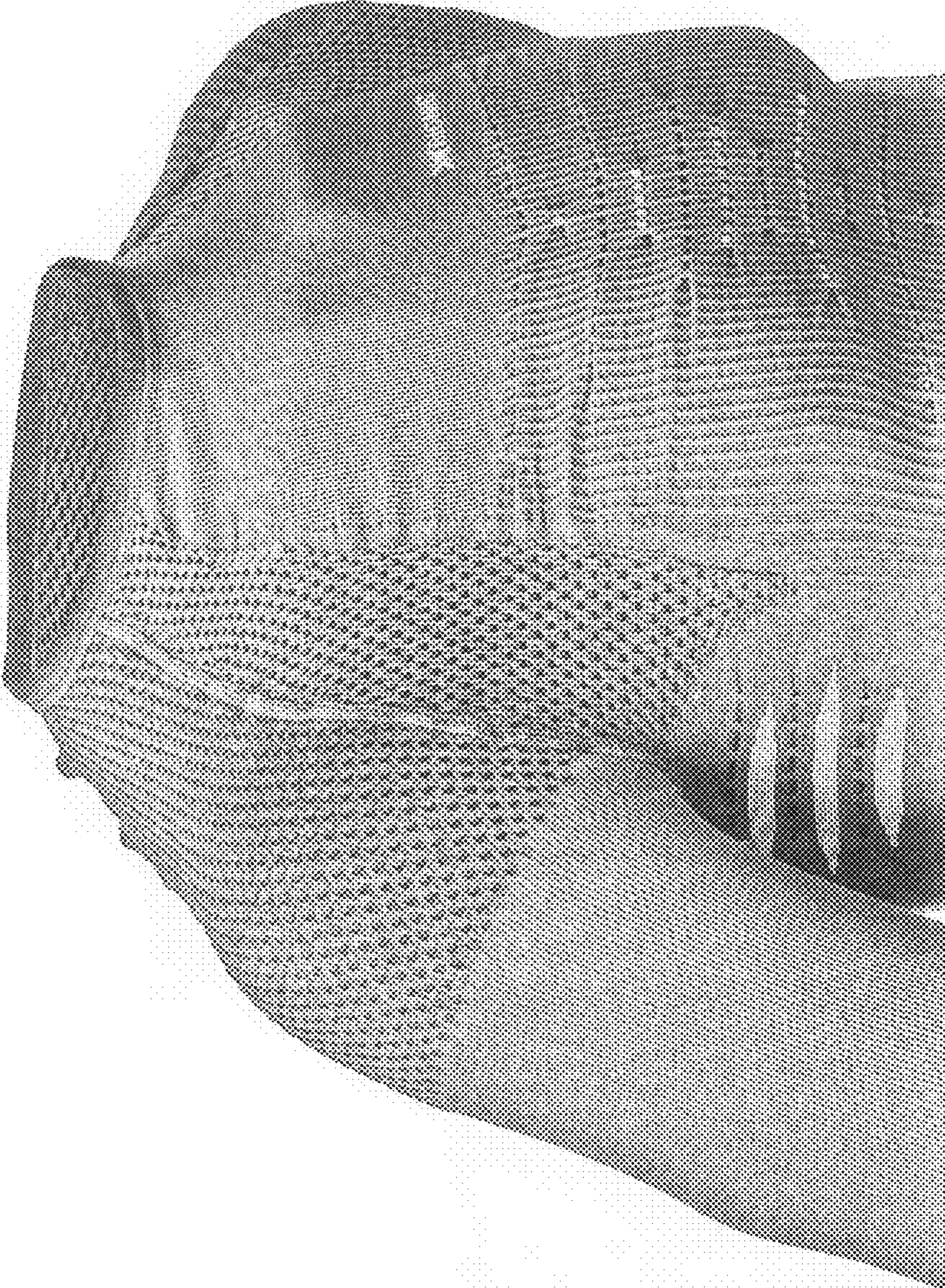

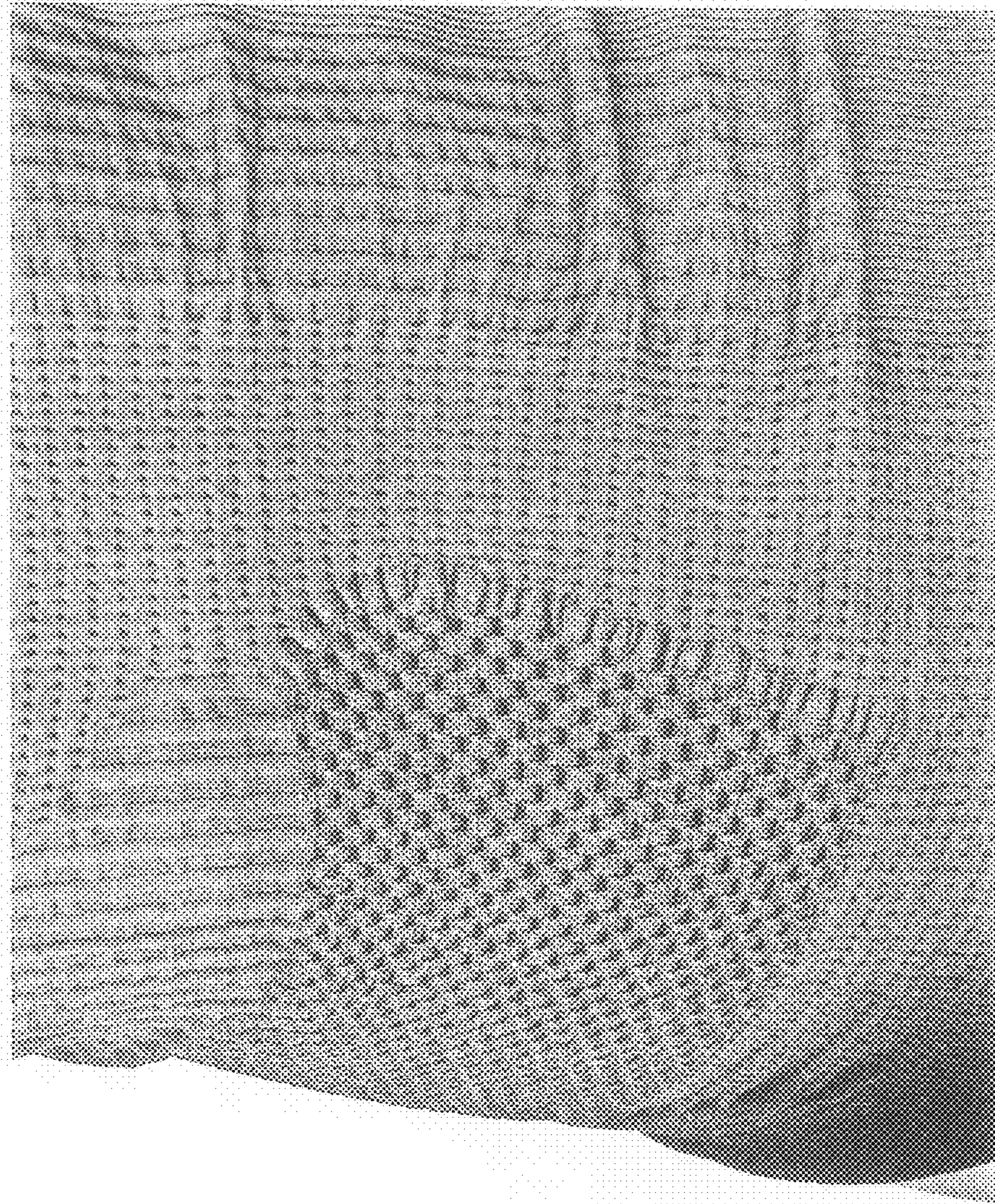

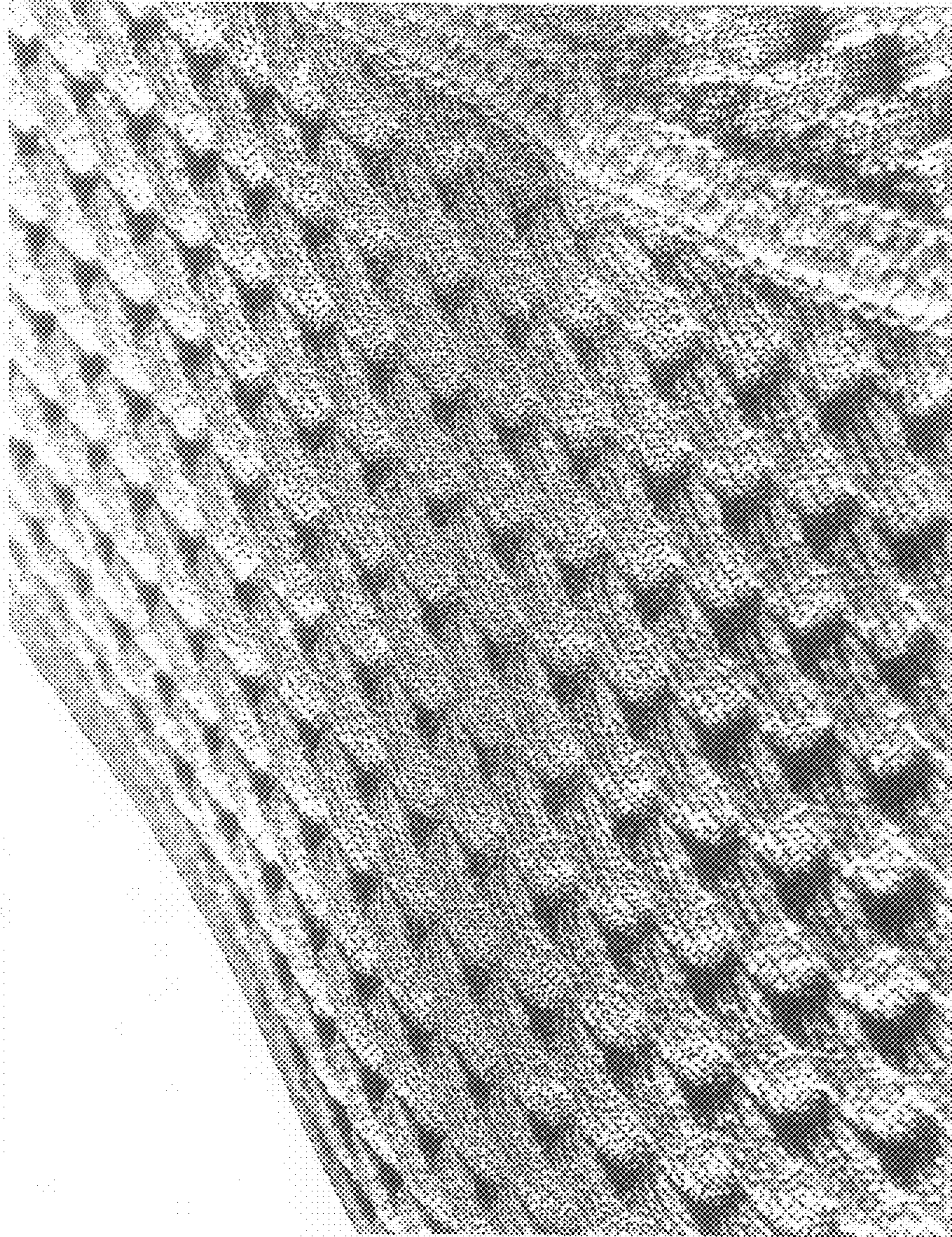

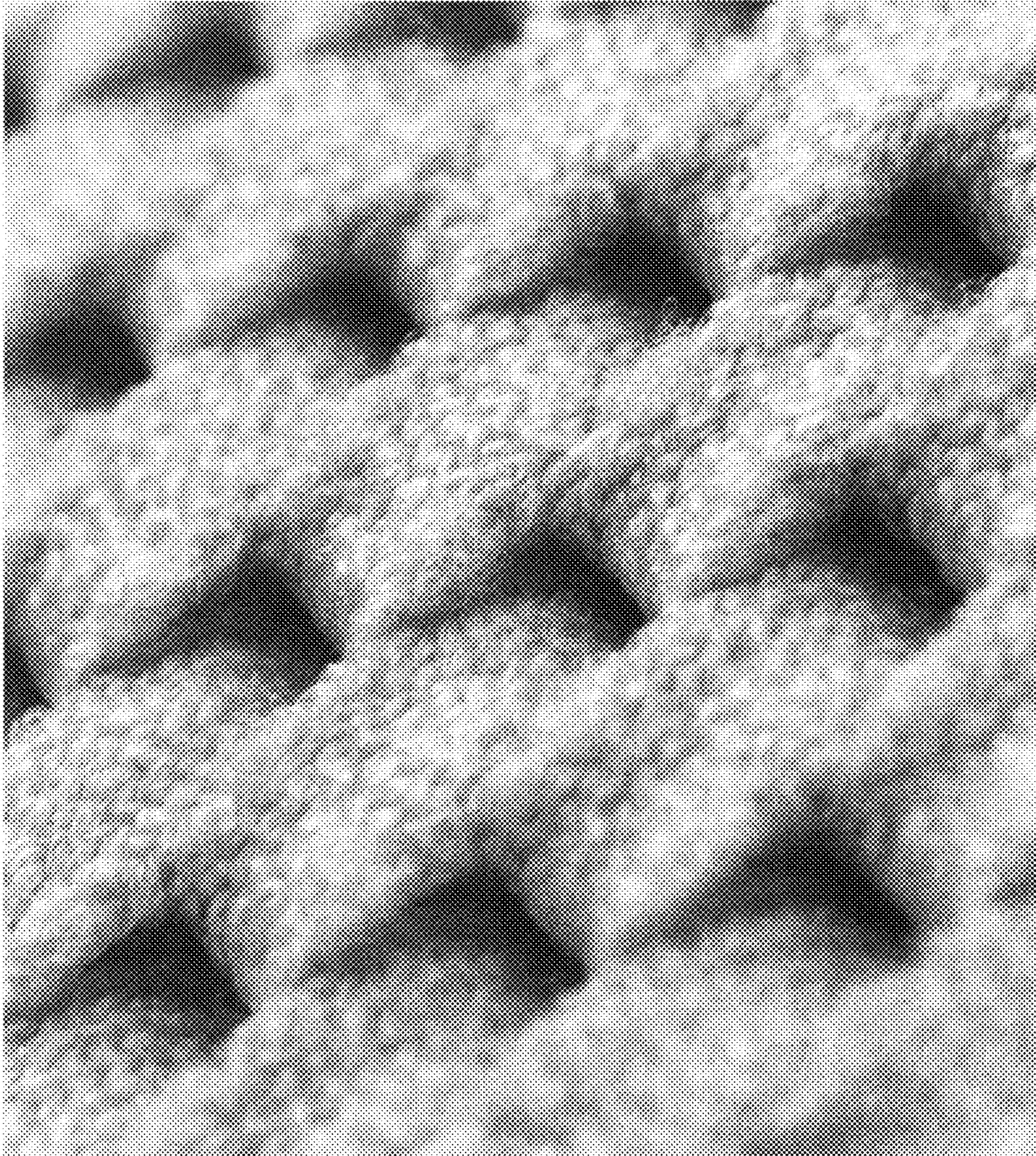

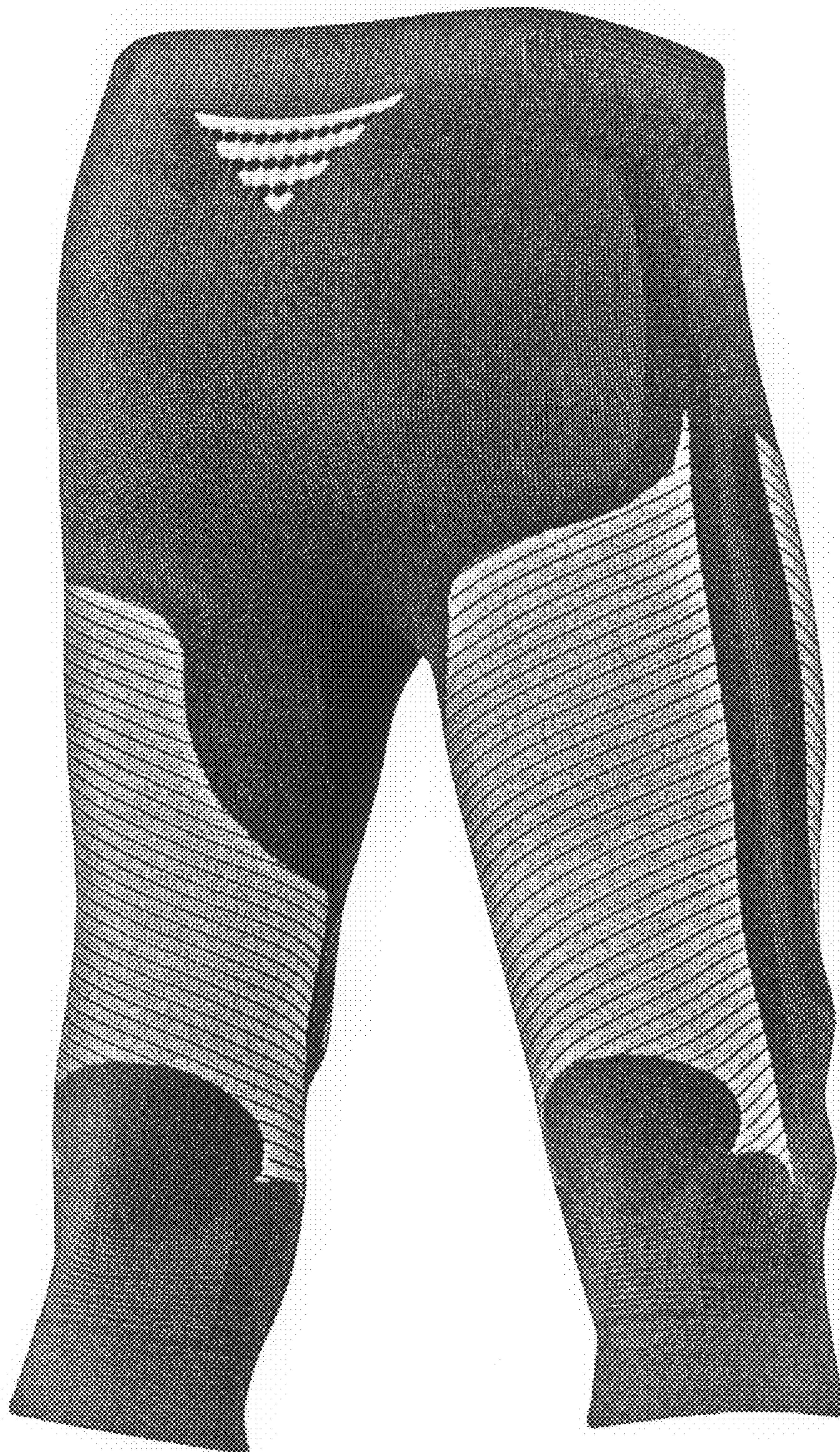
