DESCRIPTION

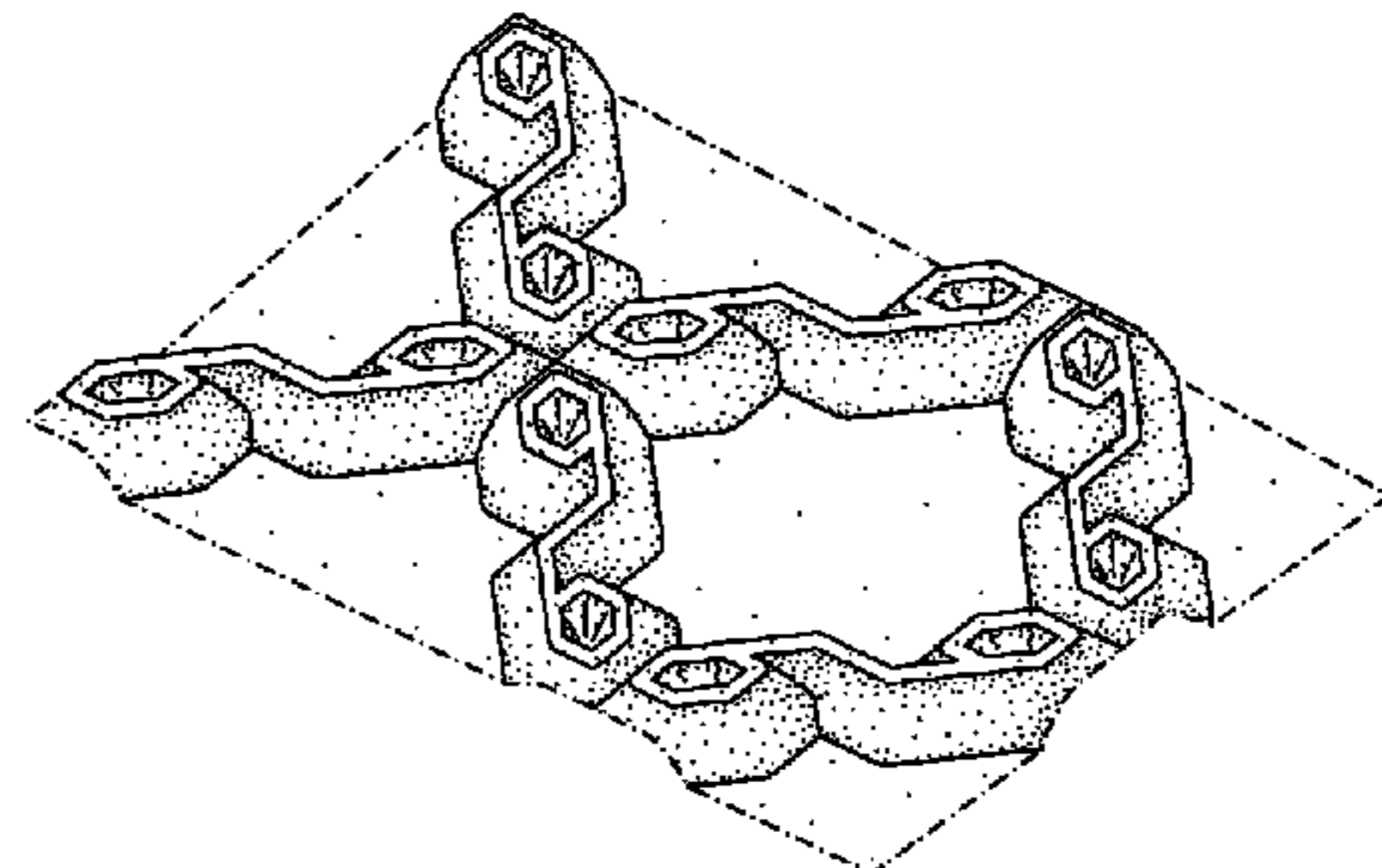
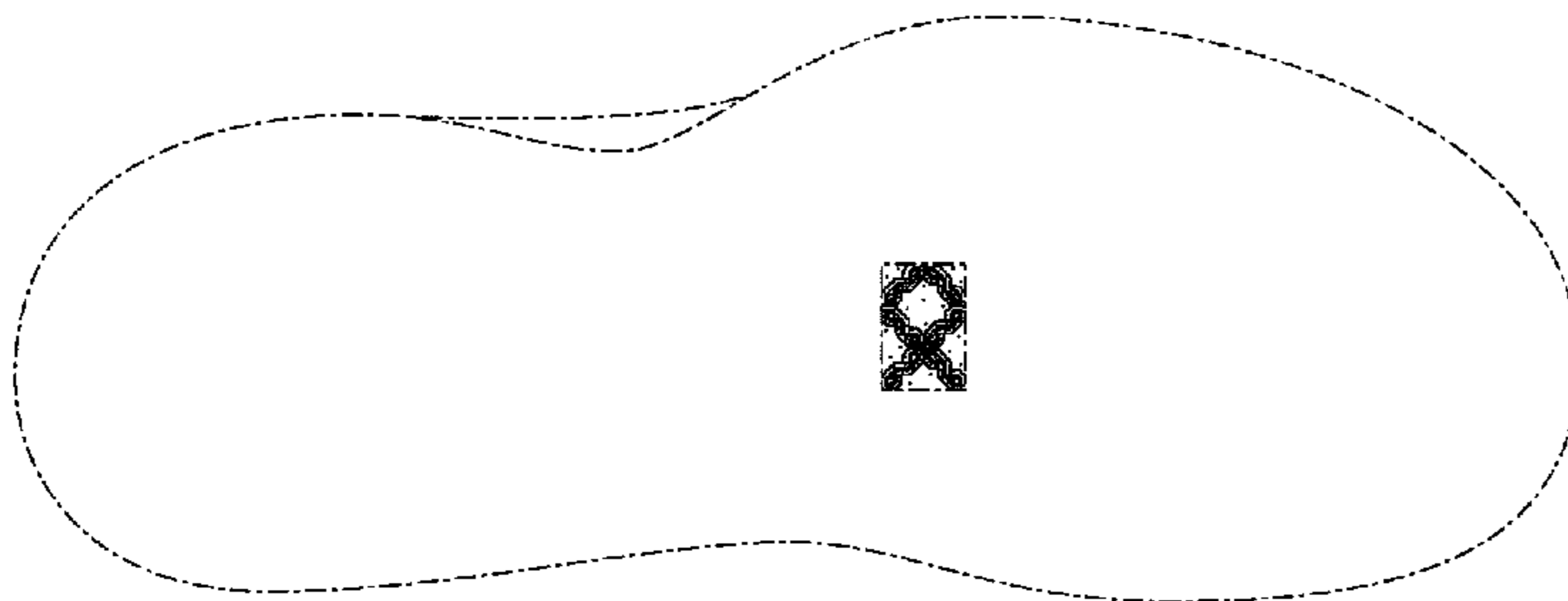
FIG. 1 is a front perspective view of a shoe outsole showing my new design;

FIG. 2 is a plan view thereof; and,

FIG. 3 is an enlarged view of the claimed region in FIG. 1, shown in isolation.

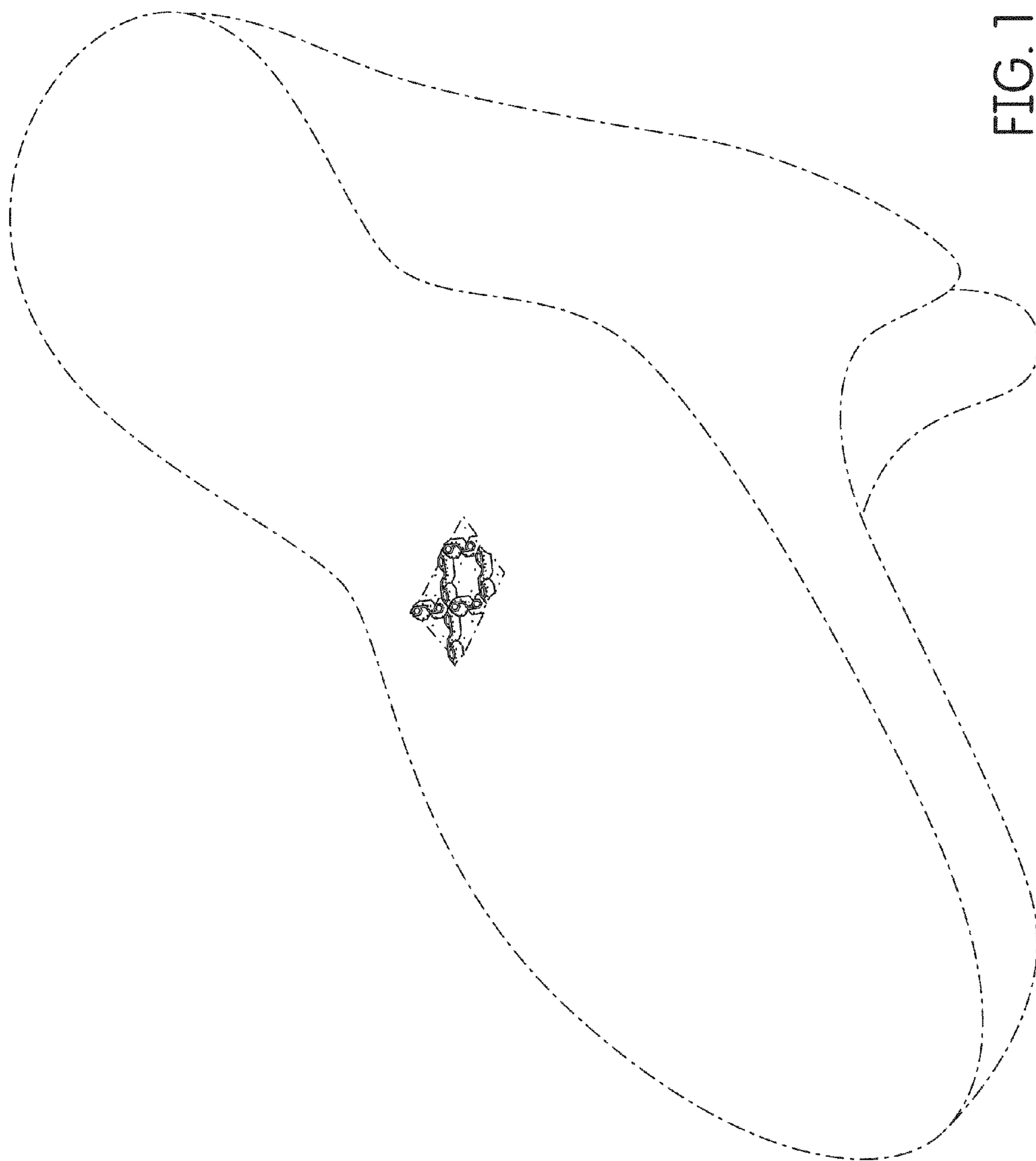

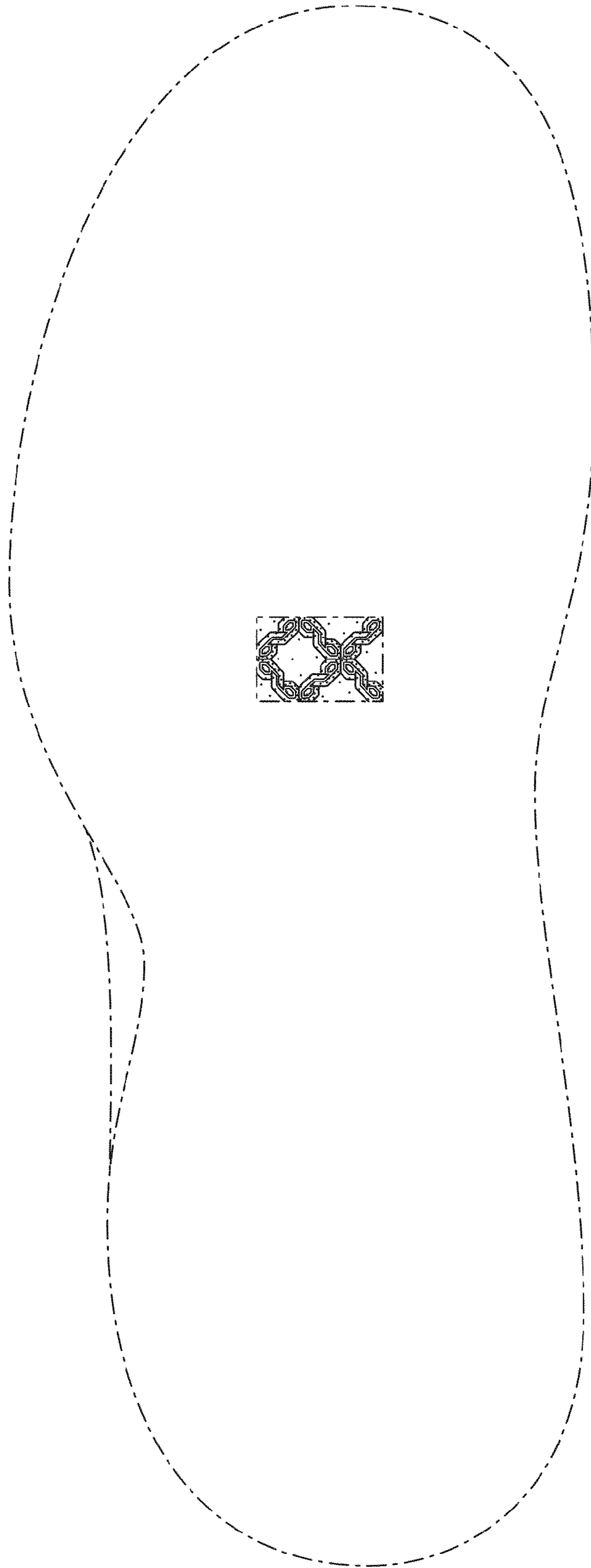

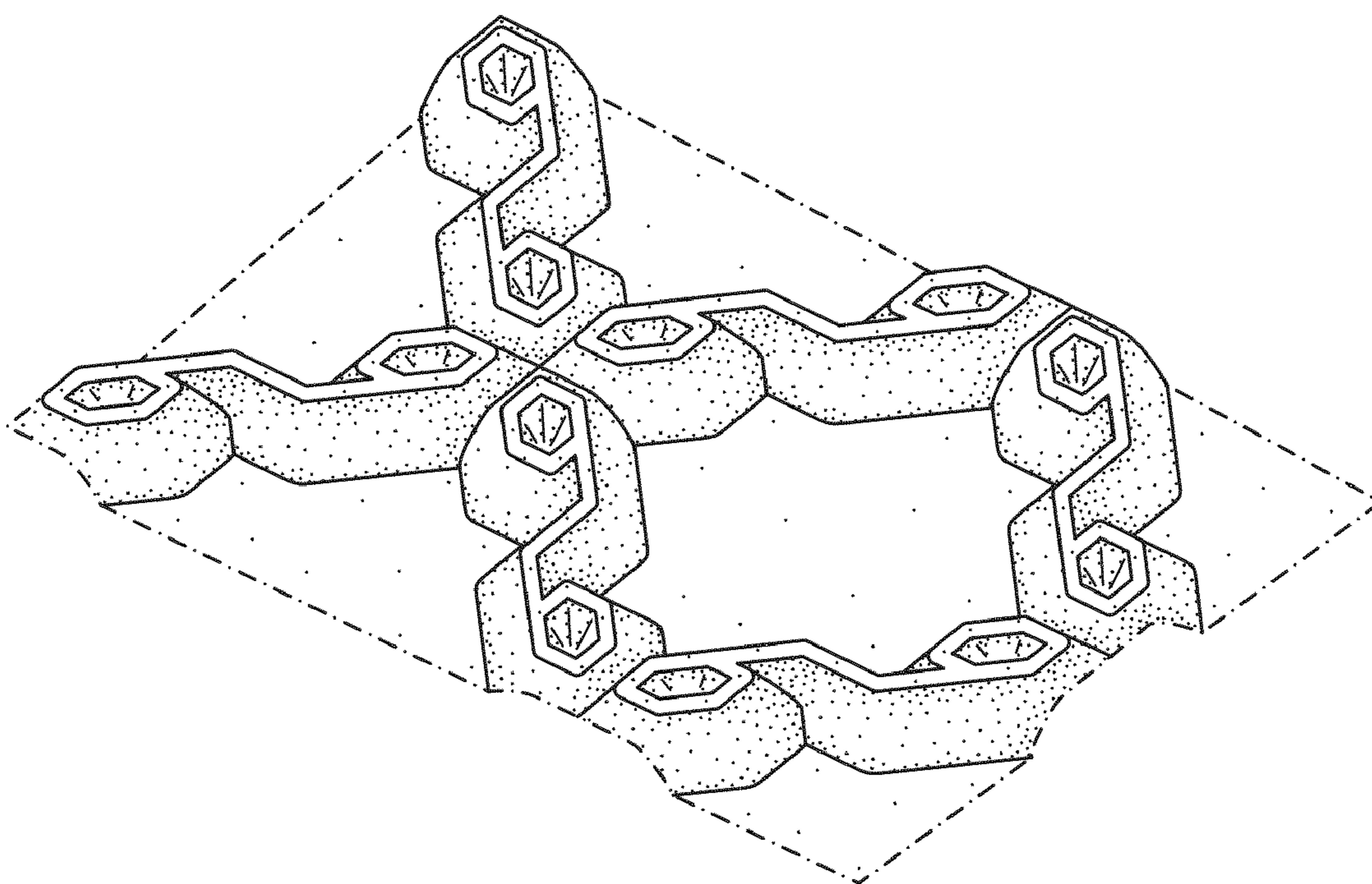
