**DESCRIPTION**

FIG. 5 is a rear view of the footwear shown in FIG. 1;

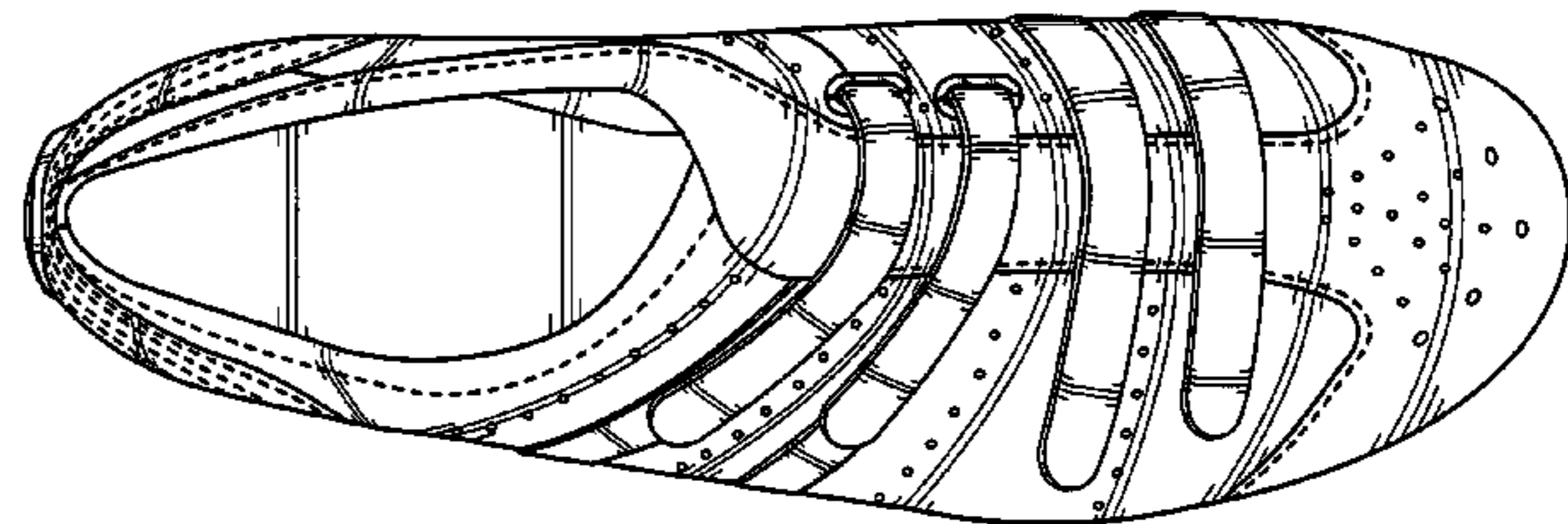
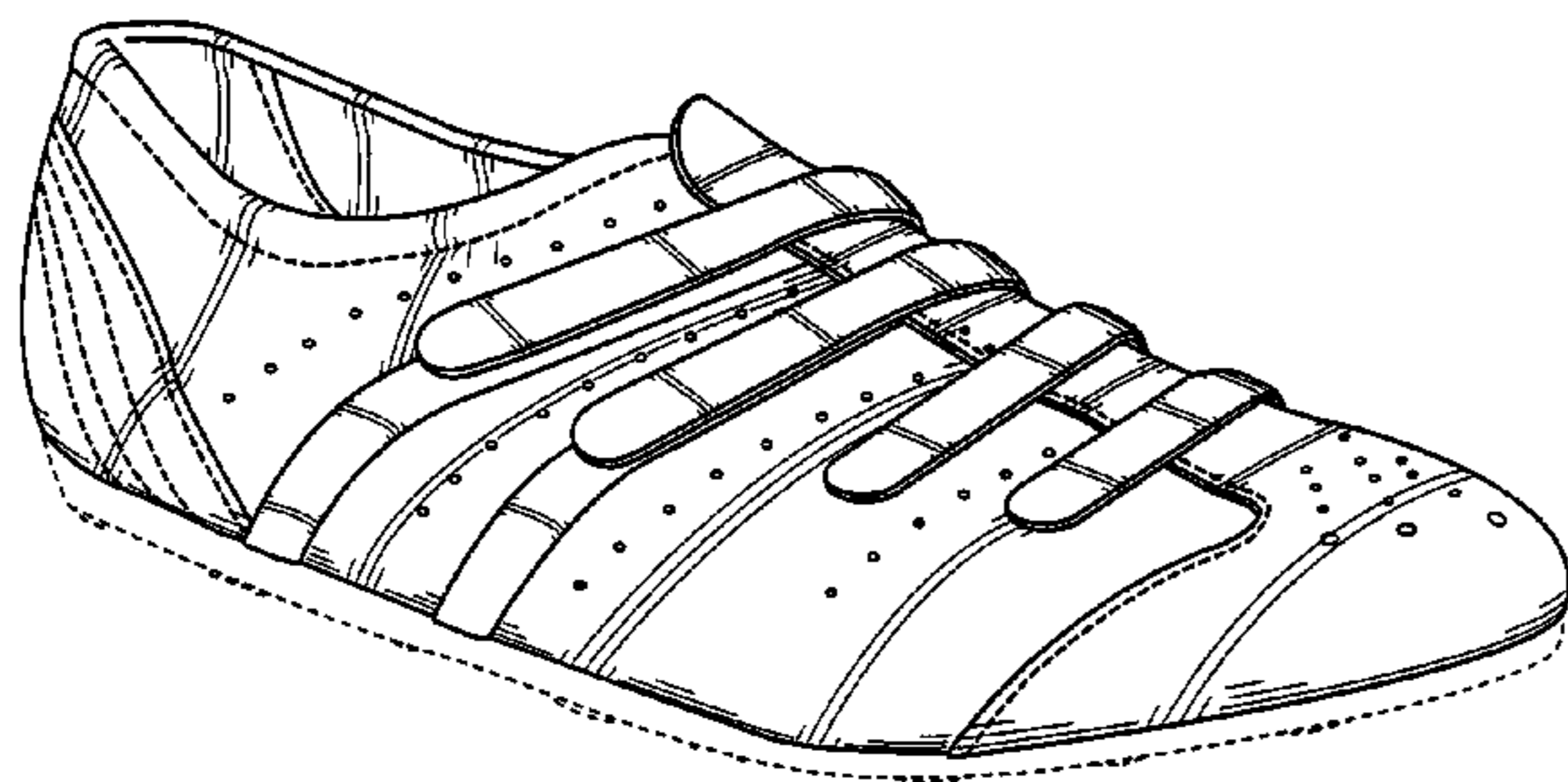
FIG. 6 is a top view of the footwear shown in FIG. 1; and,

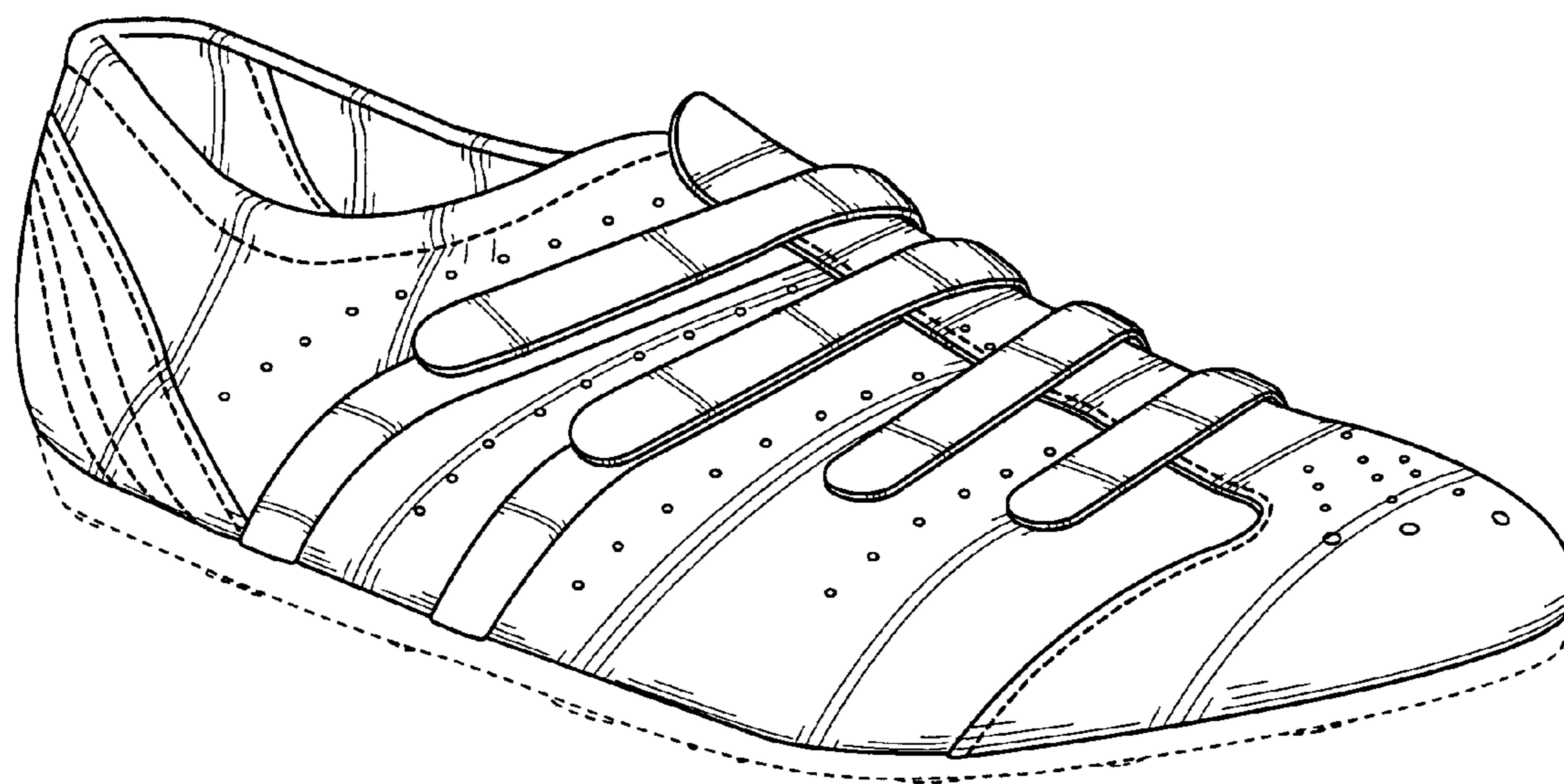

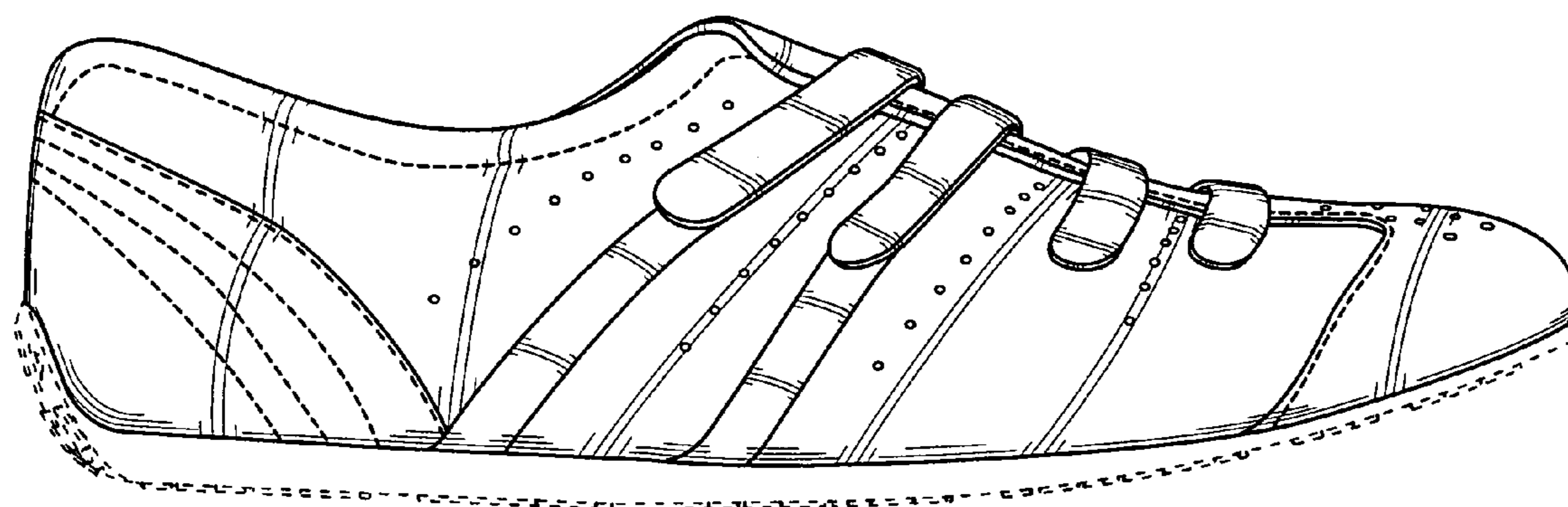

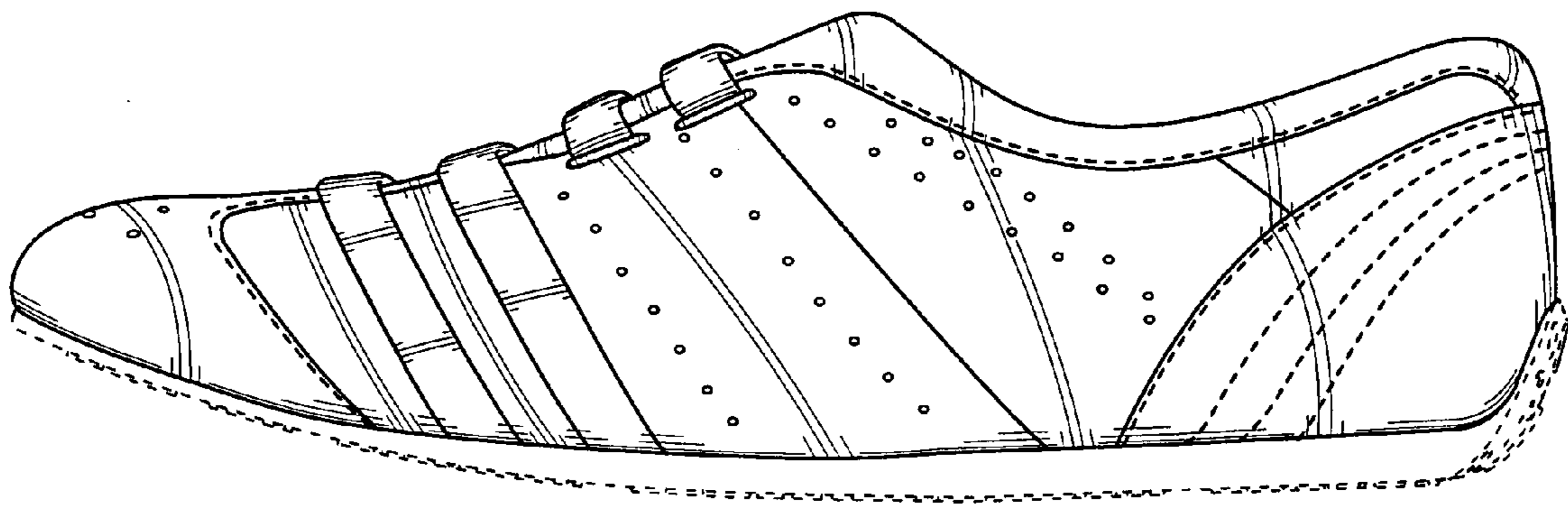

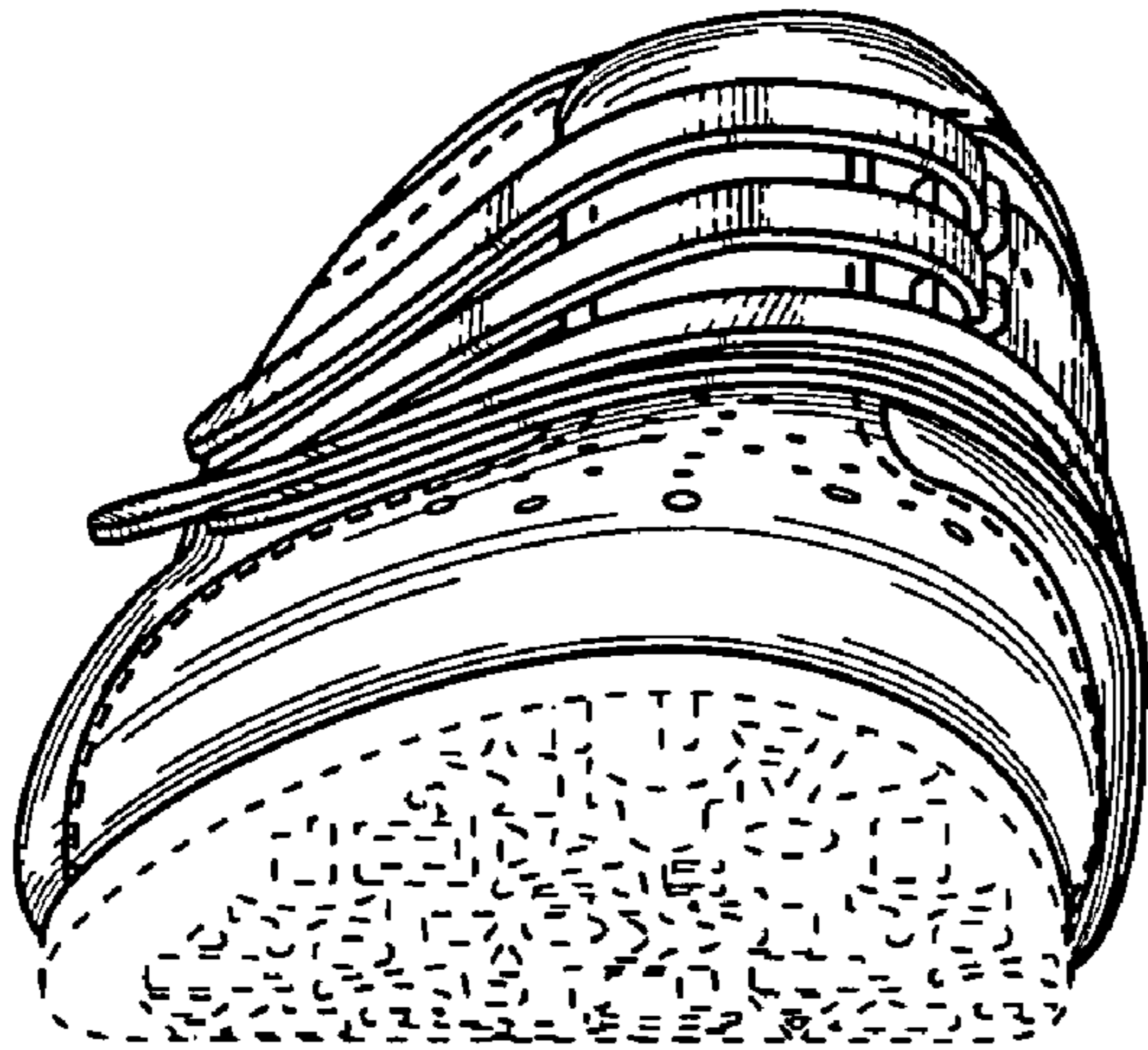

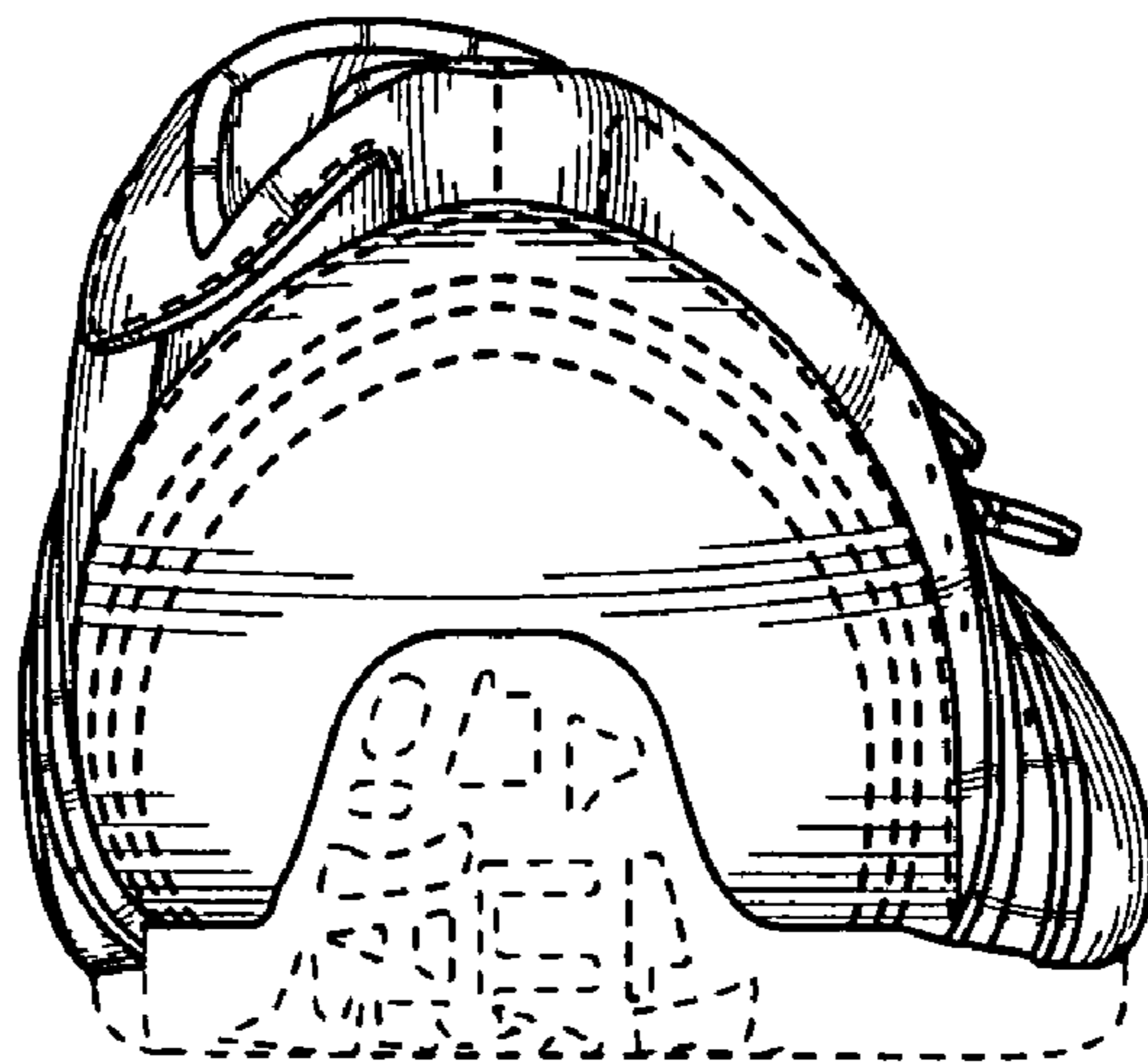

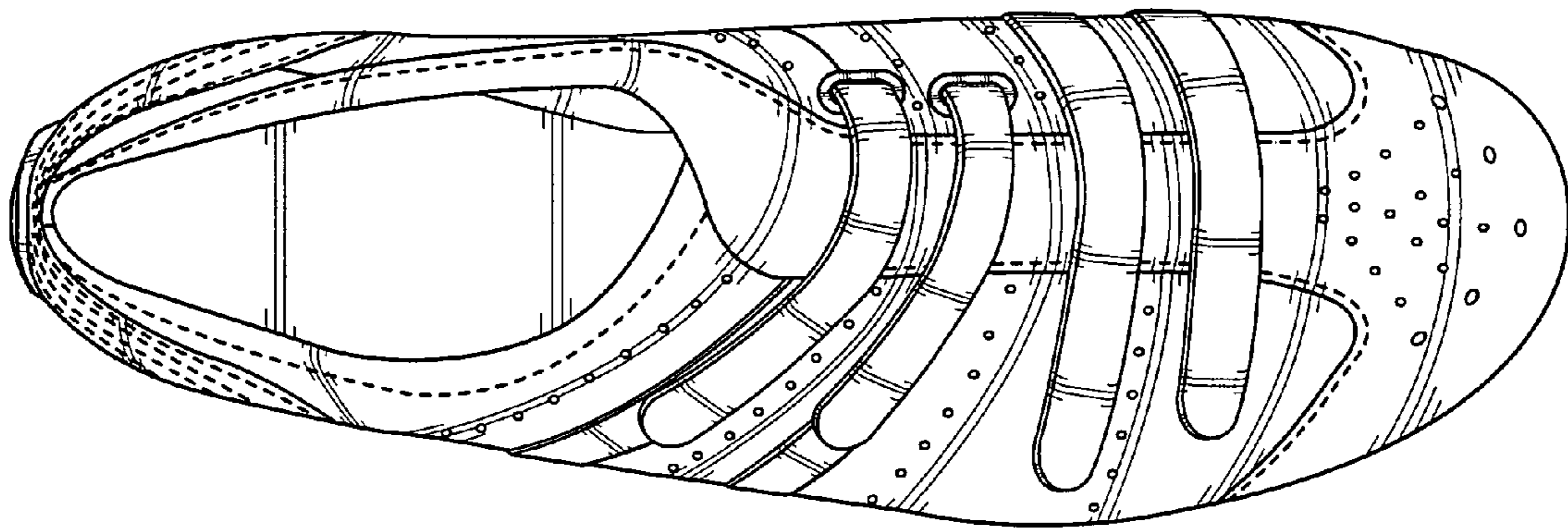

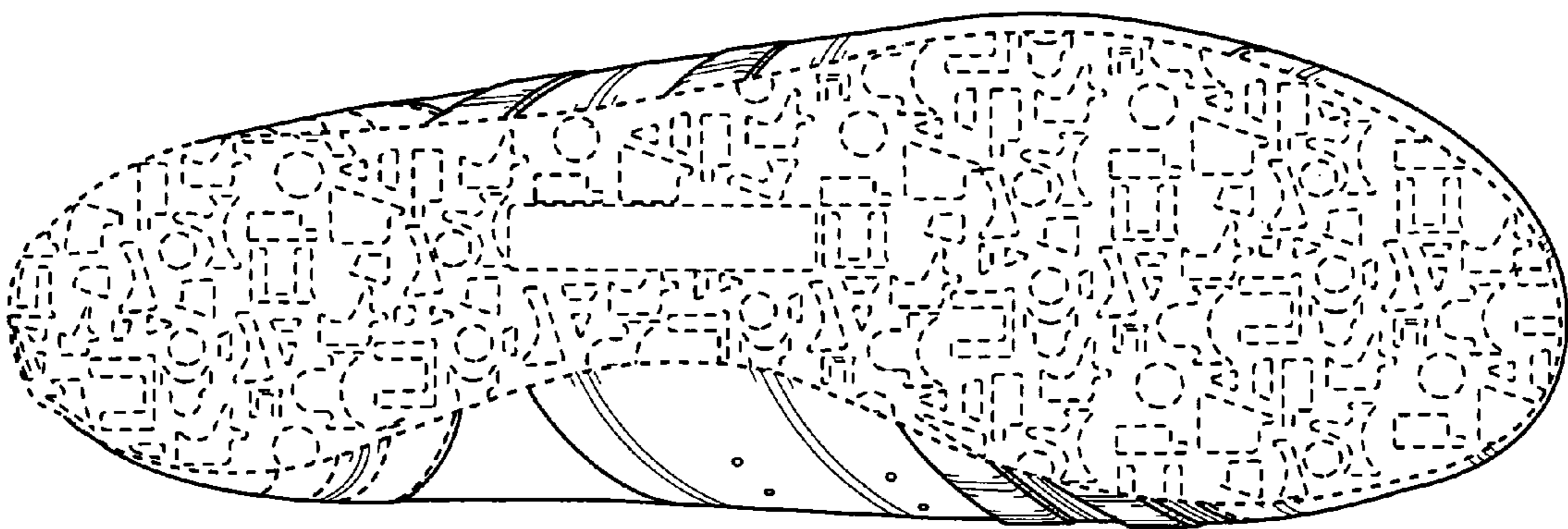
