(57) **CLAIM**

We claim the ornamental design for a beverage dispenser, as shown and described.

DESCRIPTION

FIG. 10 is a rear elevational view thereof;

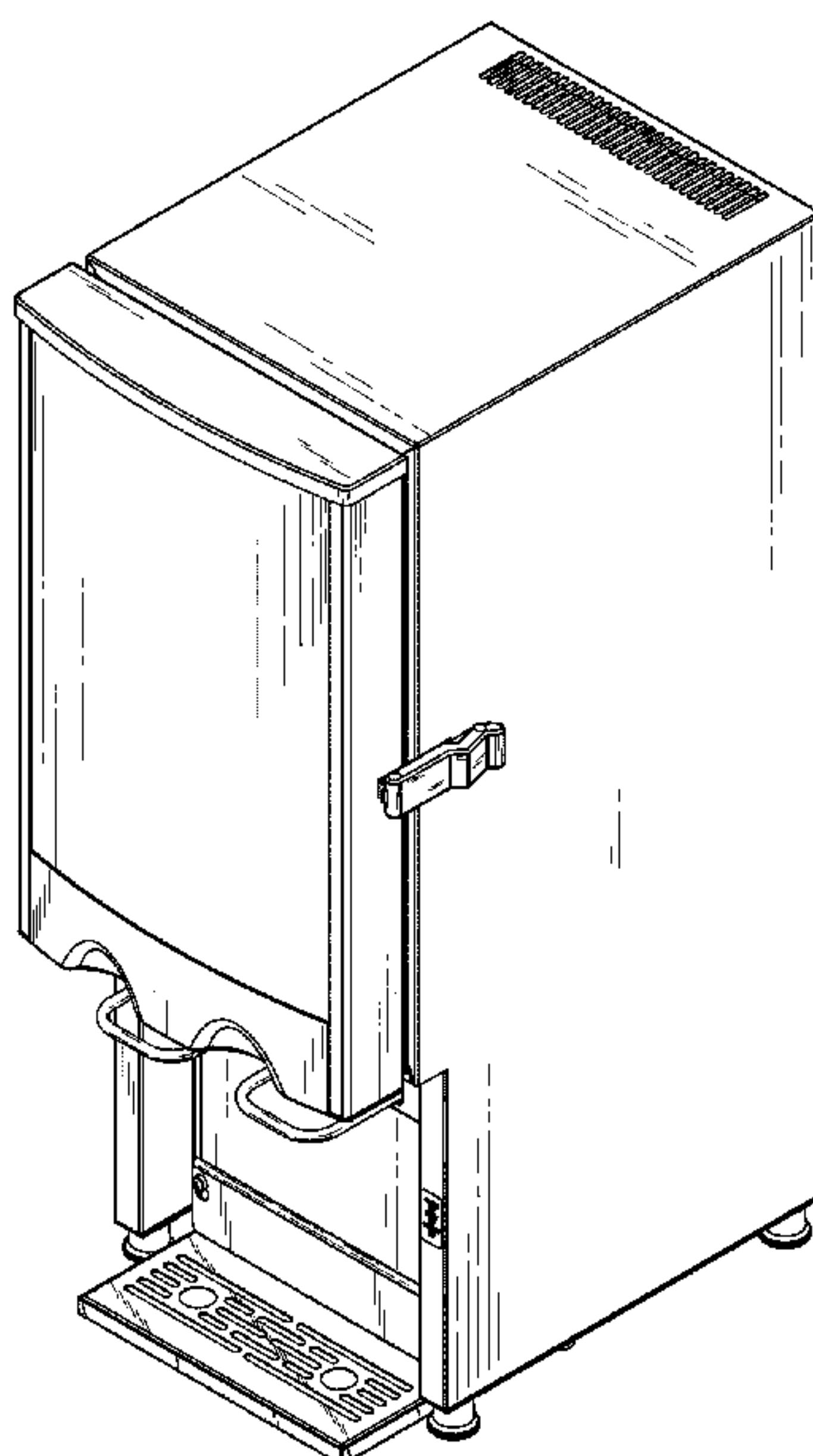
FIG. 11 is a left-side elevational view thereof;

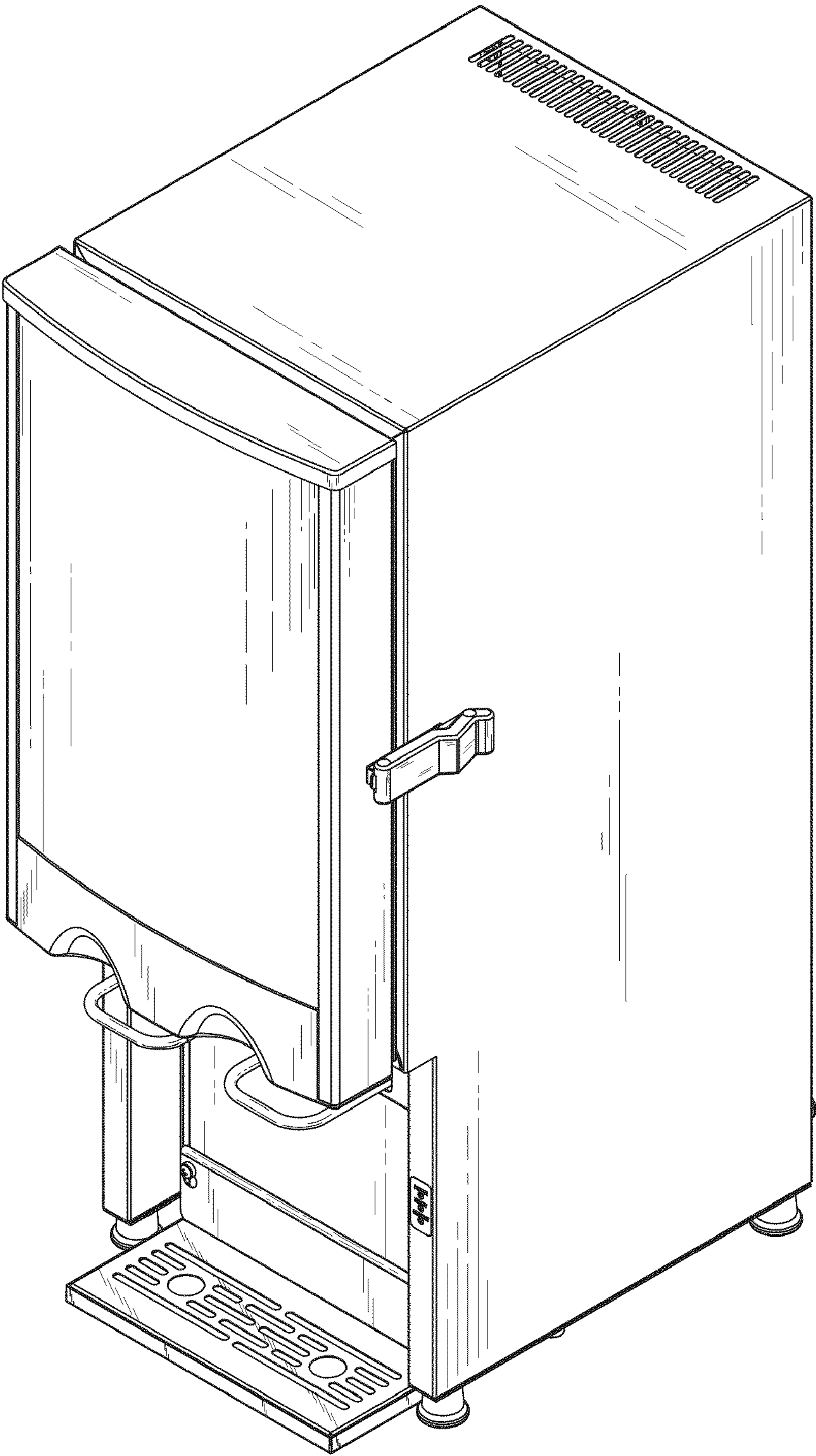

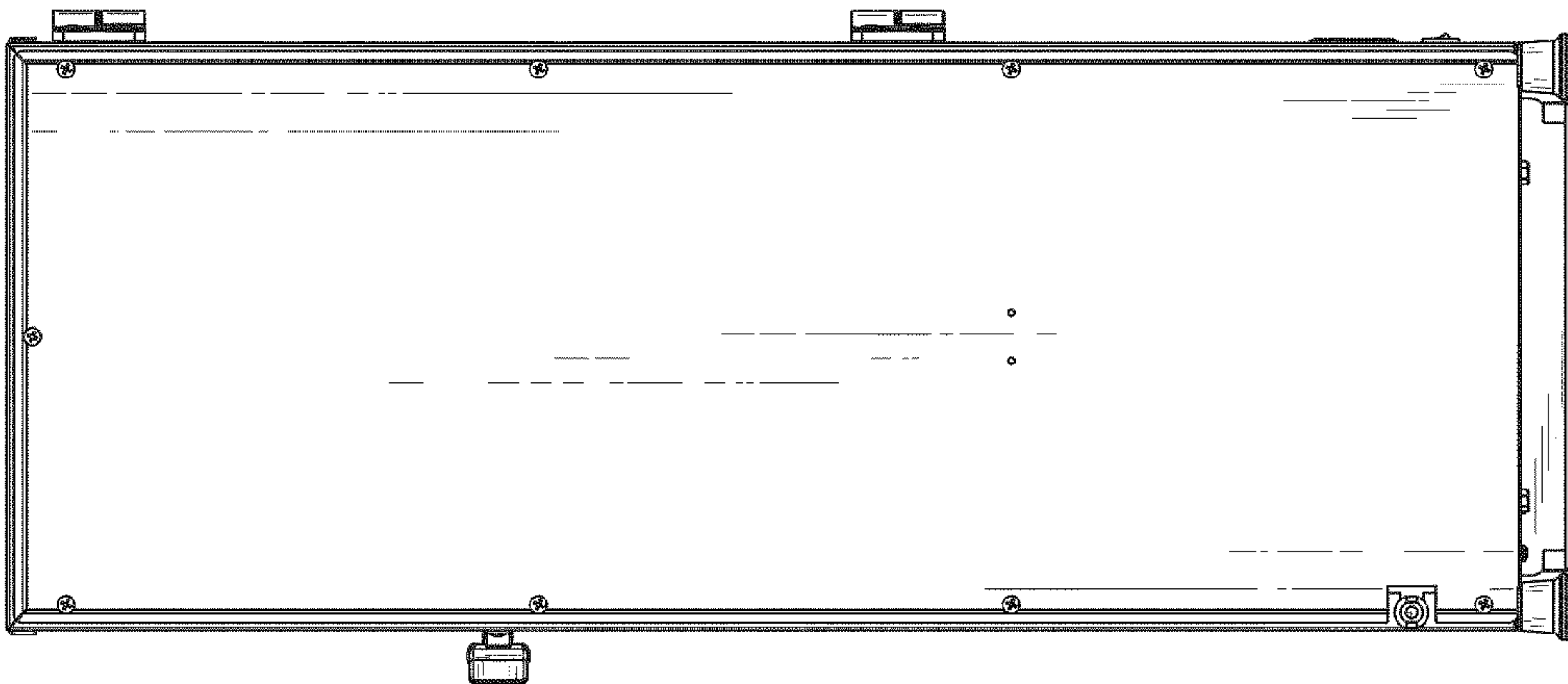

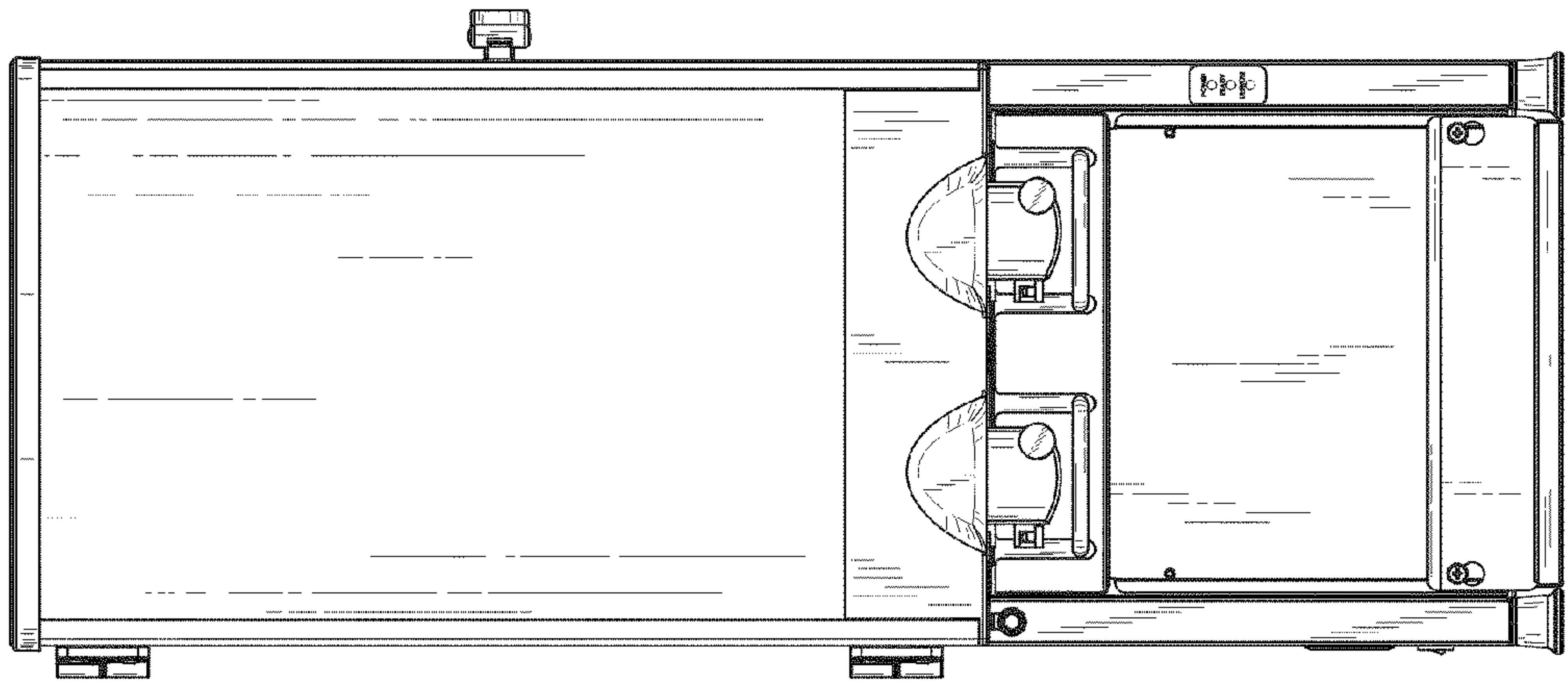

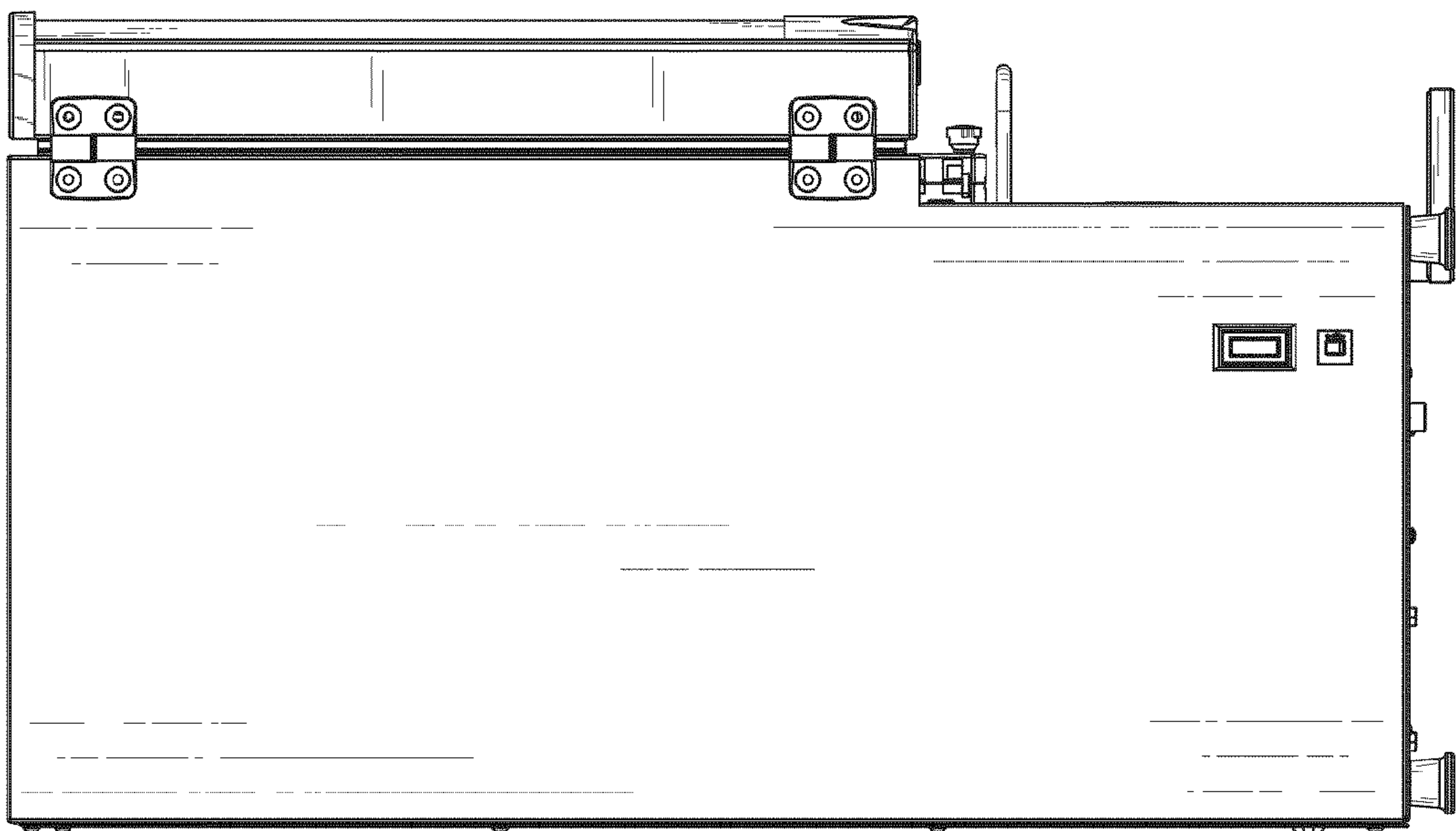

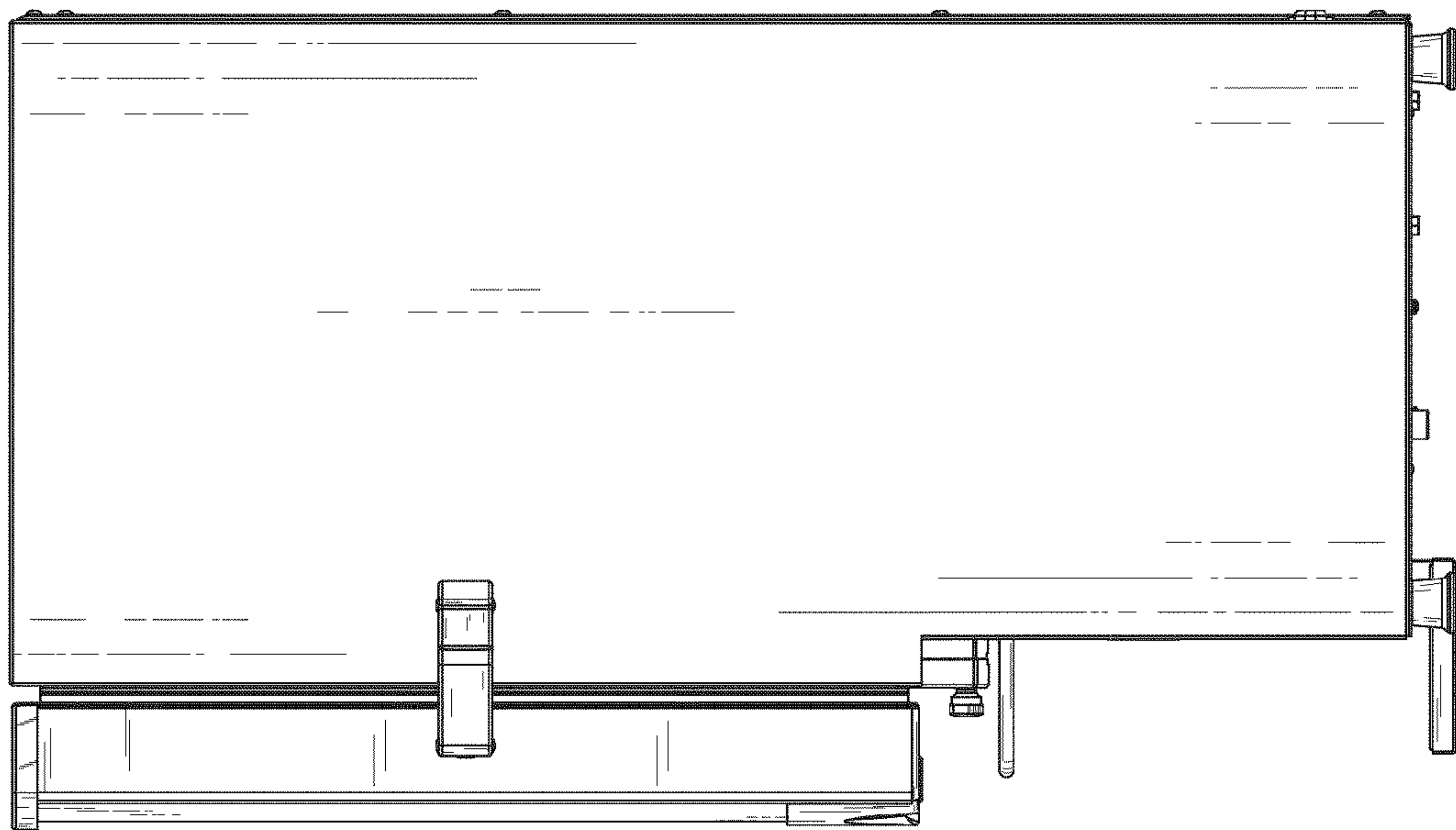

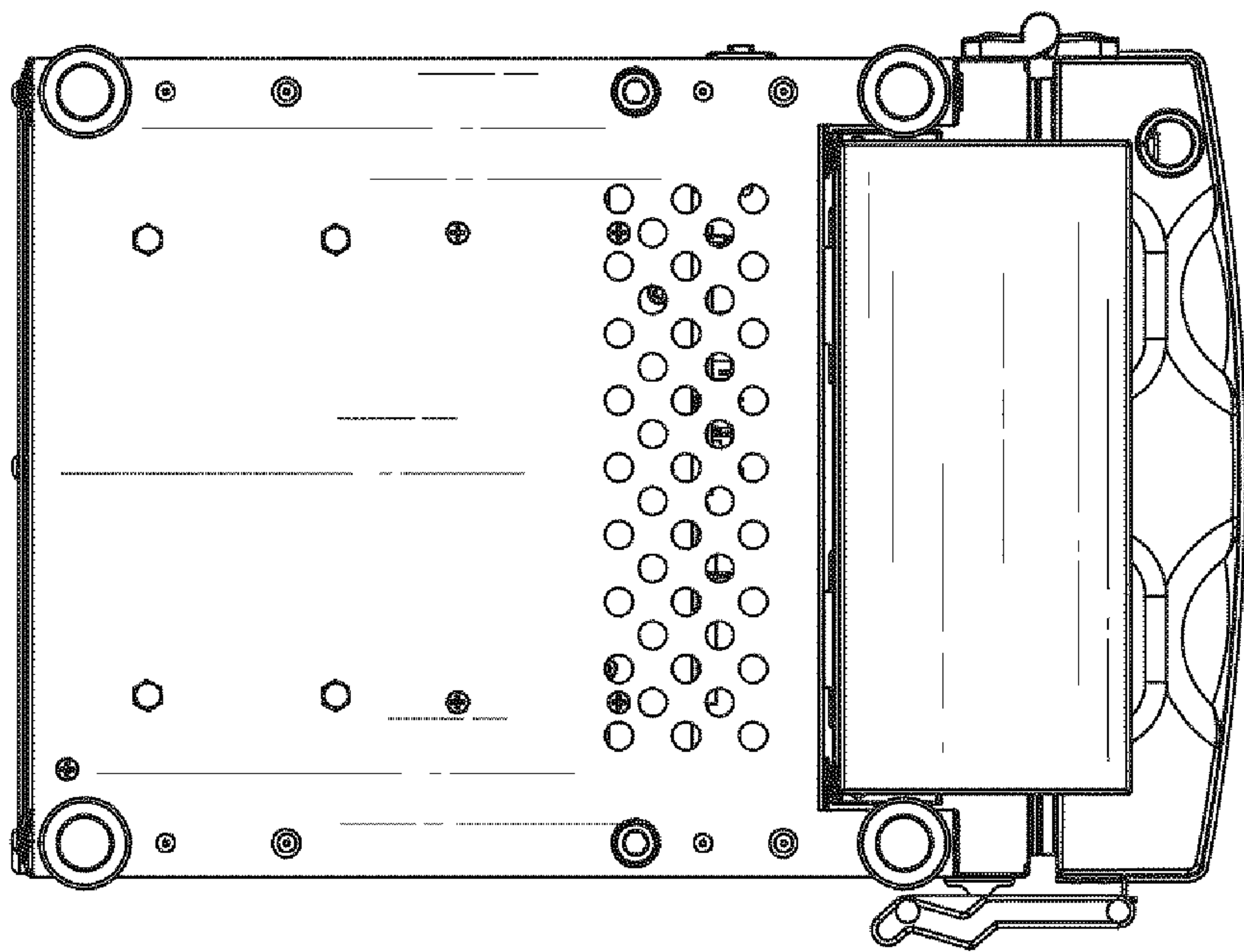

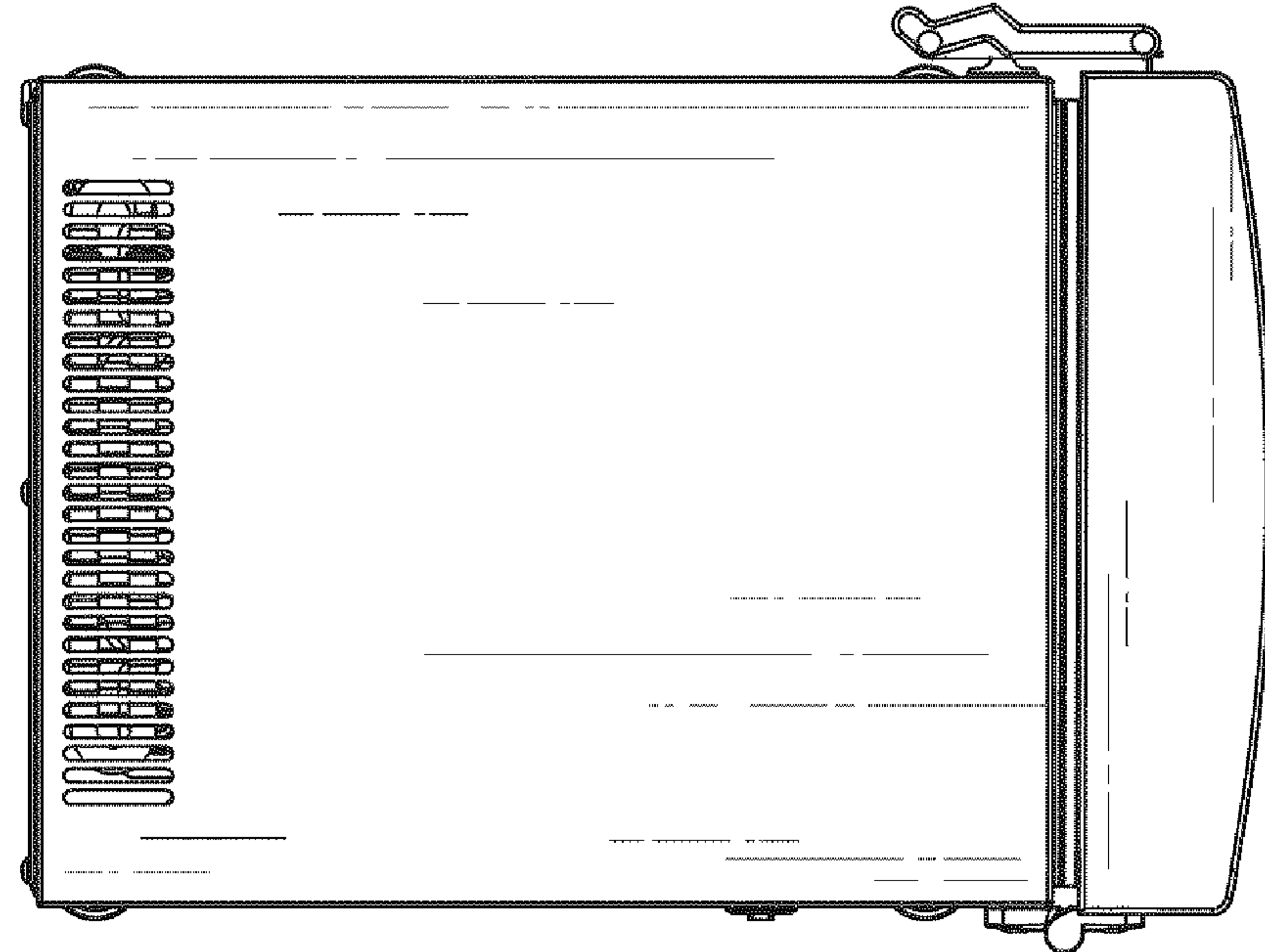

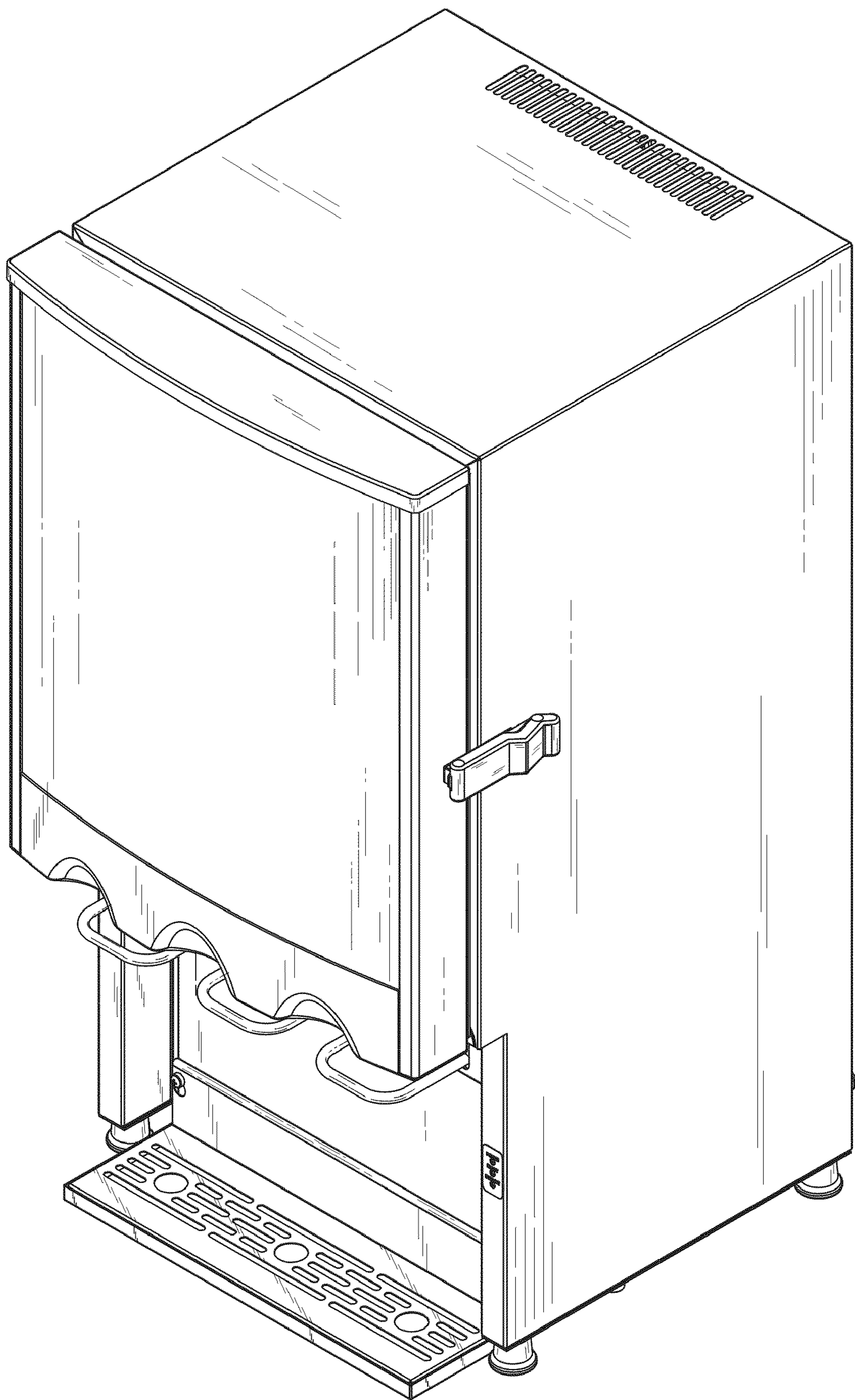

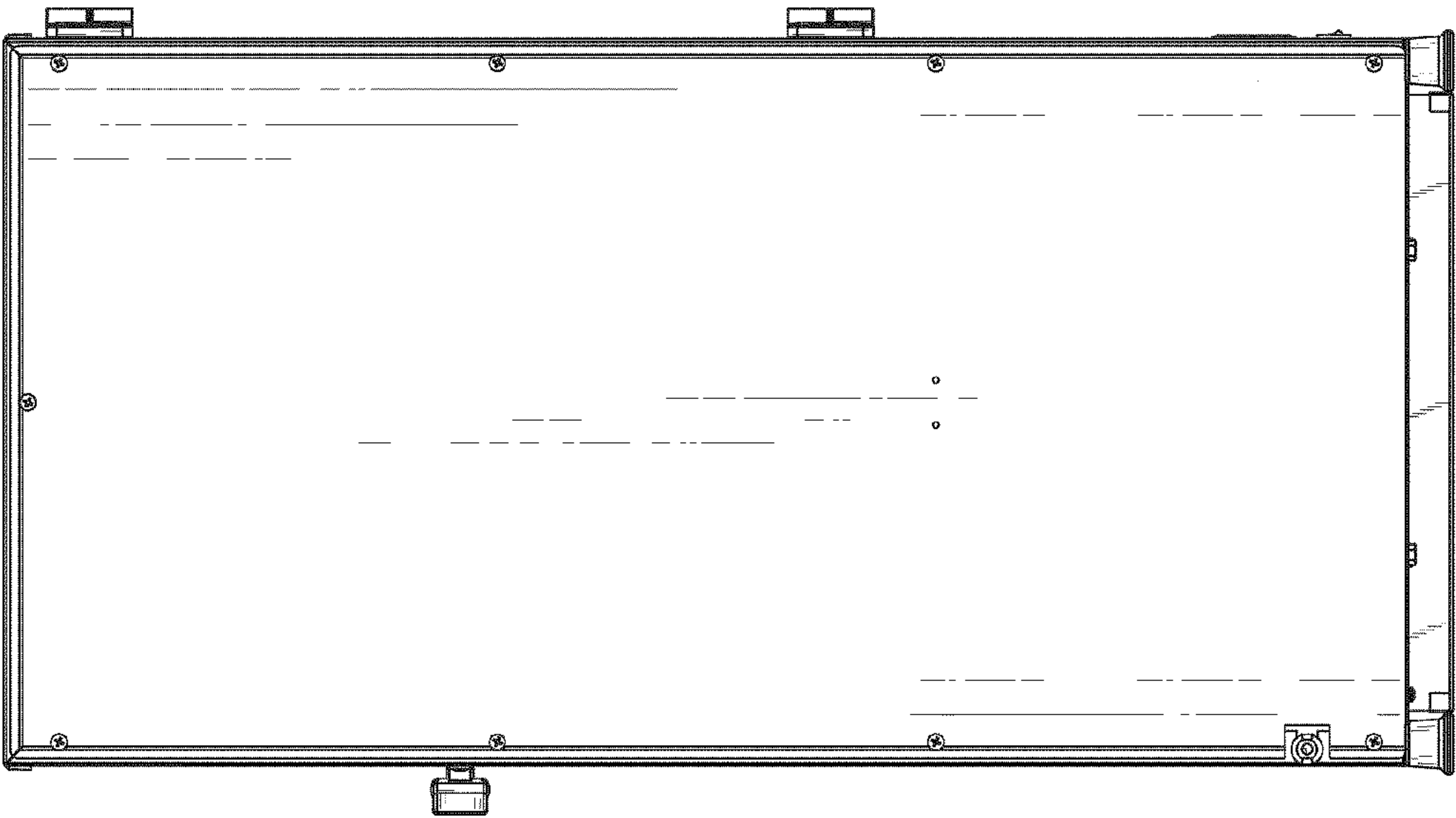

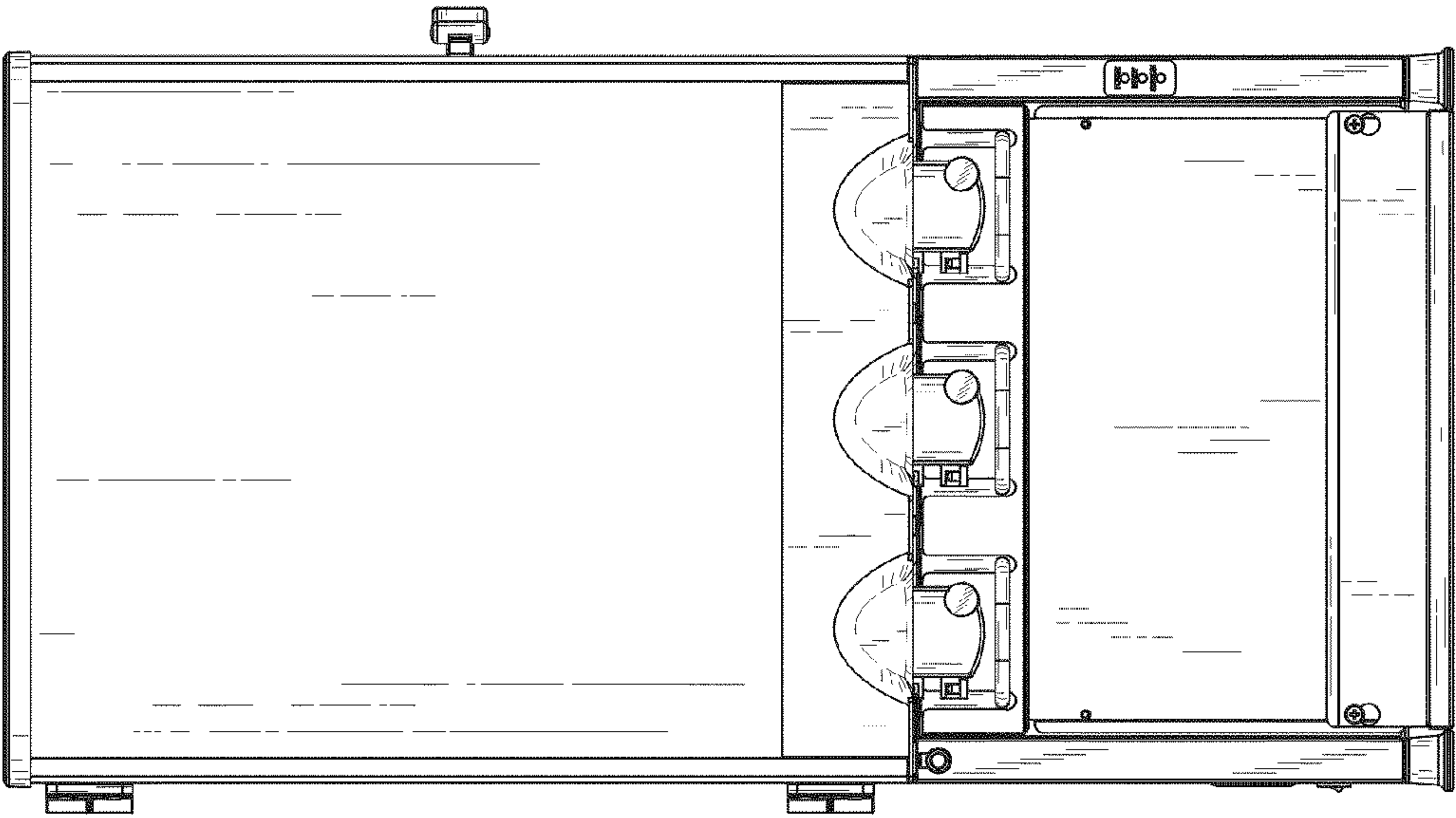

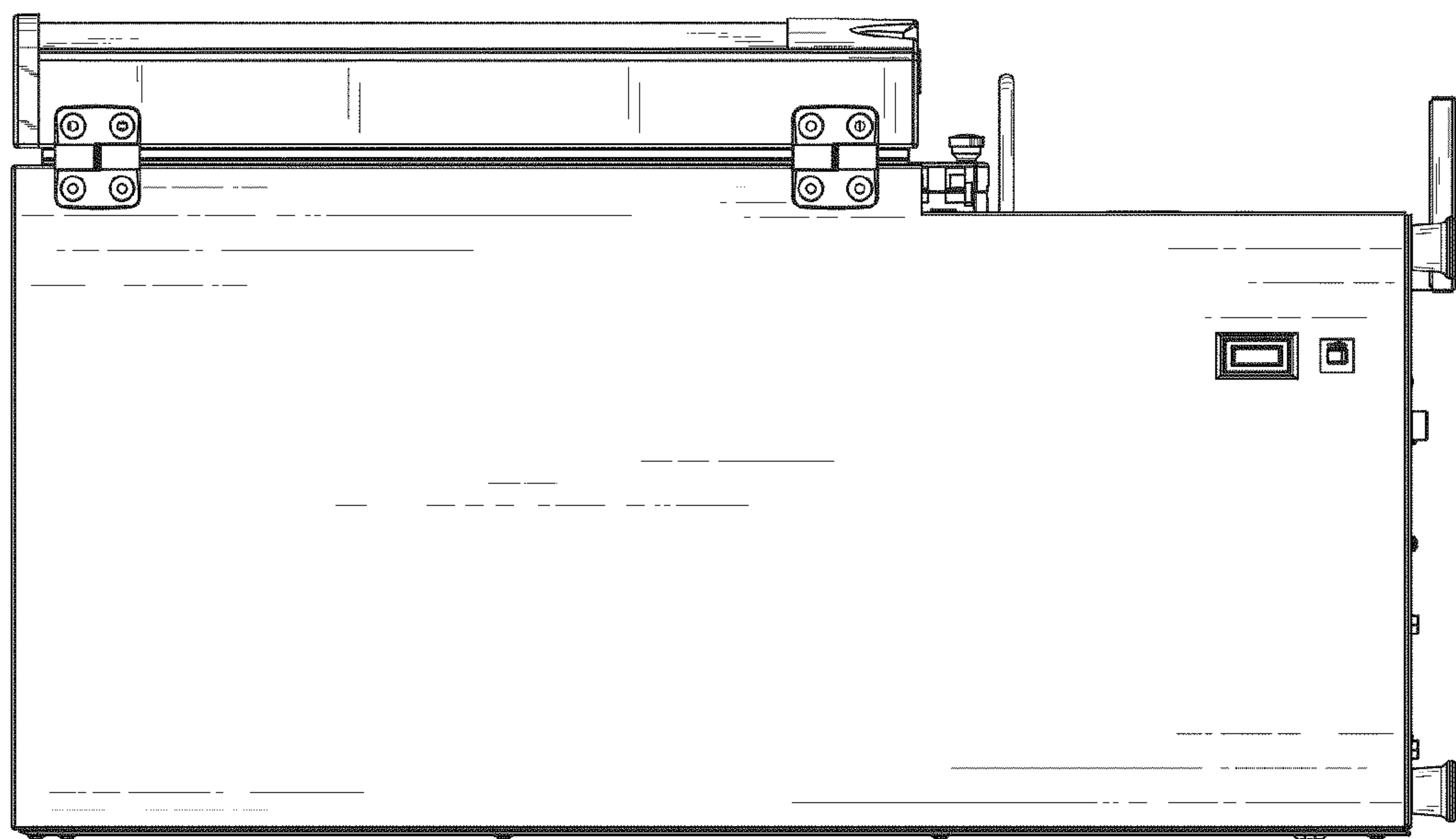

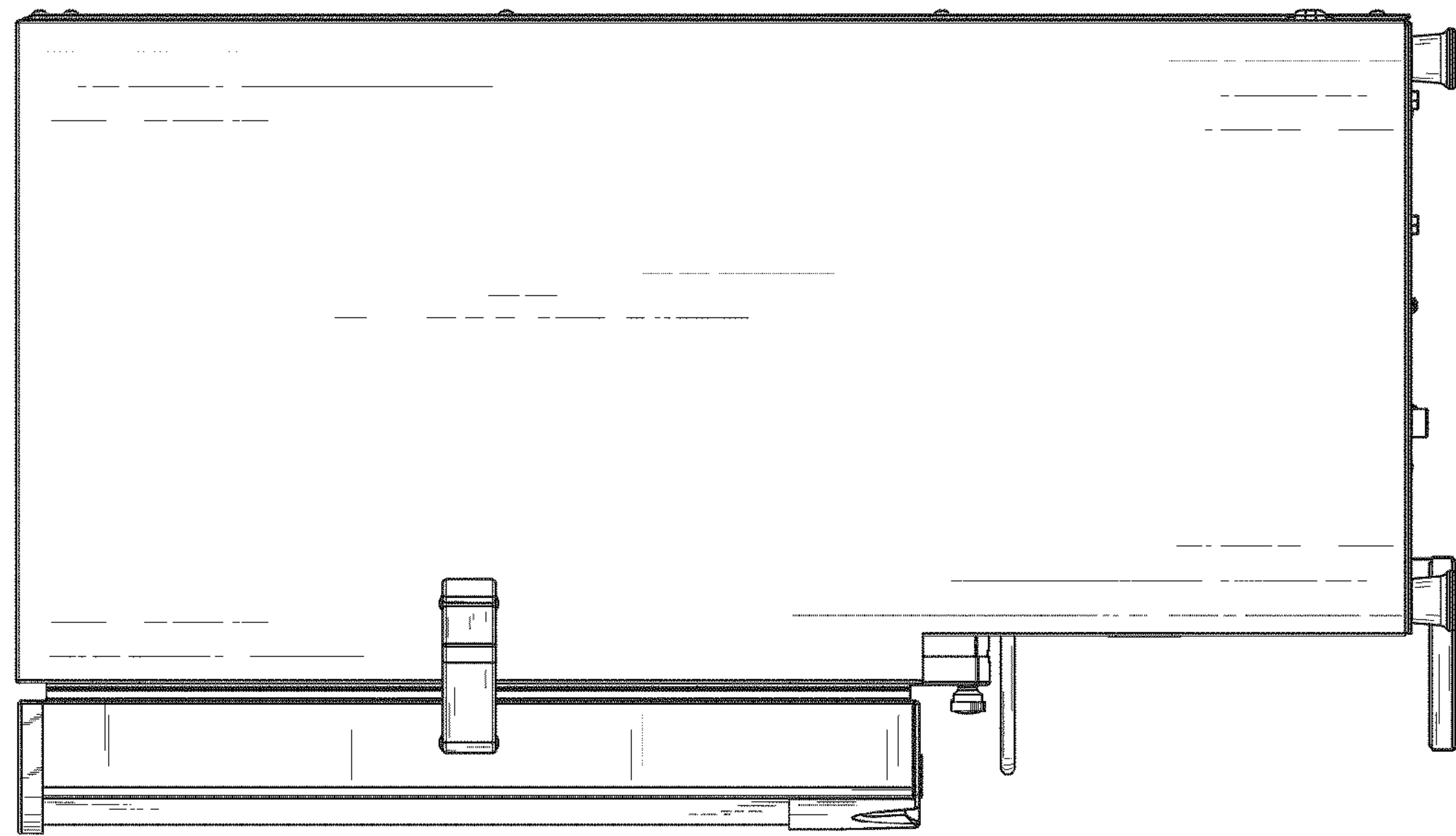

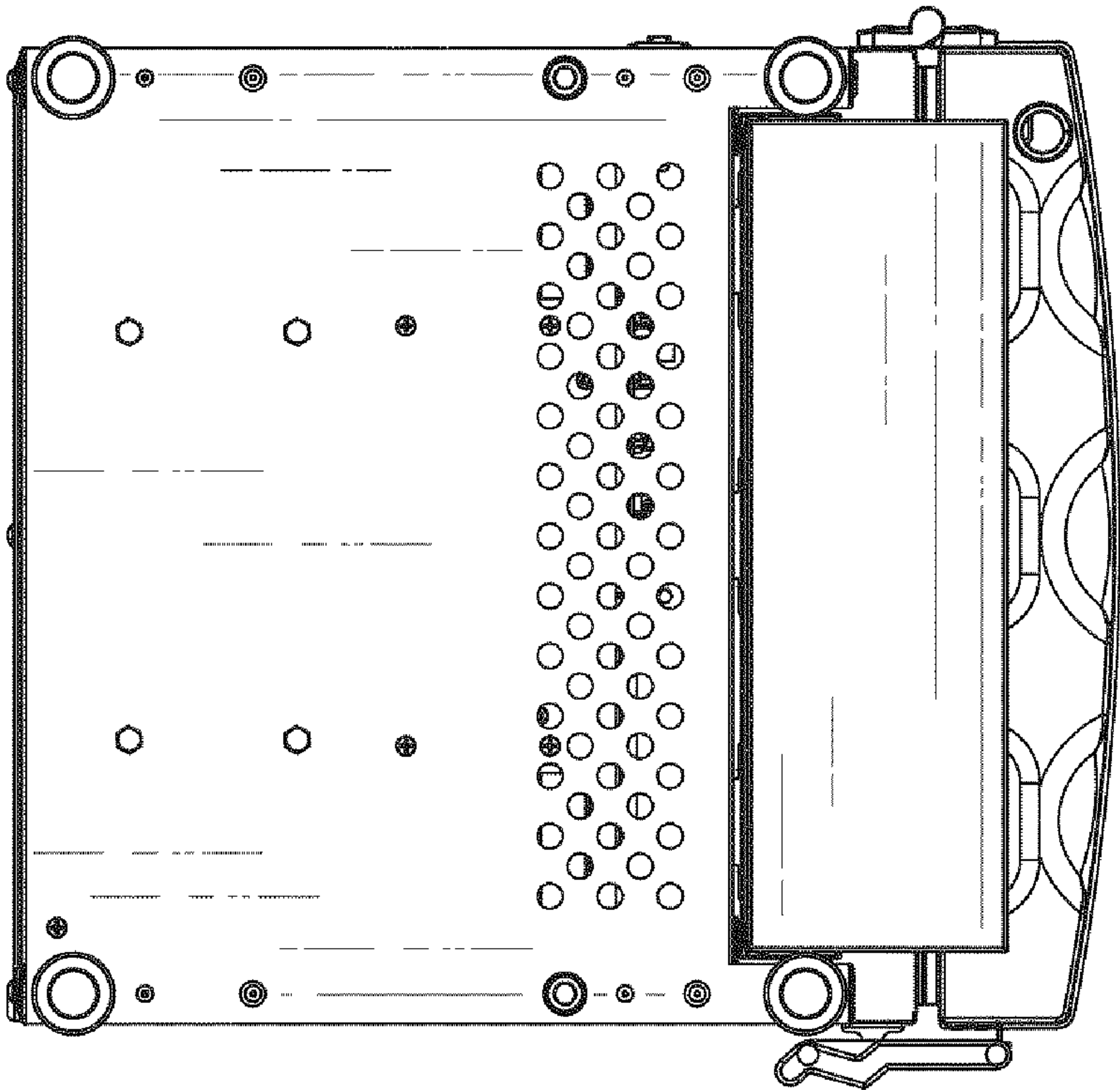

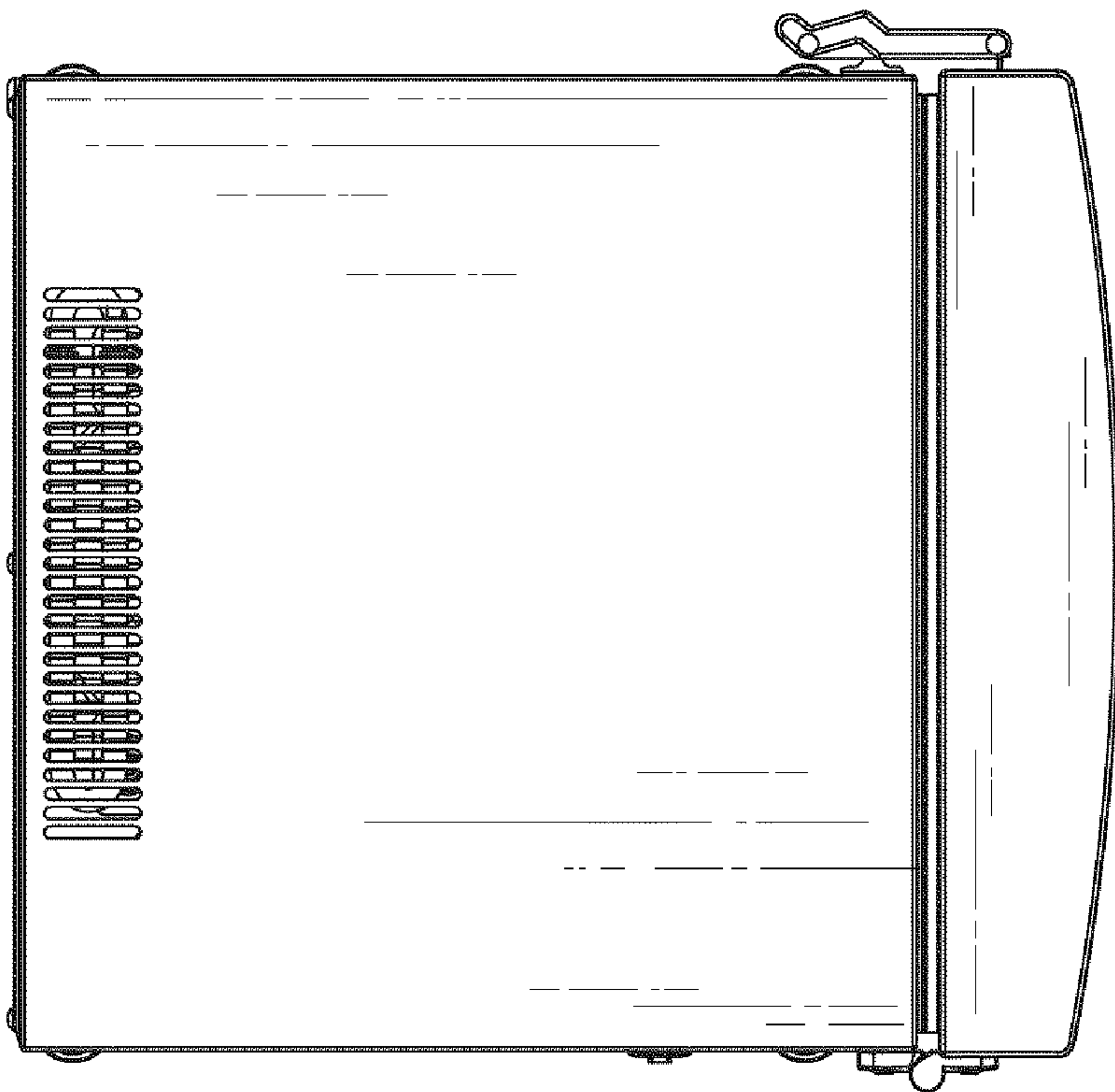
