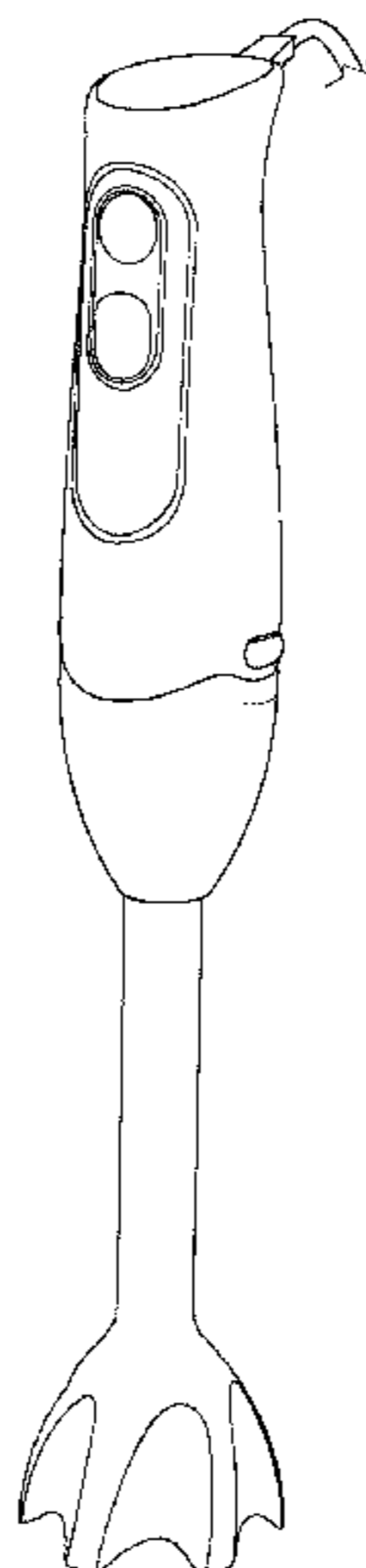
(57) **CLAIM**

The ornamental design for a hand blender, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand blender; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom view thereof. FIG. 8 is a perspective view of a handpiece of the hand blender; shown separately for completeness of illustration; FIG. 9 is a front view thereof; FIG. 10 is a right side view thereof; FIG. 11 is a rear view thereof; FIG. 12 is a left side view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom view thereof.

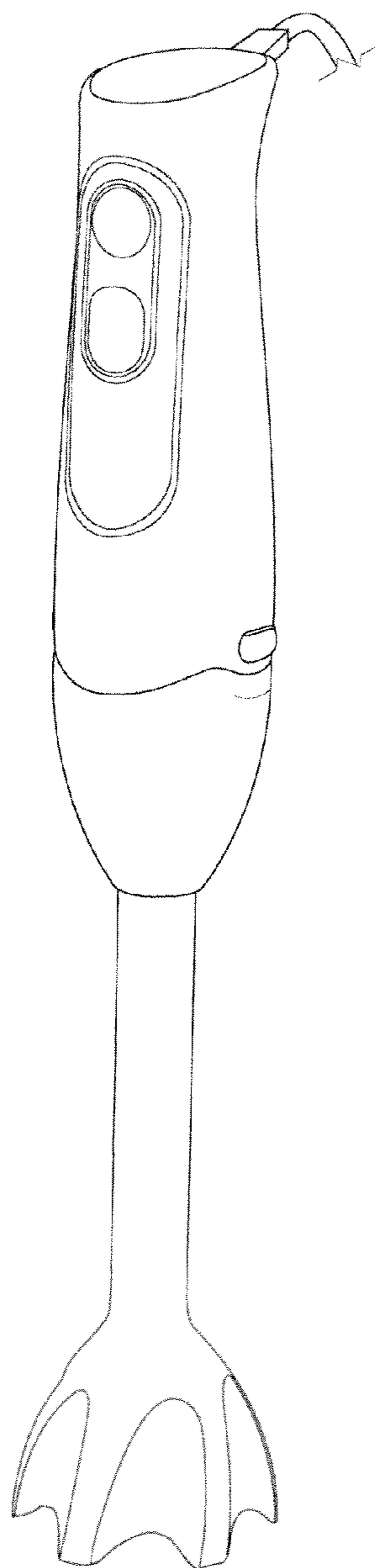

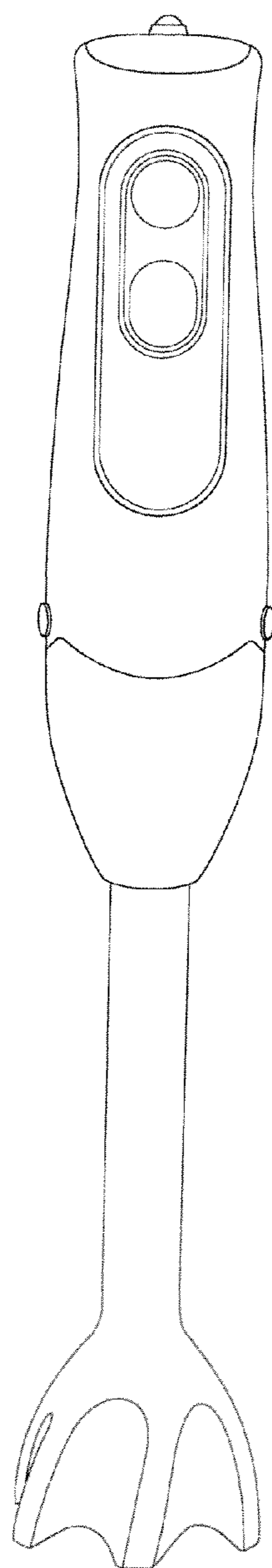

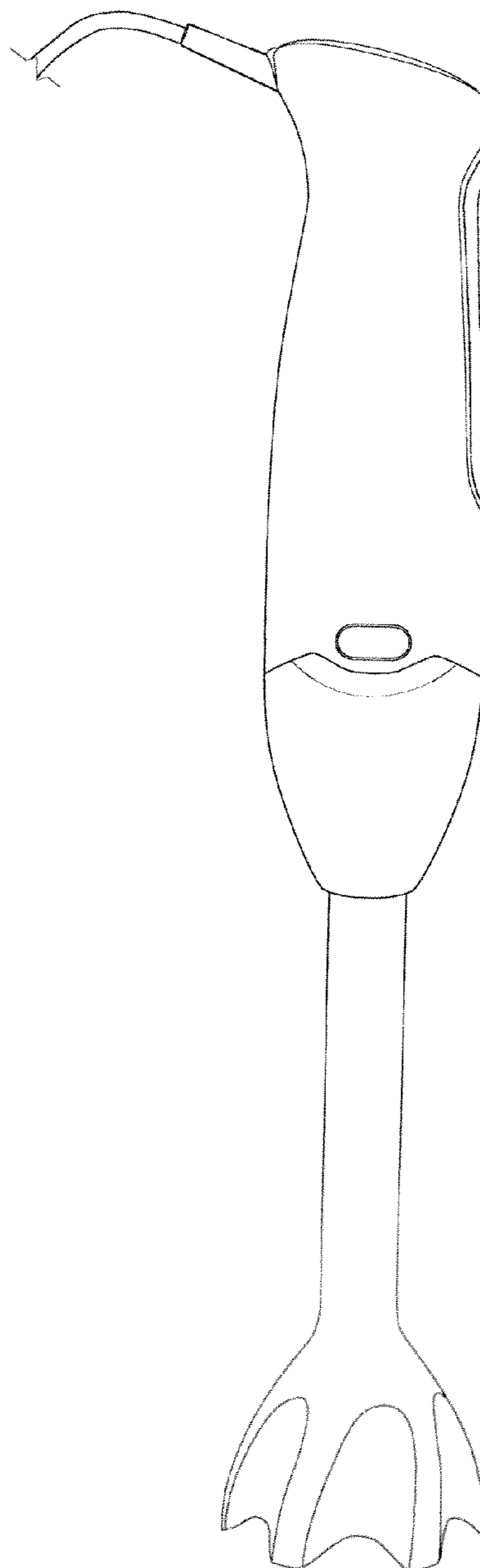

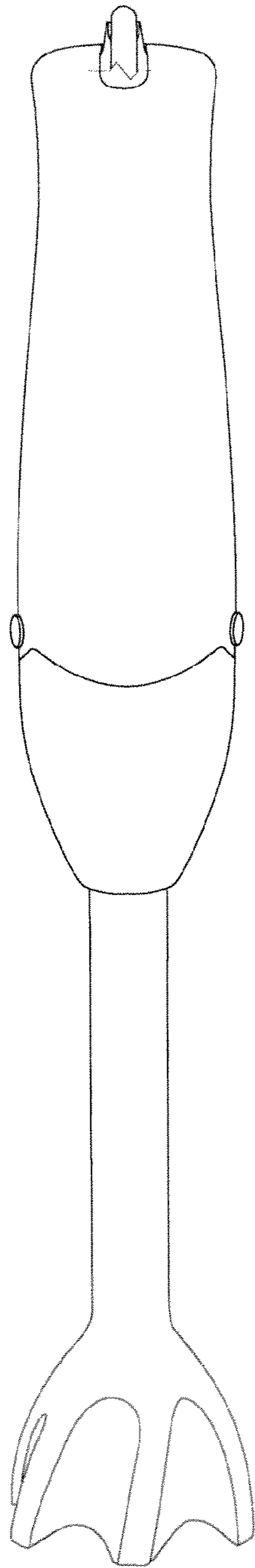

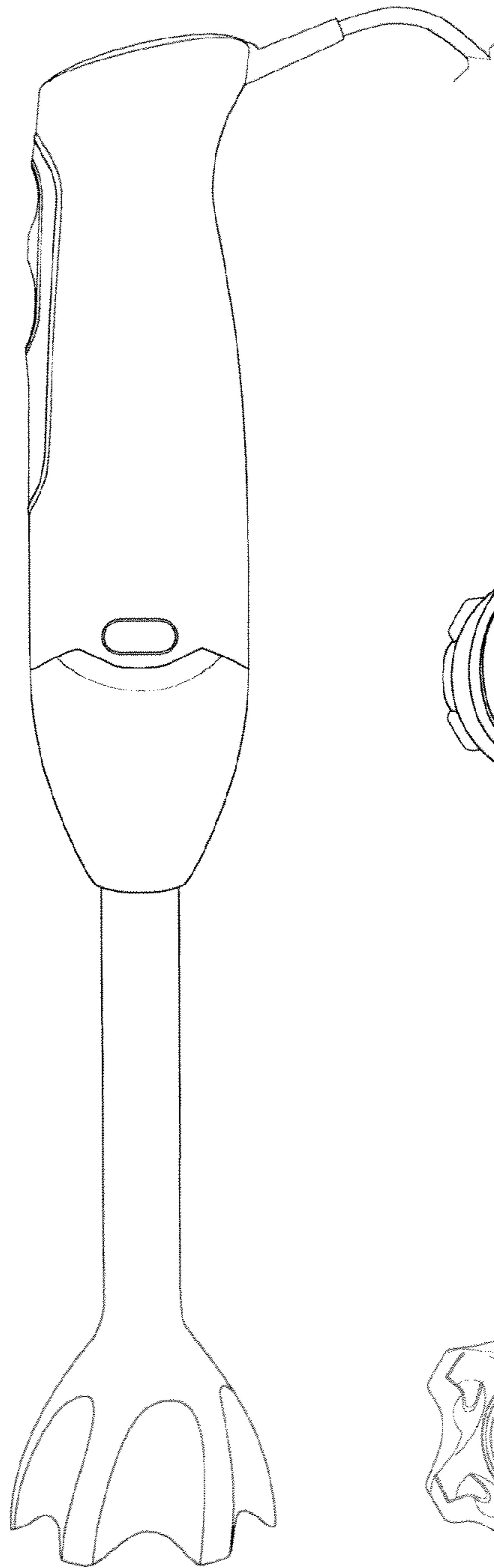

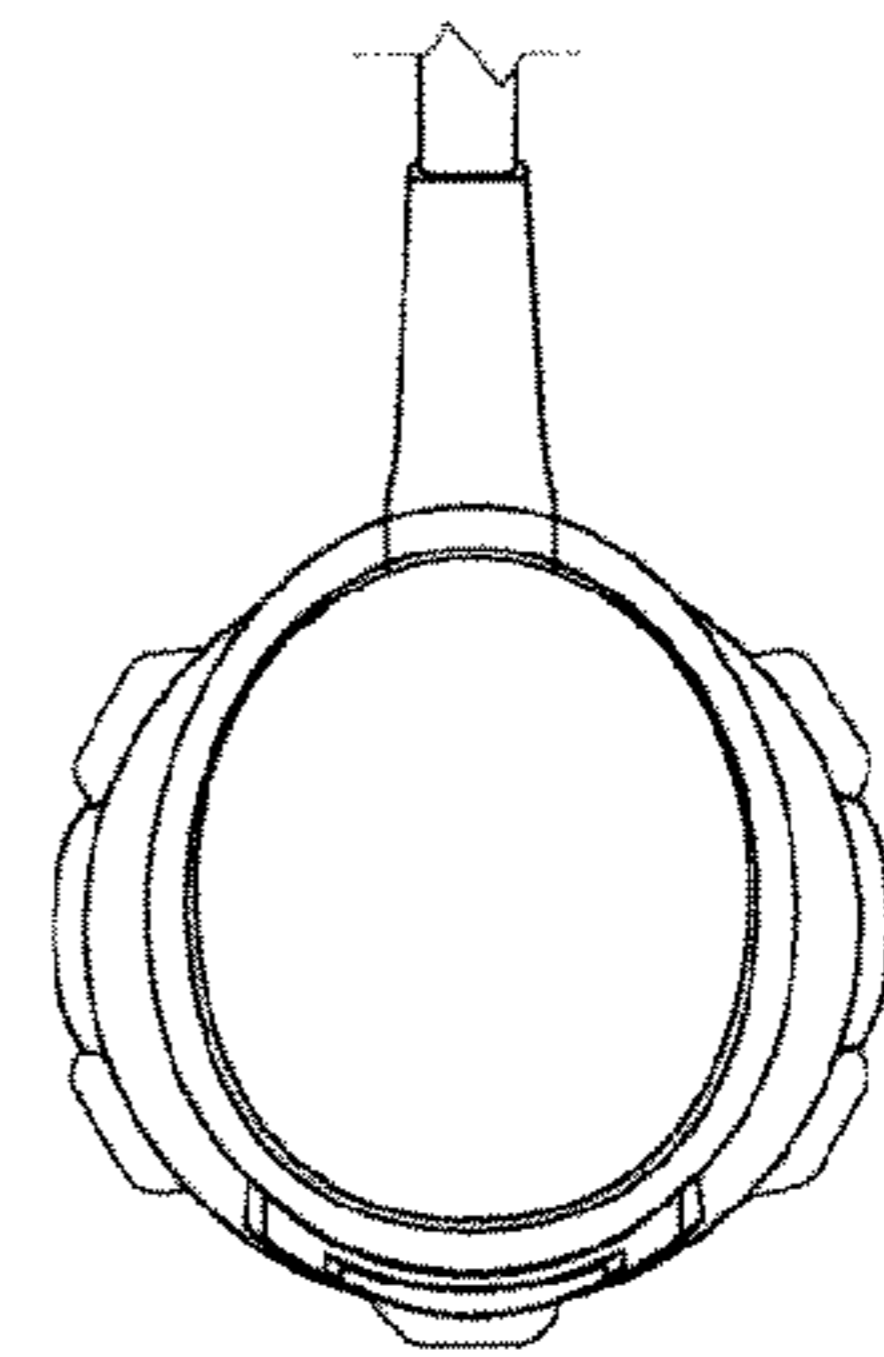

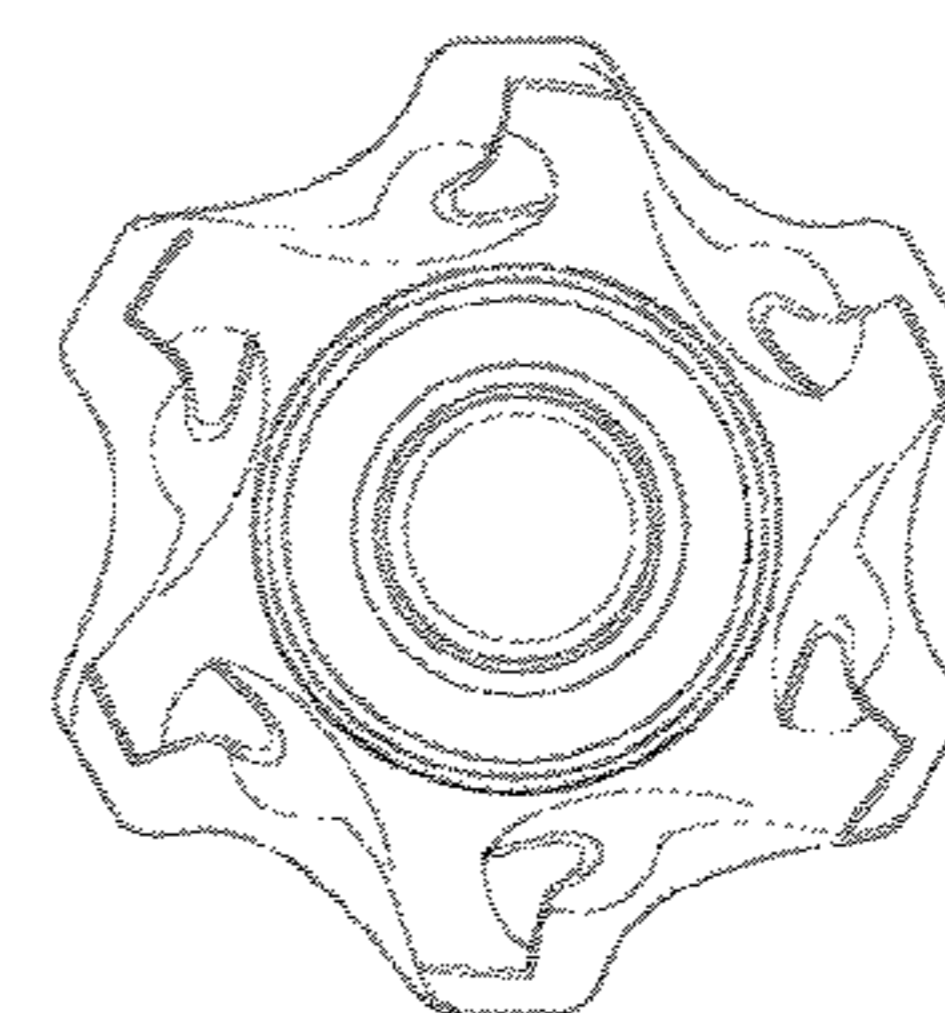

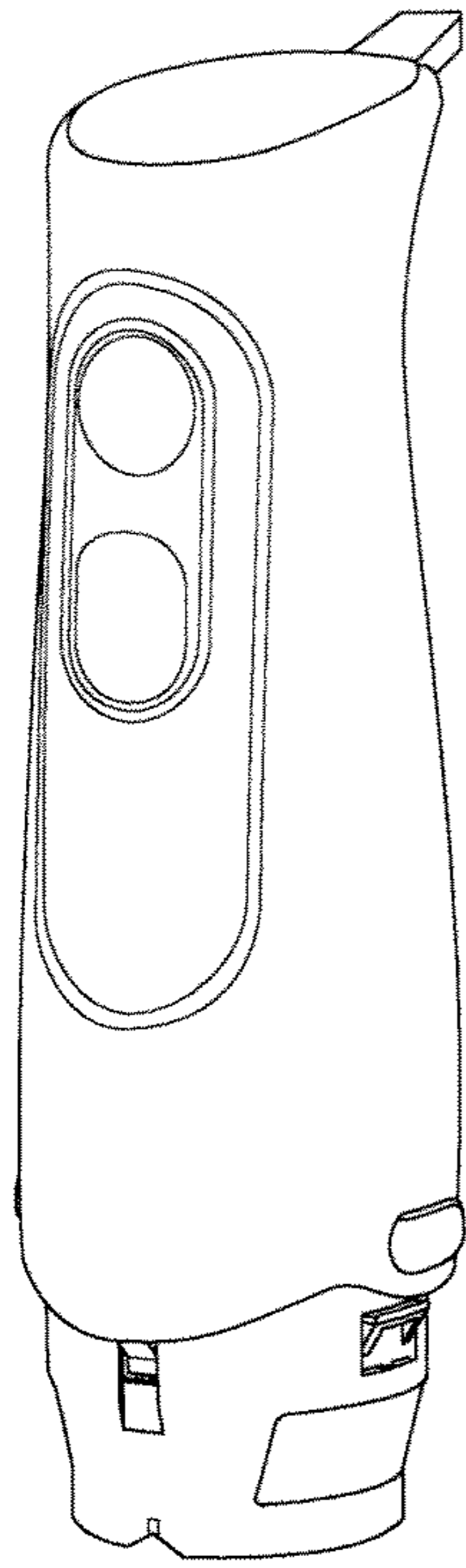

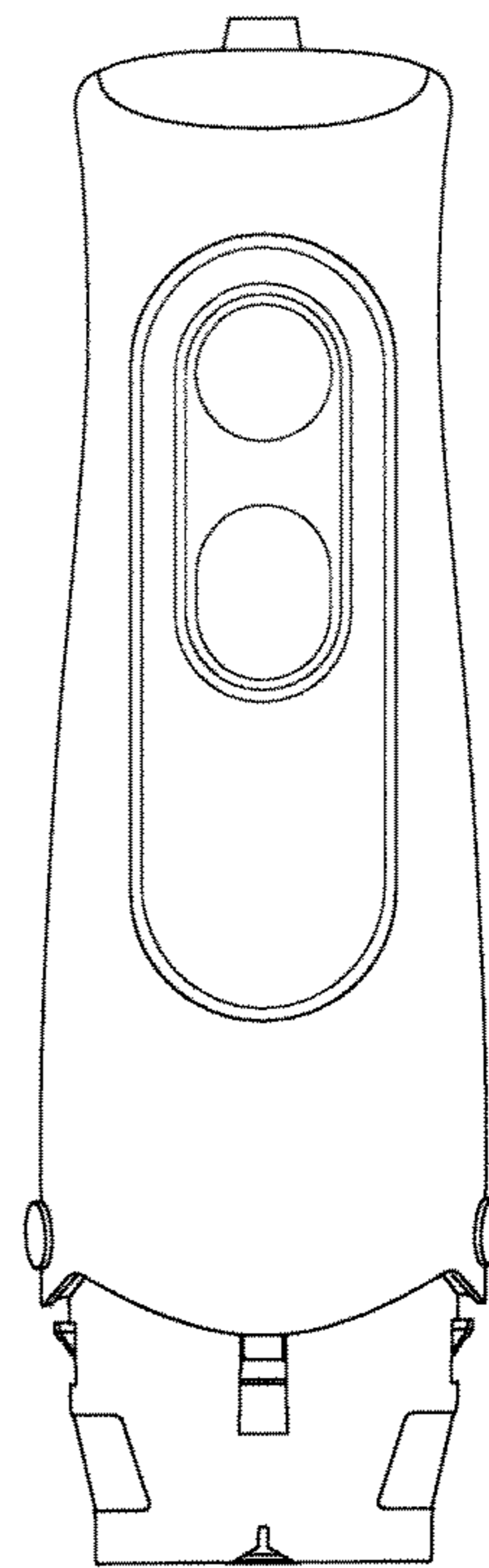

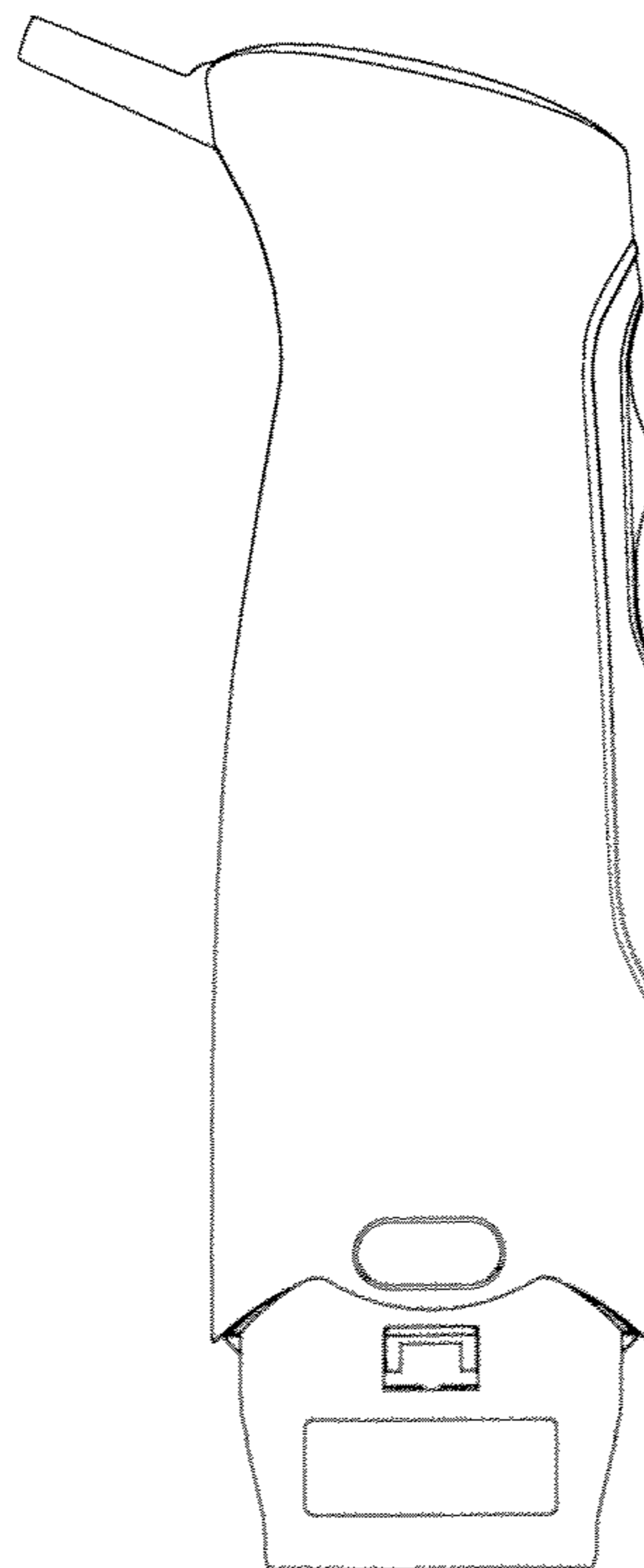

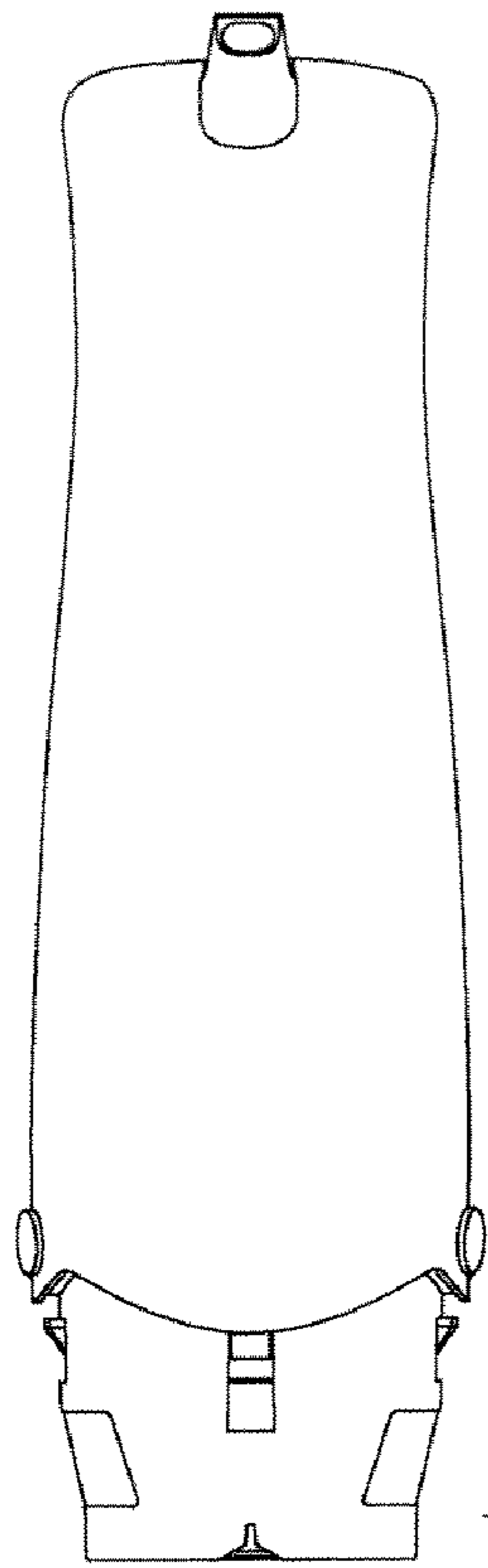

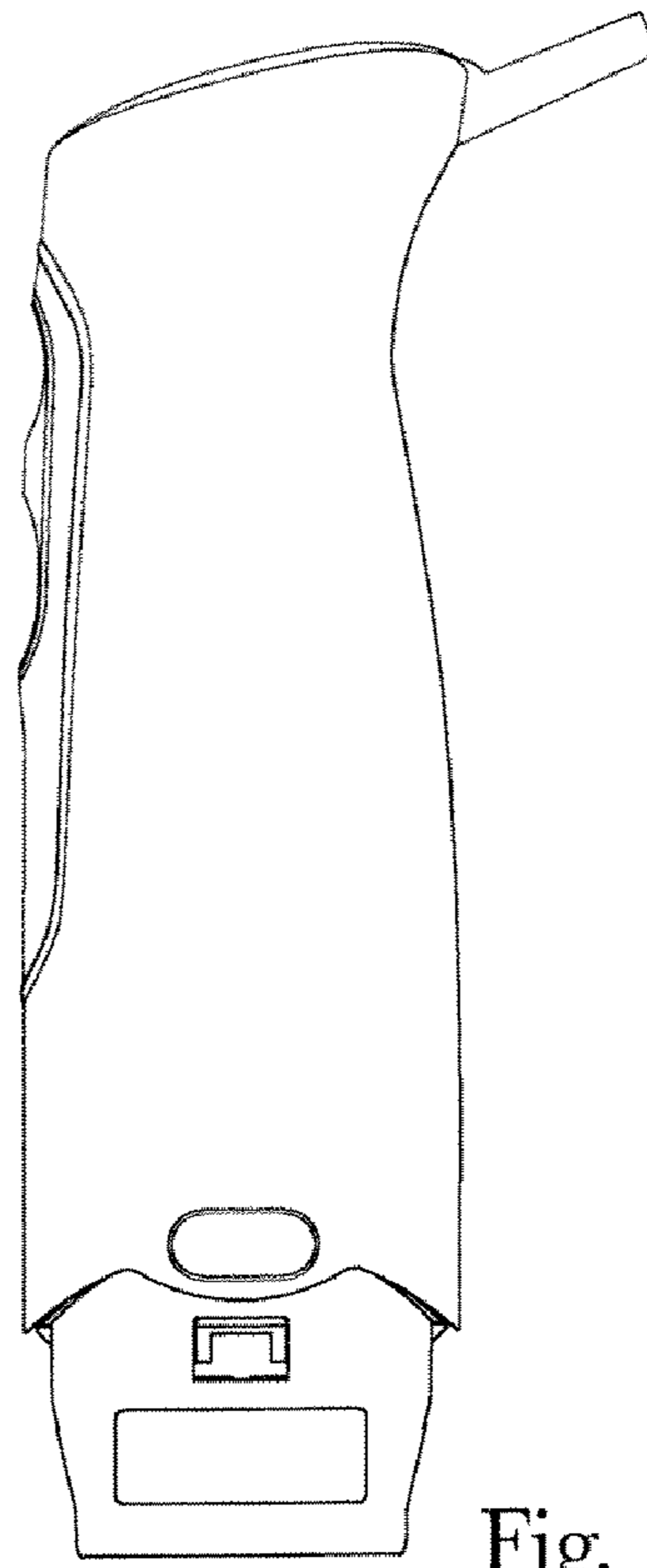

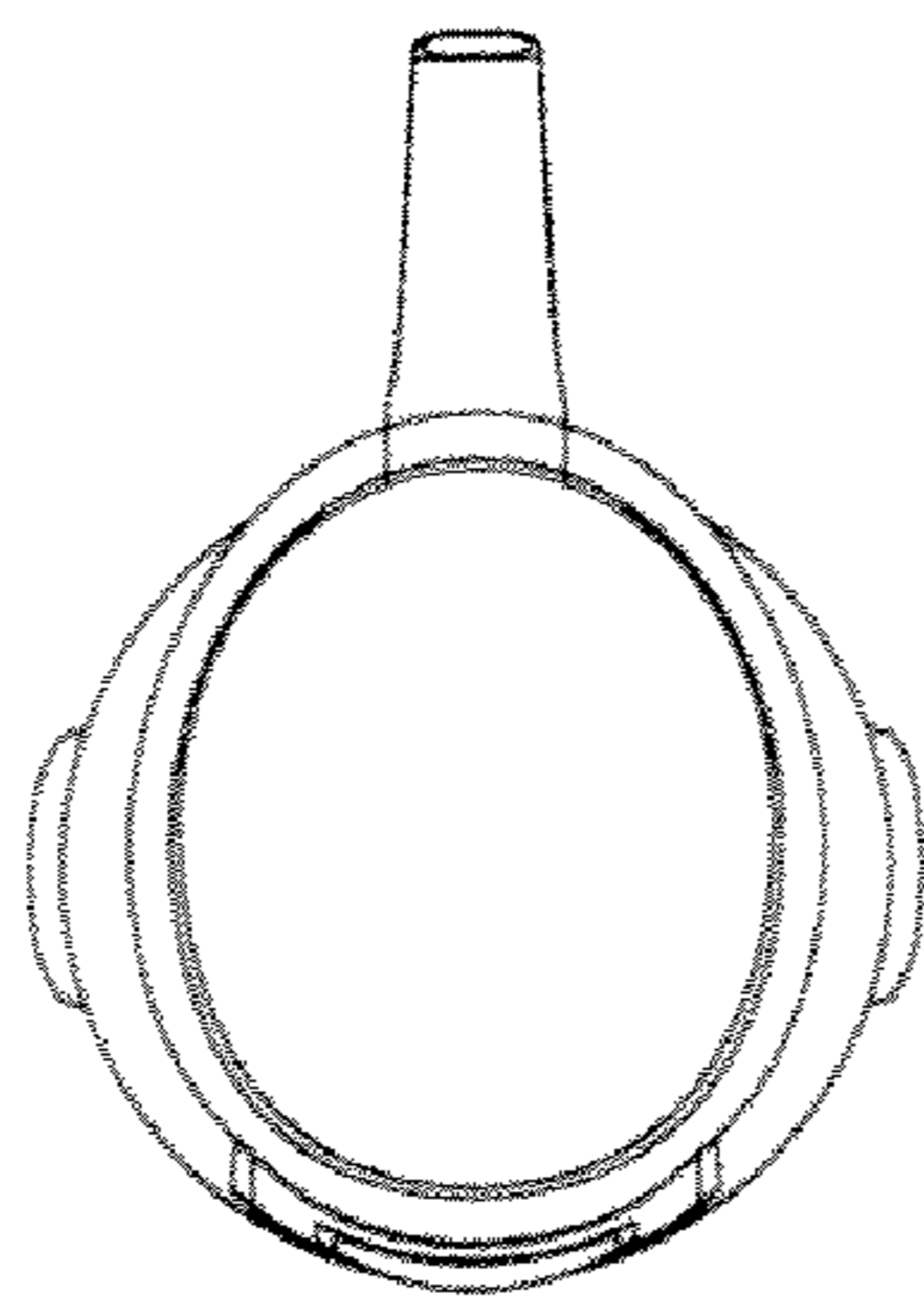

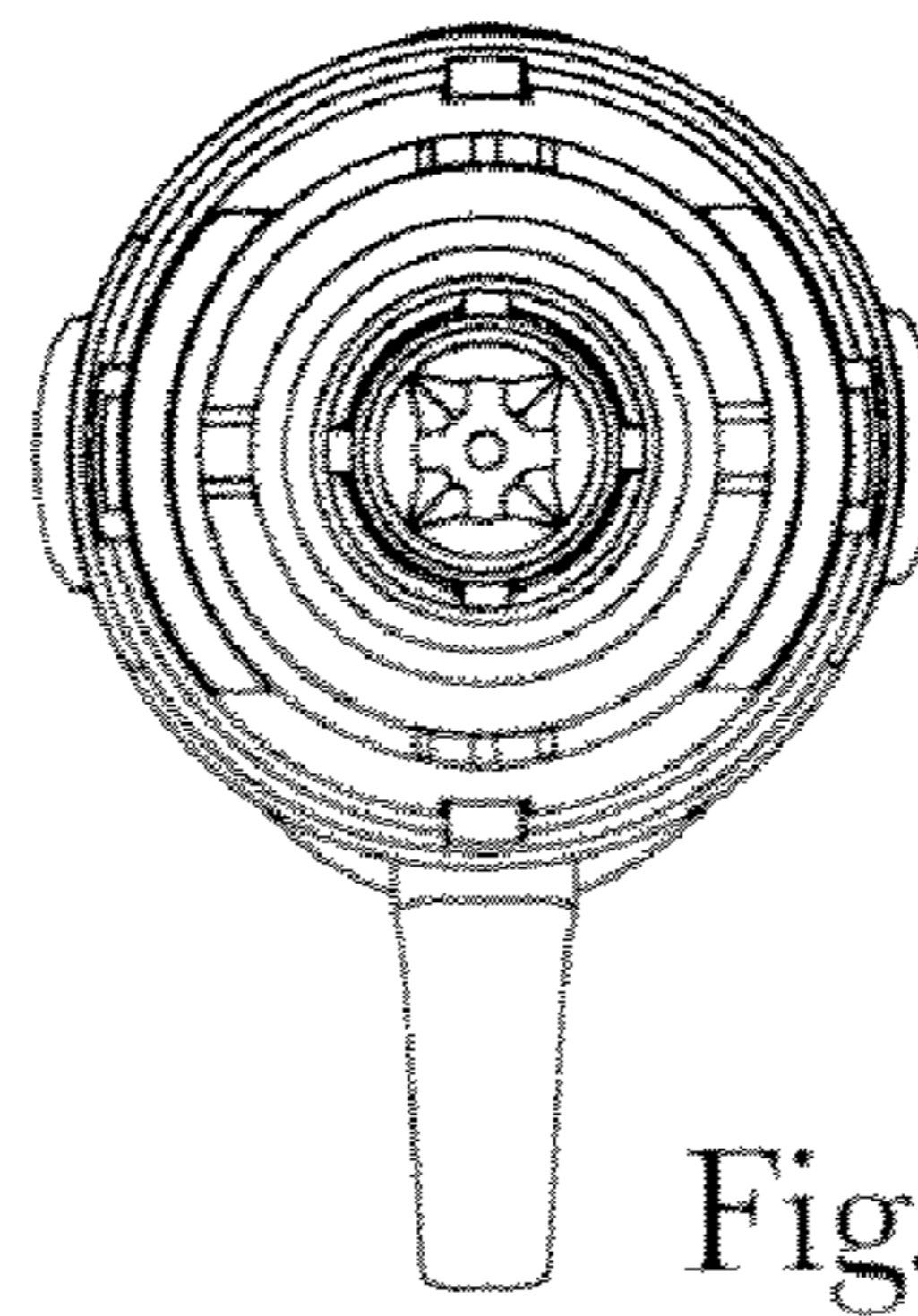
