**DESCRIPTION**

FIG. 1 is a perspective view of a smoking device showing our new design.

FIG. 3 is a bottom plan view of the design;

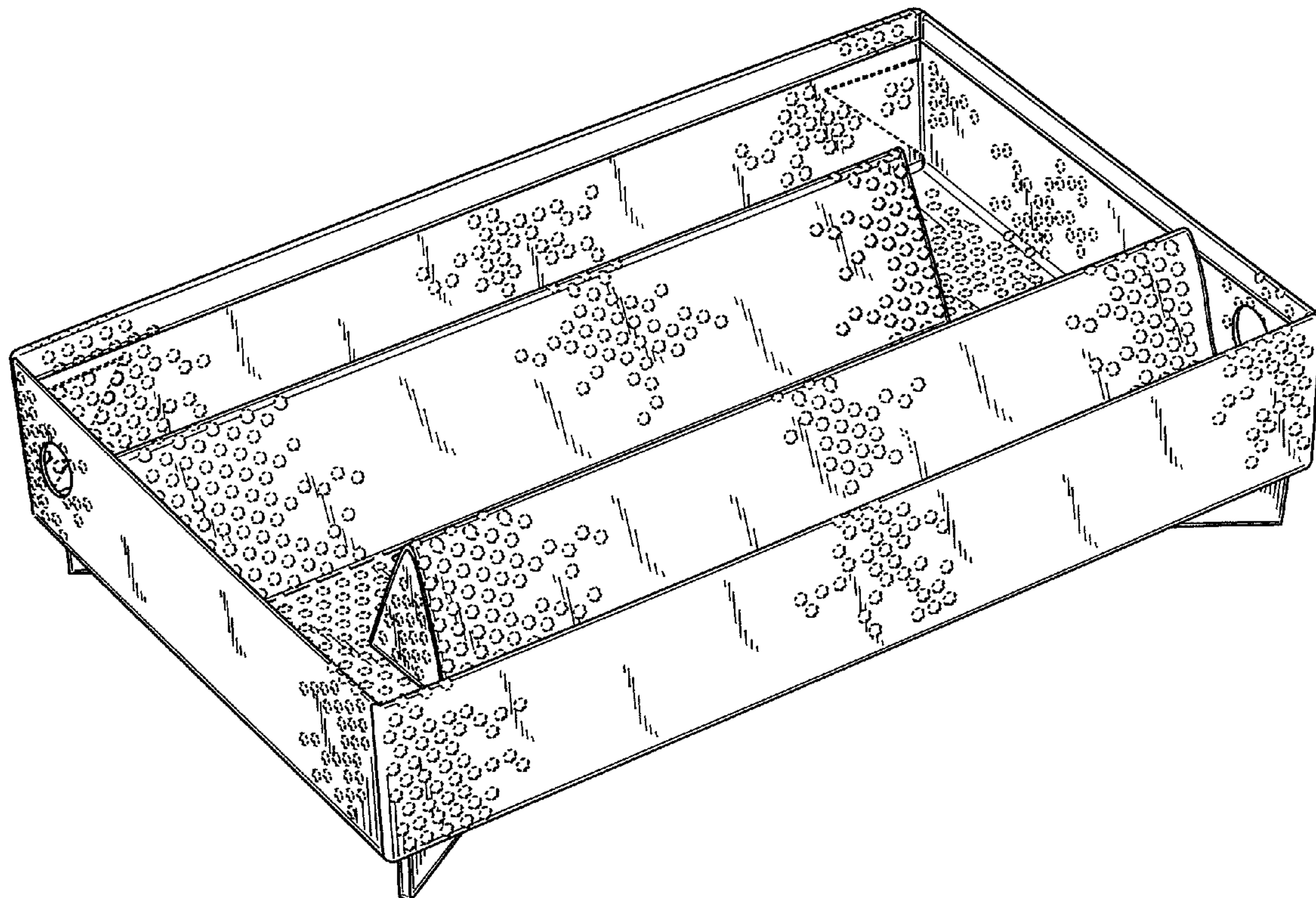
FIG. 4 is a right side elevational view of the design;

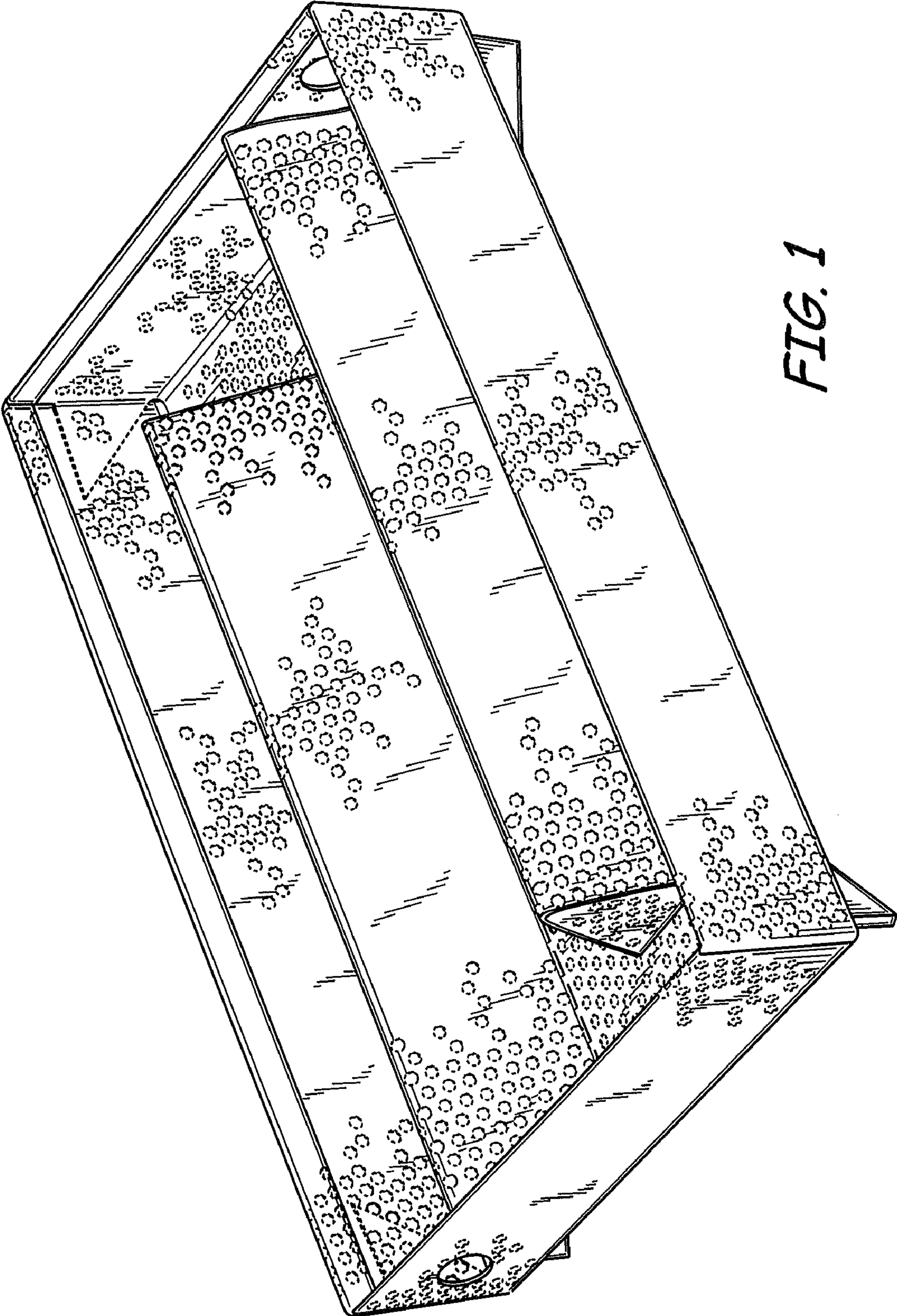

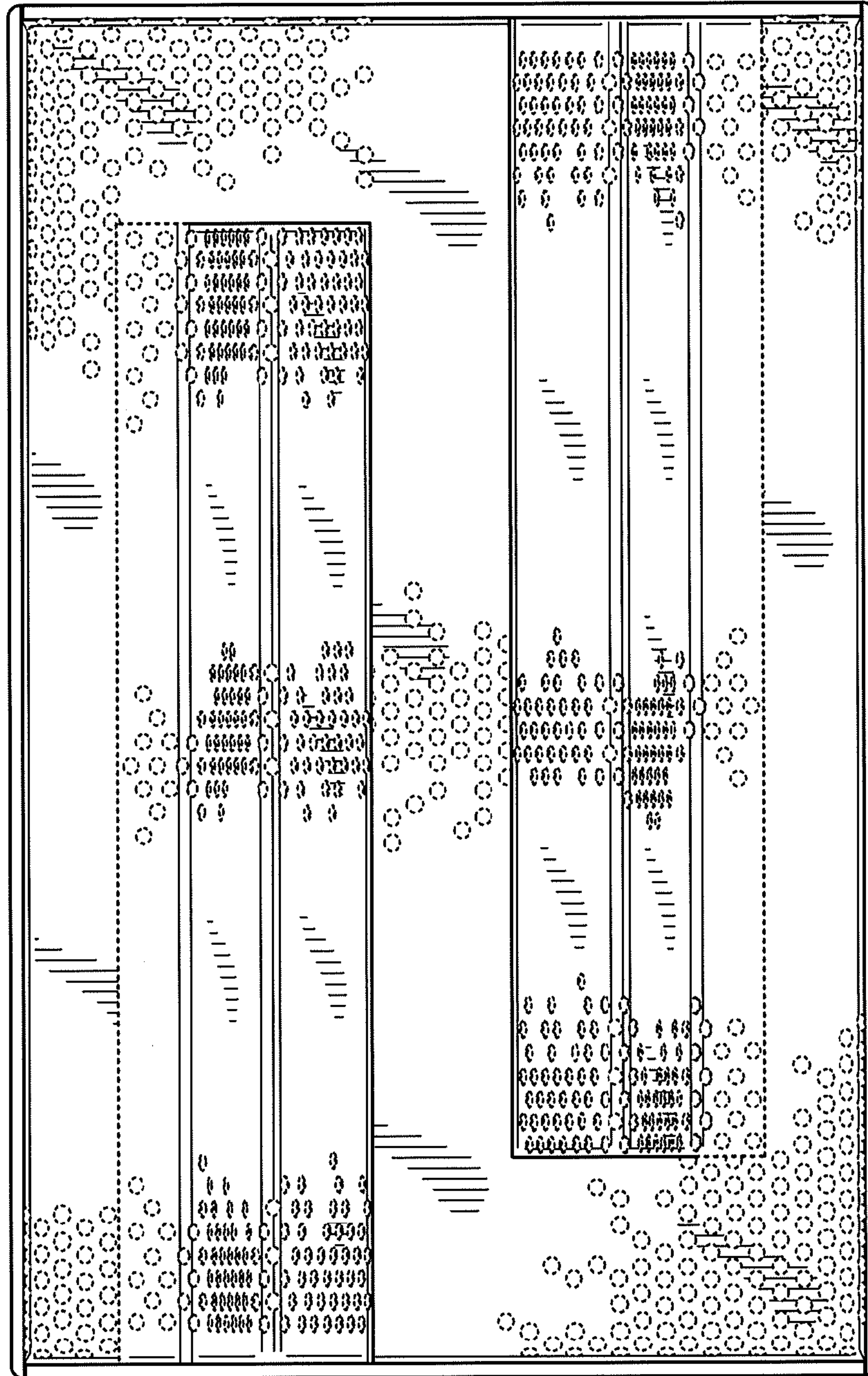
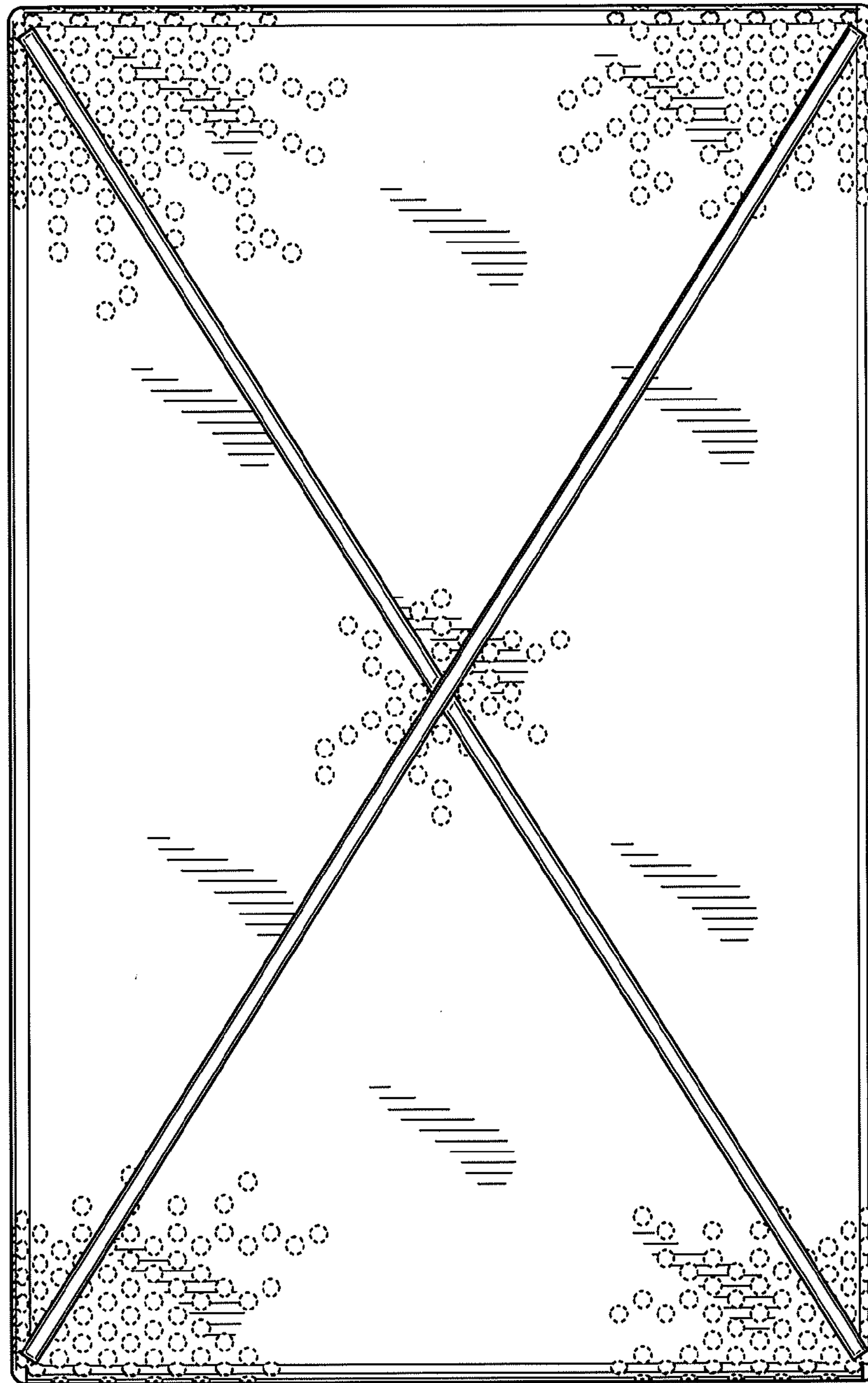

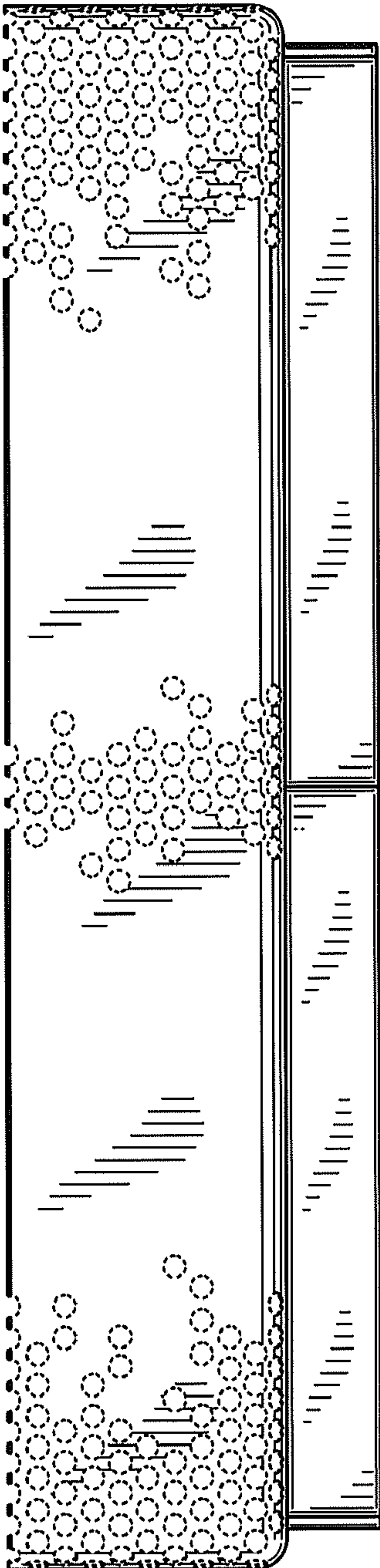

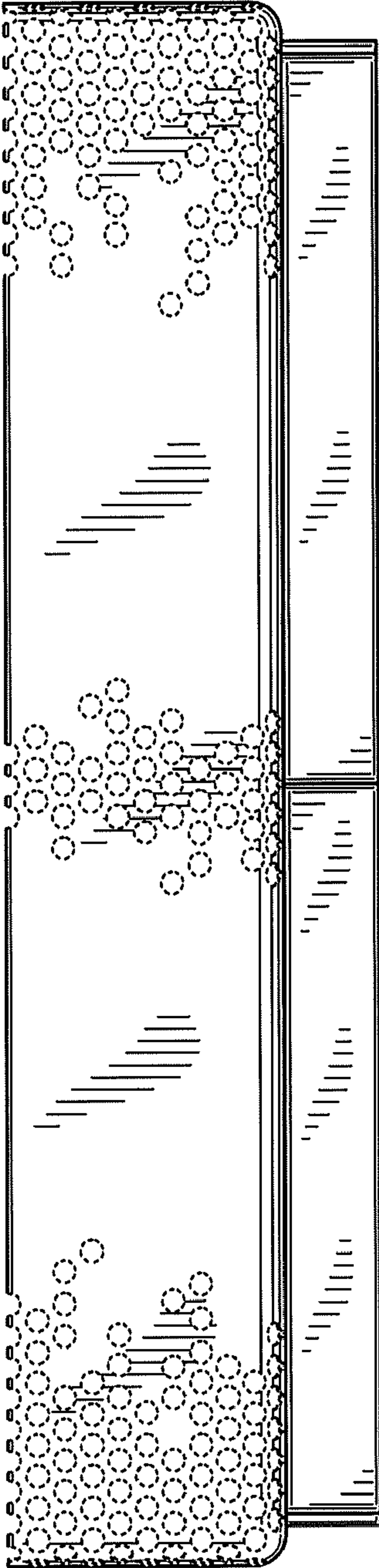

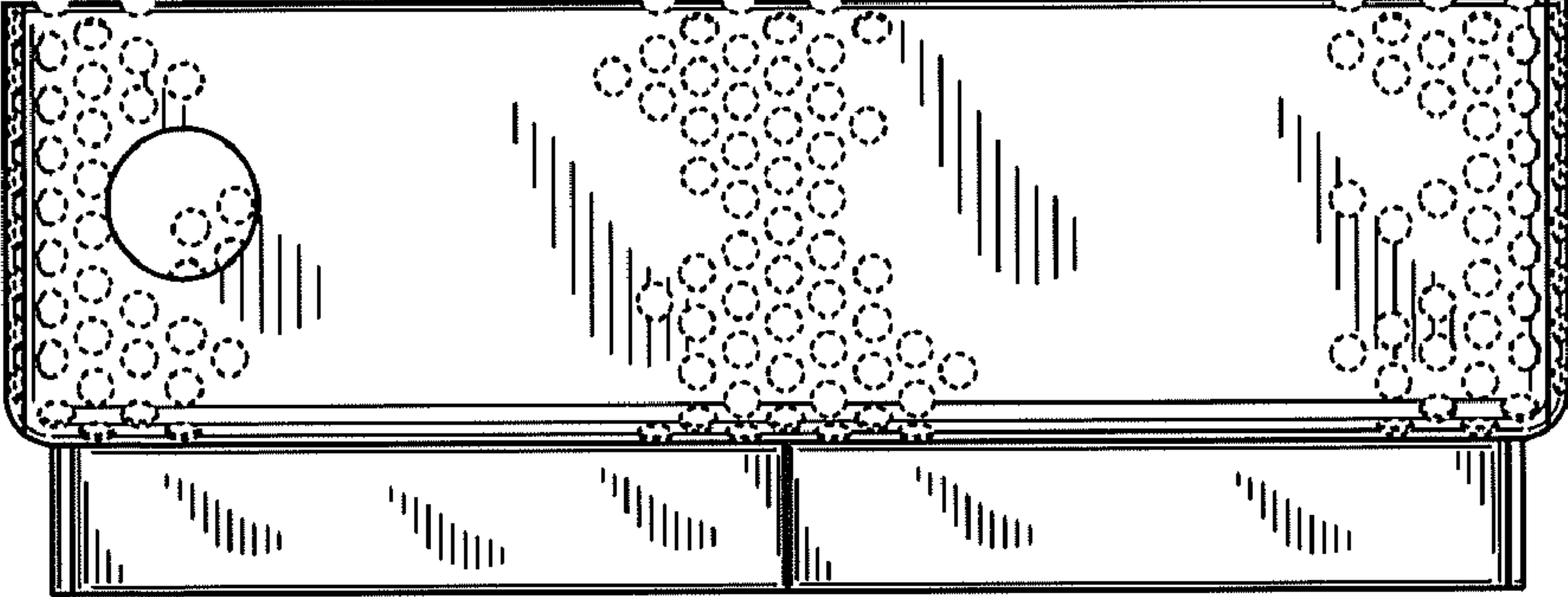

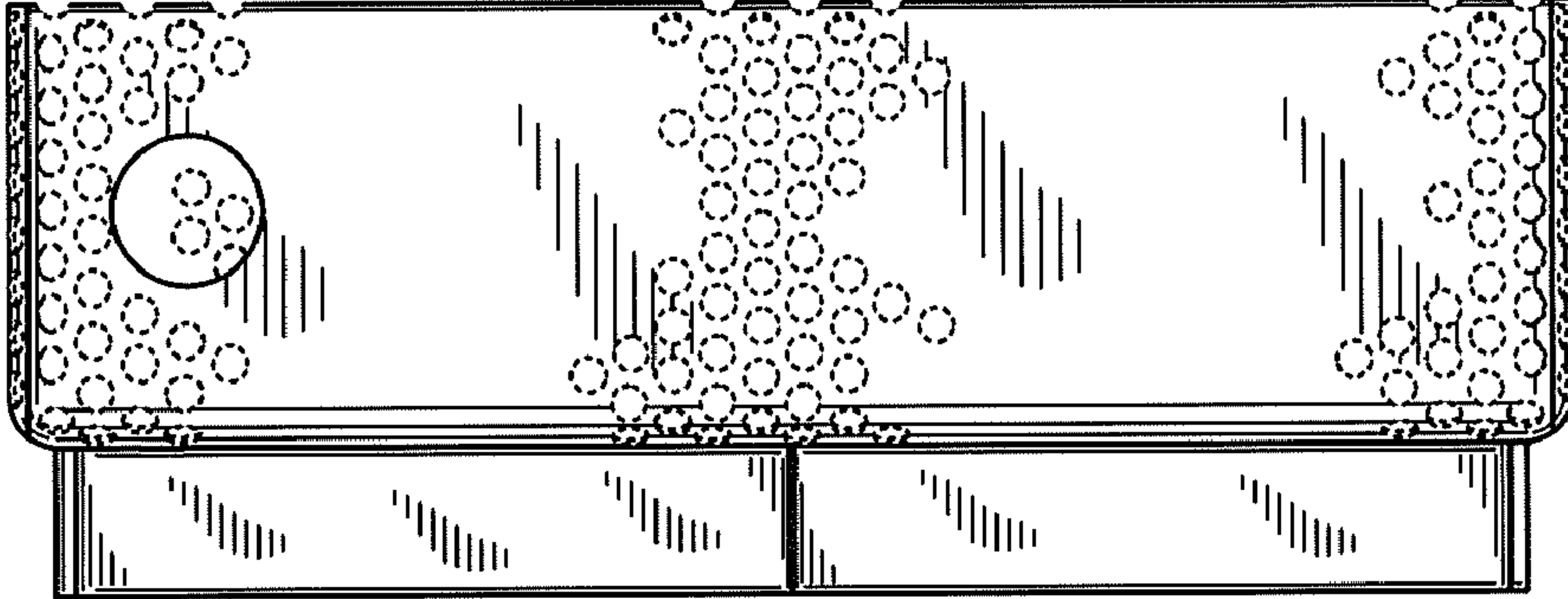
