FIG. 1 is a perspective view of a beverage container showing my new design;

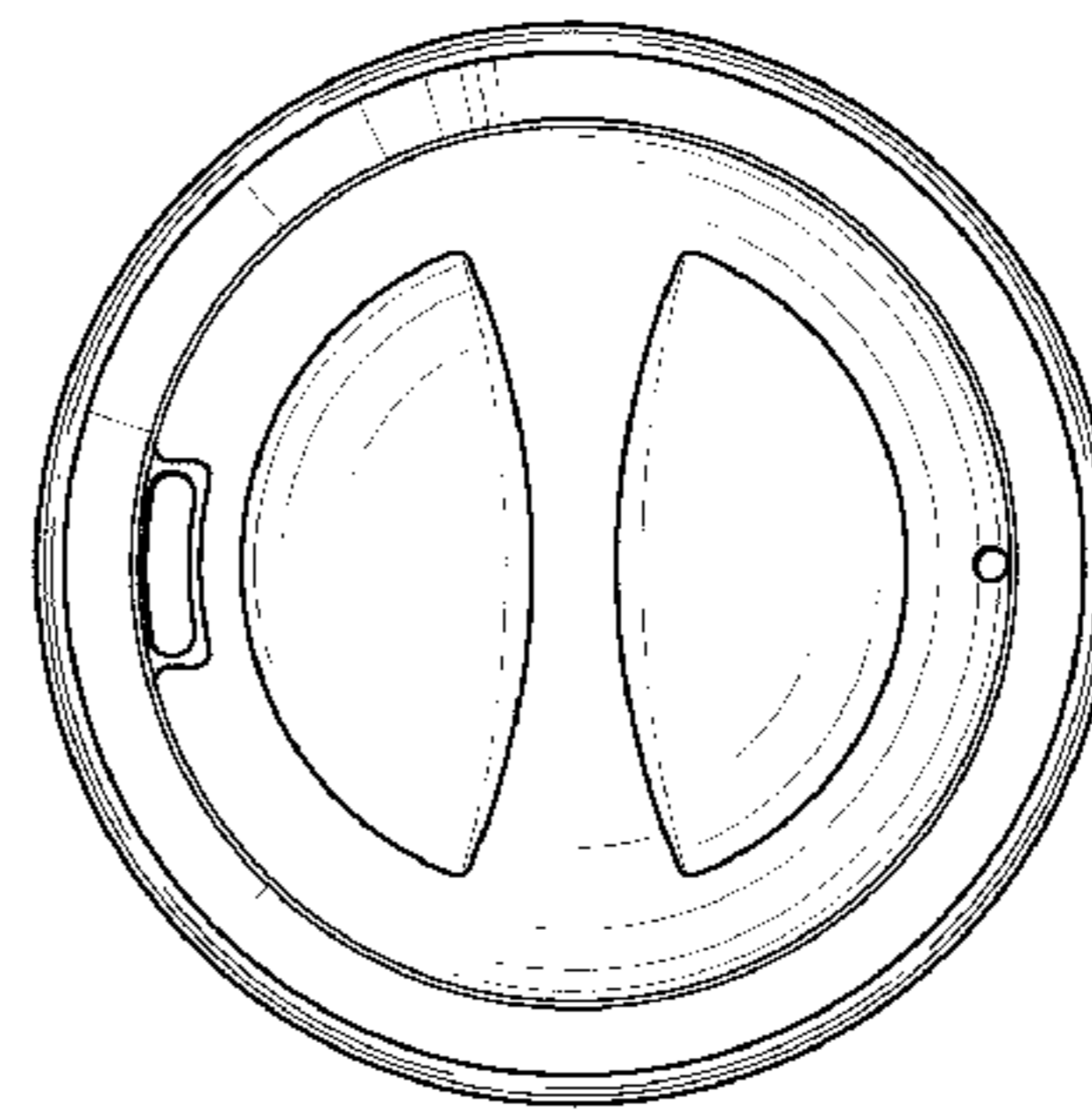
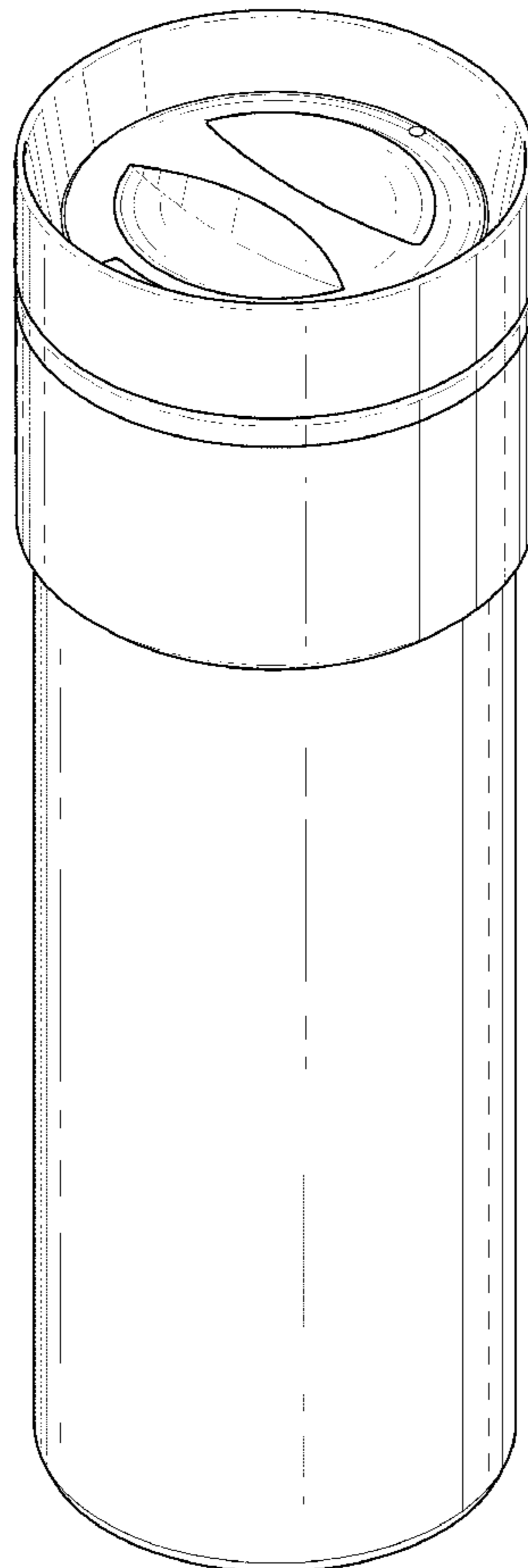
FIG. 2 is a front view thereof, with all sides being the same;

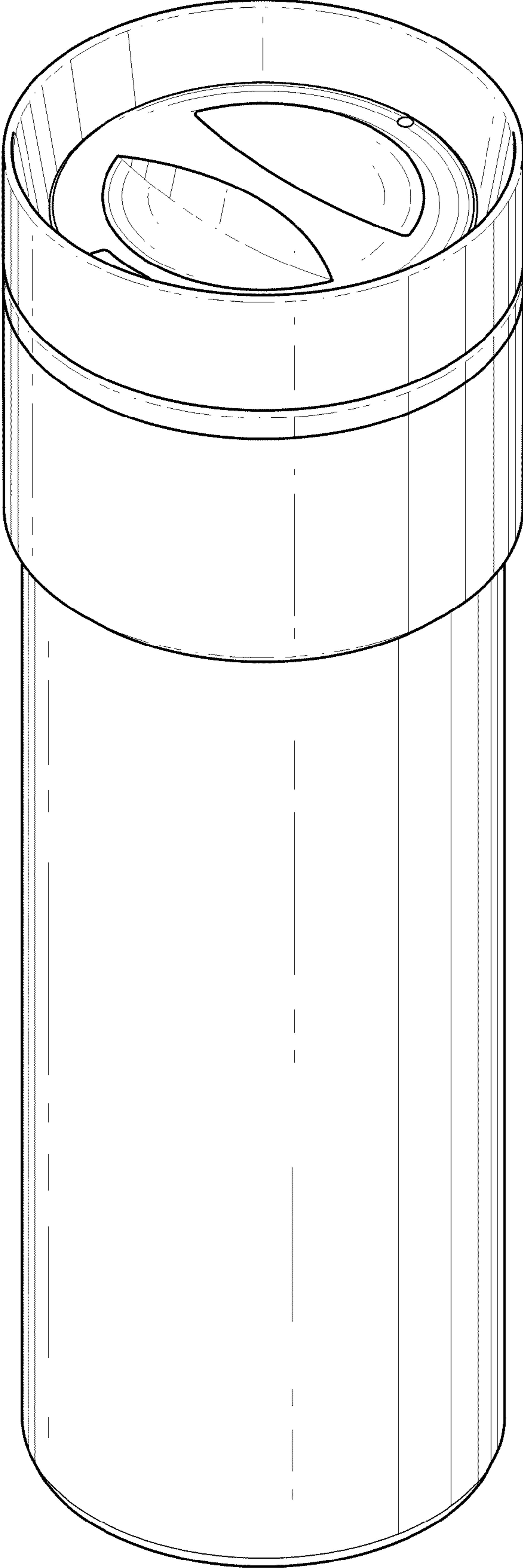

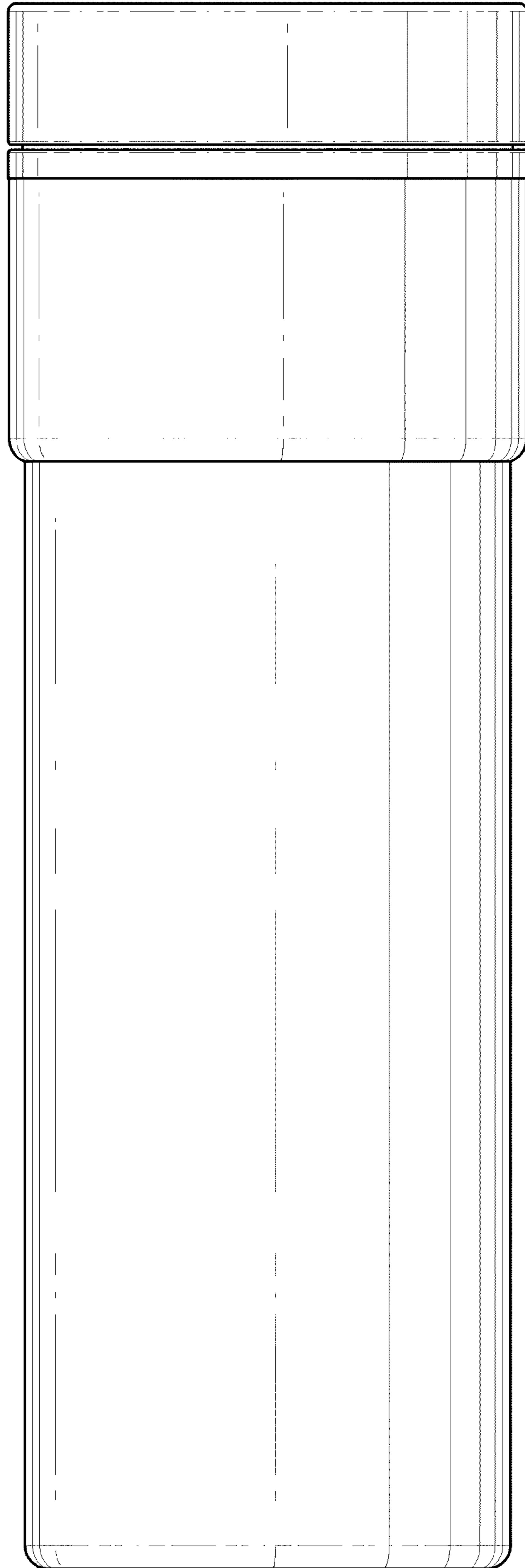

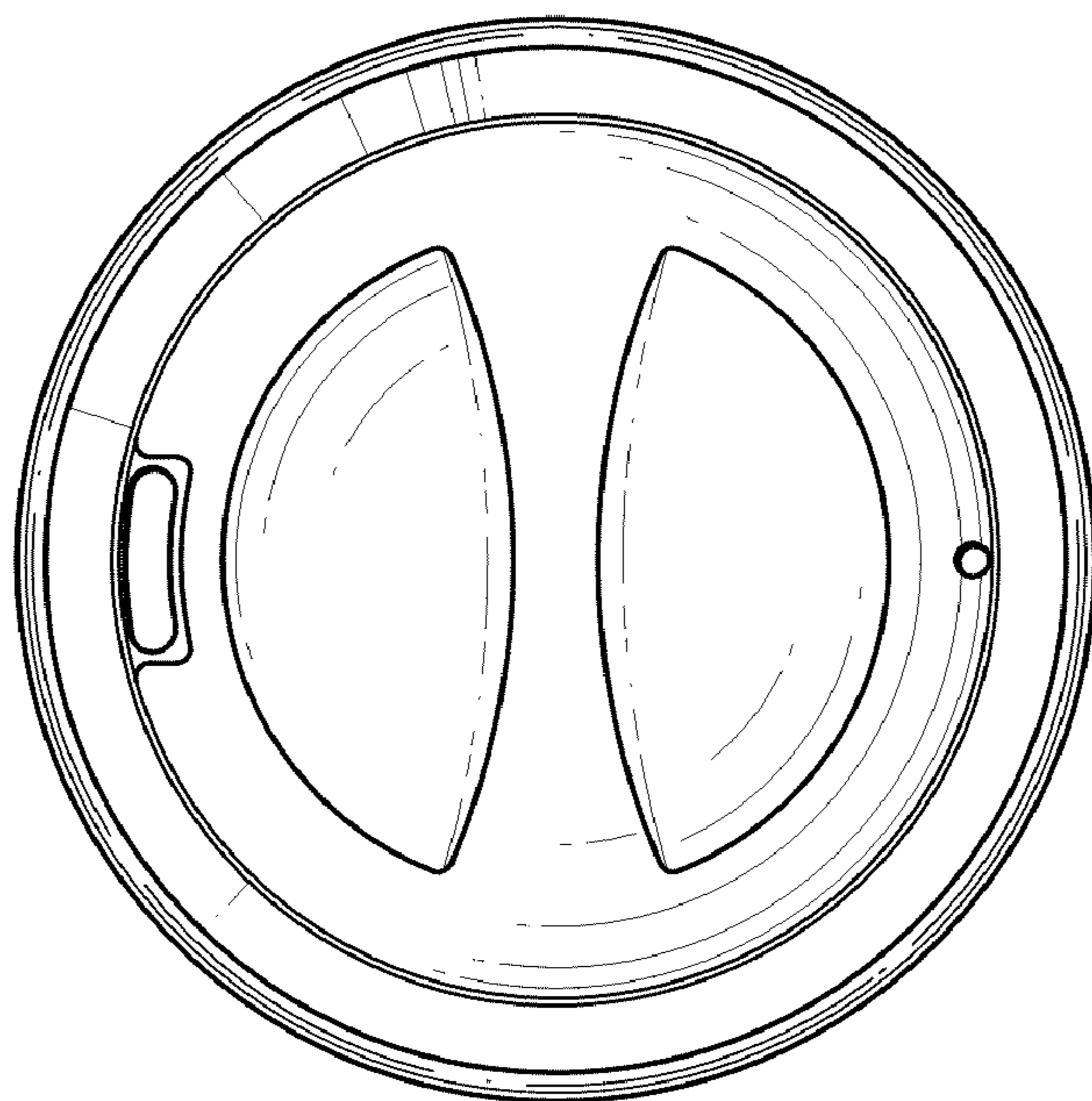

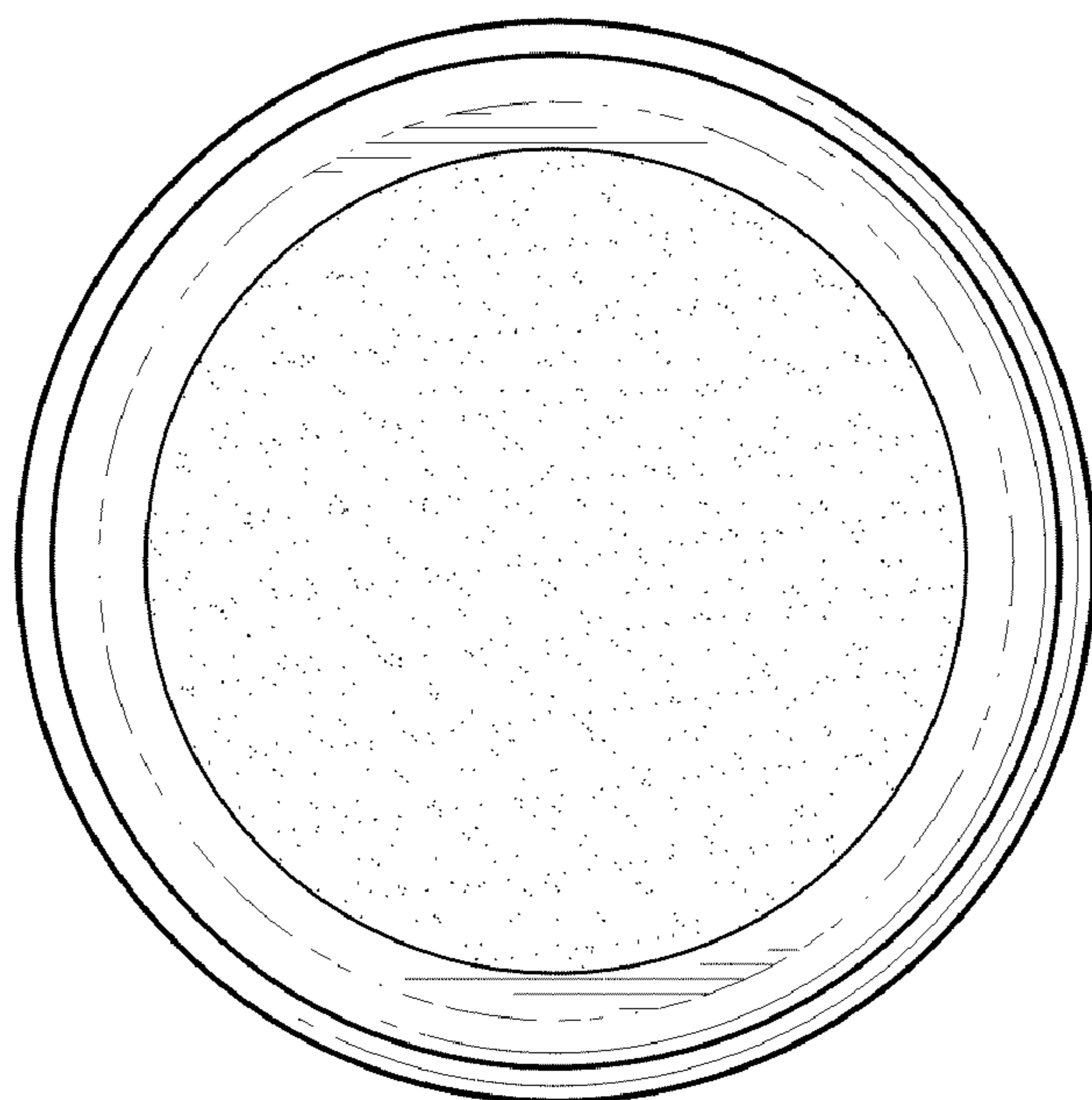
