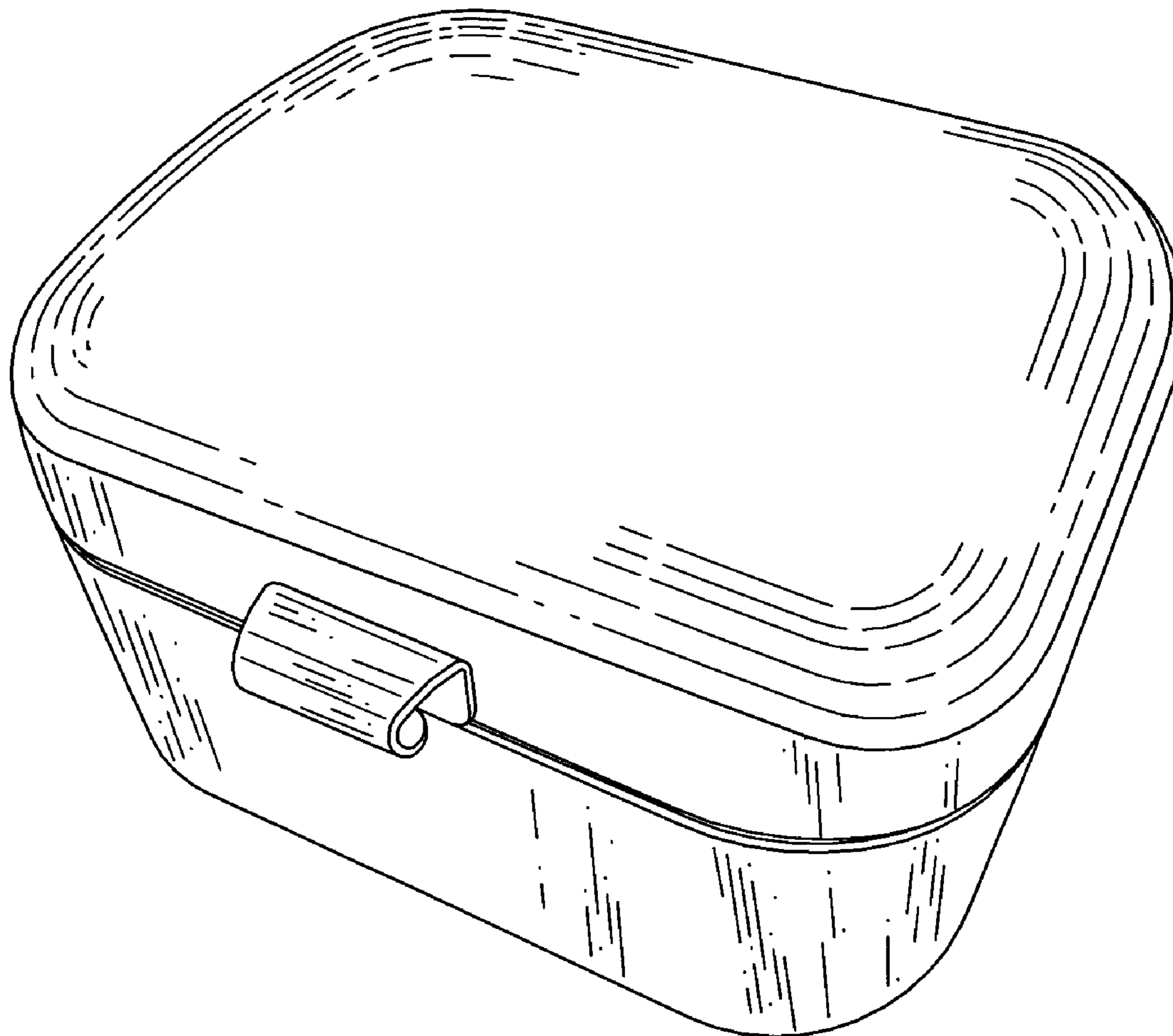
(57) **CLAIM**

The ornamental design for a bread box, as shown and described.

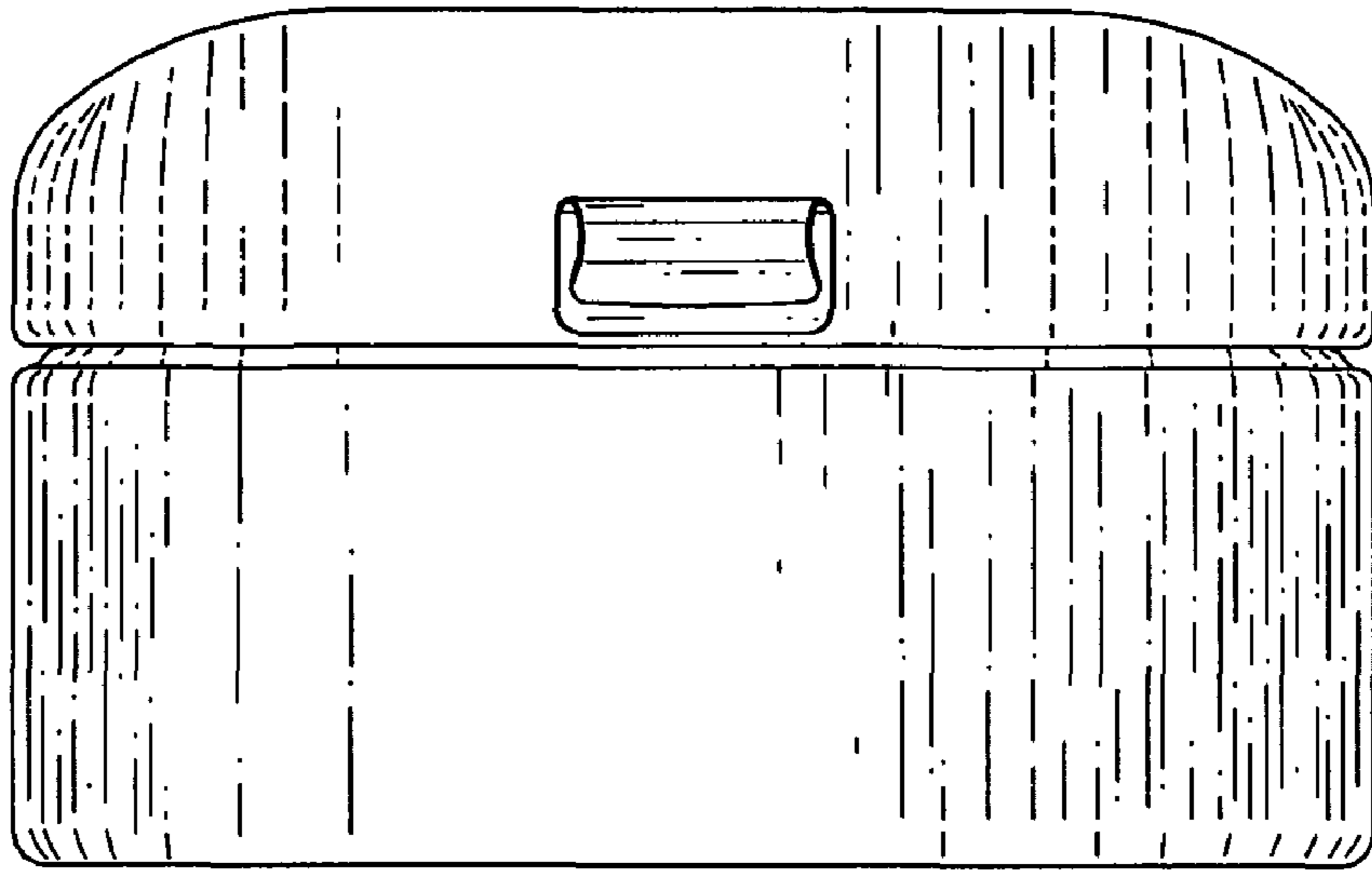
**DESCRIPTION**

FIG. 7 is a top and front perspective view thereof.

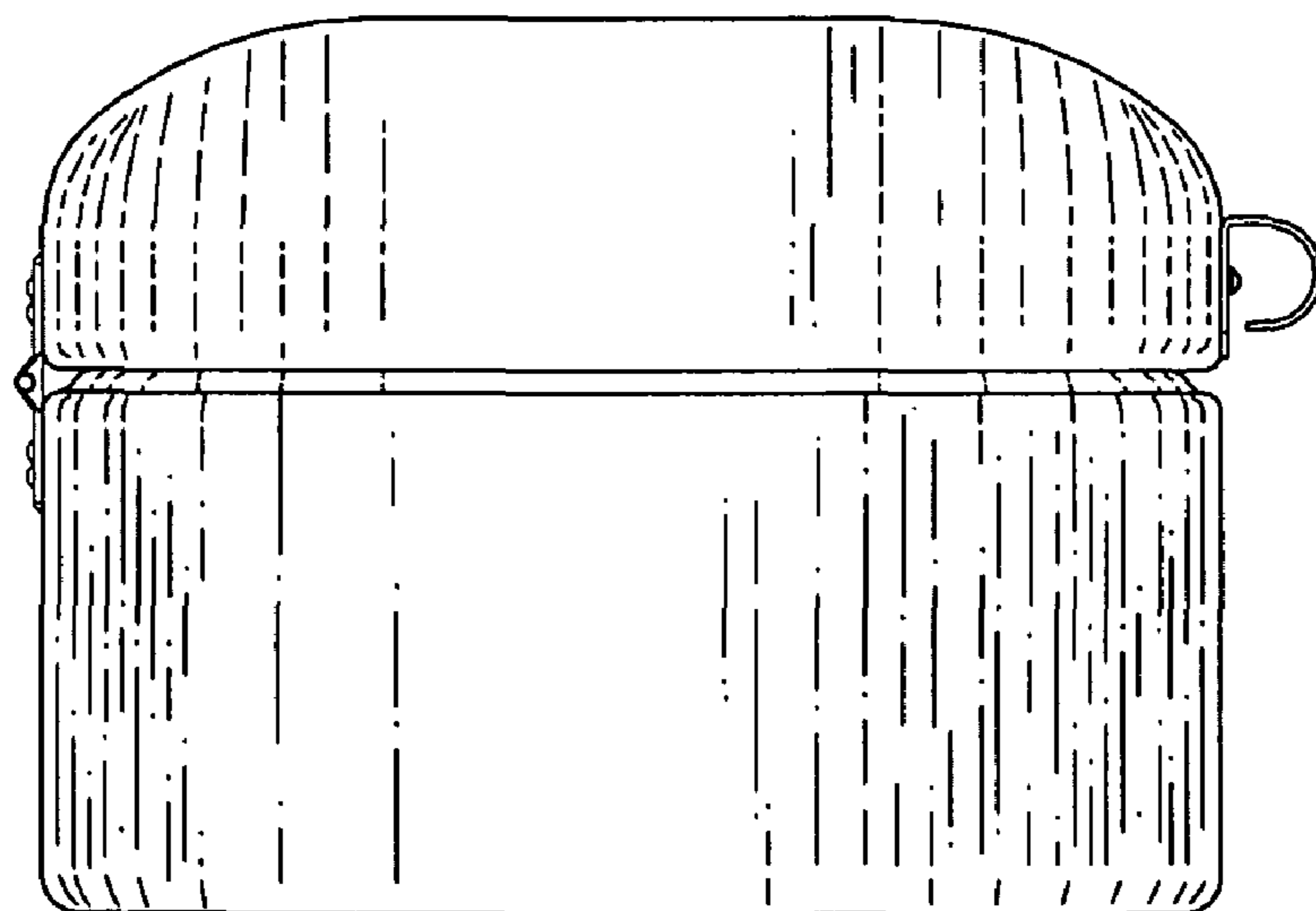

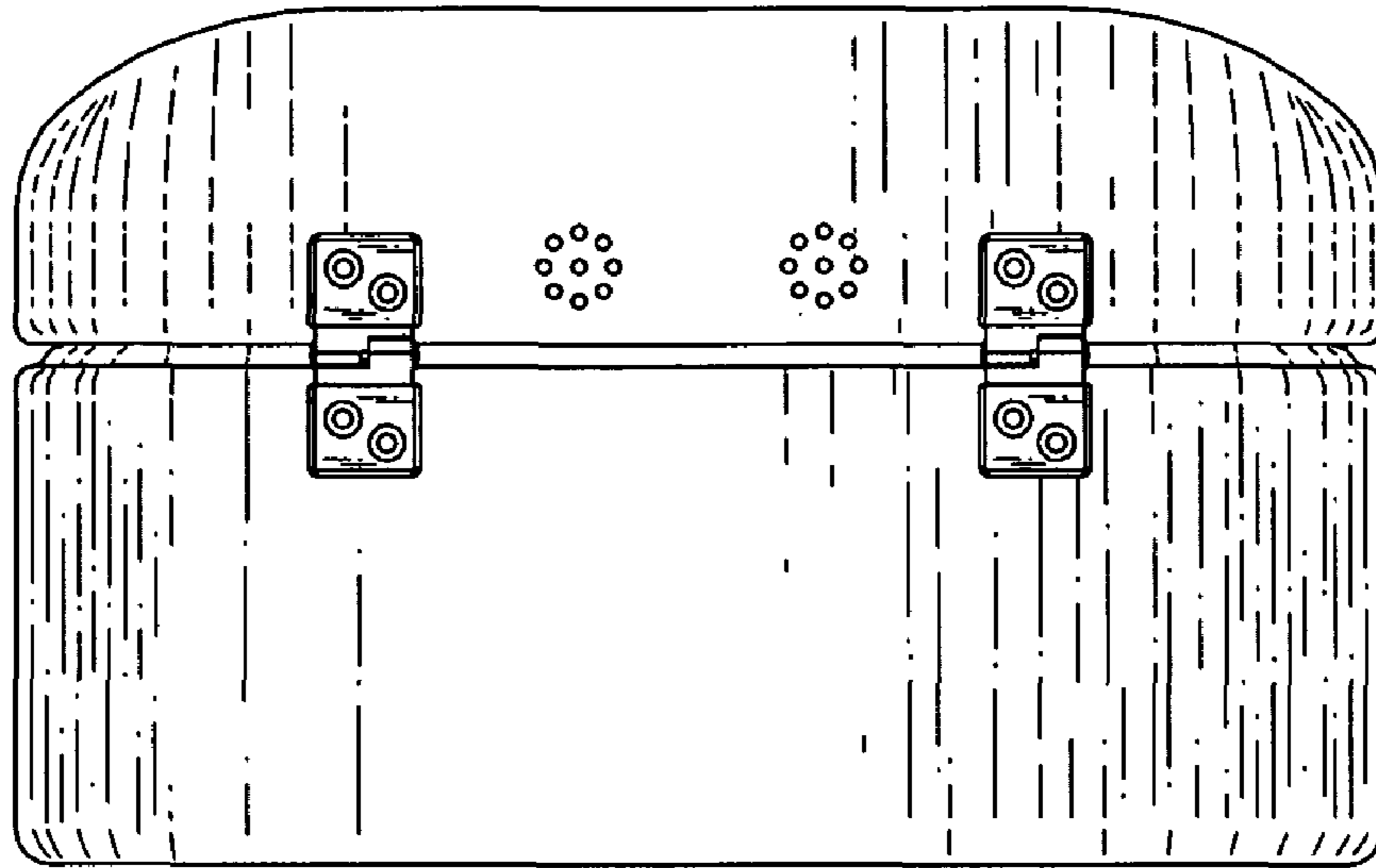

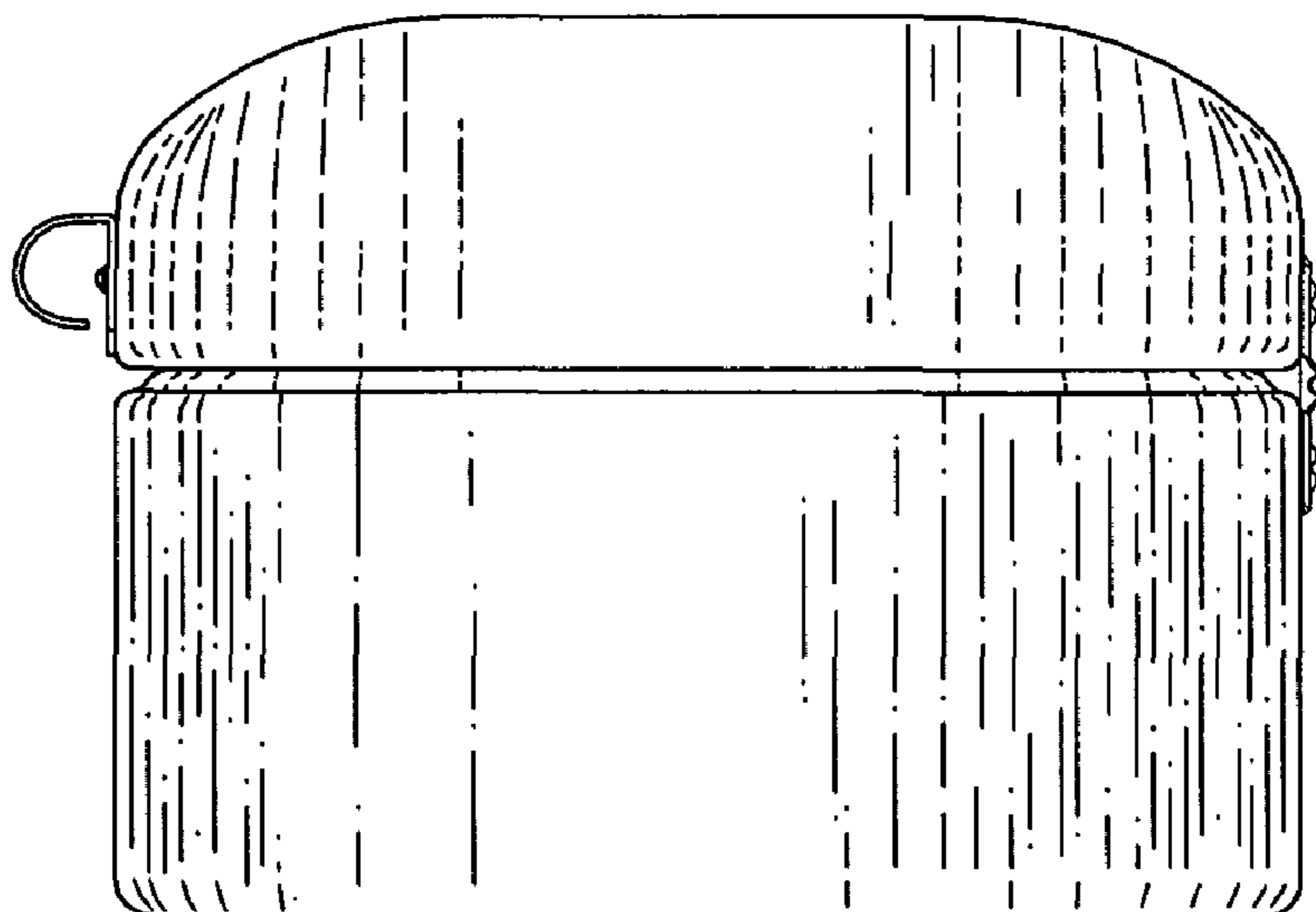

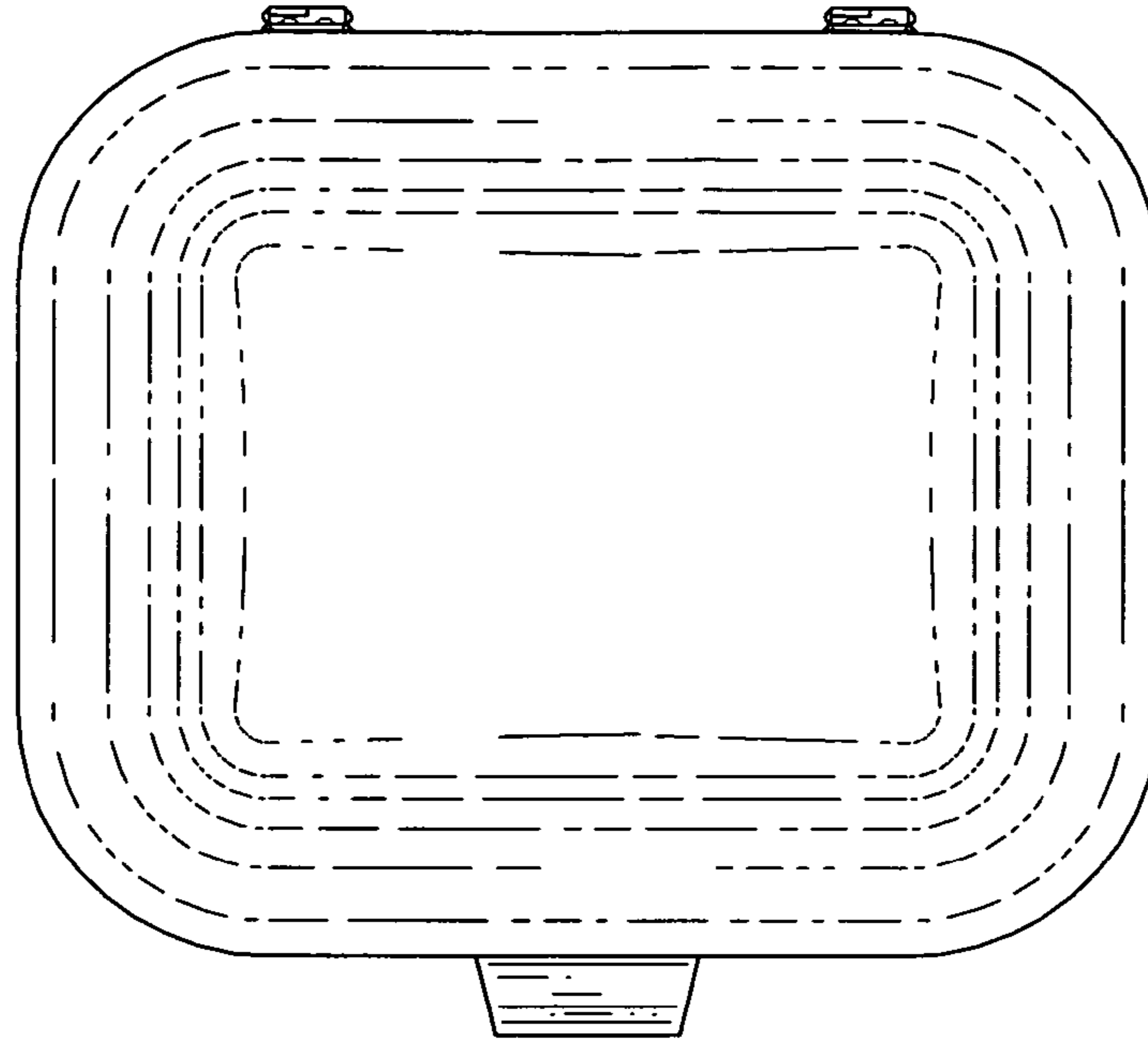

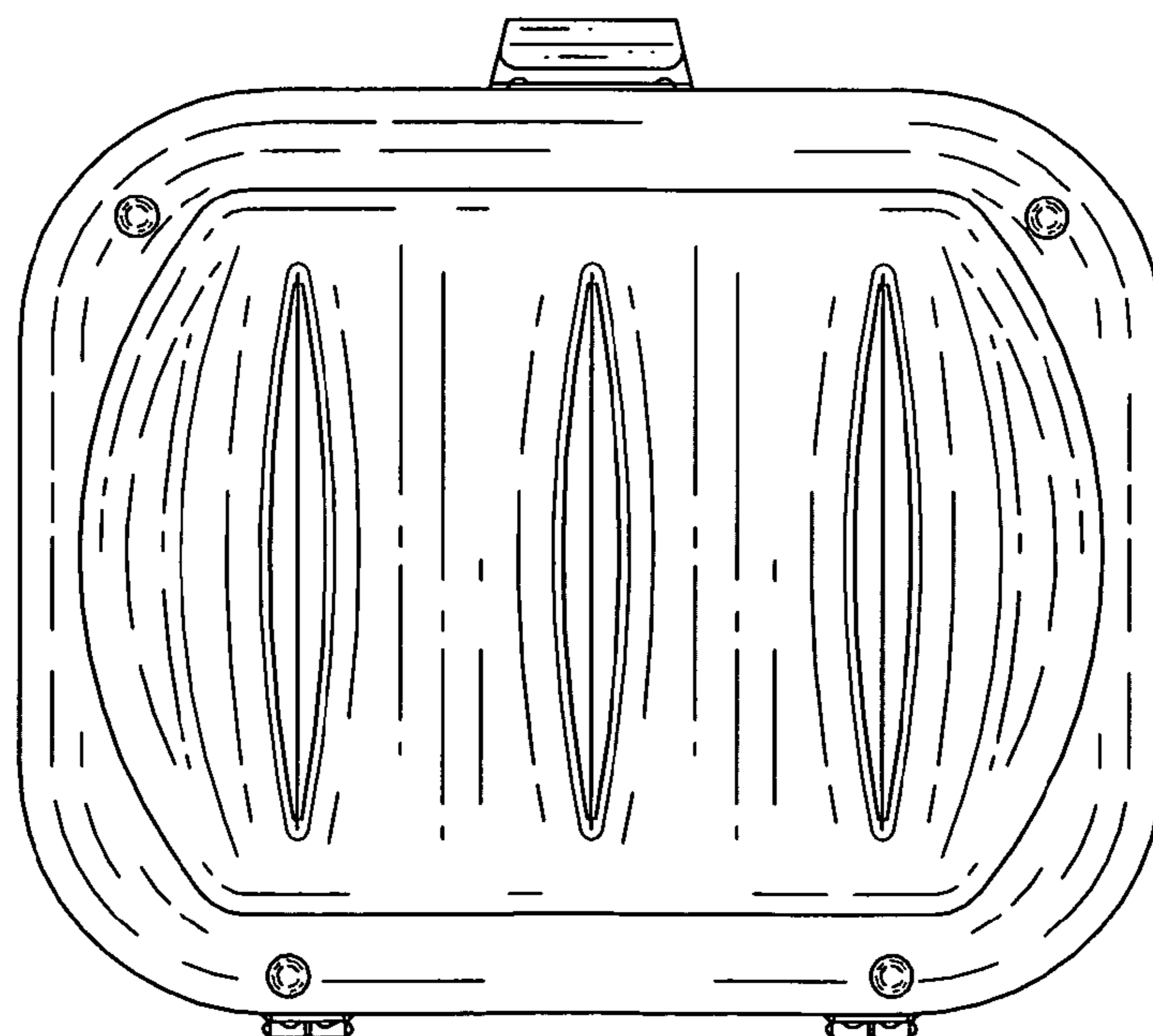
