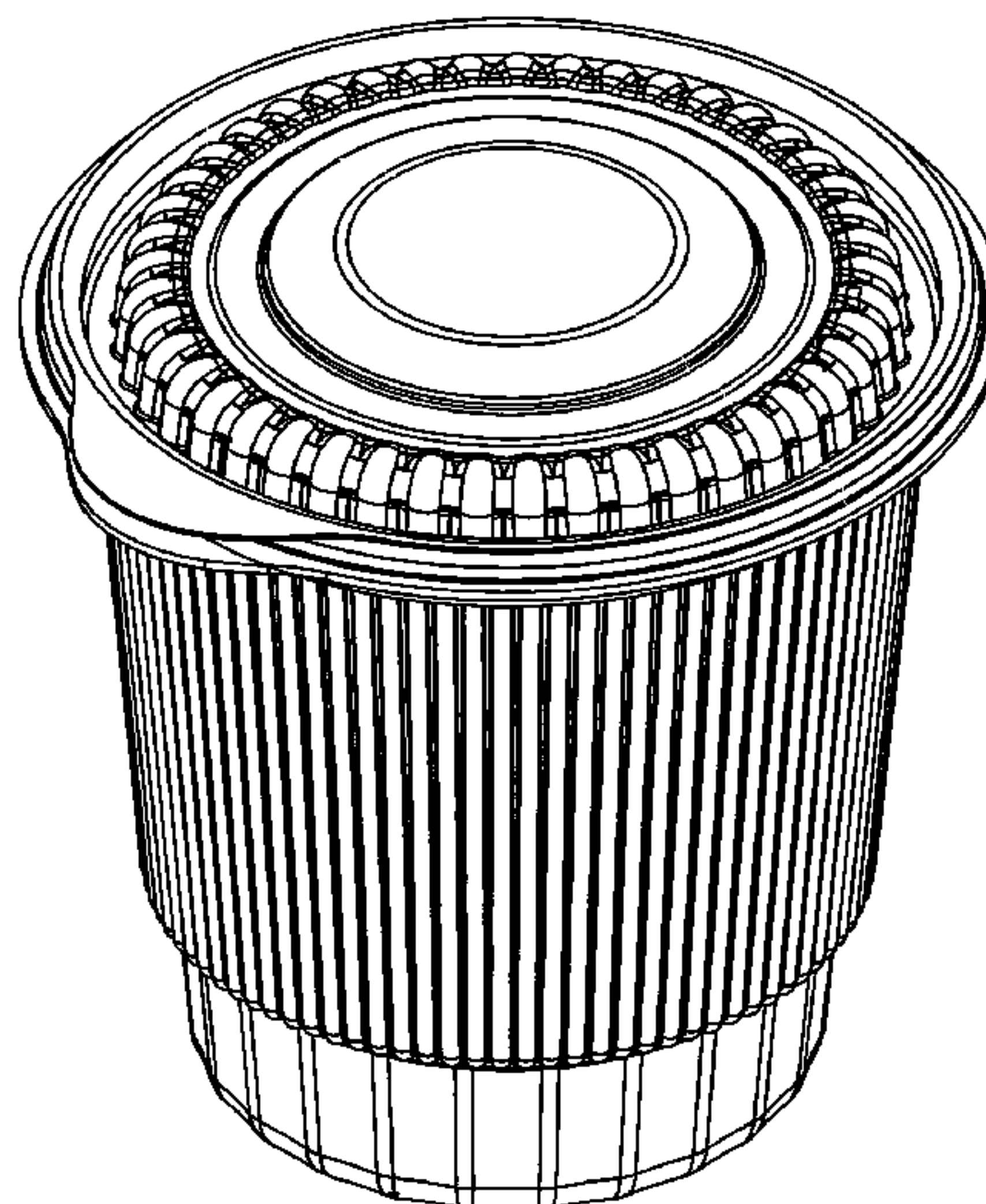
(57) **CLAIM**

The ornamental design for a side dish container comprising a lid and a base, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a side dish container comprising a lid and a base showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a right side elevation view thereof. The broken line portion of the figure drawings is included to show unclaimed subject matter only and forms no part of the claimed design.

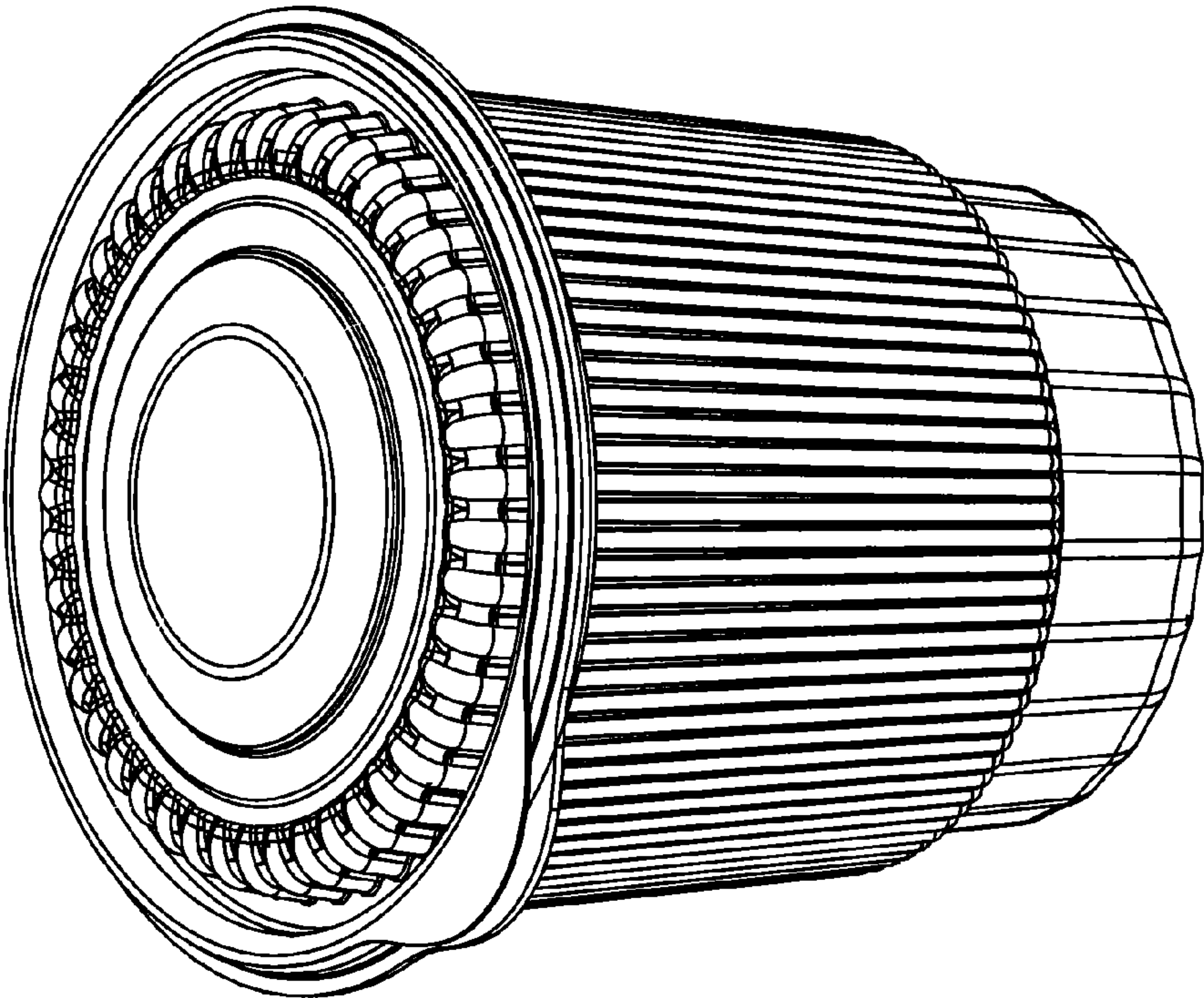

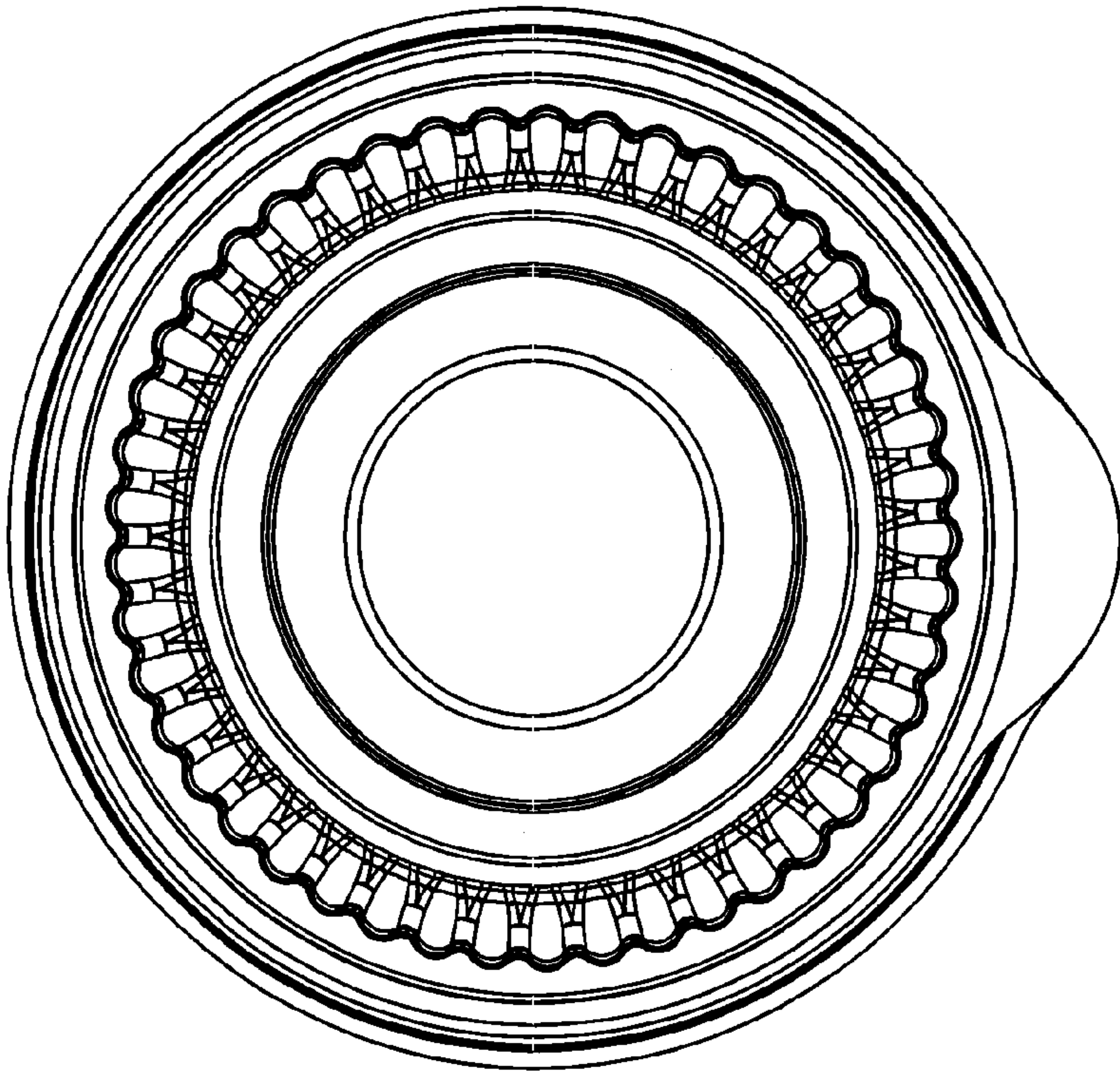

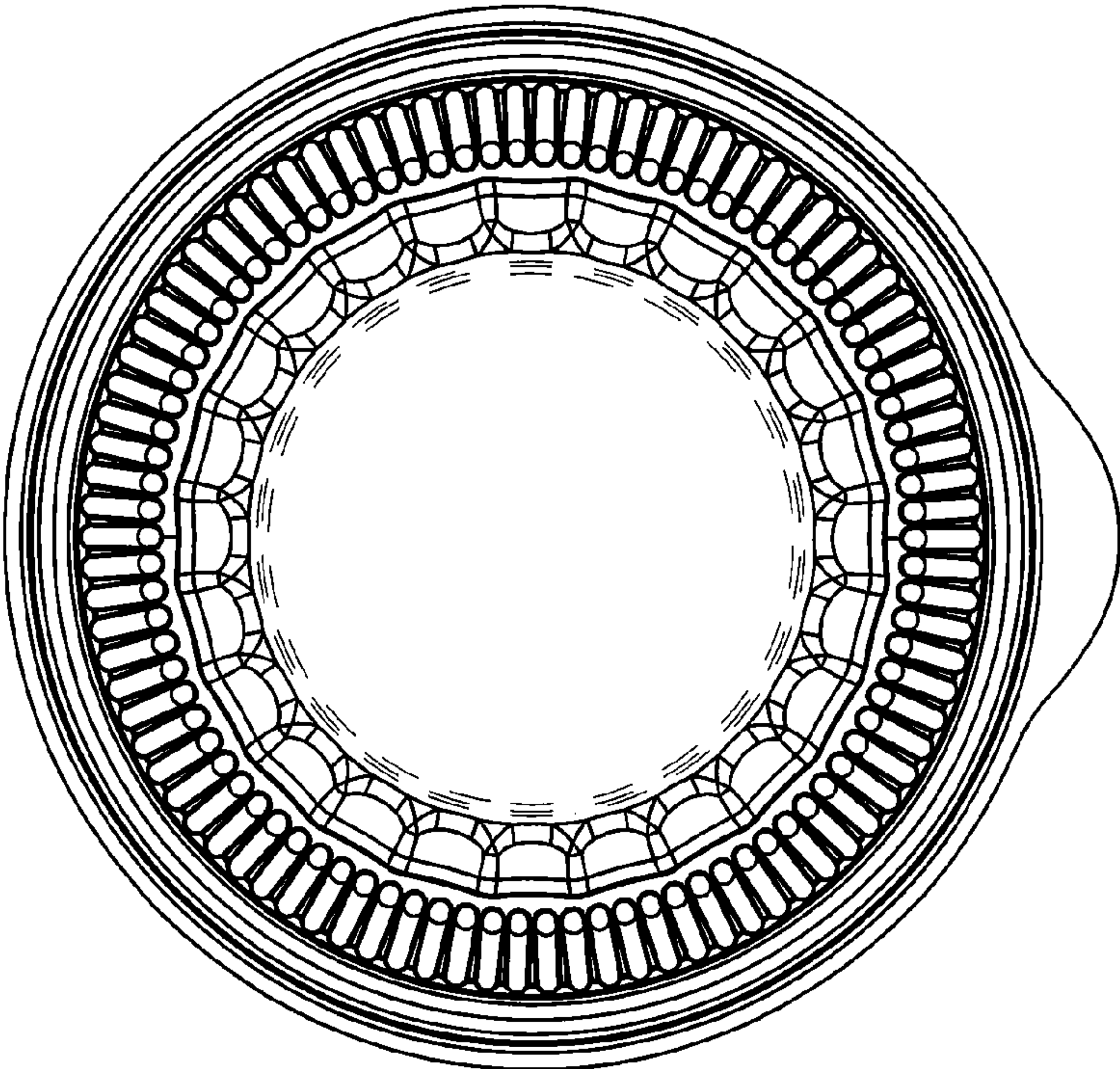

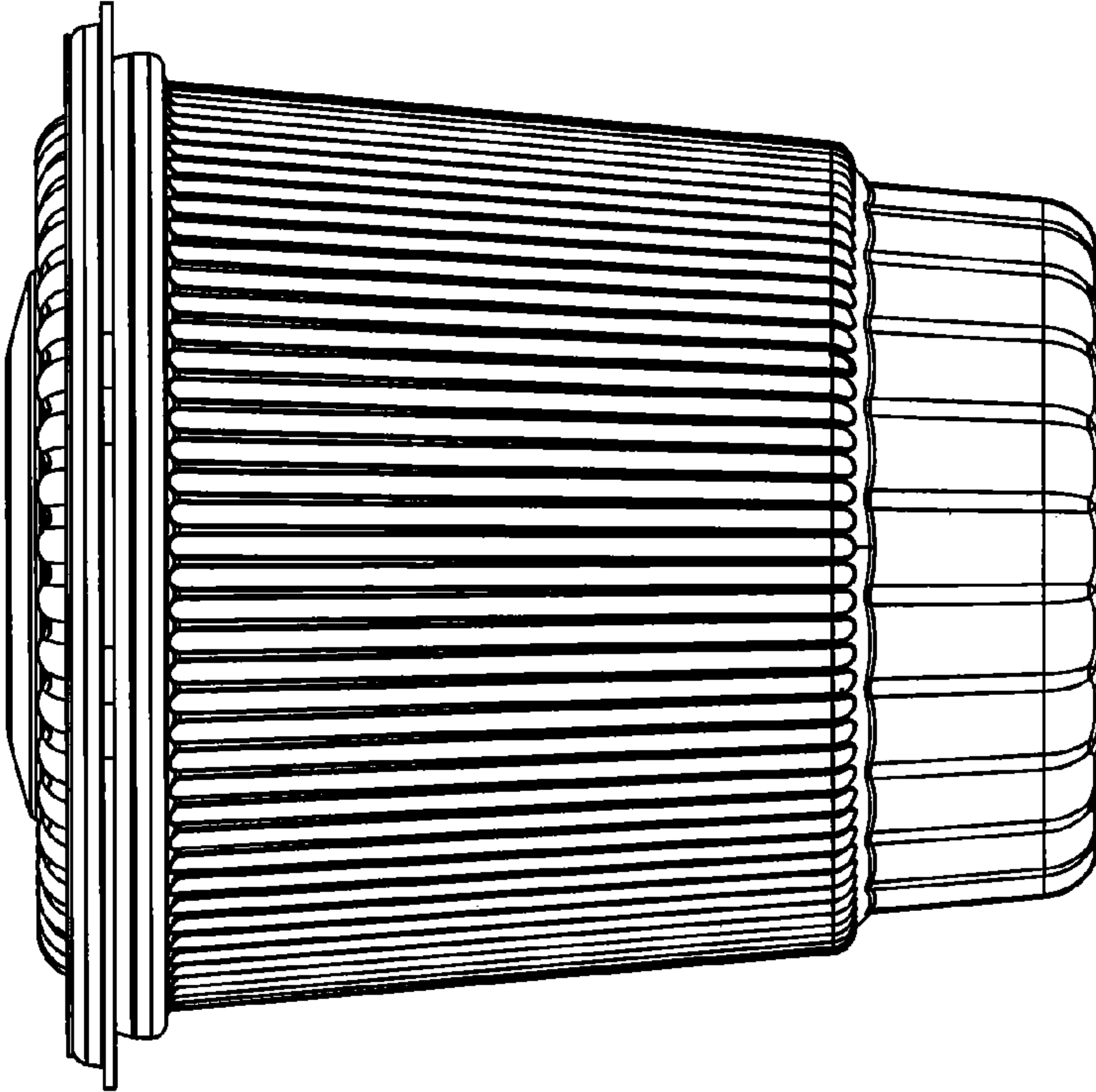

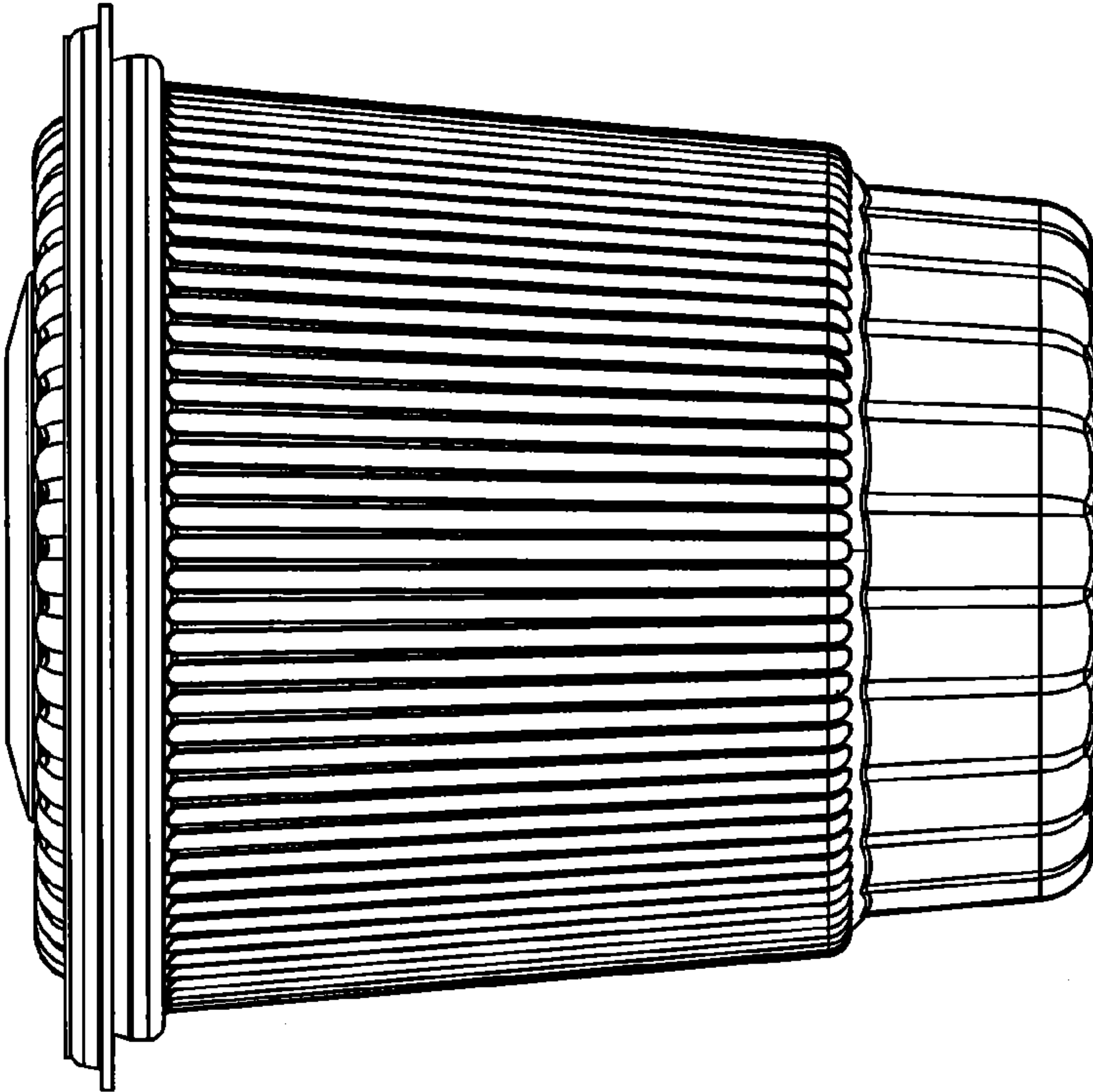

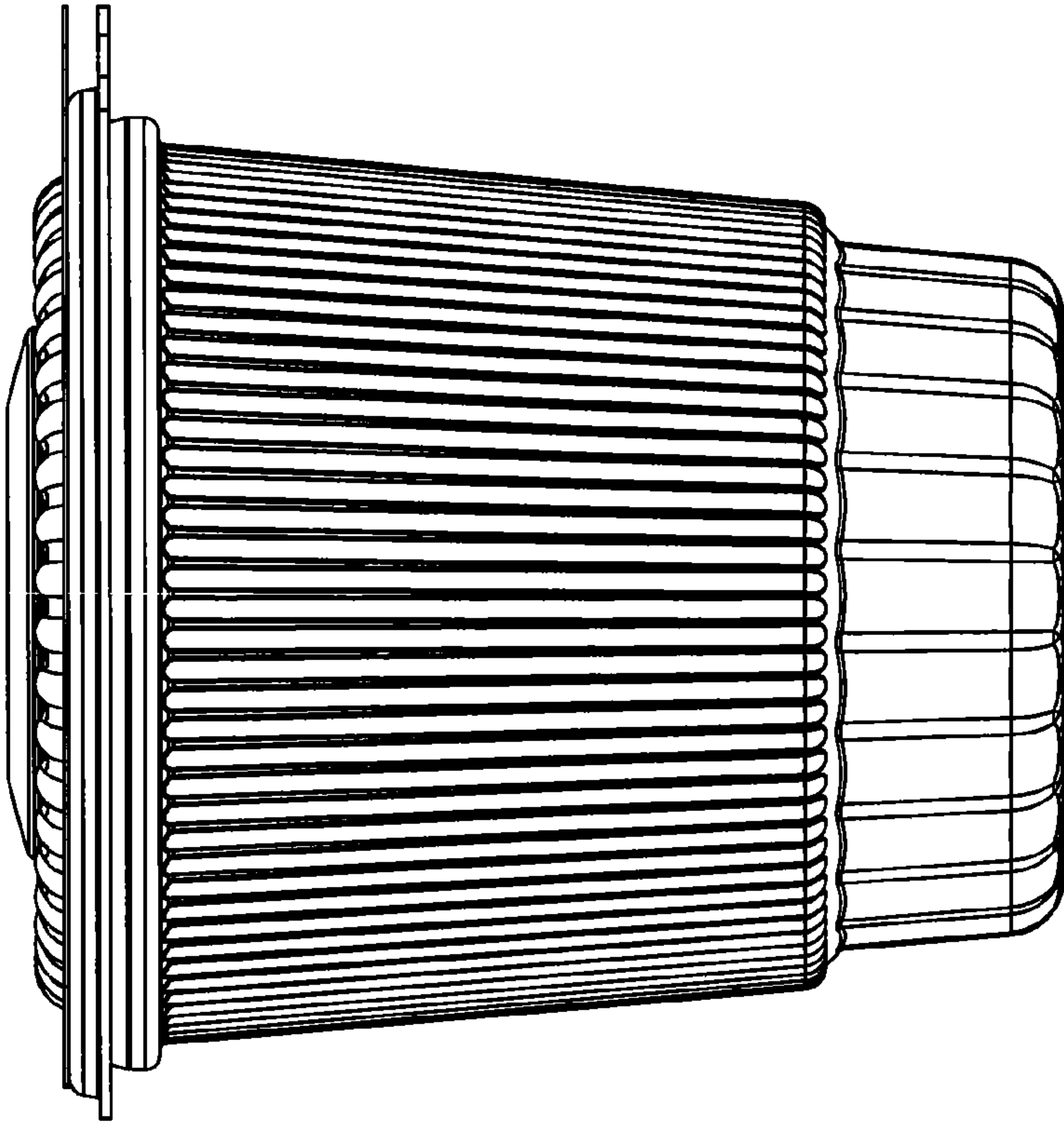

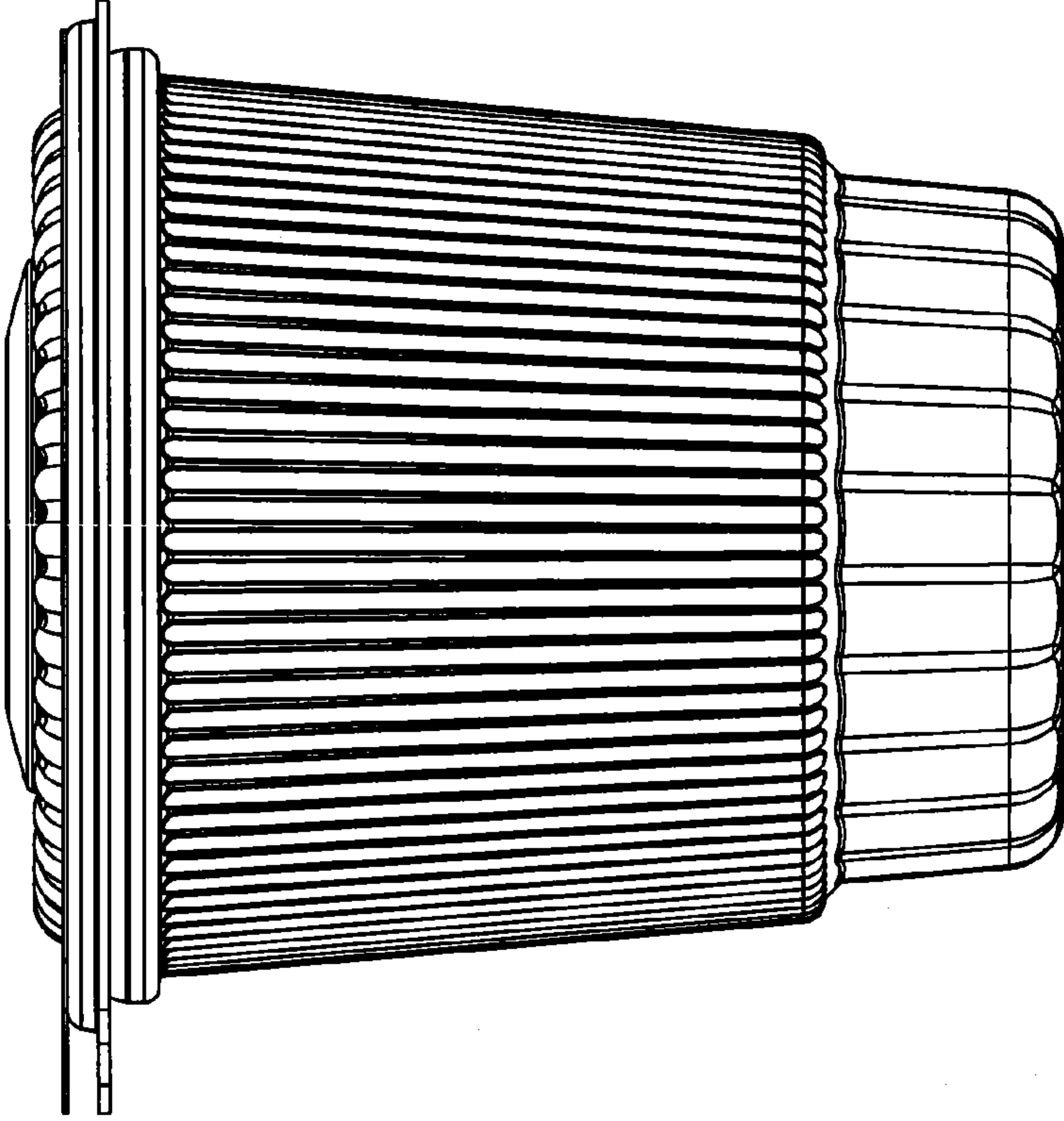
