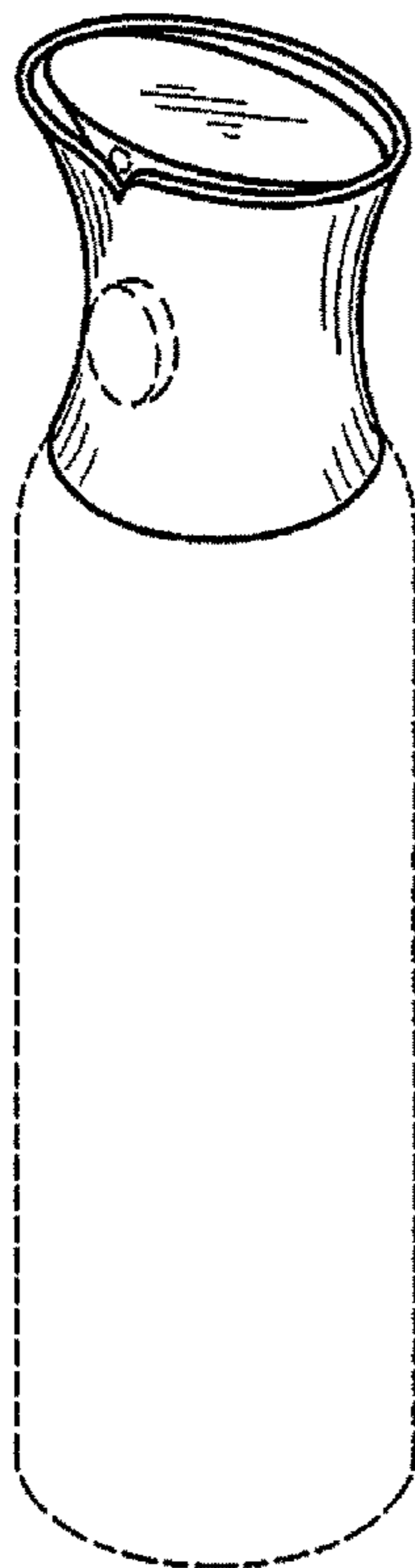
FIG. 5 is a back plan view of the dispenser of FIG. 1; and,

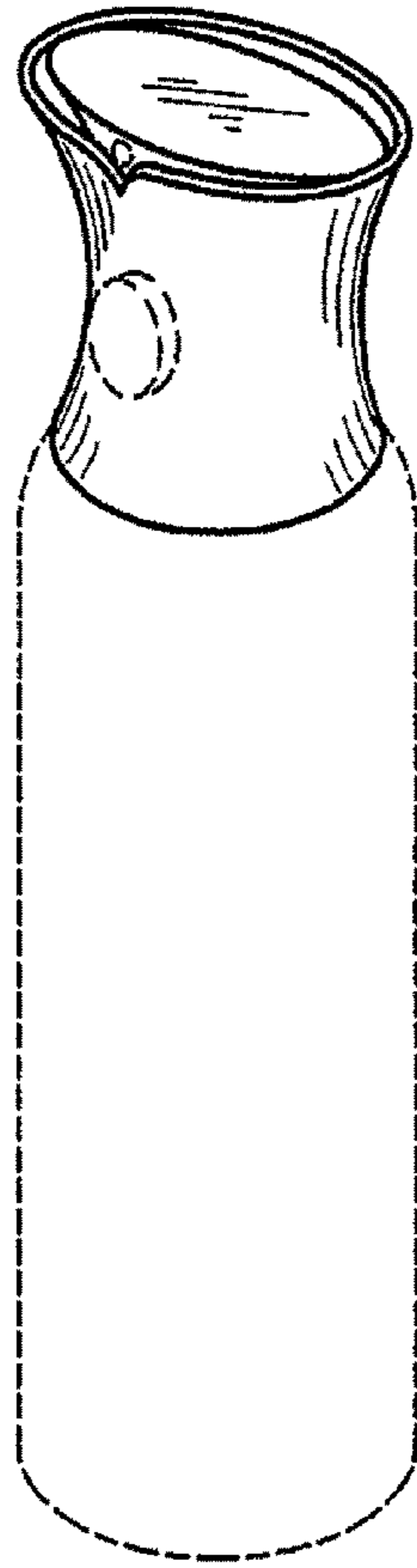

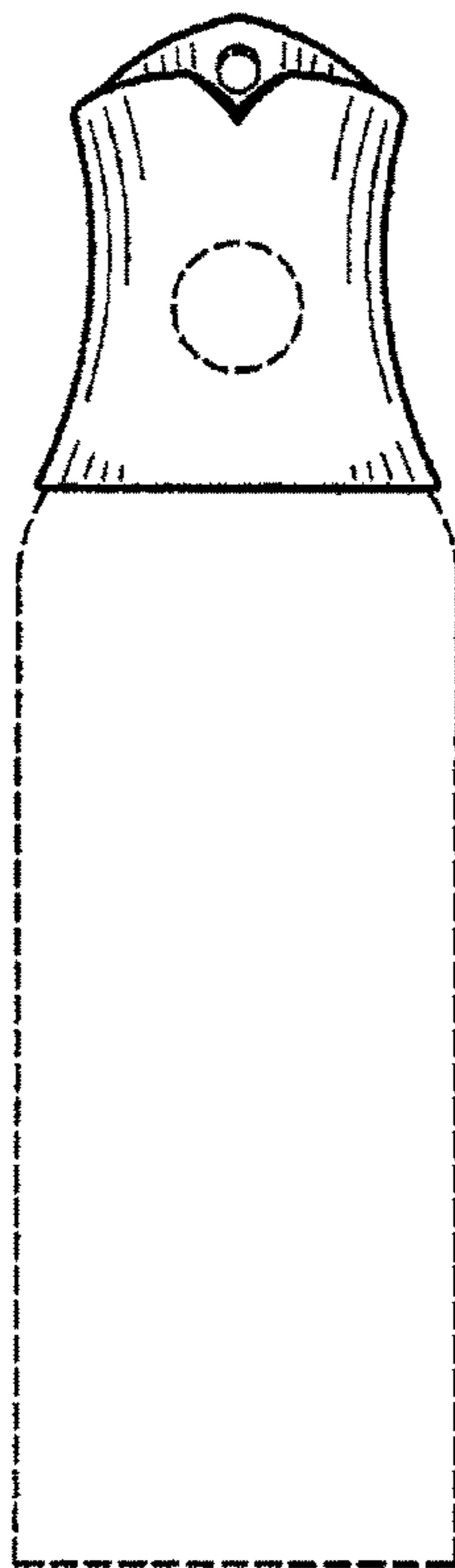

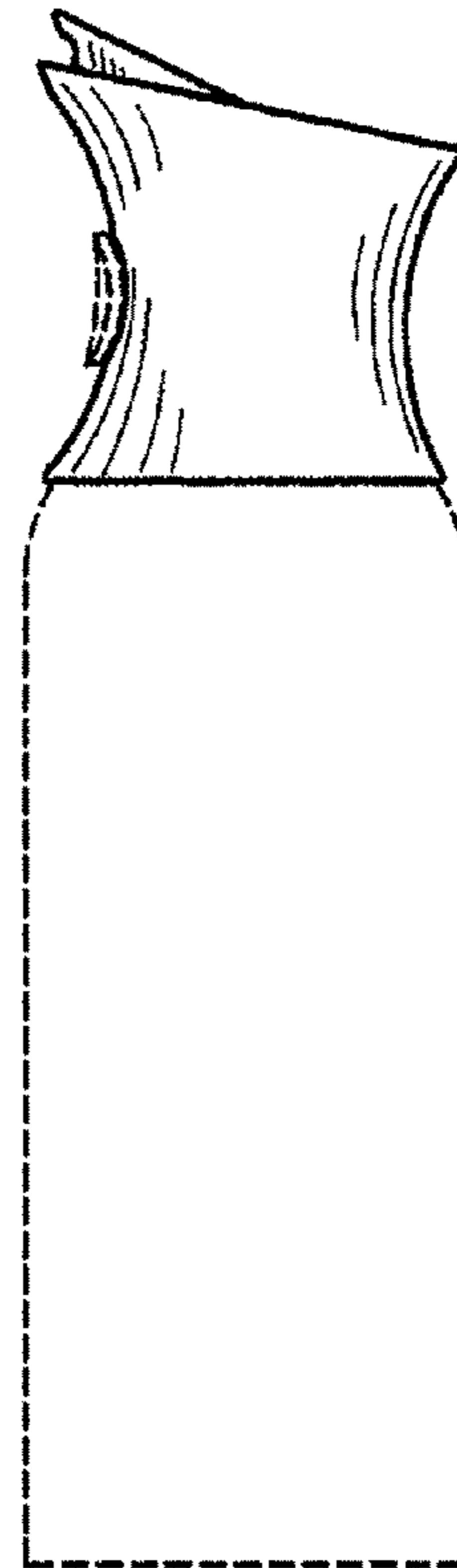

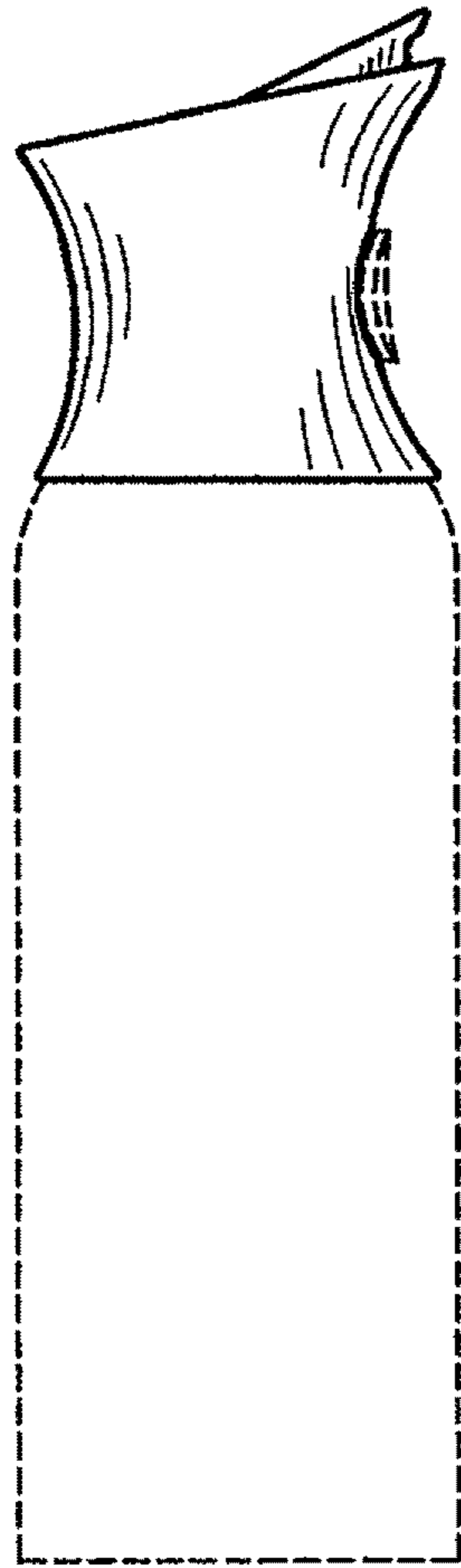

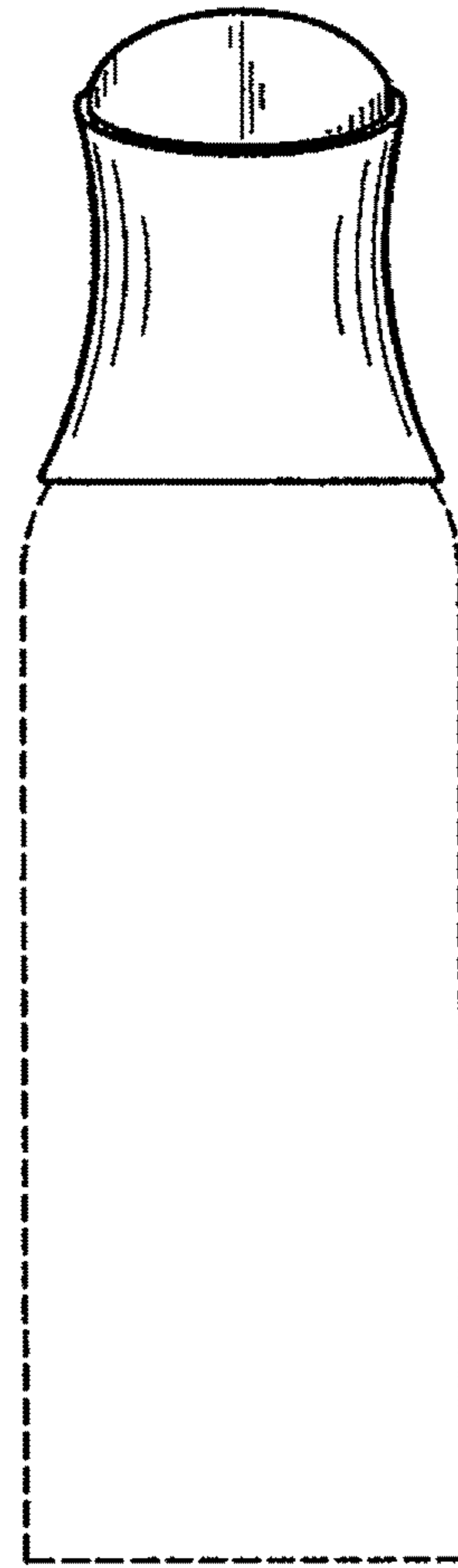

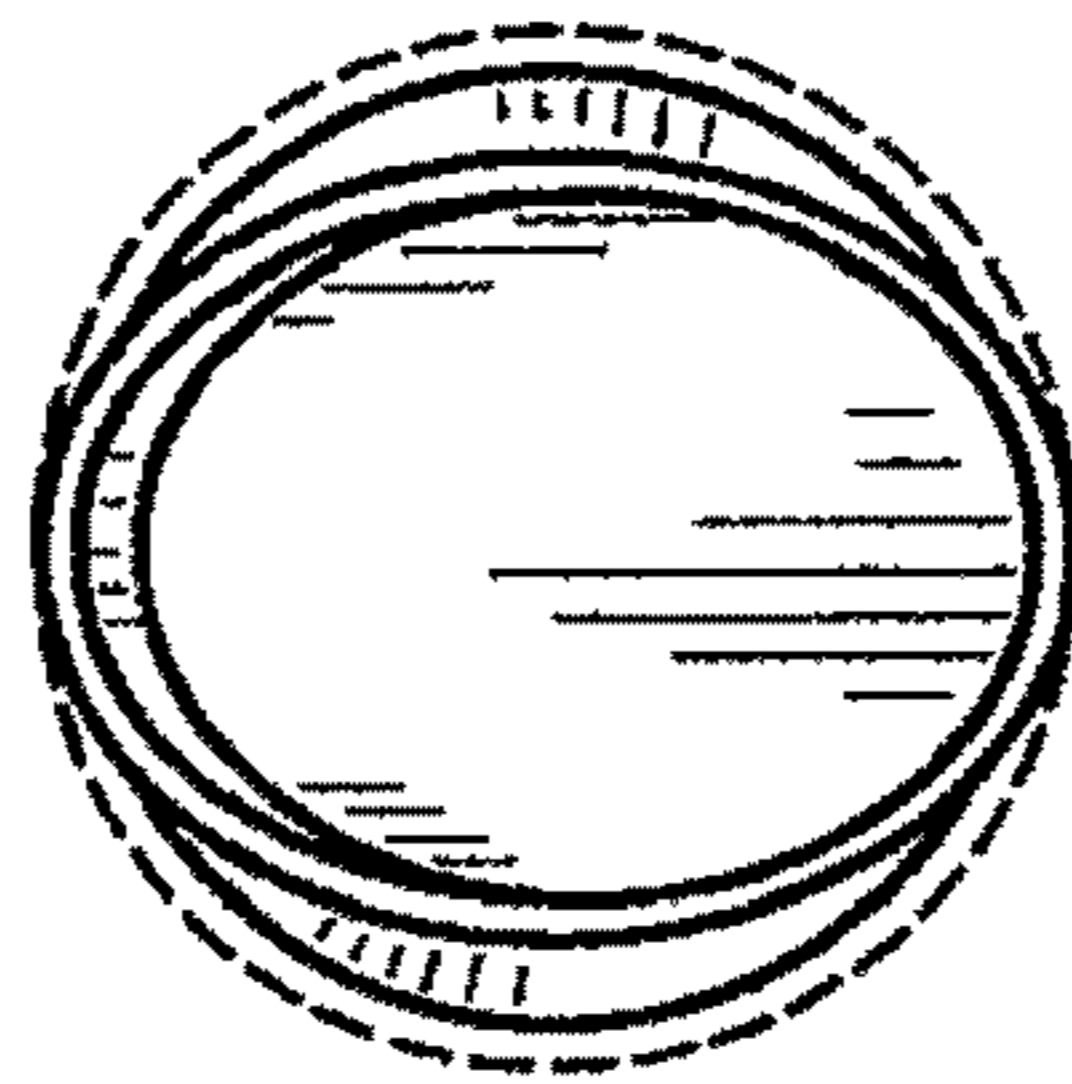
