DESCRIPTION

FIG. 1 is a top, front perspective view in accordance with the present invention;

FIG. 2 is a front elevational view thereof;

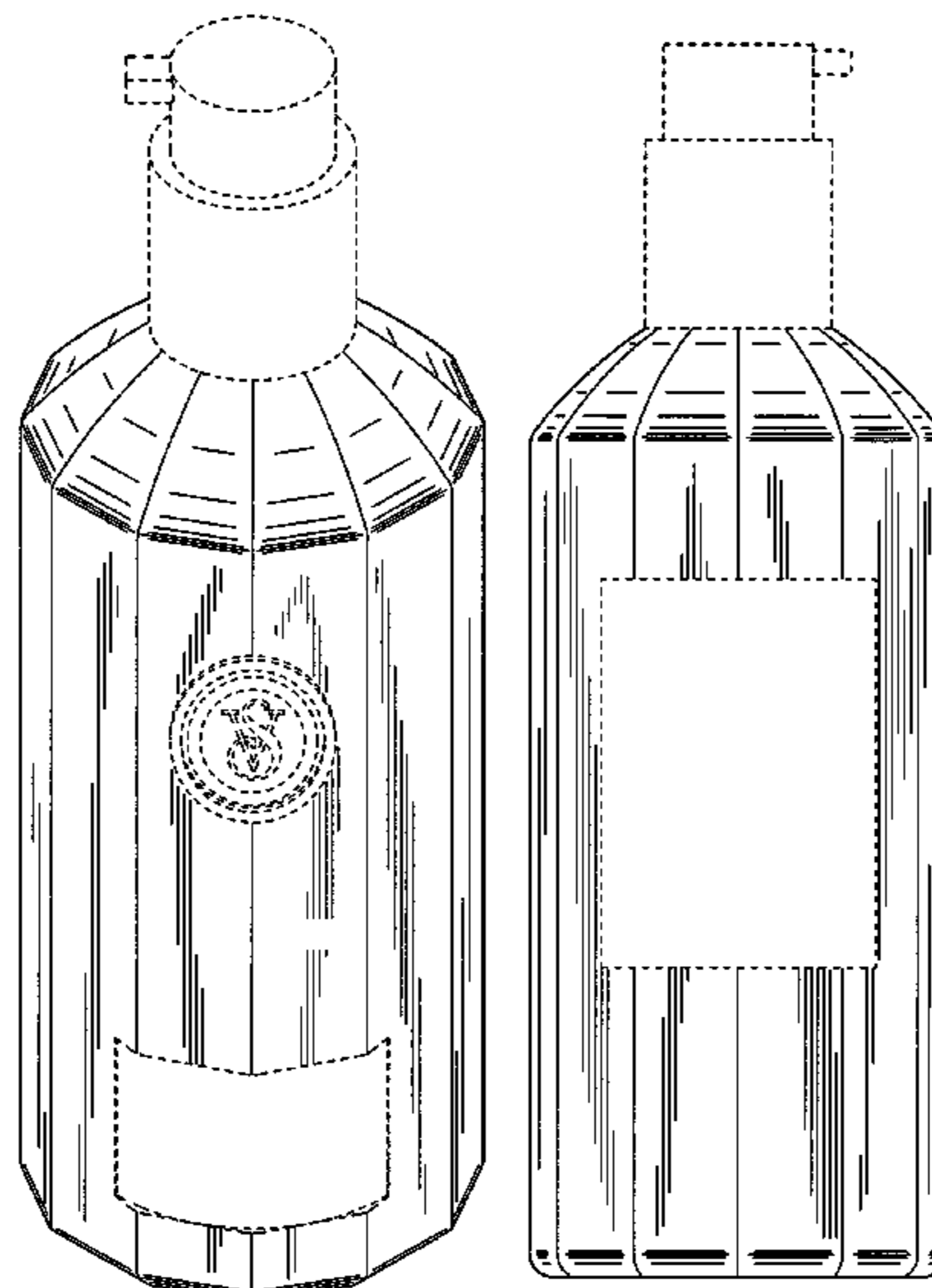
FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image except for the unclaimed circular portion on the front sidewall; and,

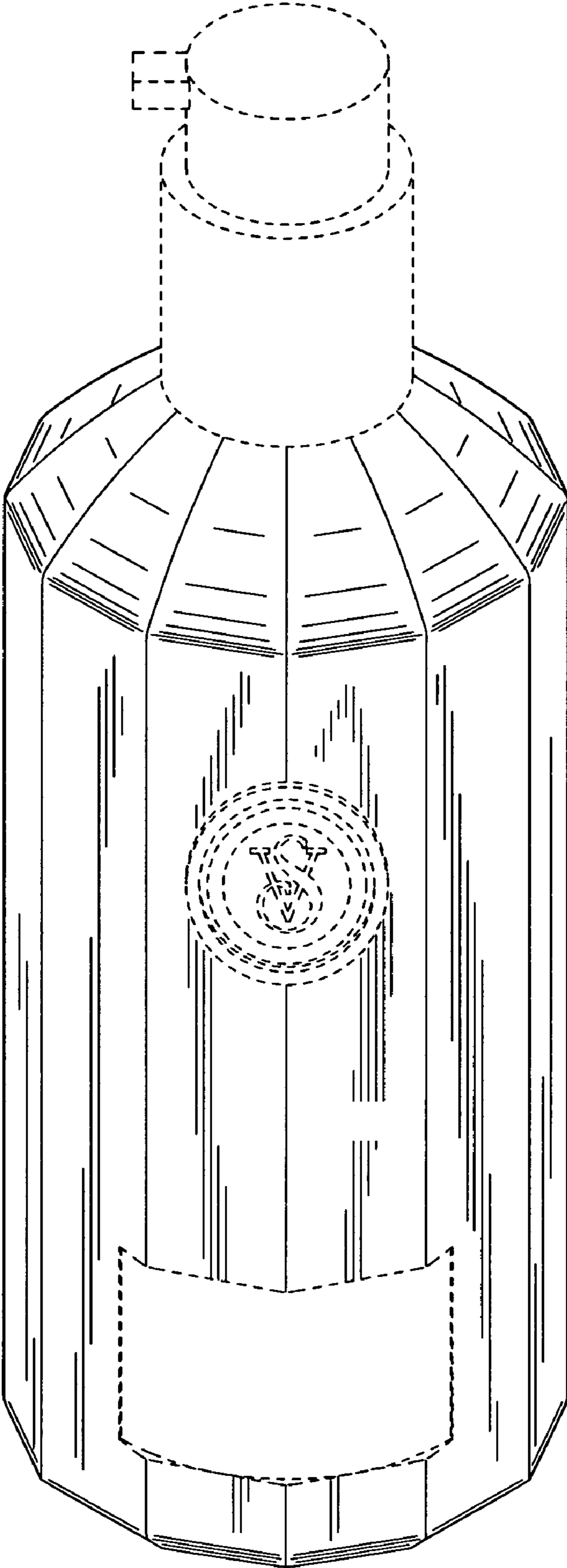

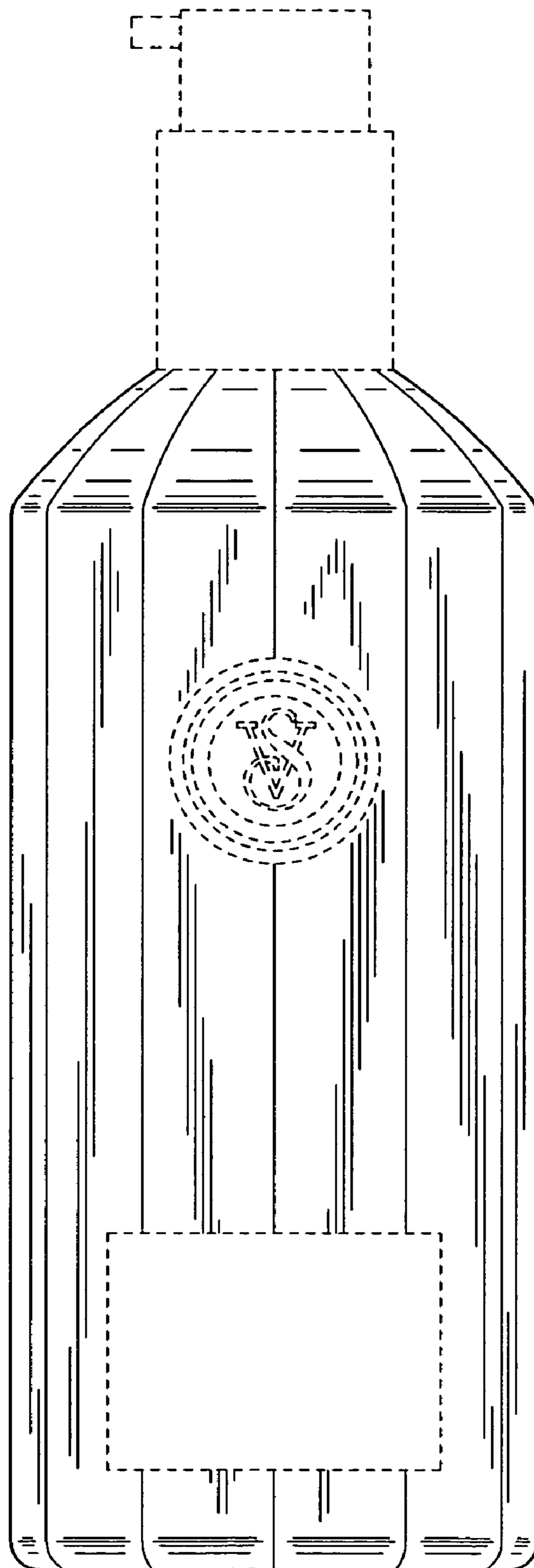

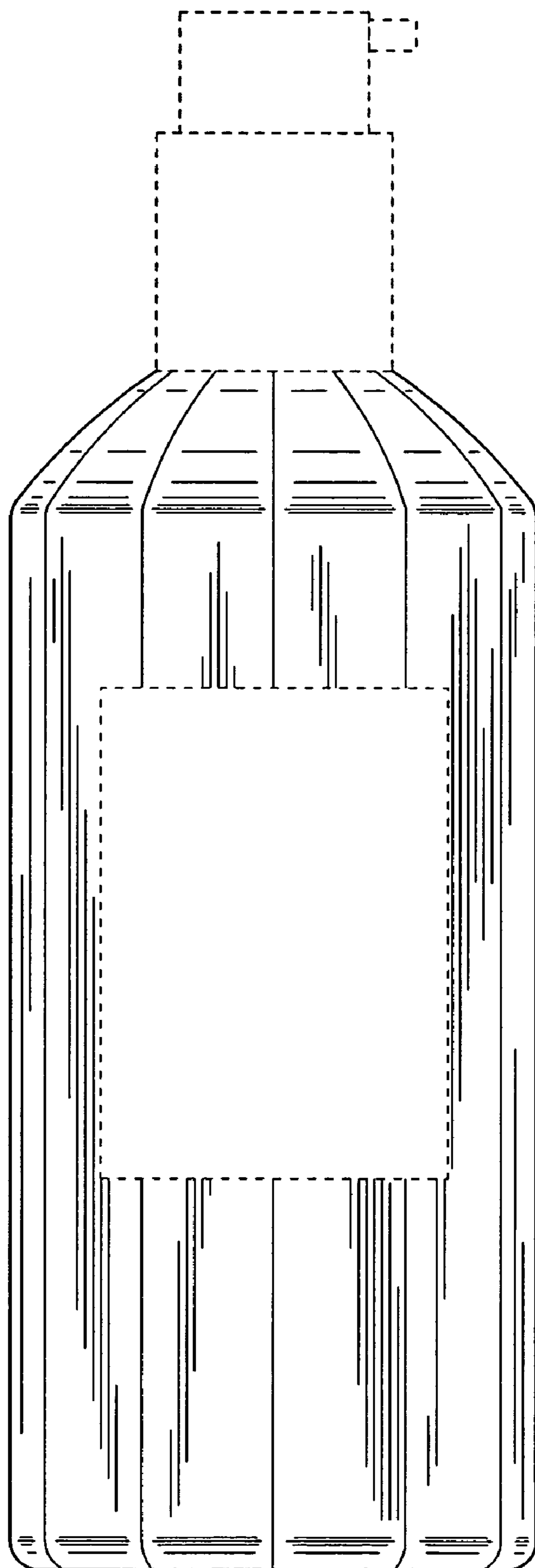

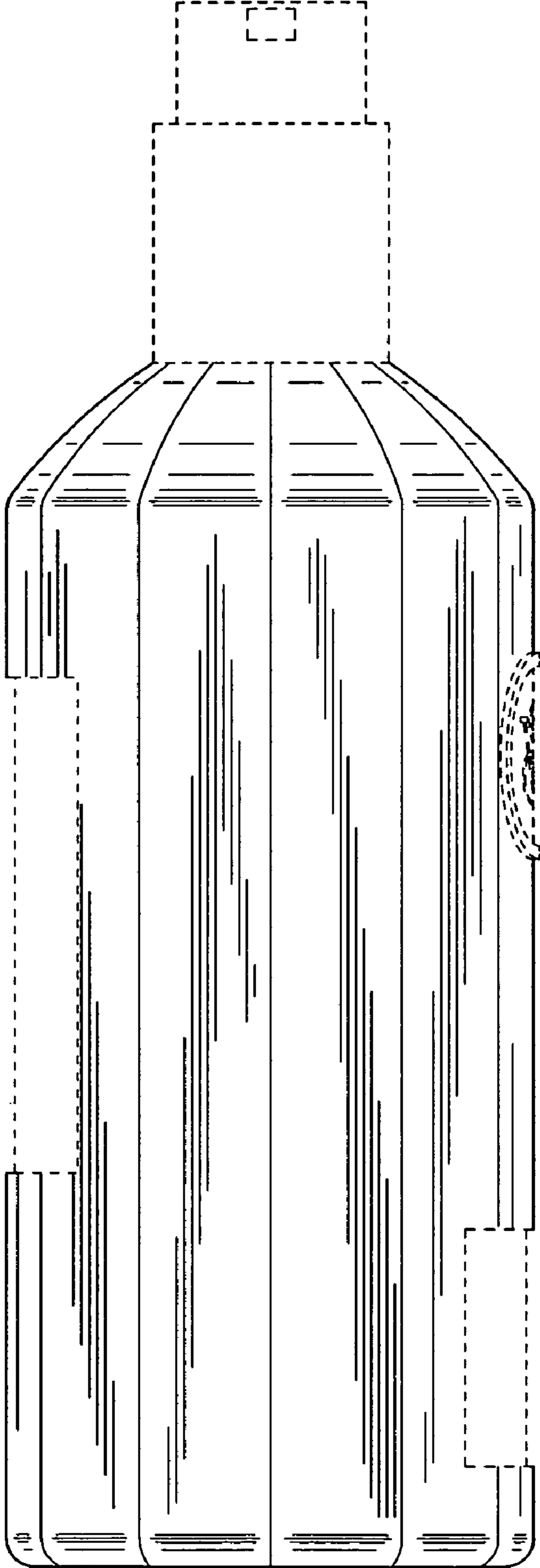
