(57) **CLAIM**

The ornamental design for a gift basket kit, as shown.

**DESCRIPTION**

FIG. 1 is a front elevation of a gift basket kit showing my new design in use with gift items and a balloon;

FIG. 2 is a front elevation thereof with the gift items and balloon removed;

FIG. 3 is a top plan view thereof;

FIG. 4 is a rear elevation thereof;

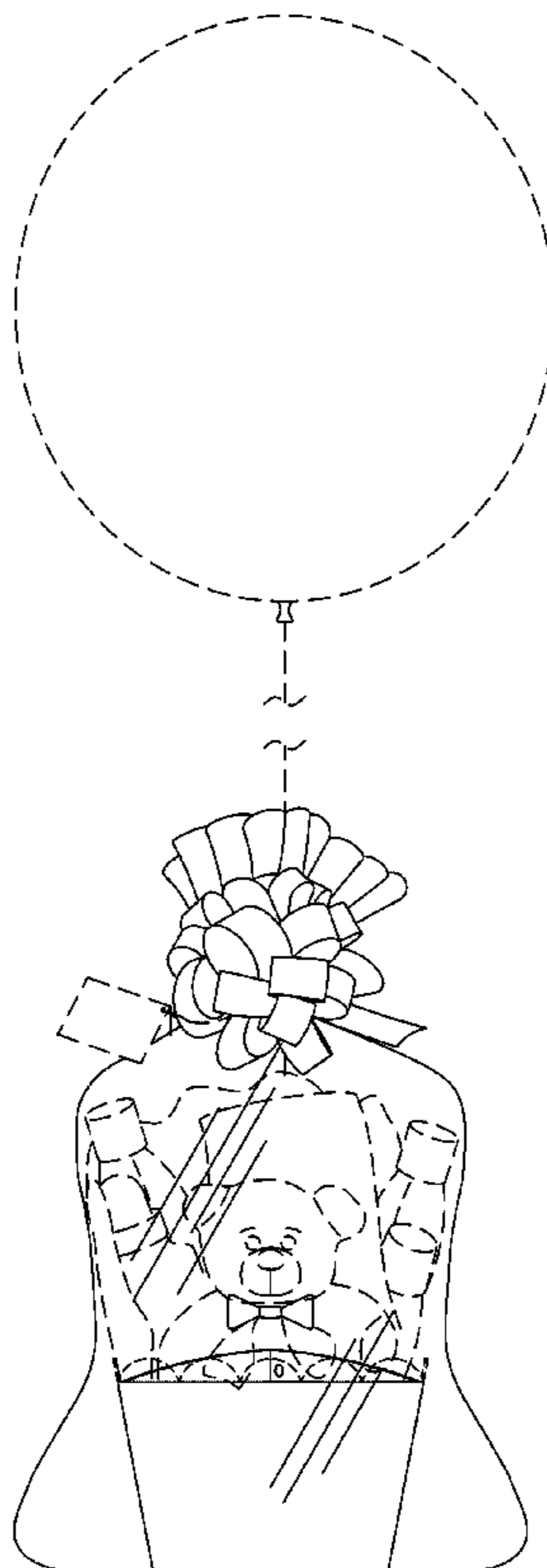
FIG. 5 is a bottom plan view thereof;

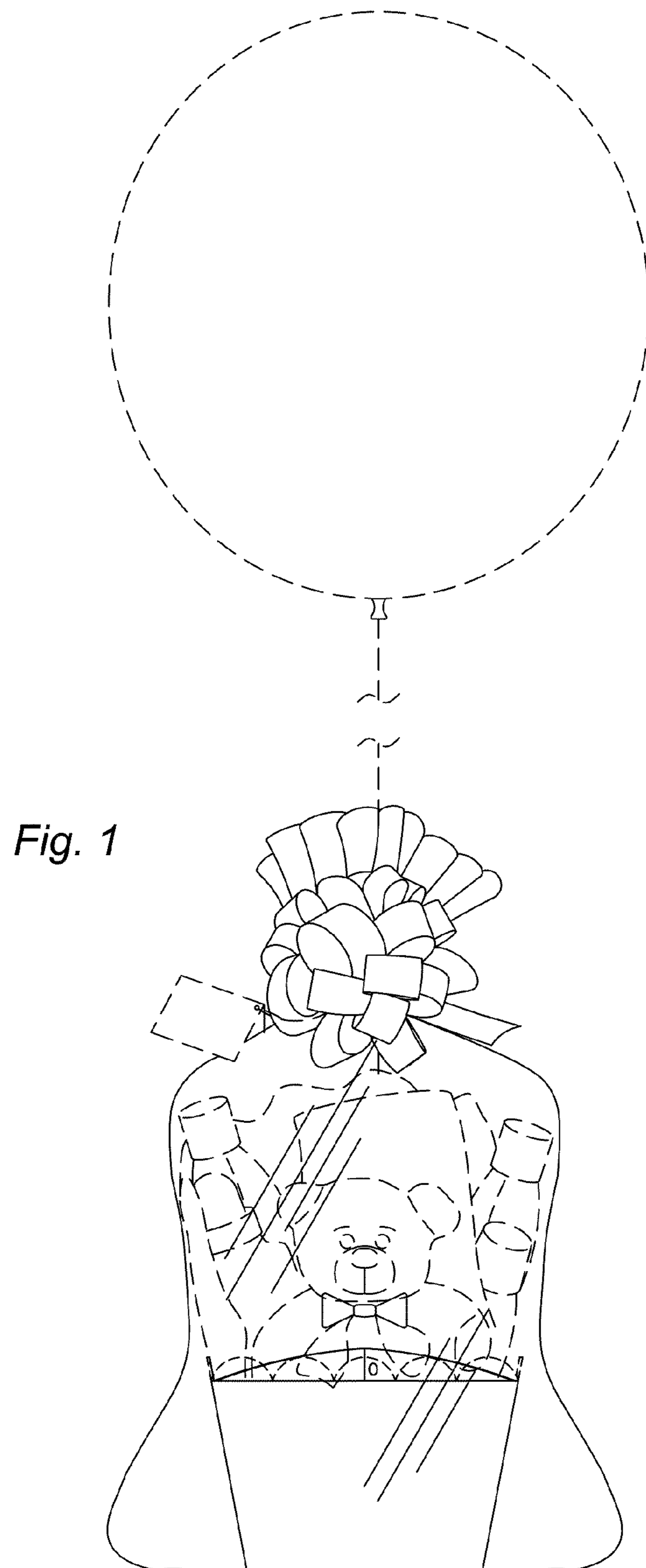
FIG. 6 is a right side elevation thereof; and,

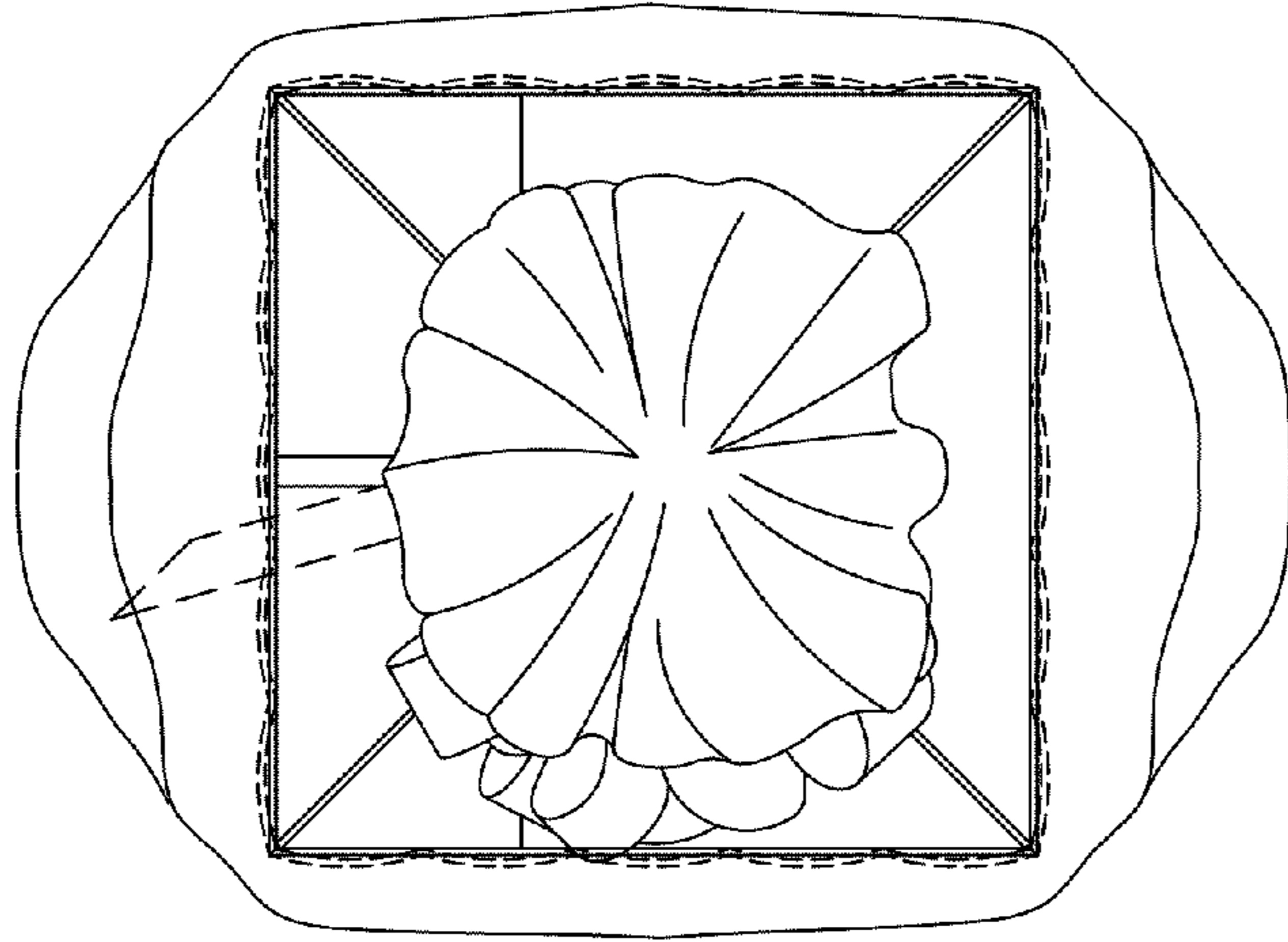

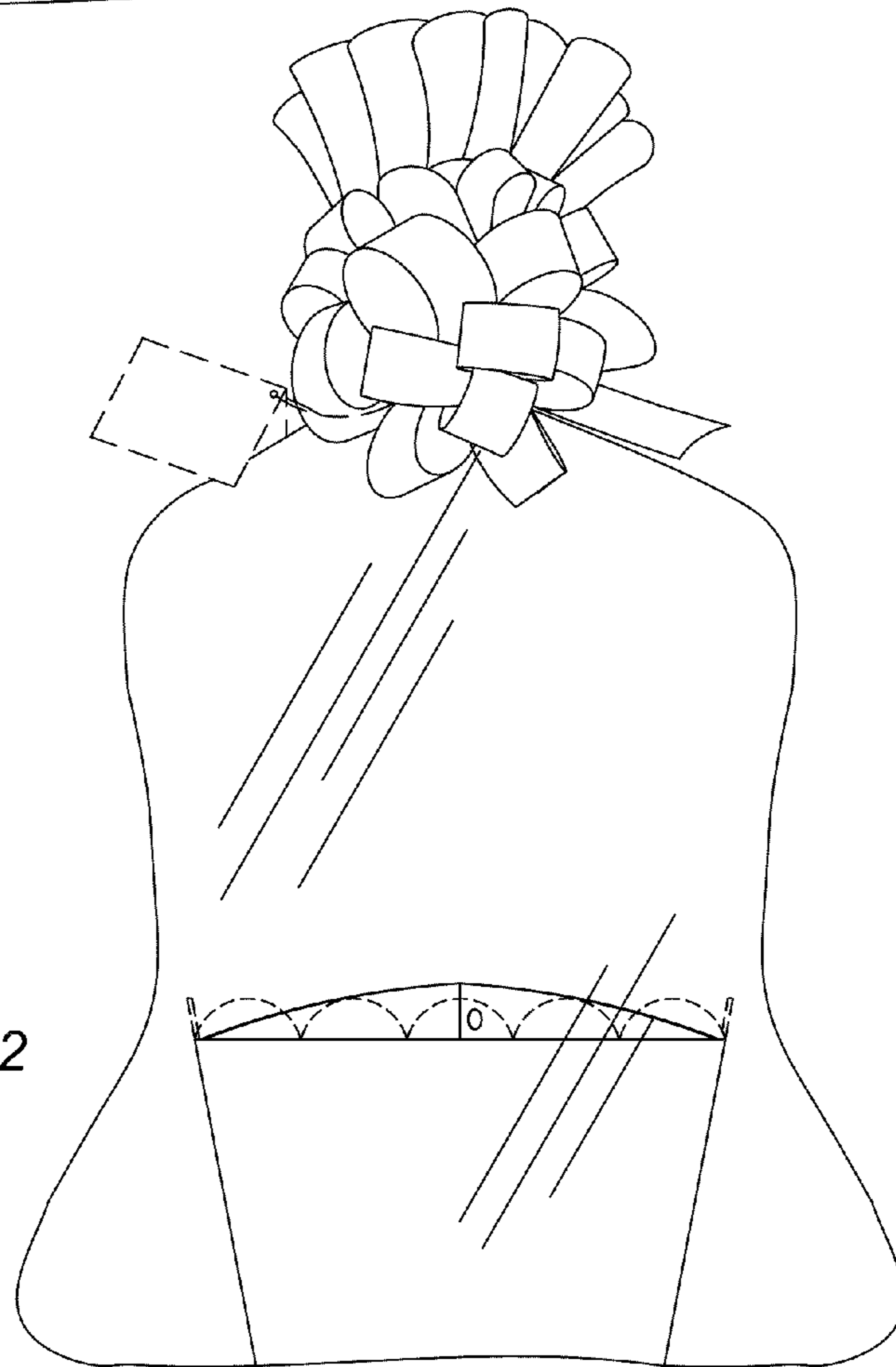

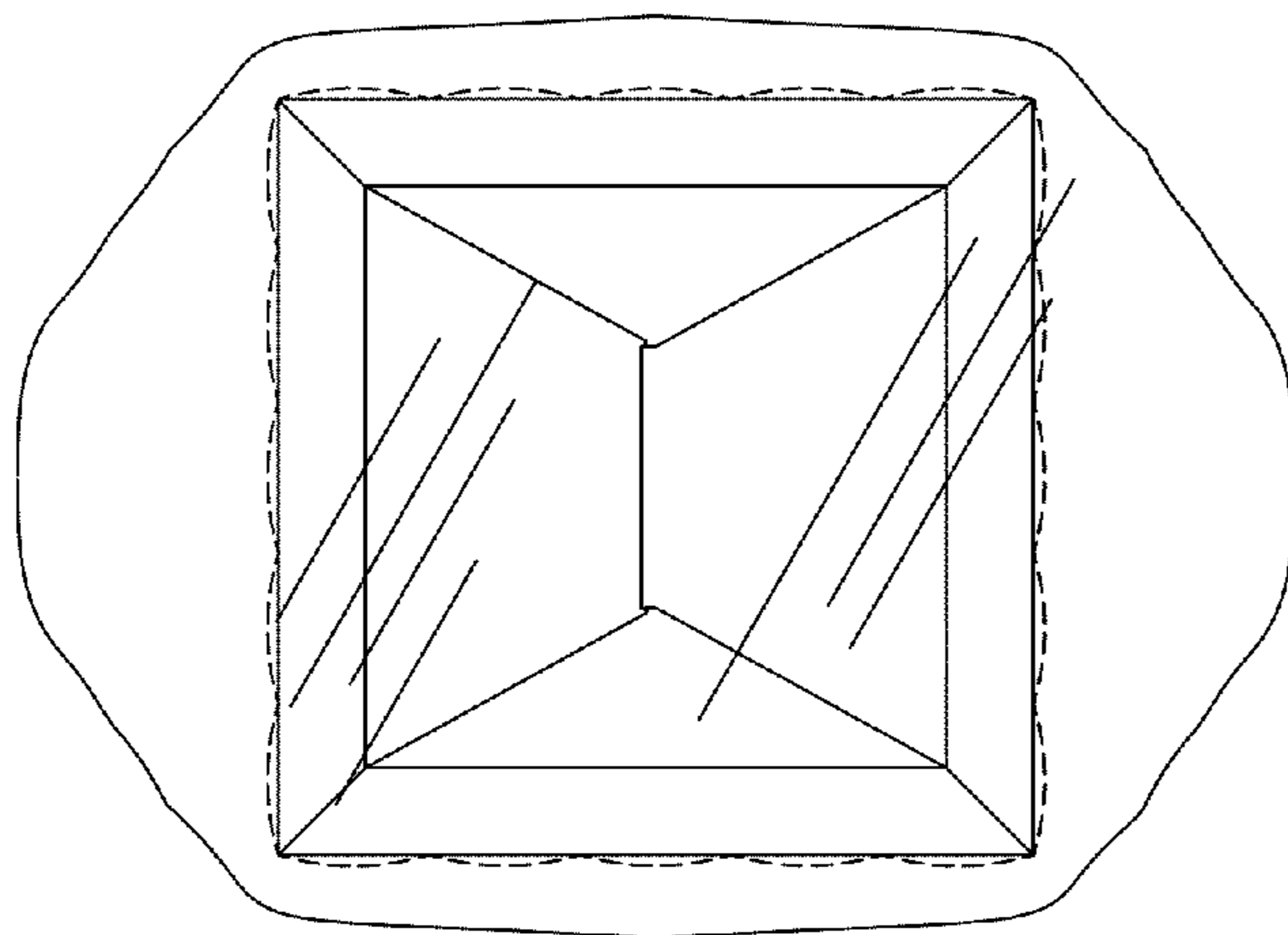
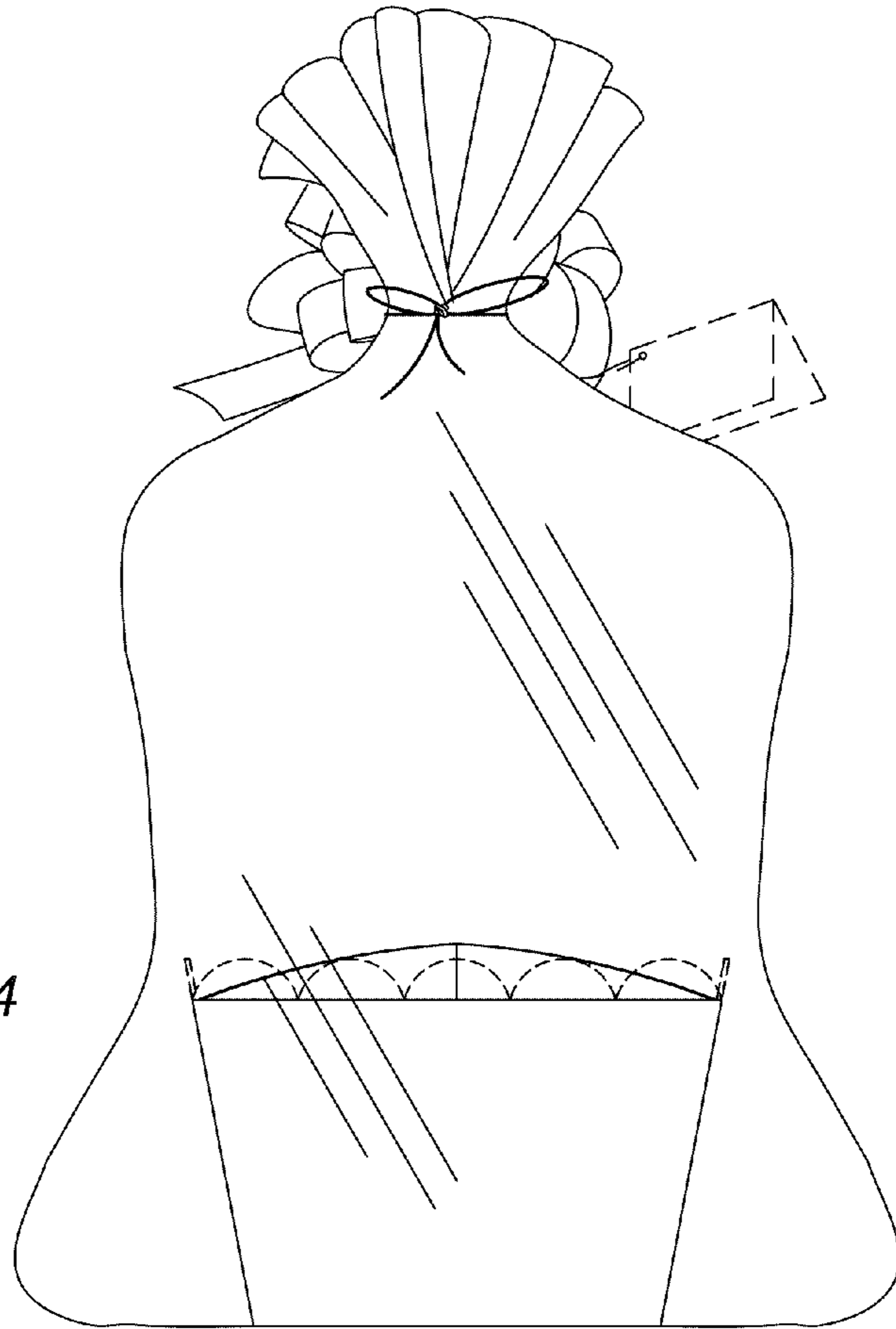

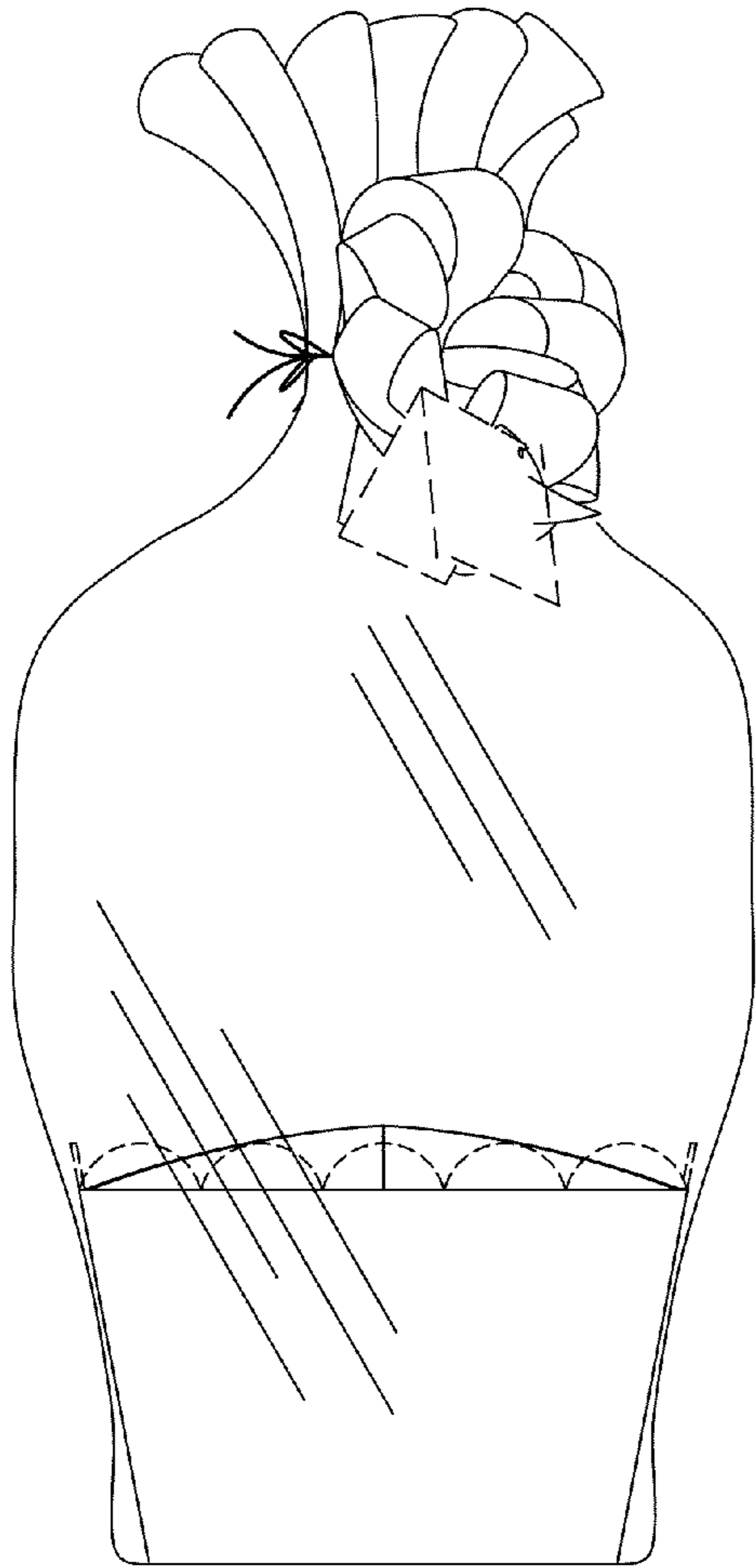

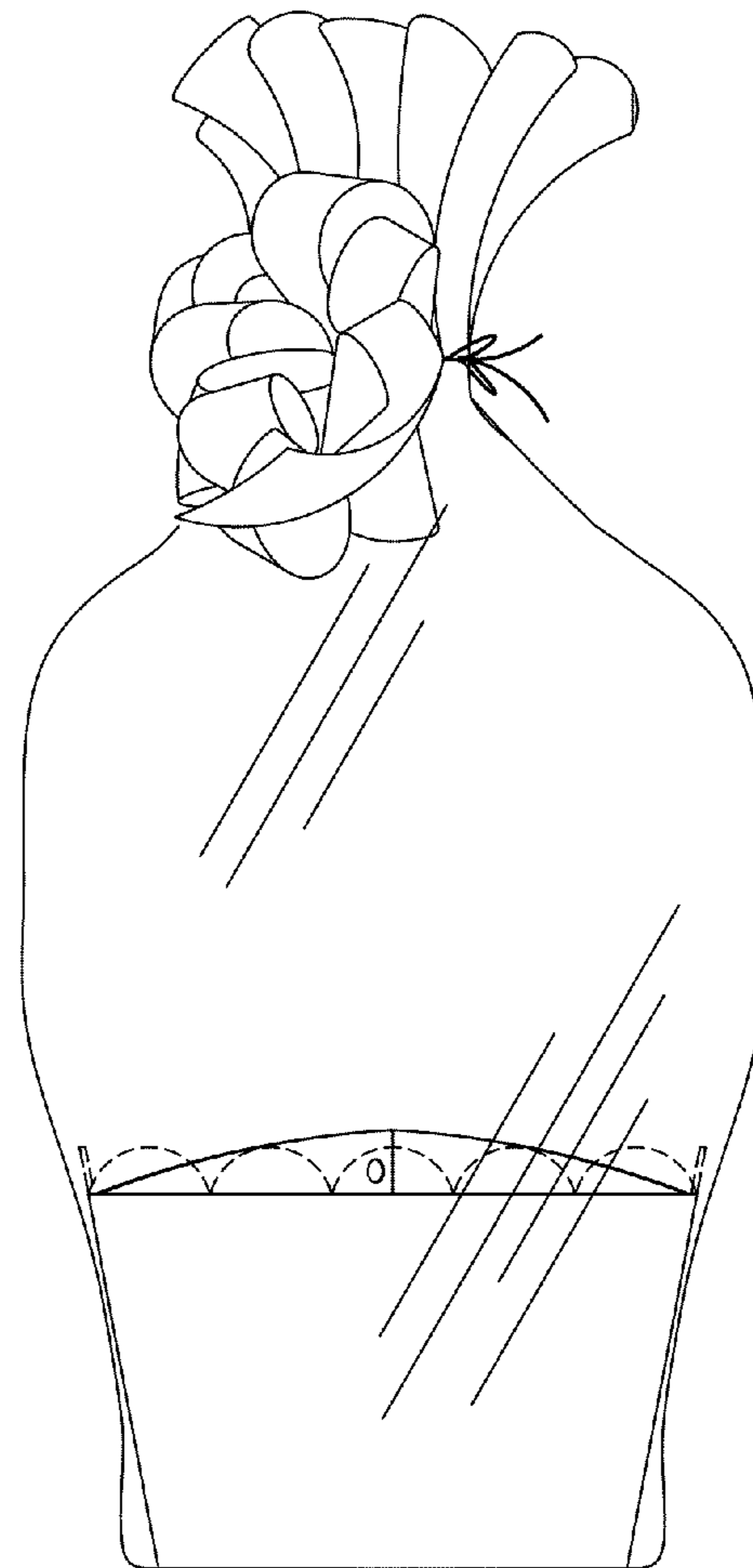
