(57) **CLAIM**

The ornamental design for a connectable wrist band and necklace, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of a first embodiment of a connectable wrist band and necklace shown broken away for purposes of illustrating the design at a larger scale, the back view being a mirror image;

FIG. 19 is a front side view thereof shown in an environment of use thereof;

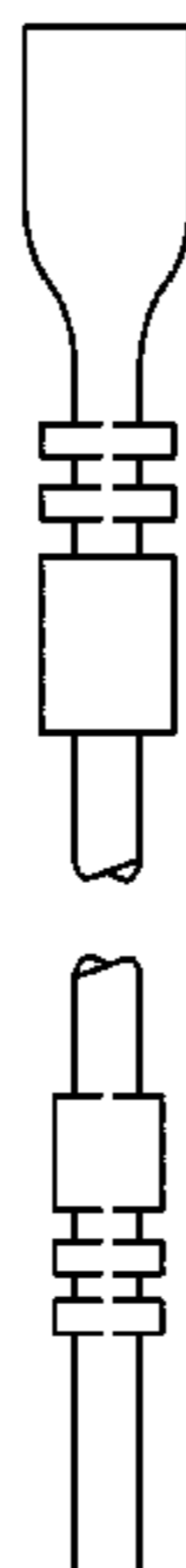
FIG. 20 is a front side view thereof shown in an environment of use thereof;

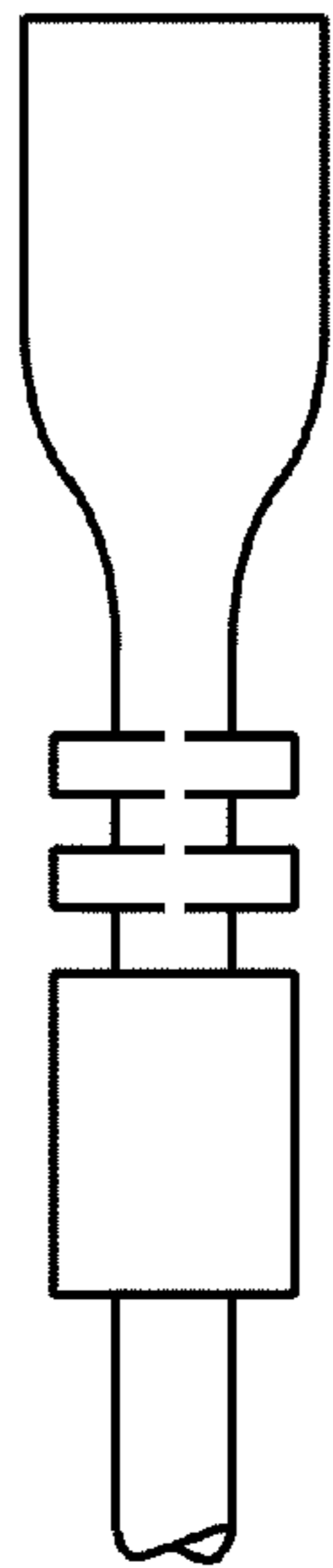

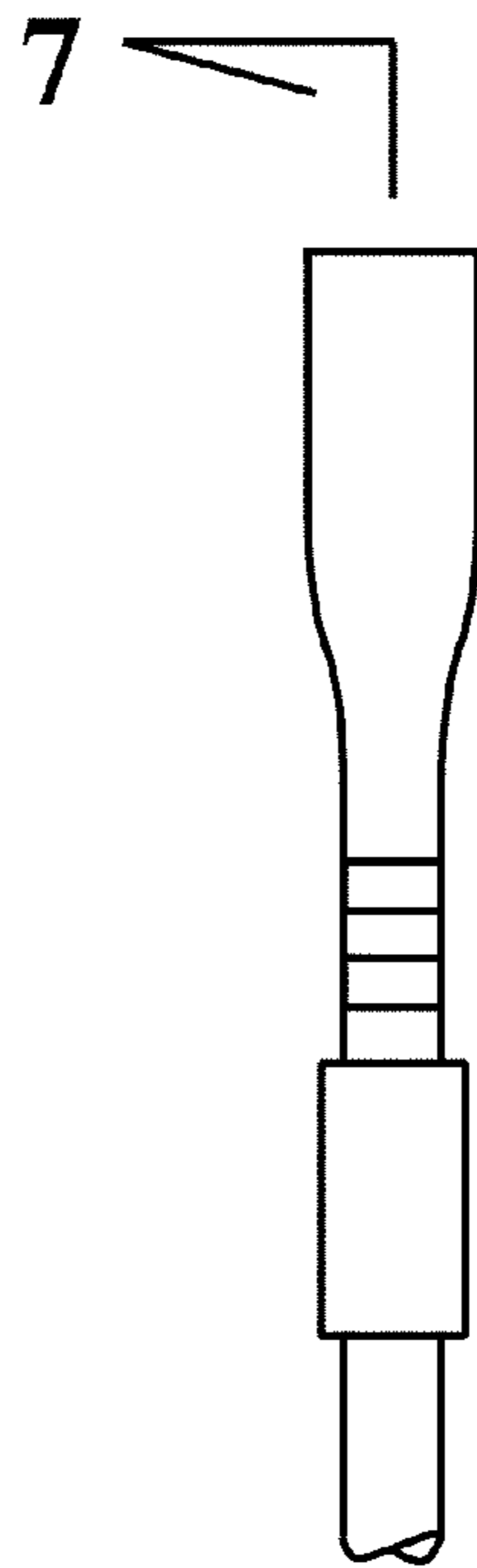

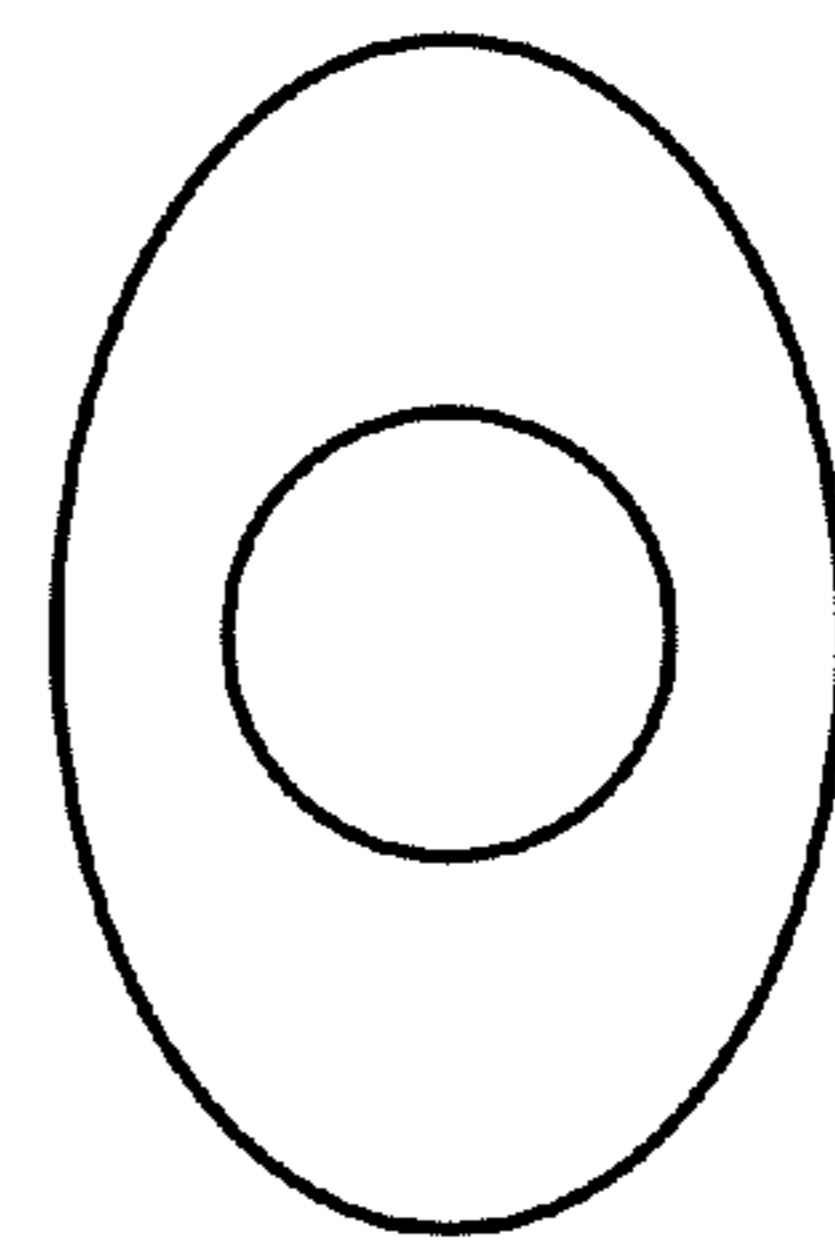

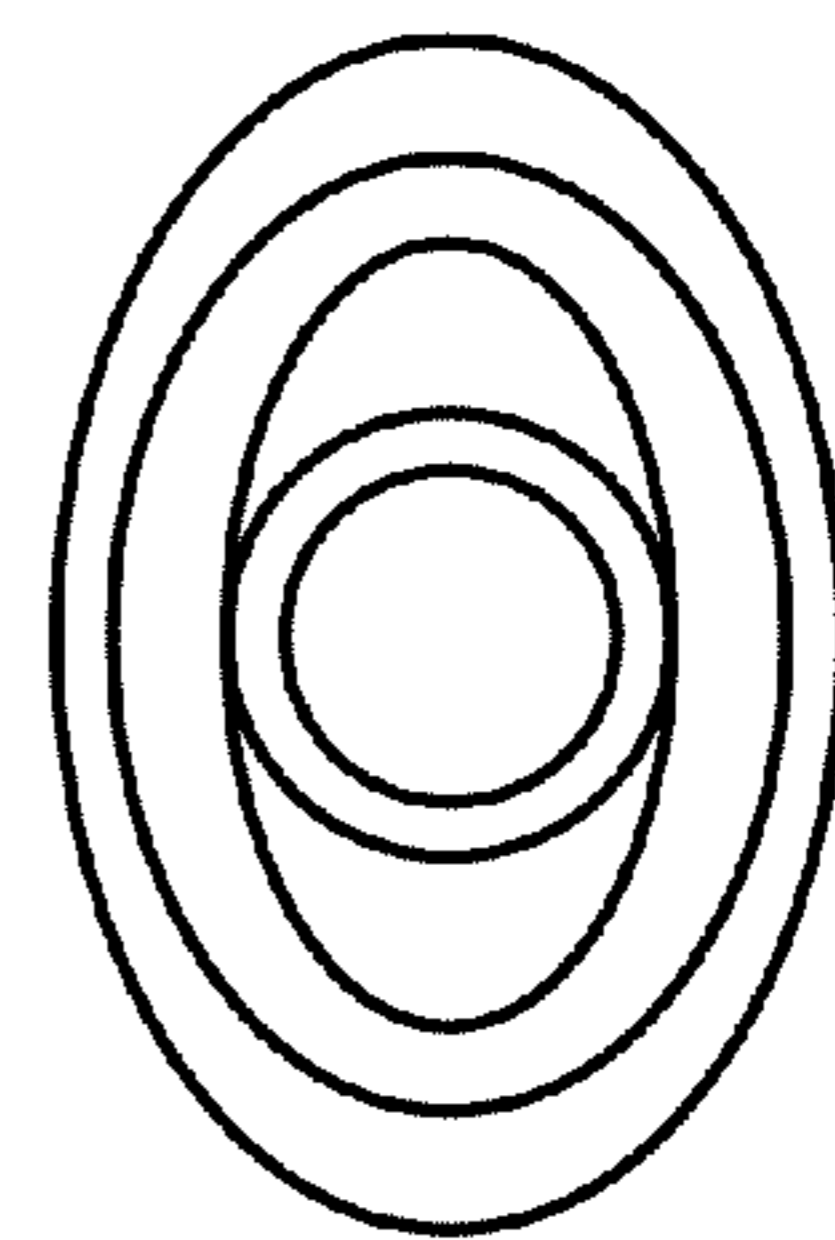
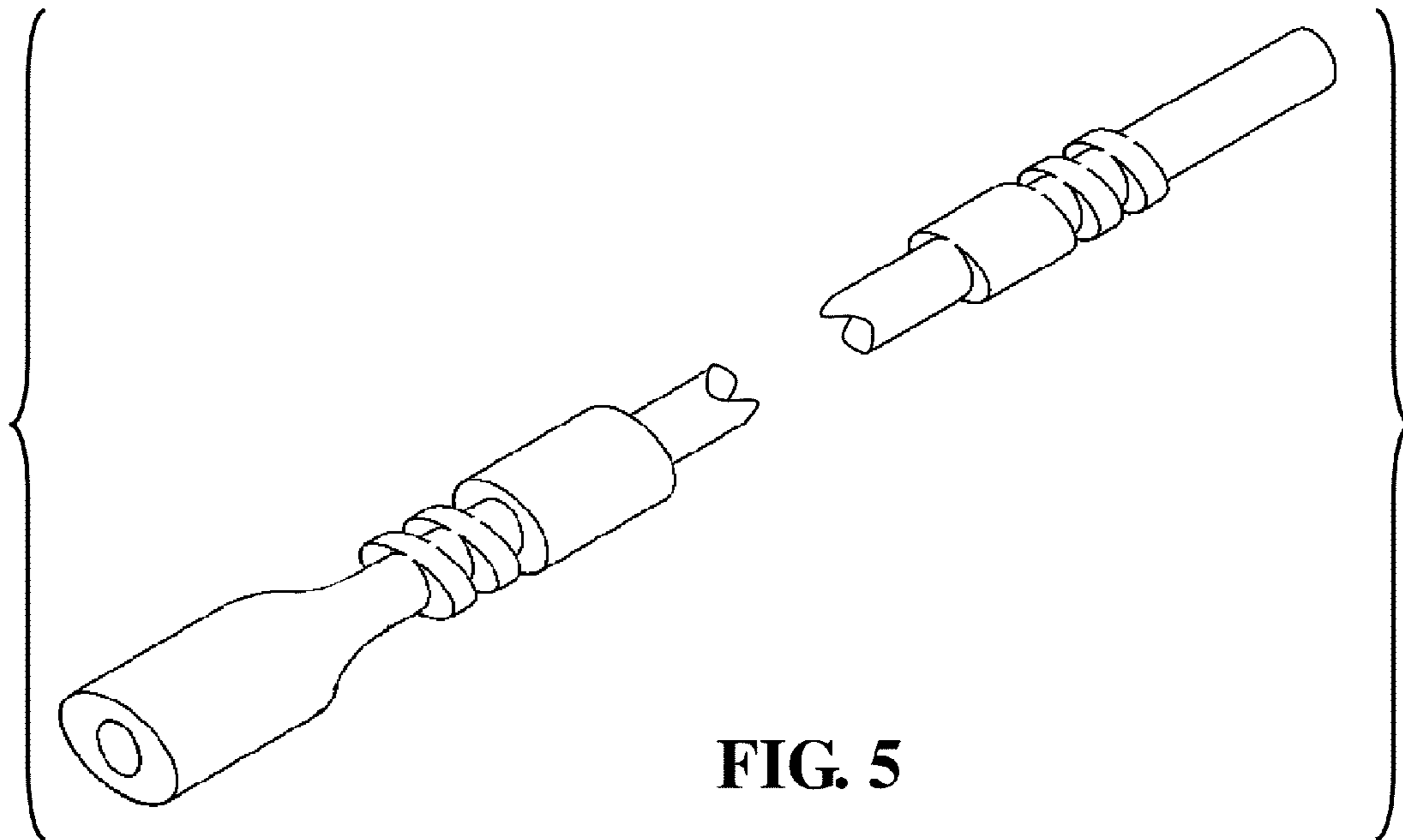
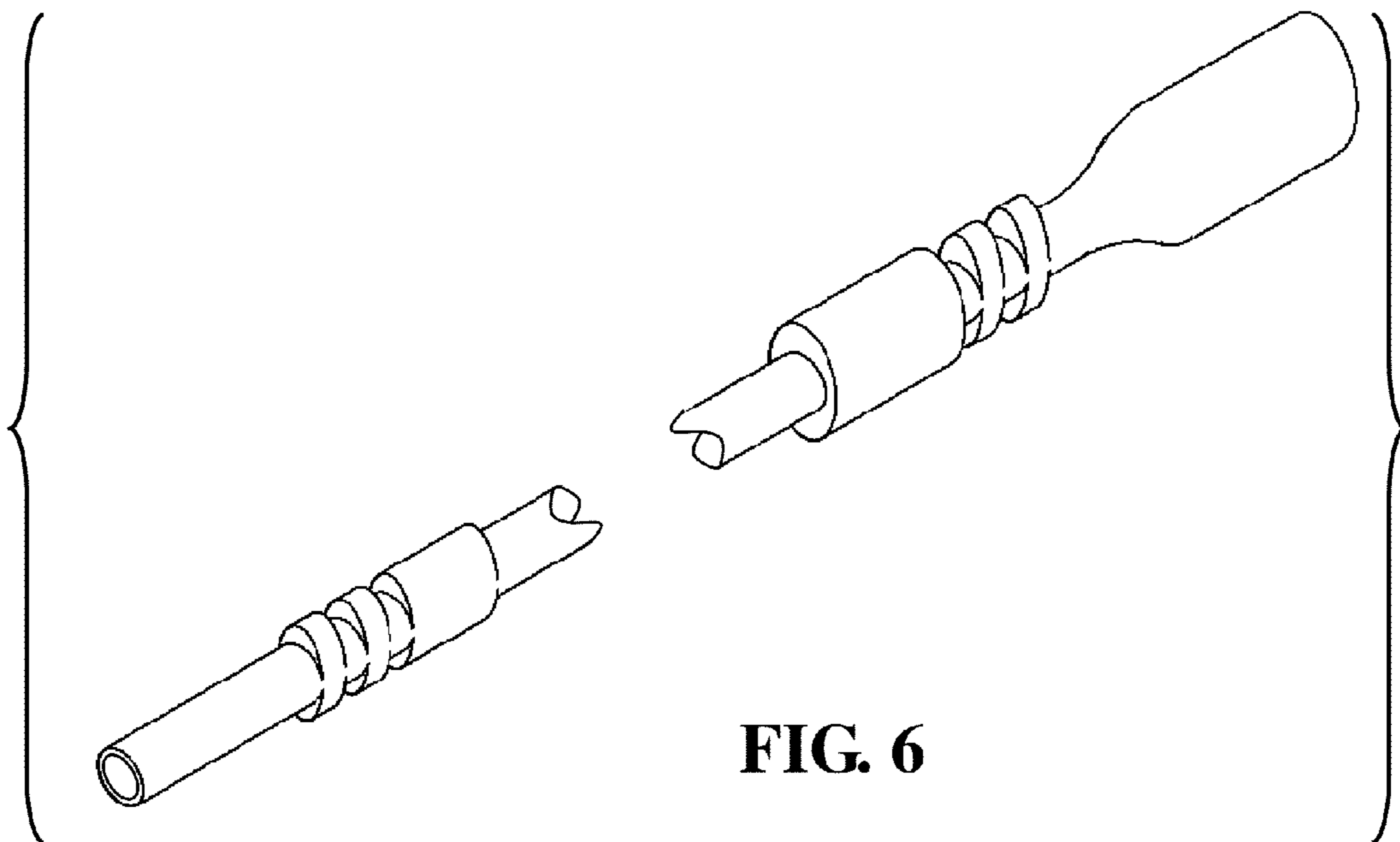


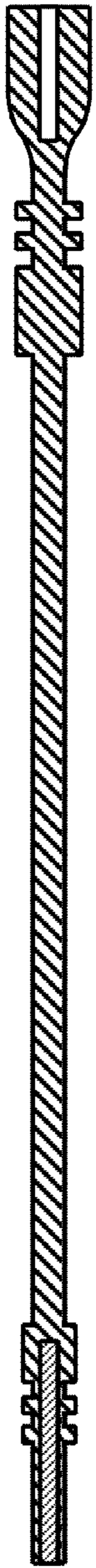

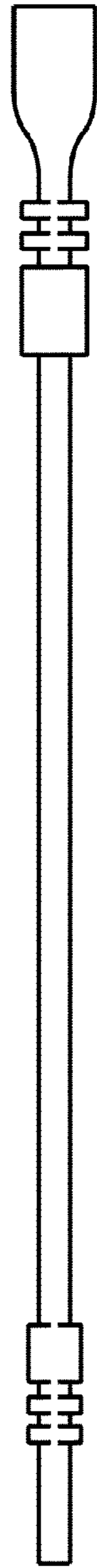

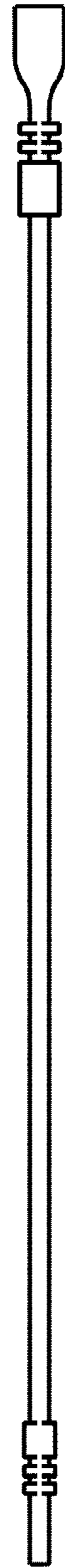

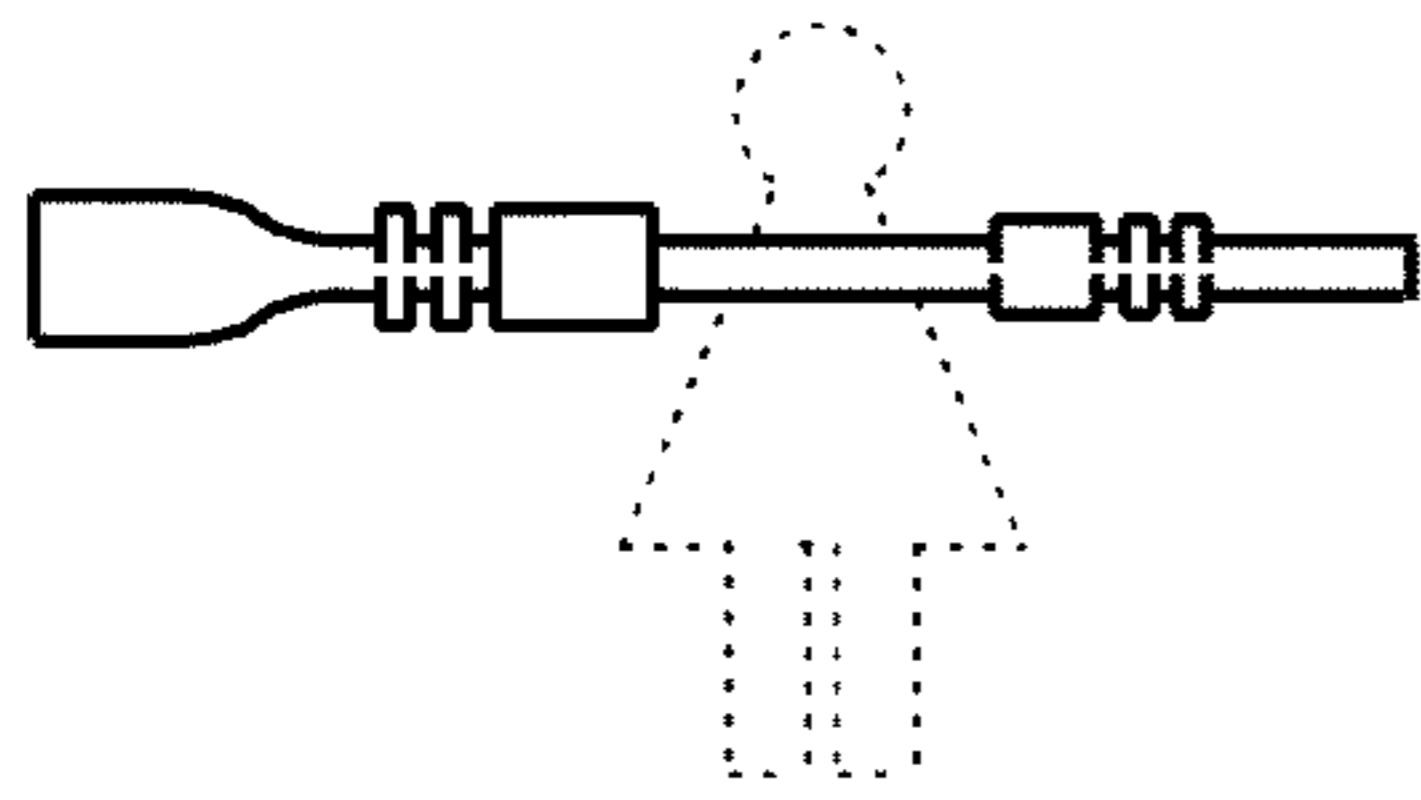

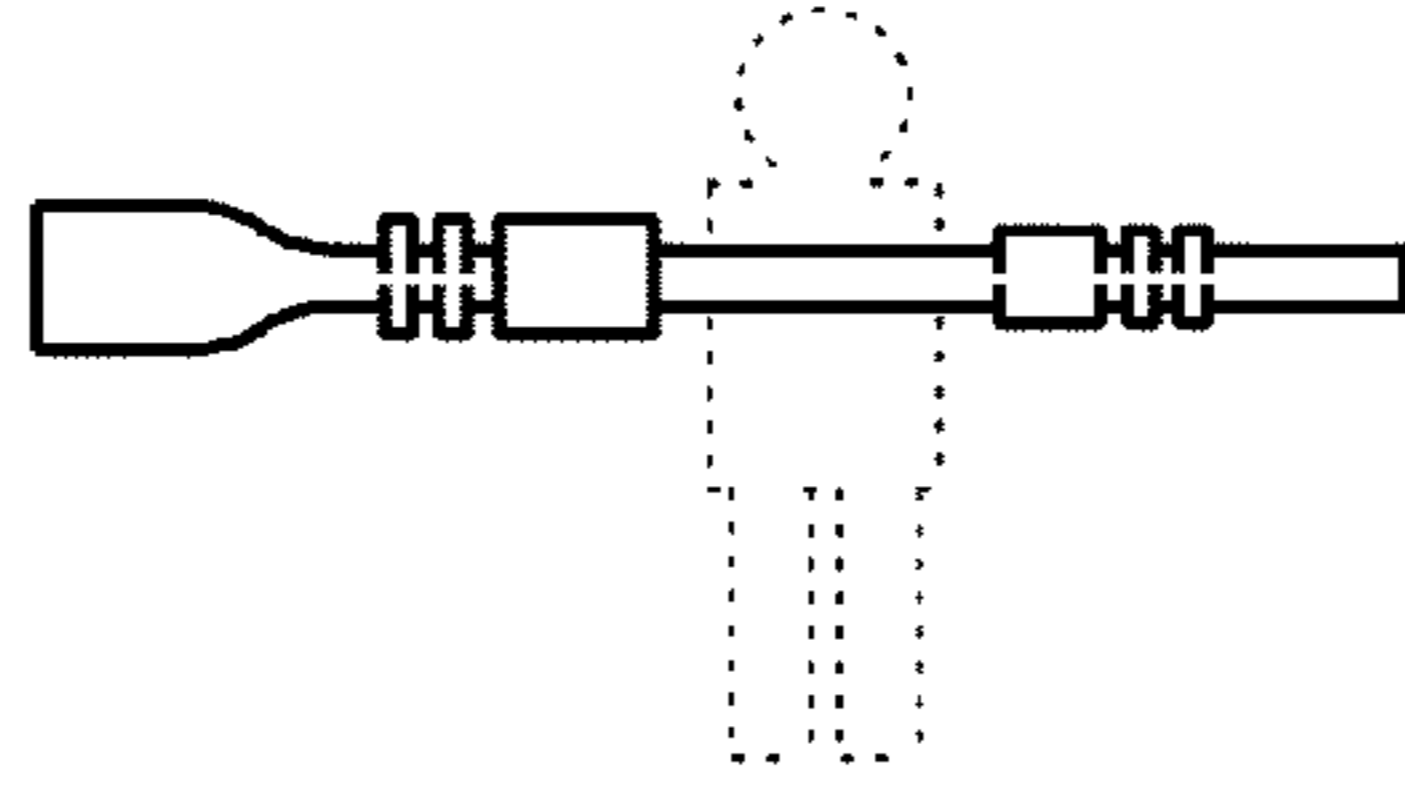

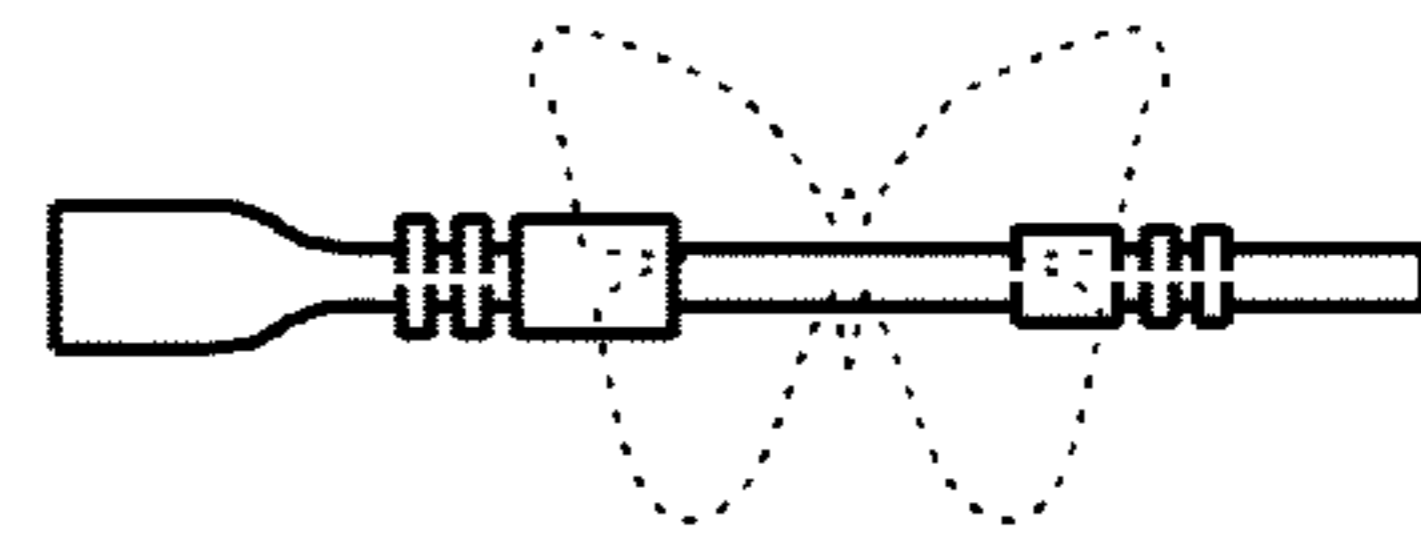

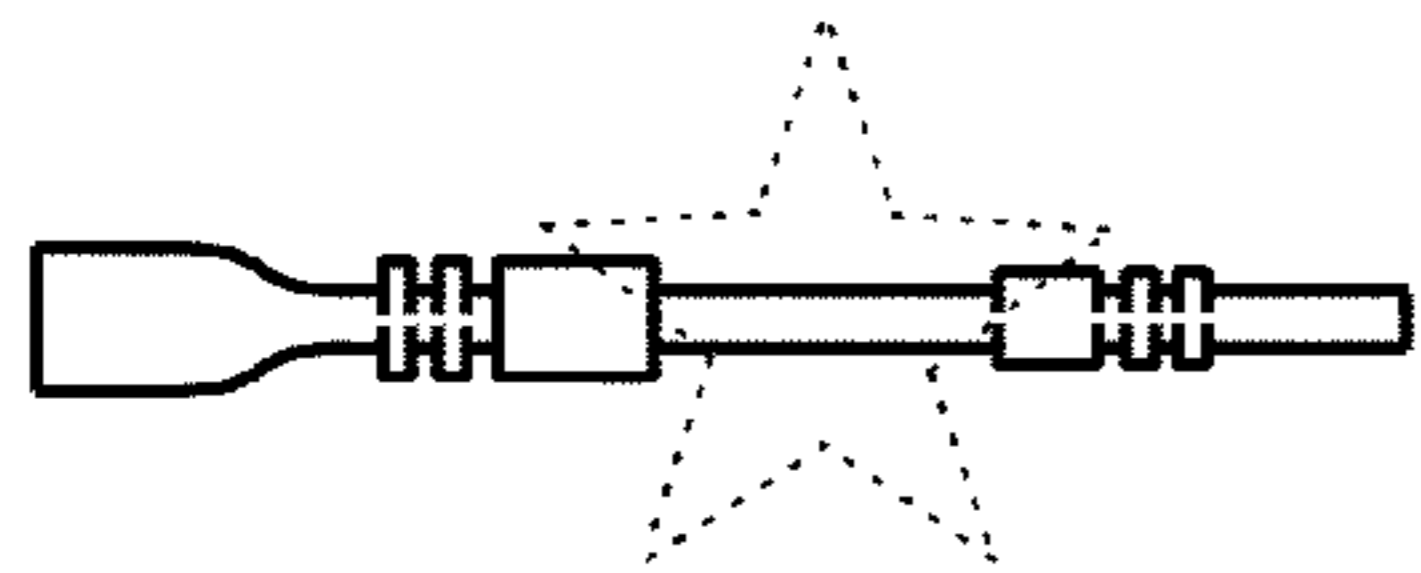

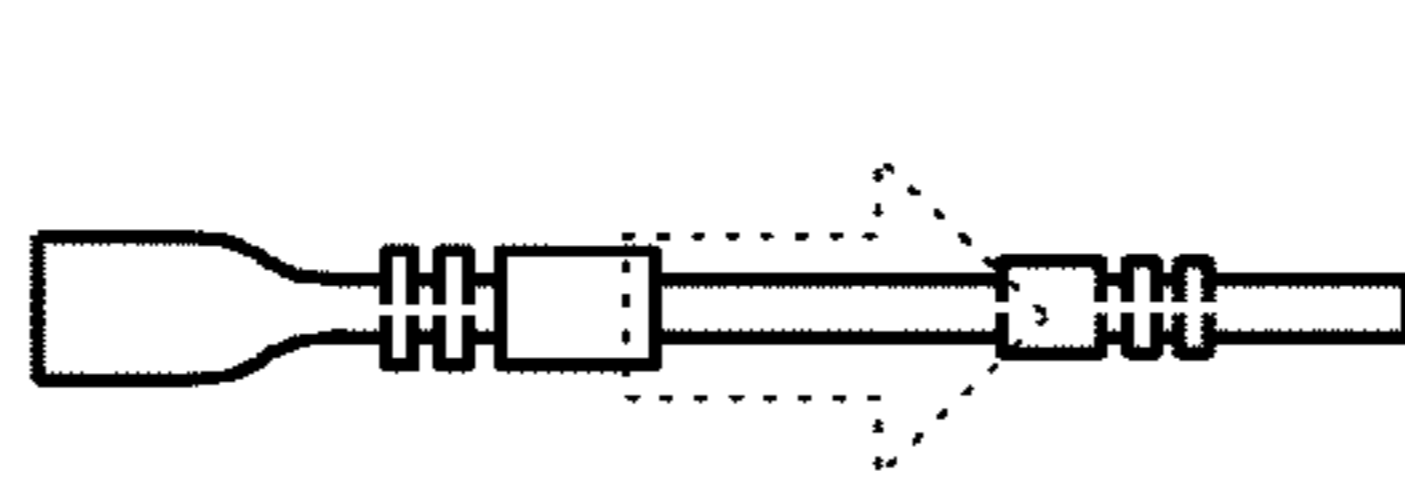

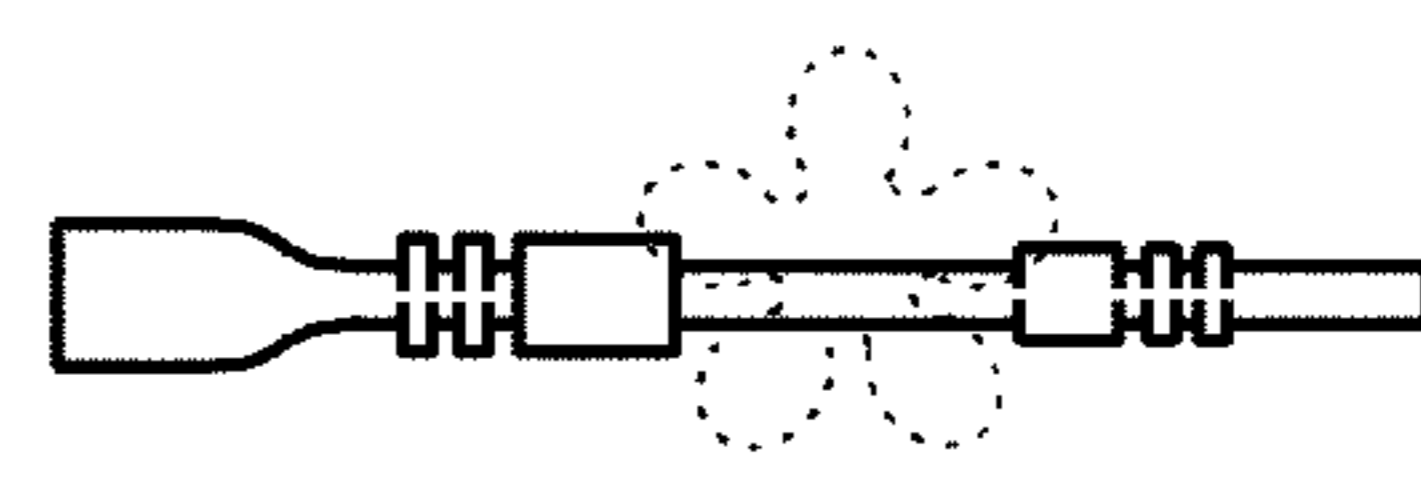

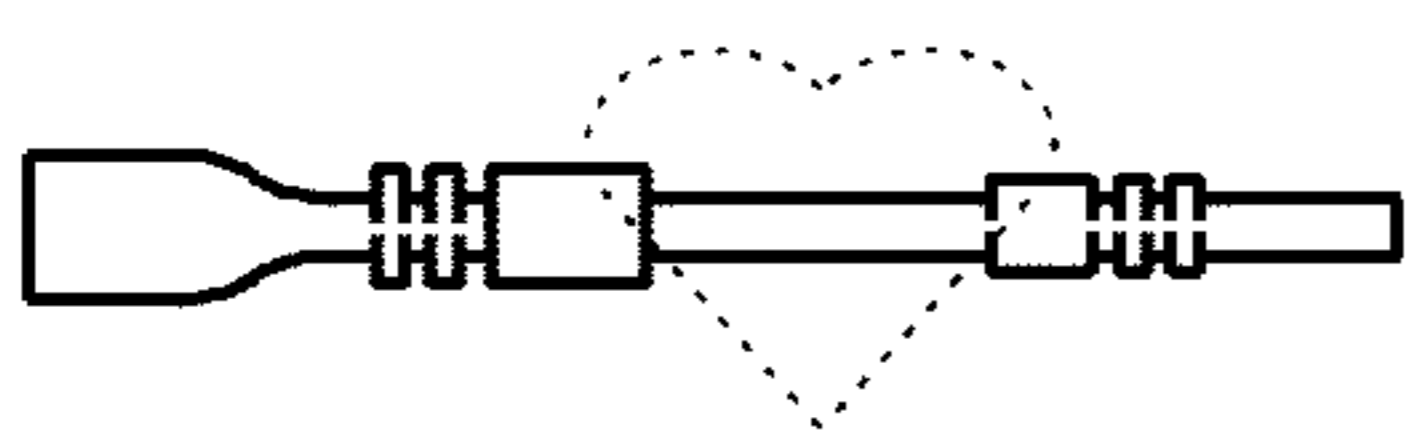

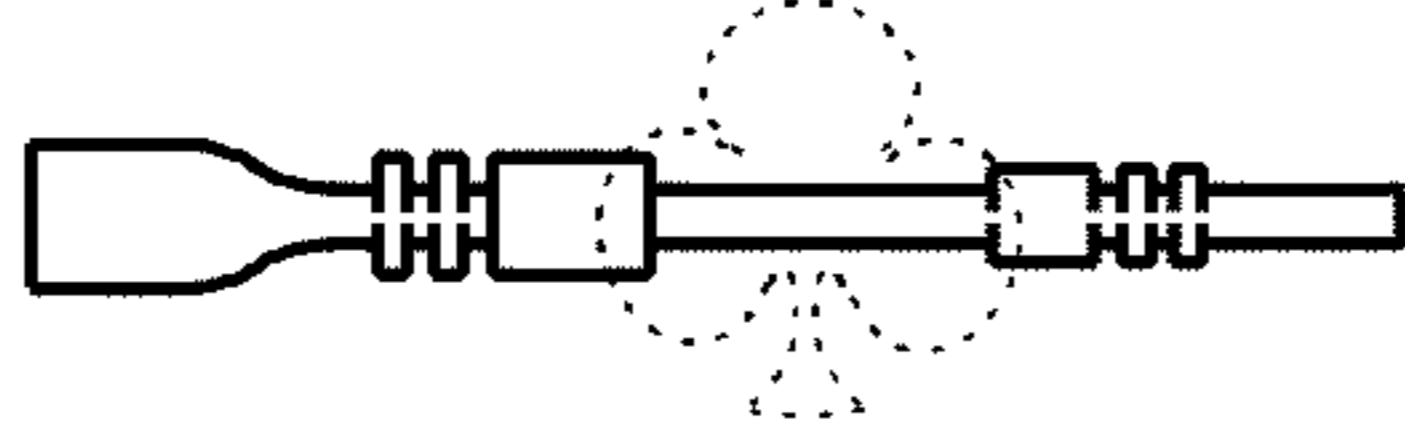

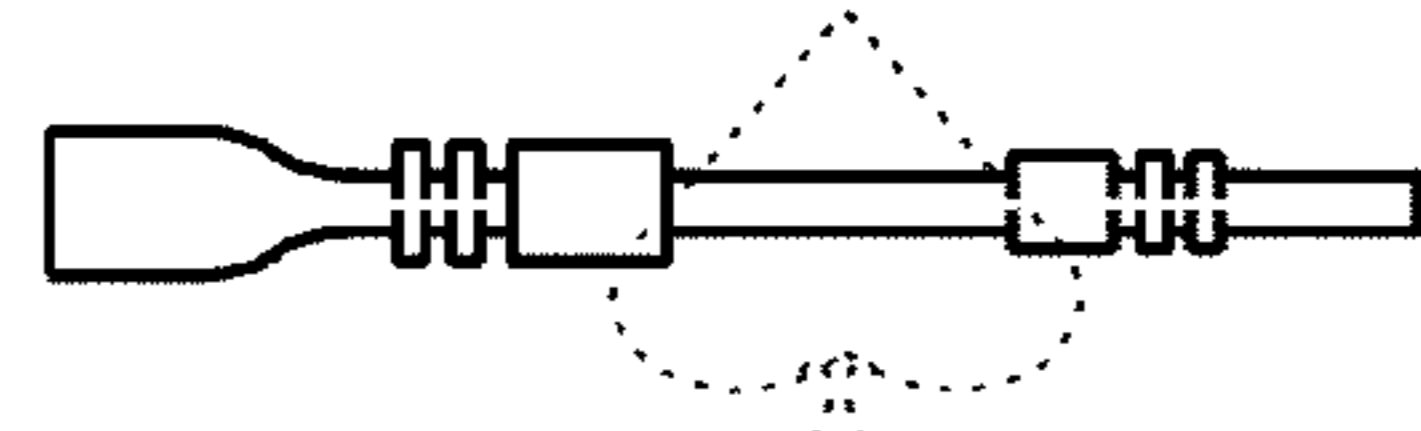

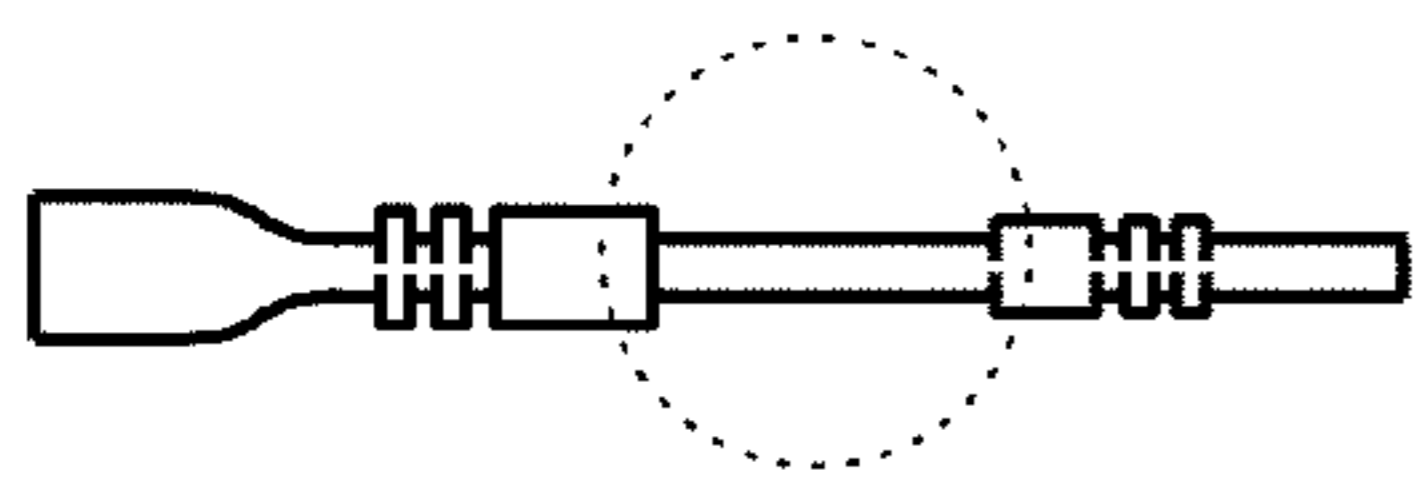

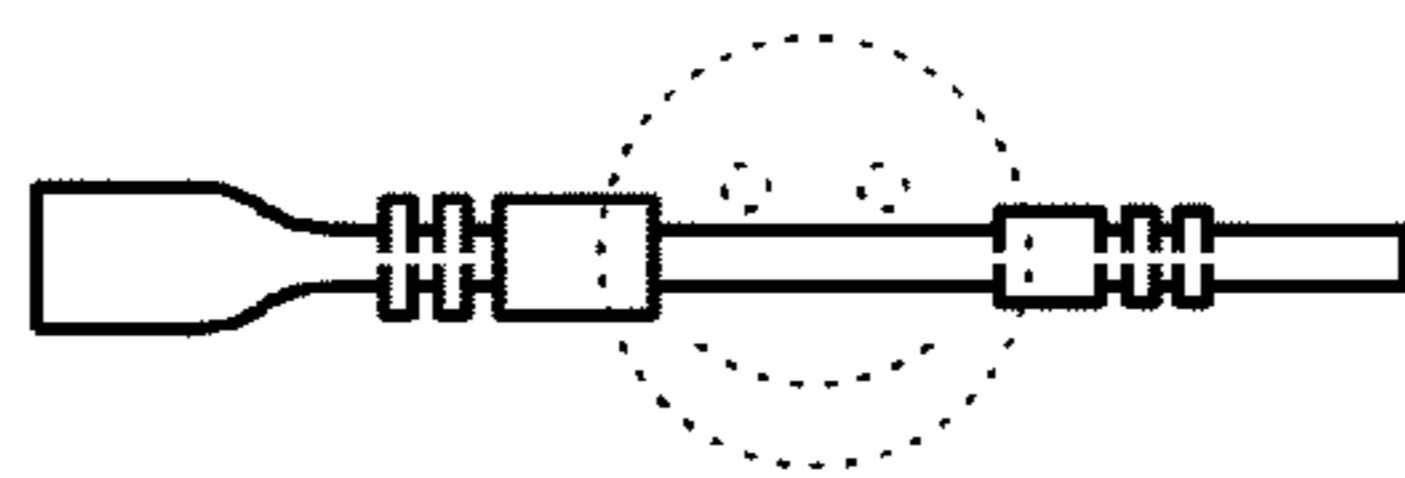

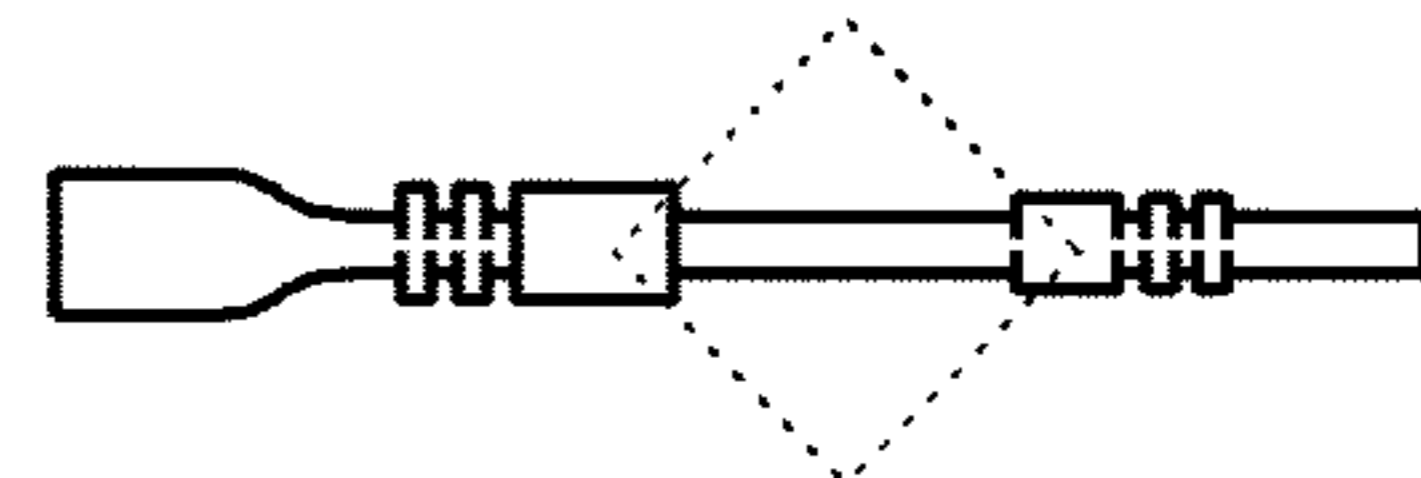
