DESCRIPTION

FIG. 1 is a perspective view of a portable recorder showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof;

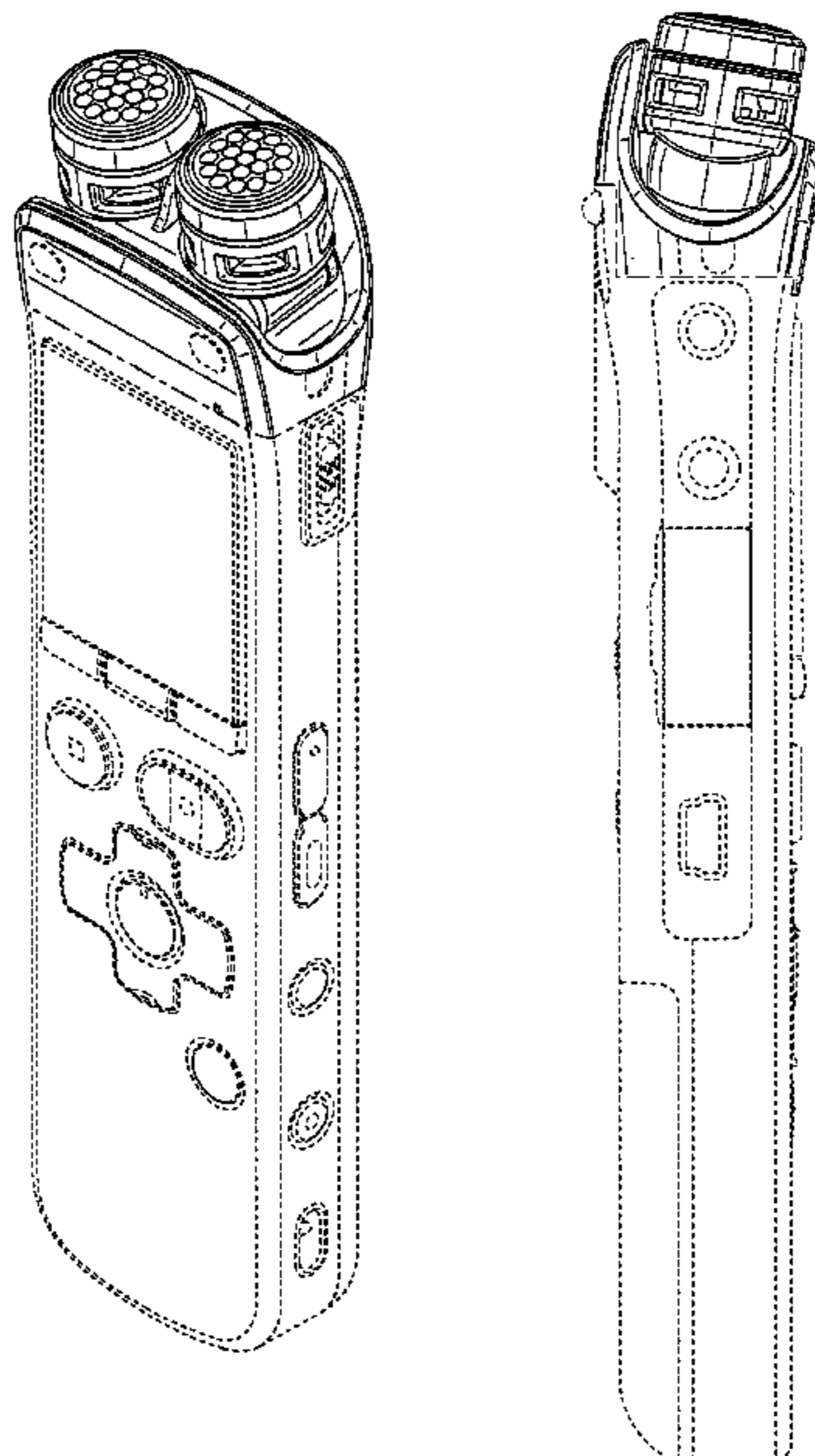

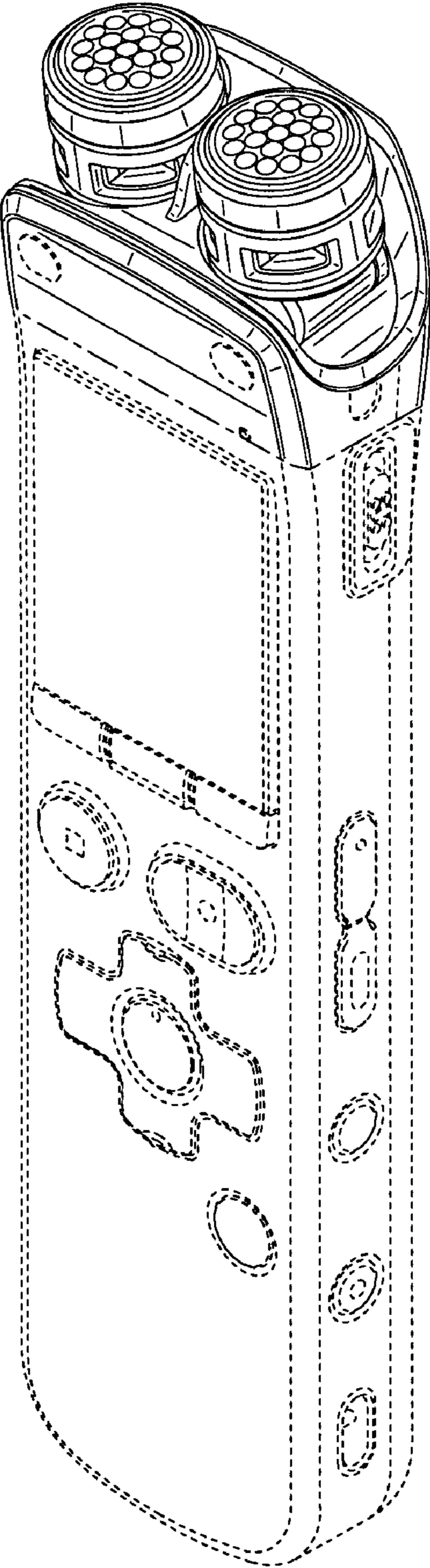

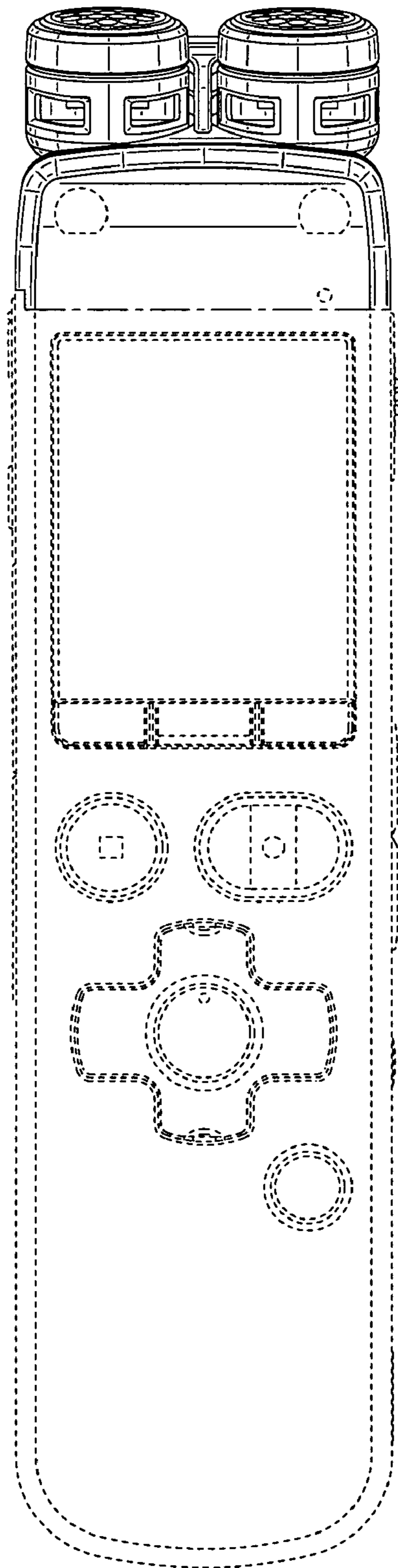

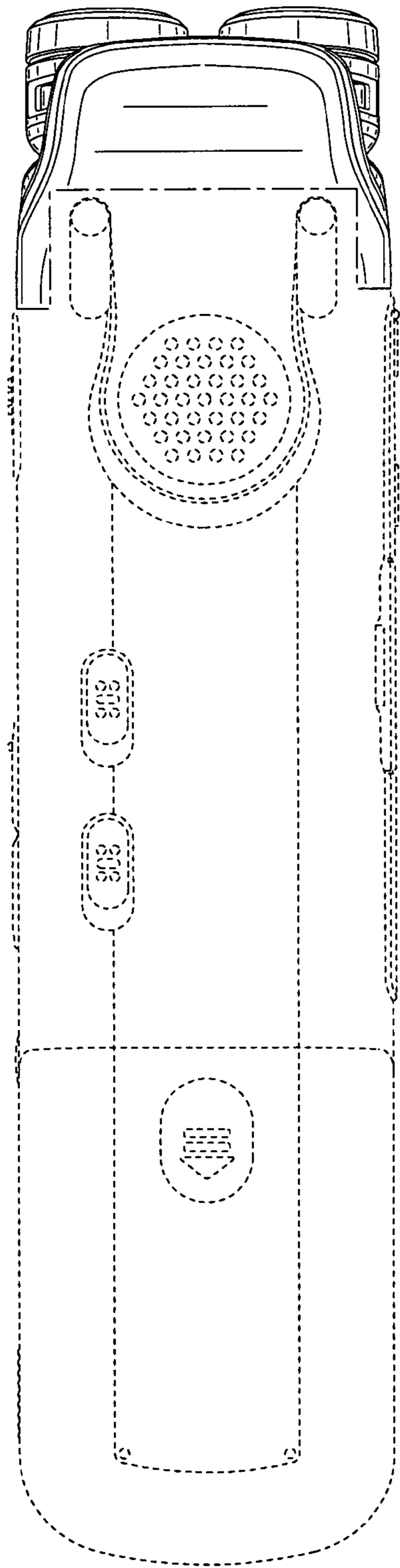

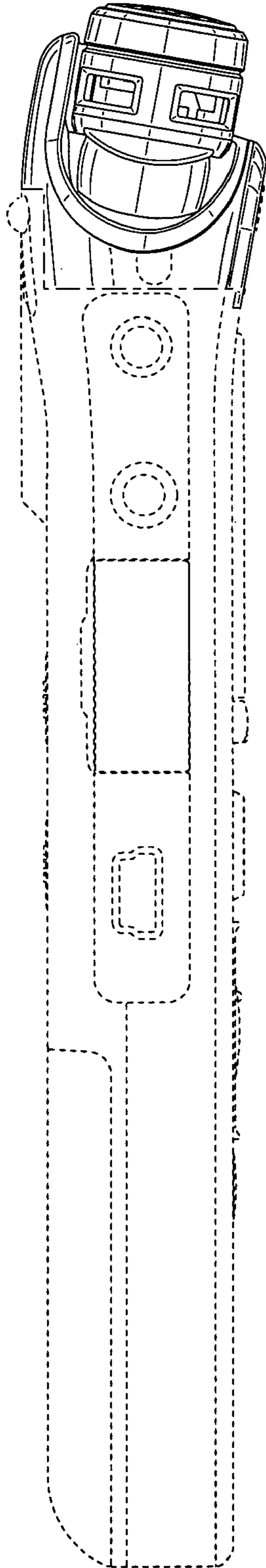

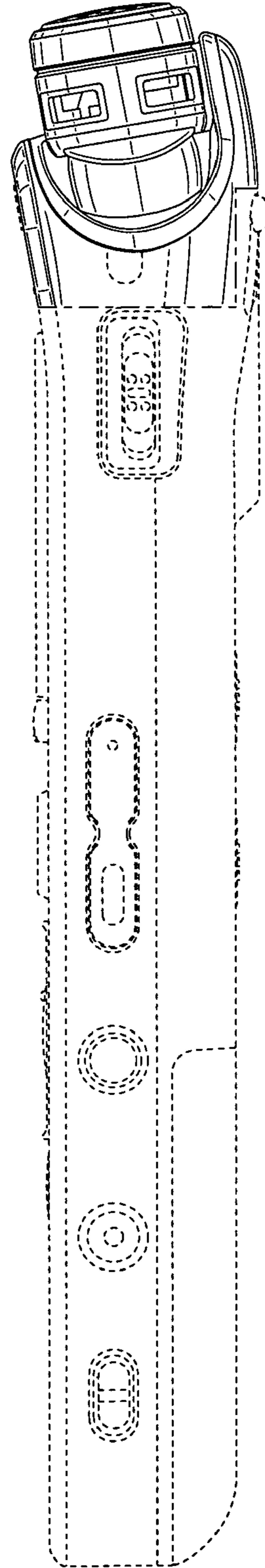

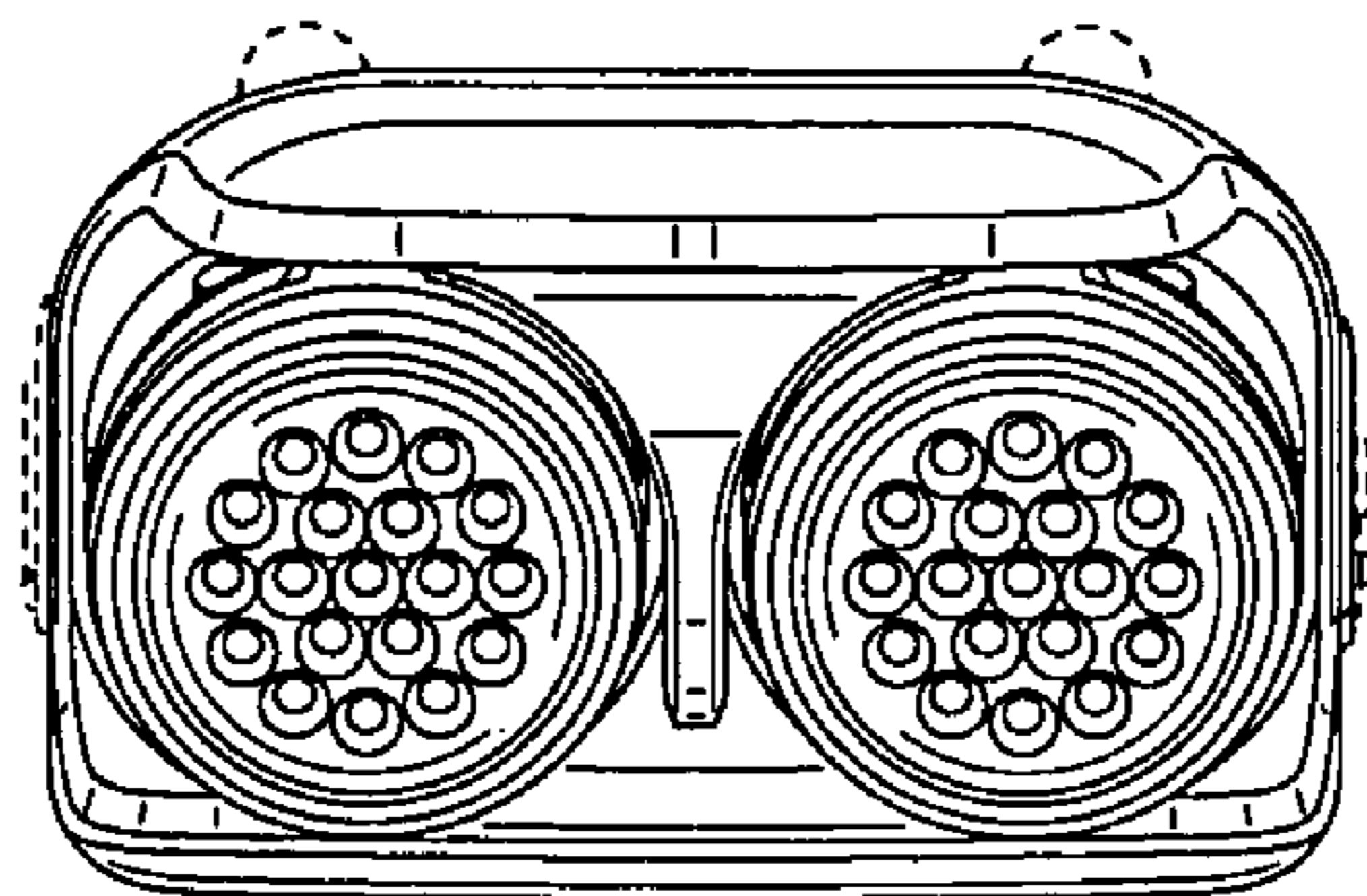
