**DESCRIPTION**

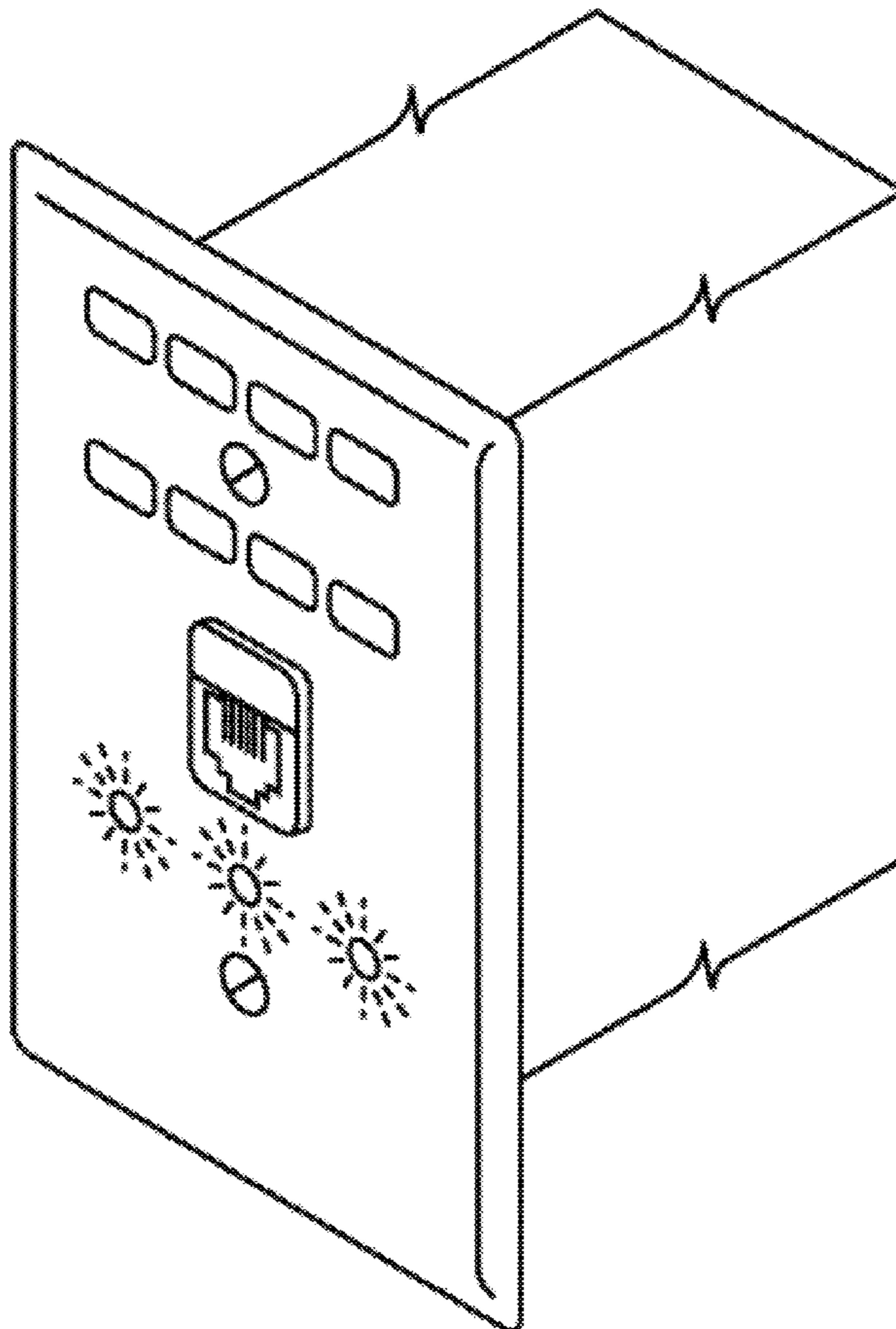
FIG. 1 is a perspective view of a wall plate for universal telephonic gateway;

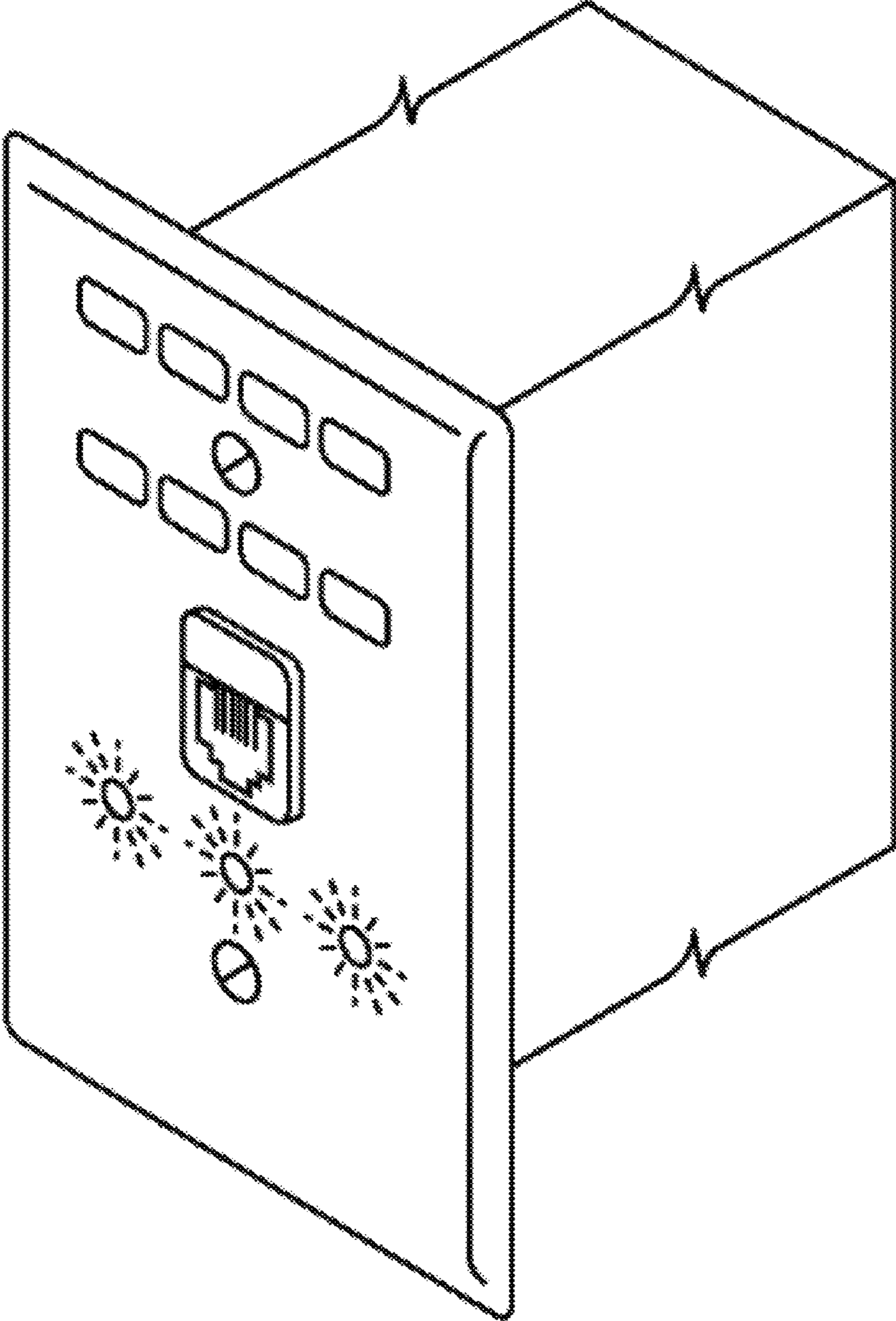

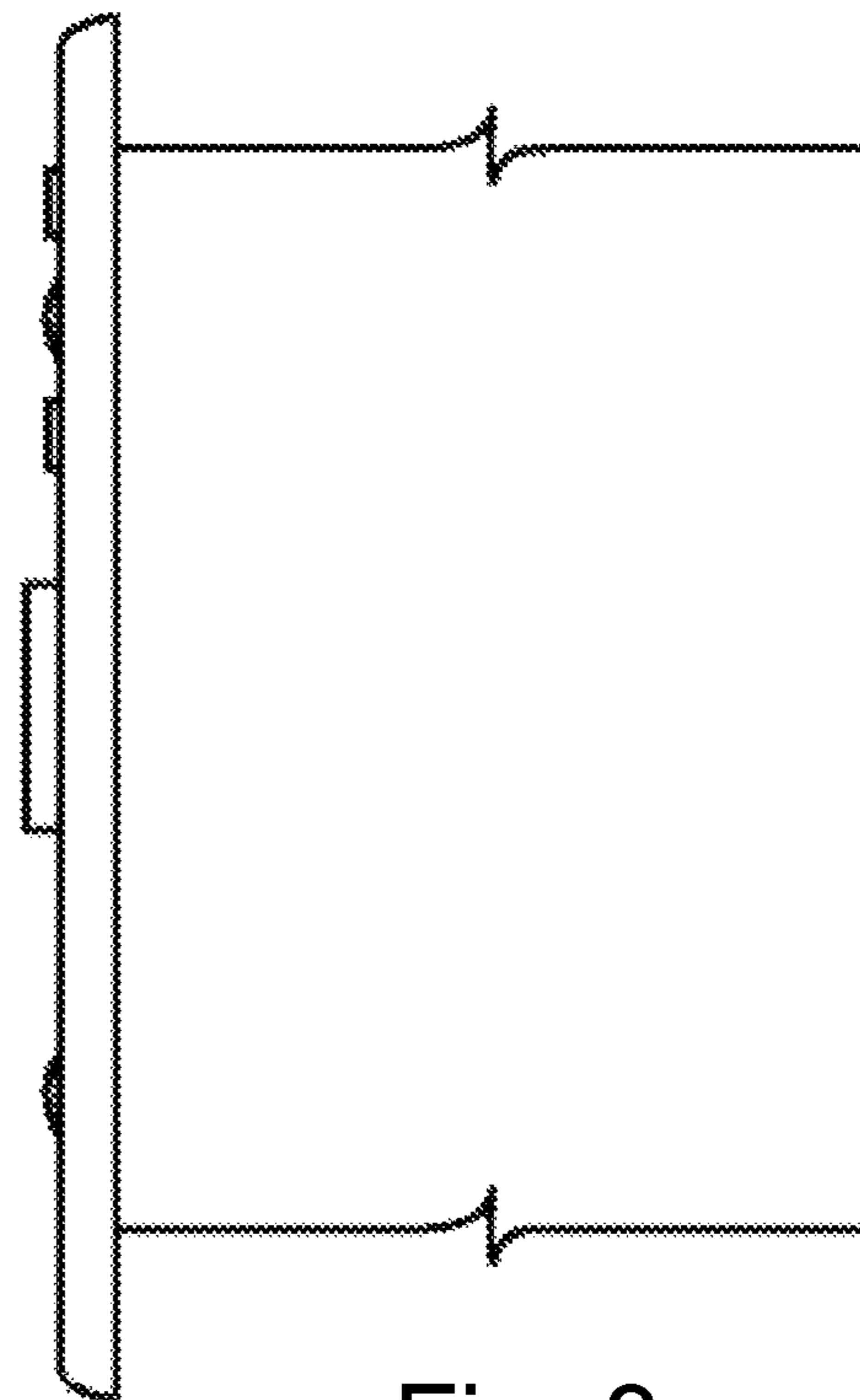
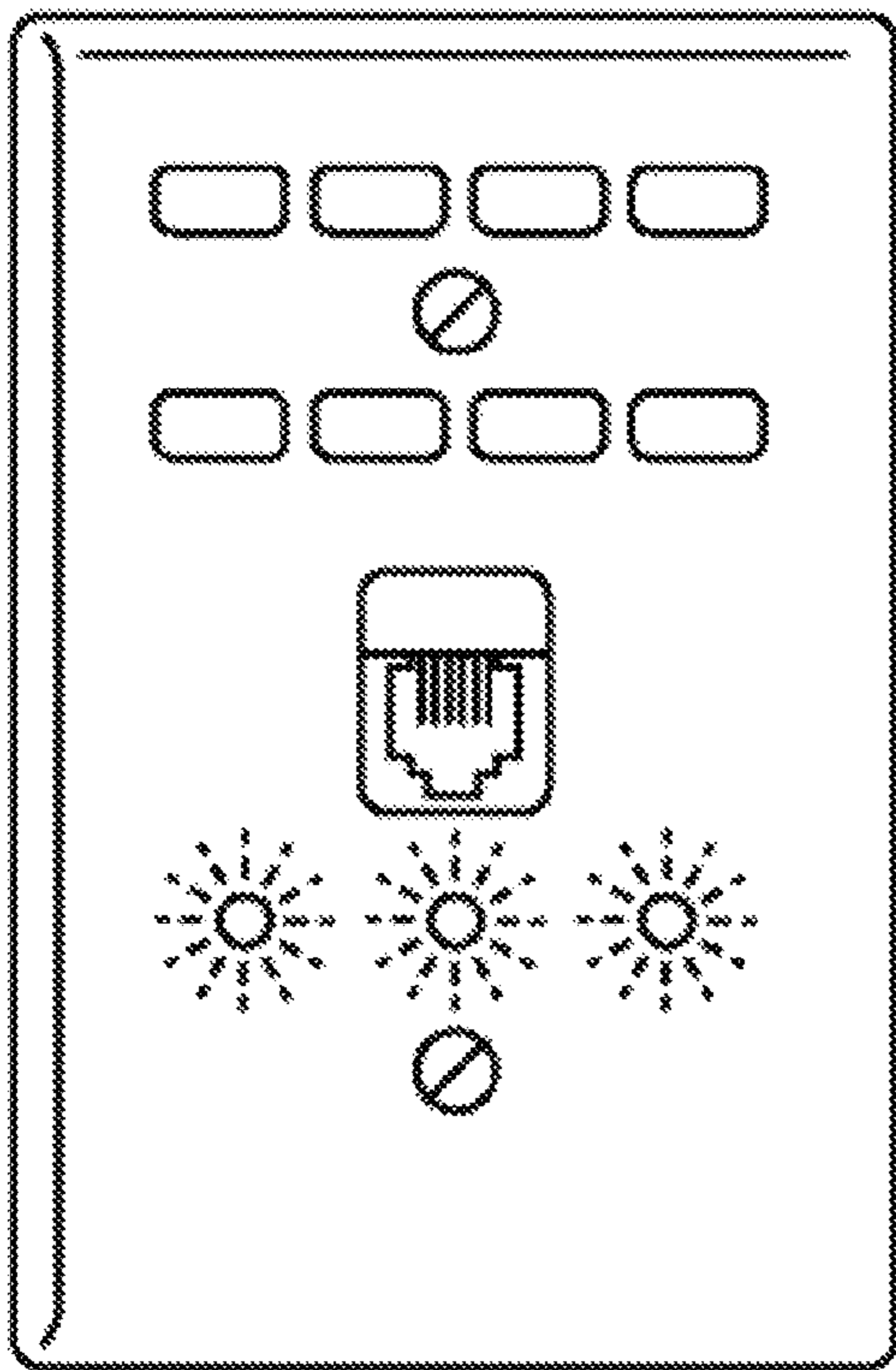

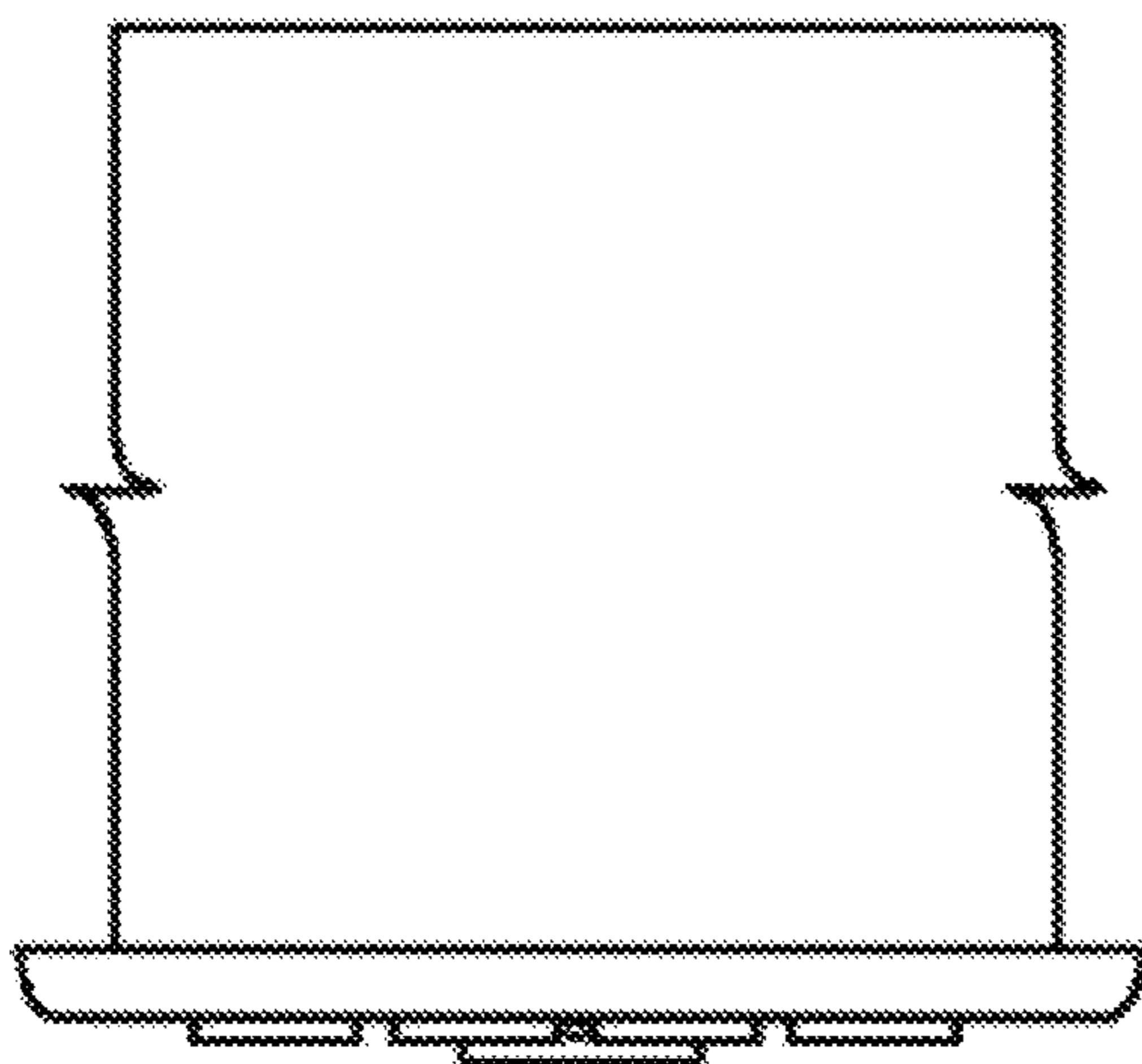
