The ornamental design for a toss game, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded bottom perspective view of a toss game showing my design;

FIG. 2 is a top perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is an enlarged front elevational of a red bean bag, also shown in FIG. 1.

FIG. 5 is a side elevational view of FIG. 4;

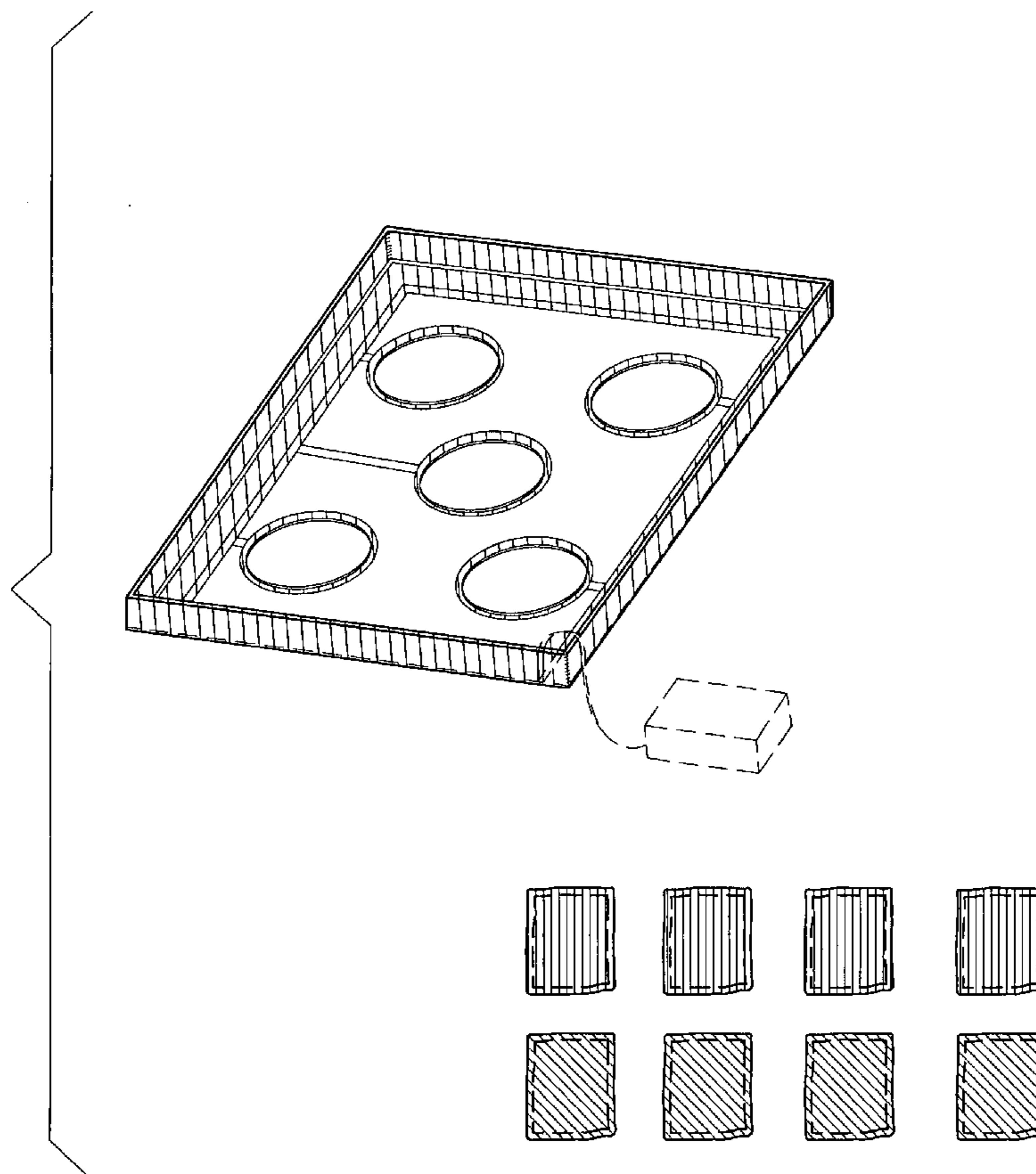
FIG. 6 is an enlarged front elevational view of a green bean bag, also shown in FIG. 1; and,

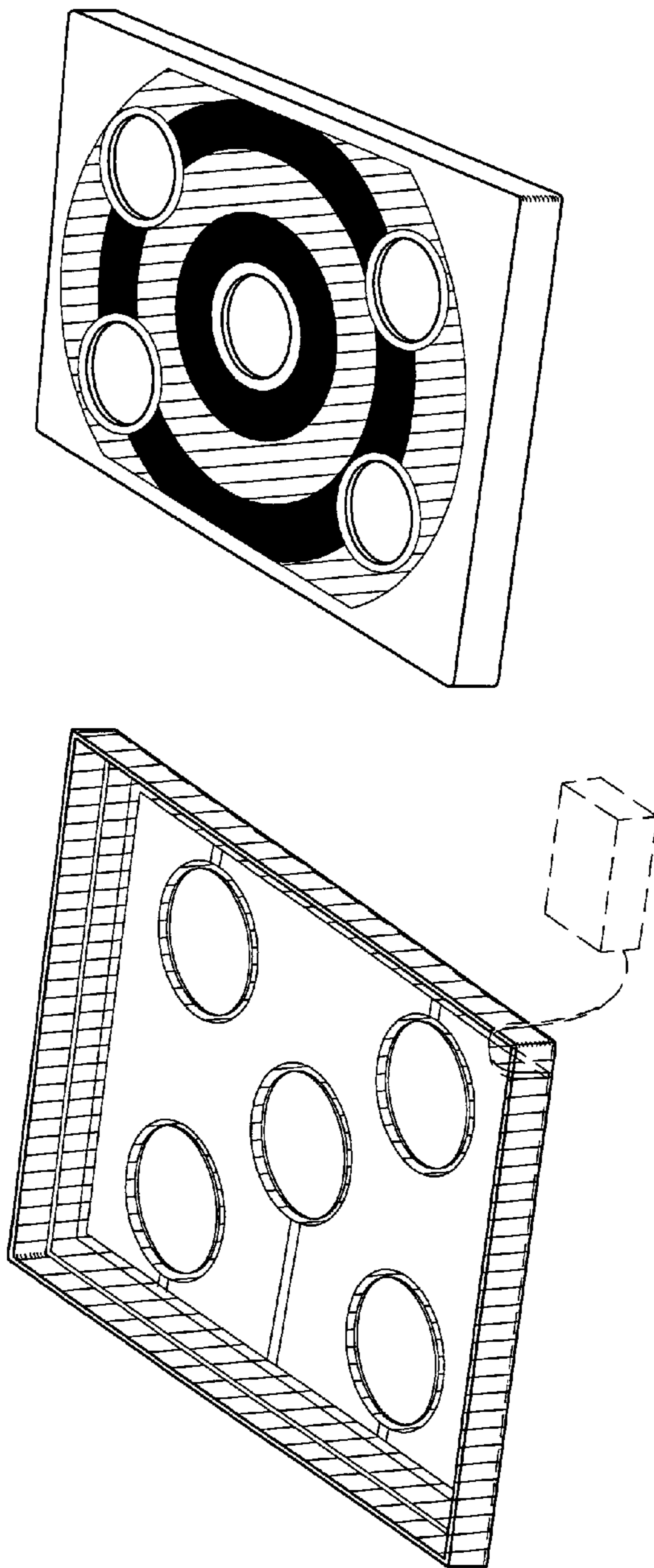
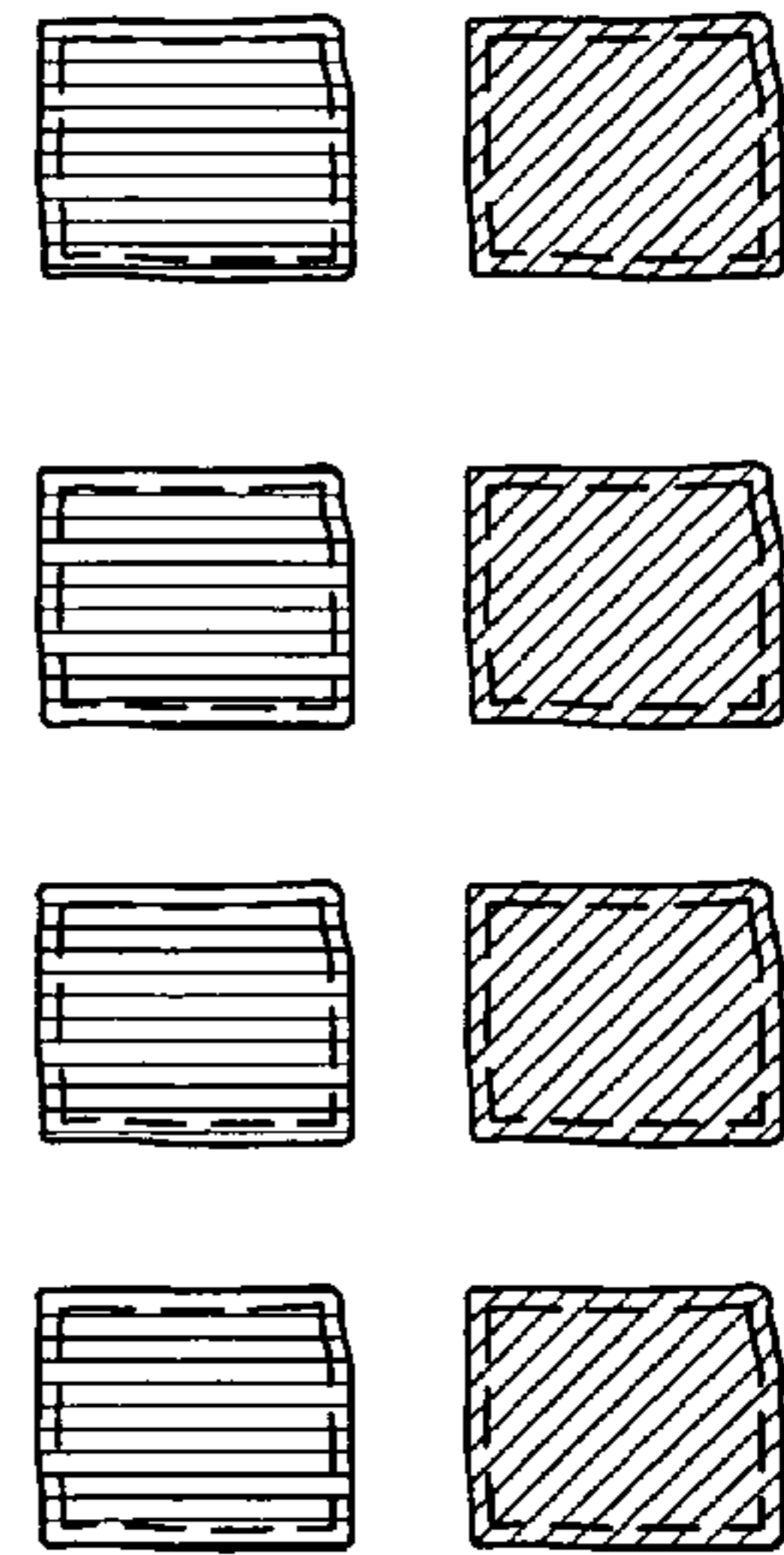

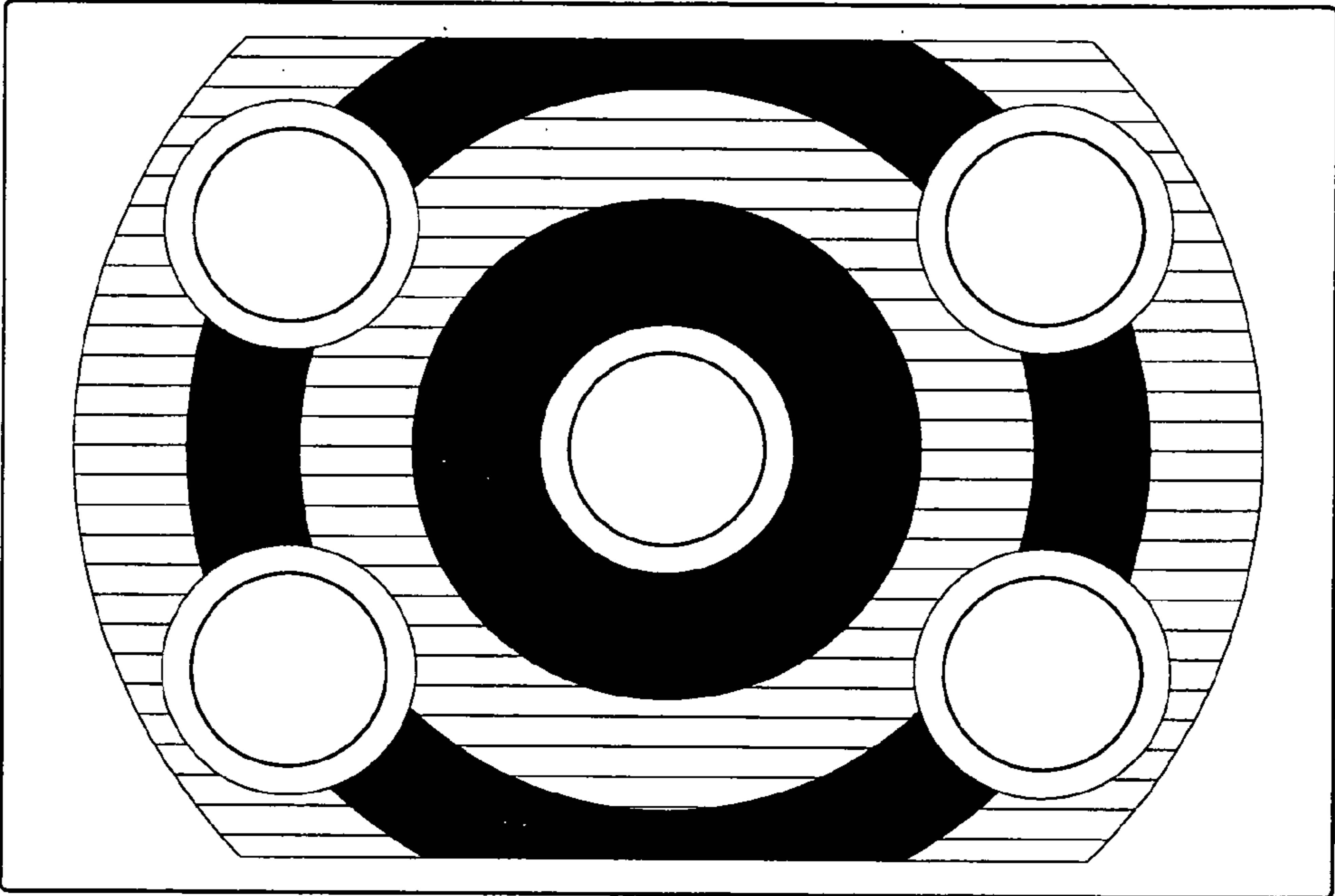

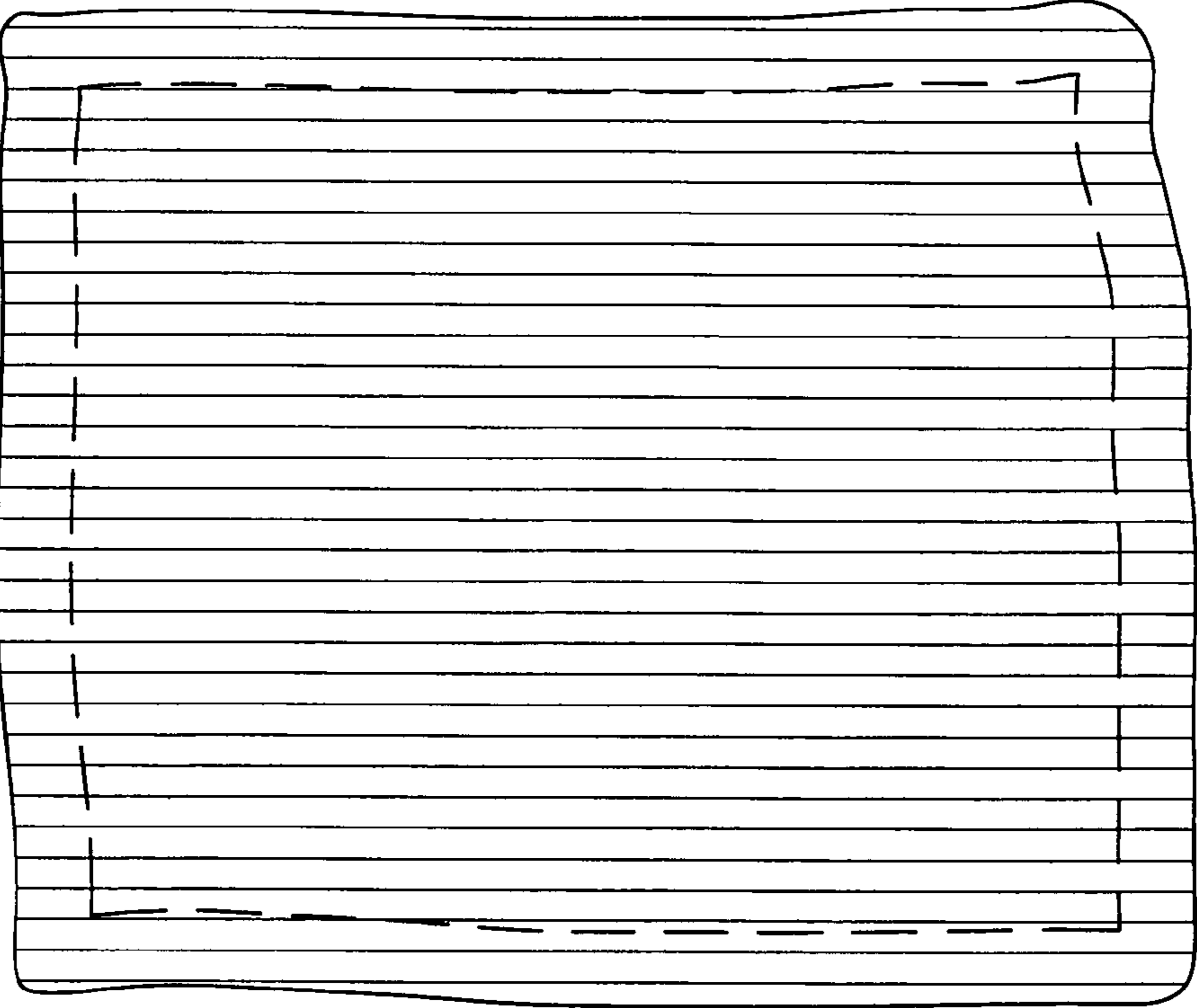

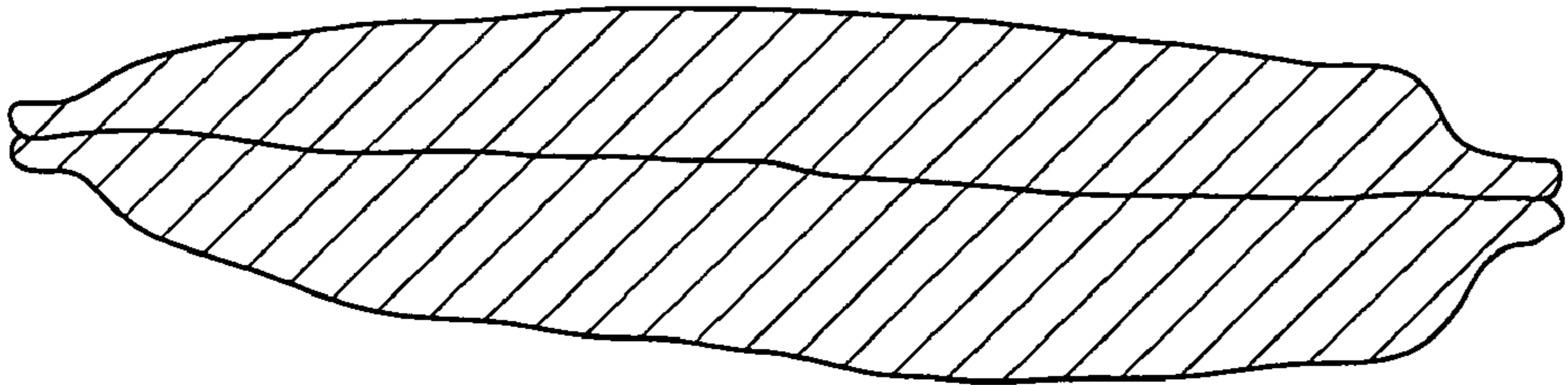

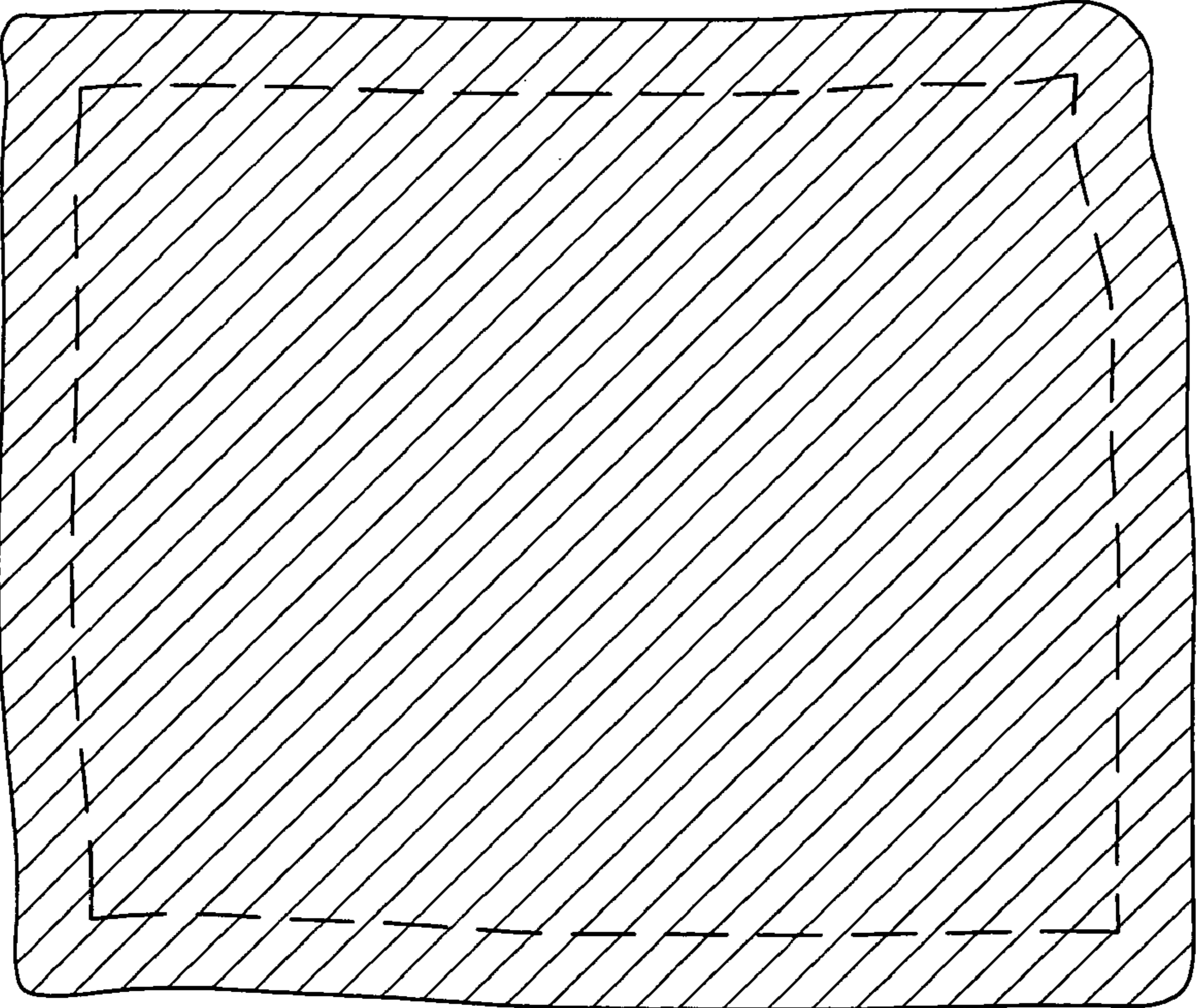
