(57) **CLAIM**

The ornamental design for a dental floss holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the dental floss holder according to the new design;

FIG. 2 is a right side view, the left side being a mirror image thereof;

FIG. 3 is a front view thereof;

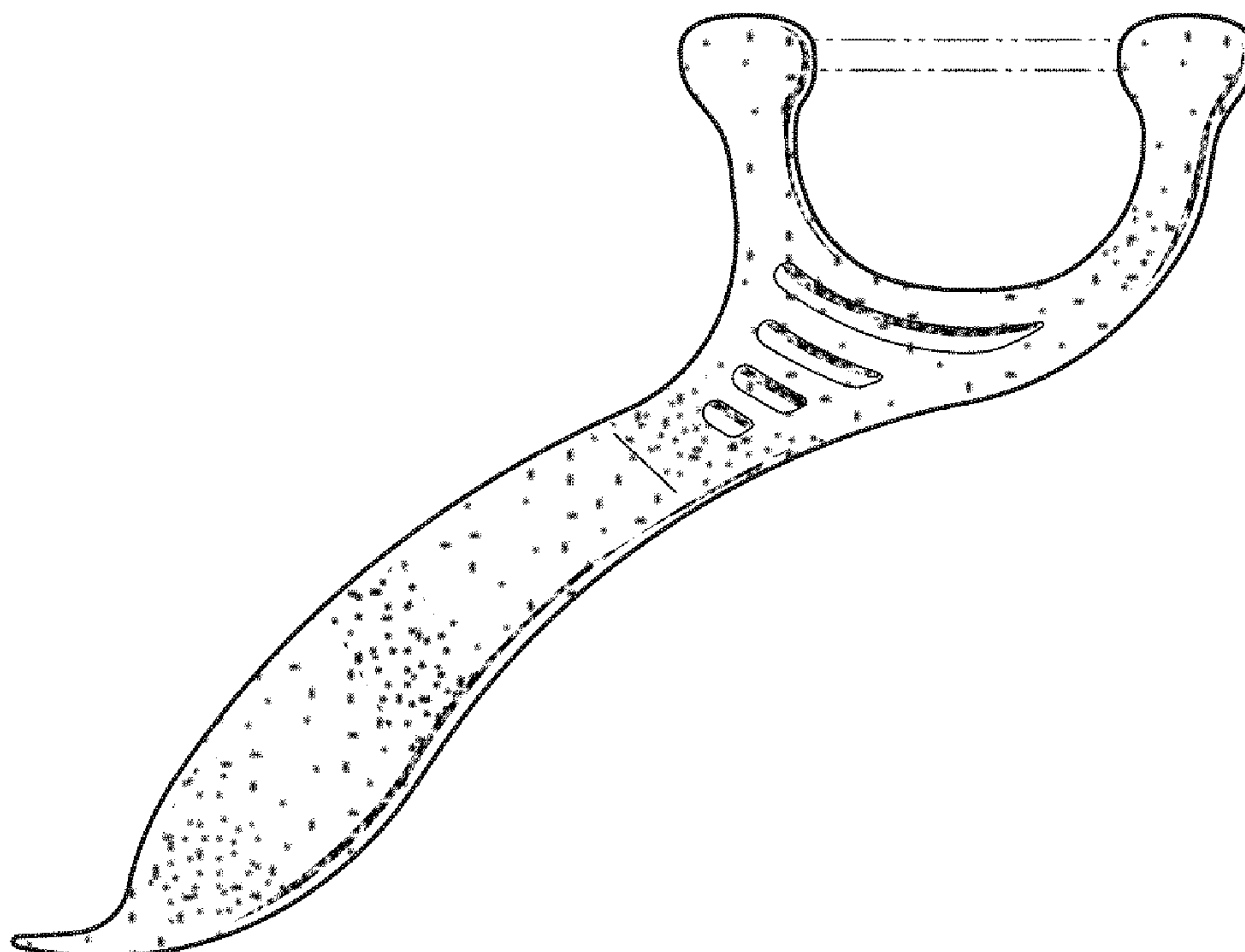
FIG. 4 is a rear view thereof;

FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

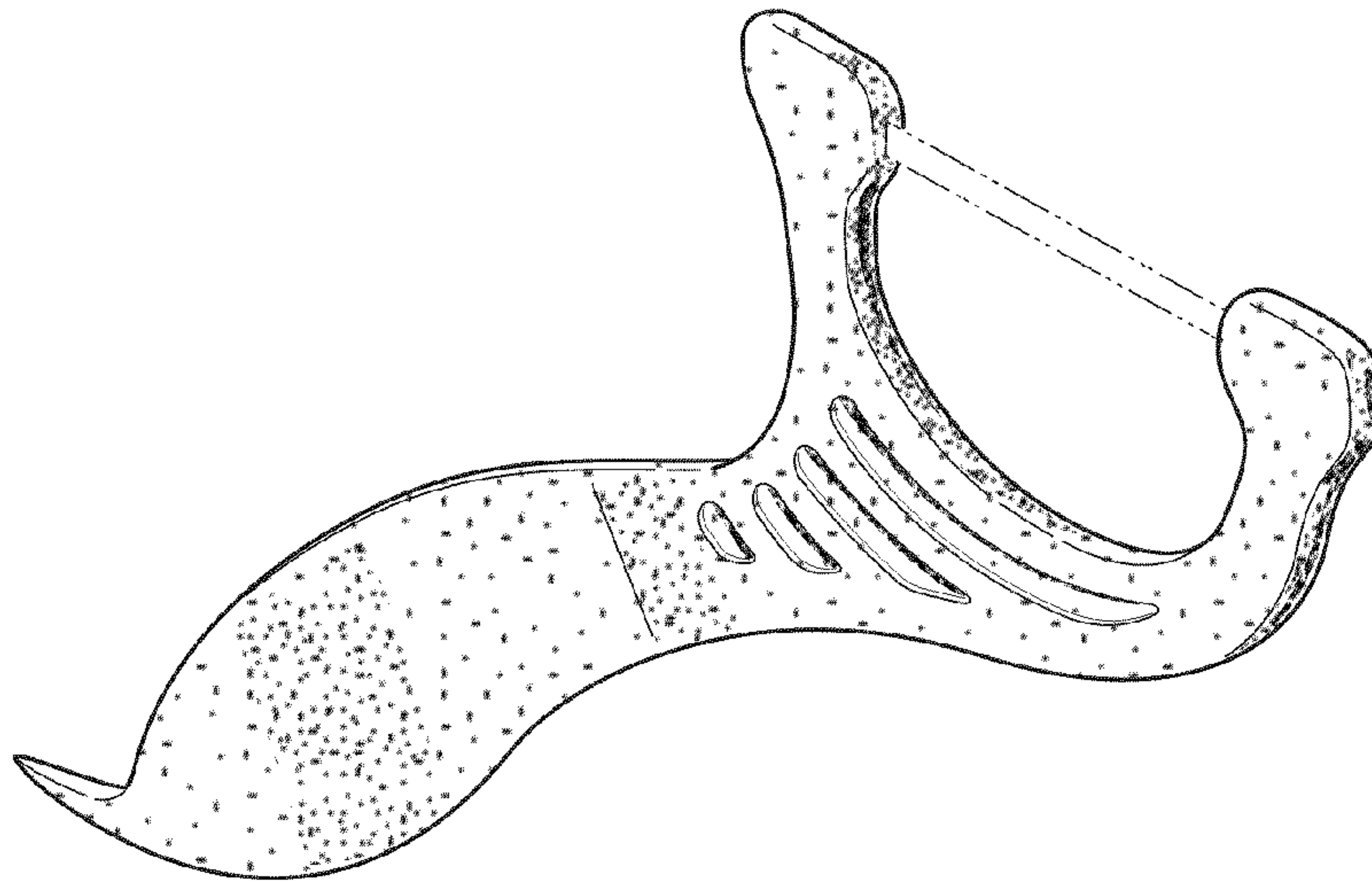

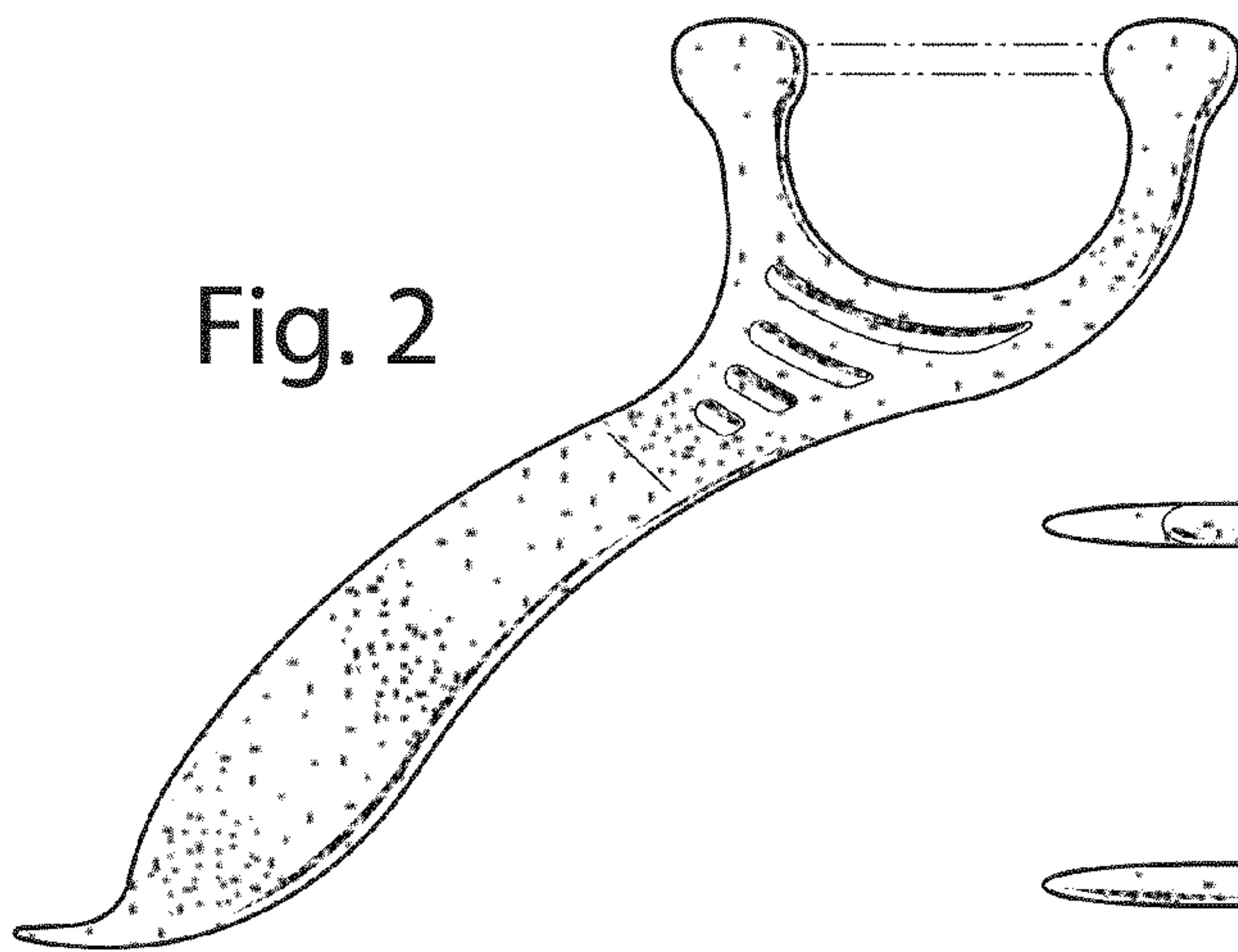

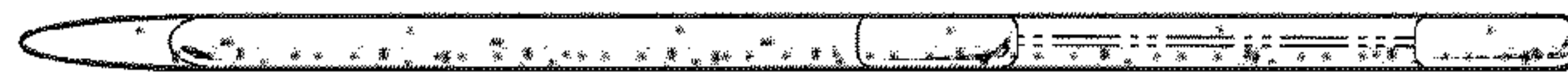

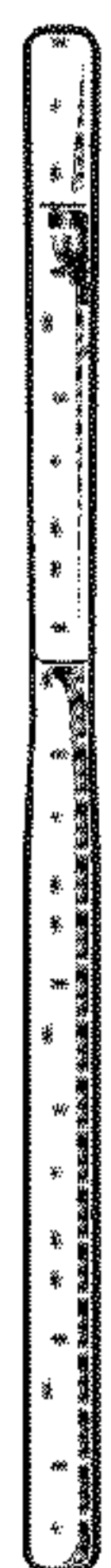
