FIG. 9 is a side view of the pail of FIG. 7, which is identical to the opposite side.

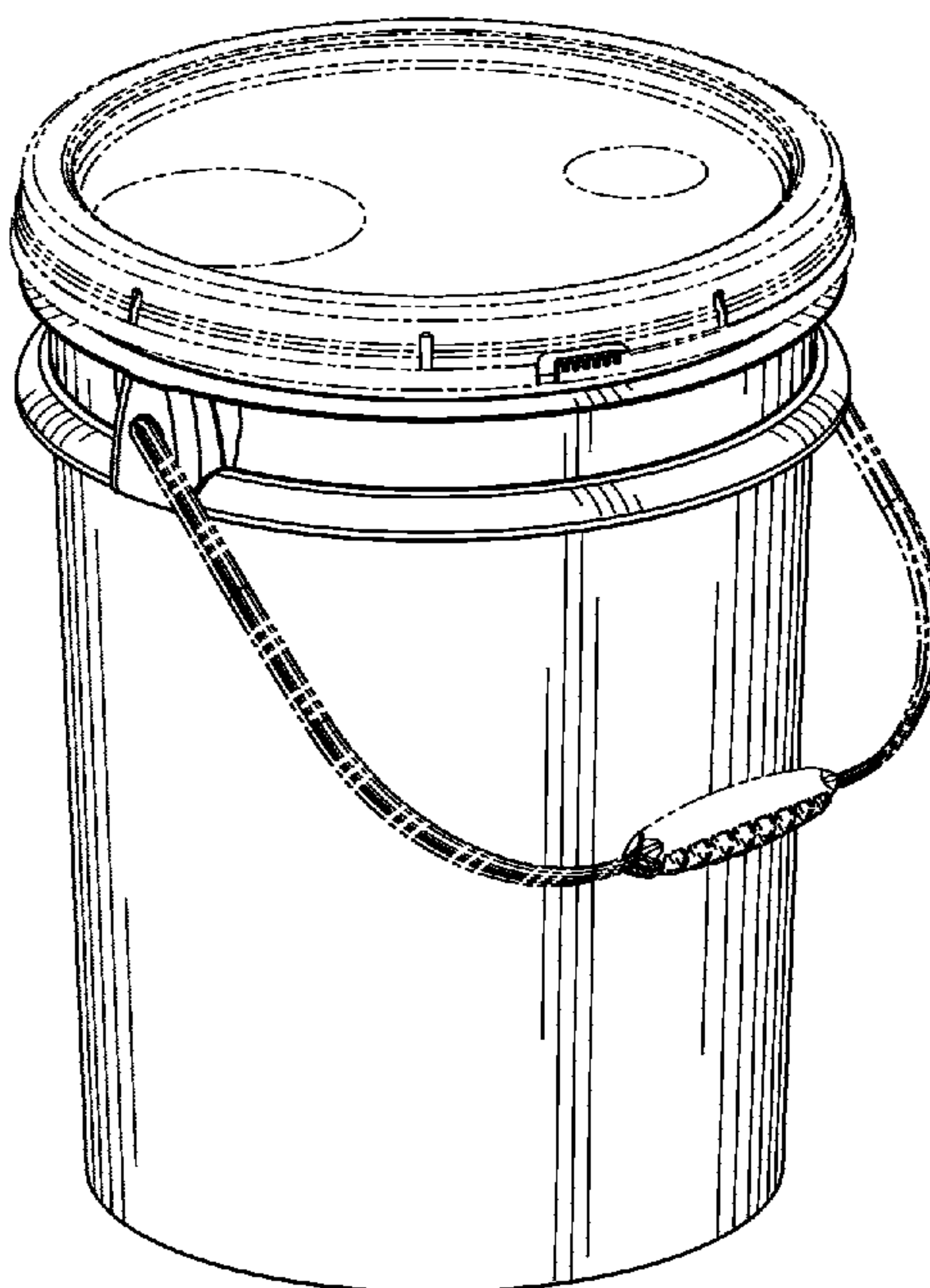
FIG. 10 is a front view of the pail of FIG. 7, which is identical to the rear.

FIG. 11 is a top view of the pail of FIG. 7; and,

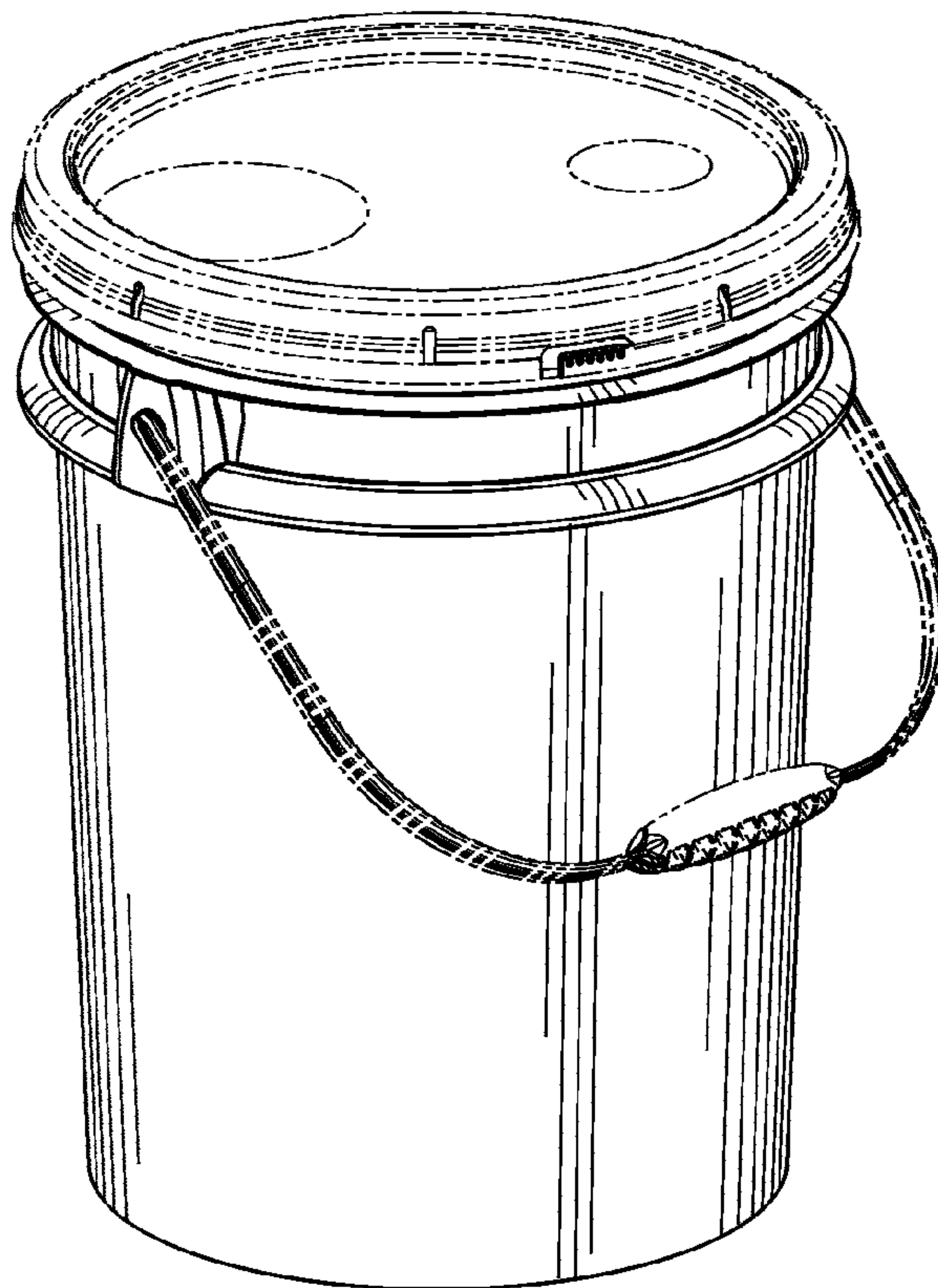
FIG. 12 is a bottom view of the pail of FIG. 7.

The broken lines shown herein are for illustrative purposes only and form no part of the claimed design.

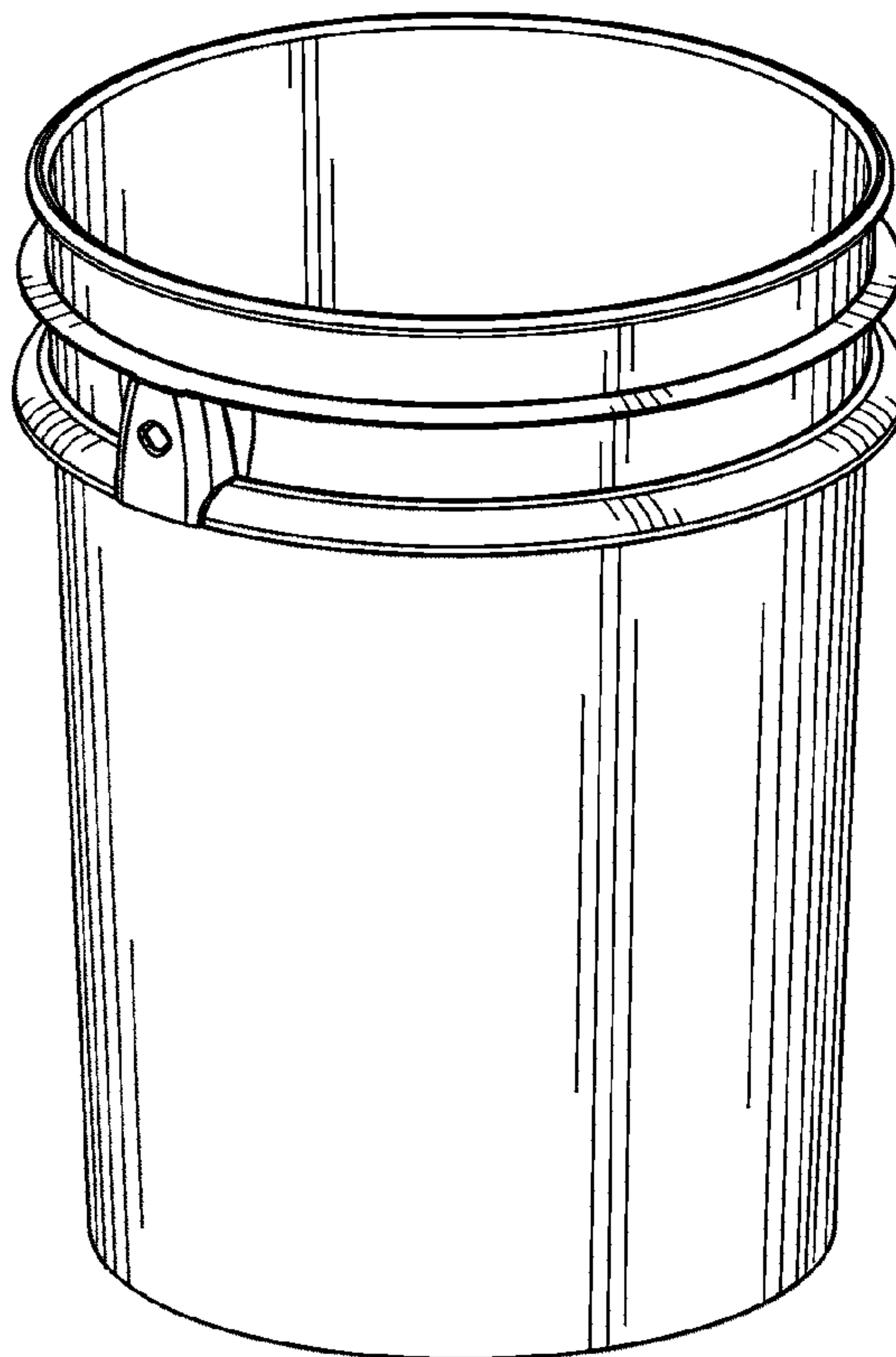

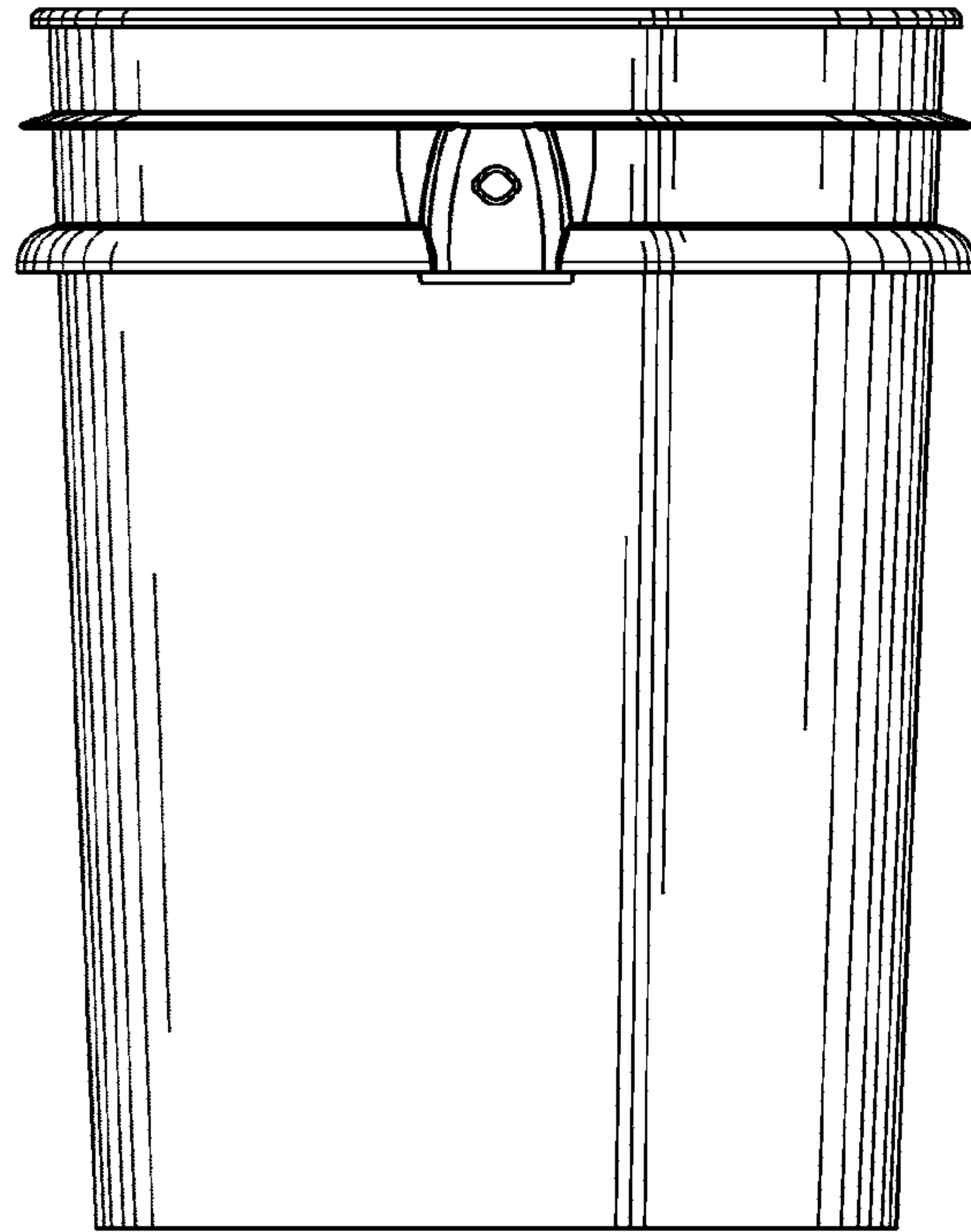

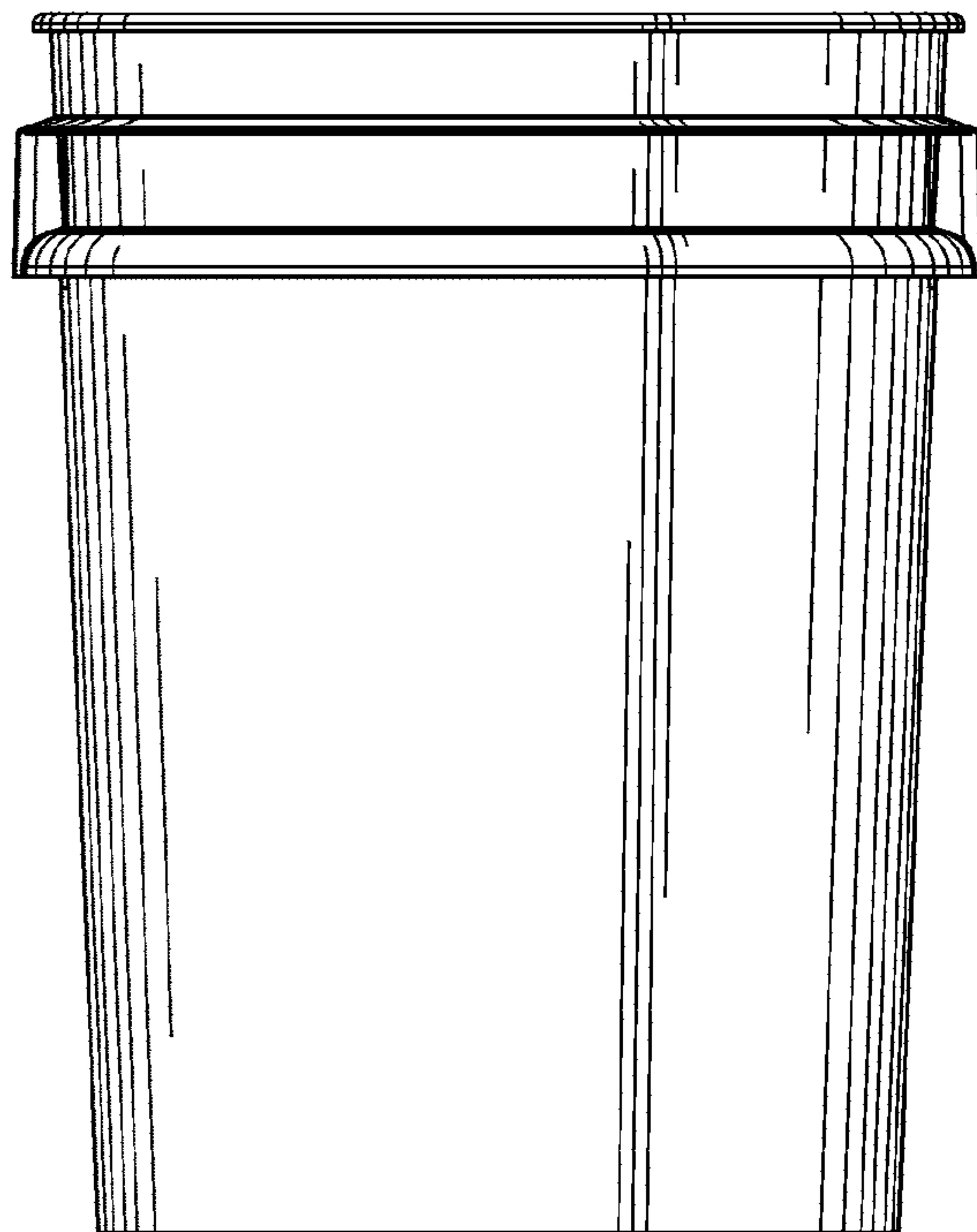

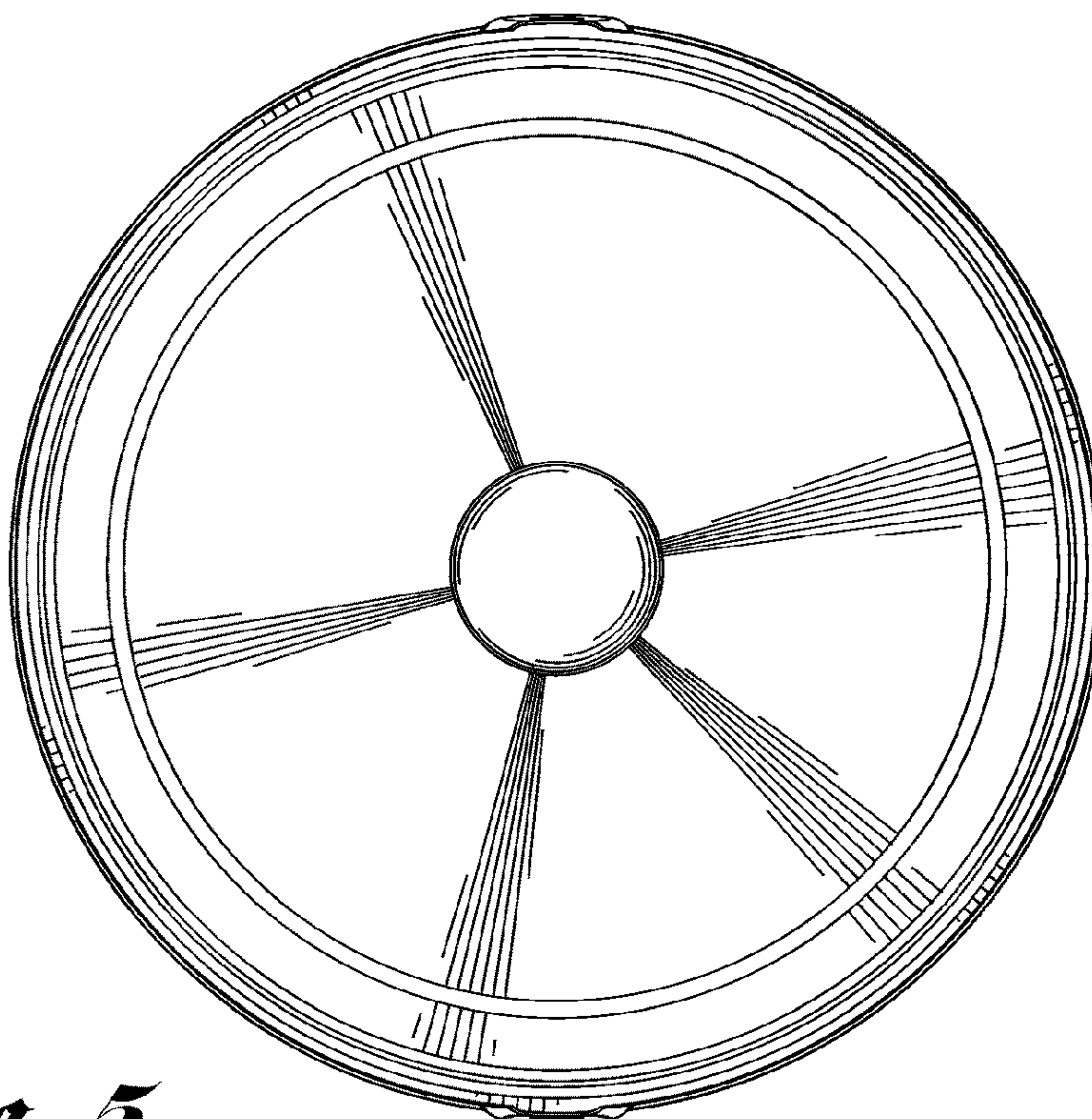

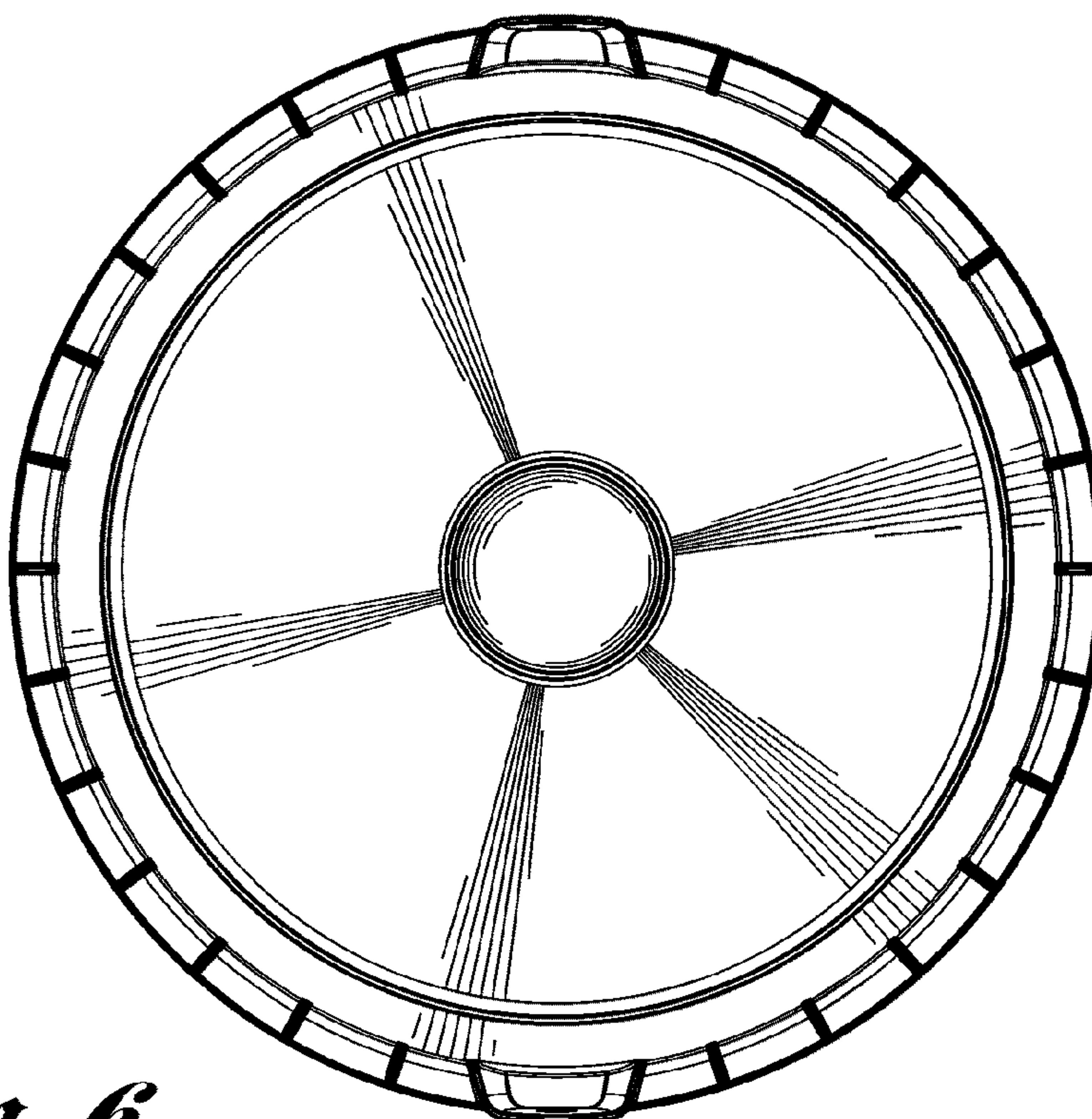

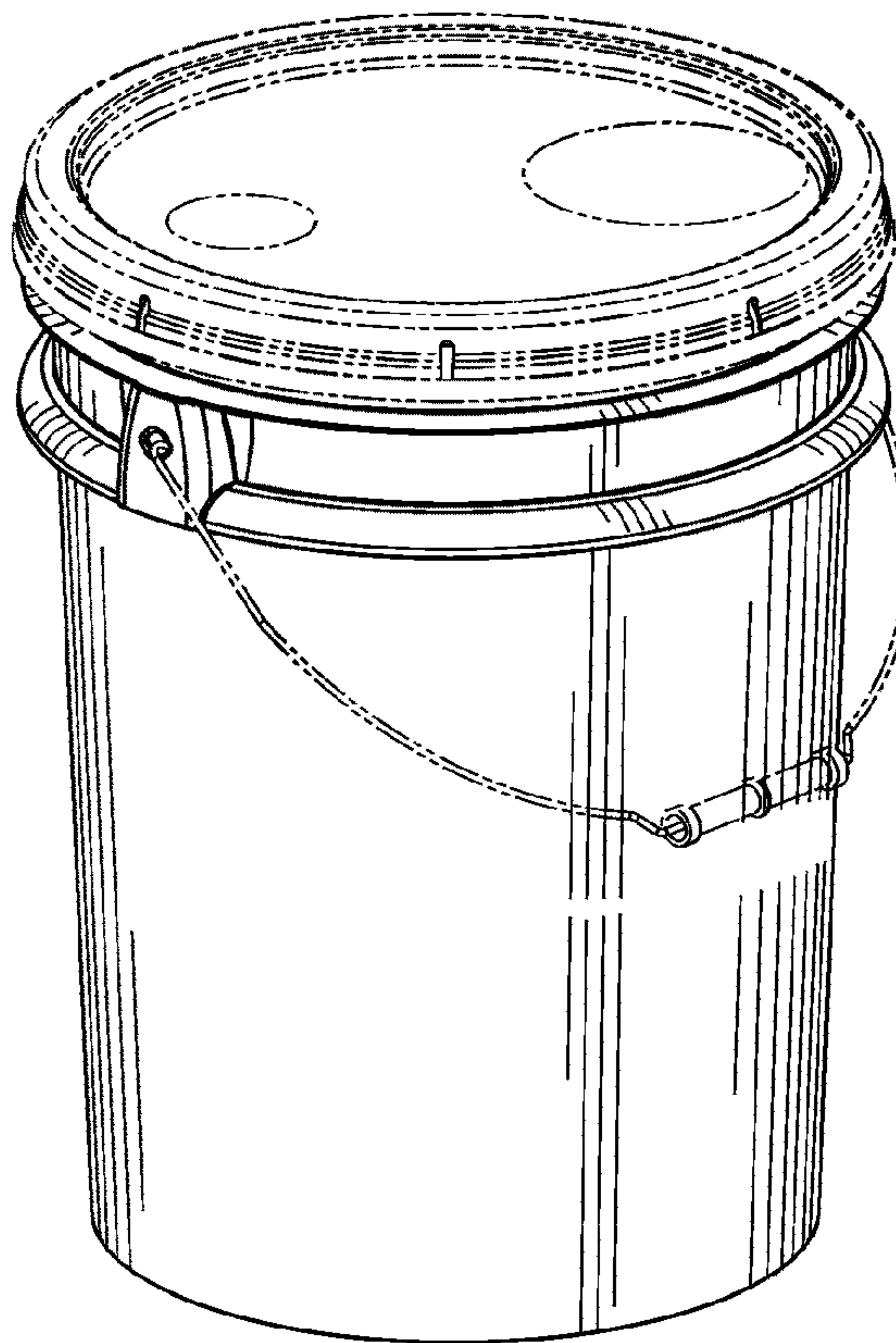

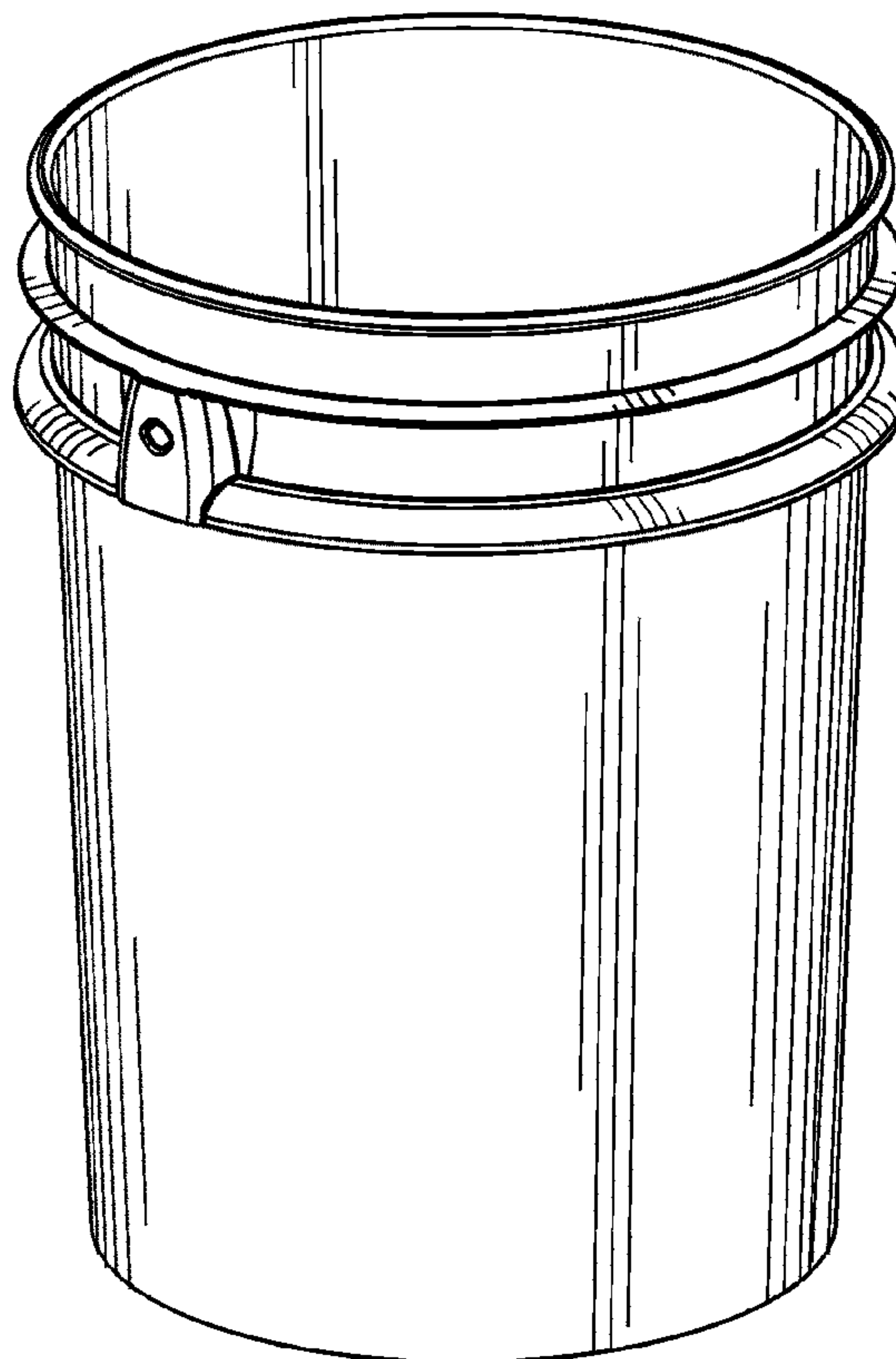


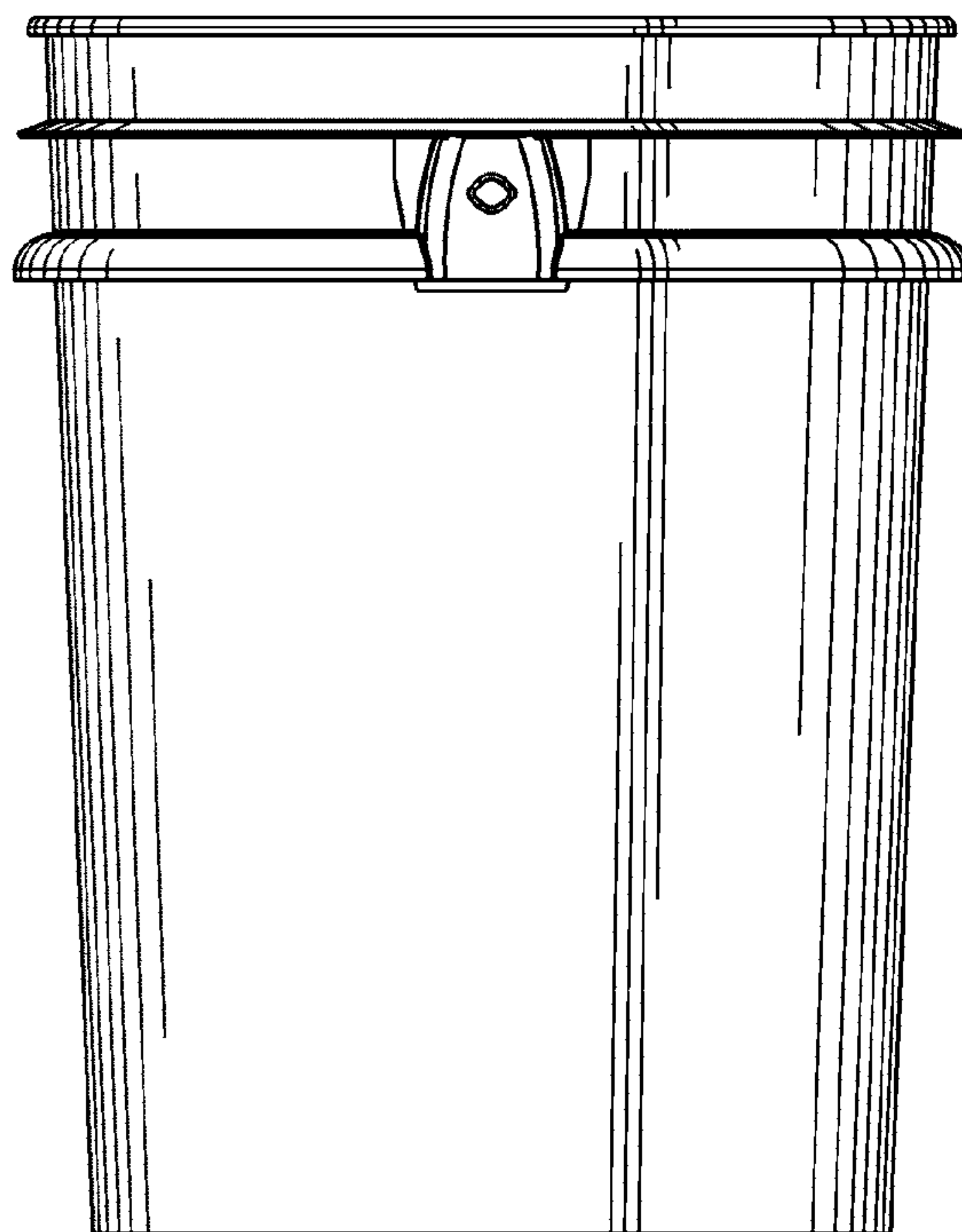

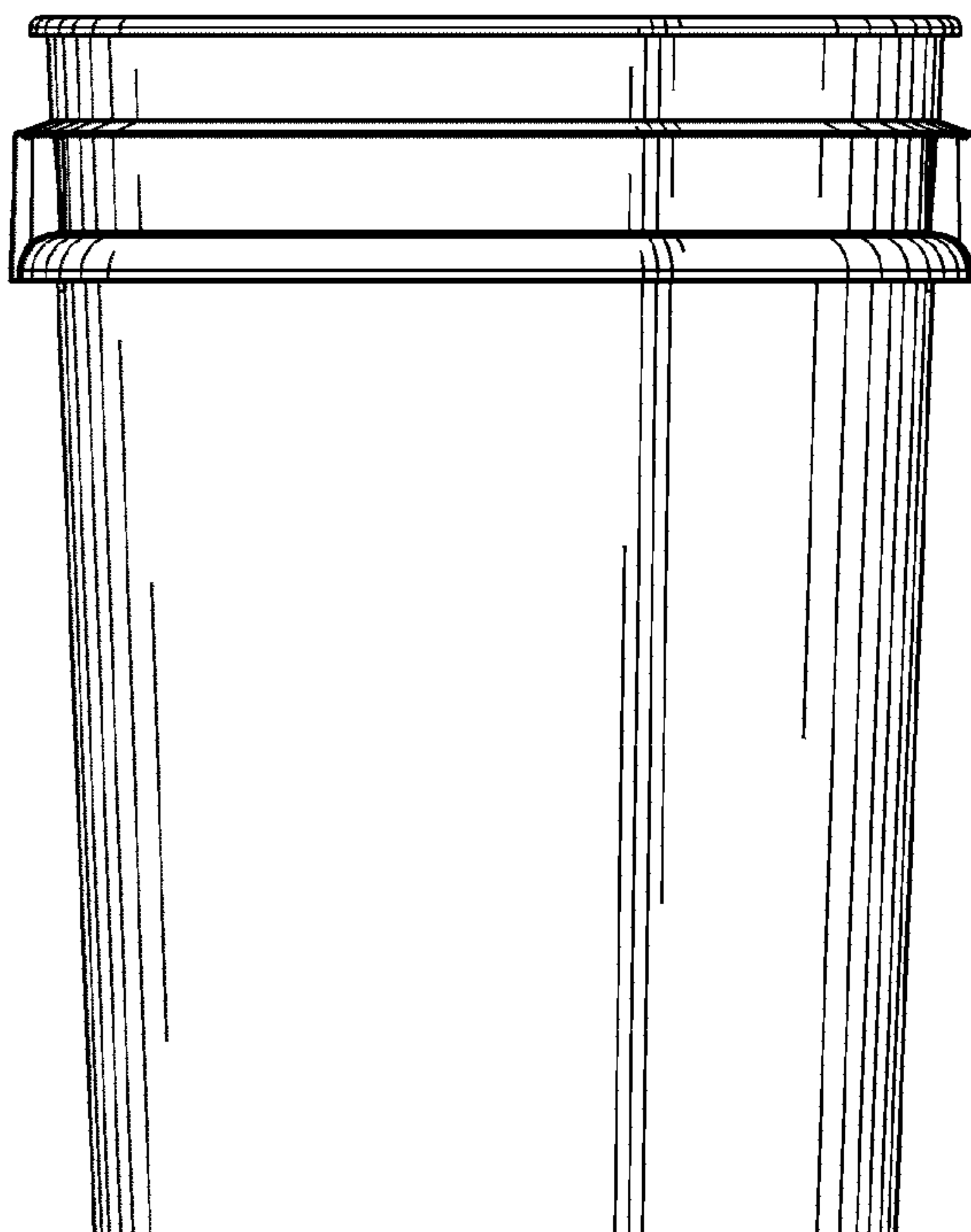

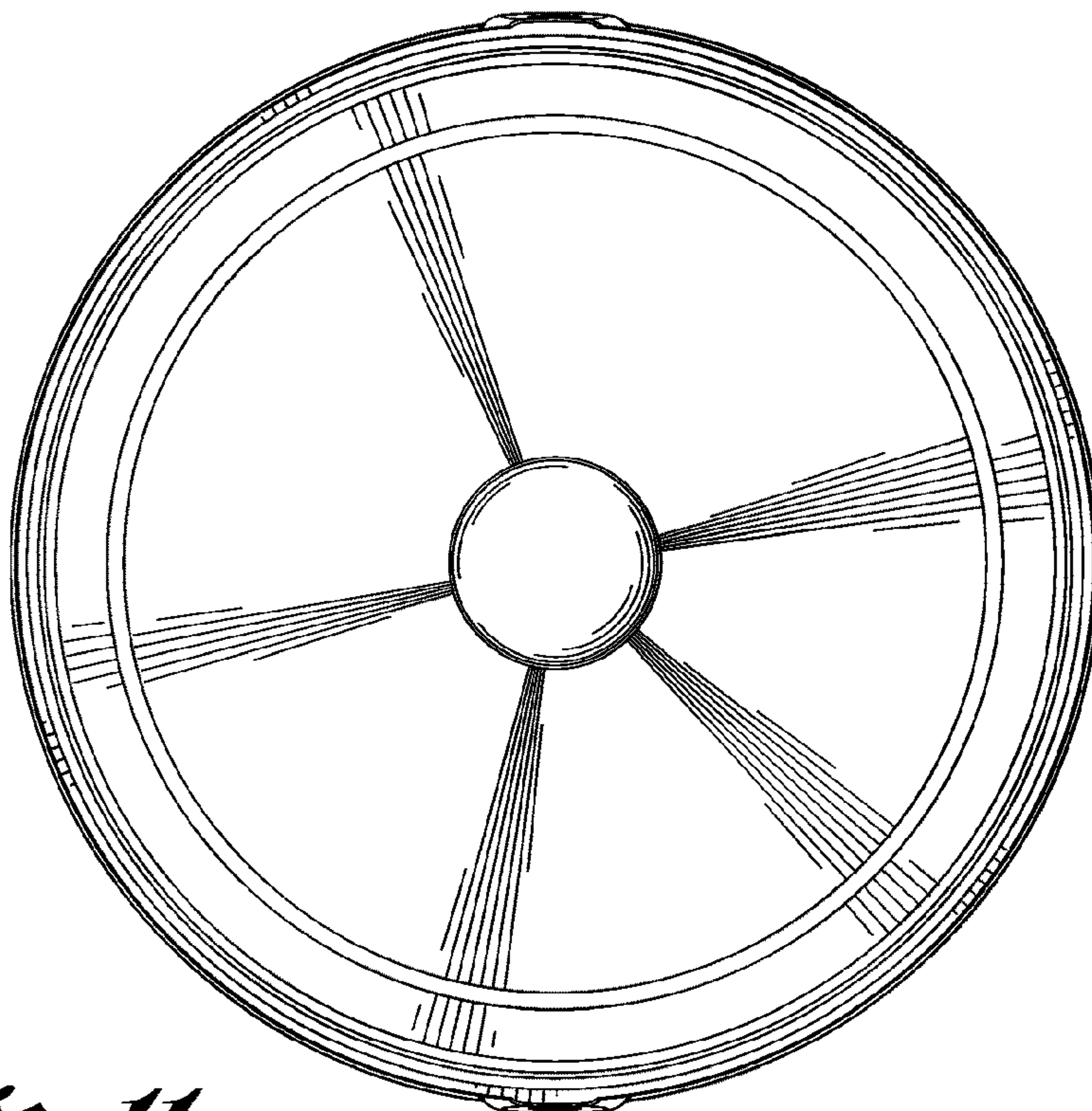

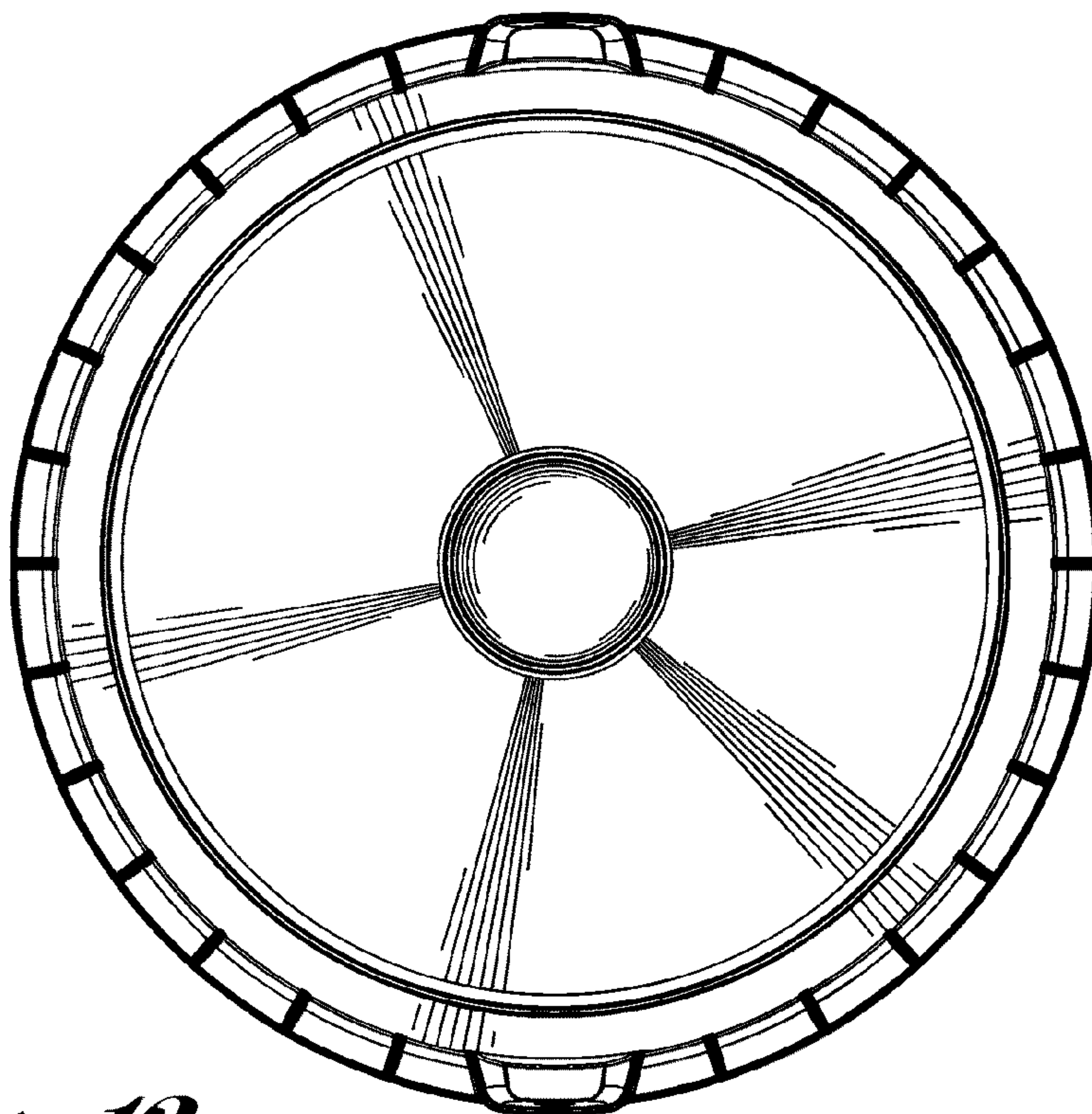
